FIG. 2 is a bottom view of the portable cellular alert device.

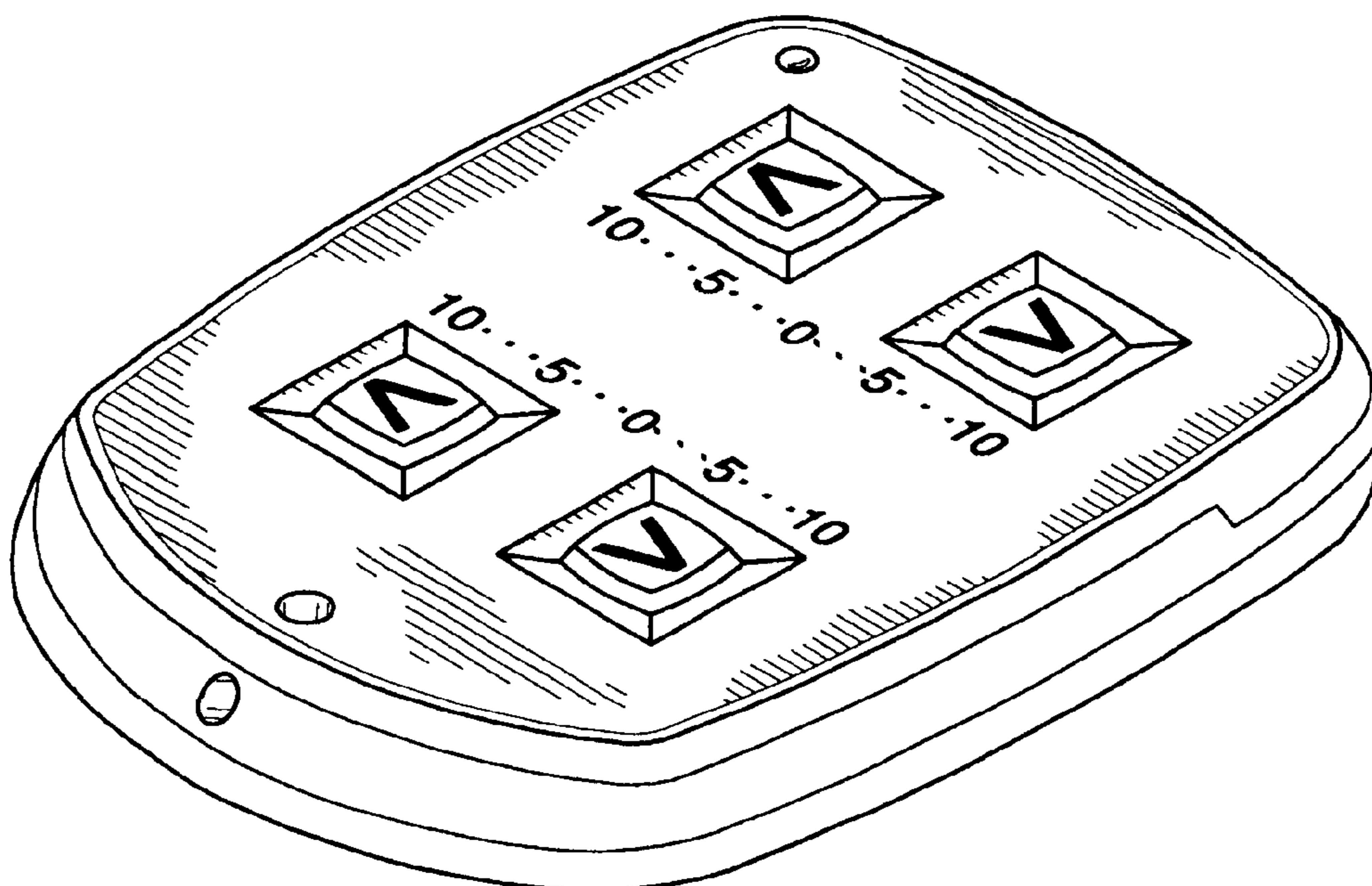
FIG. 3 is a left side elevated view of the portable cellular alert device.

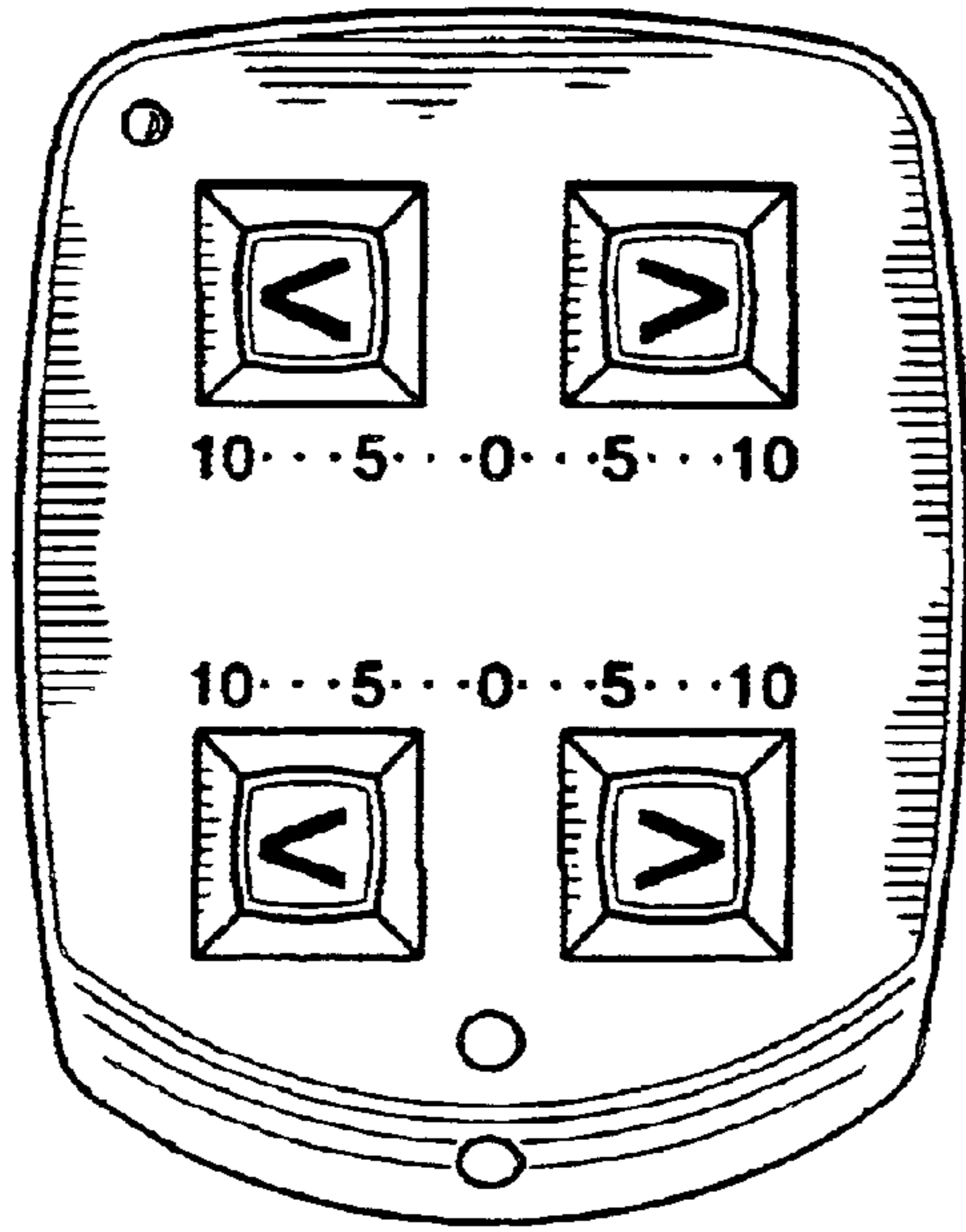

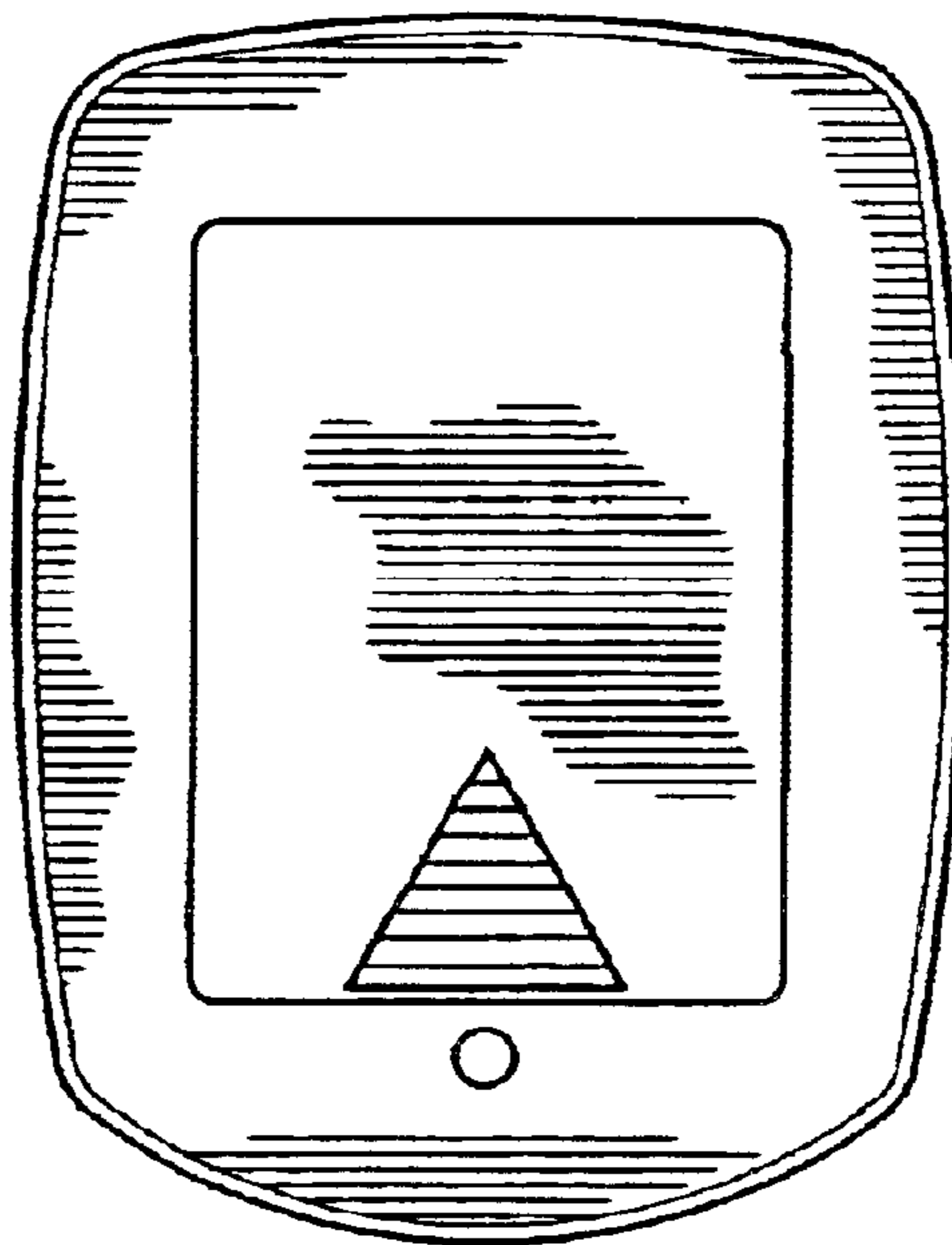

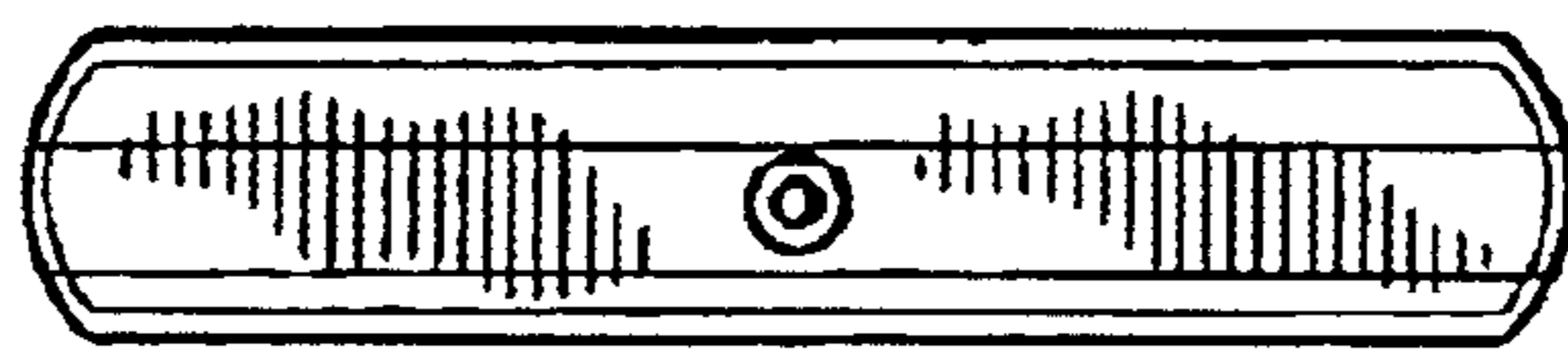

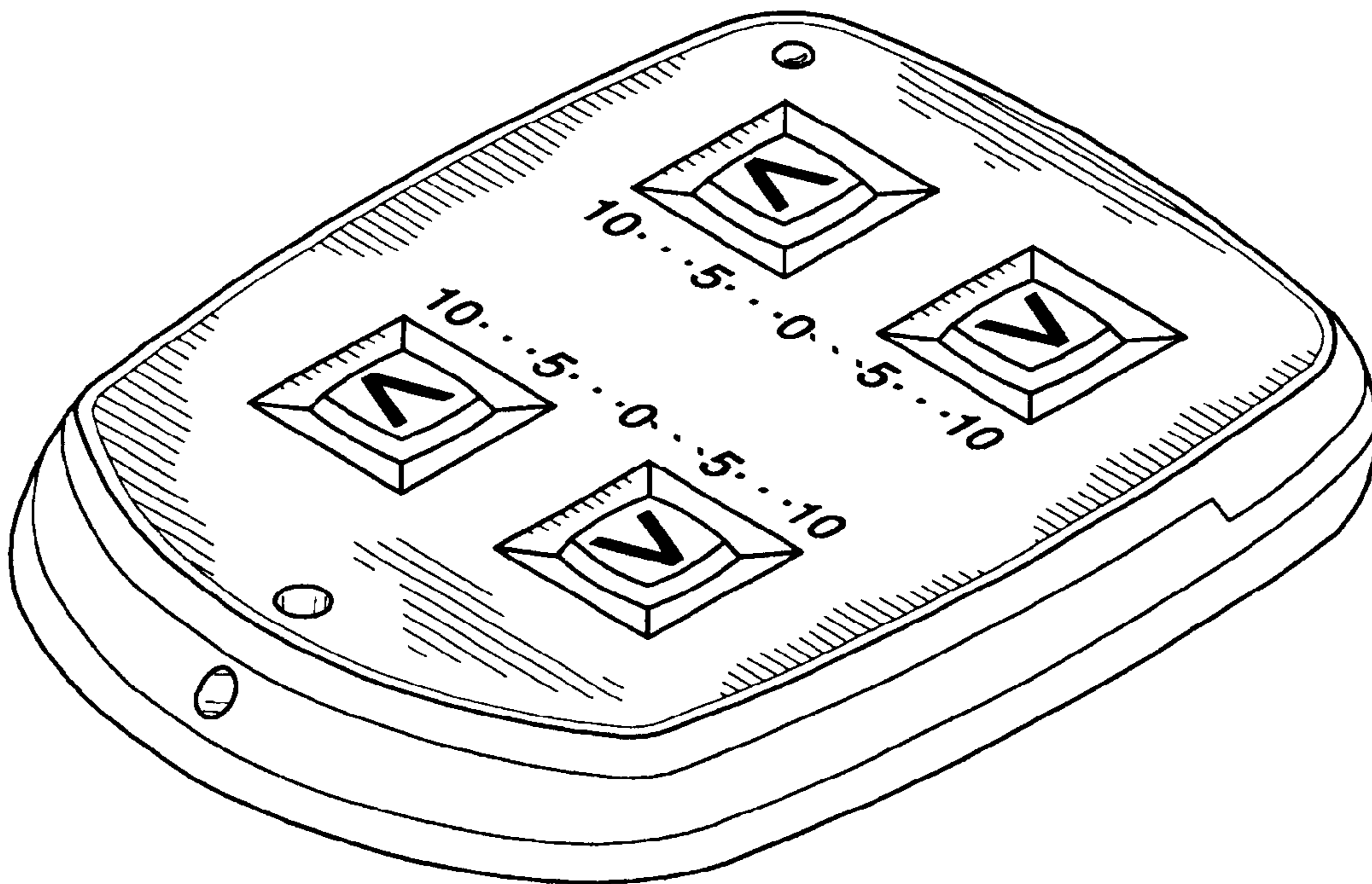
