DESCRIPTION

FIG. 1 is a front elevatoinal view of a plaque showing our new design;

FIG. 2 is a rear elevational view thereof;

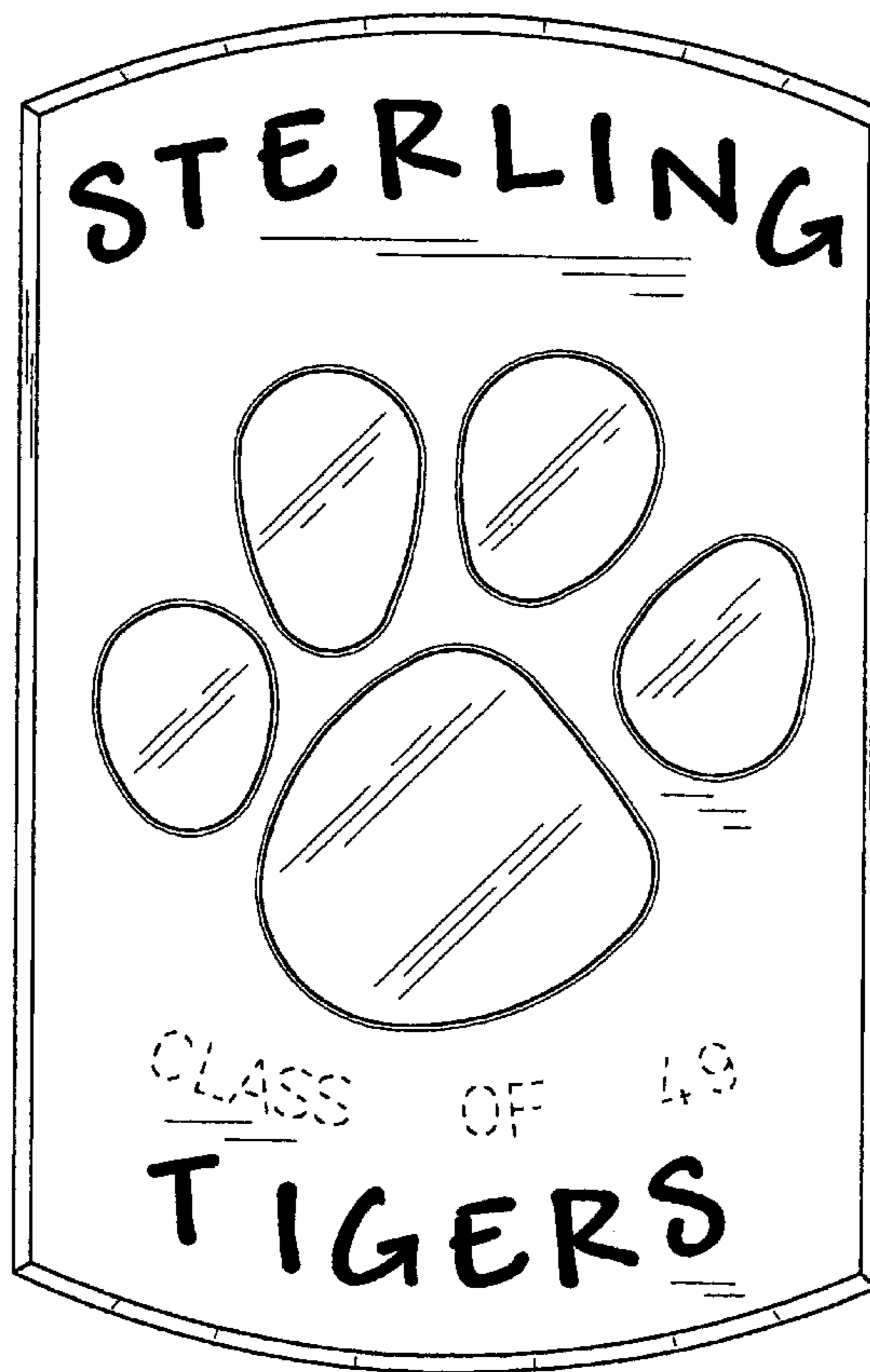
FIG. 3 is a side view, taken from the left side of FIG. 1, the right side view being a mirror image thereof;

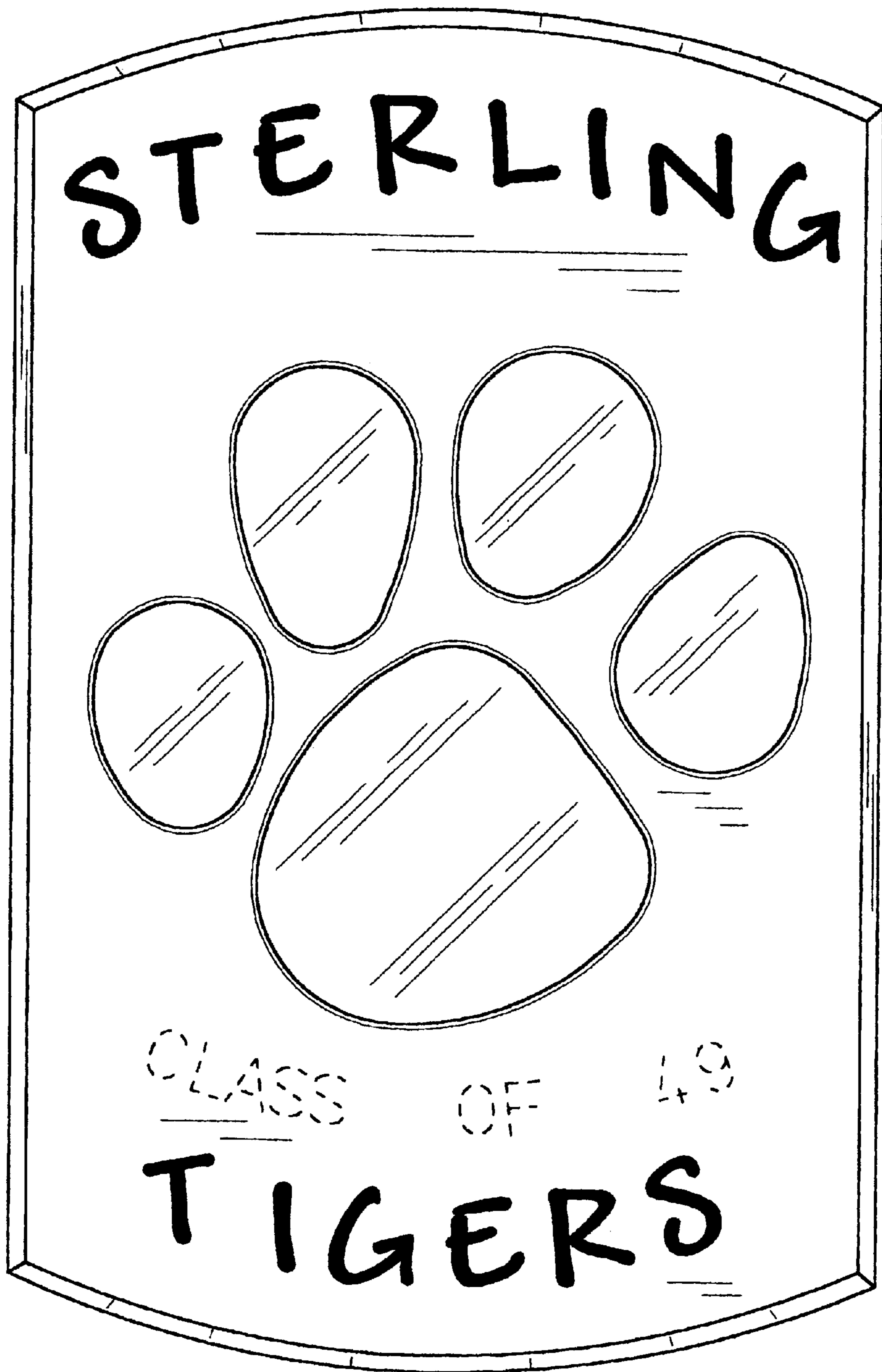

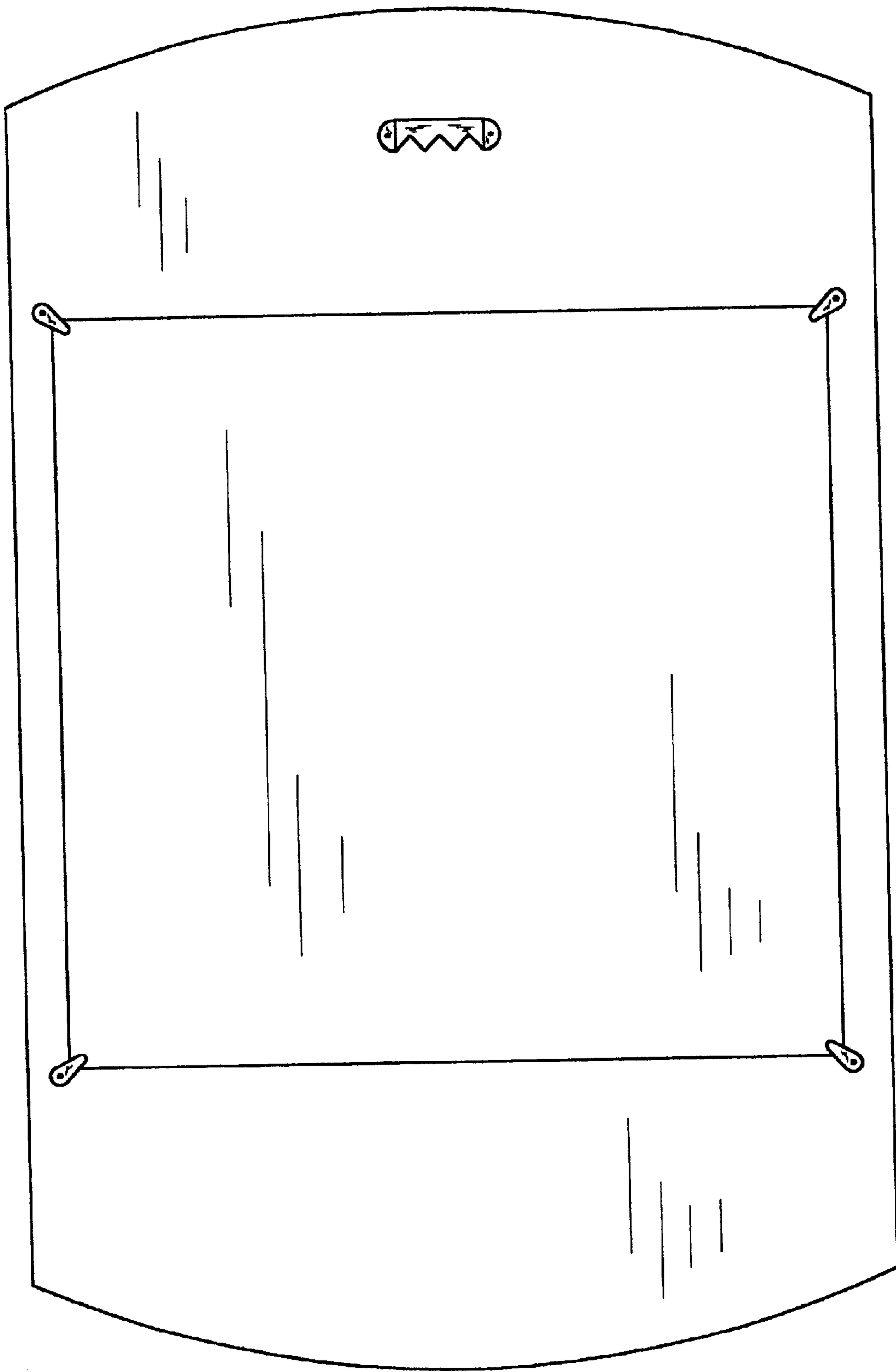

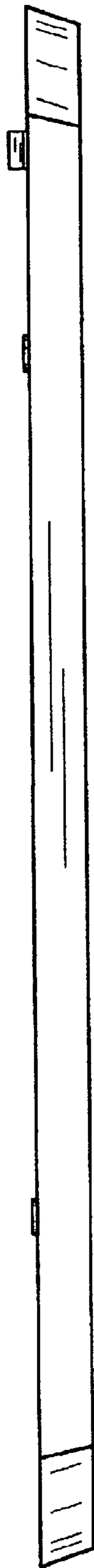

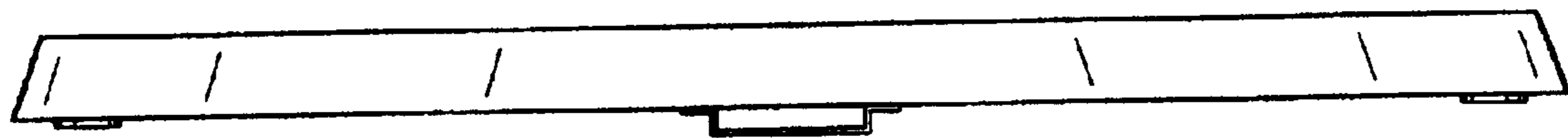
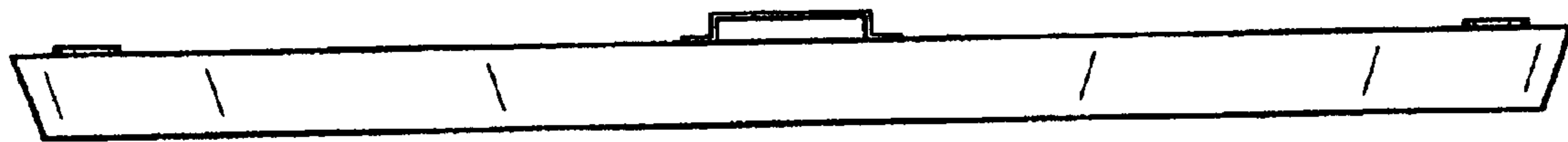
