(57) **CLAIM**

We claim the ornamental design for a vehicle antenna, as shown and described.

DESCRIPTION

FIG. 1 is a right side elevation showing the vehicle antenna; FIG. 2 is a left side elevation showing the vehicle antenna; FIG. 3 is a front elevation showing the vehicle antenna; FIG. 4 is a rear elevation showing the vehicle antenna; FIG. 5 is an enlarged top plan view of the vehicle antenna; FIG. 6 is an enlarged bottom plan view of the vehicle antenna; and, FIG. 7 is a perspective view showing the vehicle antenna in use.

The broken line showing of the vehicle is for illustrative purposes only and forms no part of the claimed design.

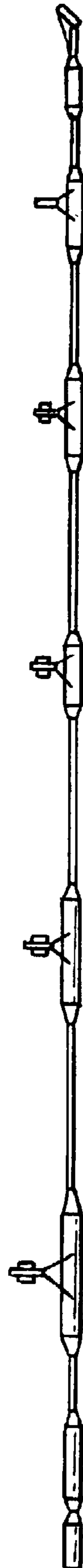

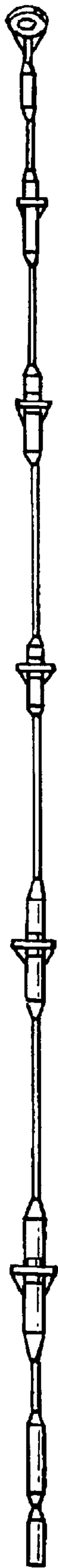

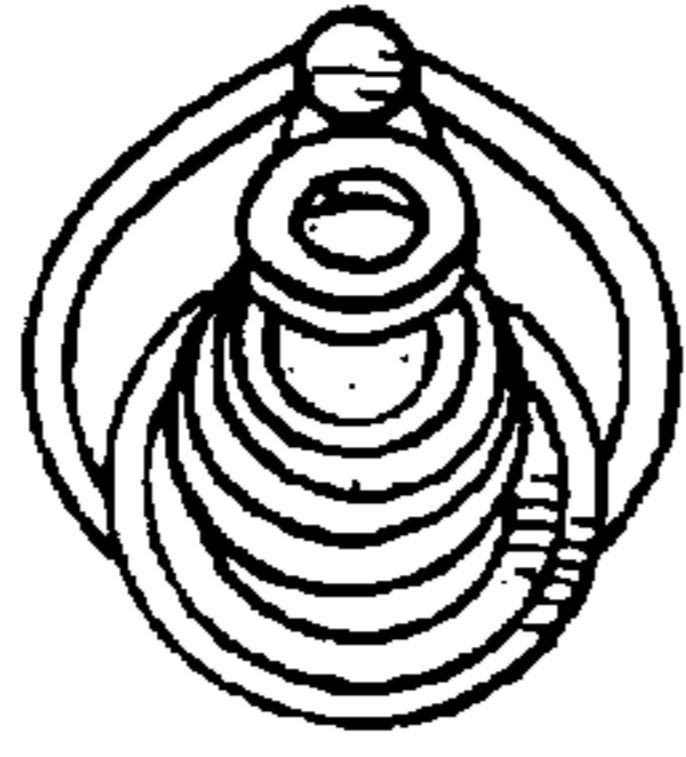

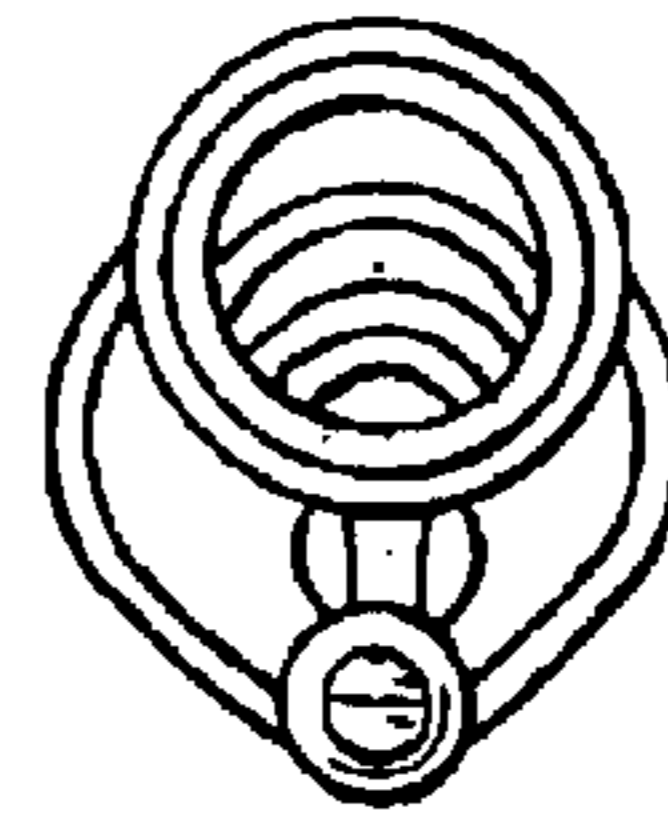
