(57) **CLAIM**

I claim the ornamental design for an input device, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a first embodiment of an input device according to my new design, the broken lines showing buttons is not part of the claimed design;

FIG. 2 is rear elevation view of FIG. 1;

FIG. 3 is a top plan view of FIG. 1, the broken lines showing buttons is not part of the claimed design;

FIG. 4 is a bottom plan view of all embodiments;

FIG. 5 is a left side elevation view of FIG. 1, the broken lines showing buttons is not part of the claimed design;

FIG. 6 is a right side elevation view of FIG. 1, the broken lines showing buttons is not part of the claimed design;

FIG. 7 is a front elevation view of a second embodiment according to my design, the broken lines showing buttons is not part of the claimed design;

FIG. 8 is a rear elevation view of FIG. 7;

FIG. 9 is a top plan view of FIG. 7;

FIG. 10 is a left side elevation view of FIG. 7; and,

FIG. 11 is a right side elevation view of FIG. 7, the broken lines showing buttons is not part of the claimed design.

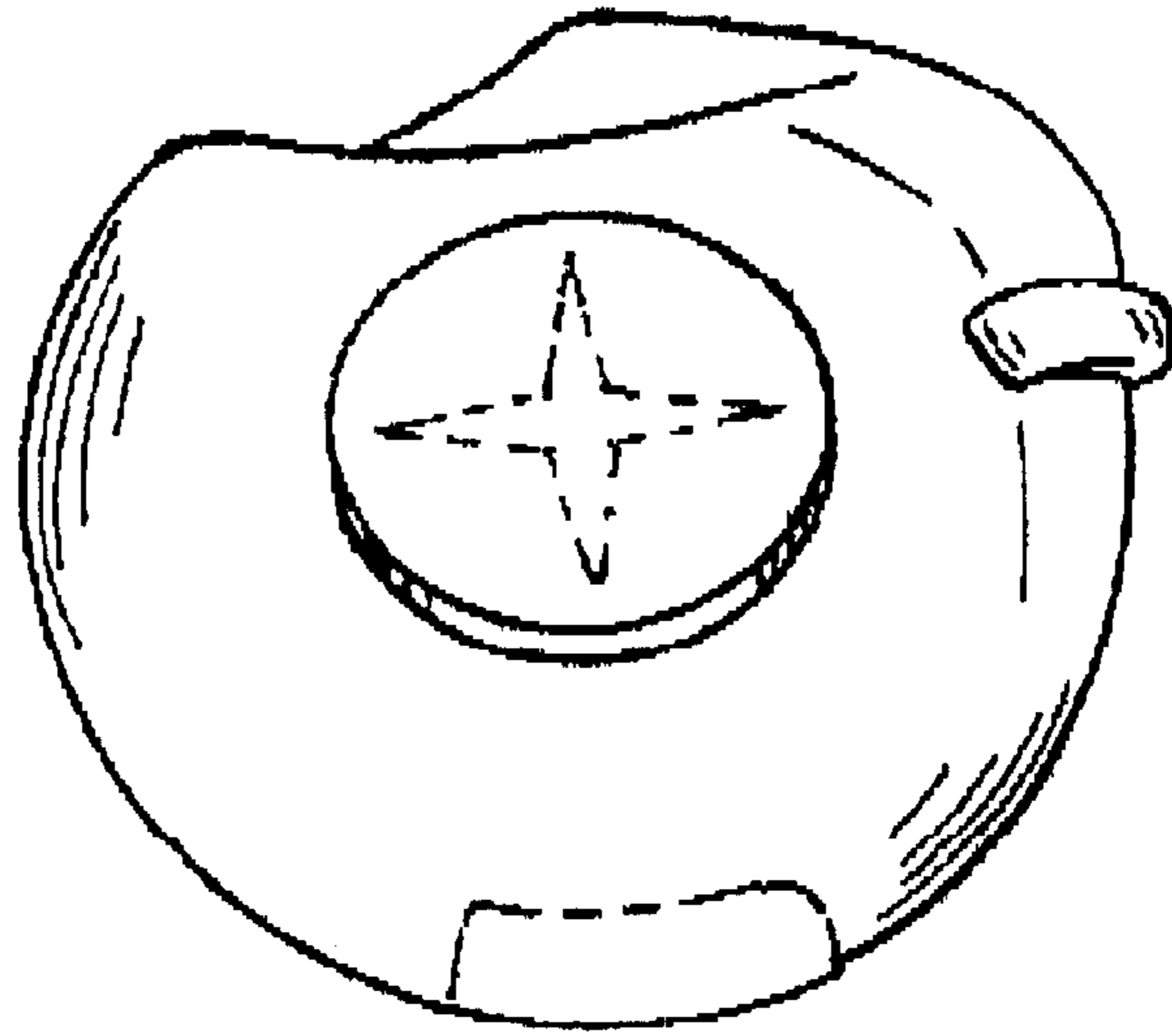

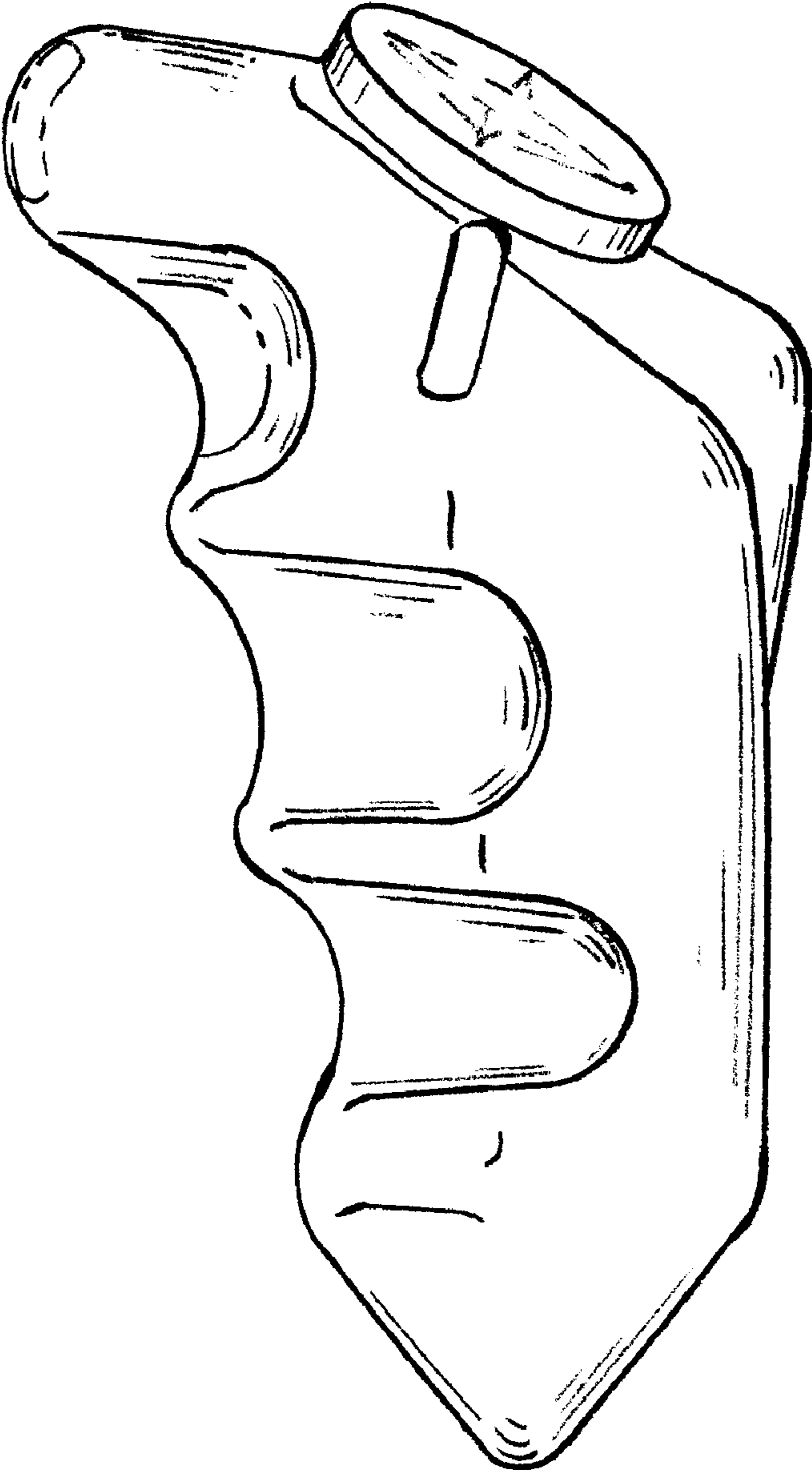

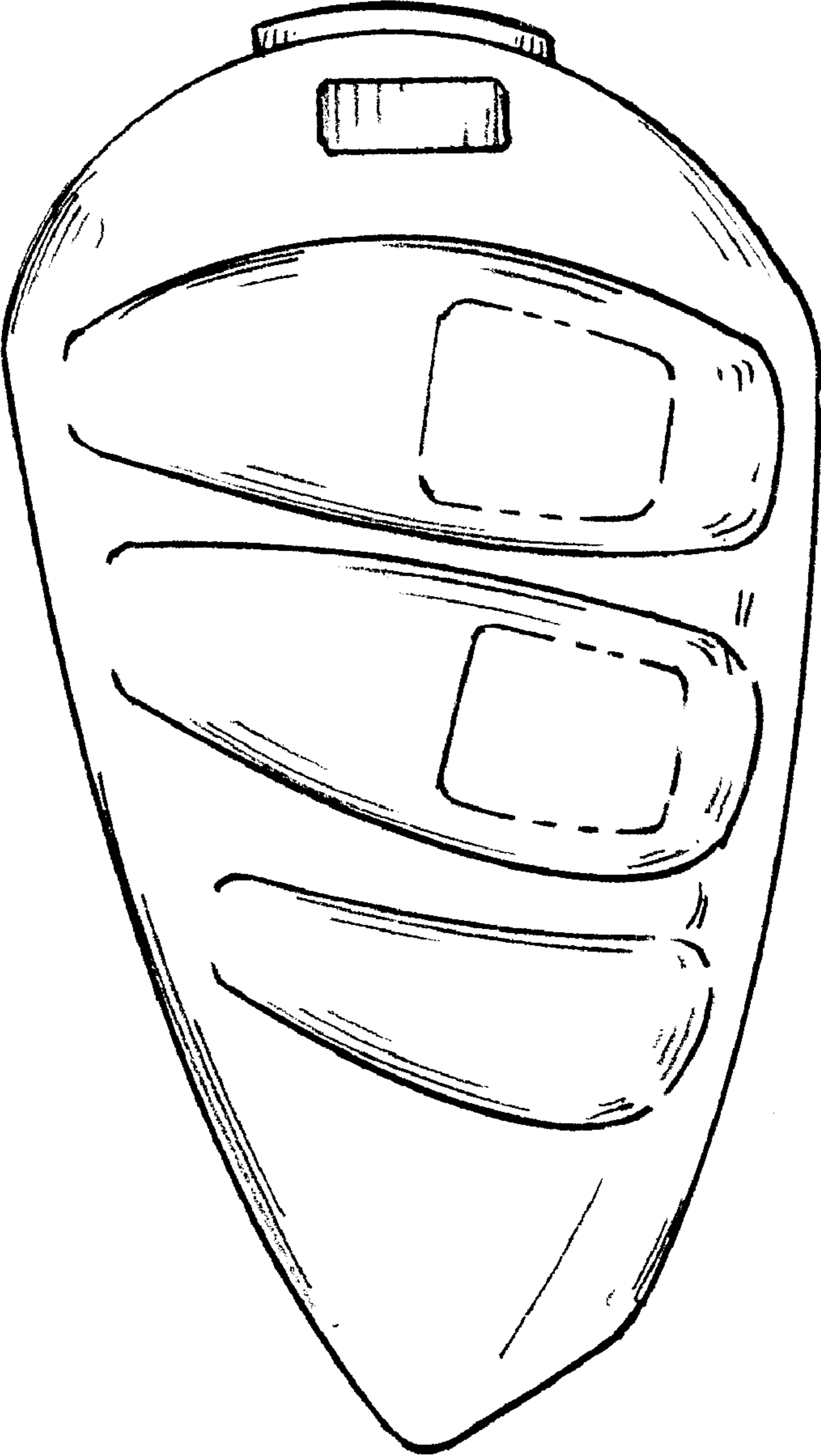

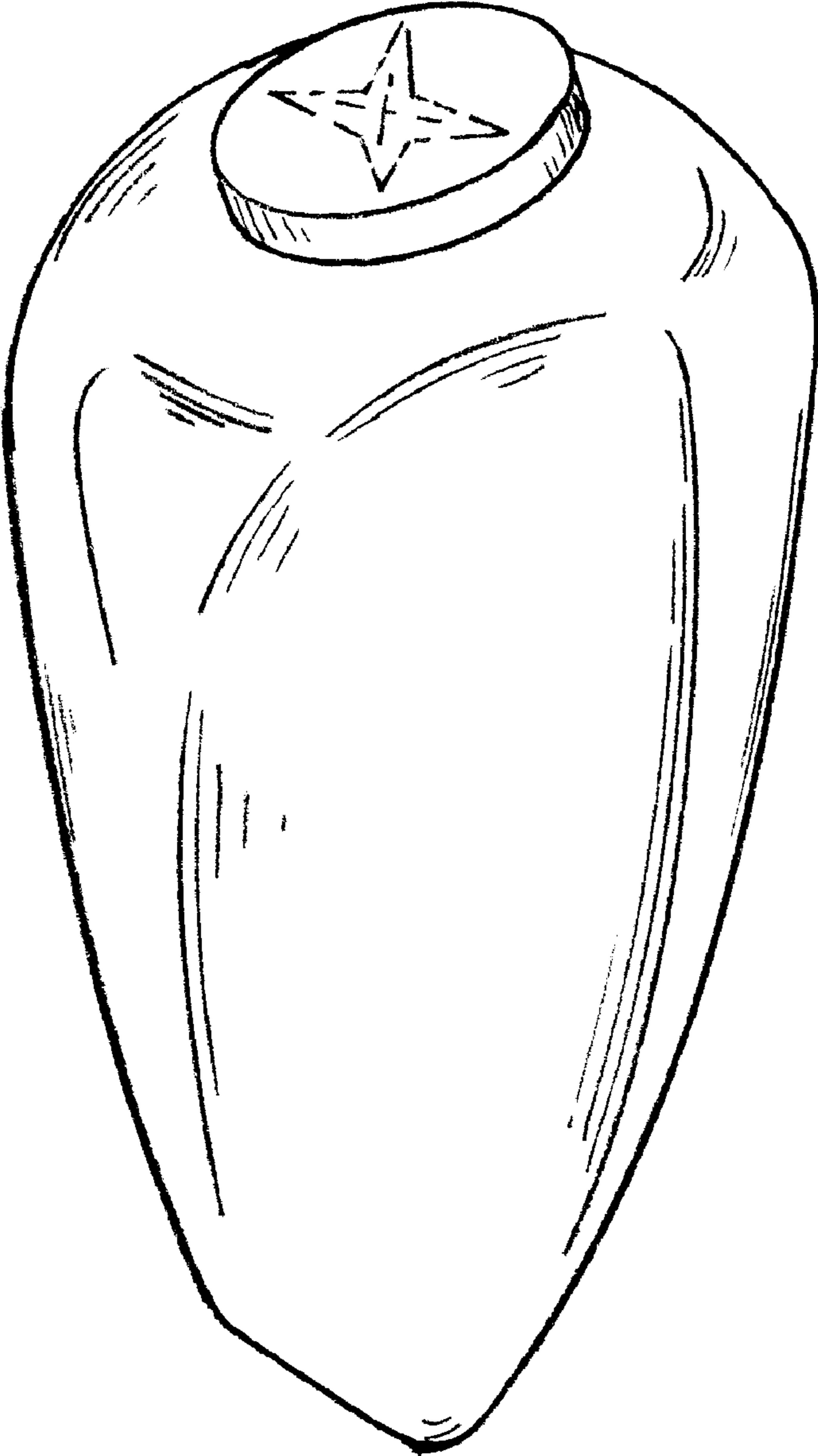

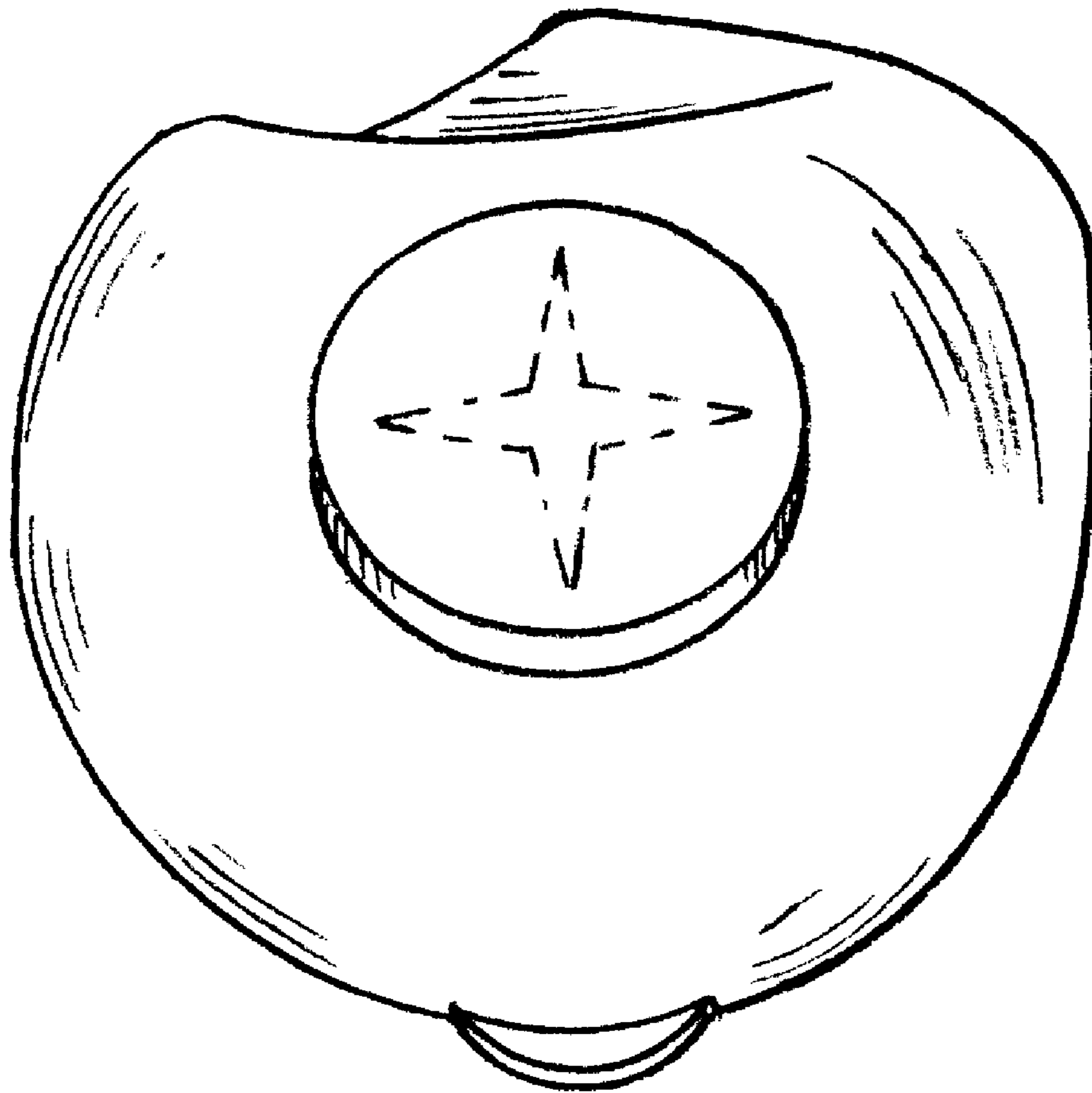

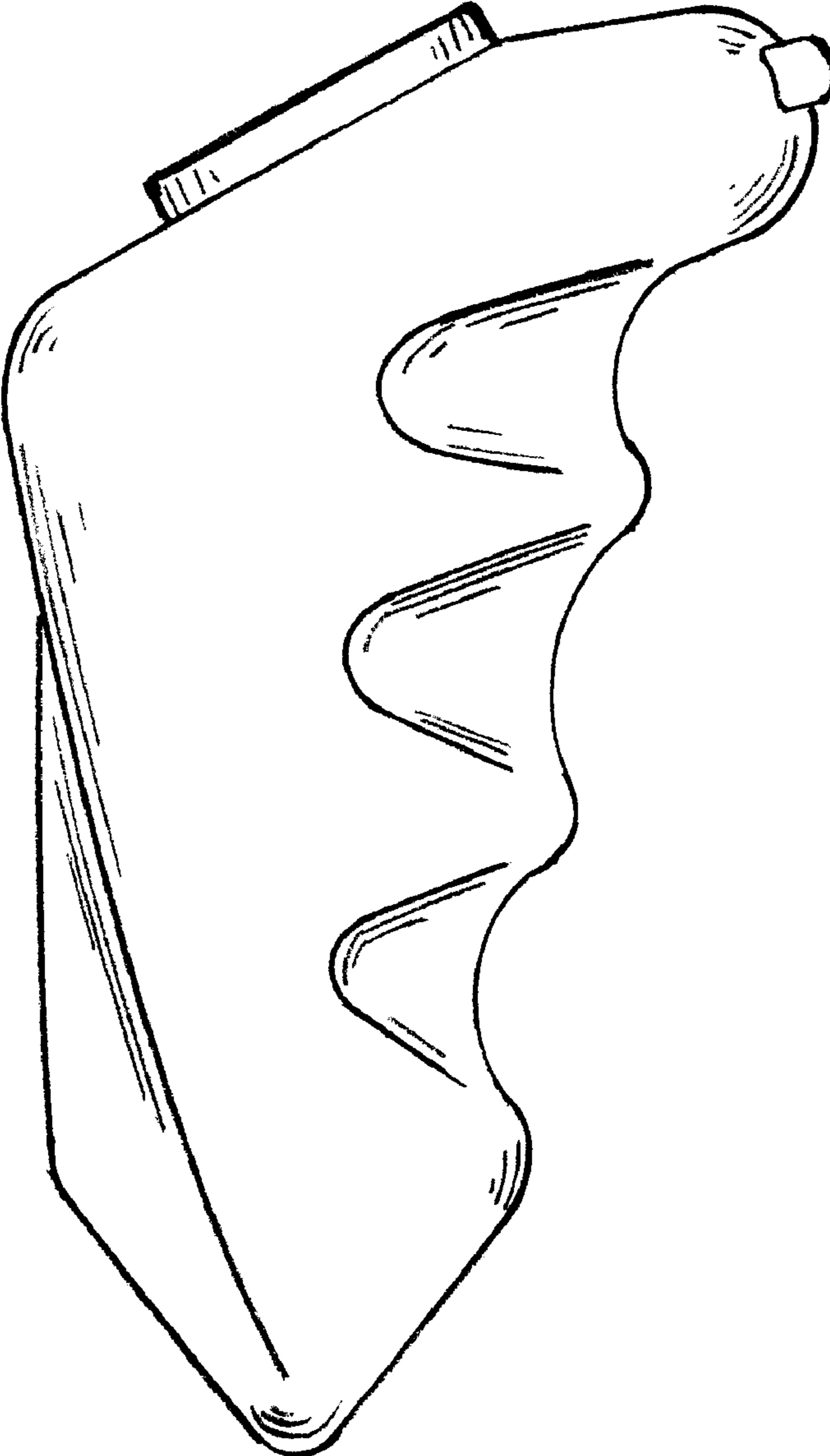

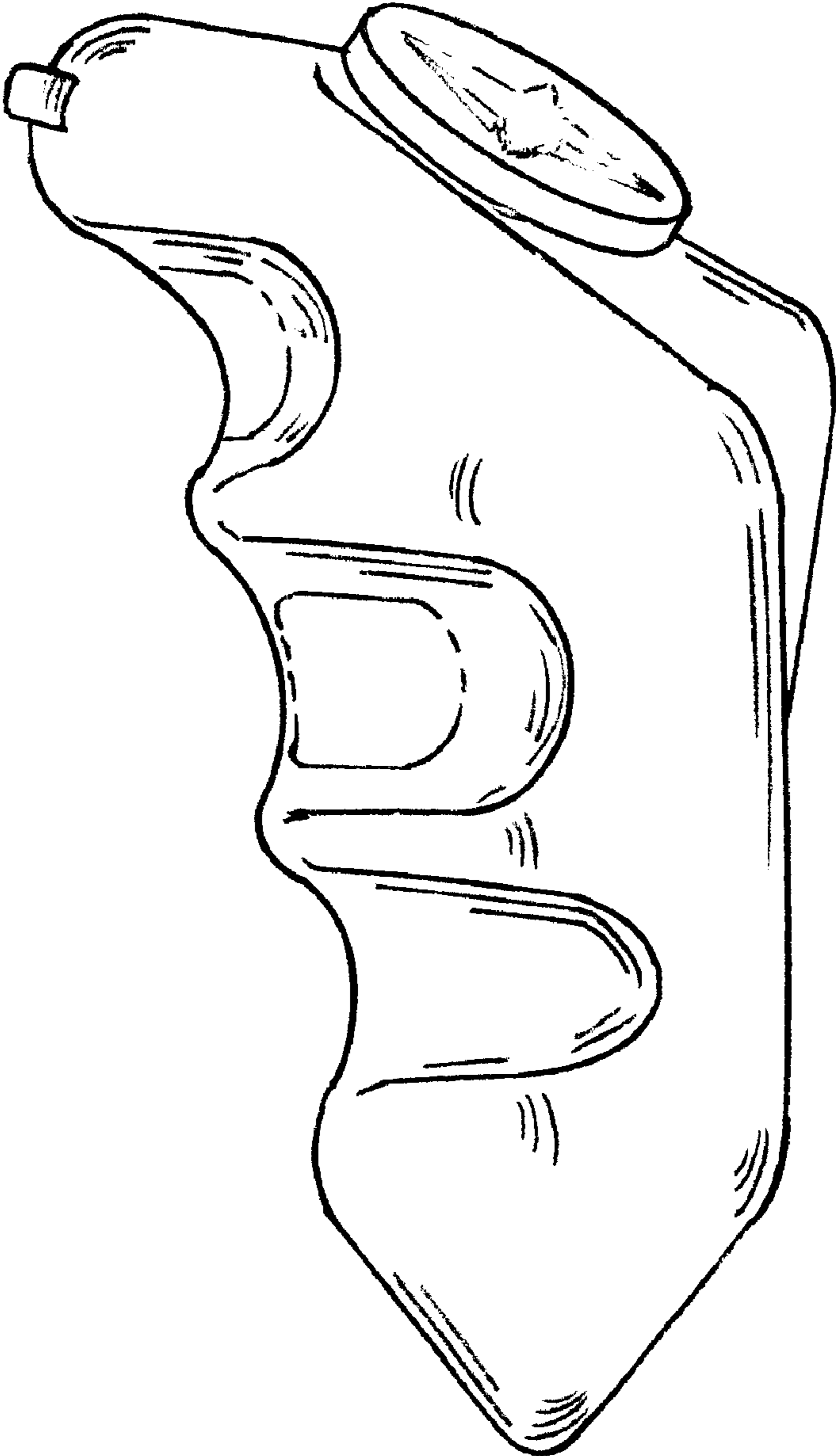
