(57) **CLAIM**

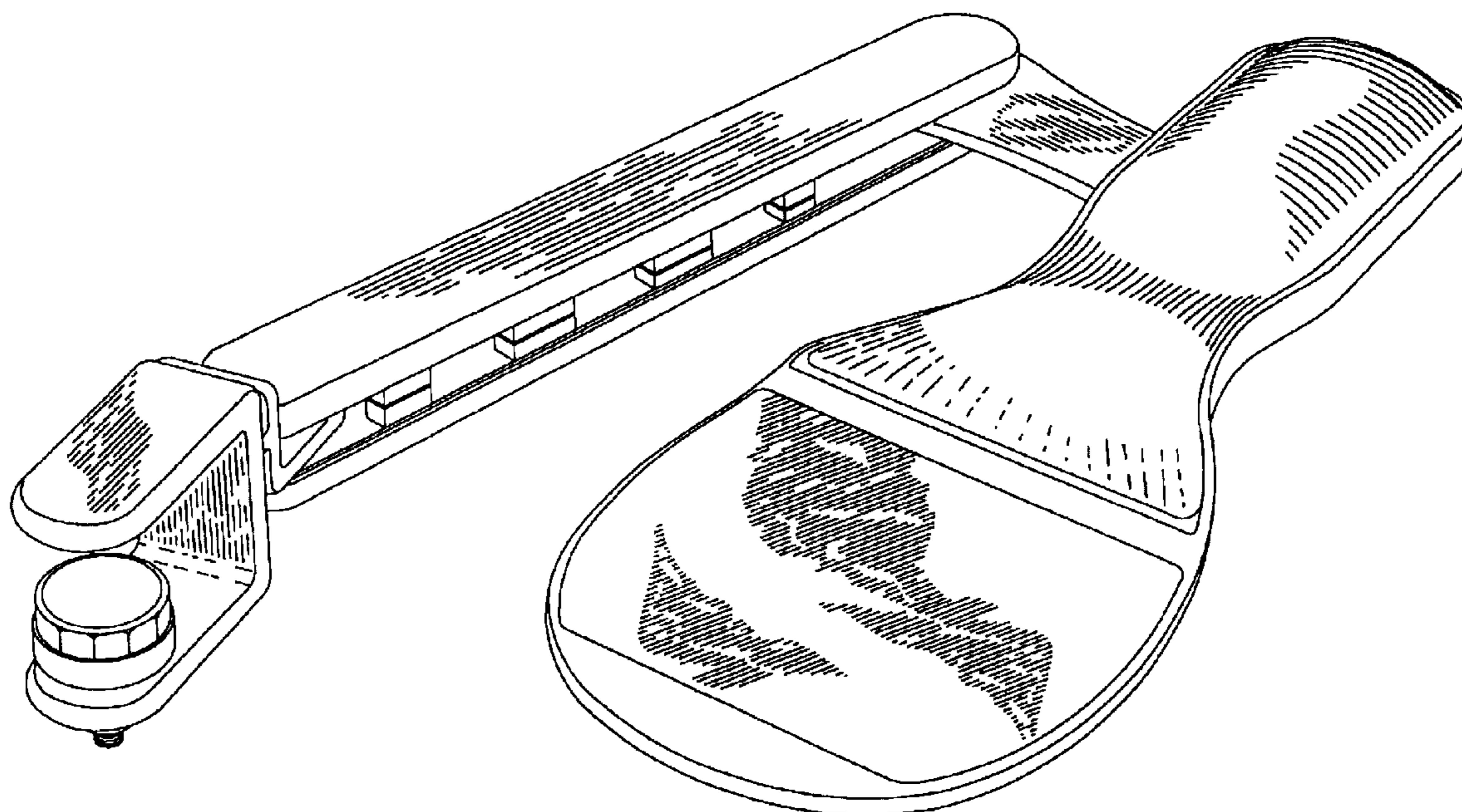
The ornamental design for a portable arm and mouse support, as shown and described.

DESCRIPTION

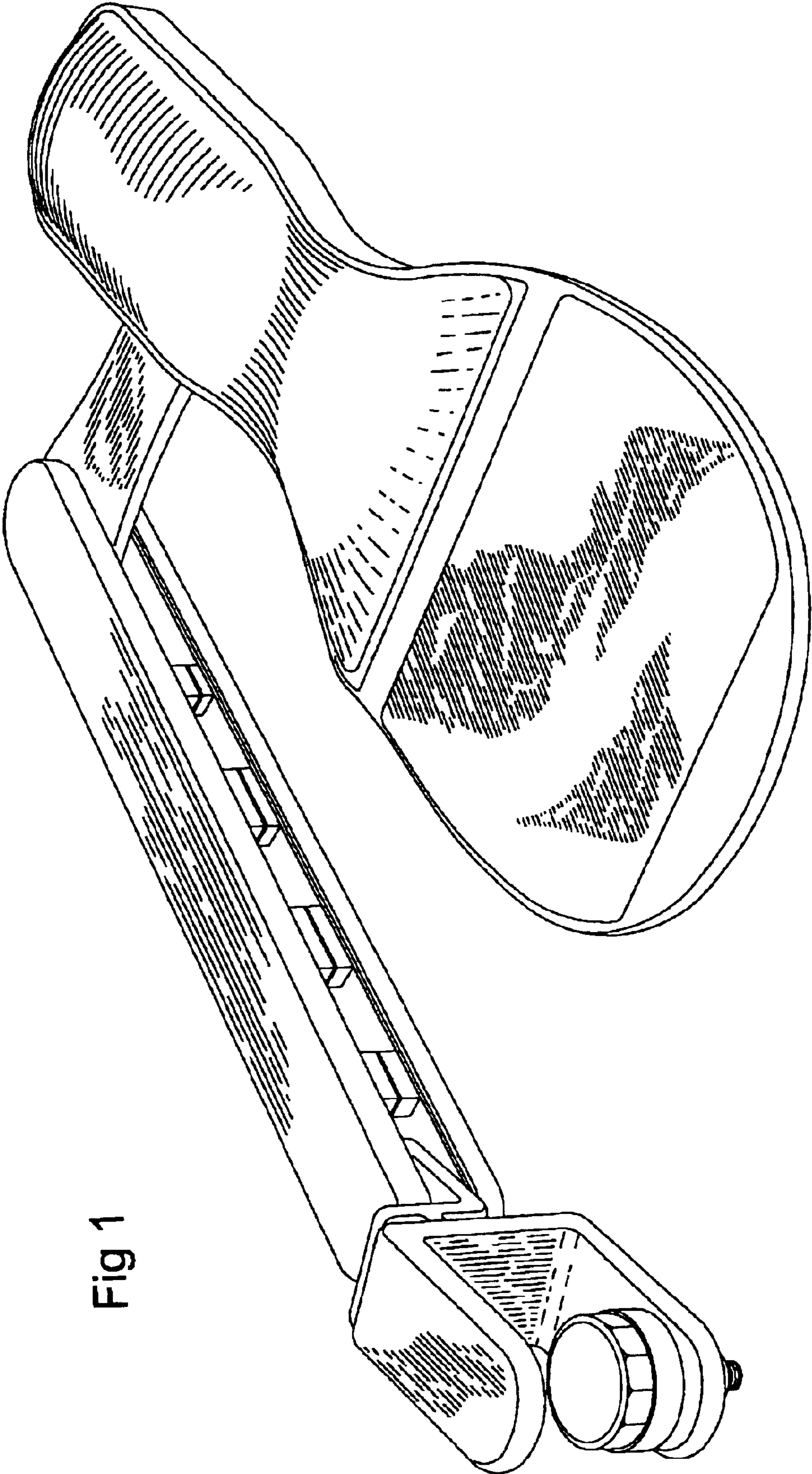

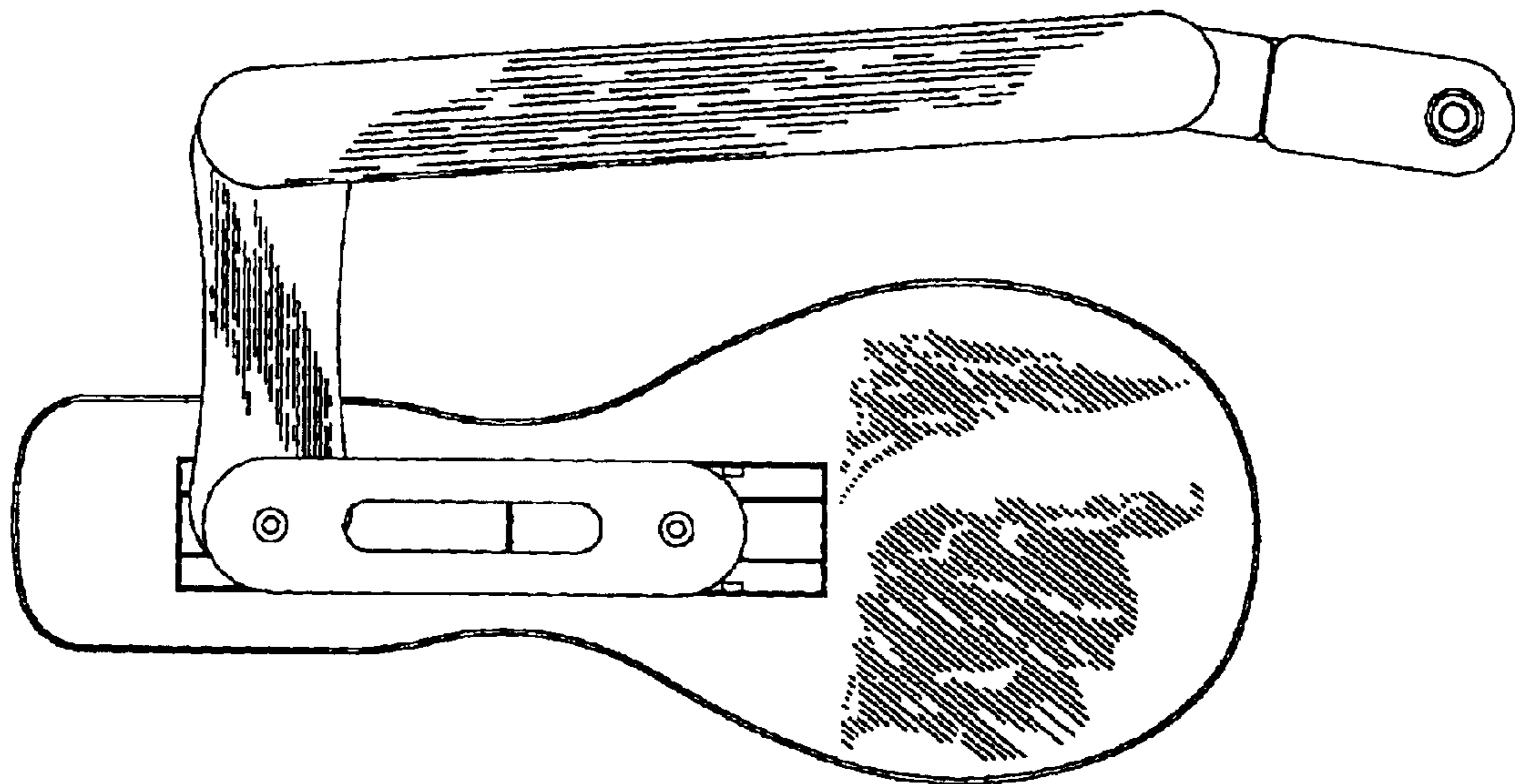
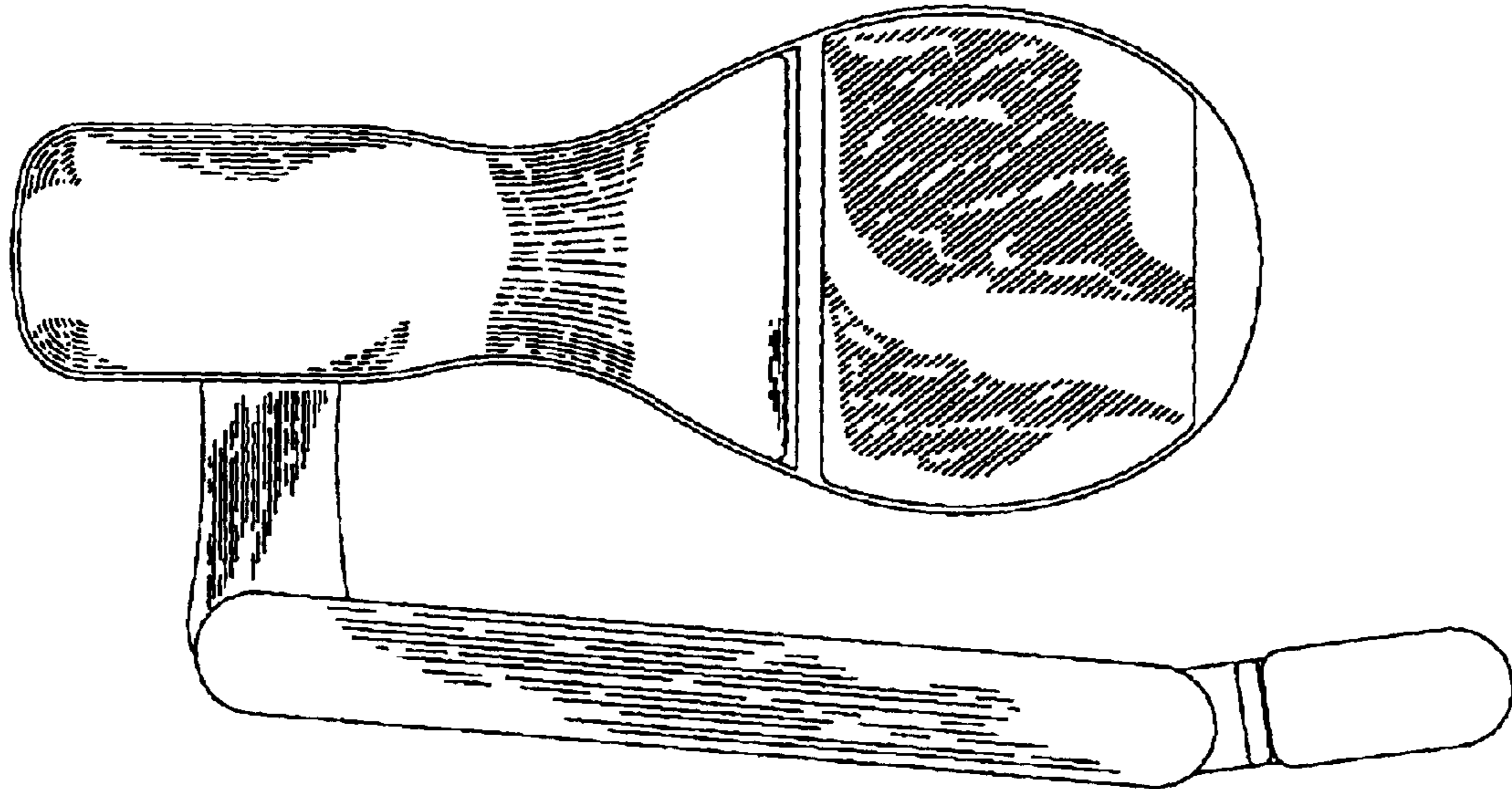

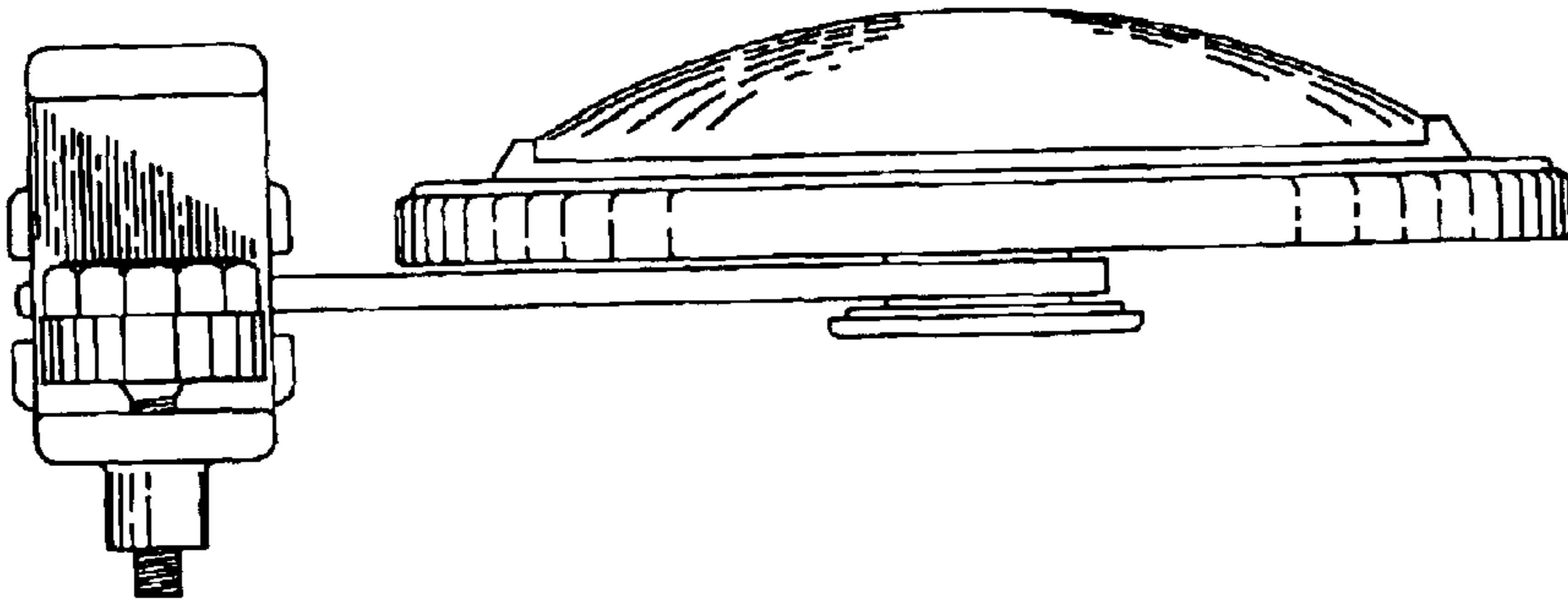

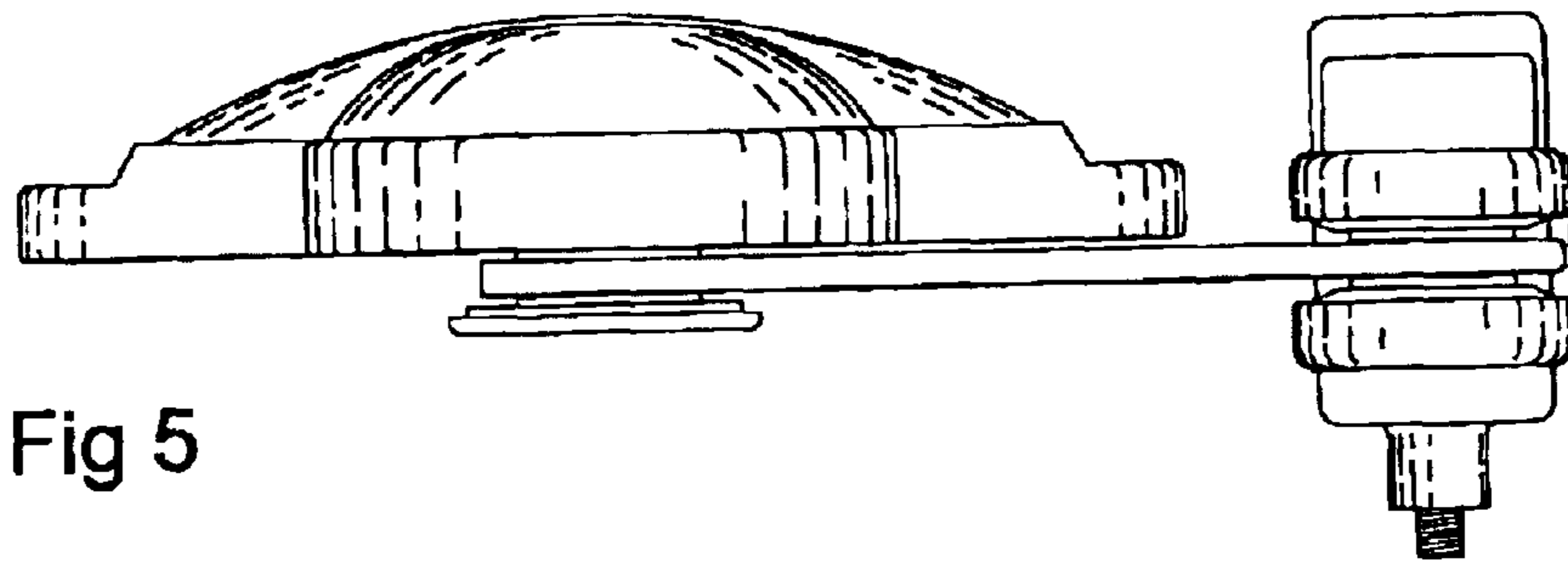

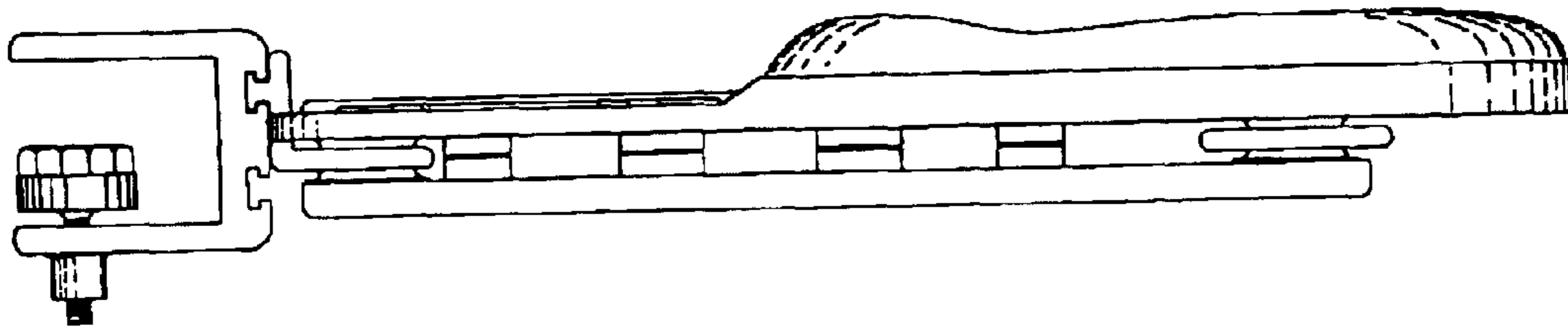
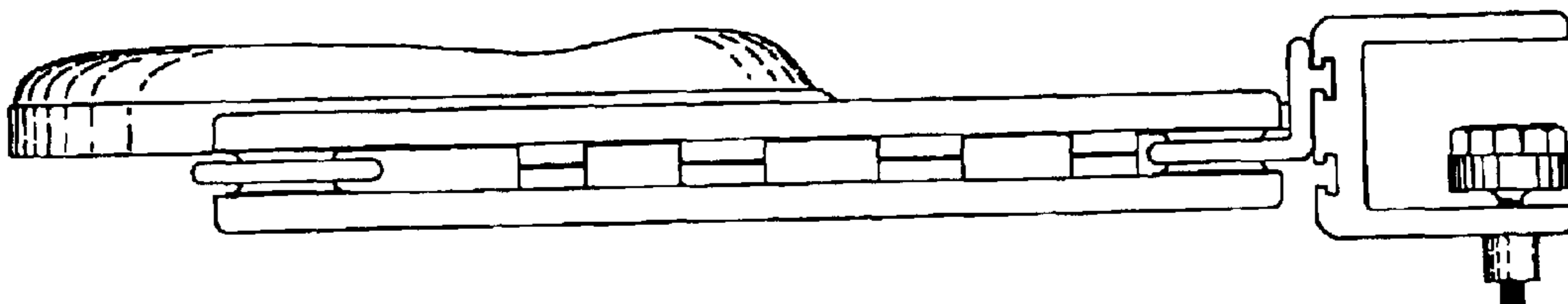

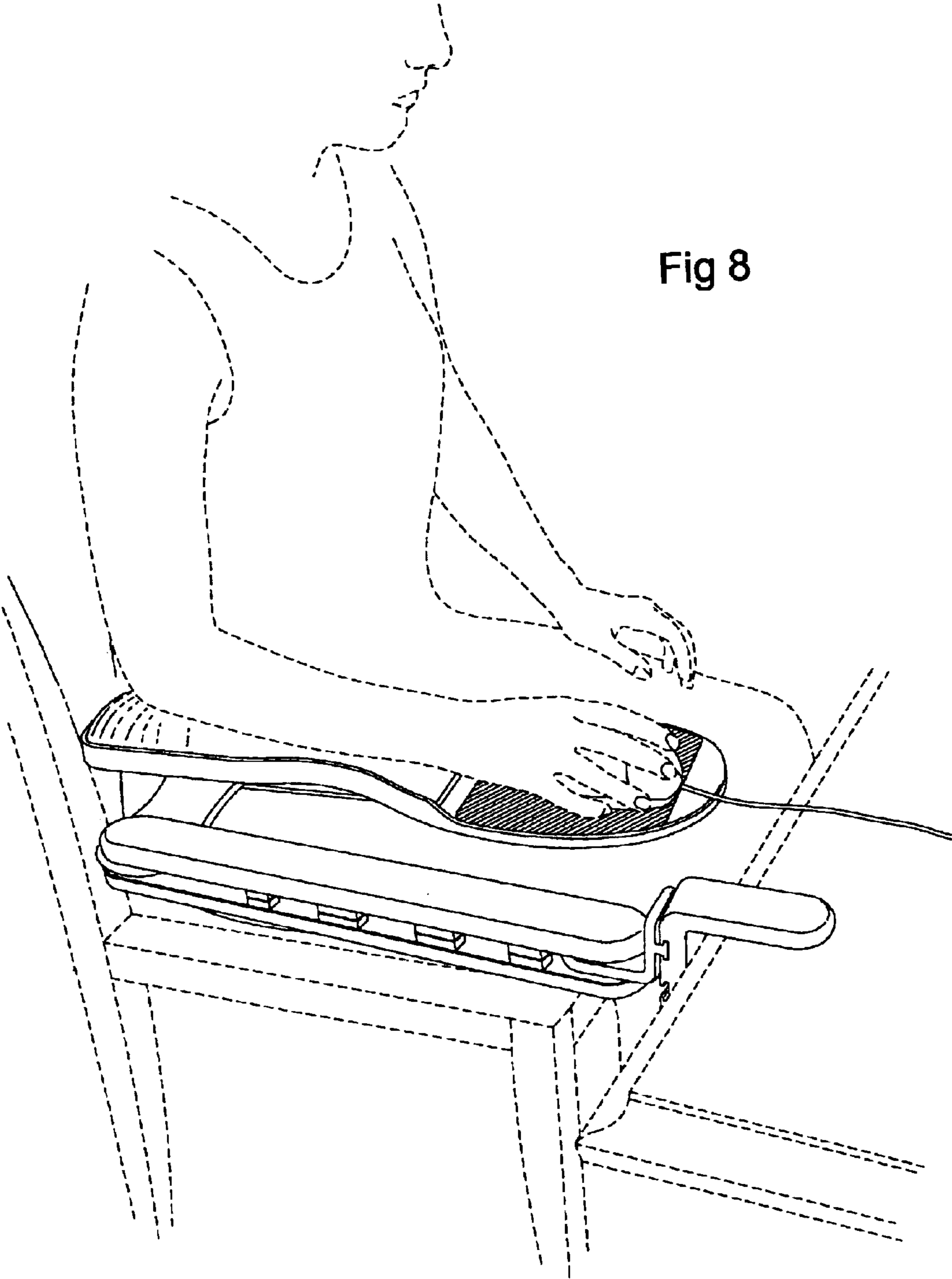
