The ornamental design for a “clip for a writing instrument,”
as shown and described.

DESCRIPTION

FIG. 1 is a perspective view taken from the front and left
side showing our new design;

FIG. 2 is a perspective view taken from the front and right
side thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a right side elevational view, the left side eleva-
tional view being a mirror image thereof;

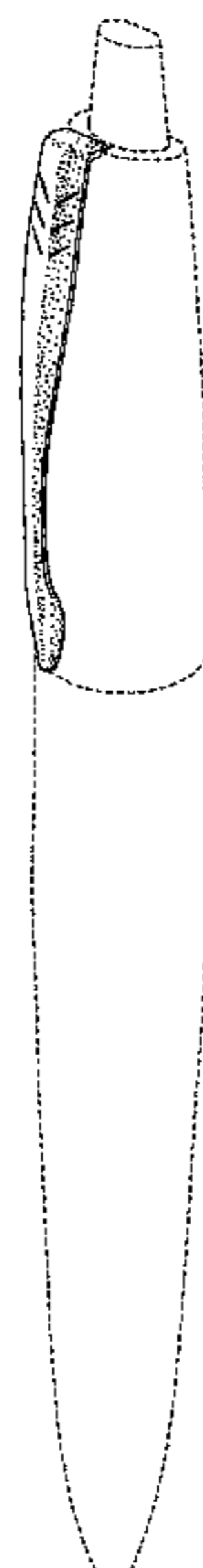
FIG. 5 is a perspective view taken from the front and right
side thereof;

FIG. 6 is a perspective view taken from front and left side
thereof; and,

FIG. 7 is a perspective view taken from the rear thereof.

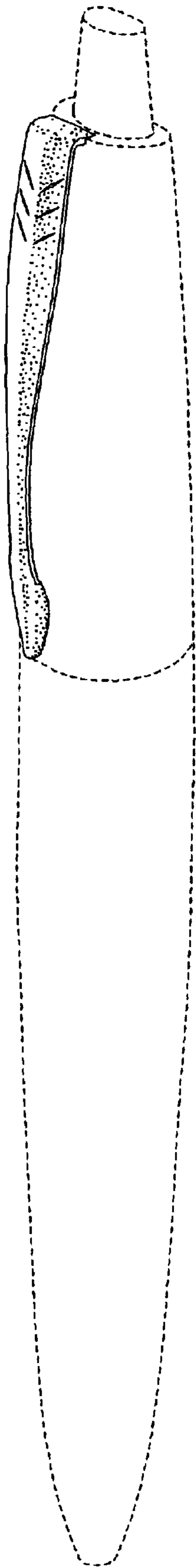

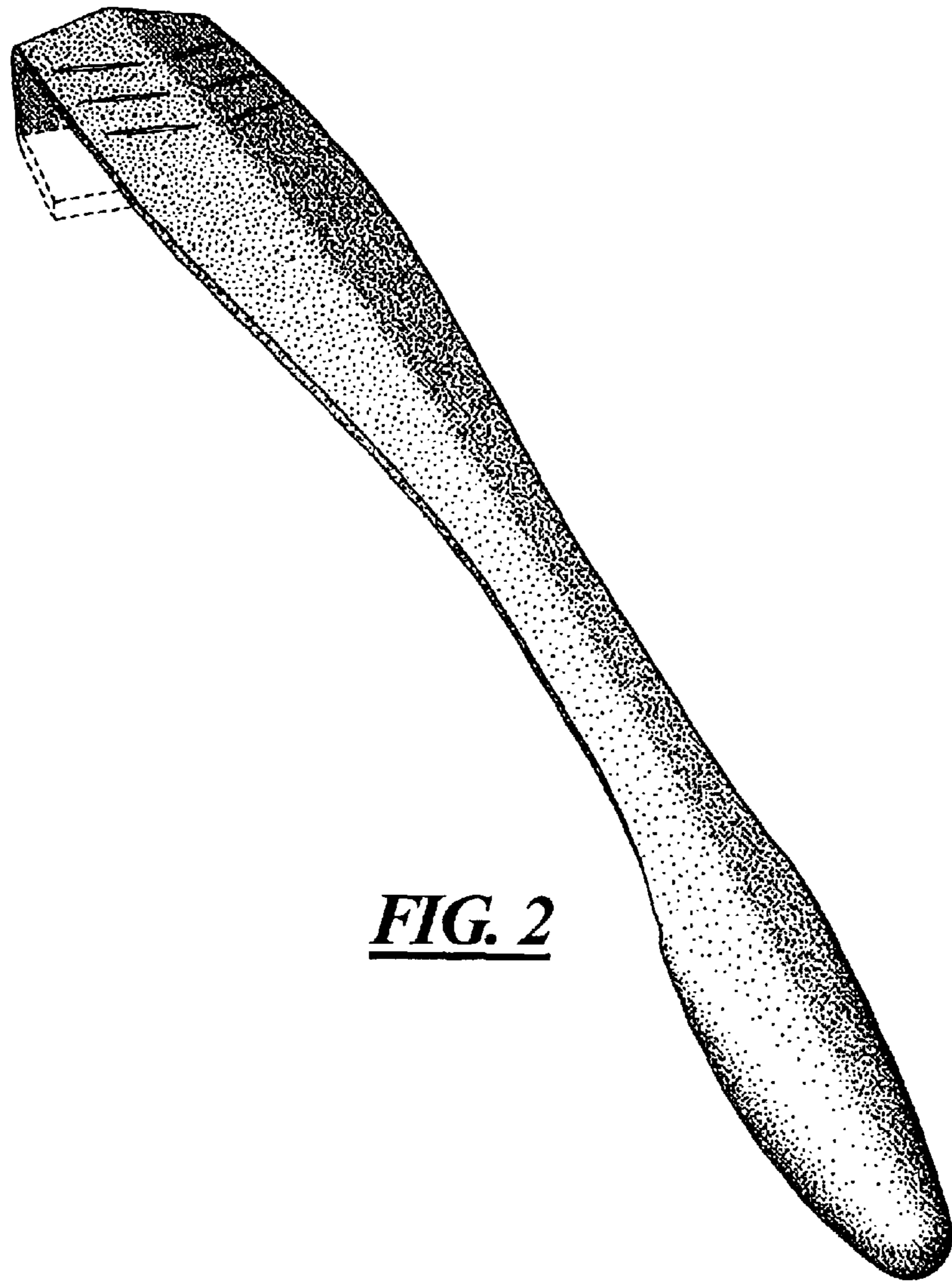

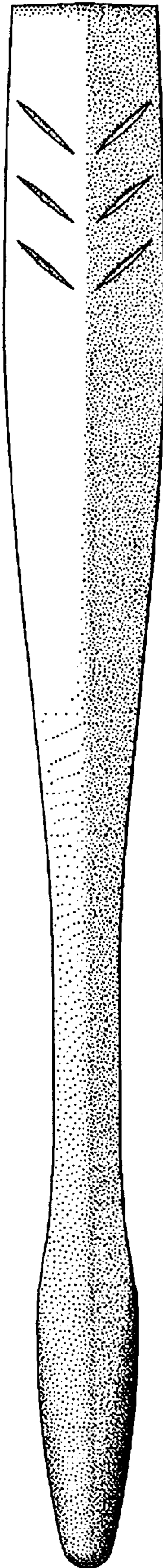
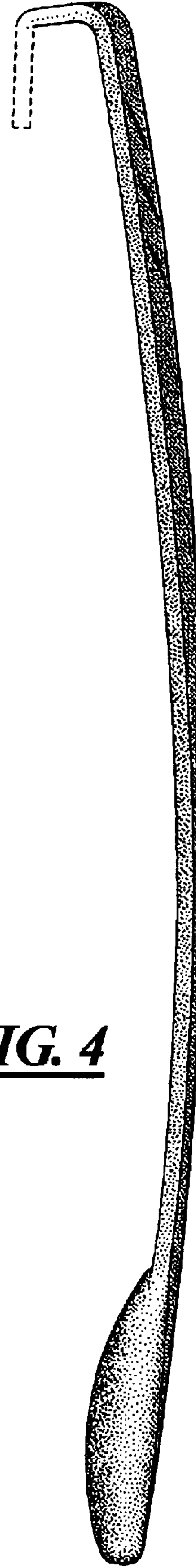

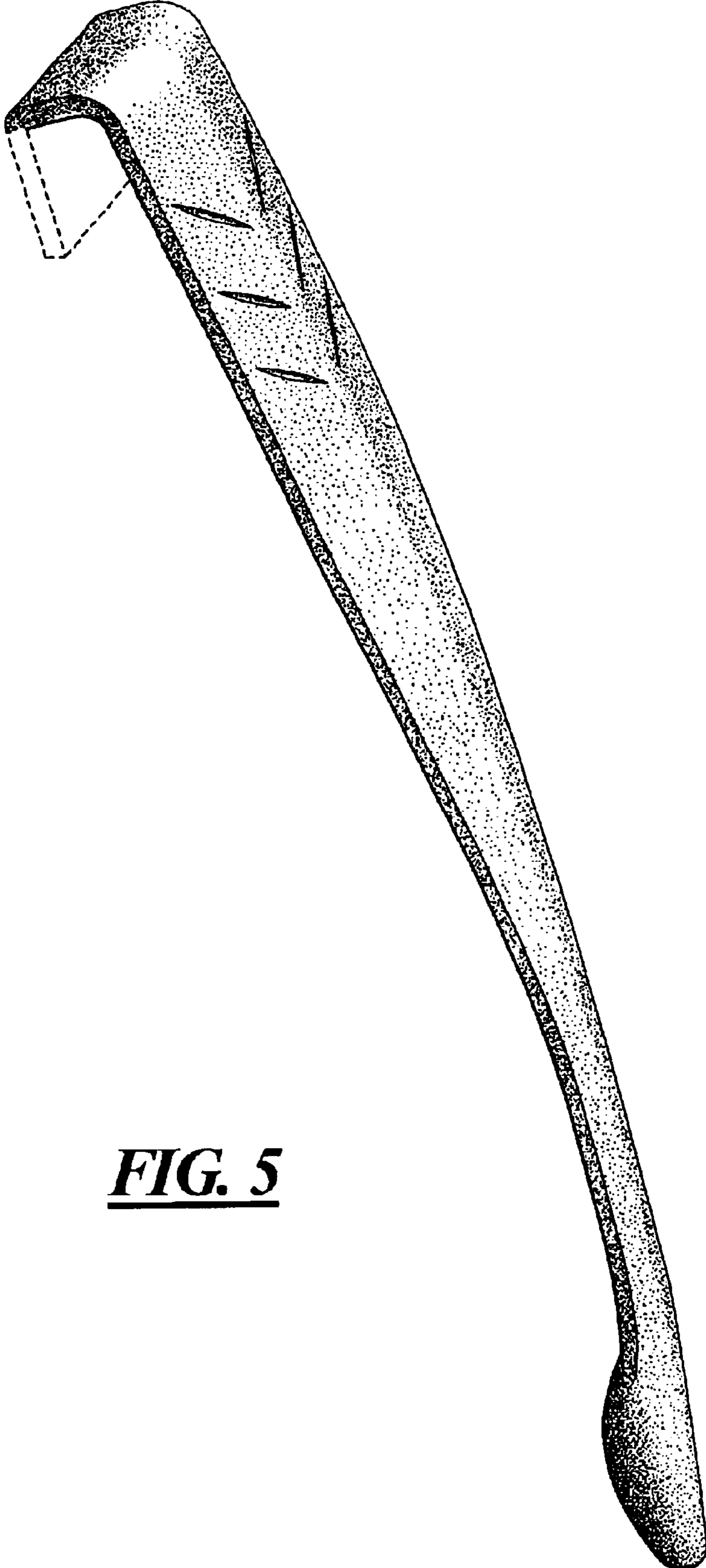

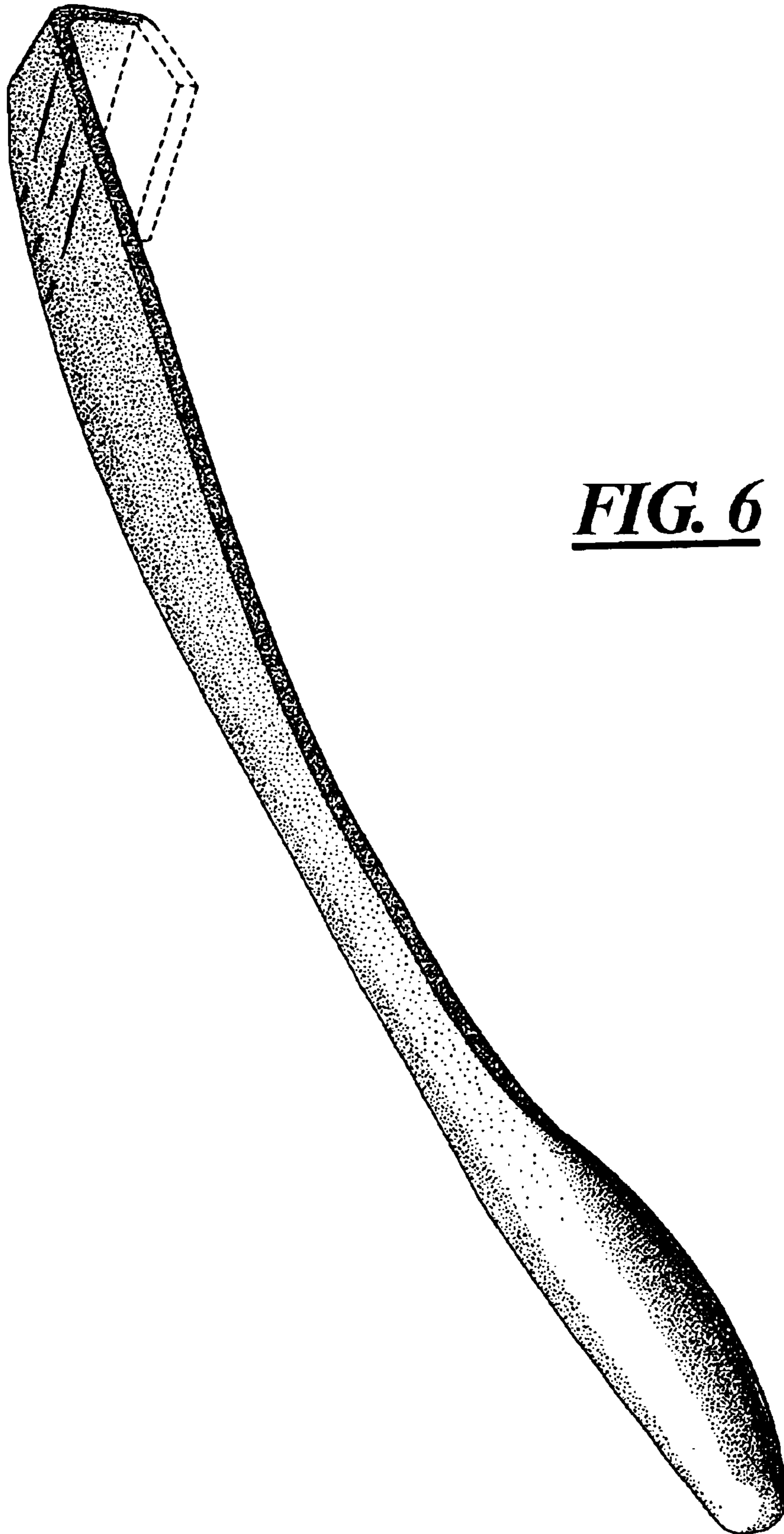

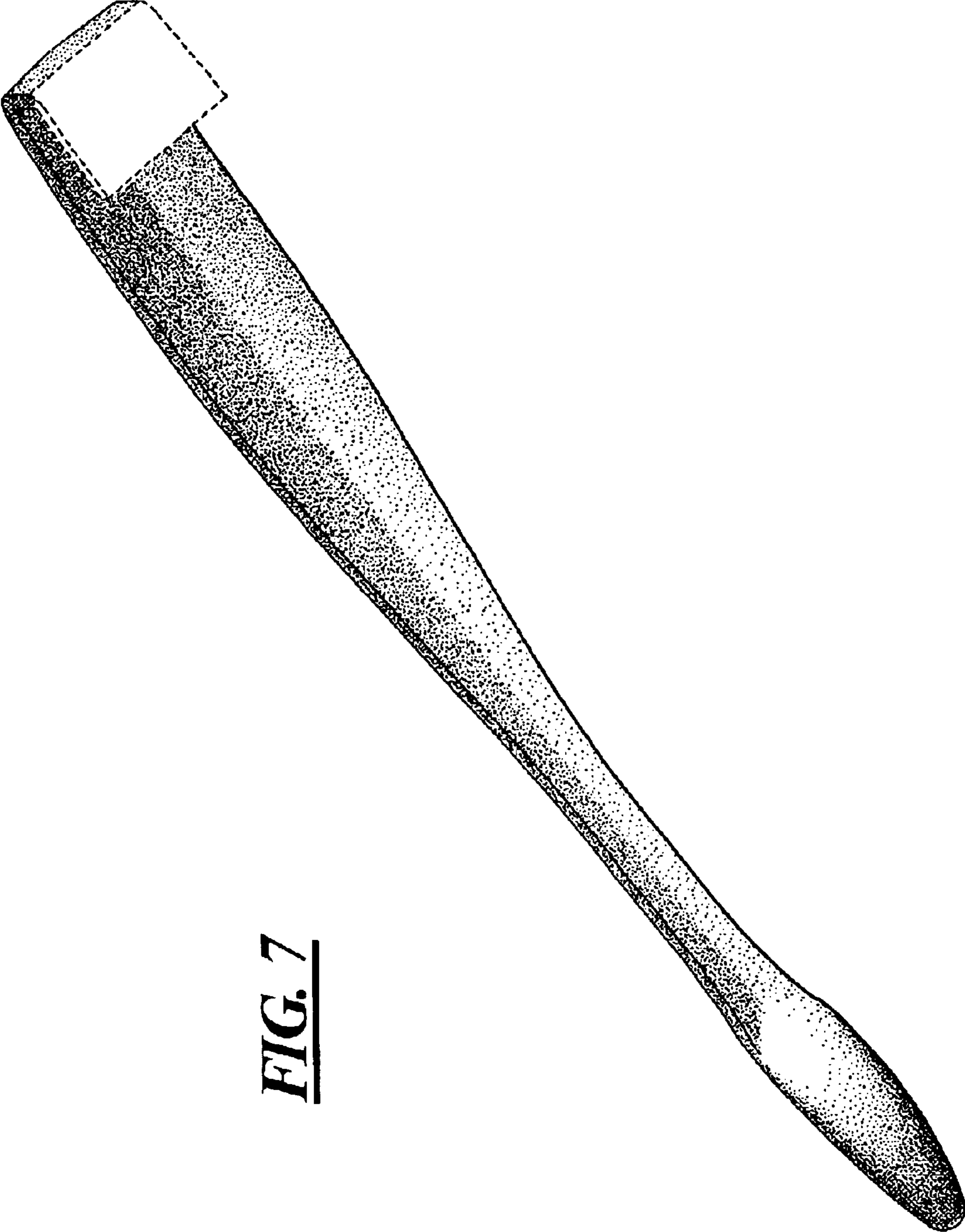
