(57)**CLAIM**

The ornamental design for a housing for electronic device, as shown and described.

DESCRIPTION

FIG. 1 is a view in perspective showing the top portion of a housing embodying the ornamental design of the present invention.

FIG. 2 is a bottom view of the housing shown in FIG. 1.

FIG. 3 is a side view of the housing shown in FIG. 1.

FIG. 4 is another side view of the housing shown in FIG. 1, taken at ninety degrees to the side view of FIG. 3.

FIG. 5 is a top view of the housing shown in FIG. 1.

FIG. 6 is a view in perspective showing the bottom portion of the housing shown in FIG. 1.

FIG. 7 is a view in perspective showing the top portion of a second form of housing embodying the ornamental design of the present invention.

FIG. 8 is a bottom view of the housing shown in FIG. 7.


FIG. 9 is a side view of the housing shown in FIG. 7.


FIG. 10 is another side view of the housing shown in FIG.
























