FIG. 2. Is a top plan view of thereof with the dotted lines showing for illustrative purposes only and to which no claim is made;

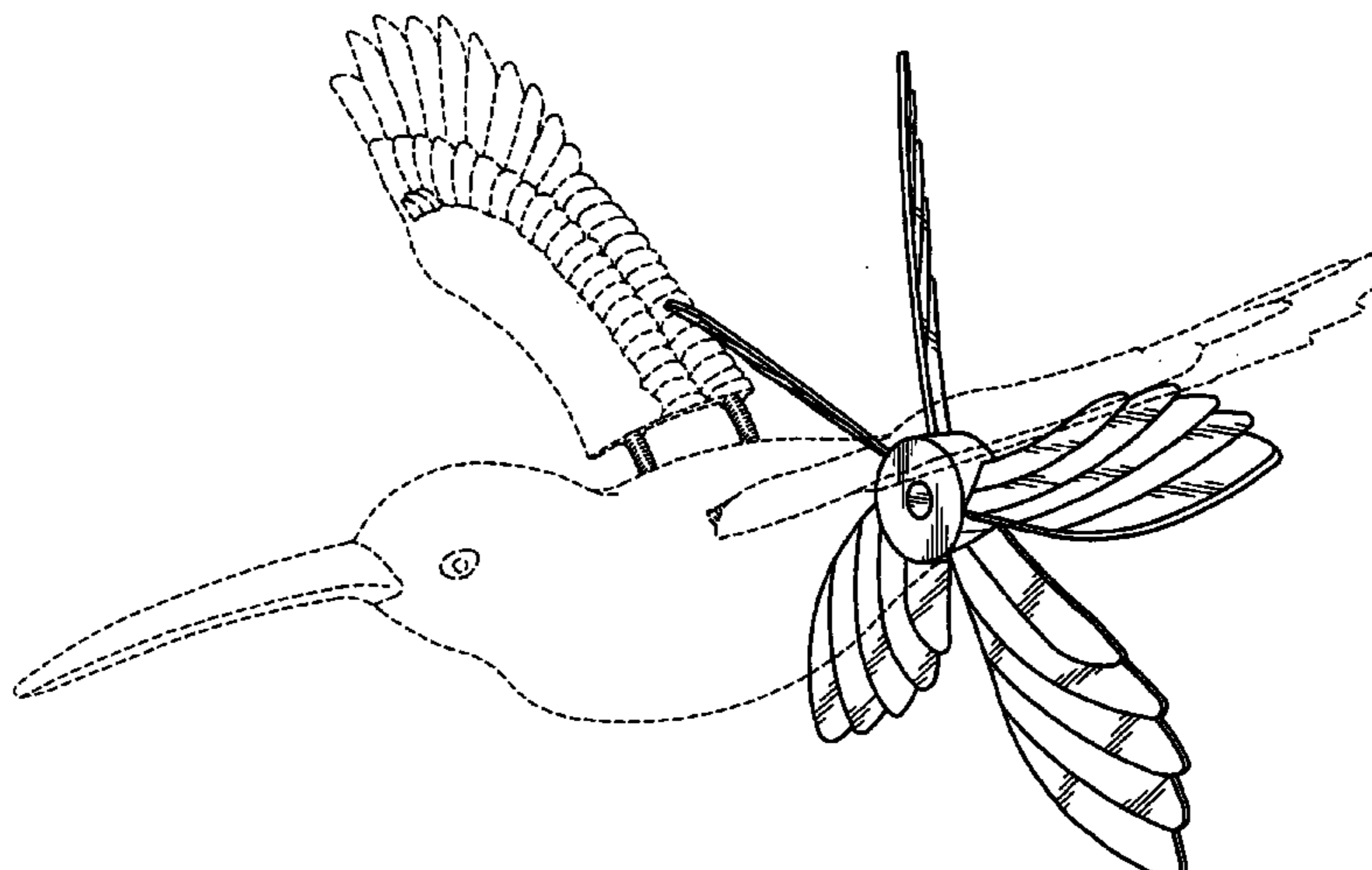
FIG. 3. Is a bottom plan thereof with the dotted lines showing for illustrative purposes only and to which no claim is made;

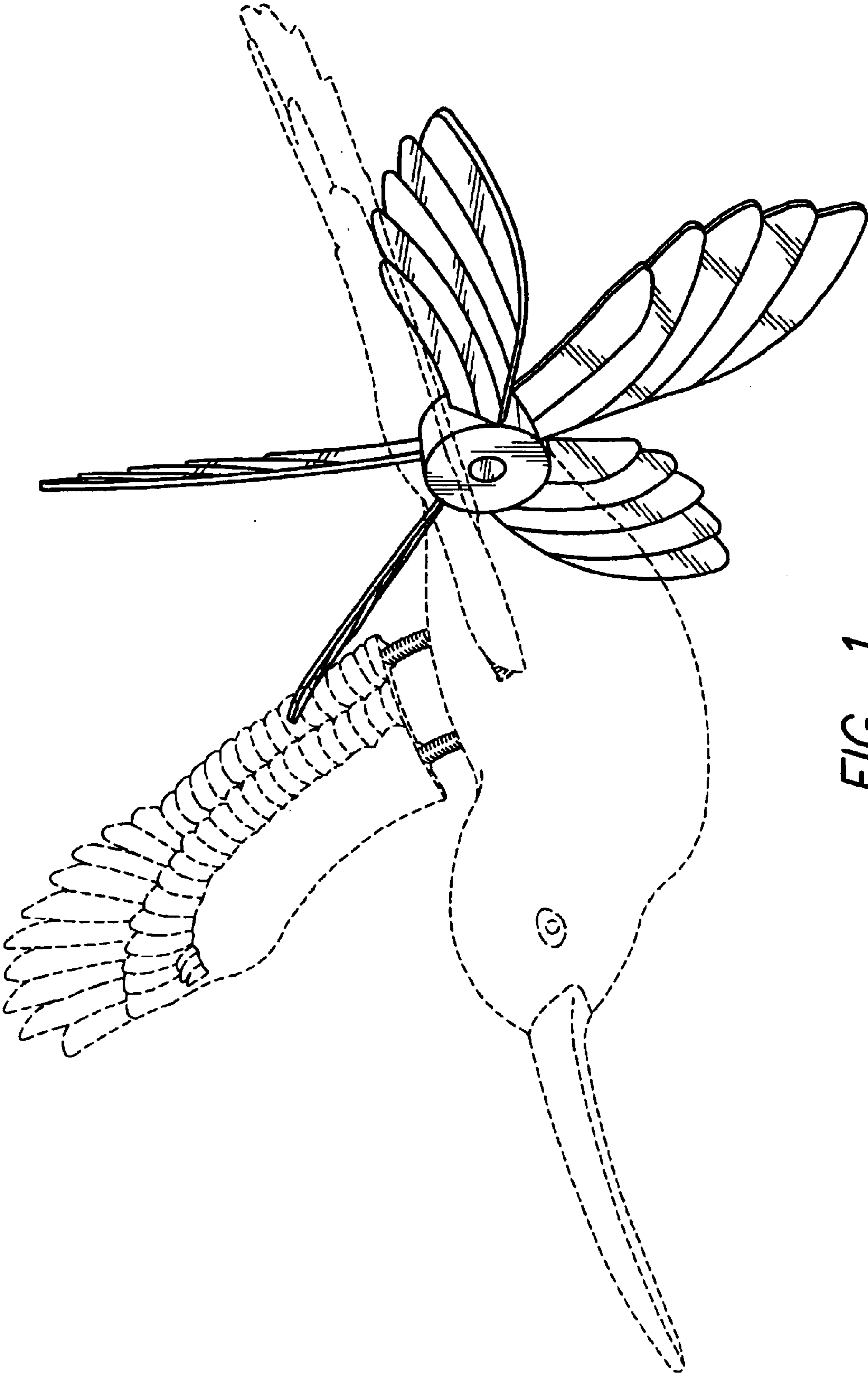

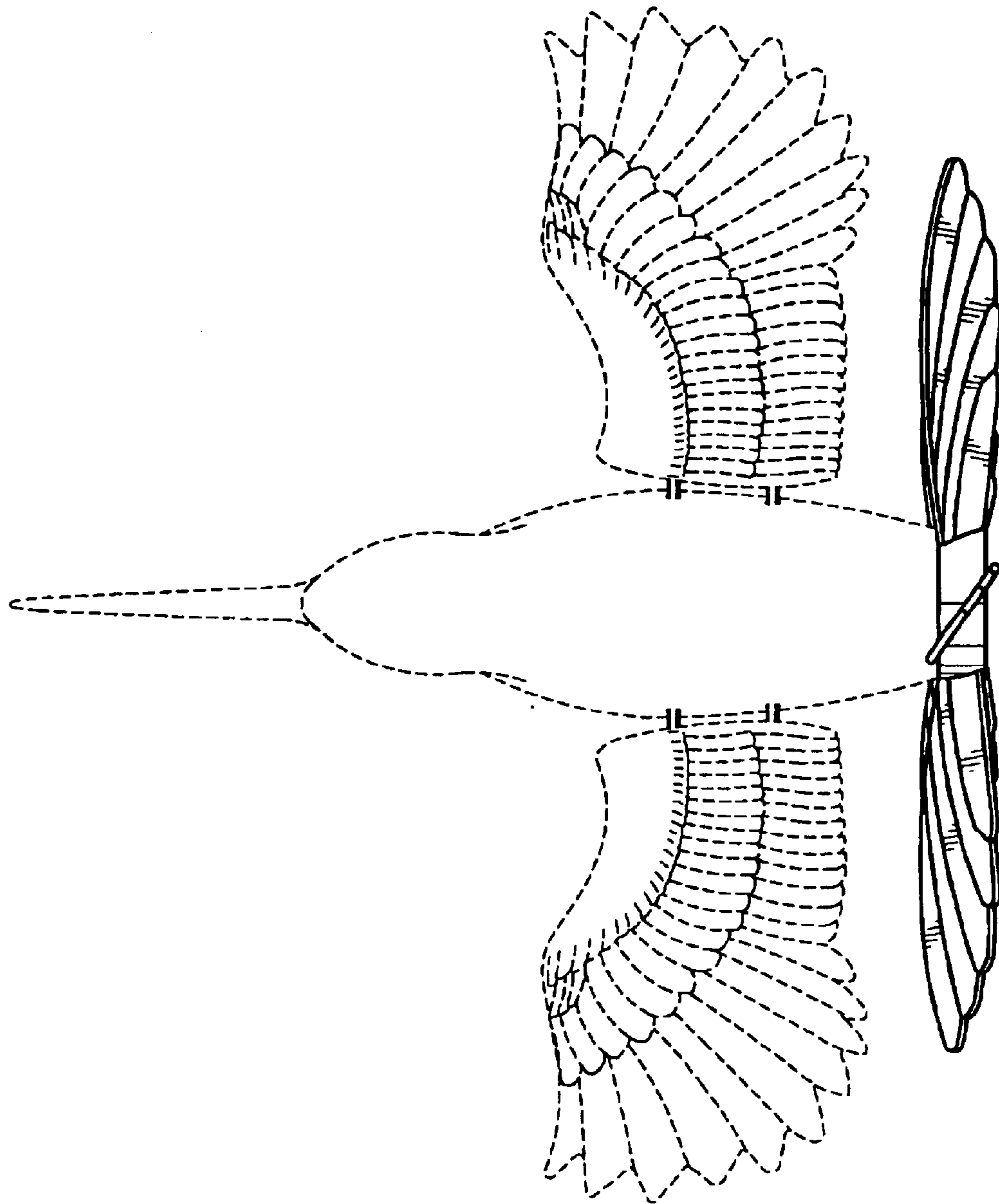

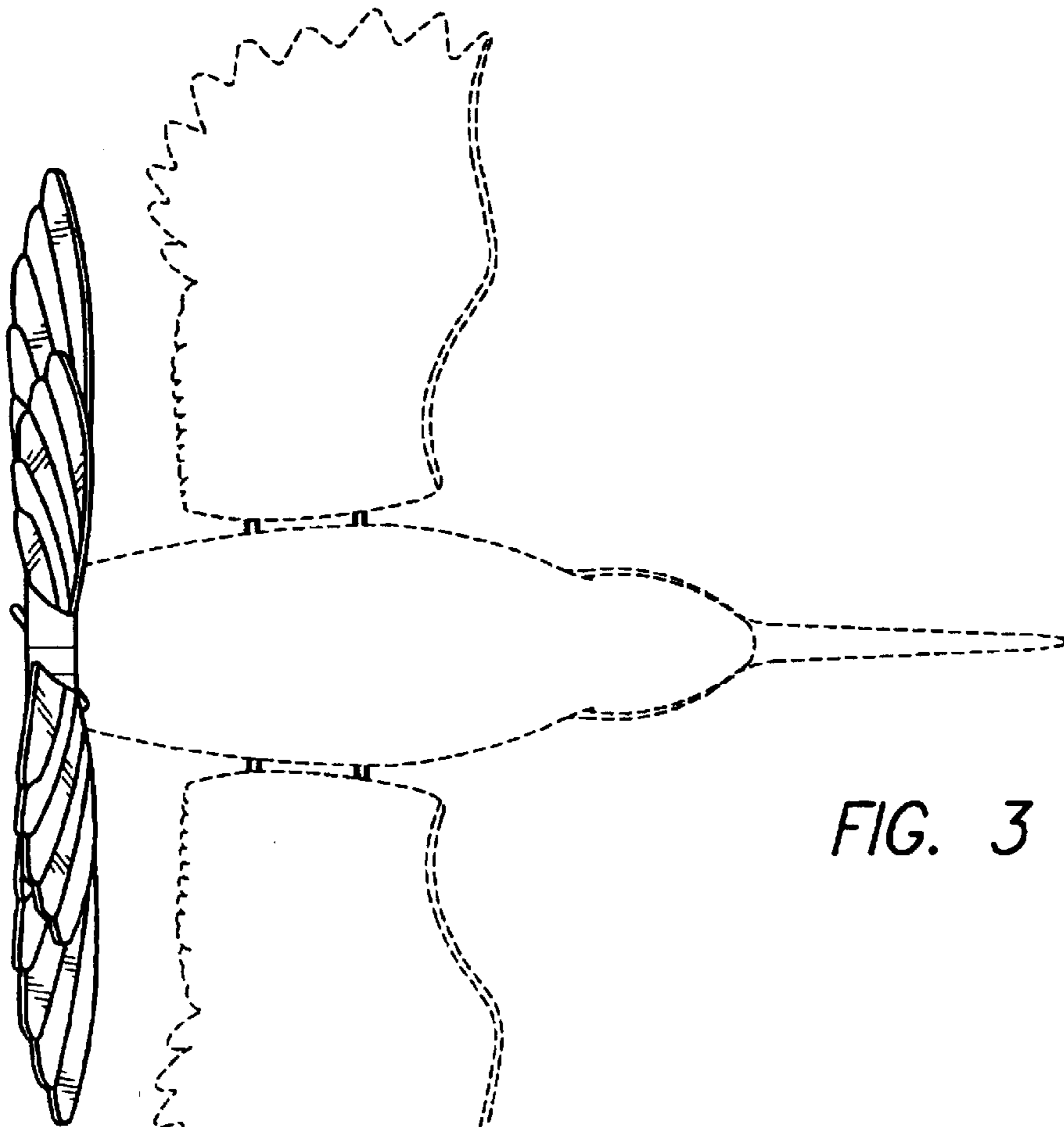

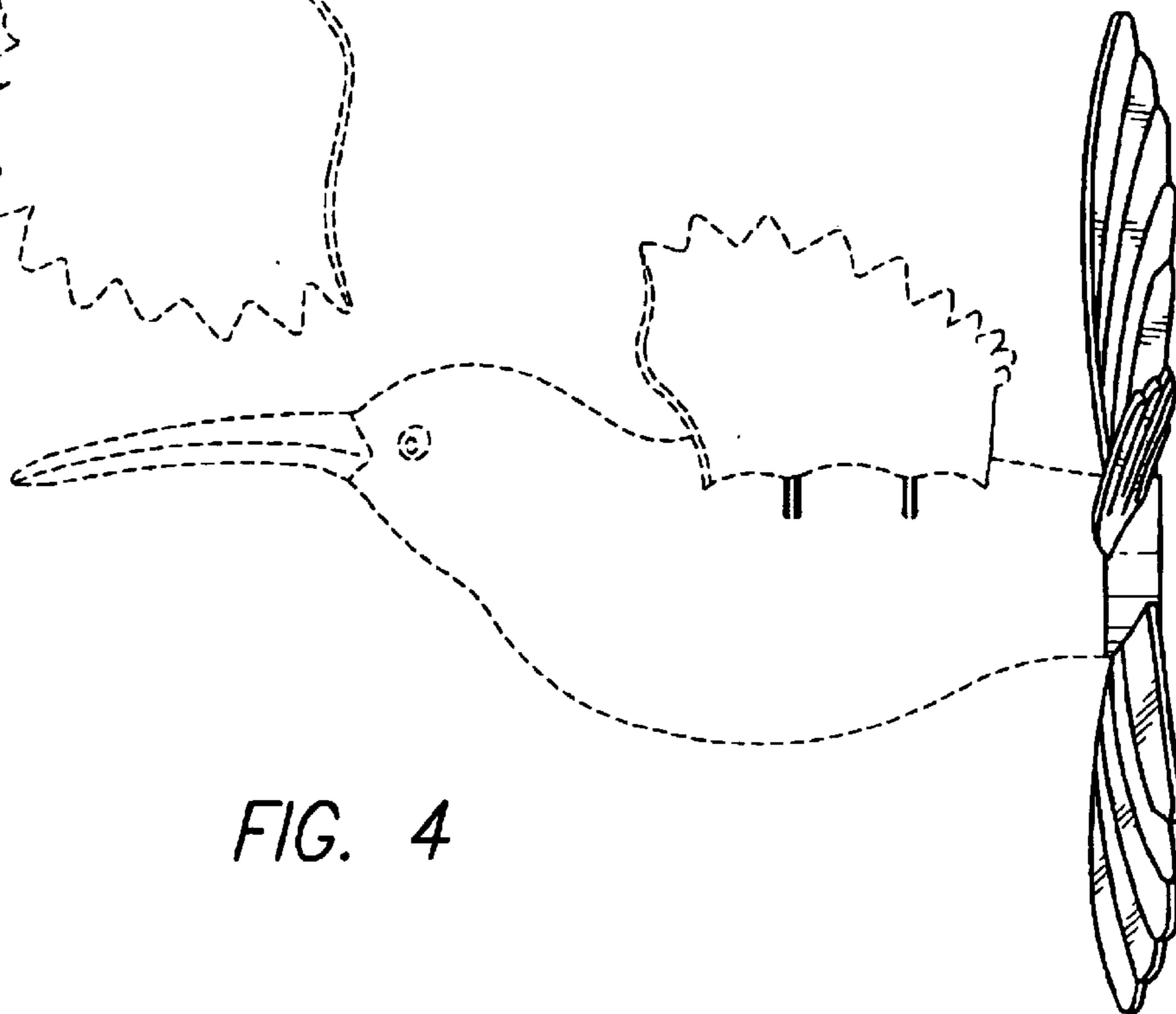

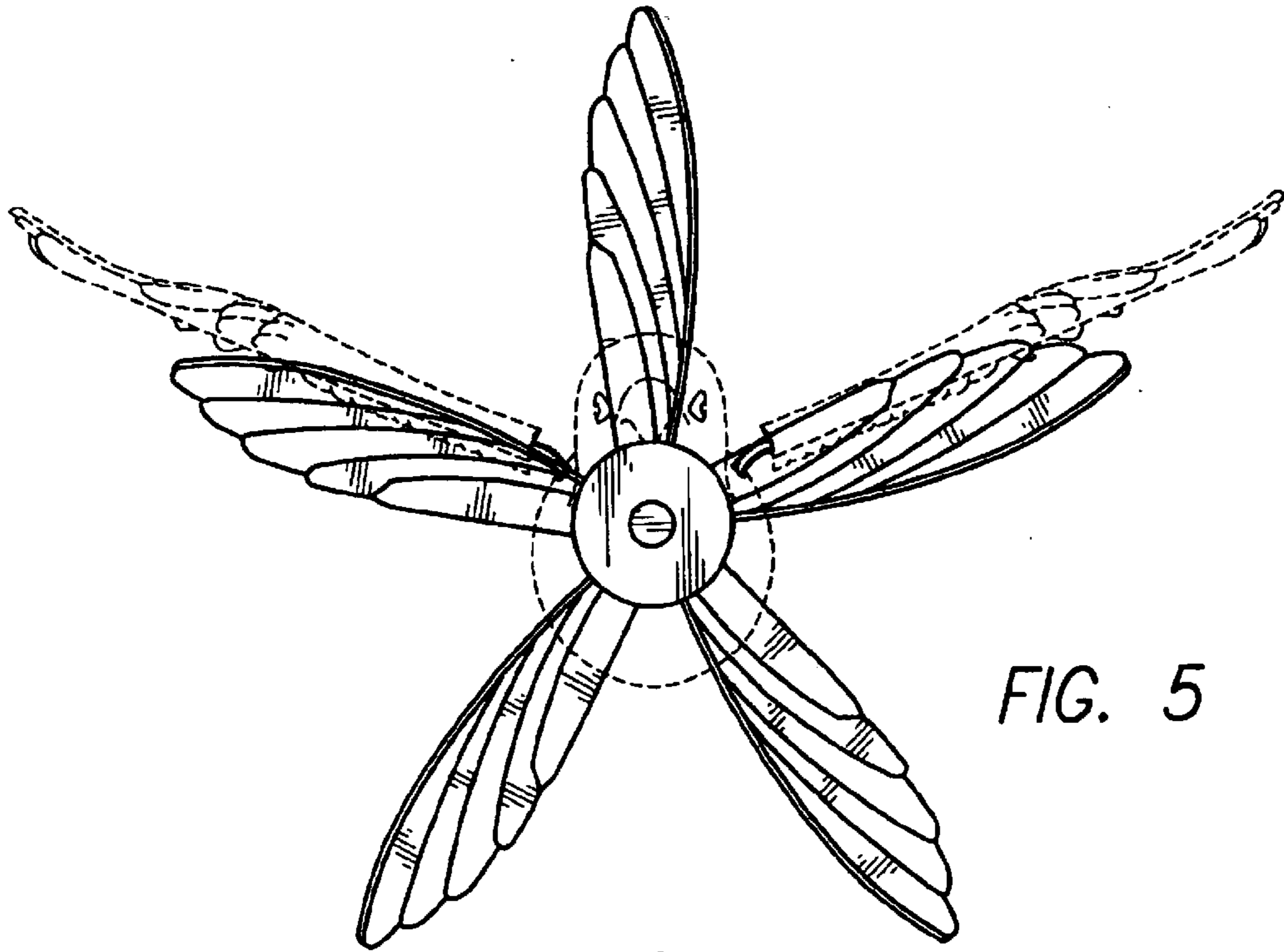

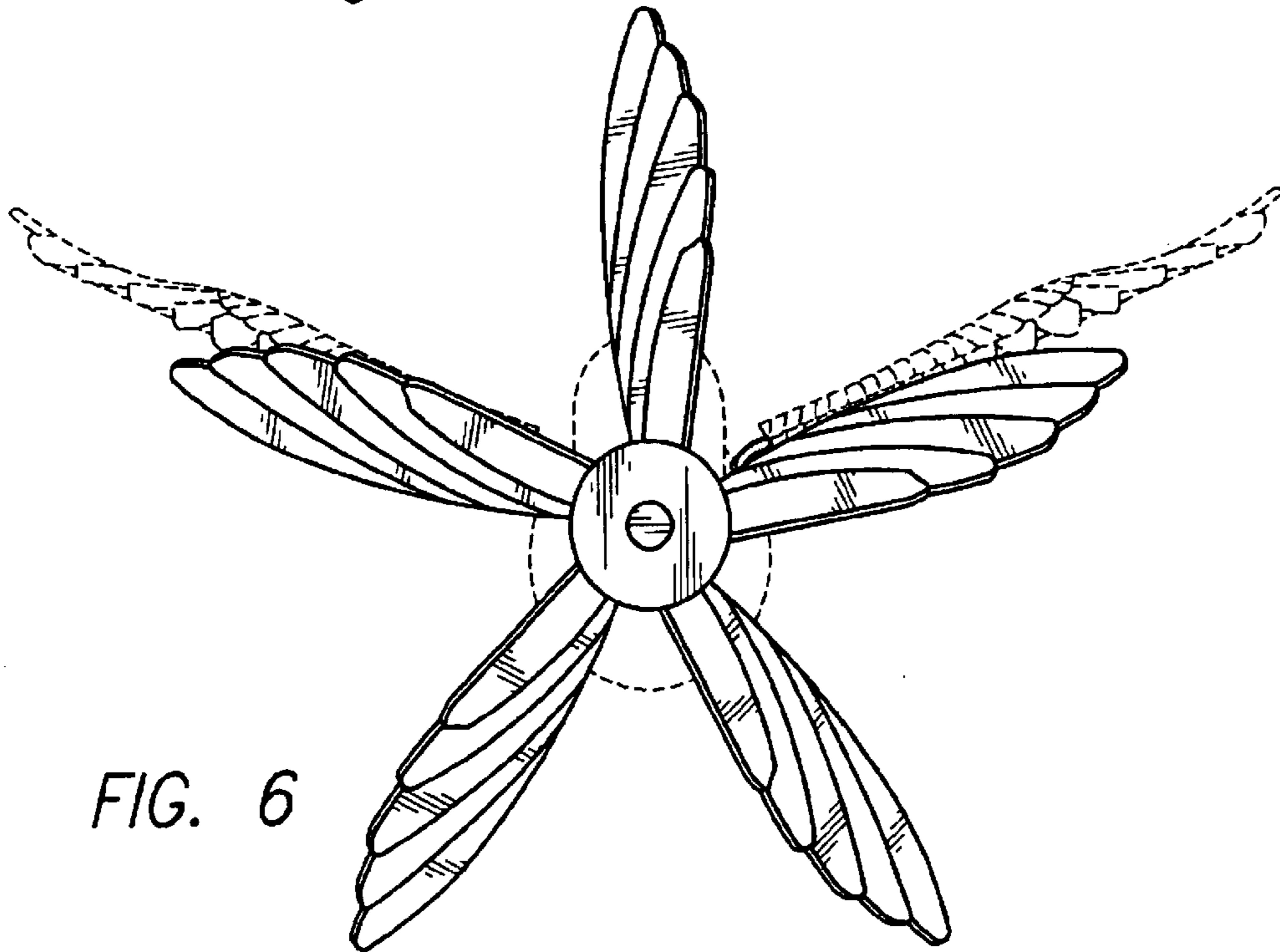
