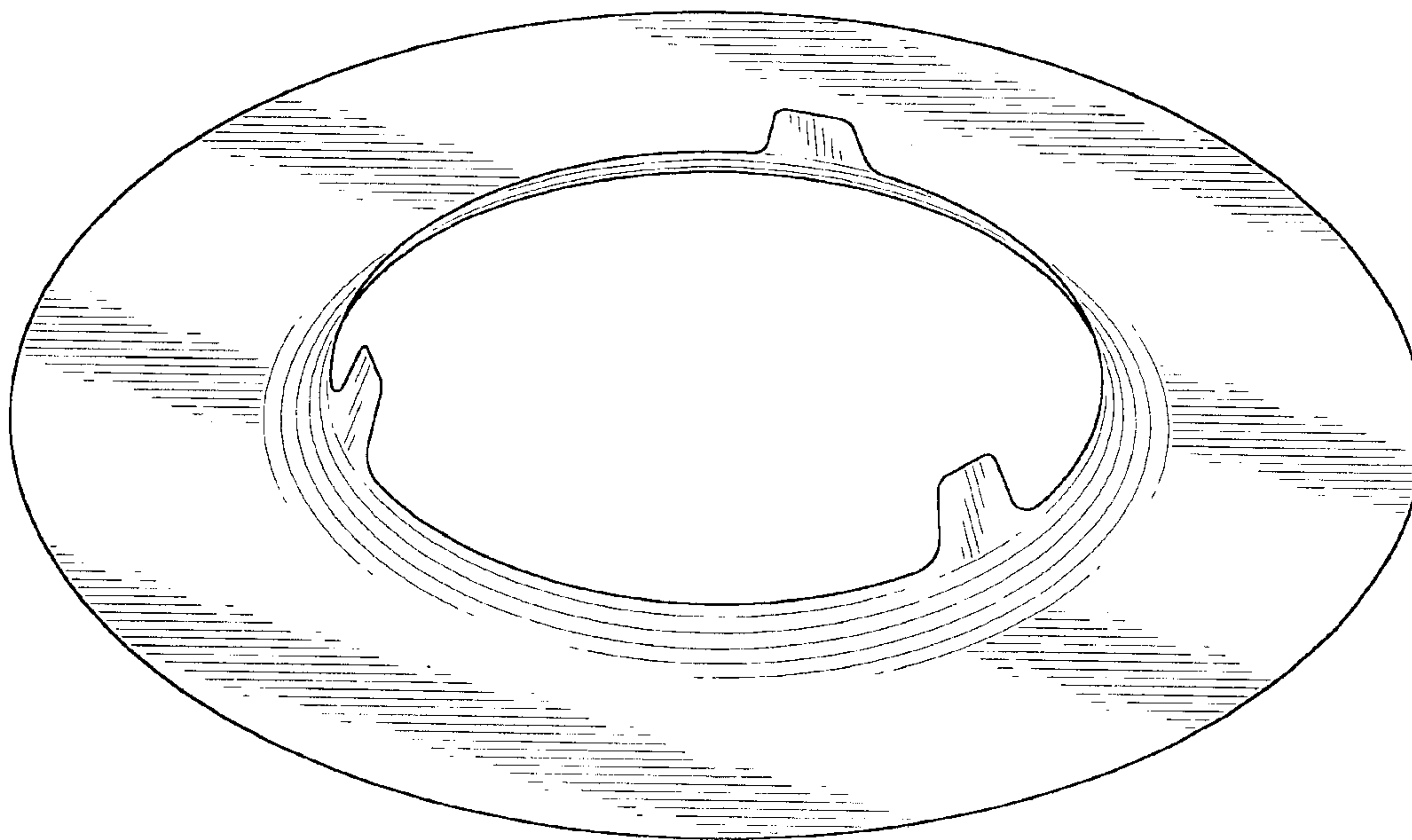
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of the support frame for round duct showing my new design.
 FIG. 2 is a top plan view of FIG. 1.
 FIG. 3 is a front elevation view of FIG. 1.
 FIG. 4 is a right side elevation view of FIG. 1; the left side being a mirror image thereof.
 FIG. 5 is a rear elevation view of FIG. 1; and,
 FIG. 6 is a bottom plan view of FIG. 1.

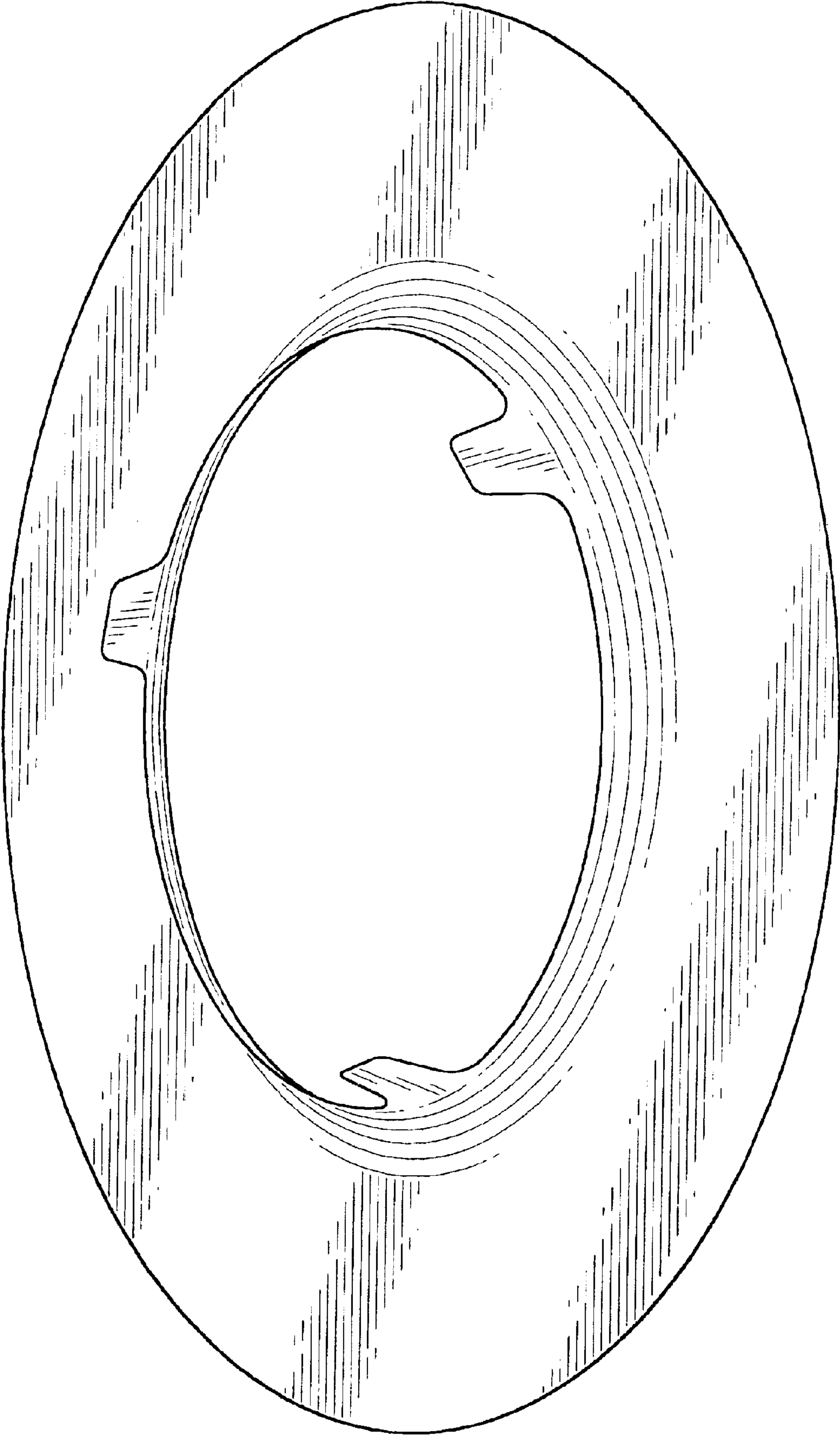

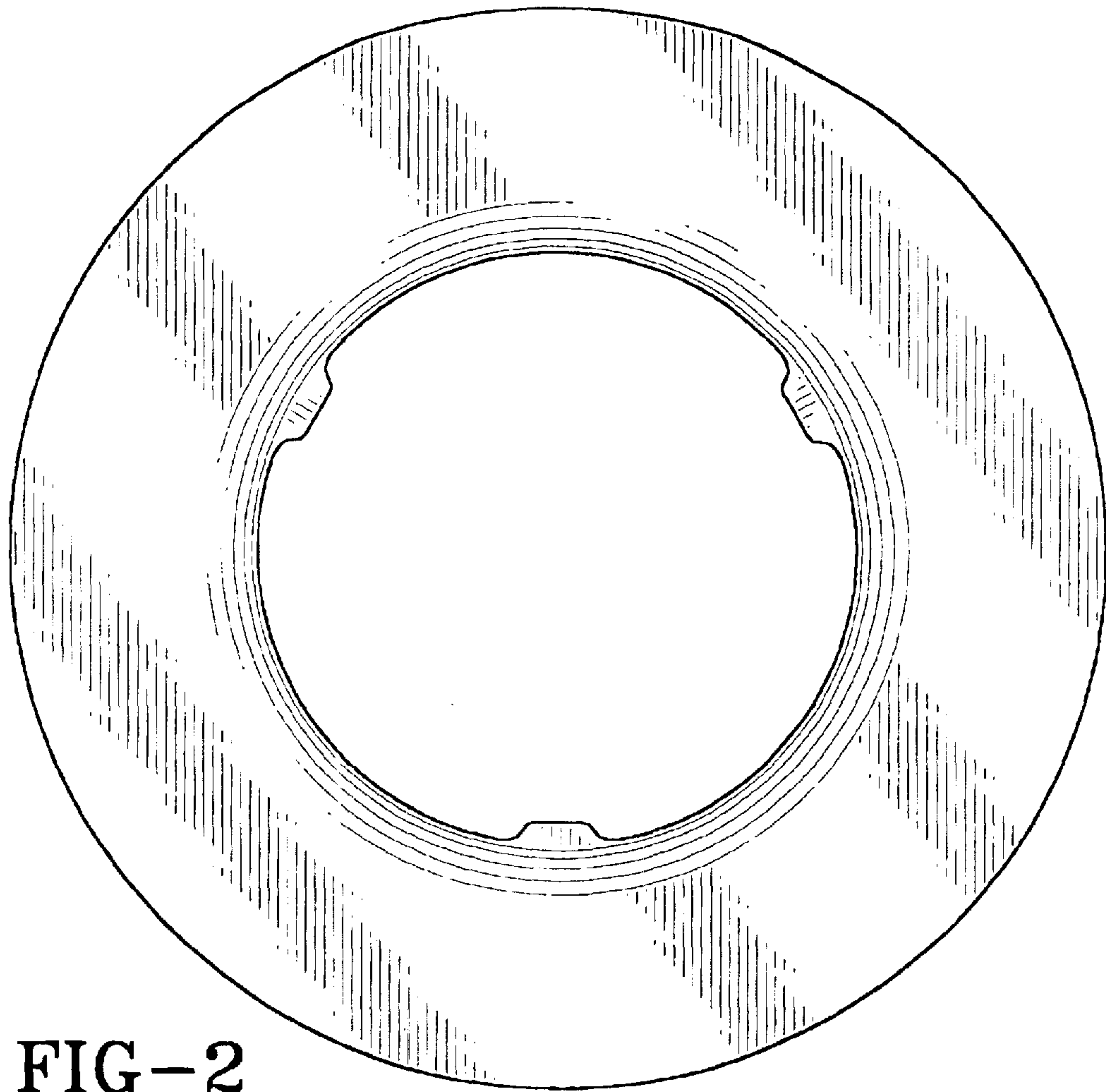

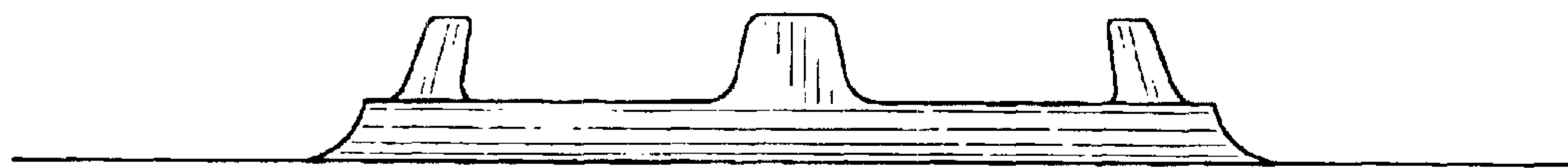

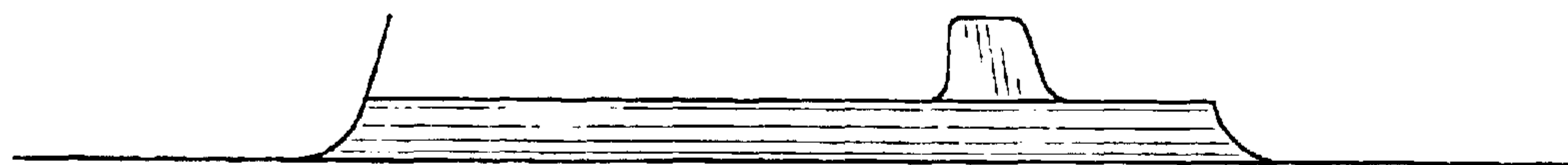

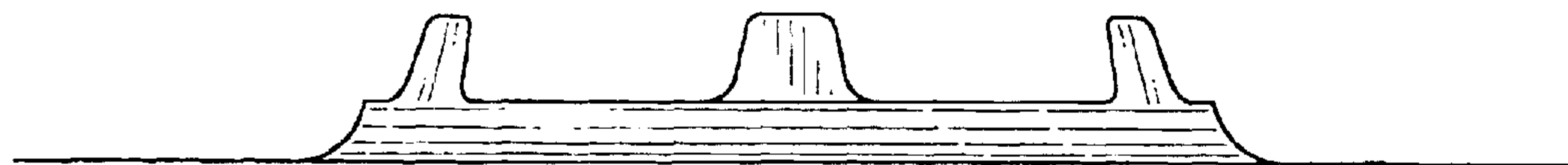

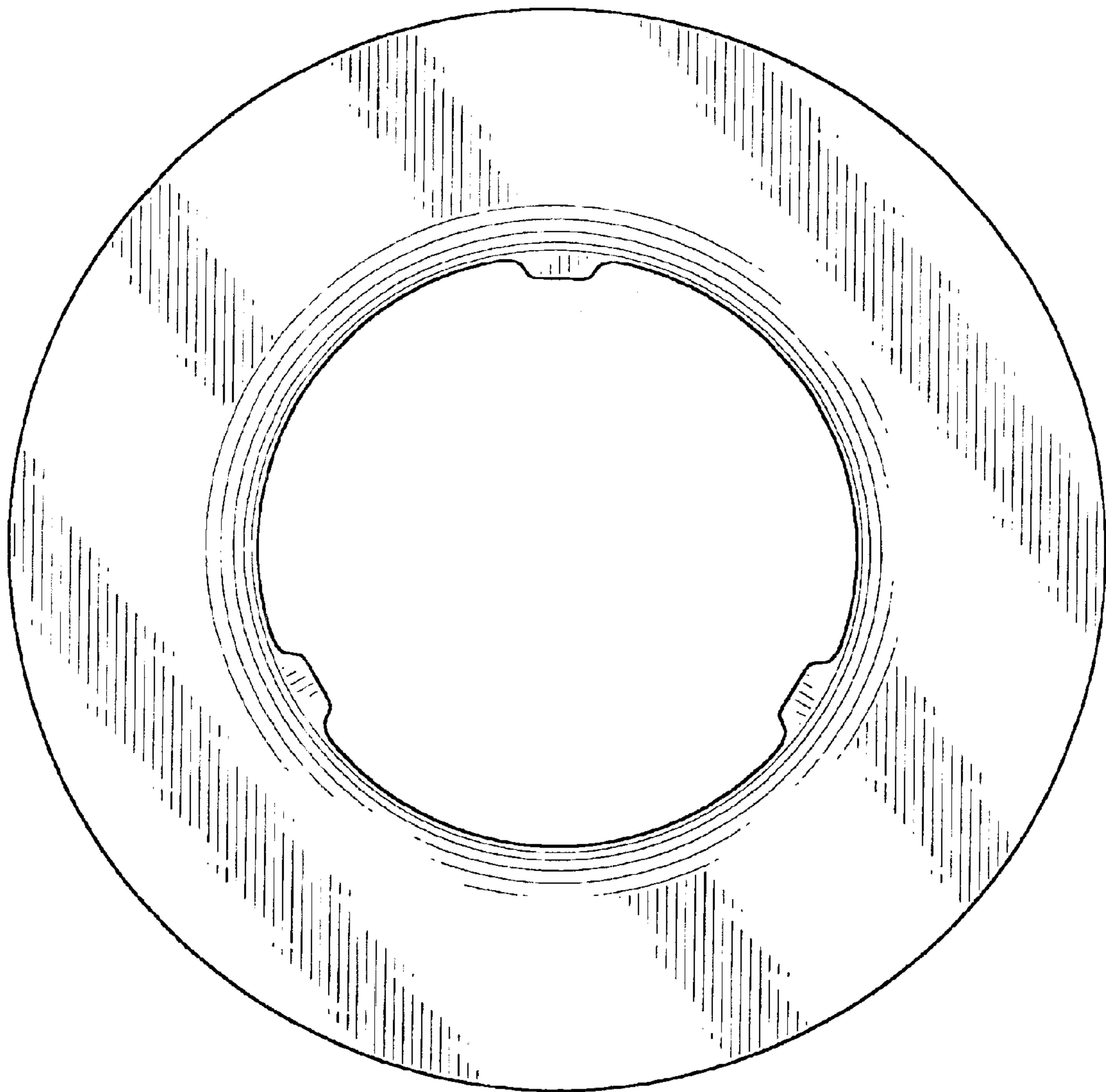
