FIG. 4 is a side view of the design.

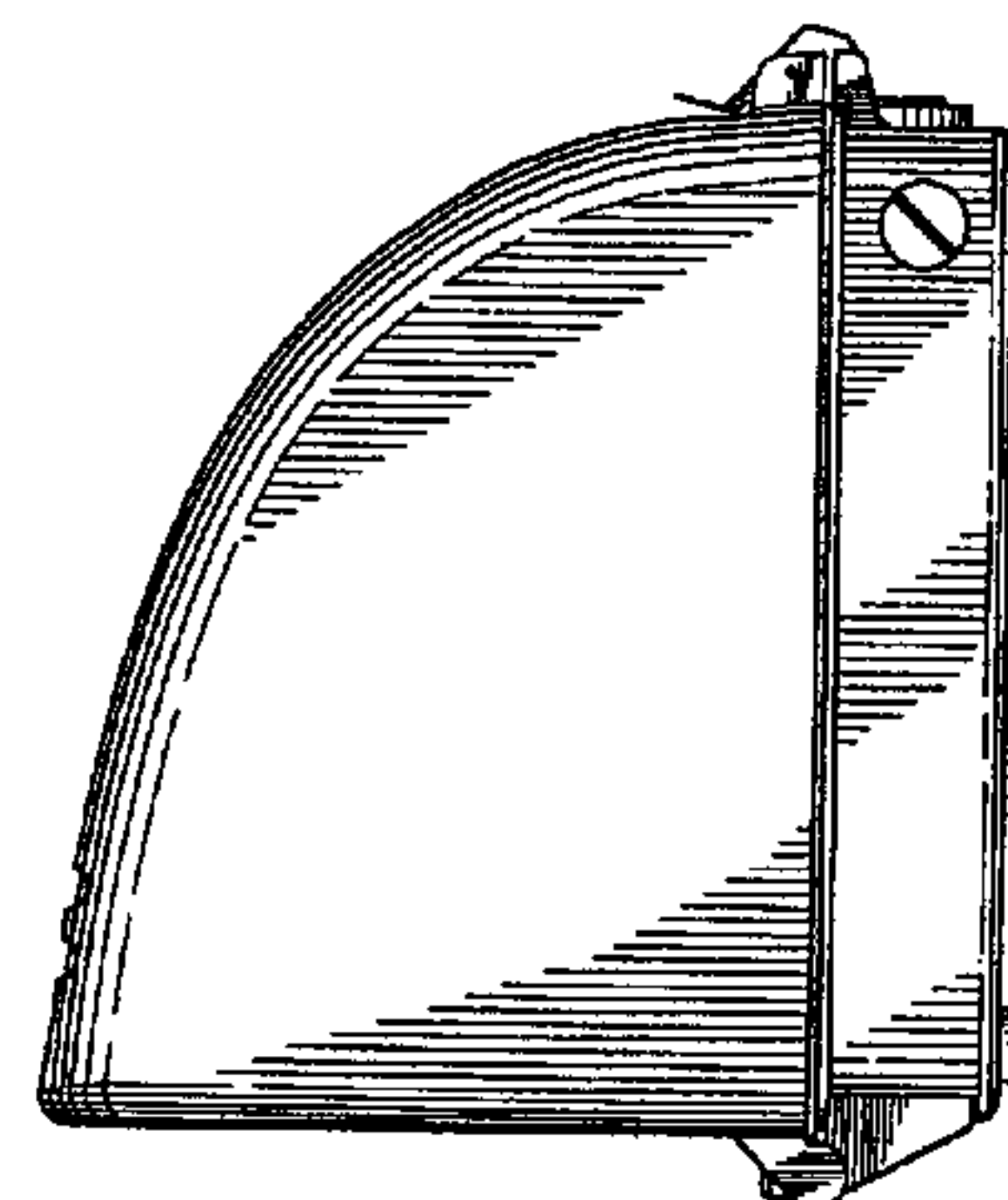
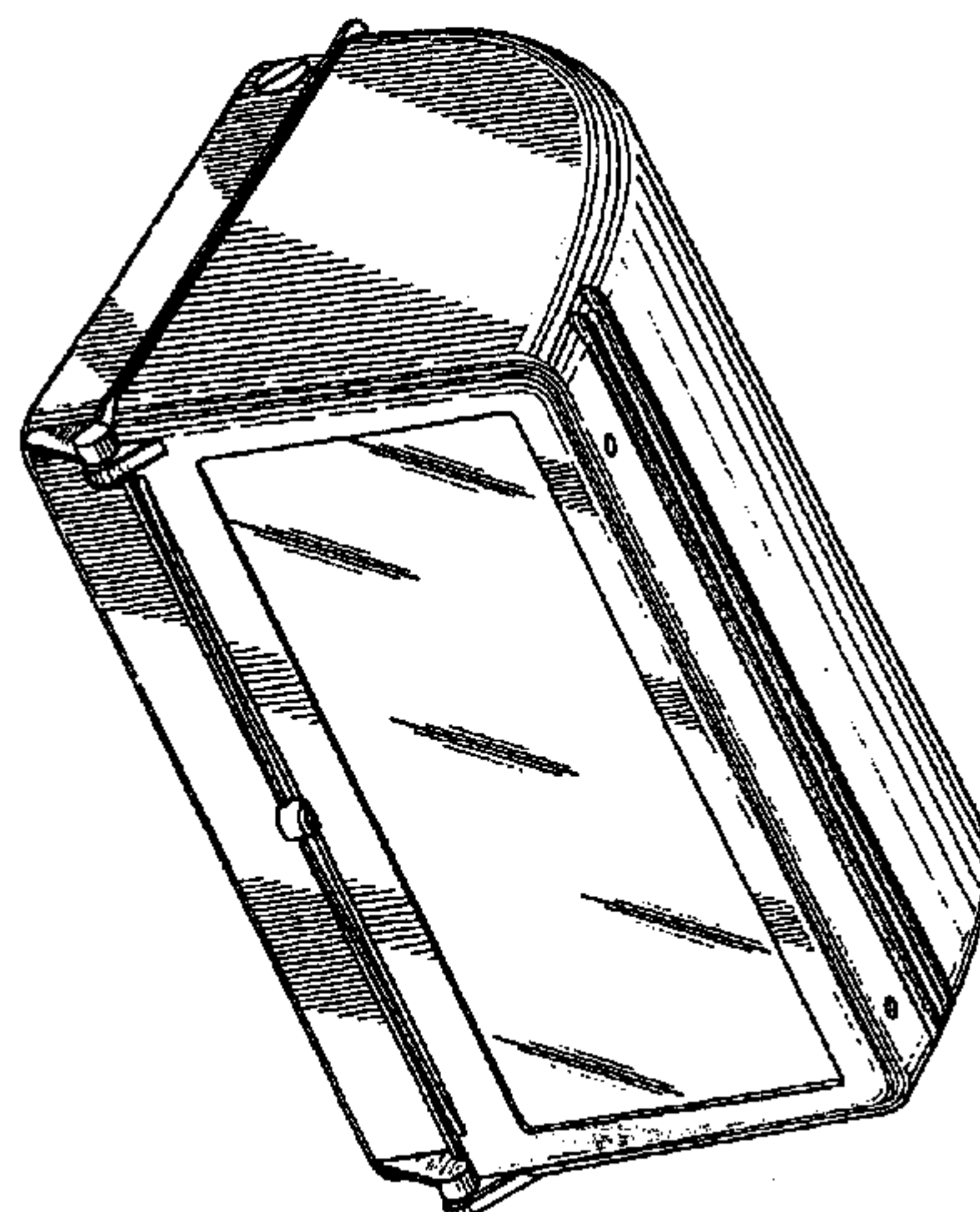
FIG. 5 is a rear view the design.

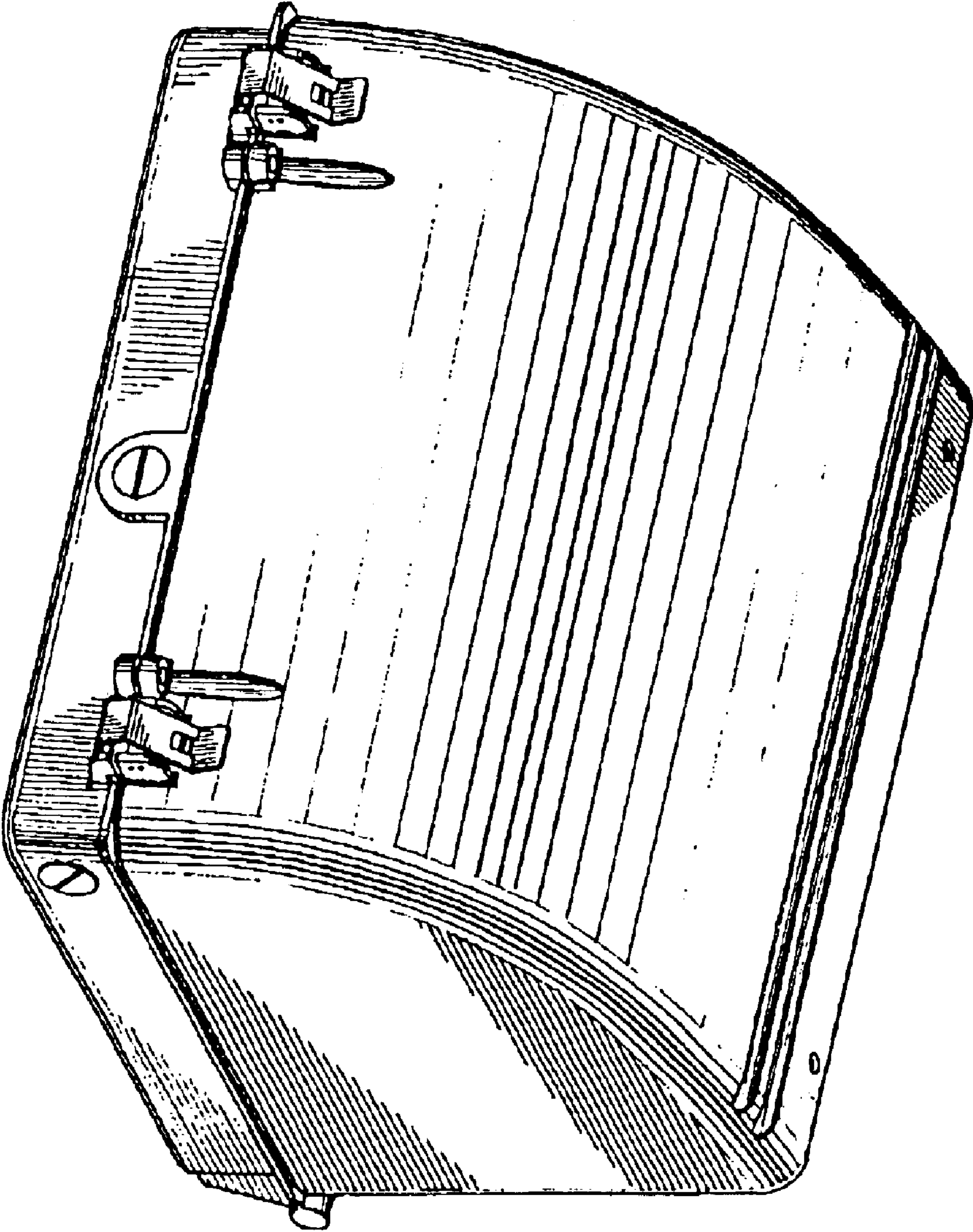

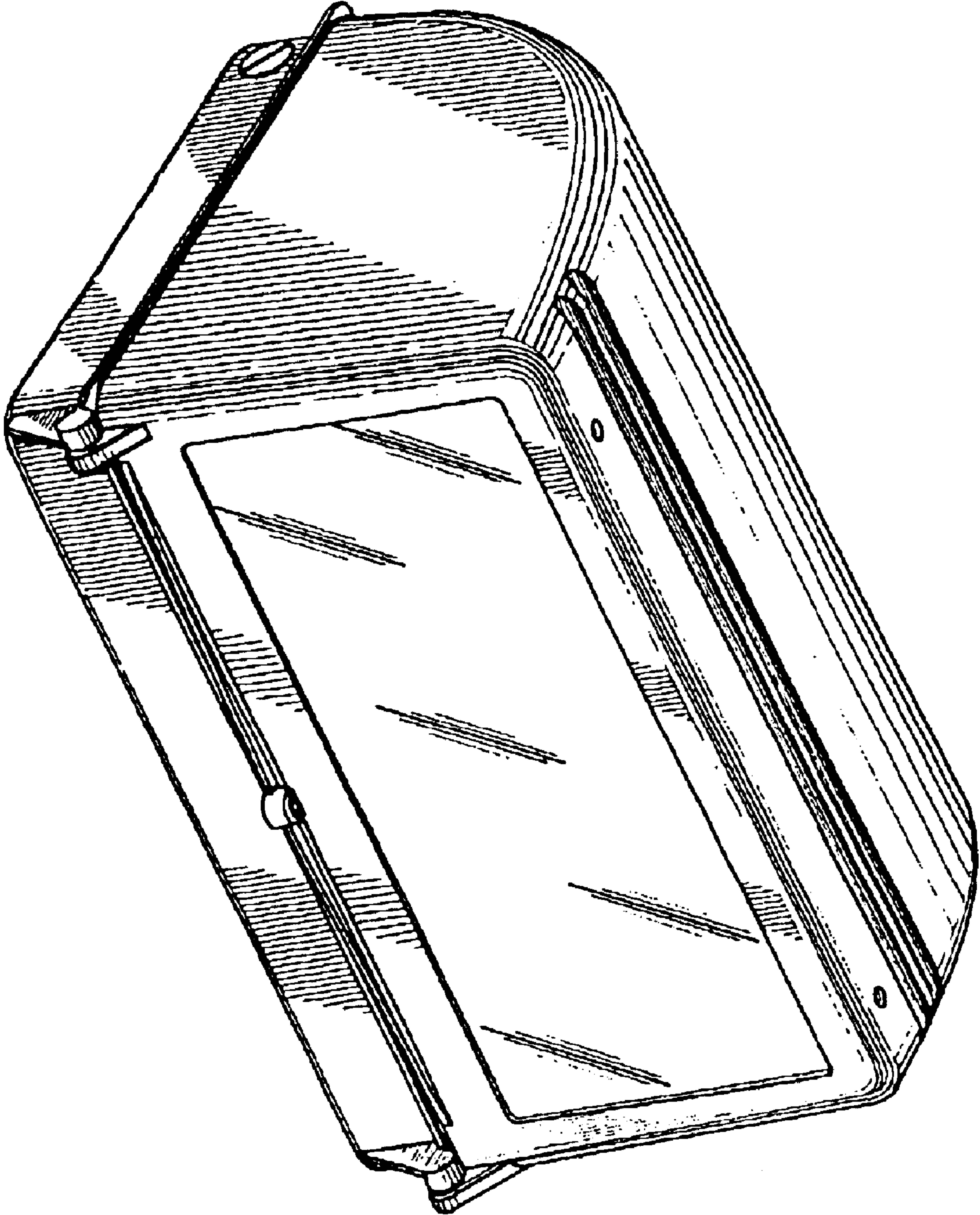

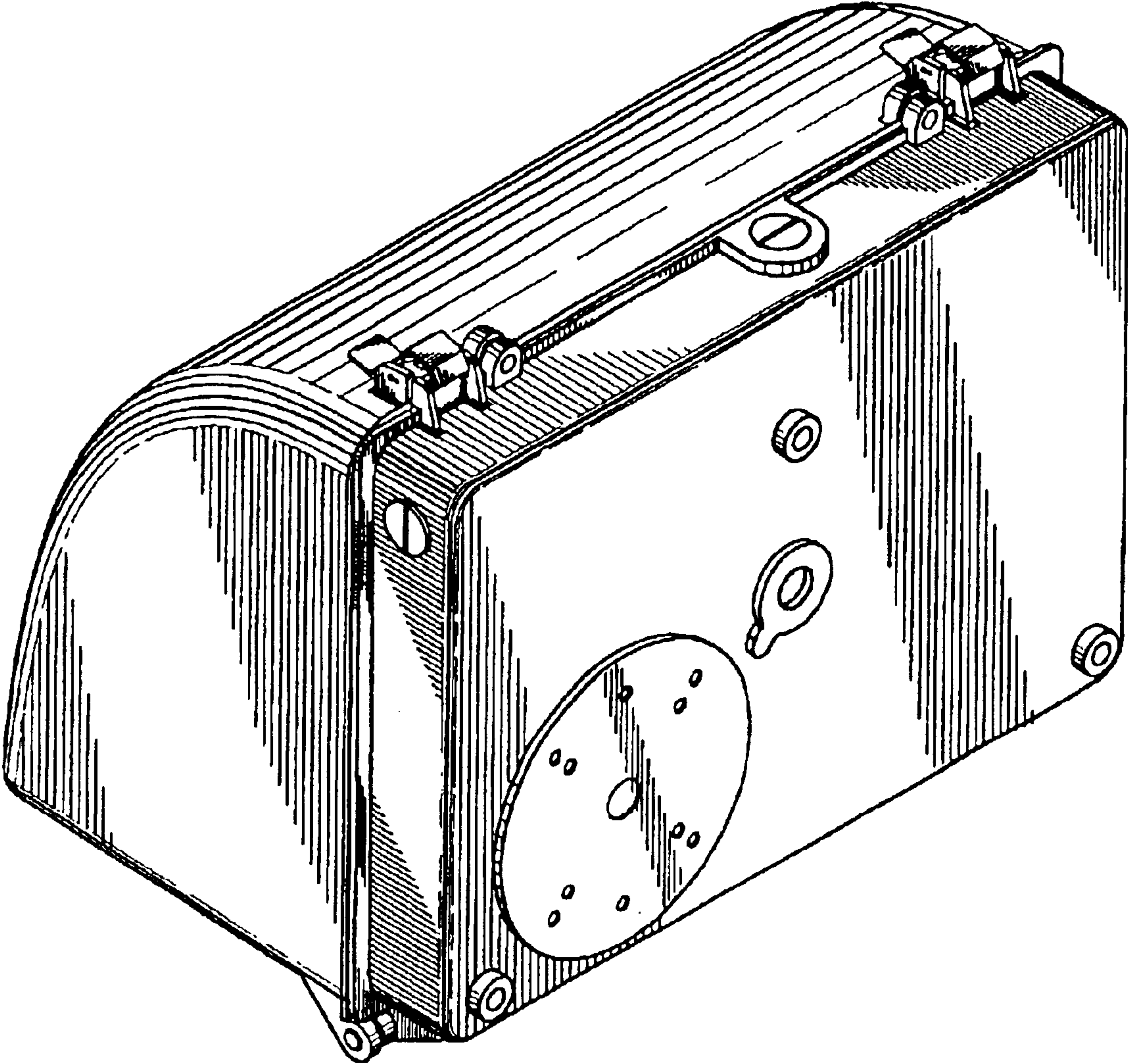

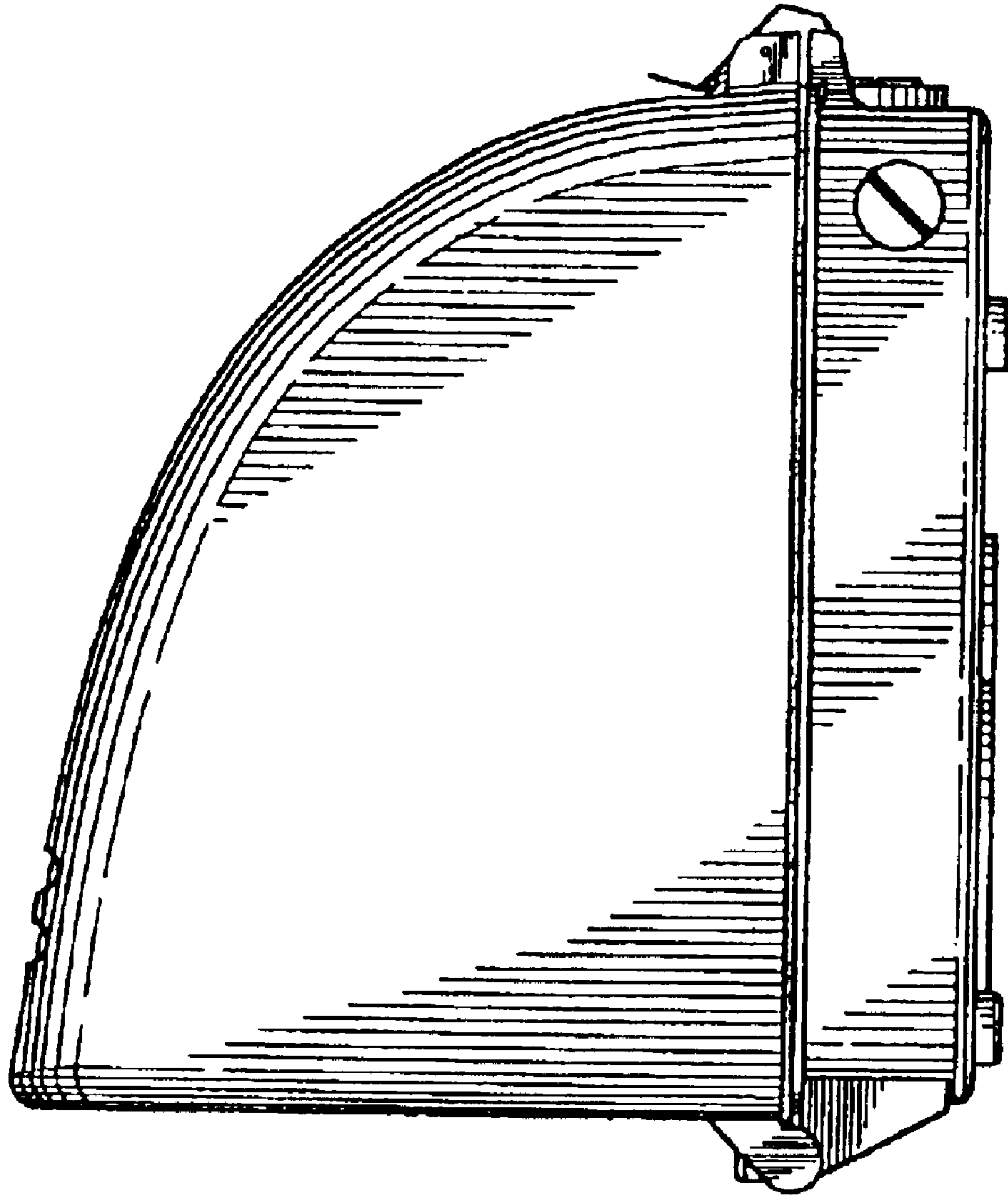

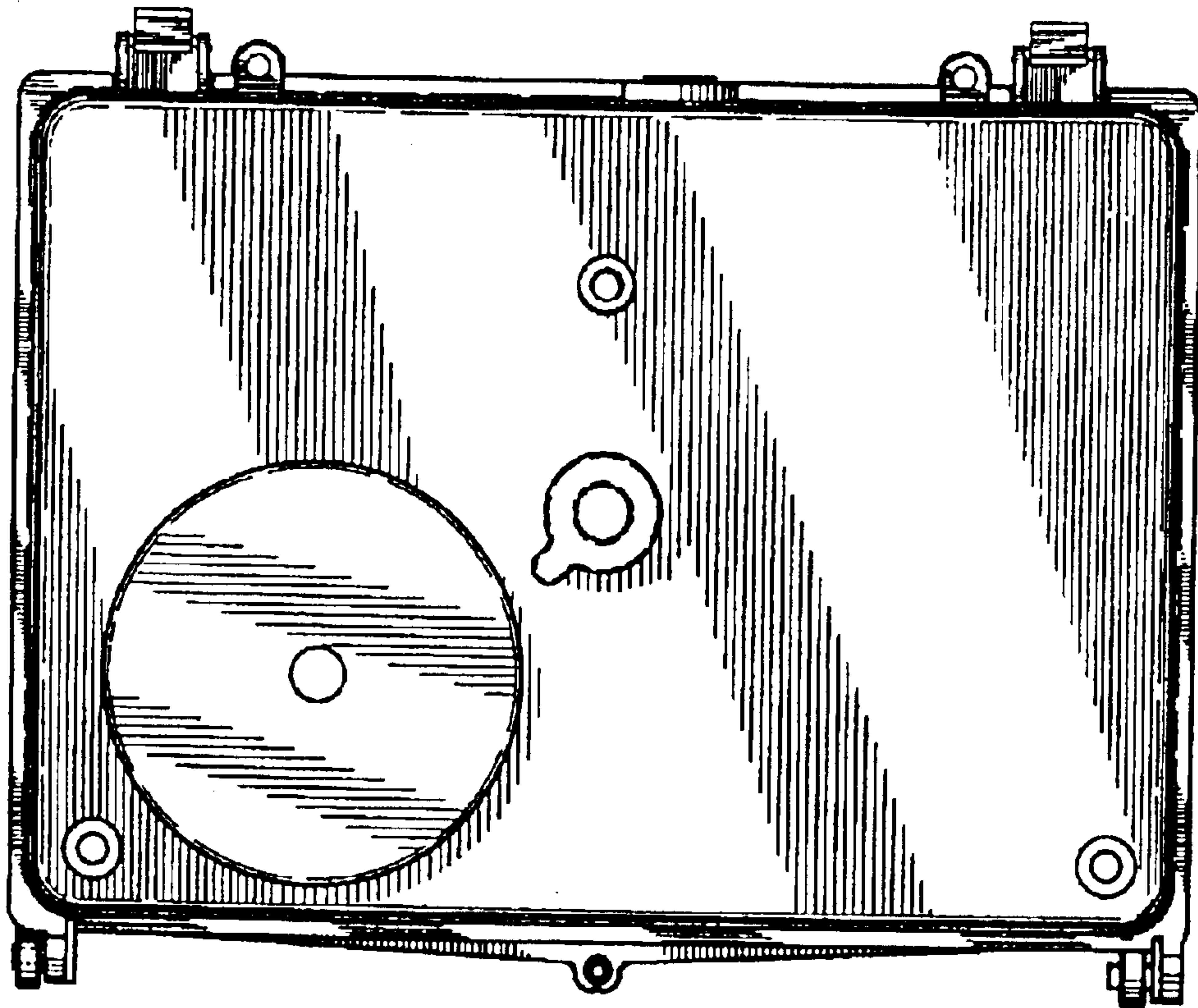

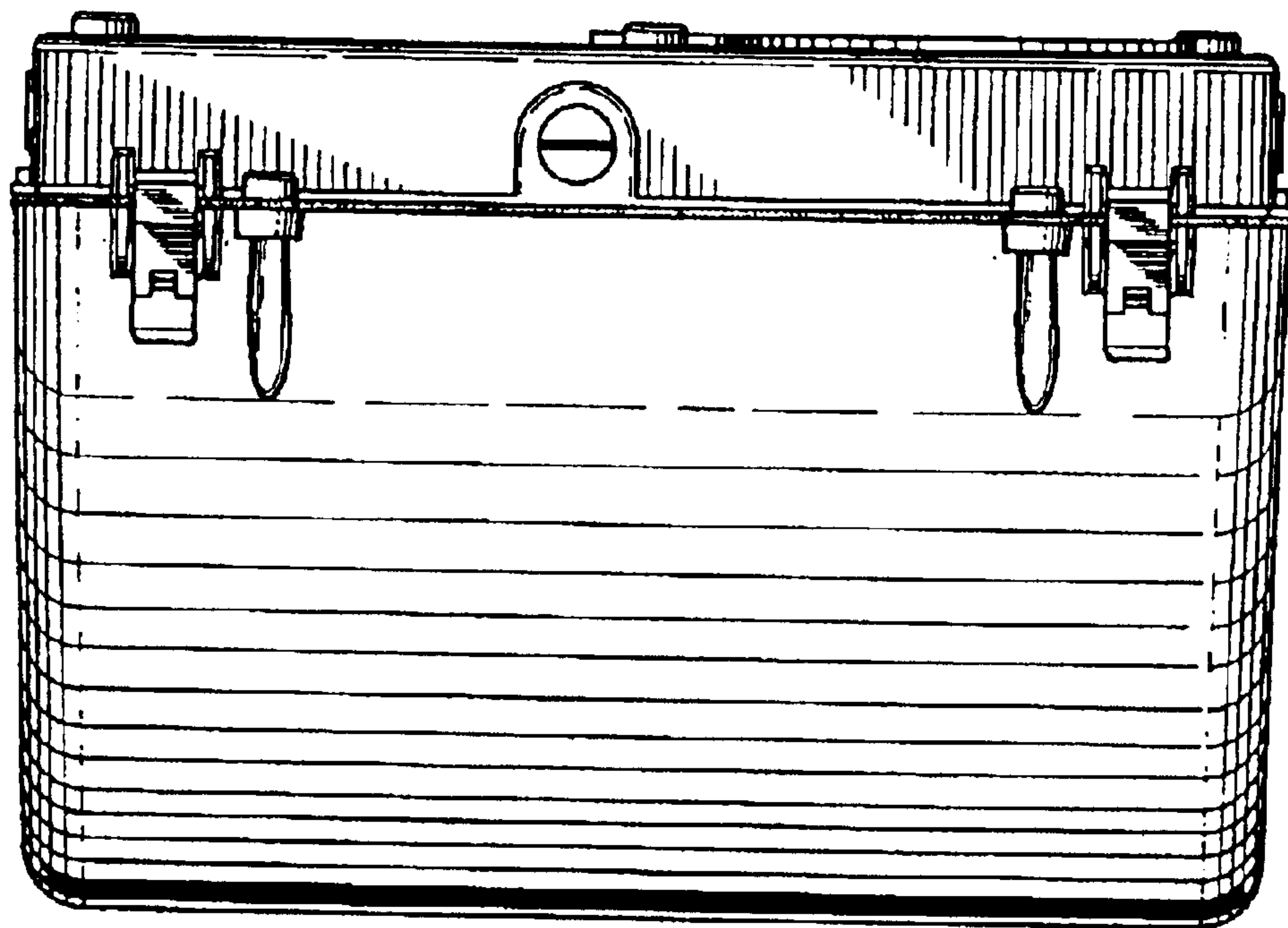

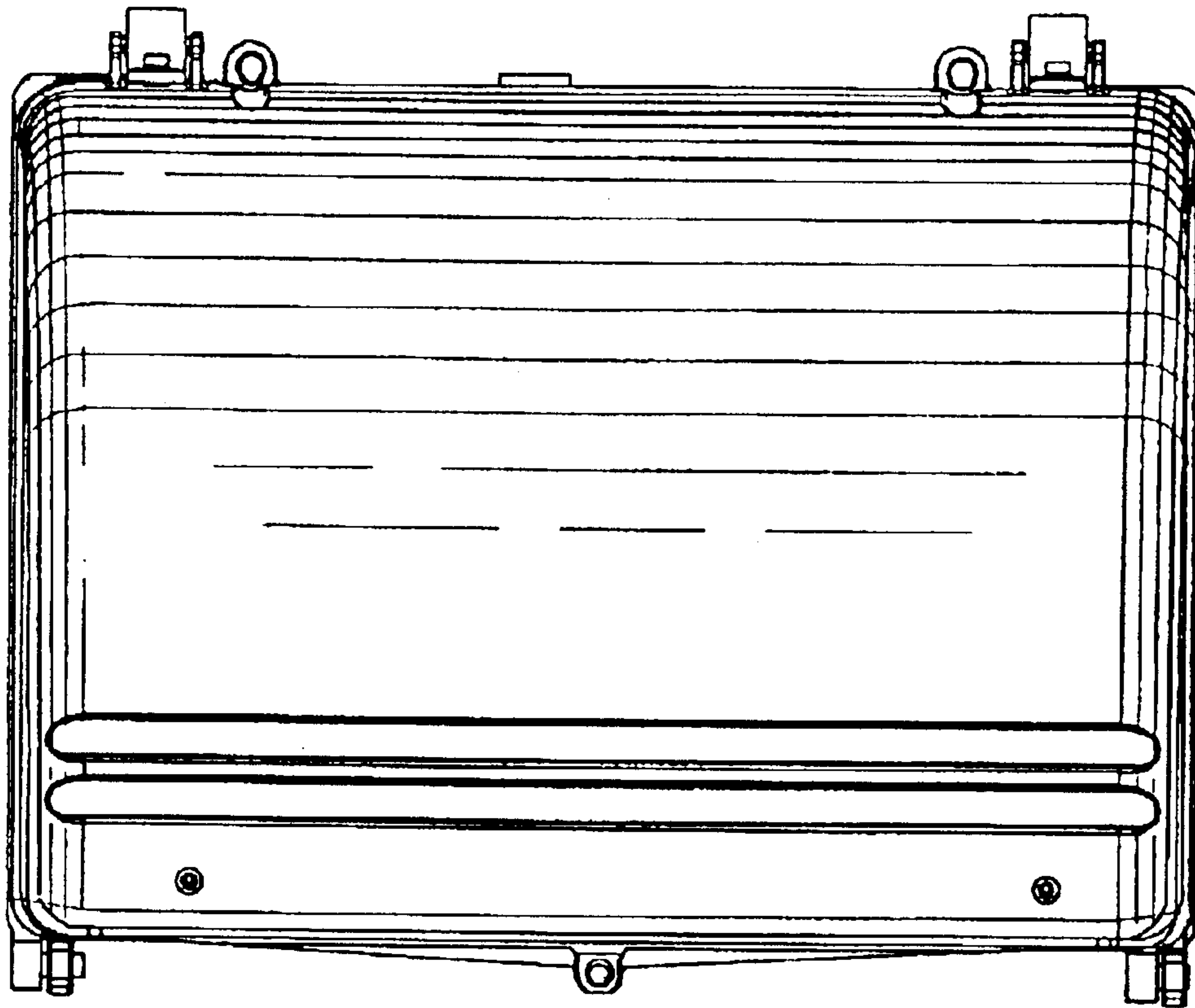

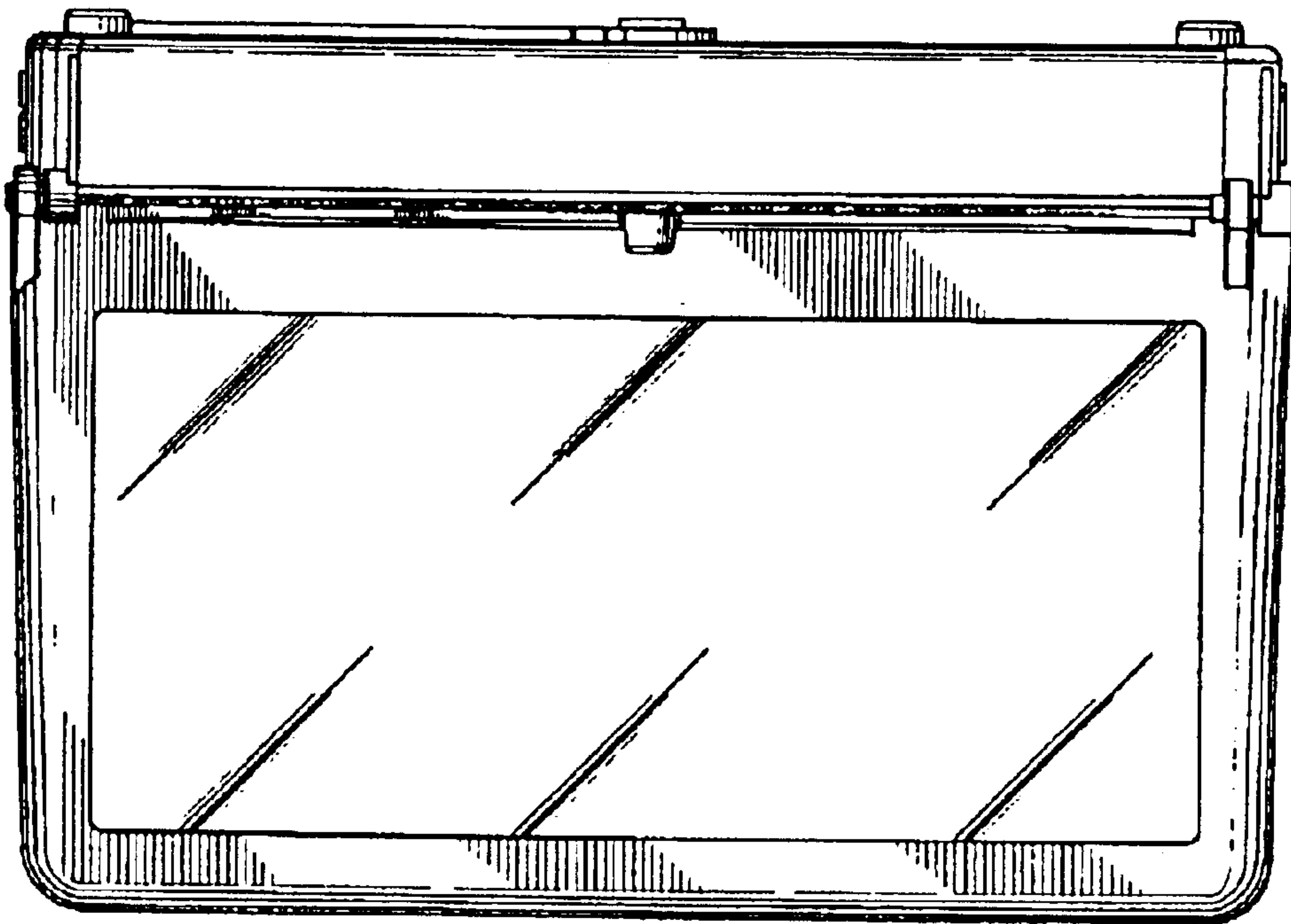
