DESCRIPTION

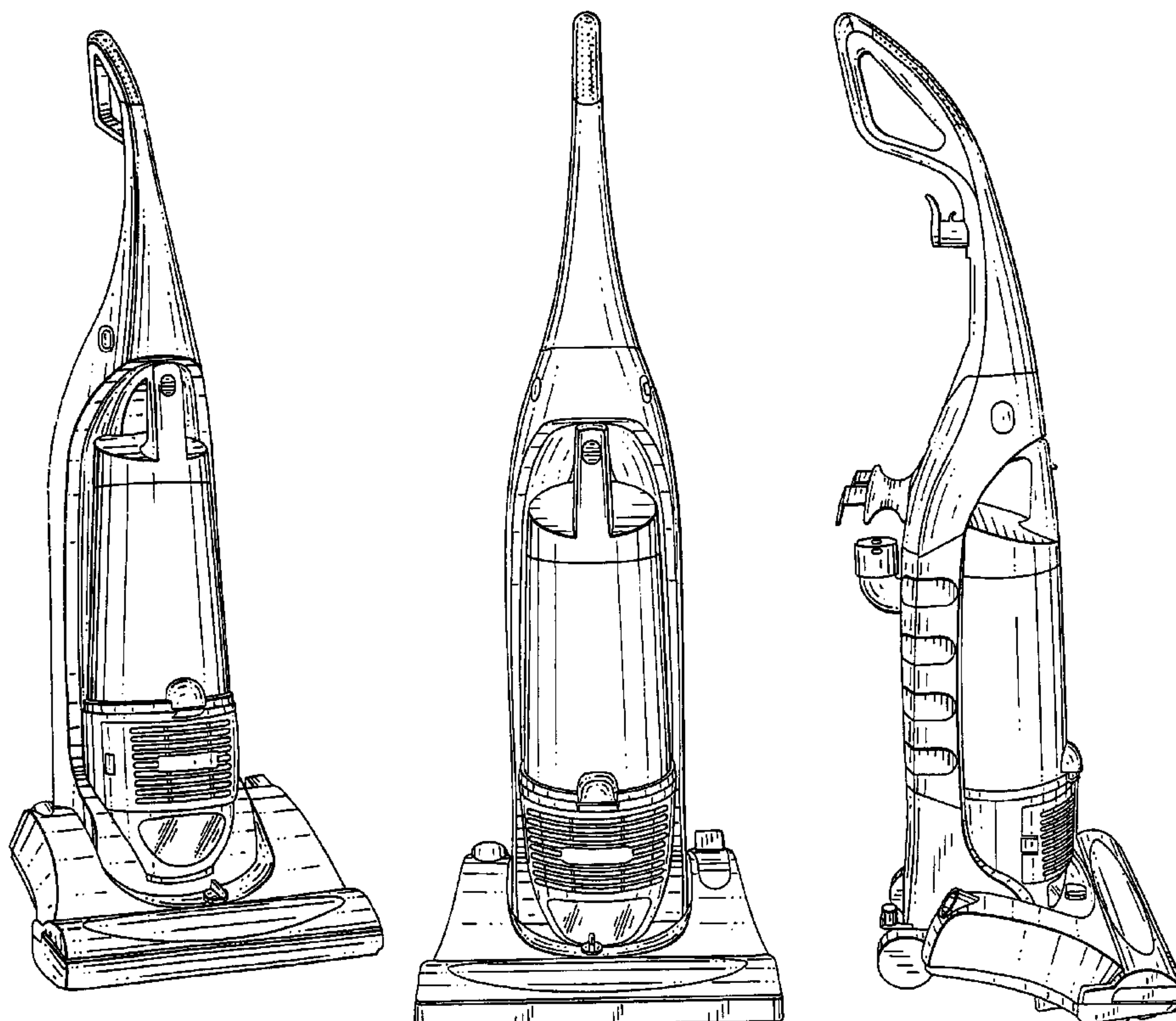

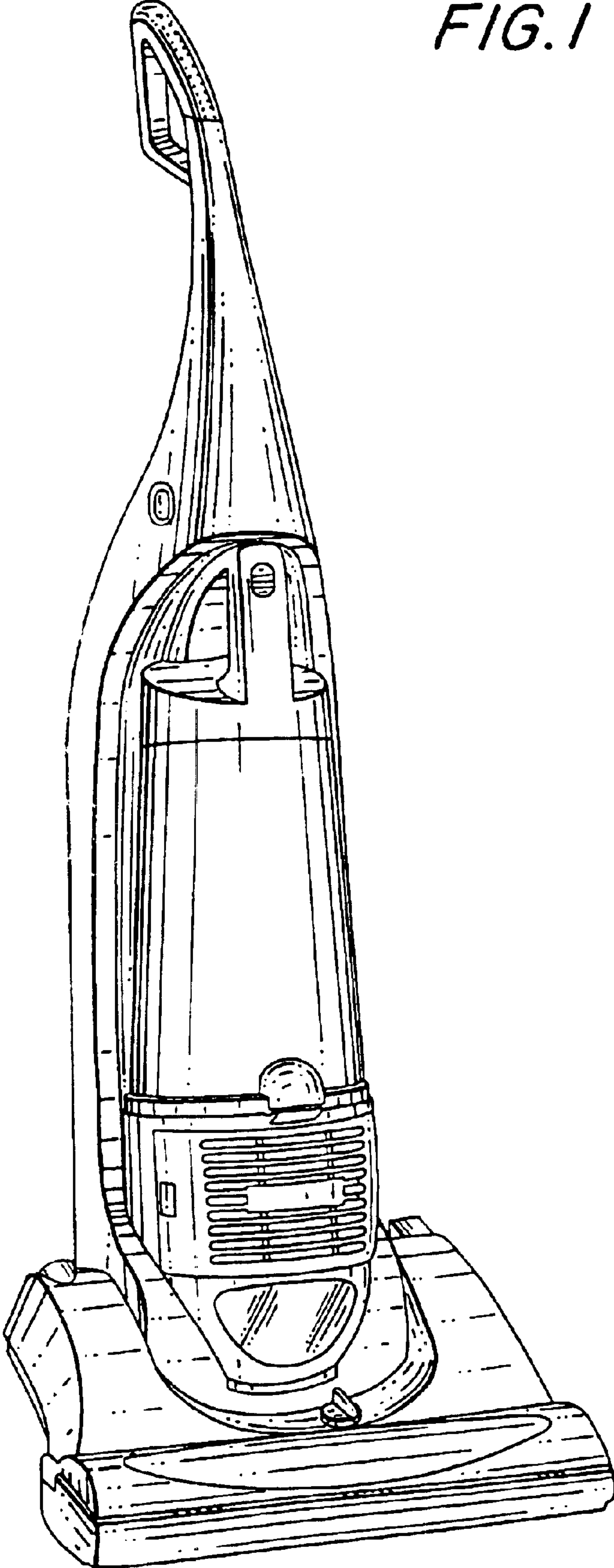

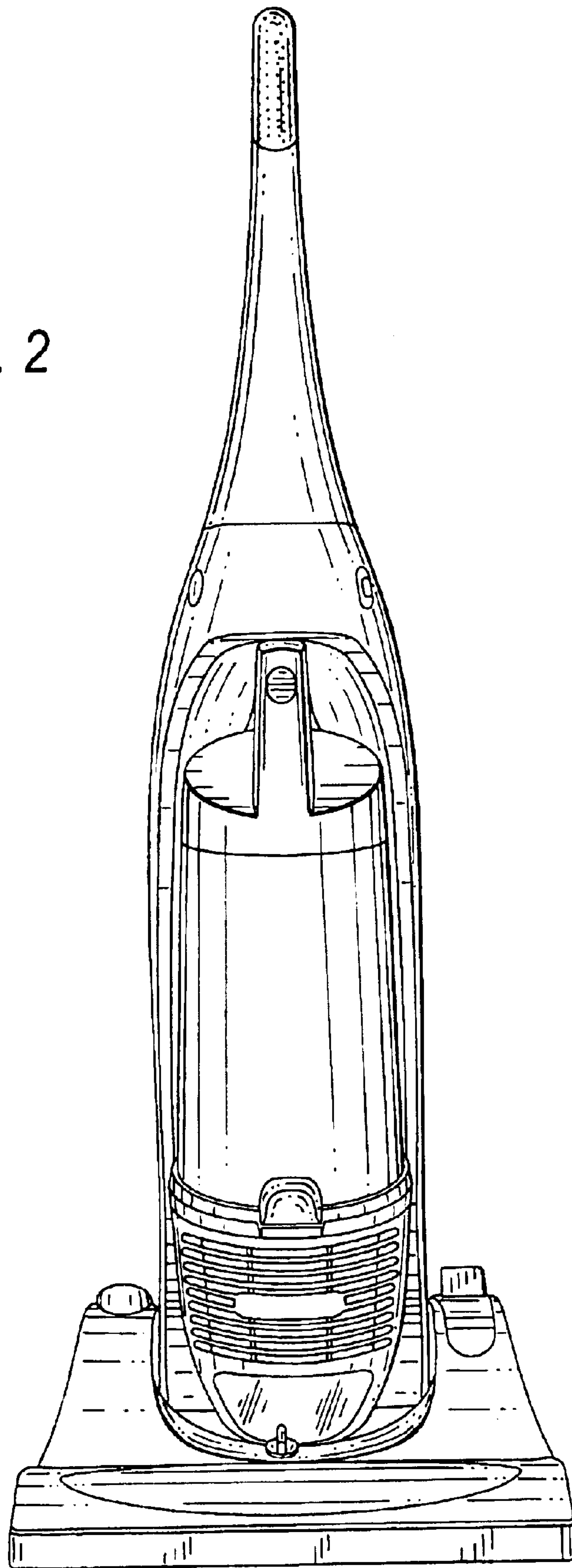

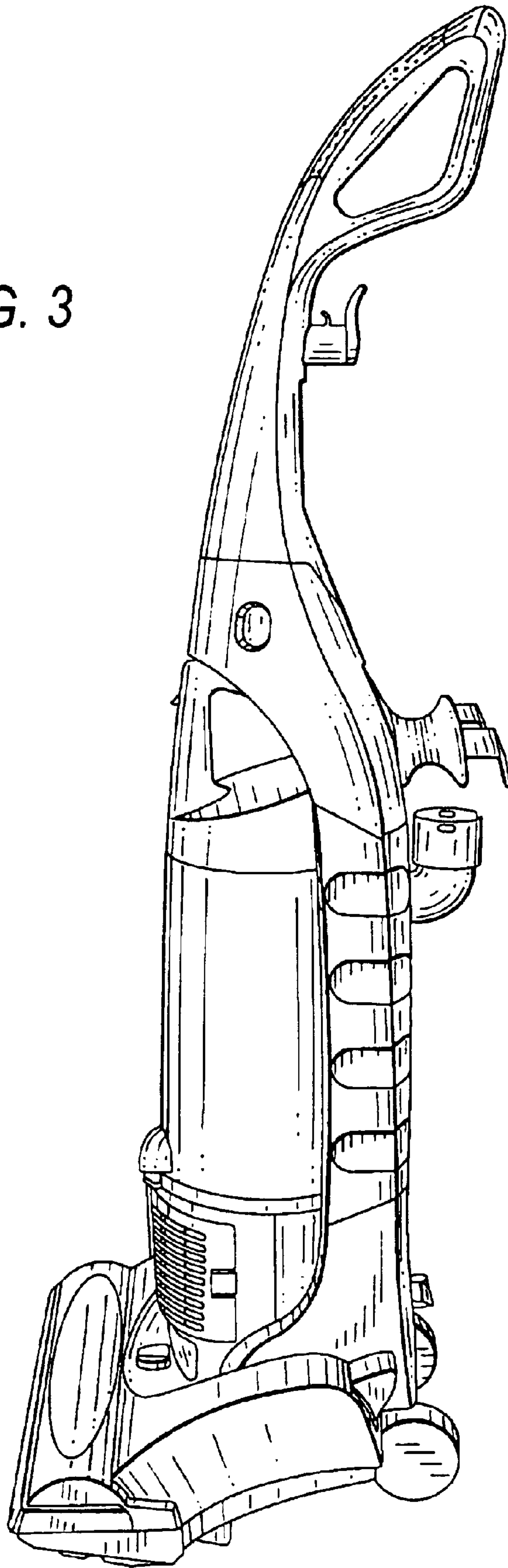

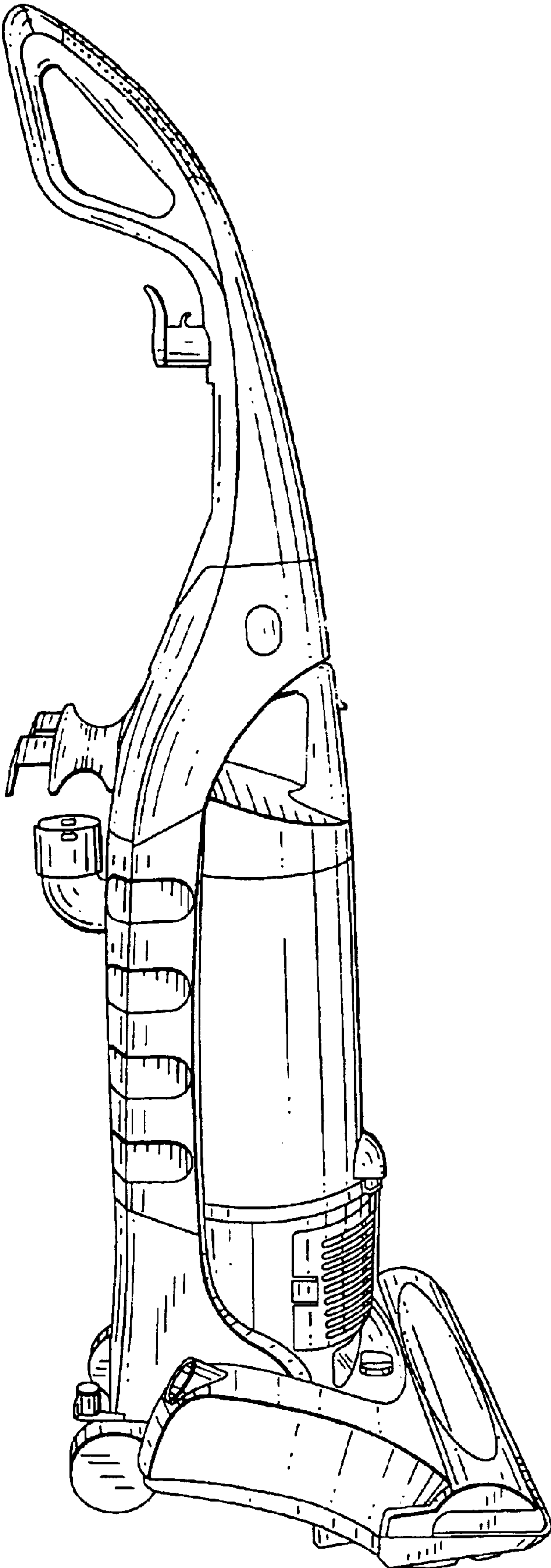
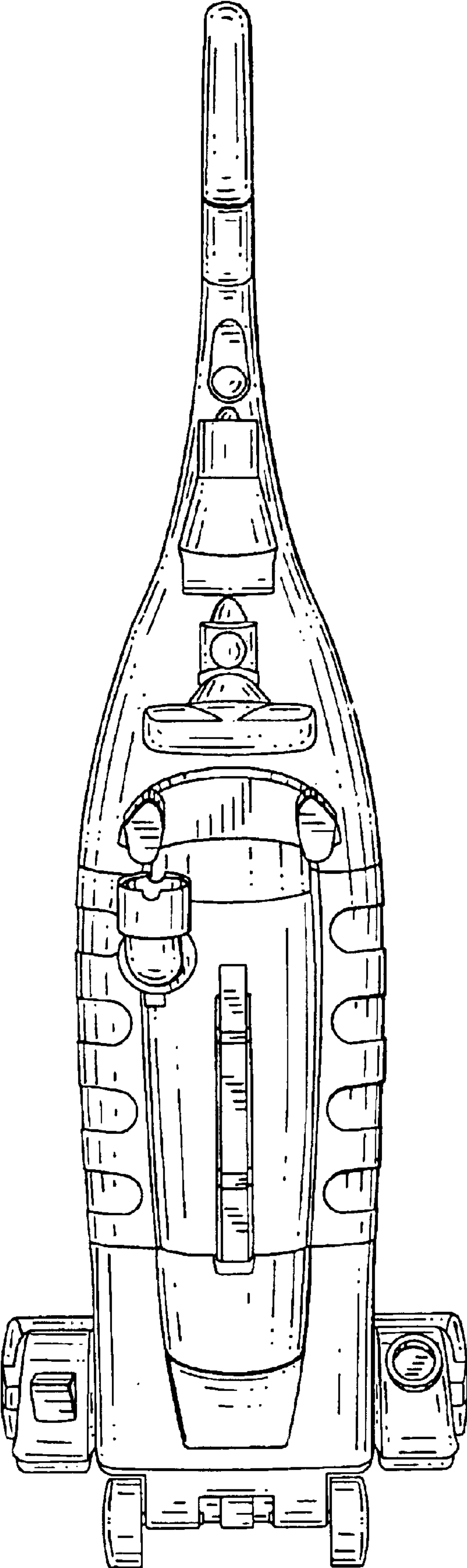

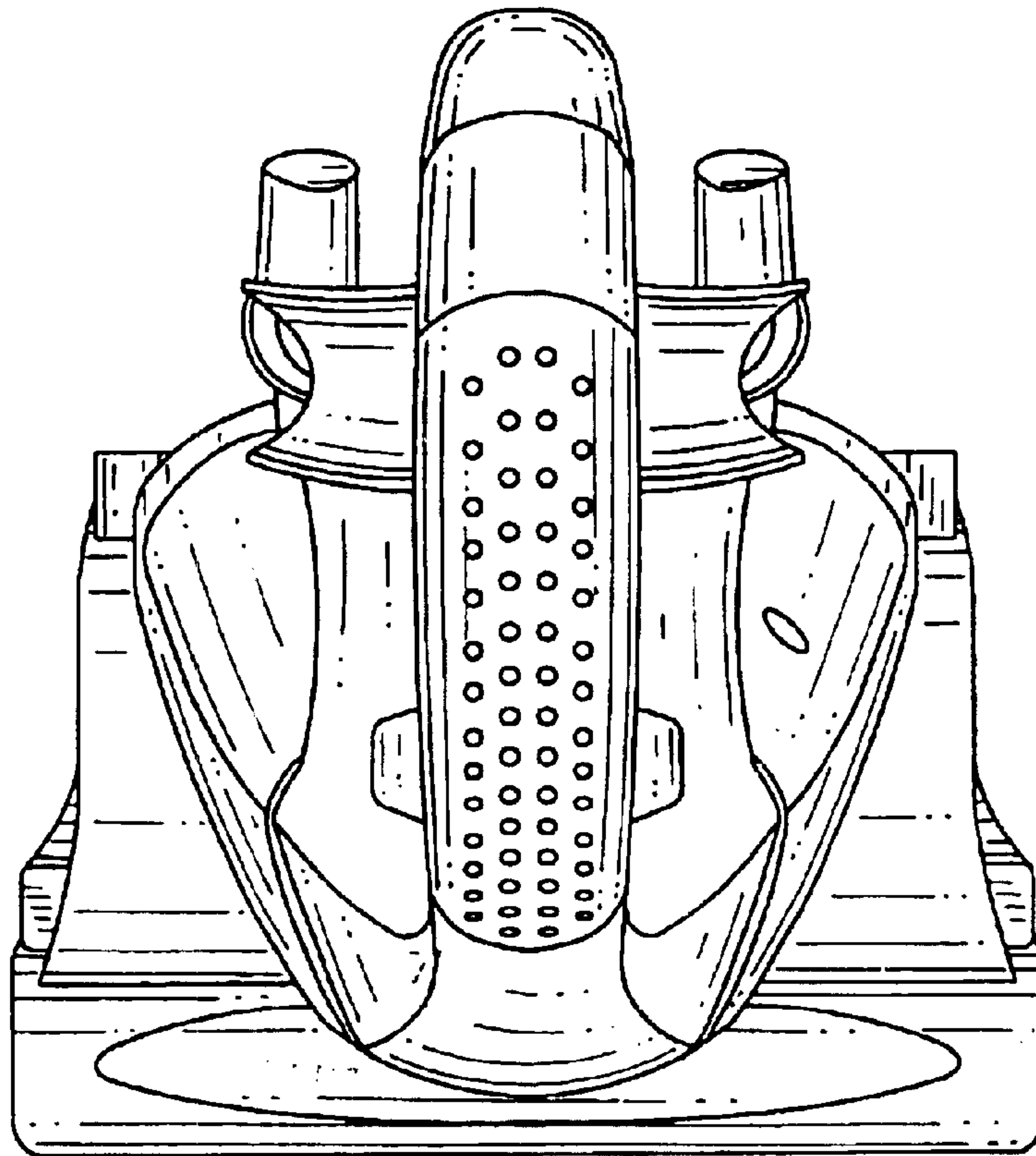

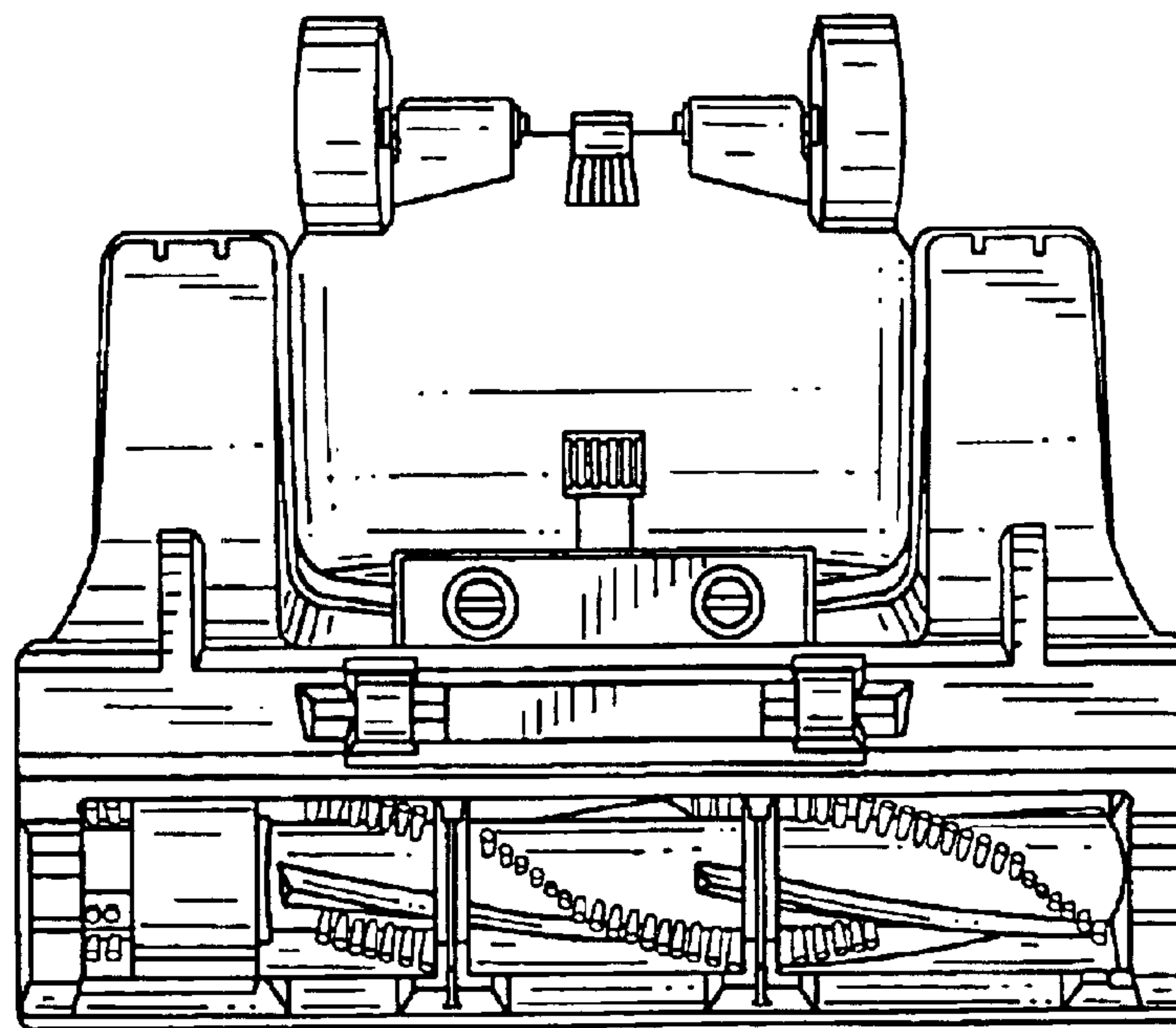
