(57) **CLAIM**

The ornamental design for headwear piece, as shown and described. The elements on the headwear piece shown in broken lines form no part of the claimed design.

DESCRIPTION

FIG. 1 is a front, top and side perspective view of my design for ornamentation on a headwear piece, according to the present invention;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a reduced top plan view thereof;

FIG. 4 is an elevation view thereof from the same side as in FIG. 1;

FIG. 5 is a perspective view of a second embodiment of my design for a headwear piece, according to the present invention;

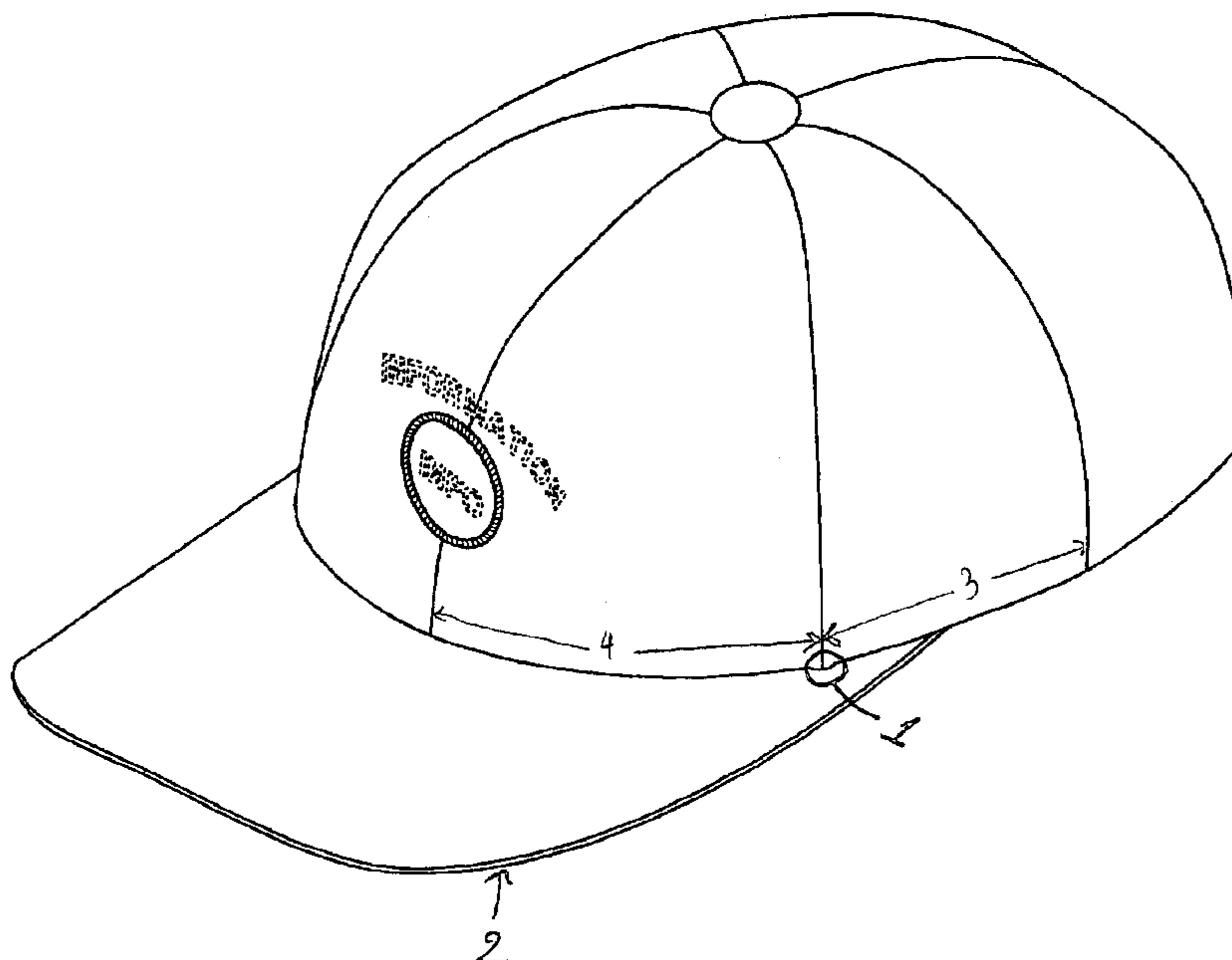
FIG. 6 is a reduced front elevation view thereof;

FIG. 7 is a reduced top plan view thereof;

FIG. 8 is a reduced side elevation view thereof.

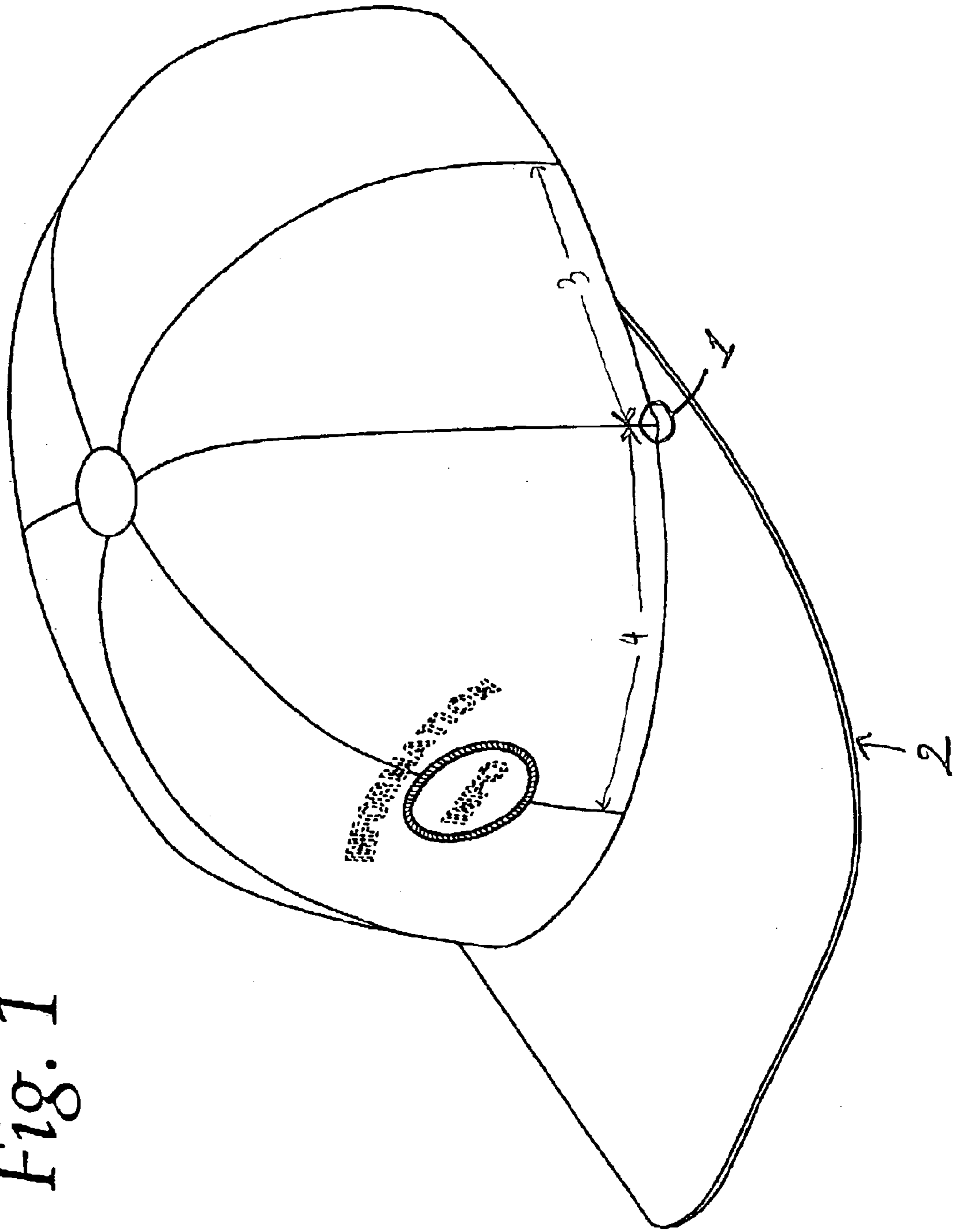

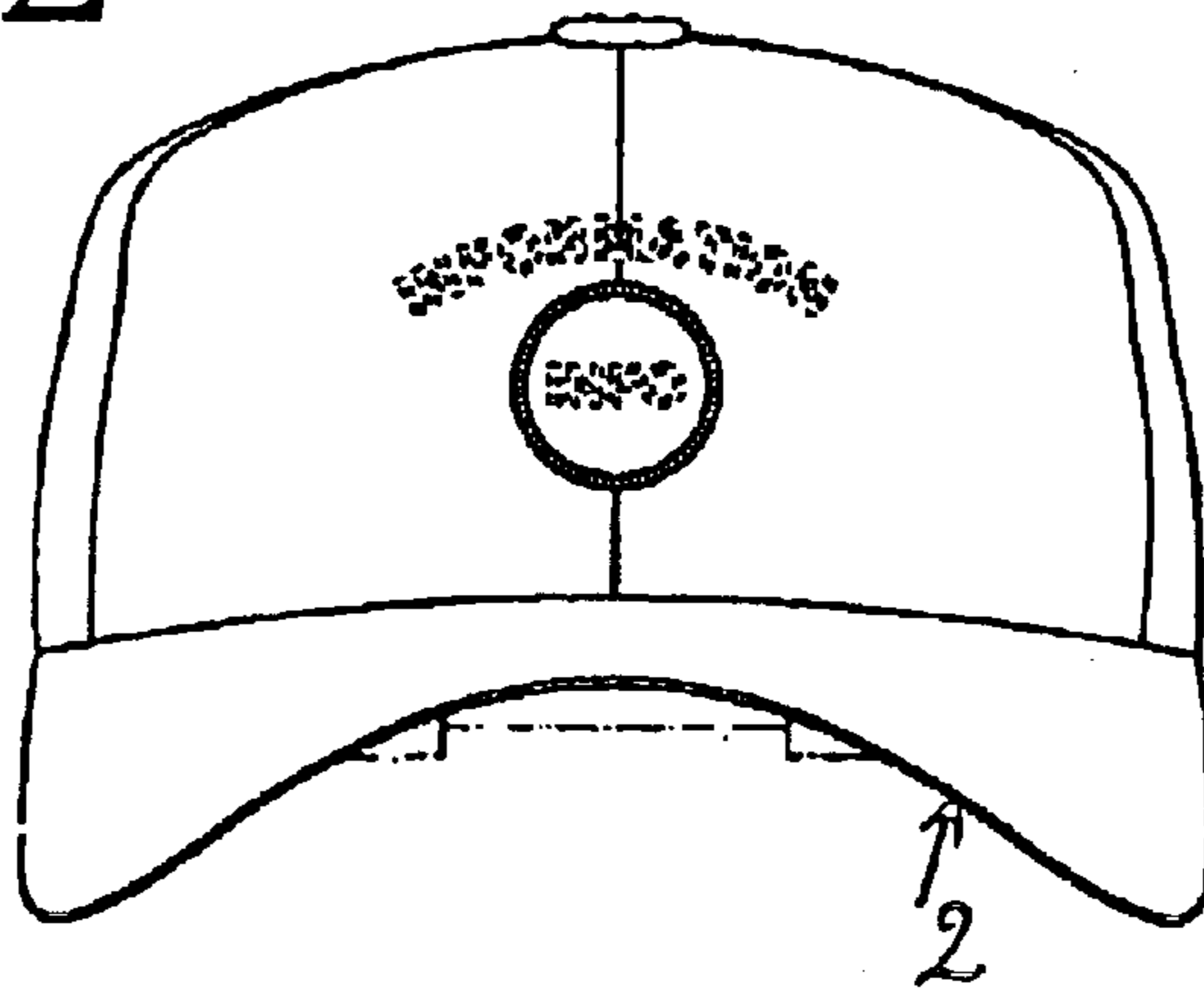

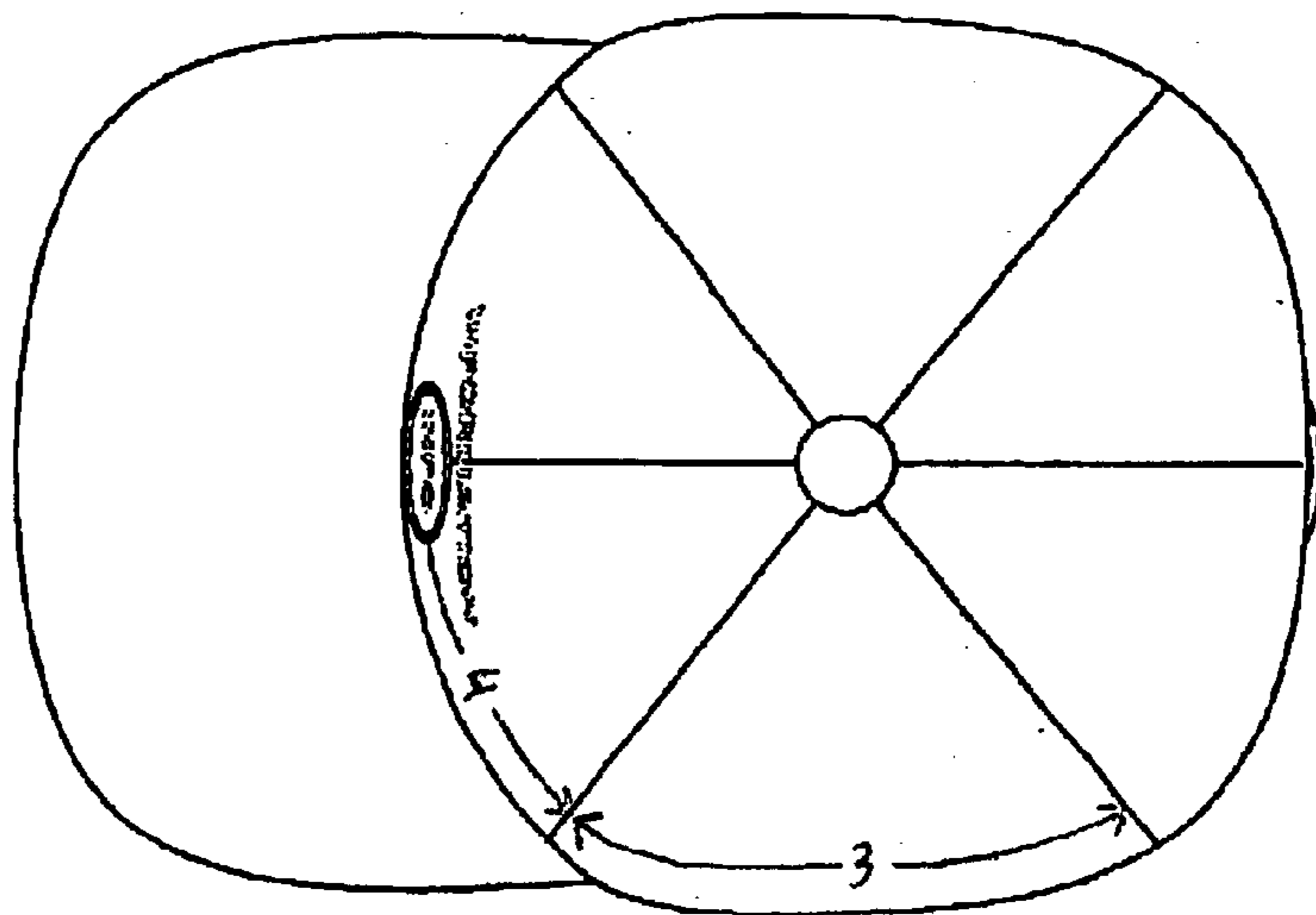
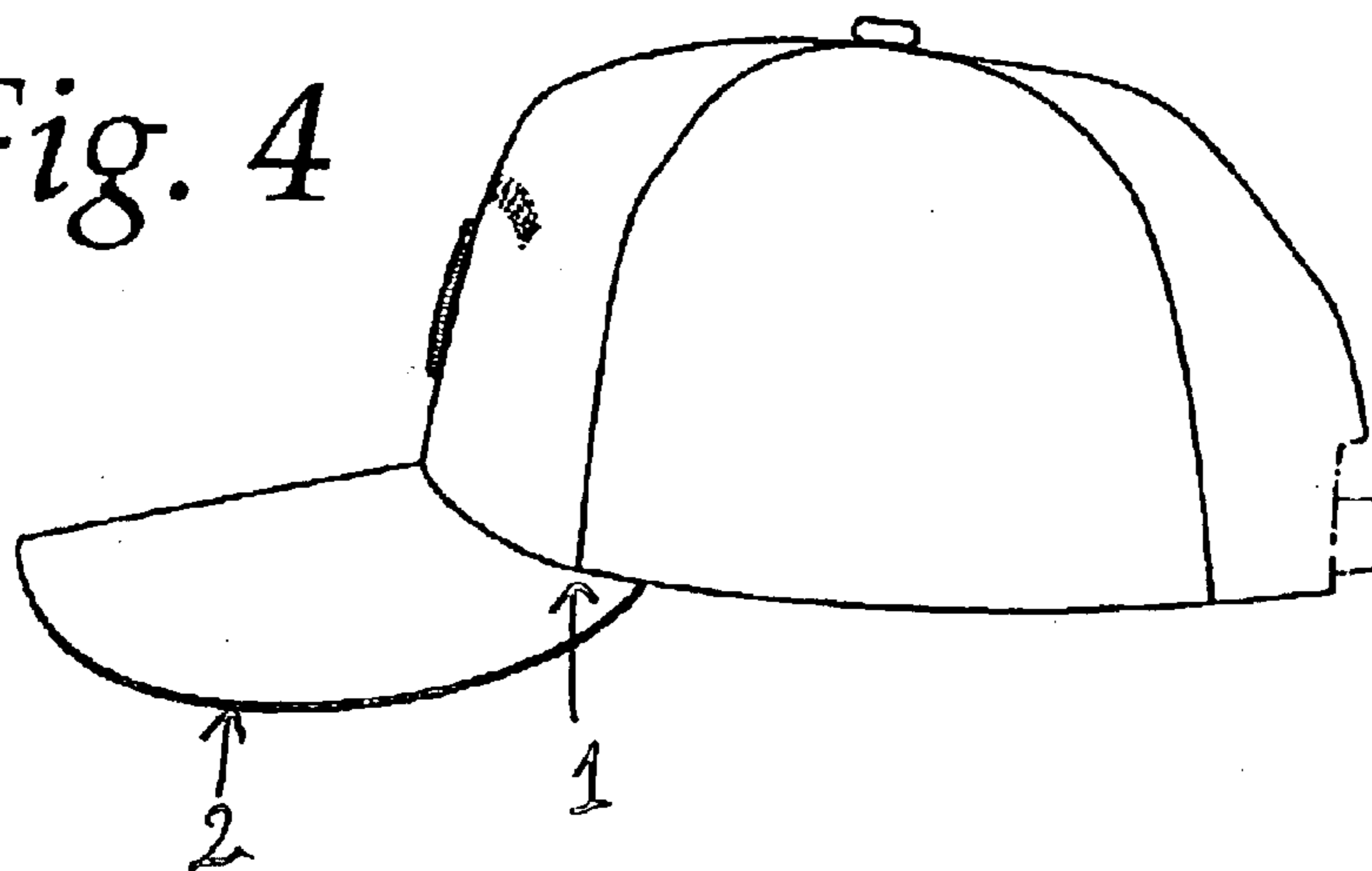

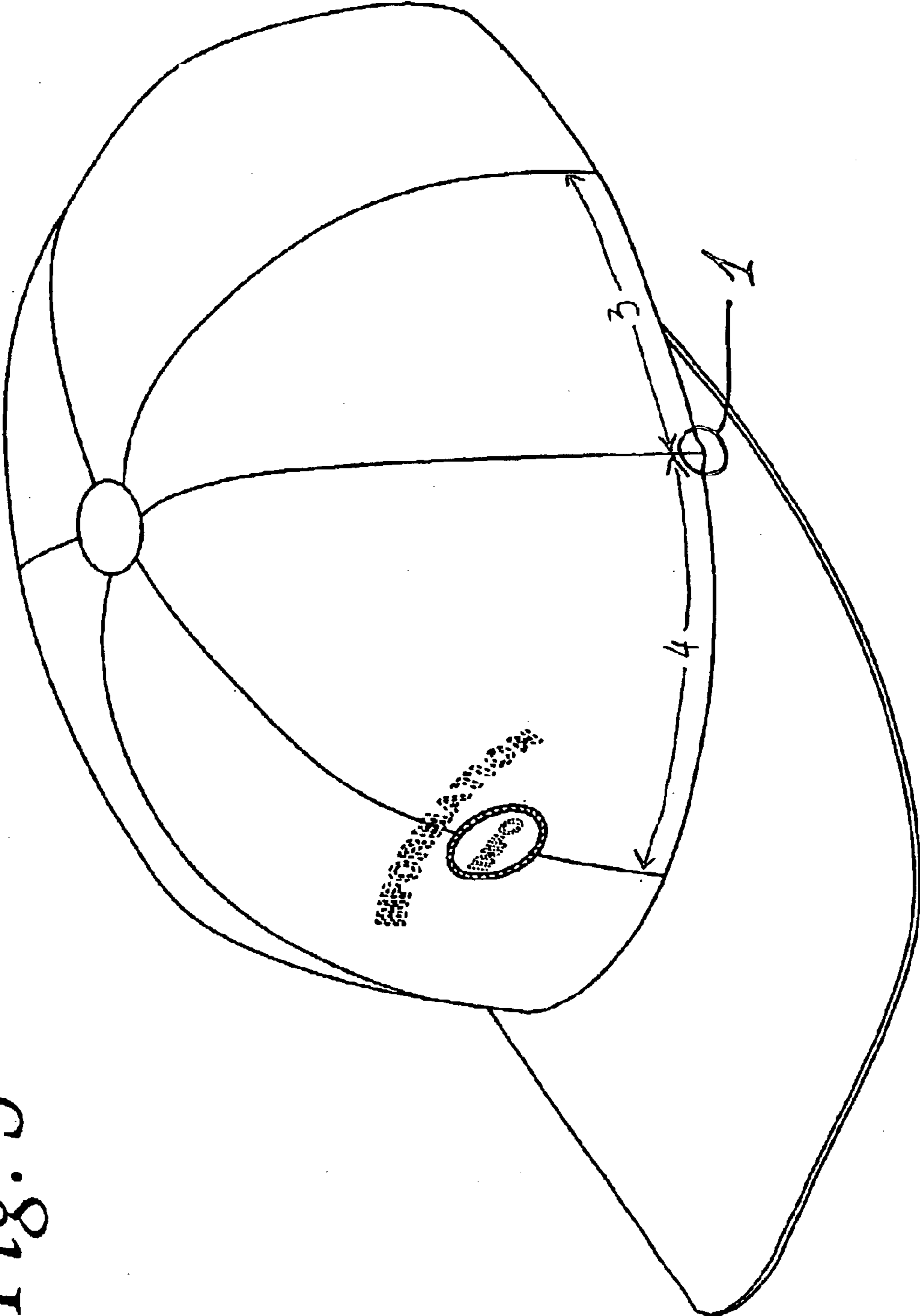

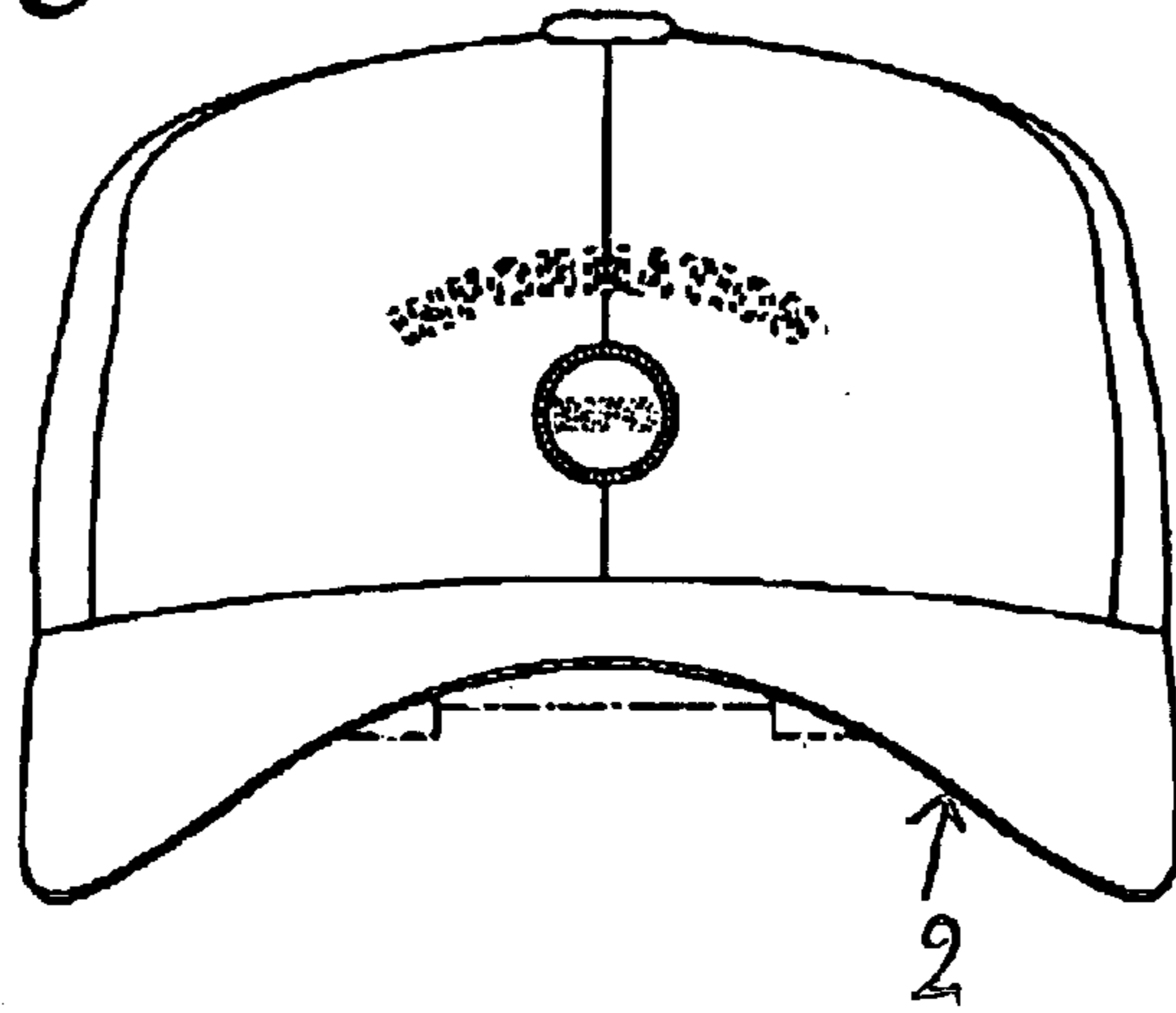

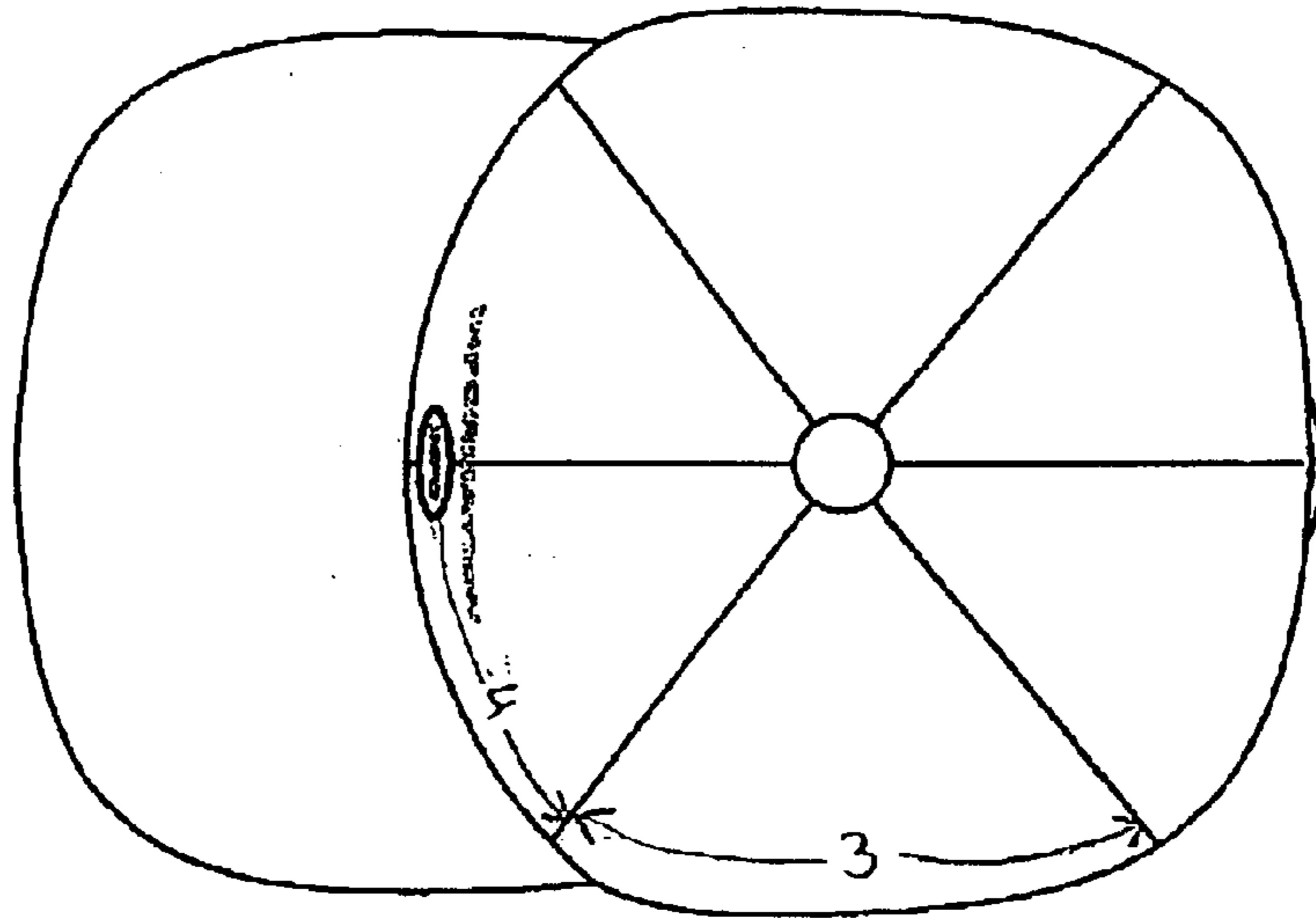
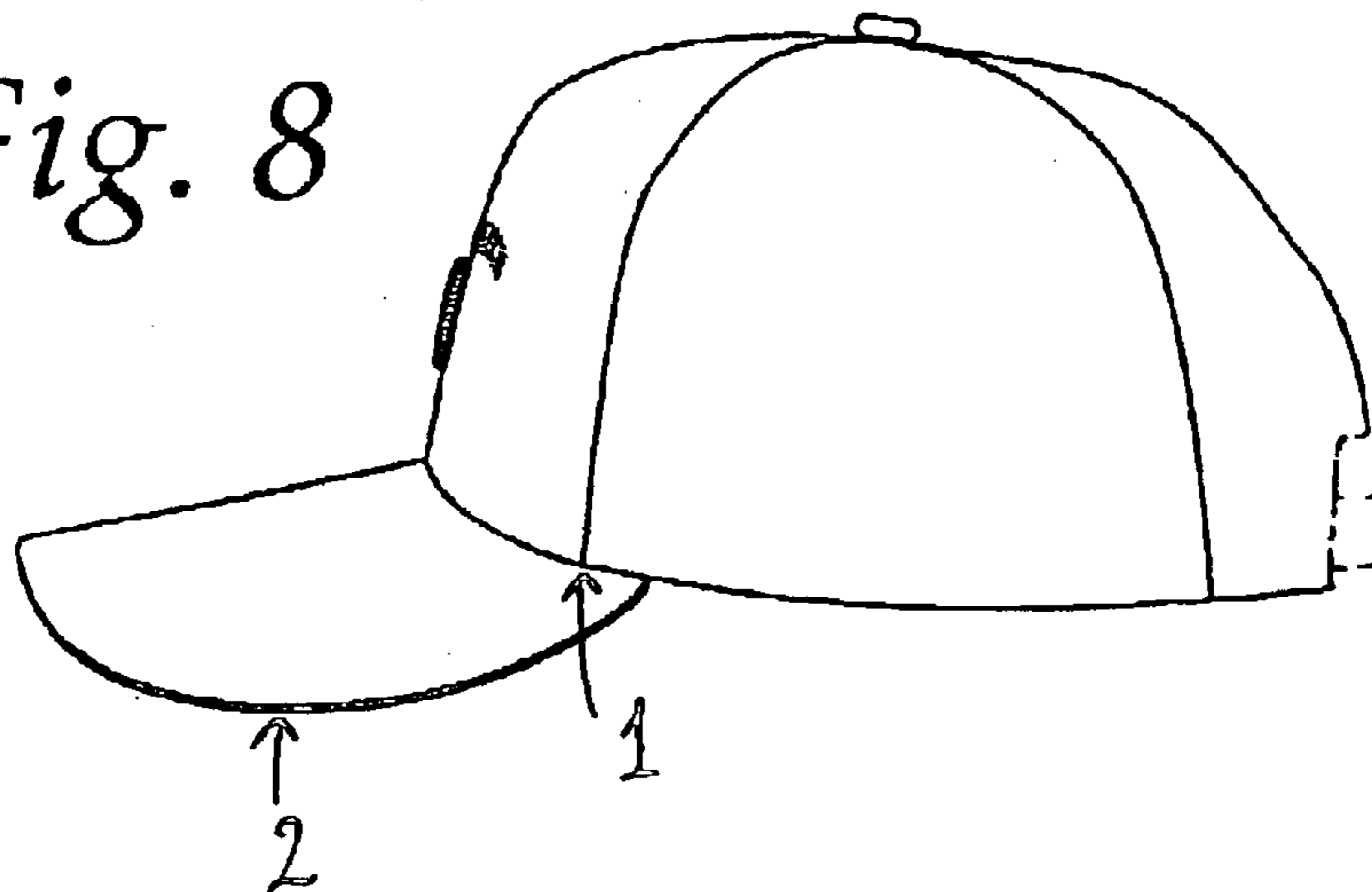

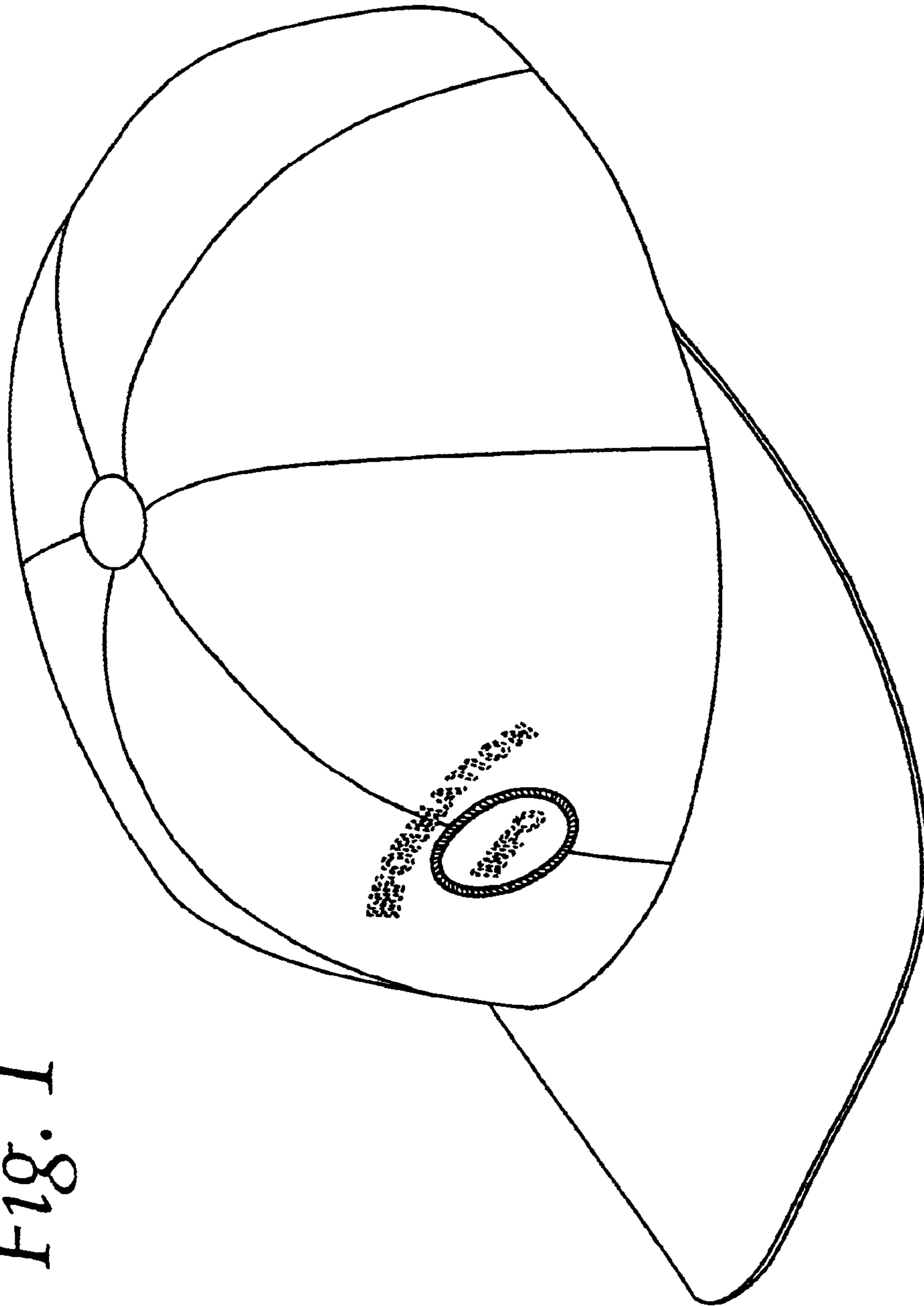

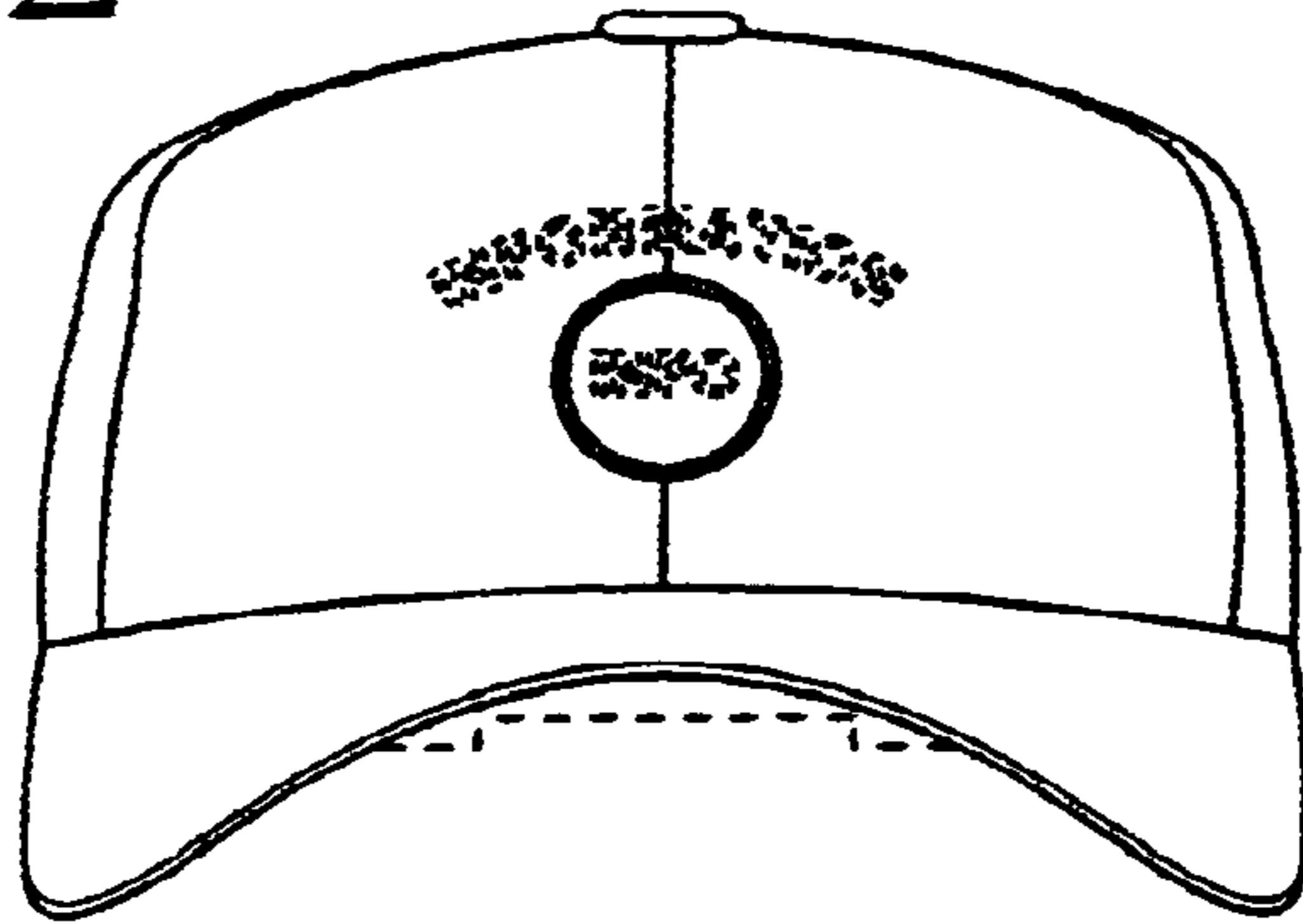

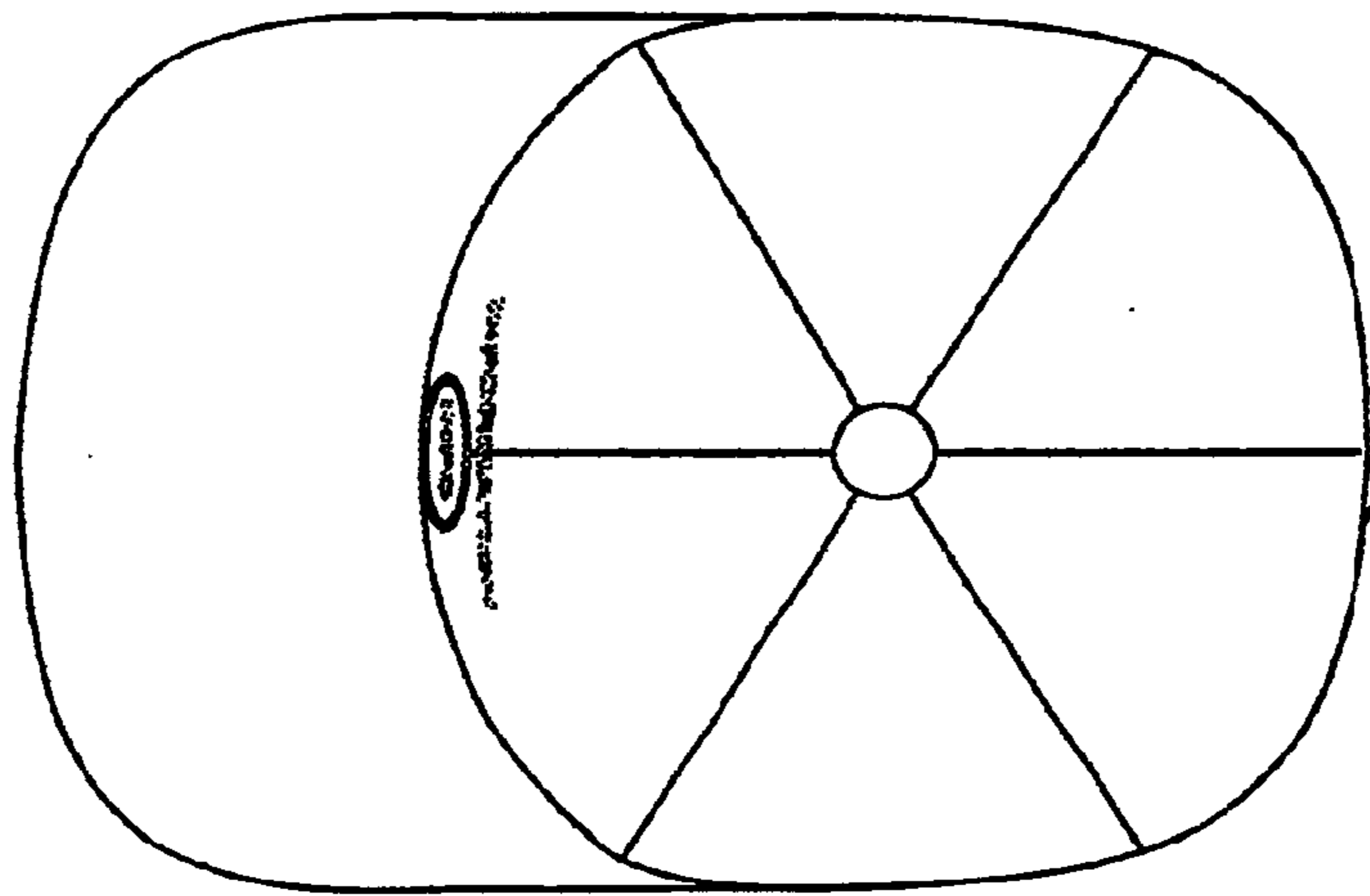
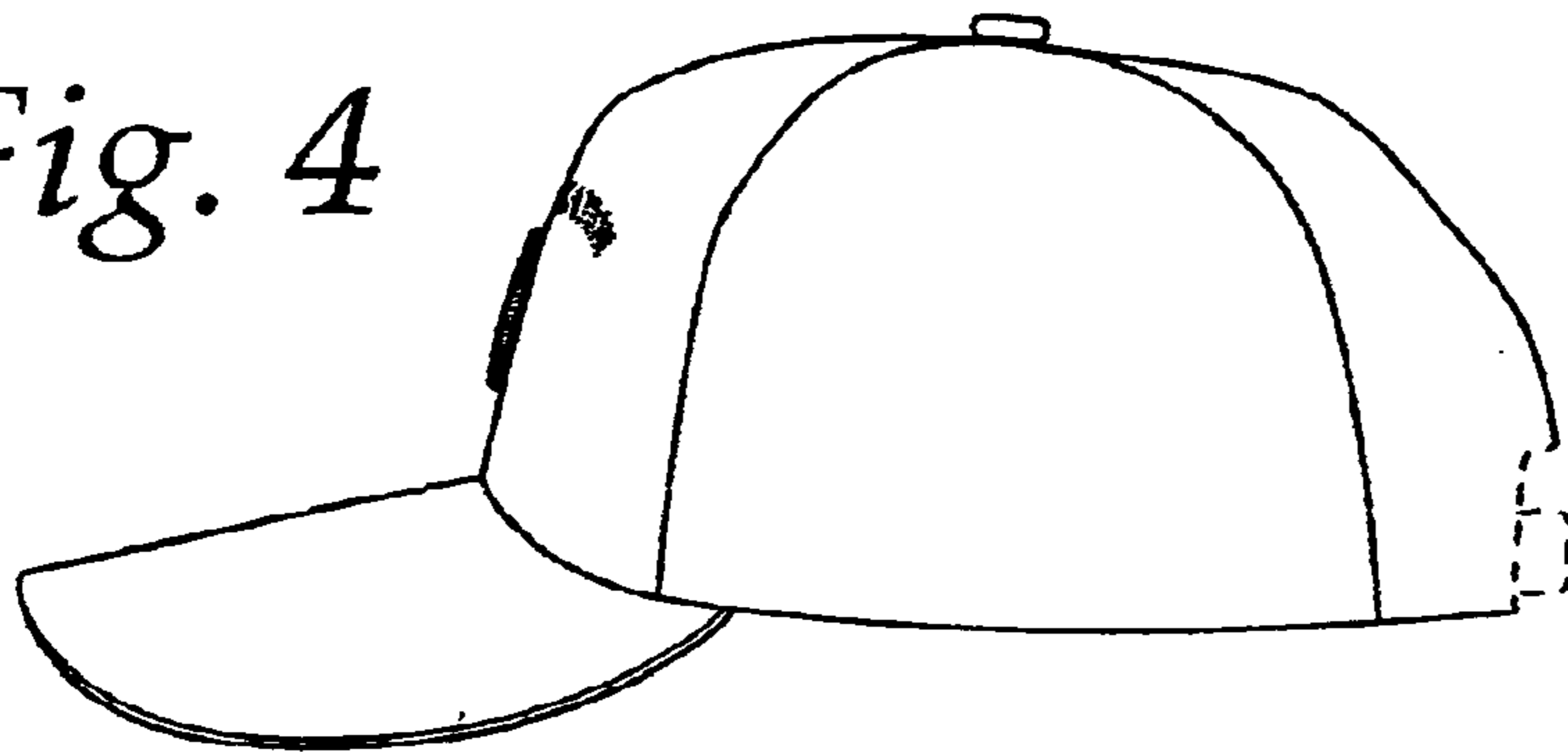

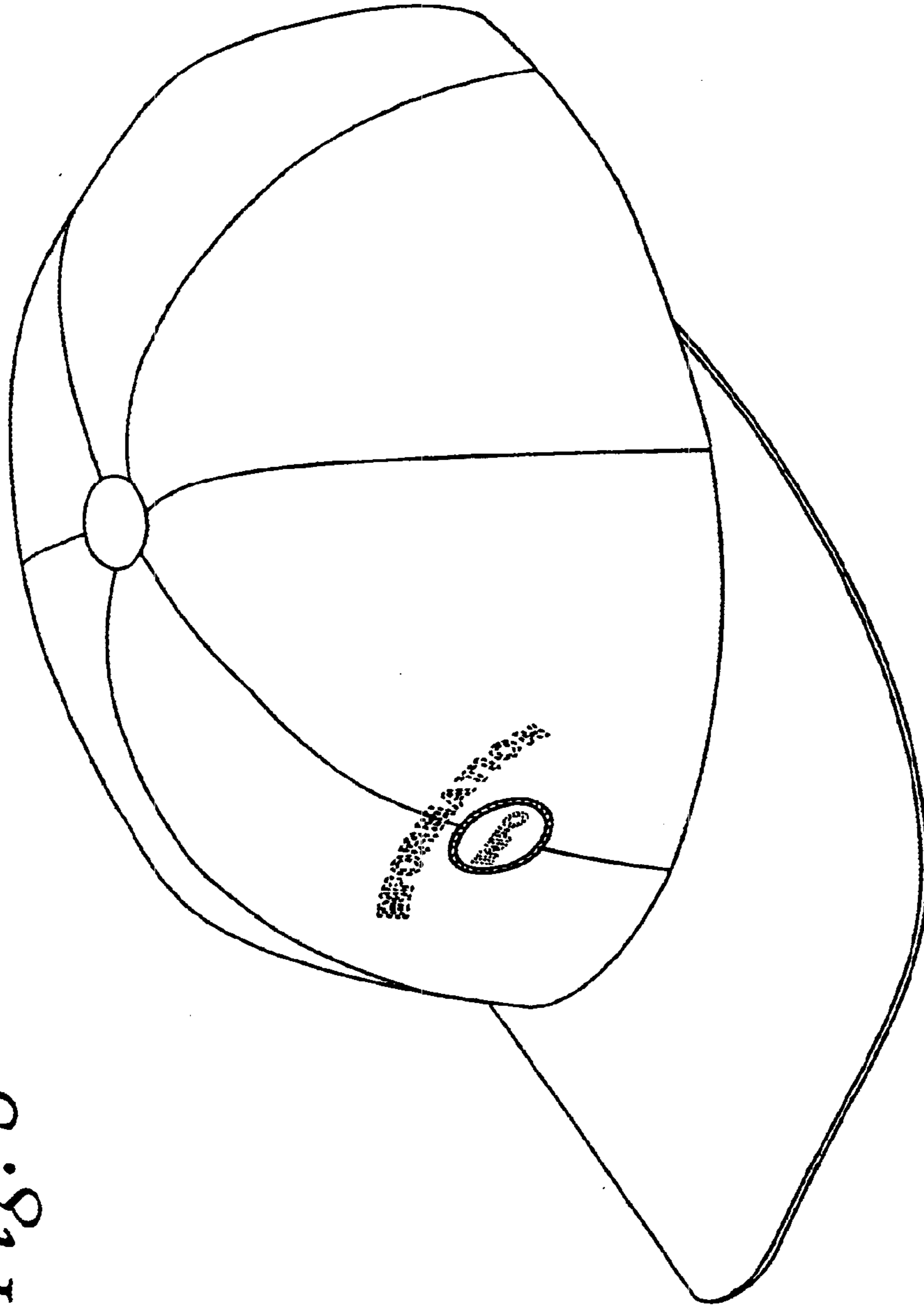

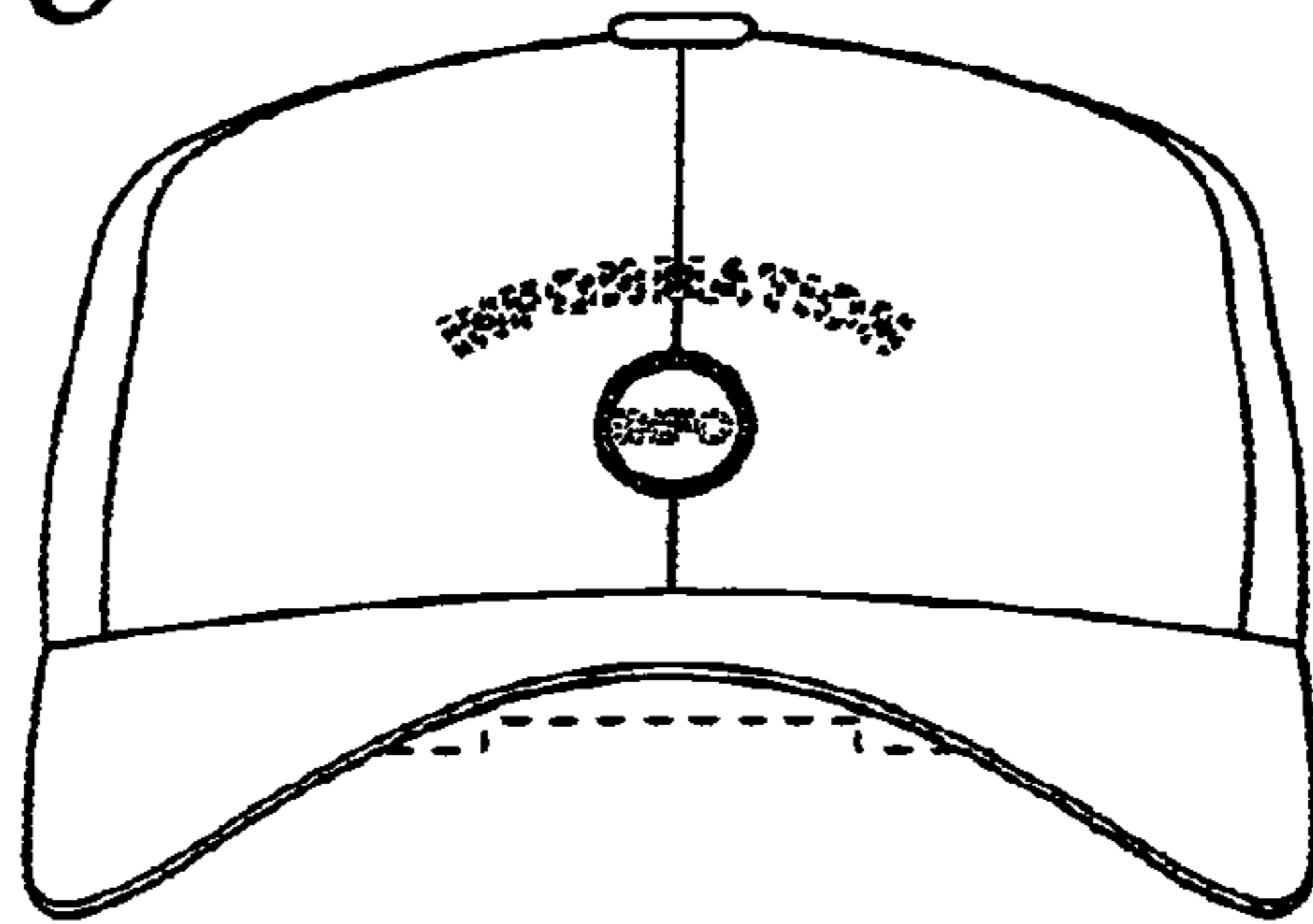

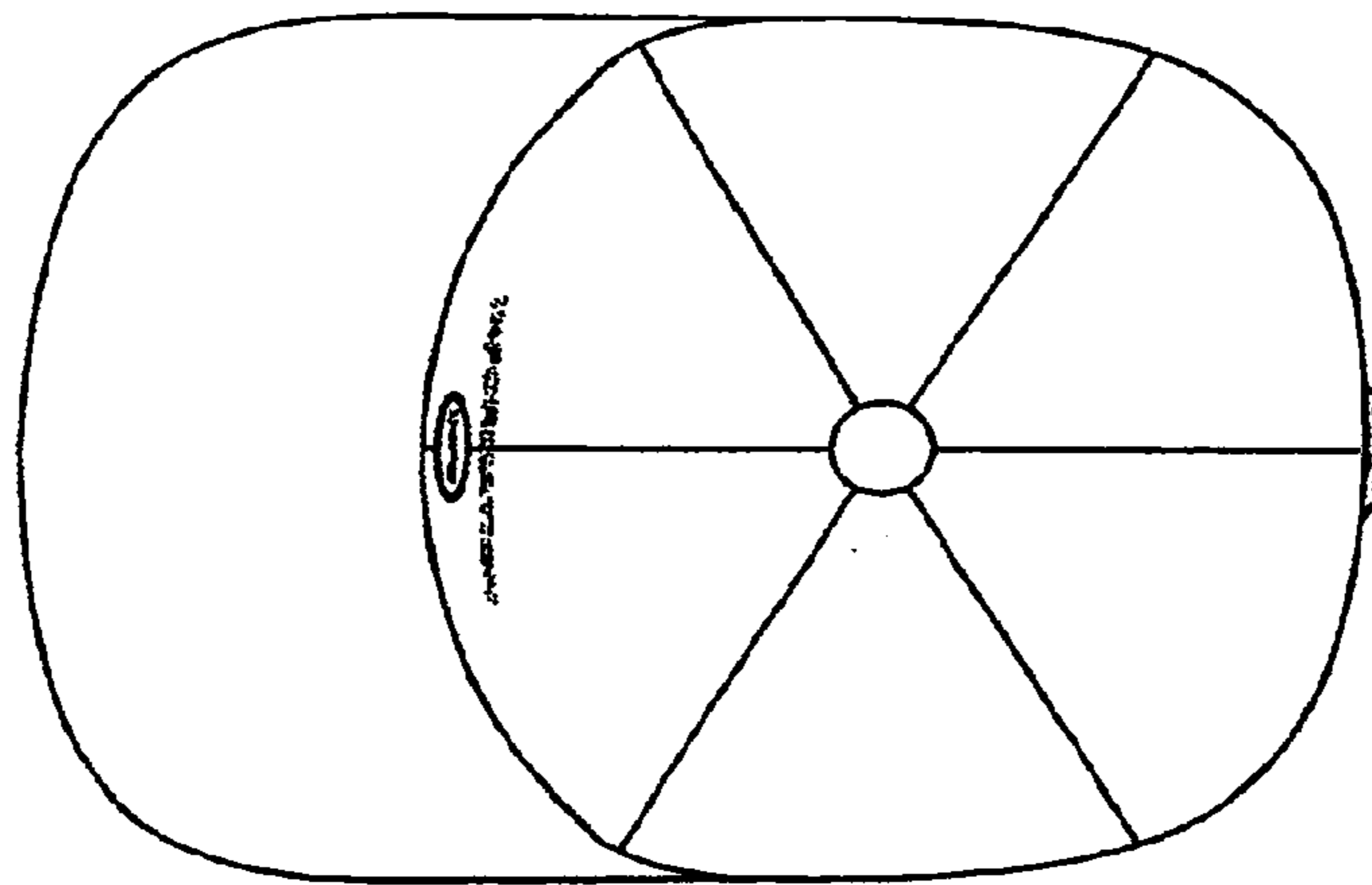
