(57) **CLAIM**

The ornamental design of a combined hairbrush and mirror, as shown and described.

**DESCRIPTION**

FIG. 1 is a top front perspective view of a combined hairbrush and mirror showing my new design.

FIG. 2 is a front elevational view thereof.

FIG. 3 is a rear elevational view thereof.

FIG. 4 is a left side elevational view thereof.

FIG. 5 is a right side elevational view thereof.

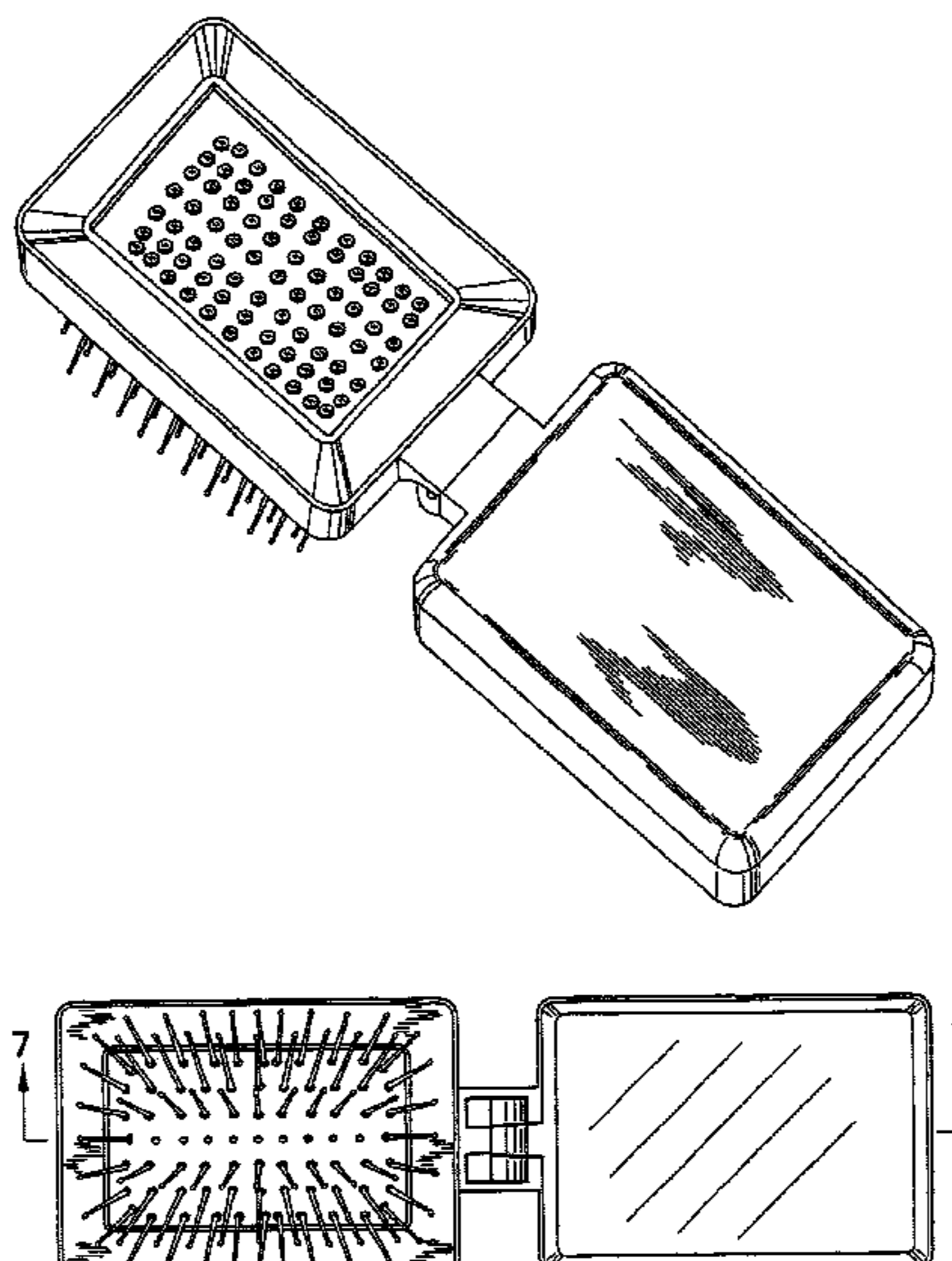
FIG. 6 is a bottom plan view thereof, the top plan view being a mirror image.

FIG. 7 is a sectional view taken along line 7—7 of FIG. 3.

FIG. 8 is a top front perspective view of a combined hairbrush and mirror showing the closed state of the cover; and,

FIG. 9 is a rear perspective view of a combined hairbrush and mirror showing the closed state of the cover.

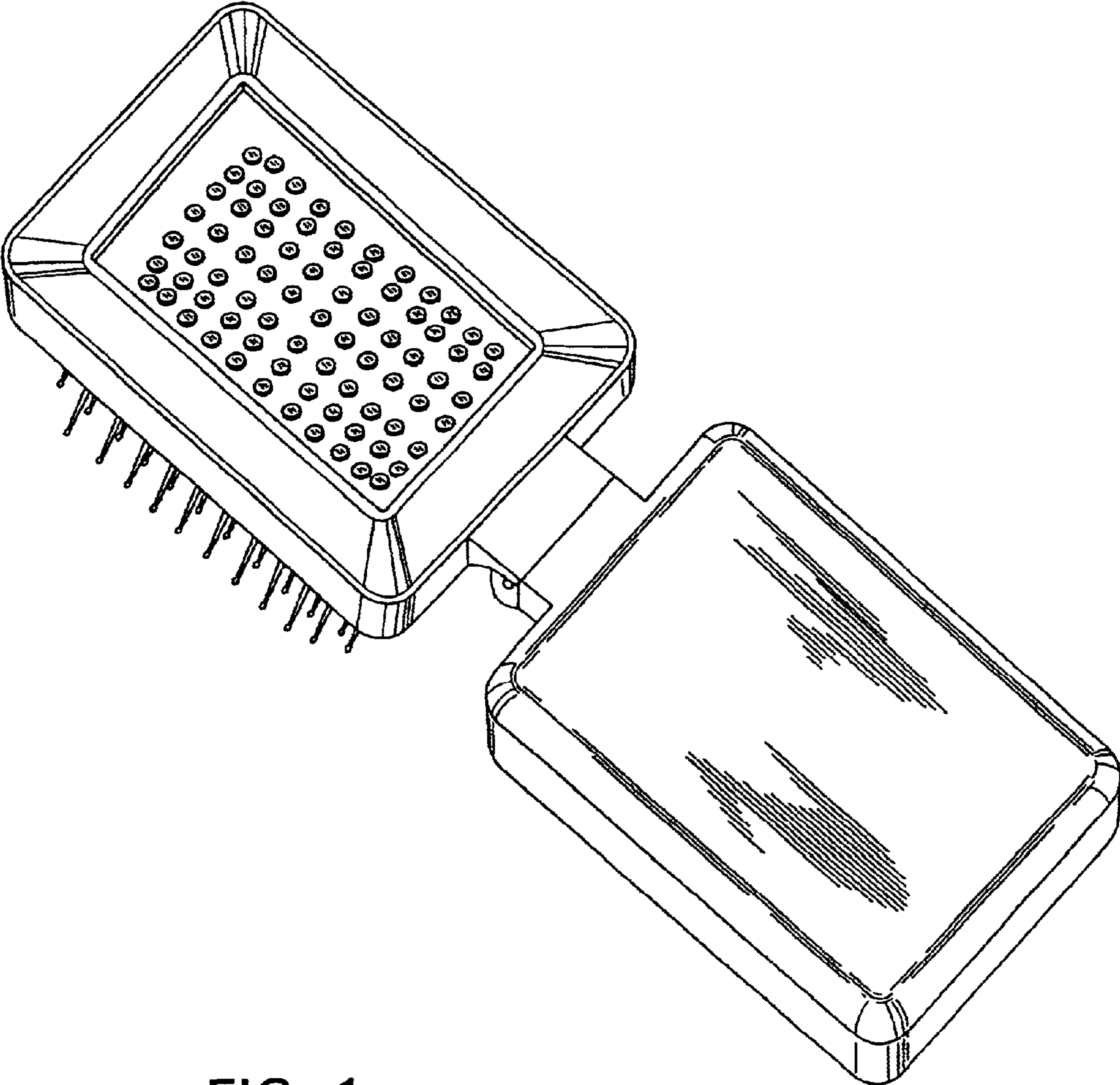

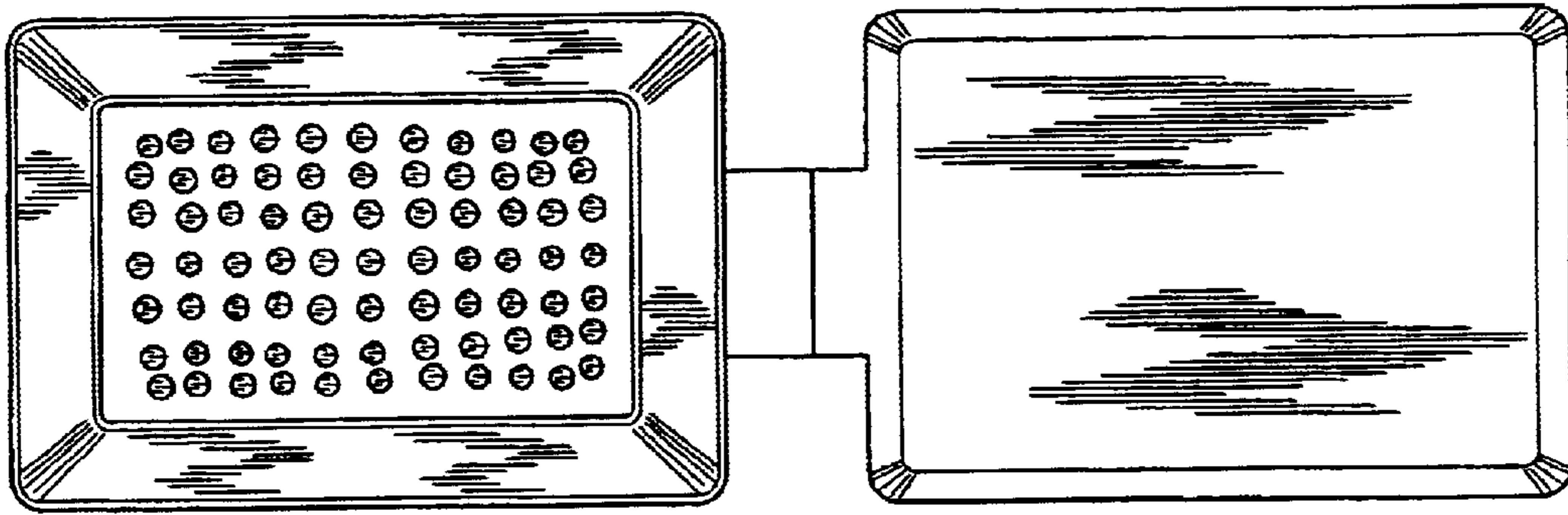

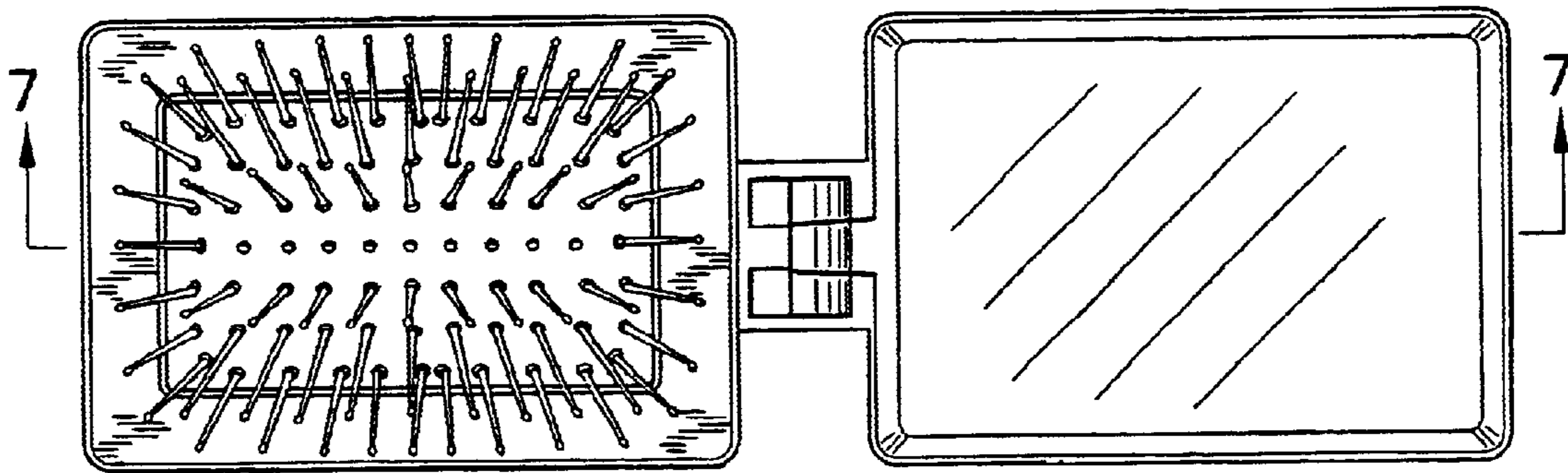

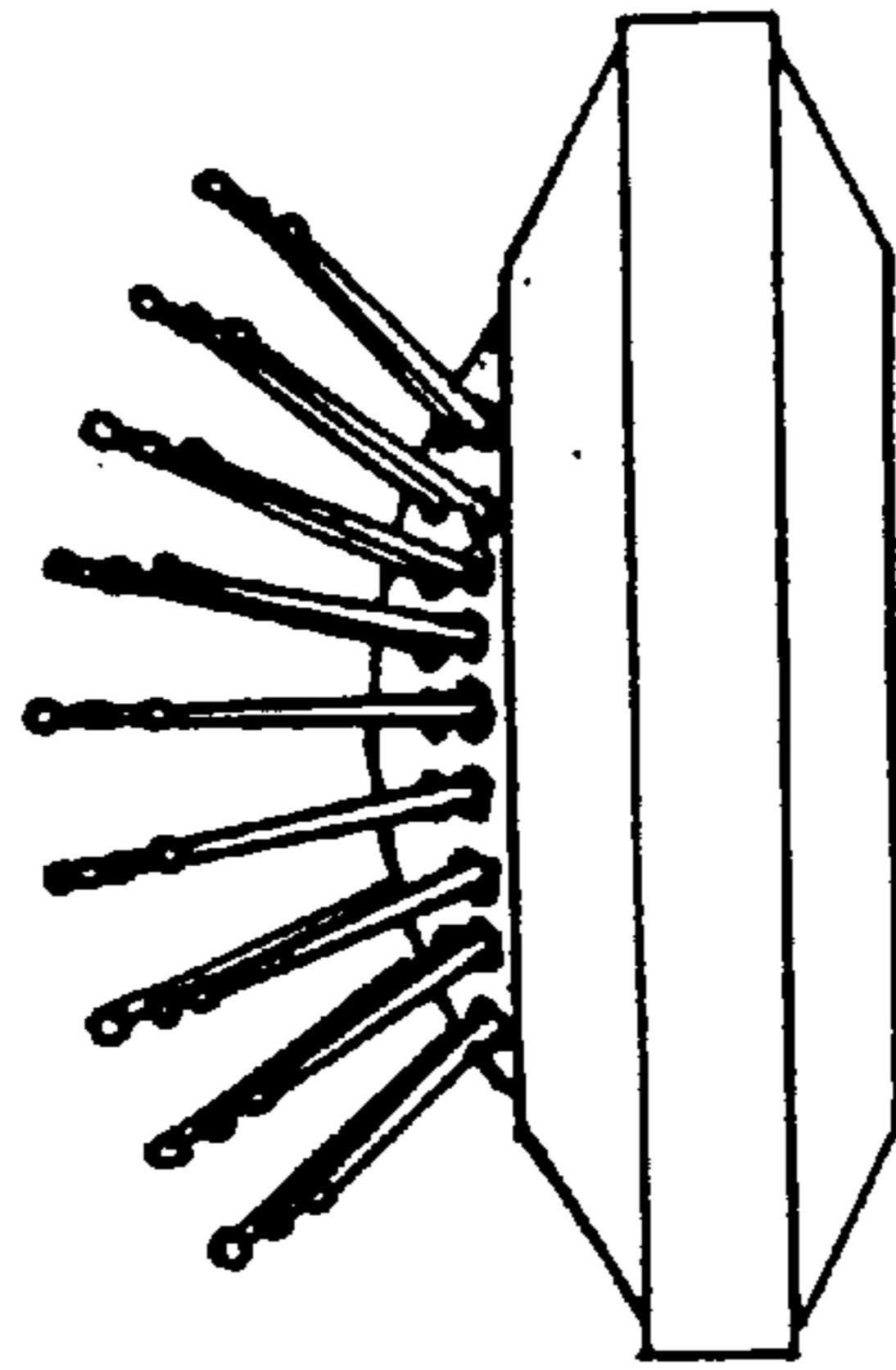

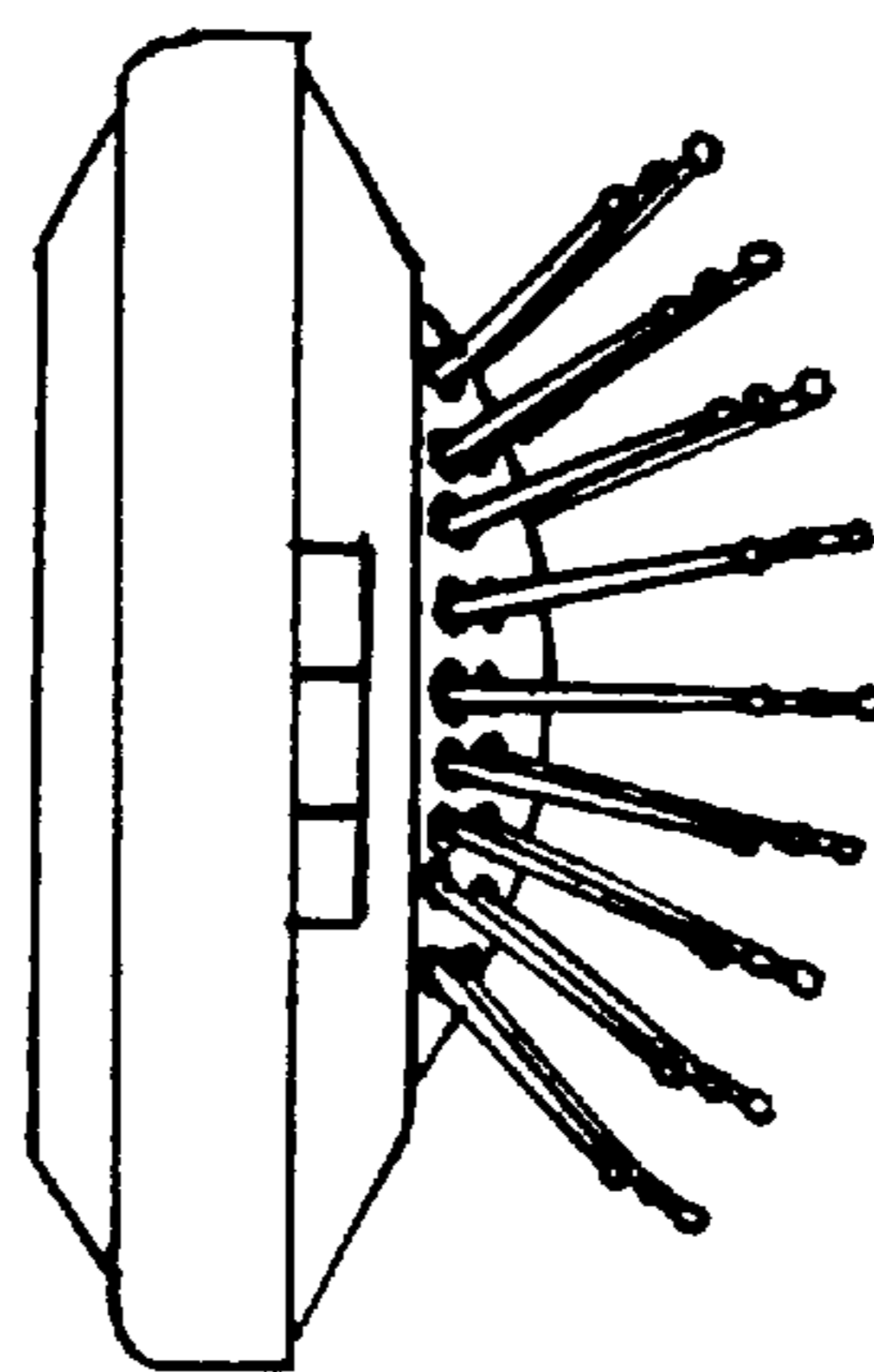

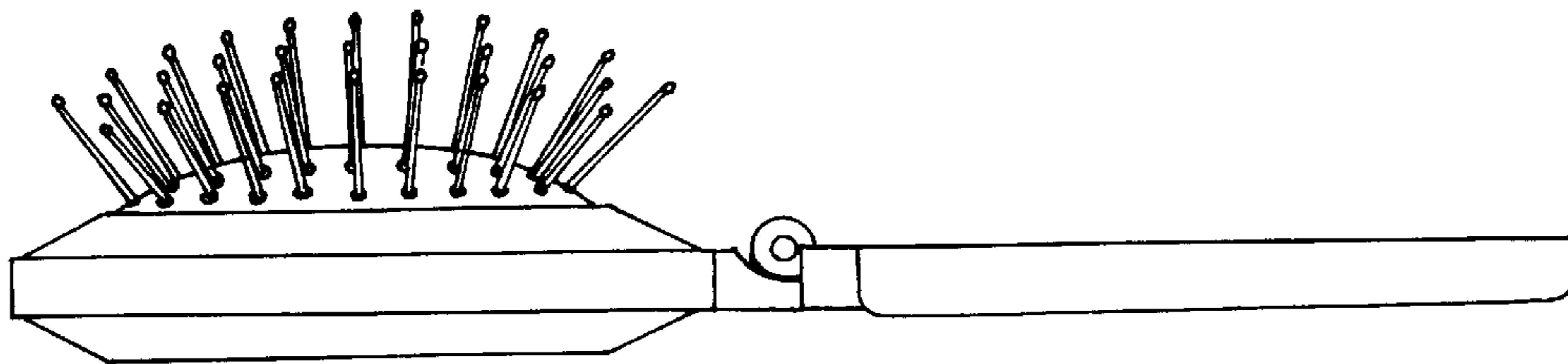

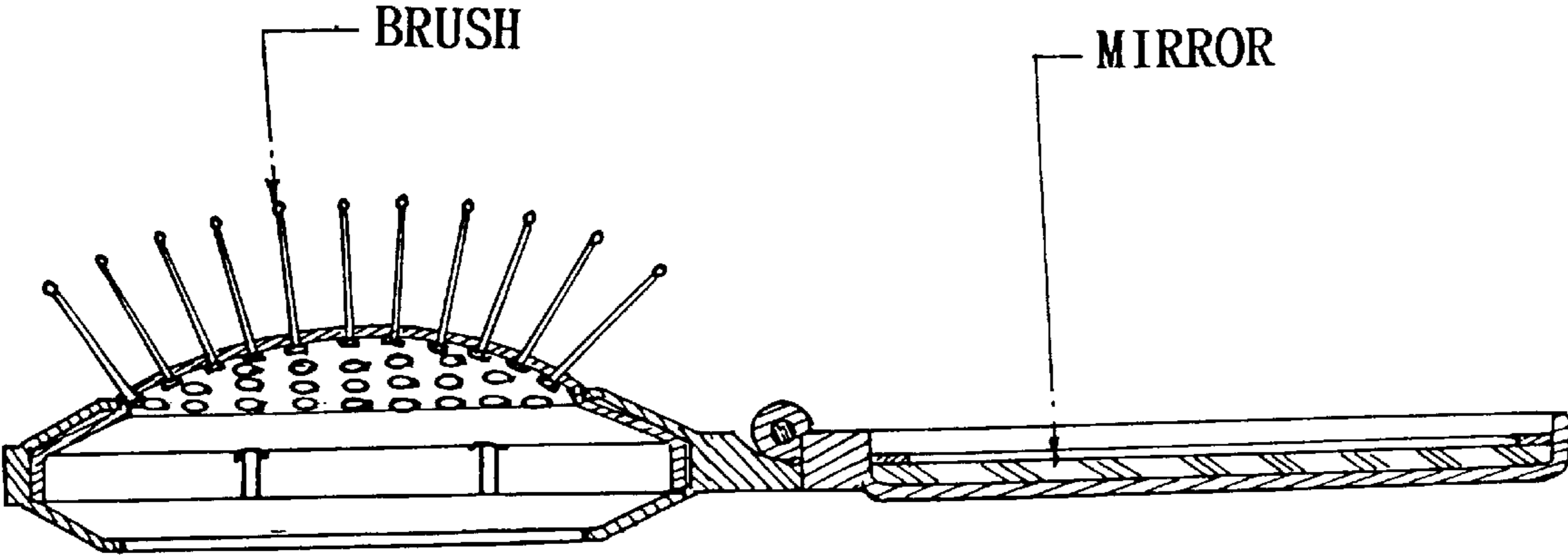

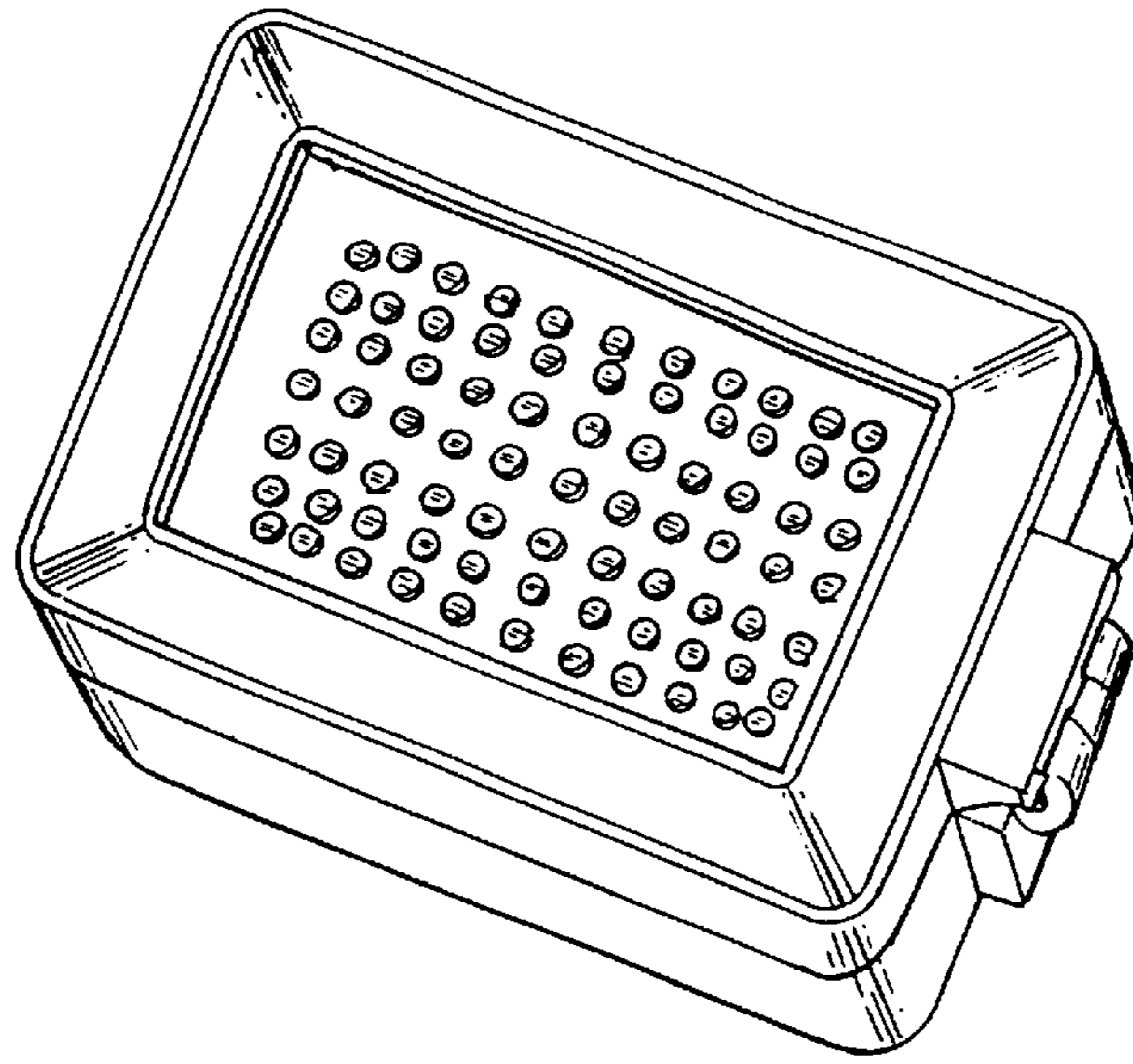

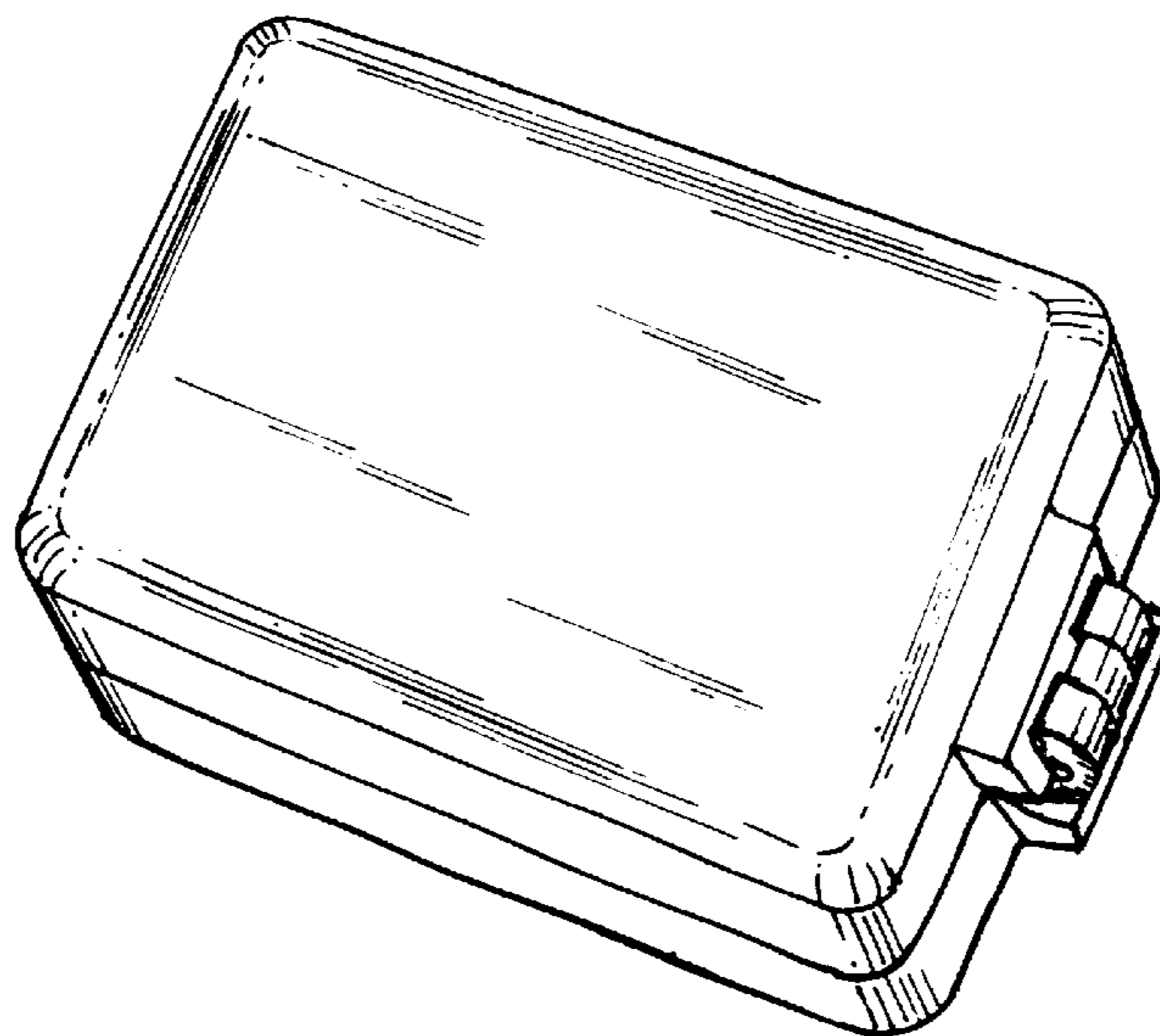
