(57) **CLAIM**

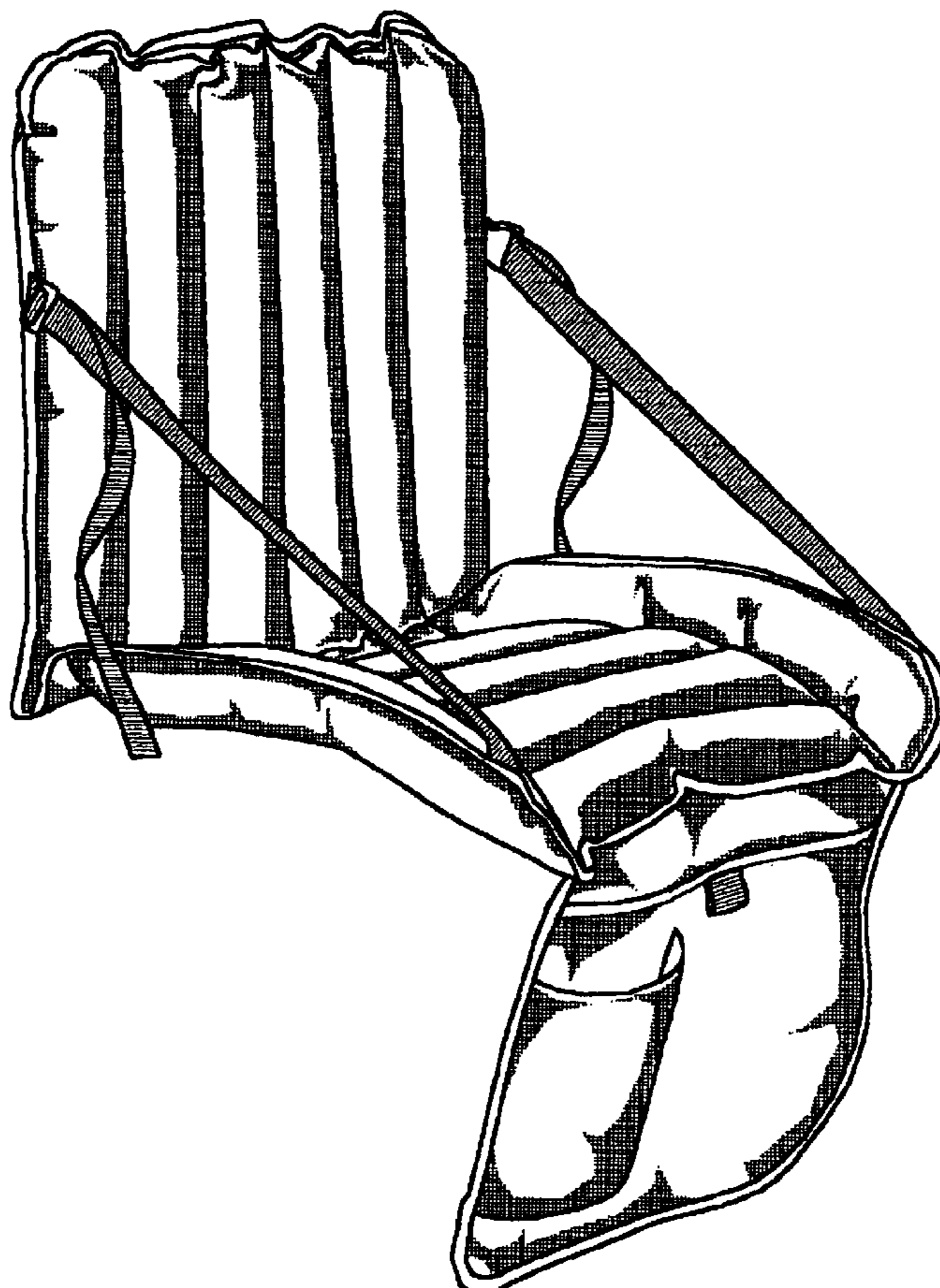
I claim the ornamental design for the inflatable stadium or bleacher seat, as shown.

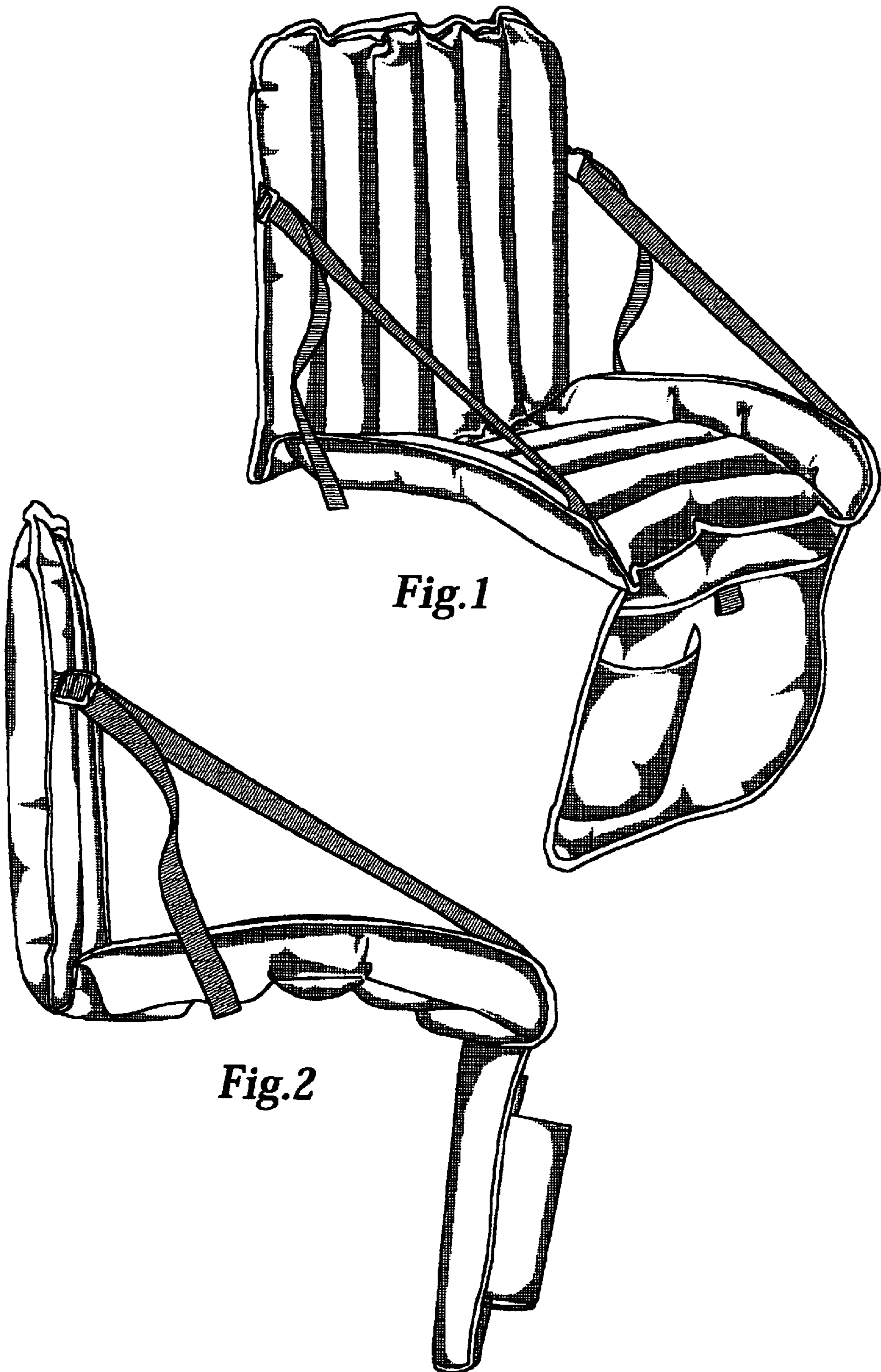
**DESCRIPTION**

FIG. 1 is a perspective view of the inflatable stadium or bleacher seat;

FIG. 6 is a bottom view thereof.

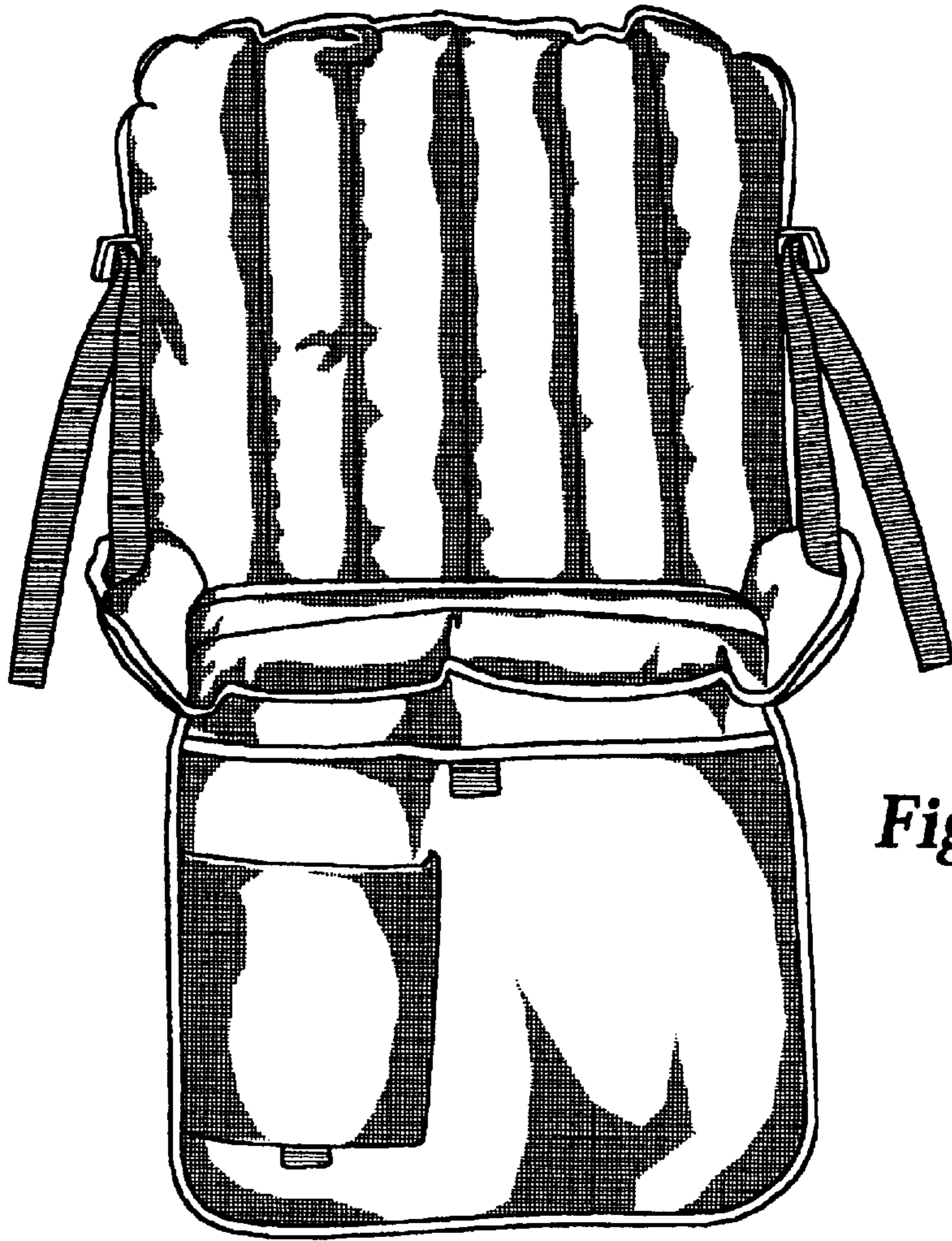
The cross-hatching pattern shown in the drawing is understood to be repeated uniformly throughout the circumscribed area.

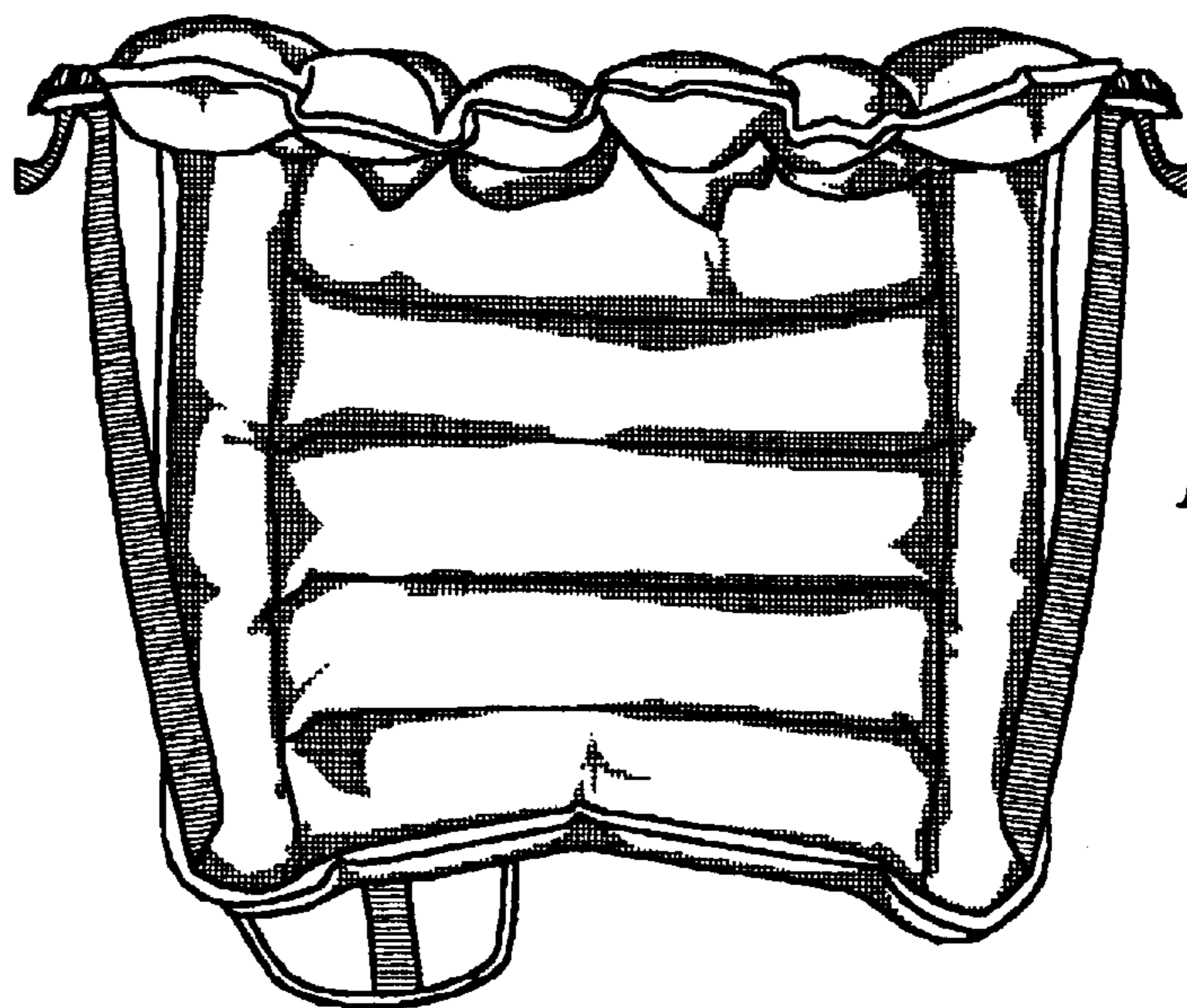




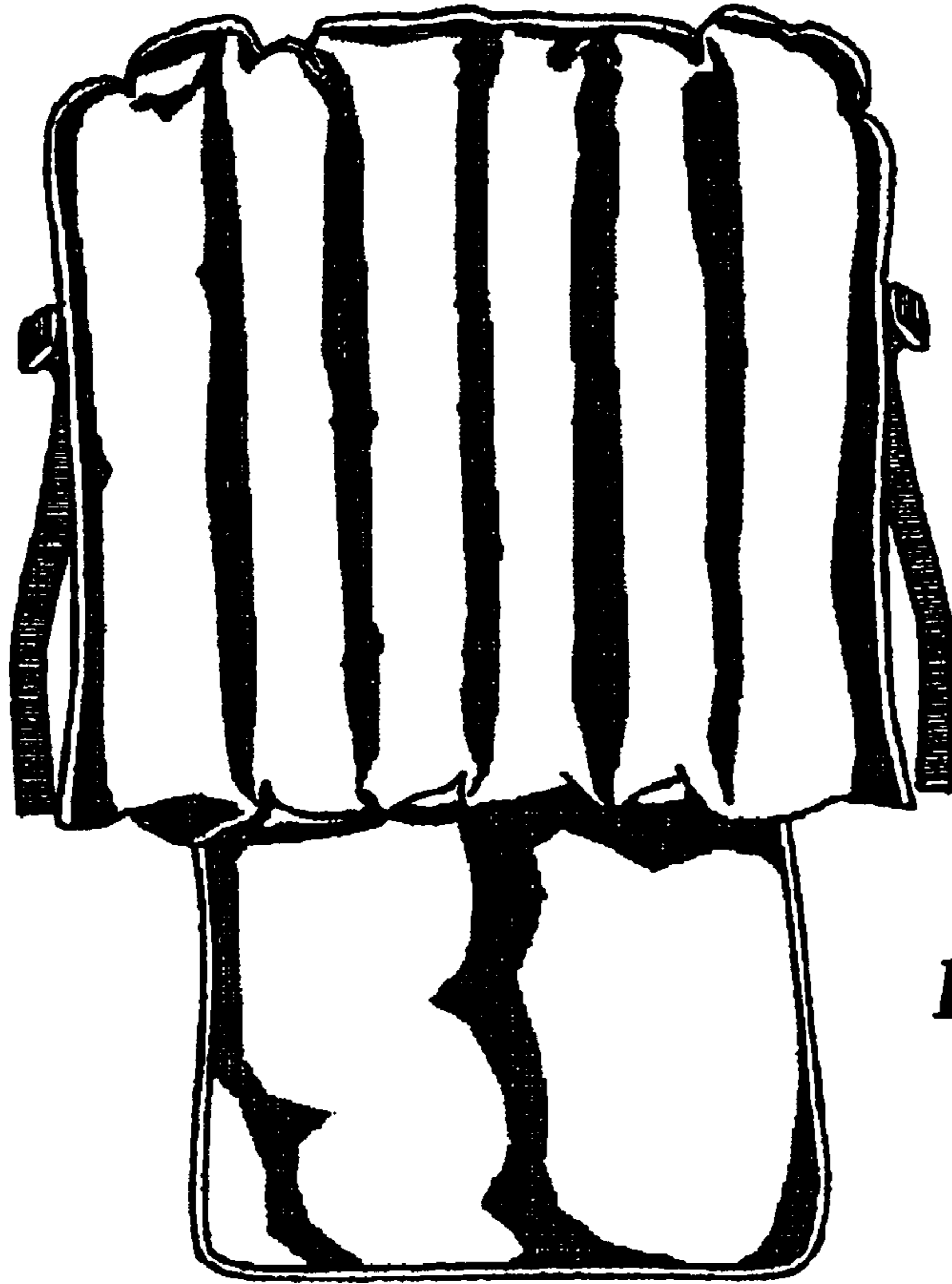
