The ornamental design for a splash prevention device for use with hot beverage cups and lids, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a splash prevention device for use with hot beverage cups and lids.

FIG. 3 is a rear elevational view thereof;

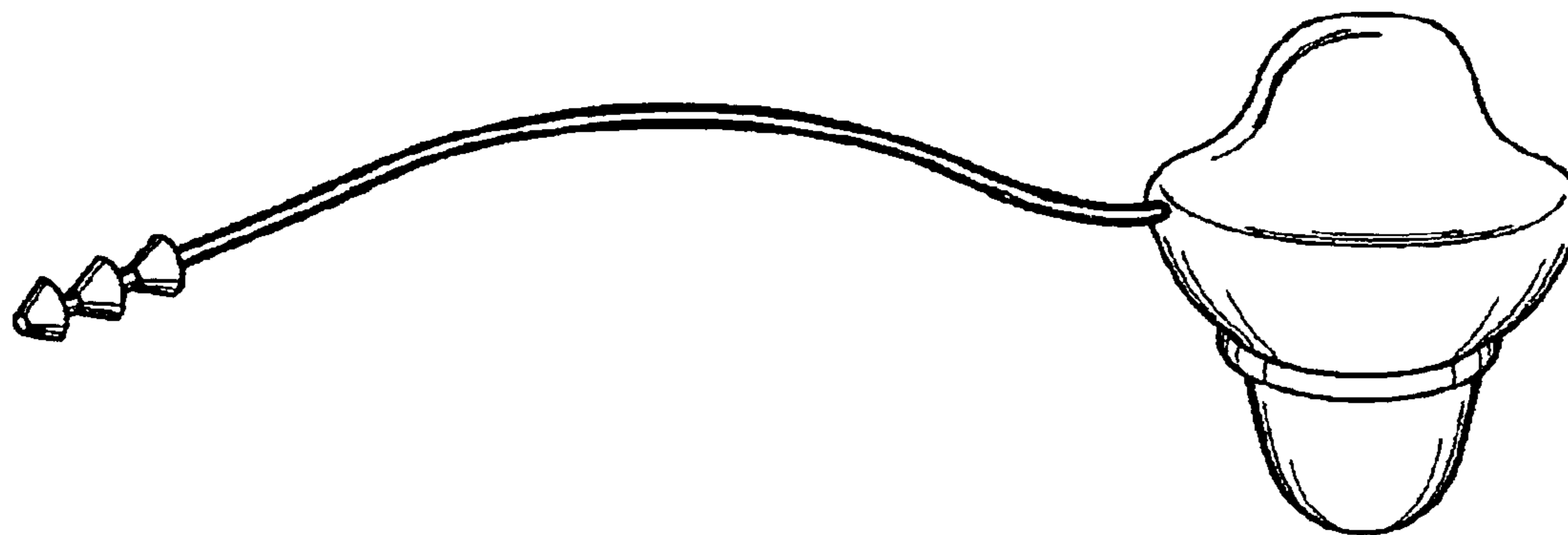
FIG. 4 is a right side elevational view thereof.

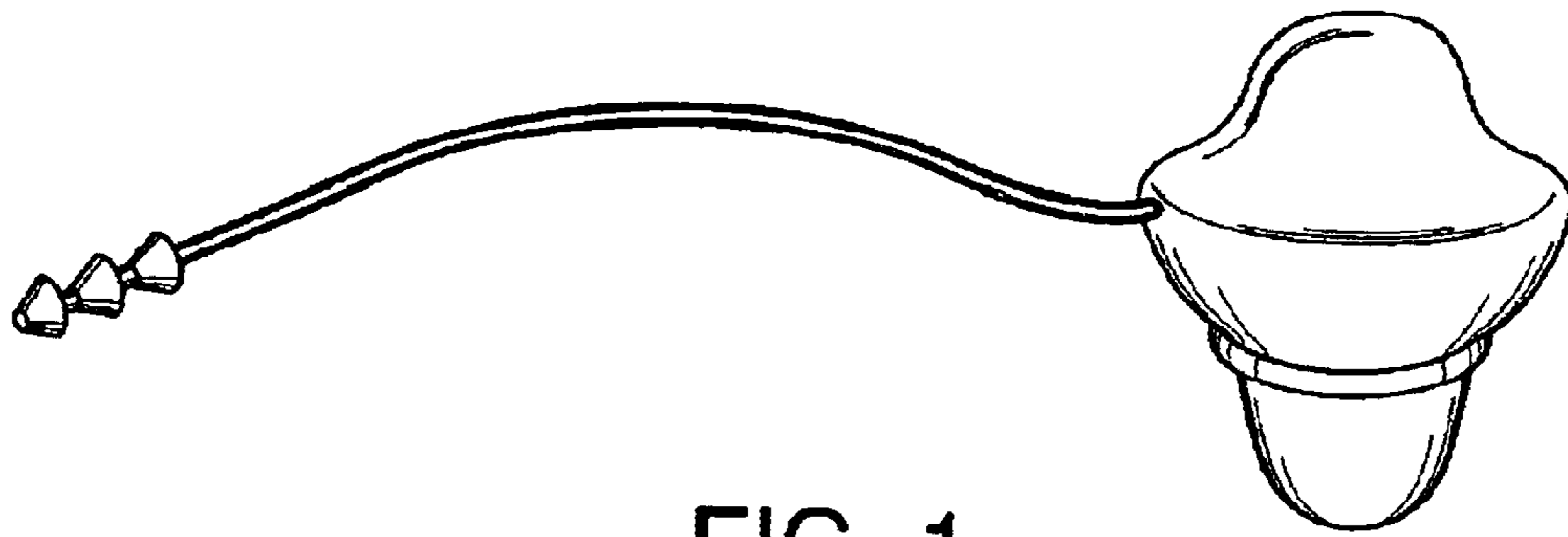

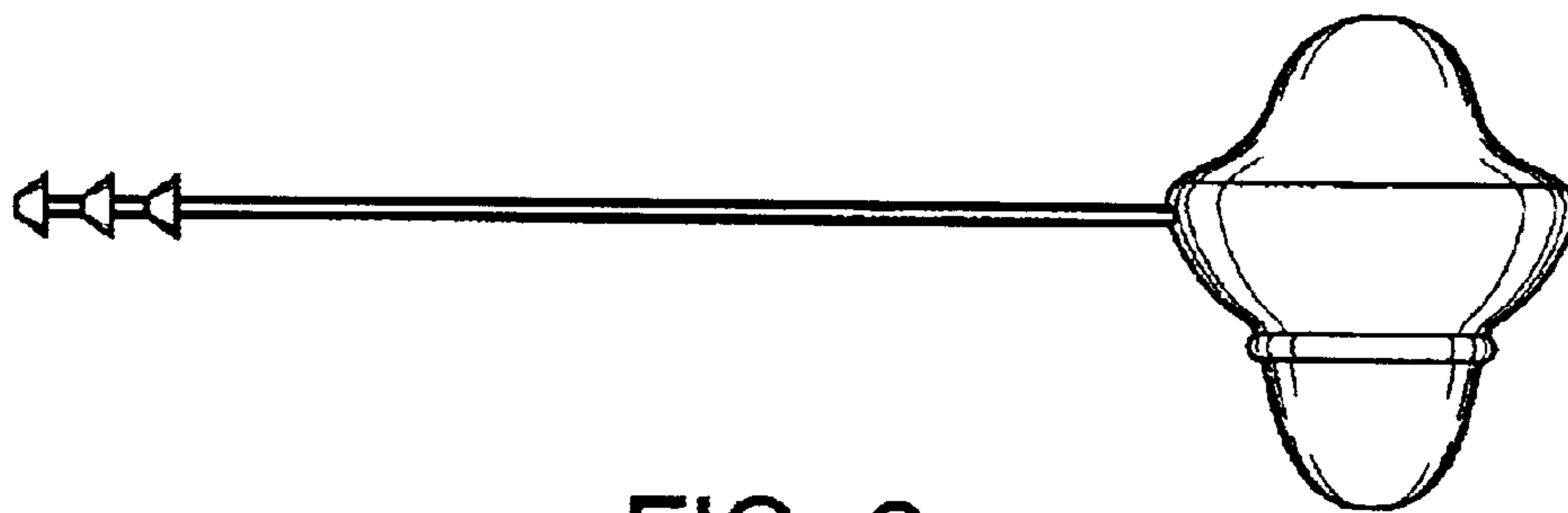

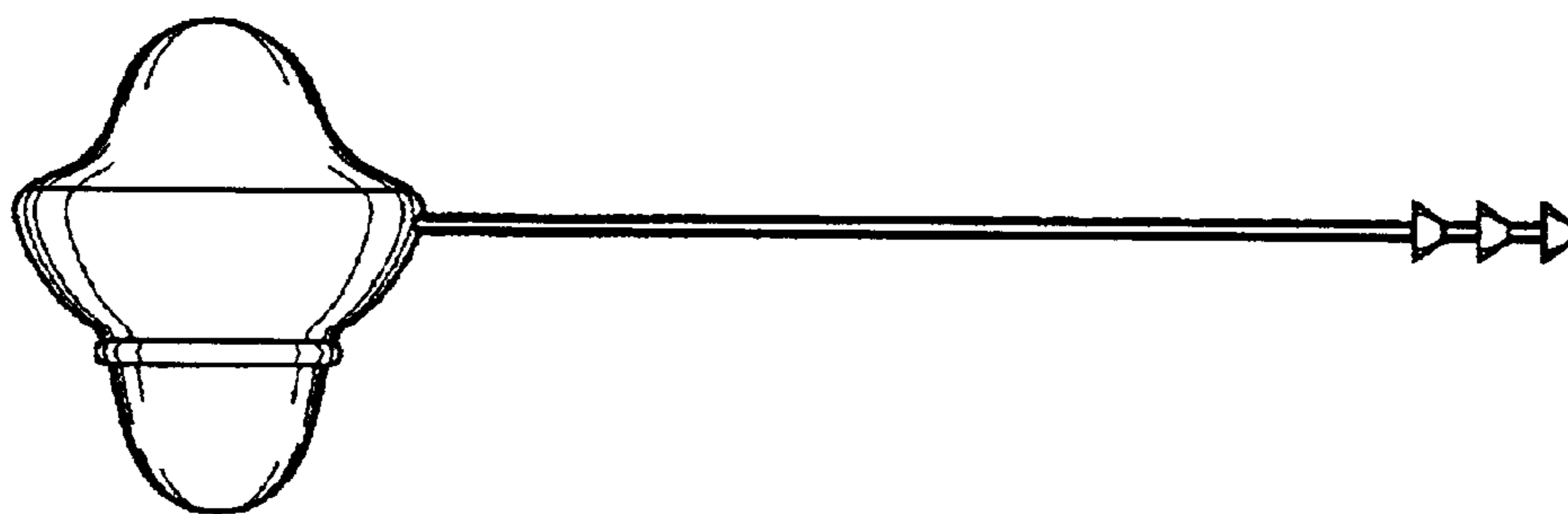

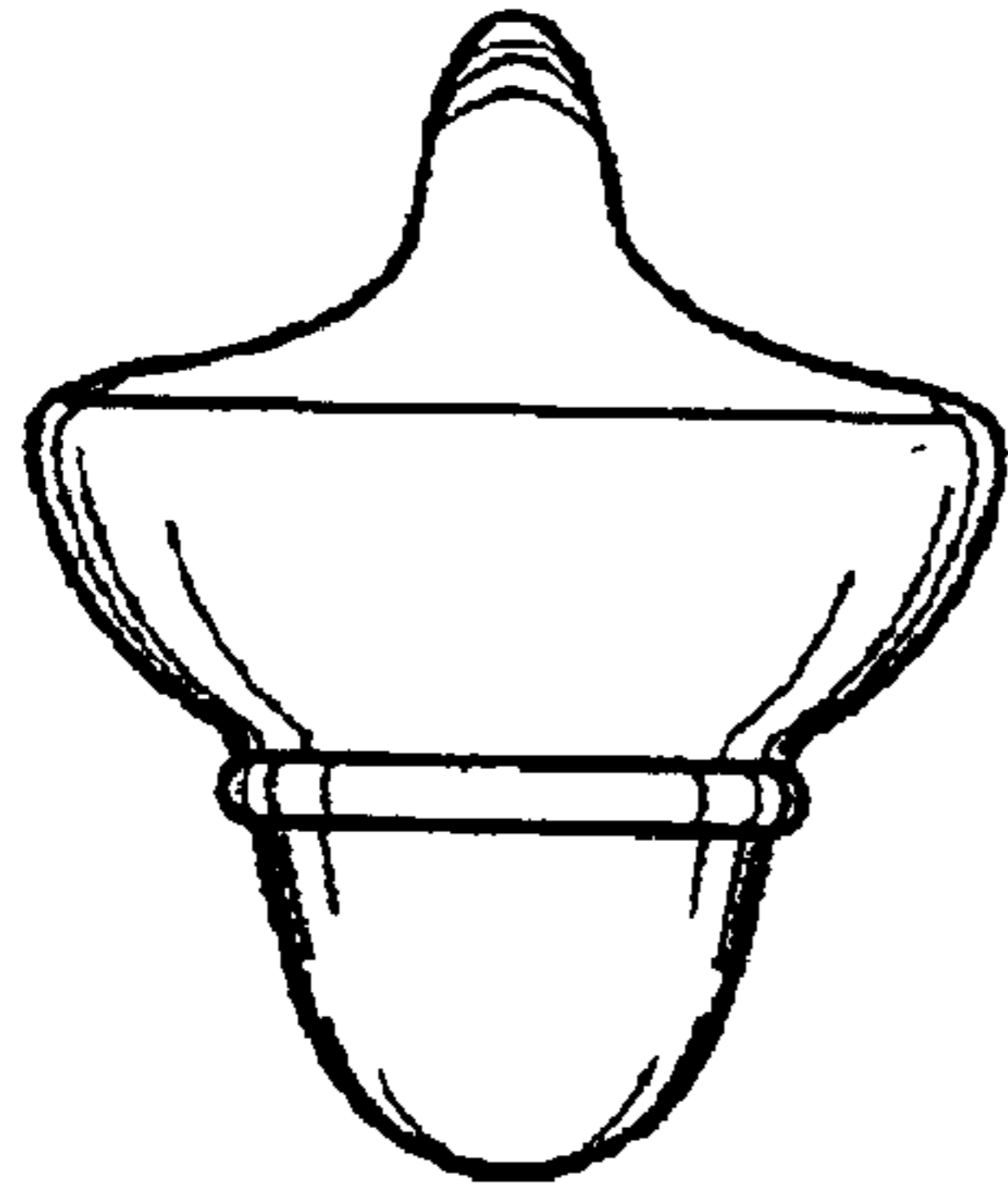

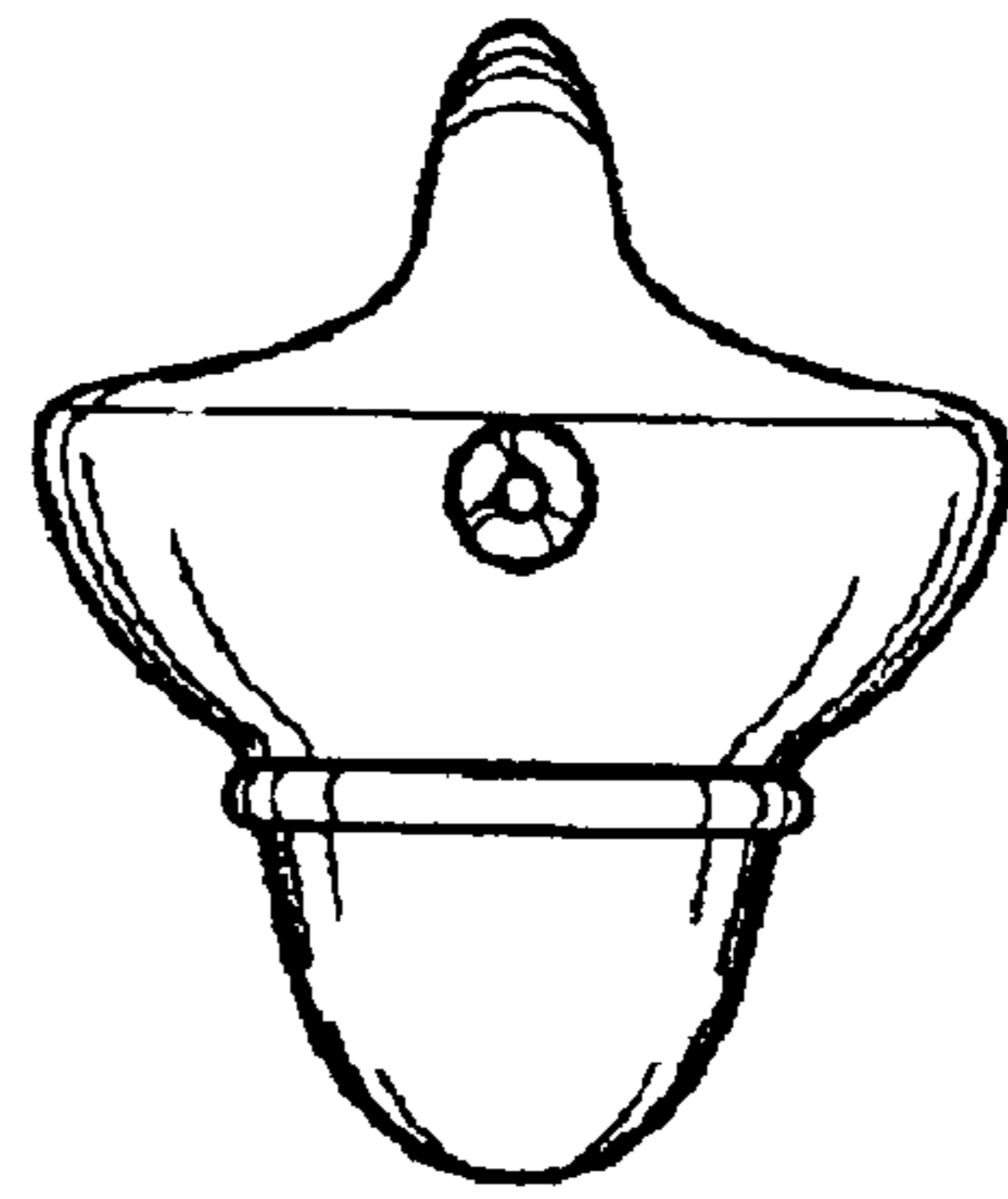

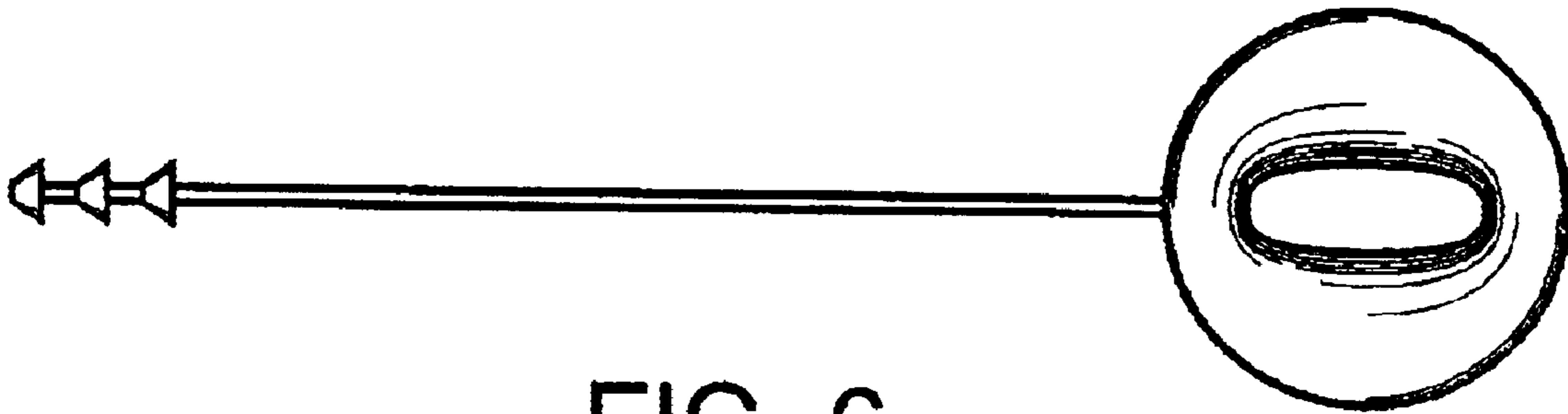

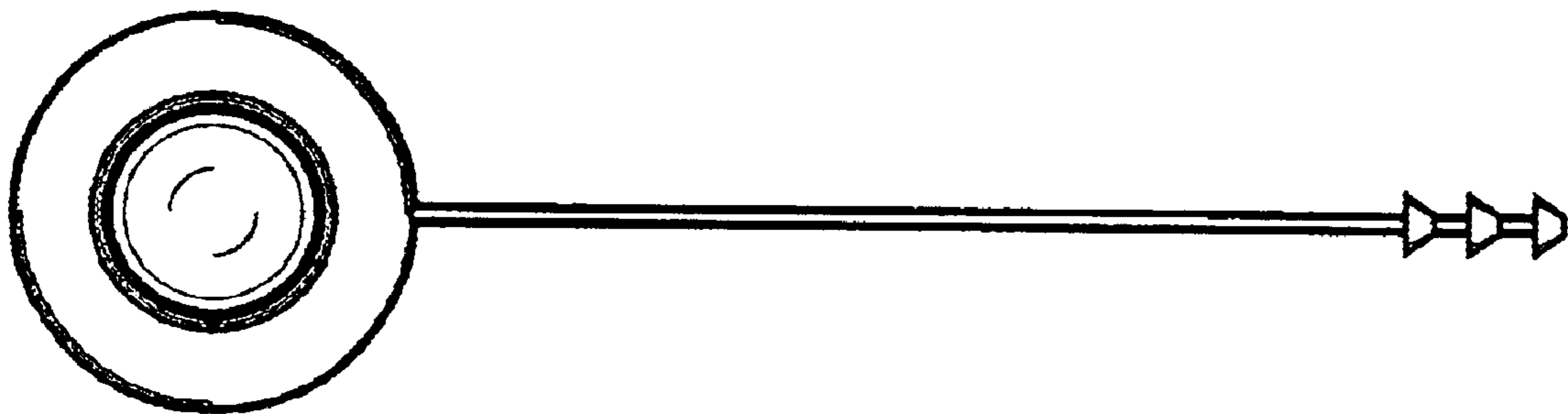
