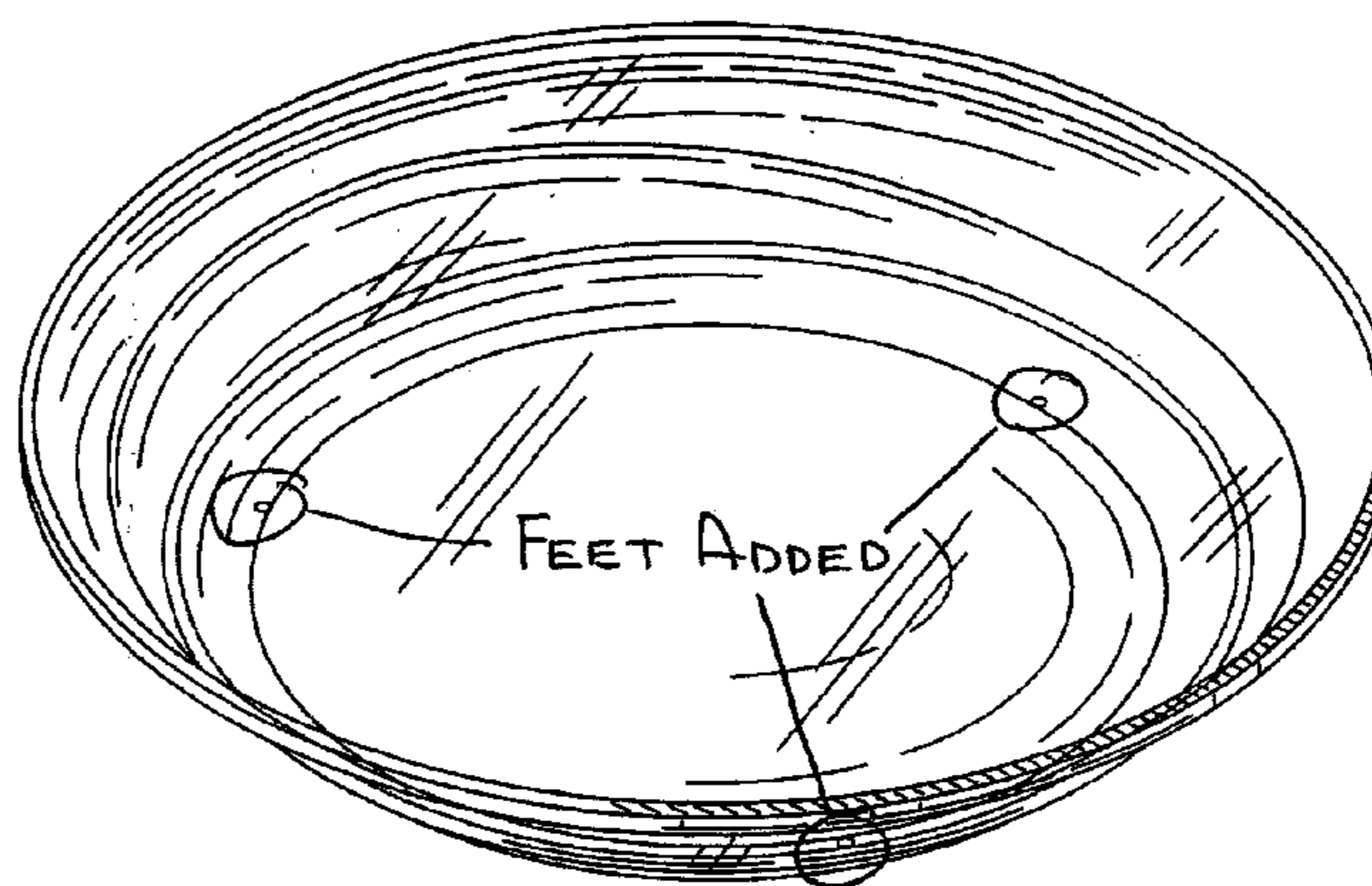
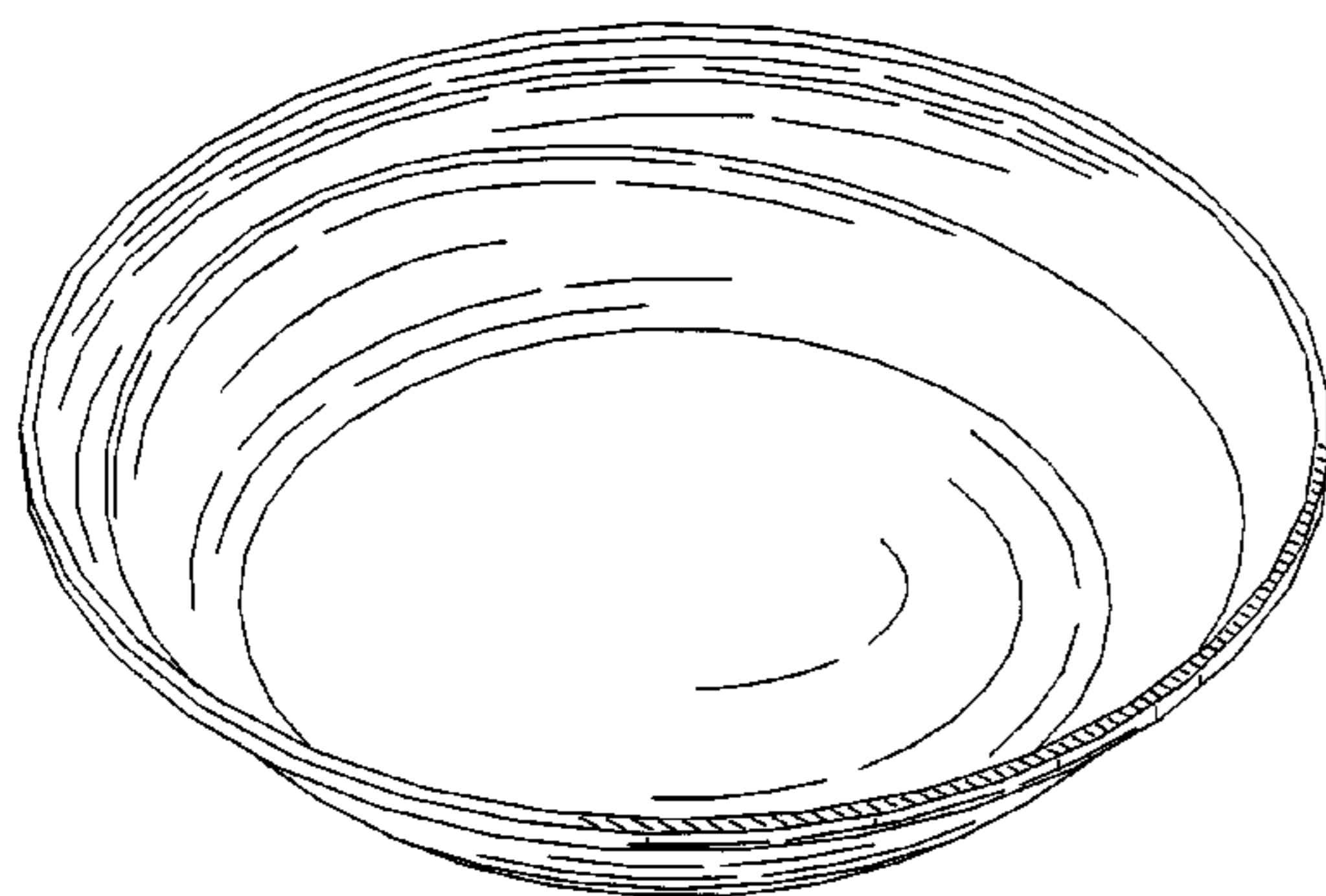
(57) **CLAIM**

The ornamental design for a shallow serving bowl, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, side and front perspective view of a shallow serving bowl showing the new design;  
 FIG. 2 is a front elevation view thereof;

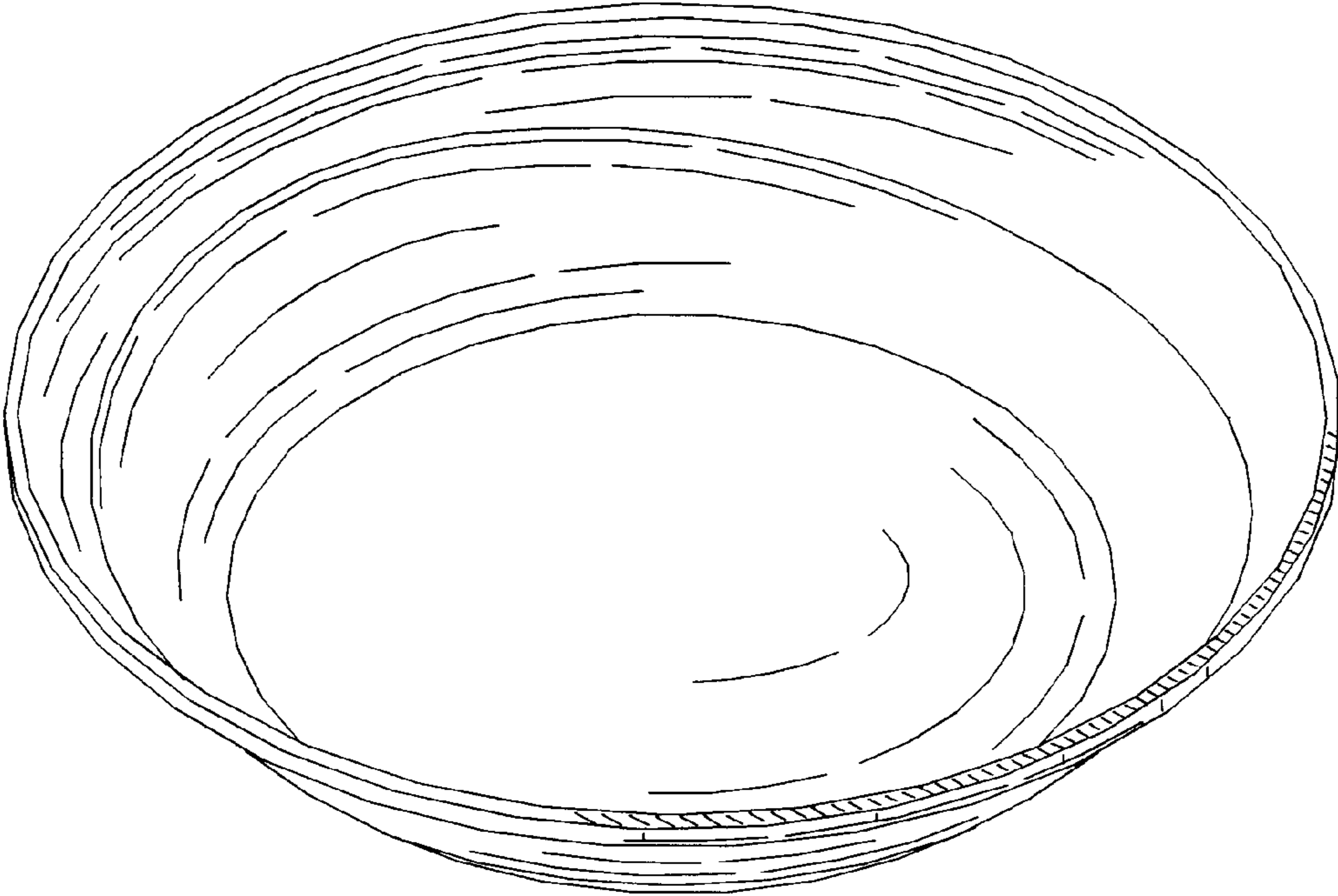

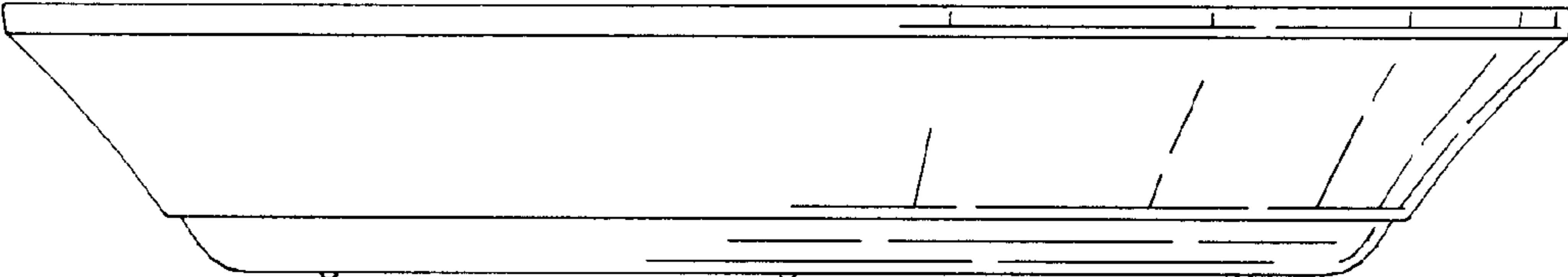

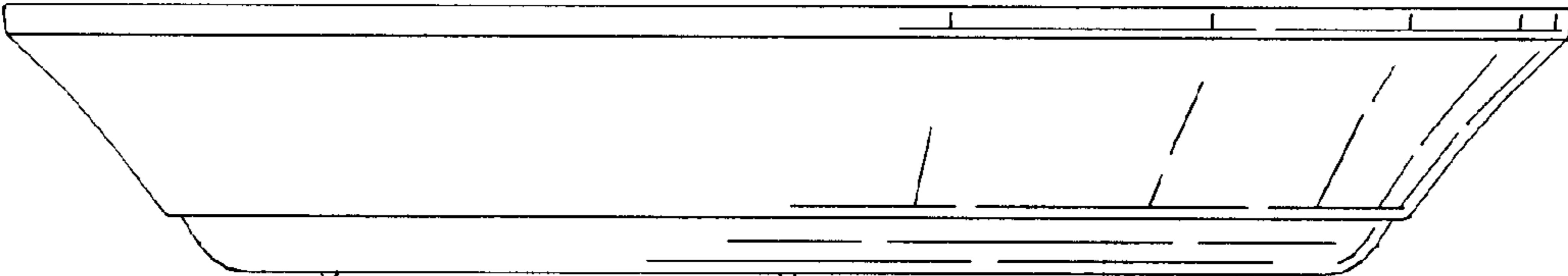

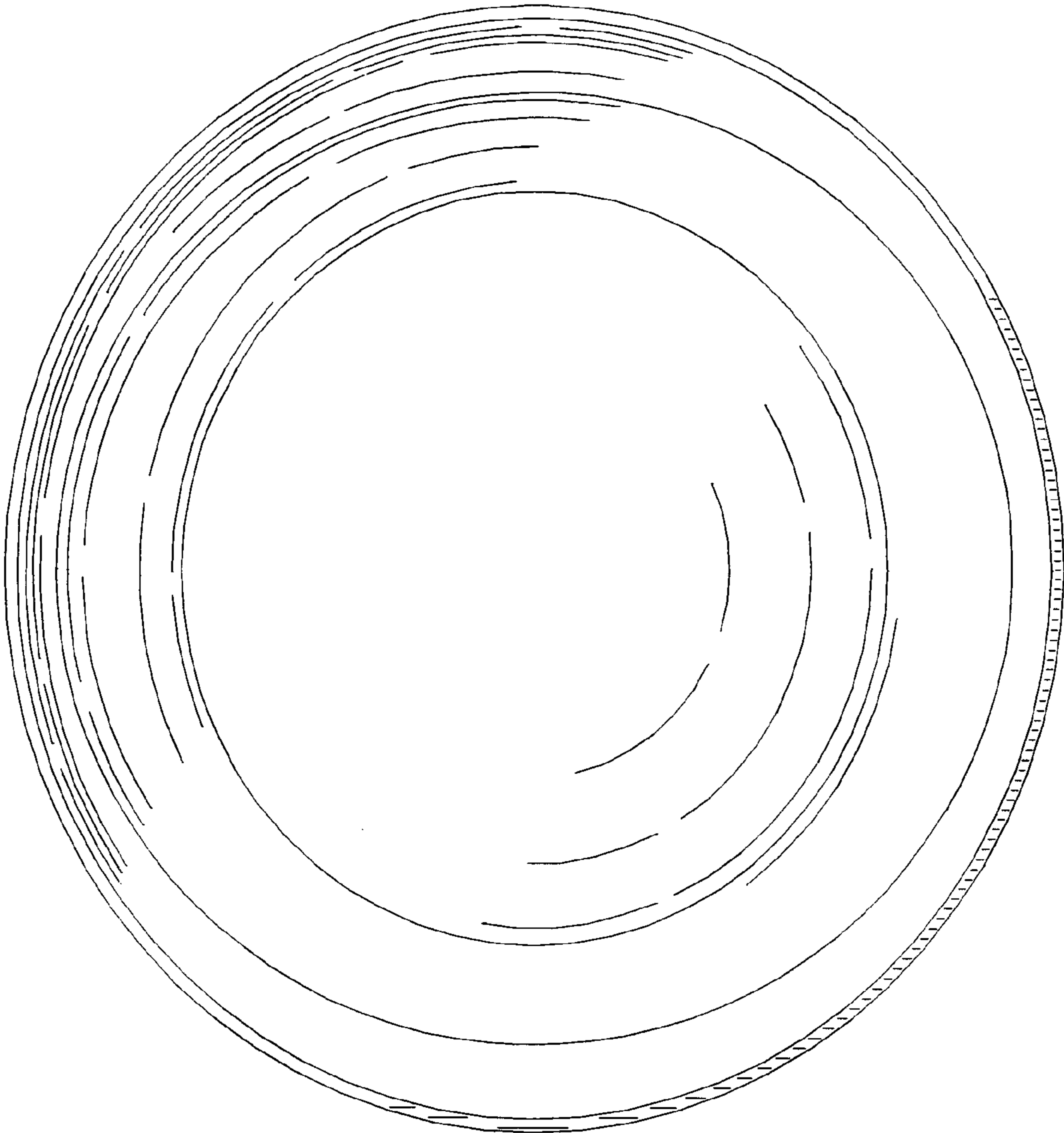

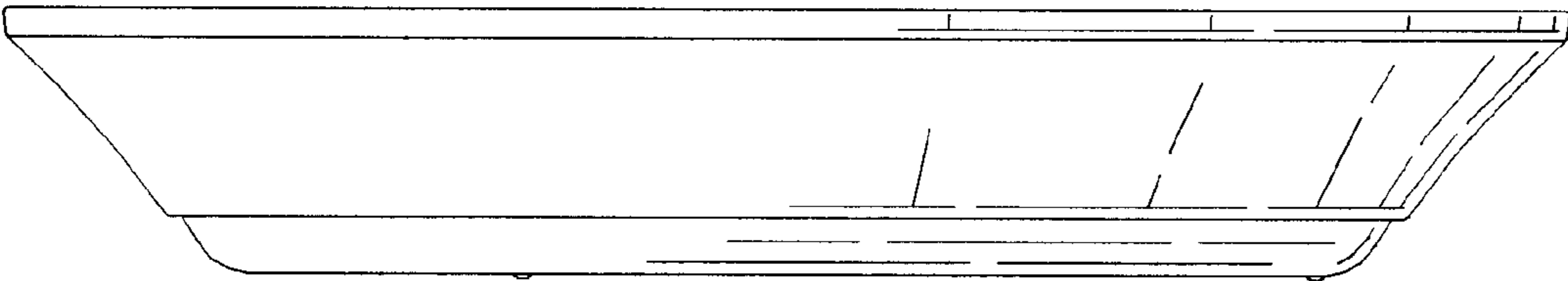

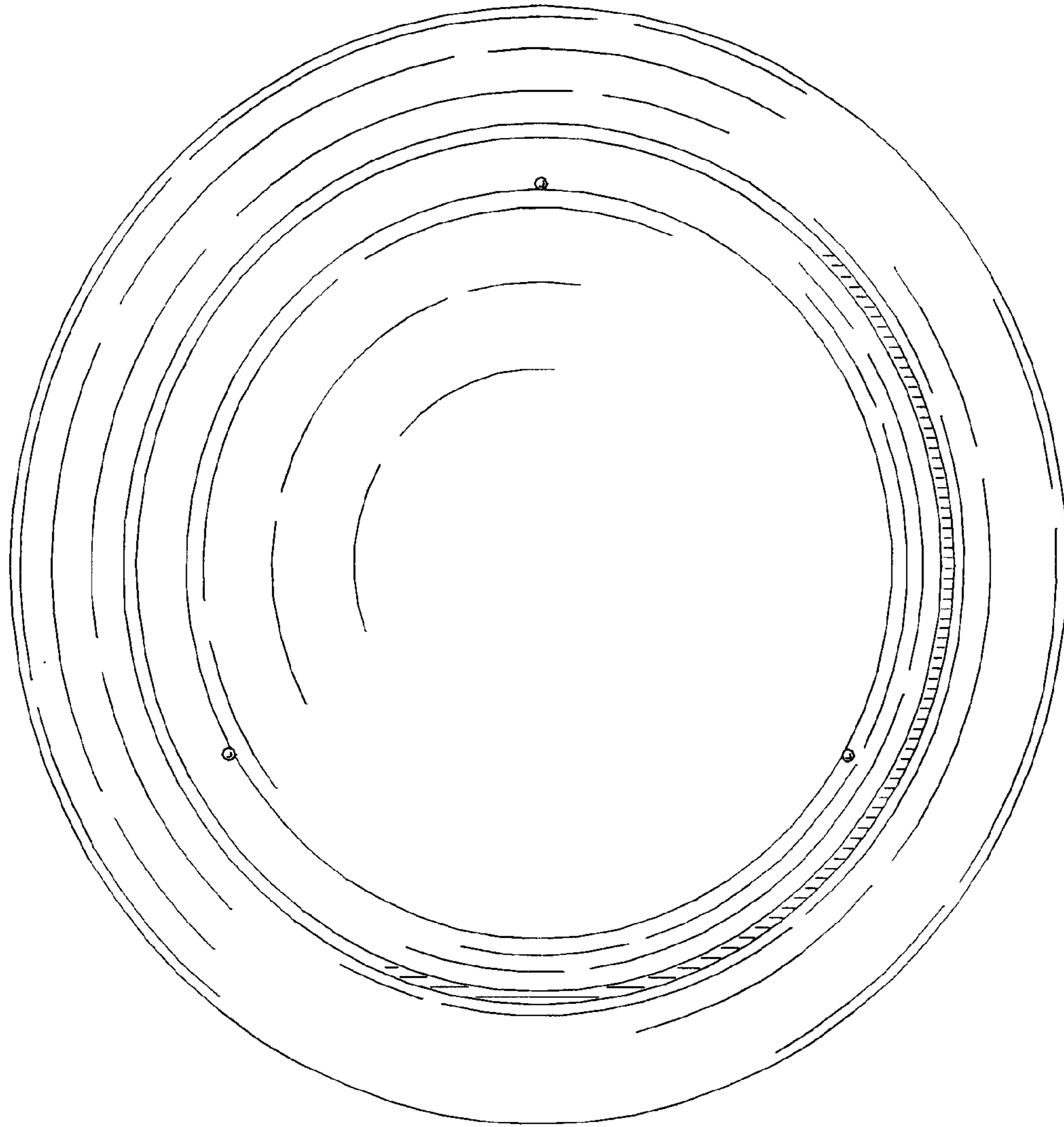

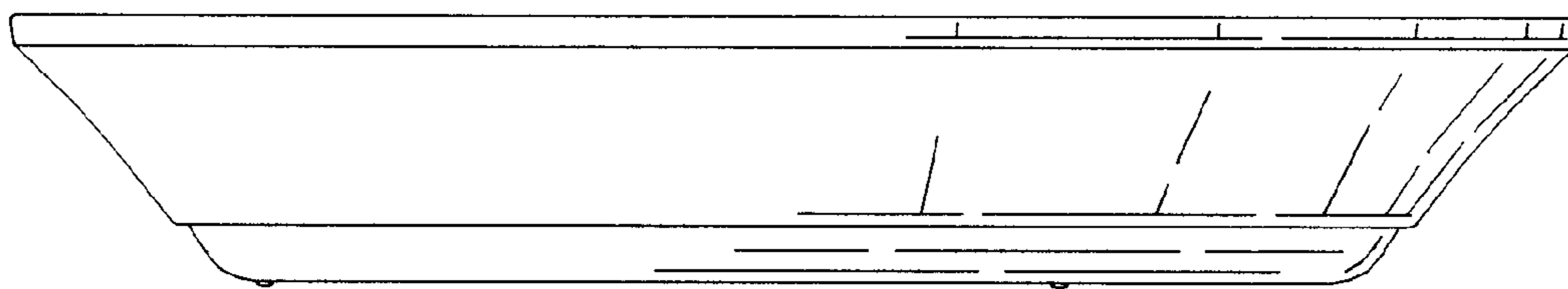

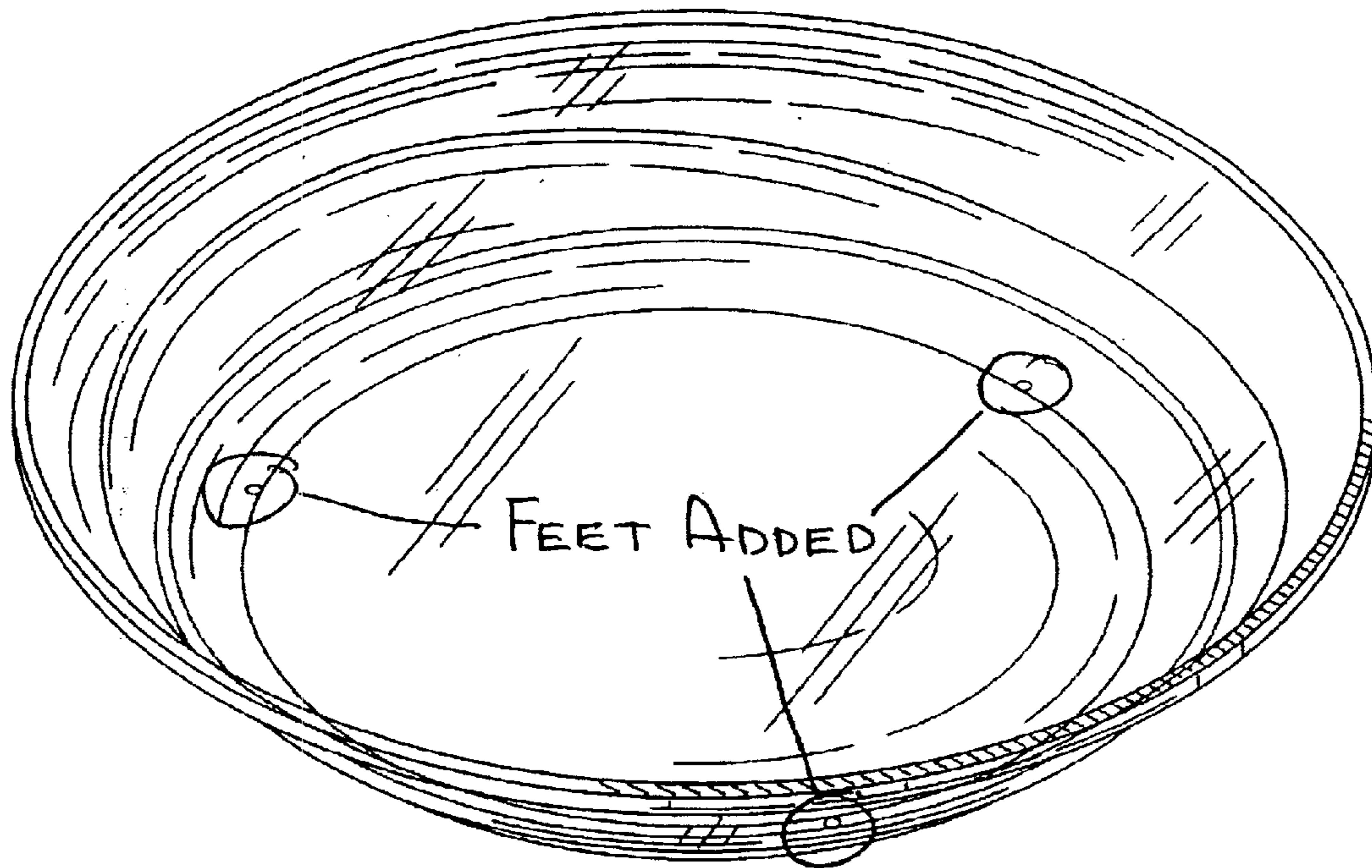

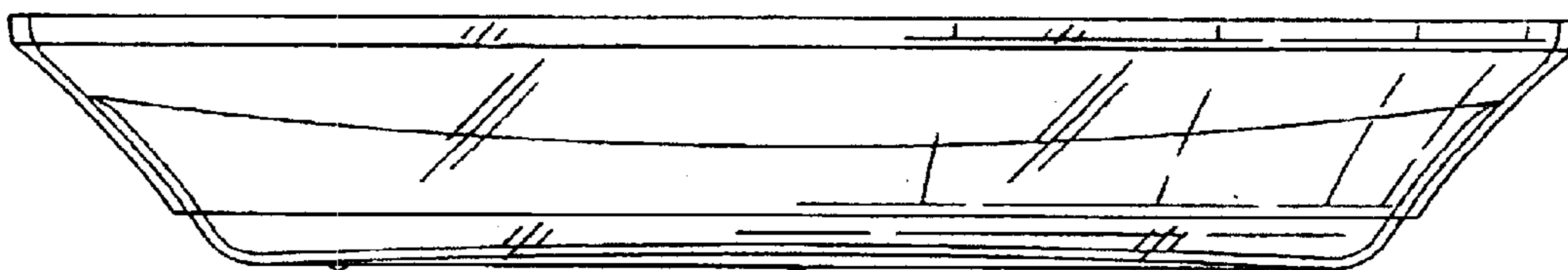

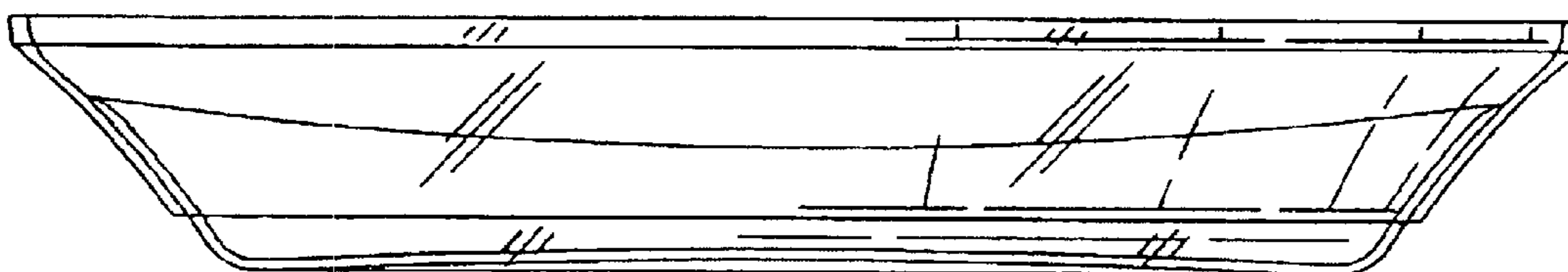

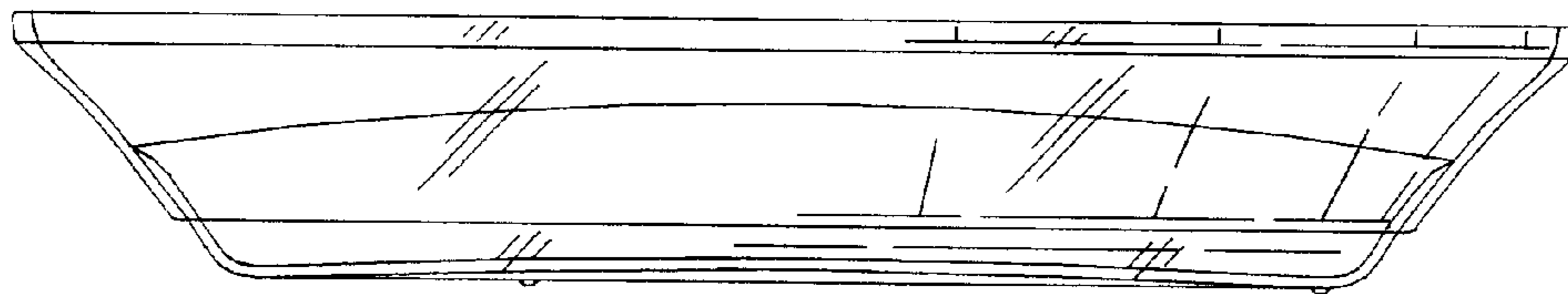

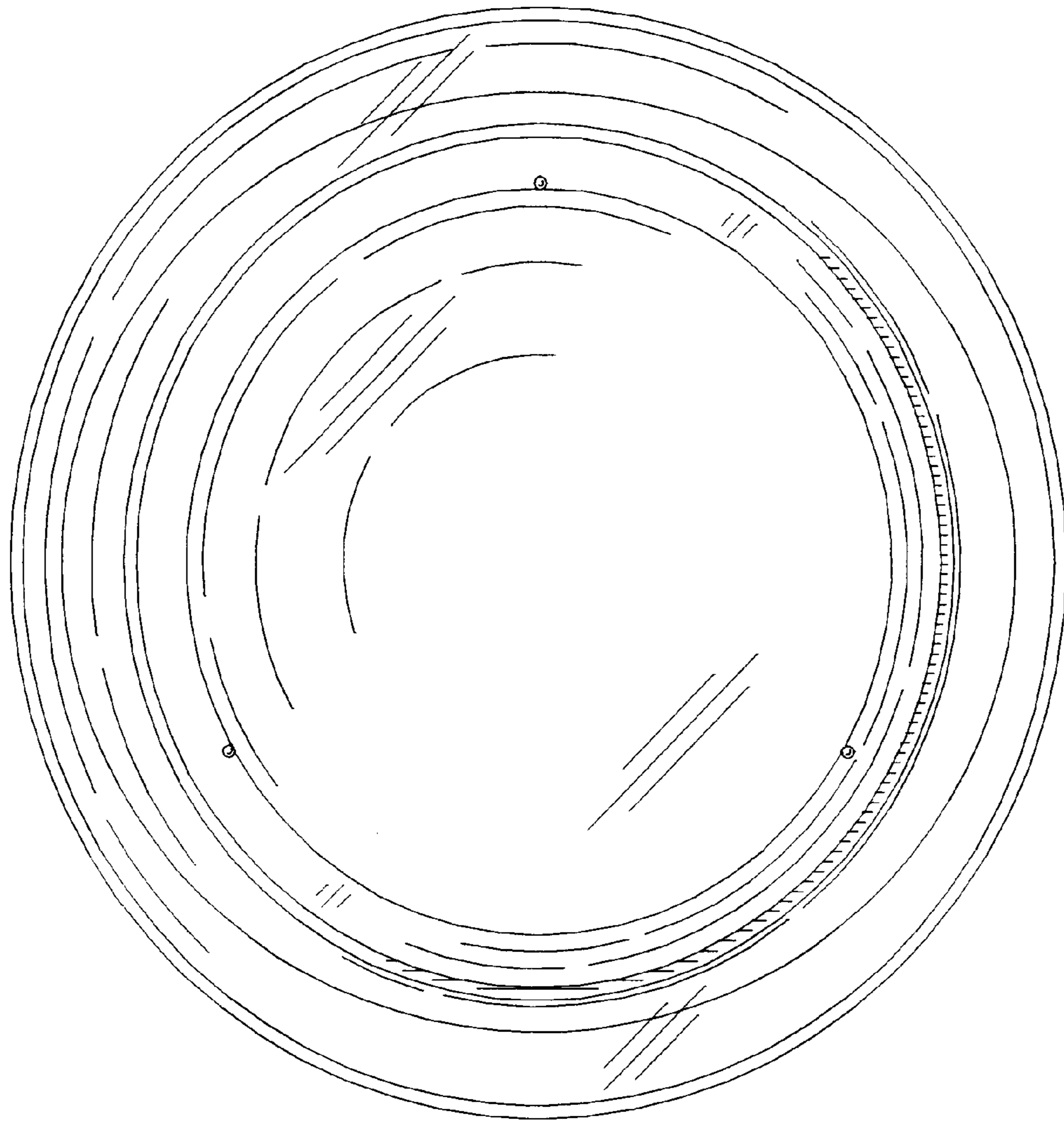

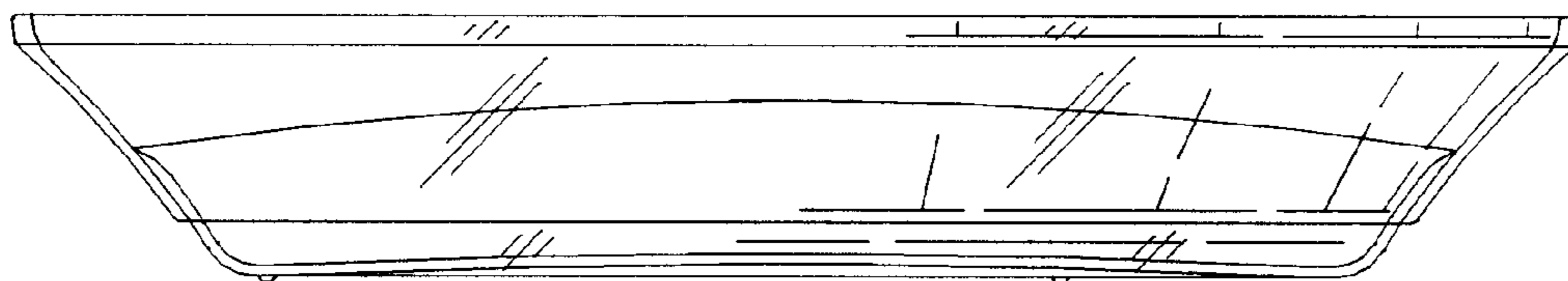
