The ornamental design for a recessed handle with lid, as shown and described.

DESCRIPTION

FIG. 11 is a right side view of FIG. 8;

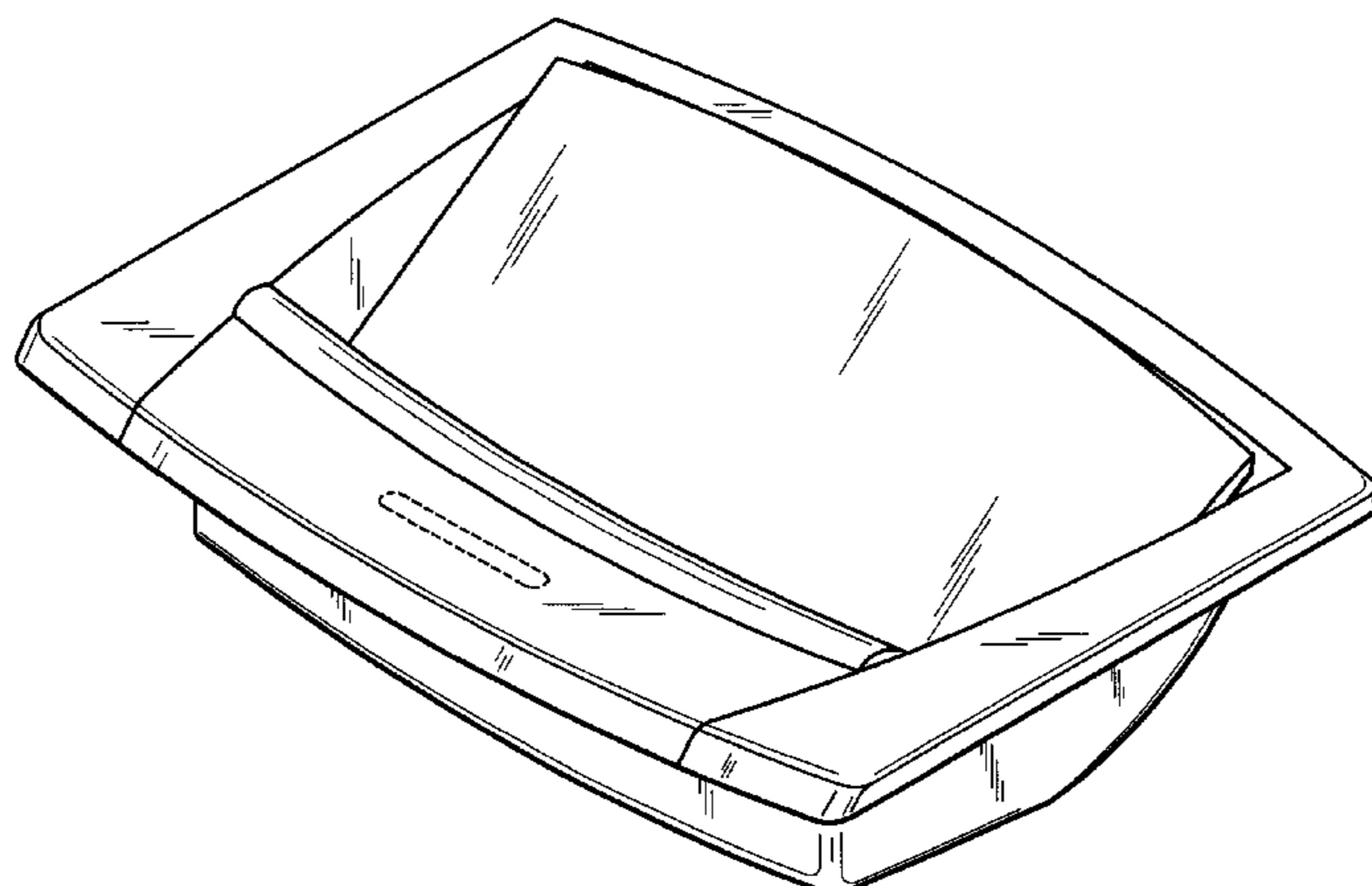
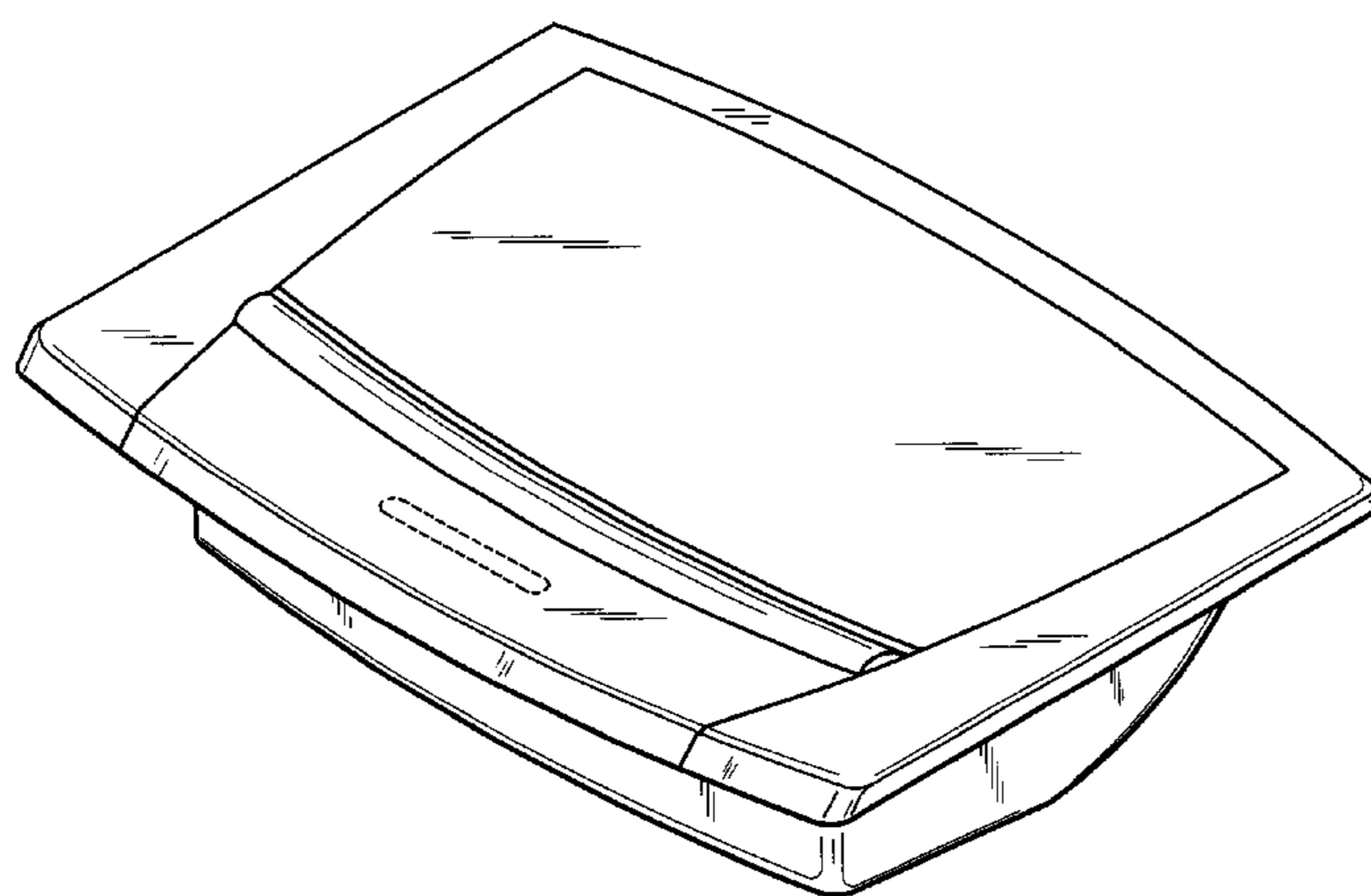
FIG. 12 is a left side view of FIG. 8;

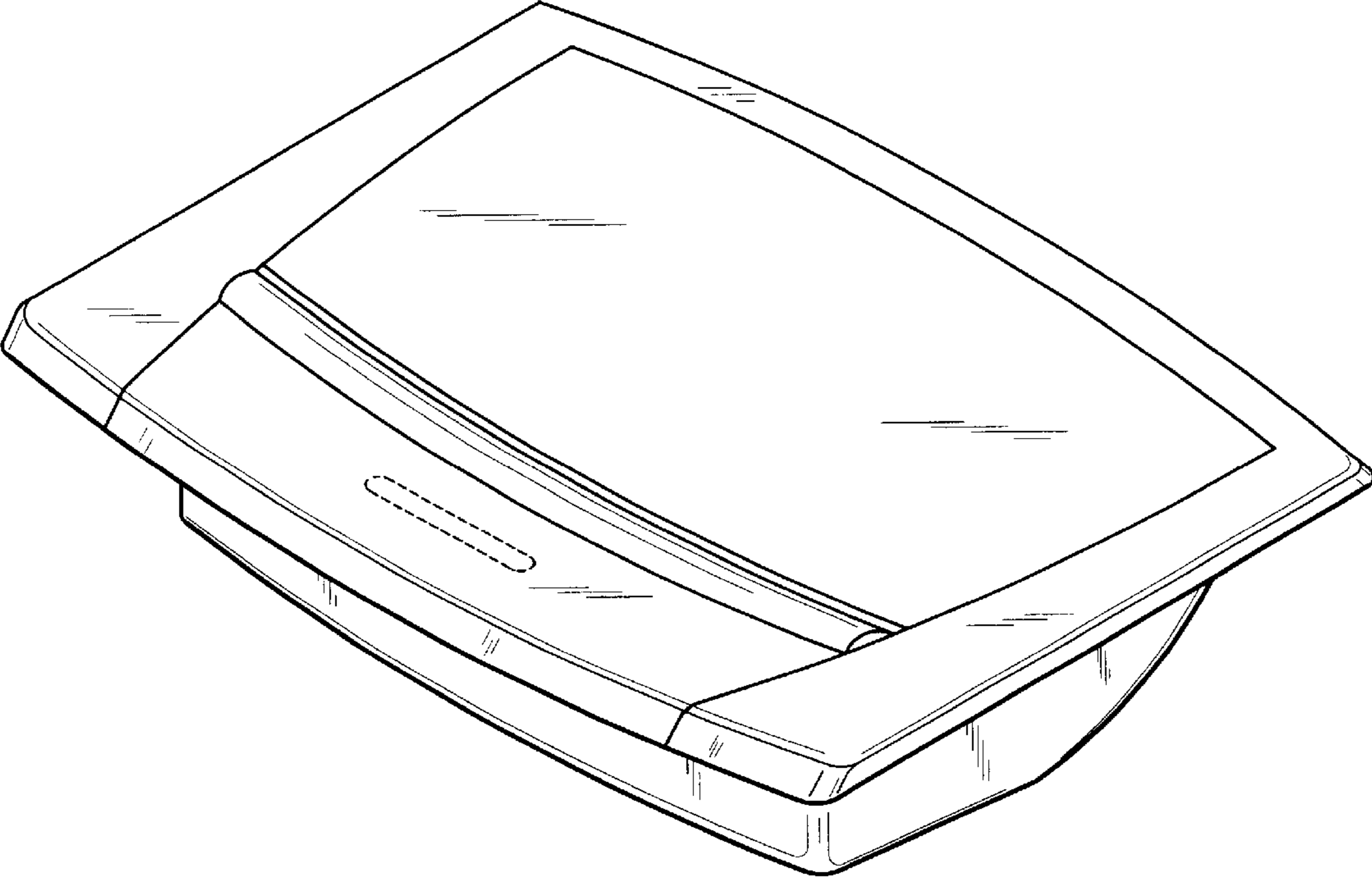

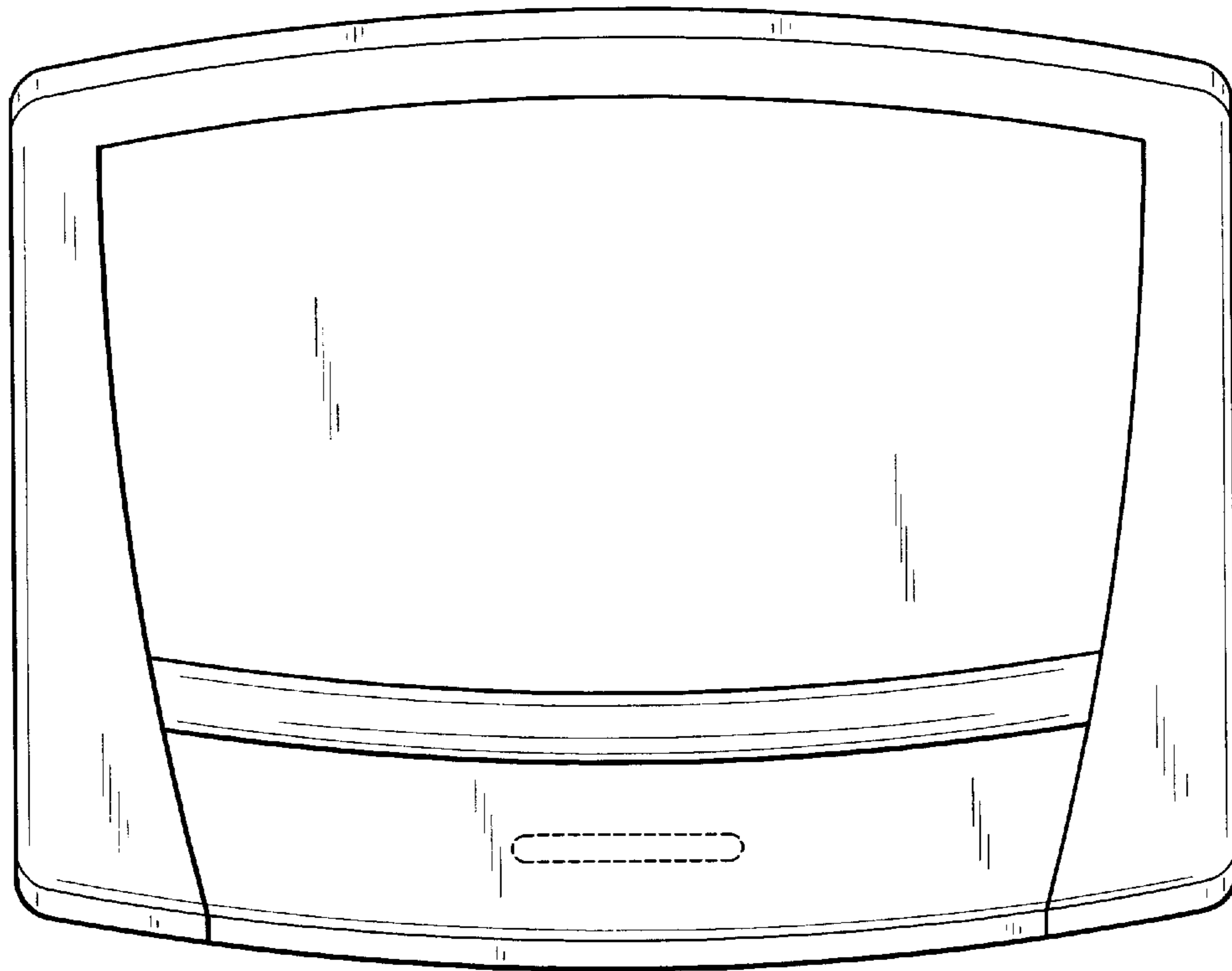

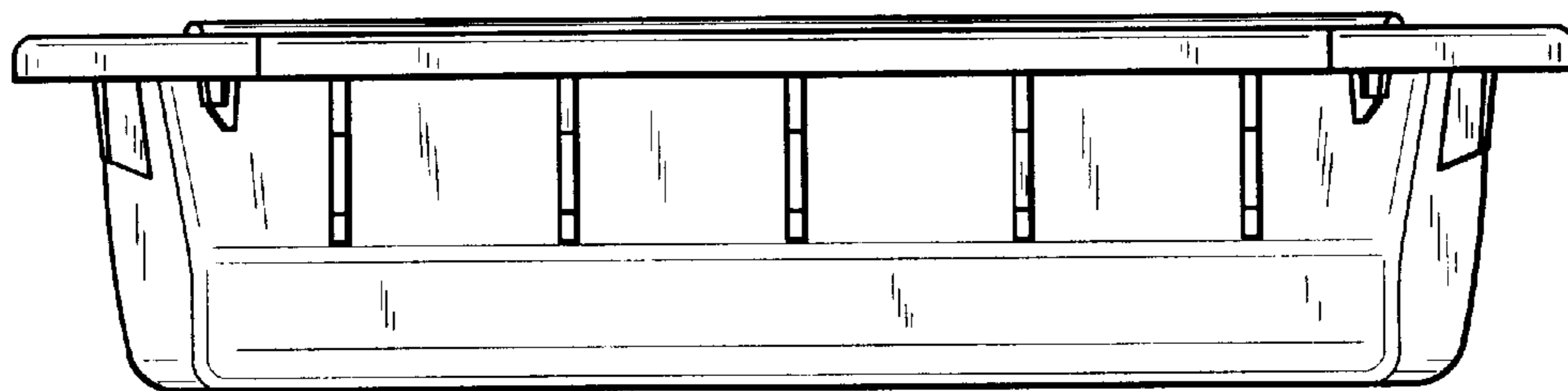

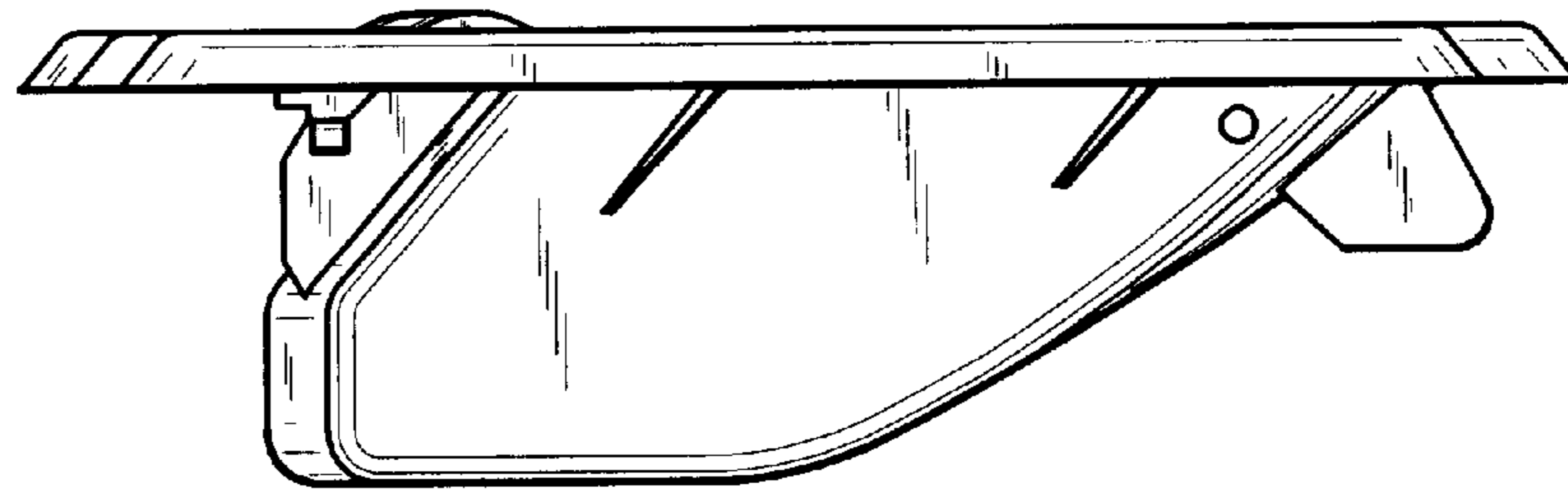

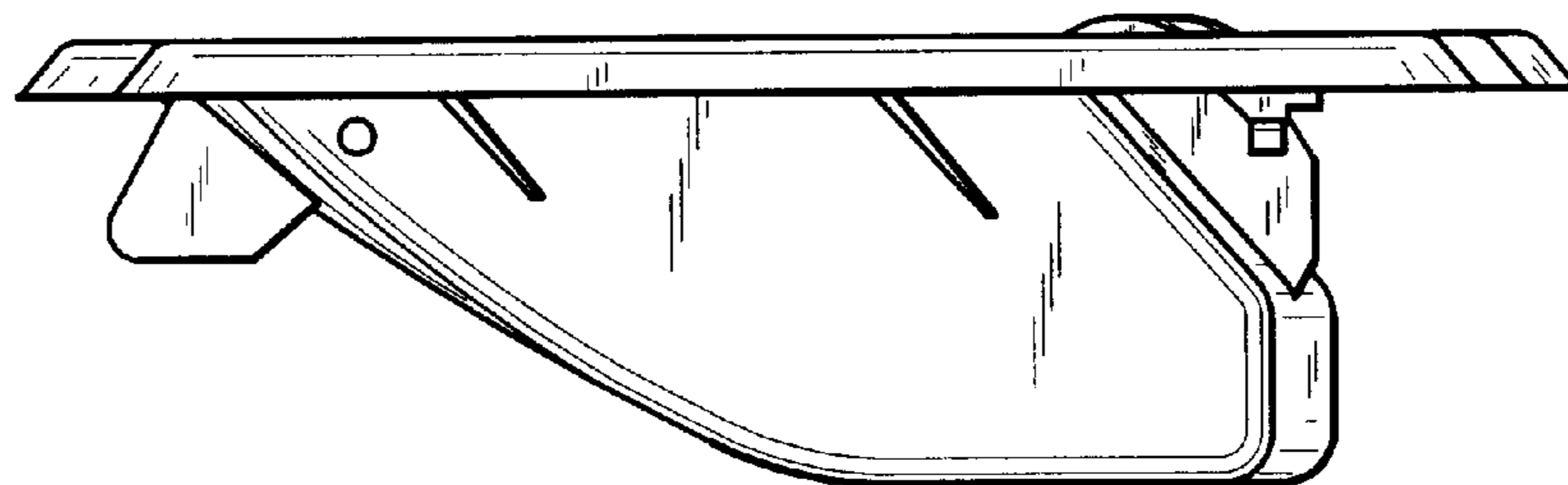

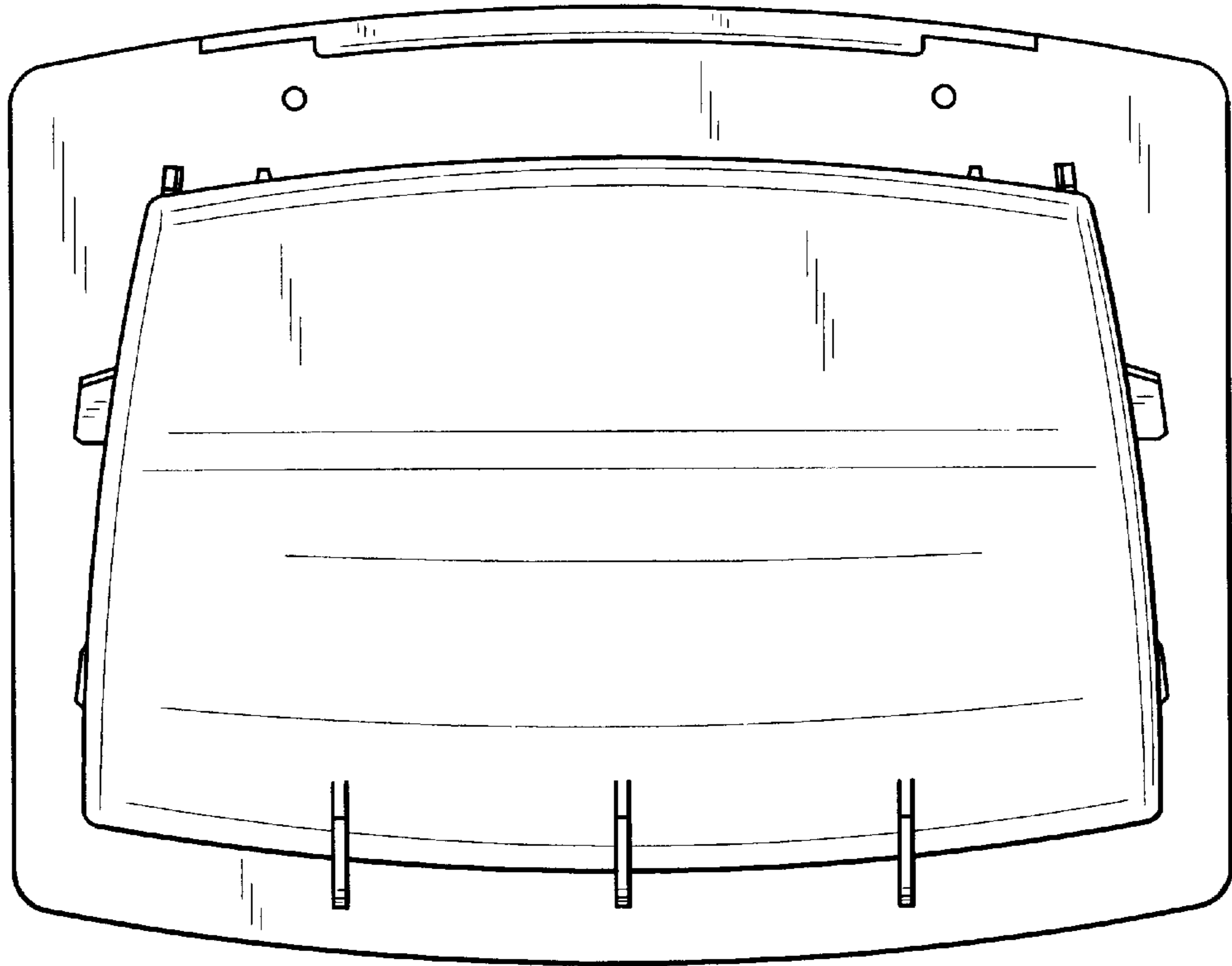

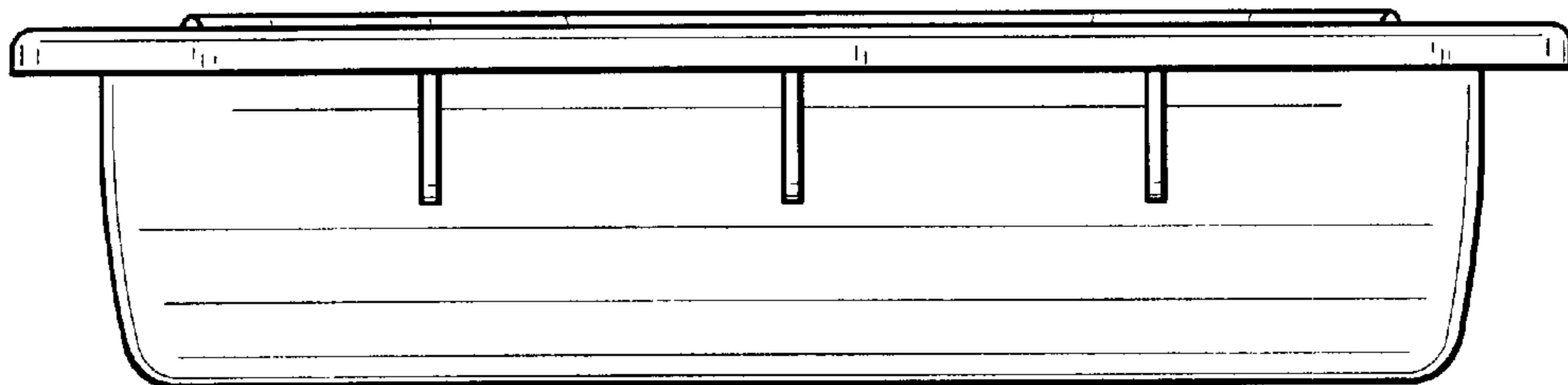

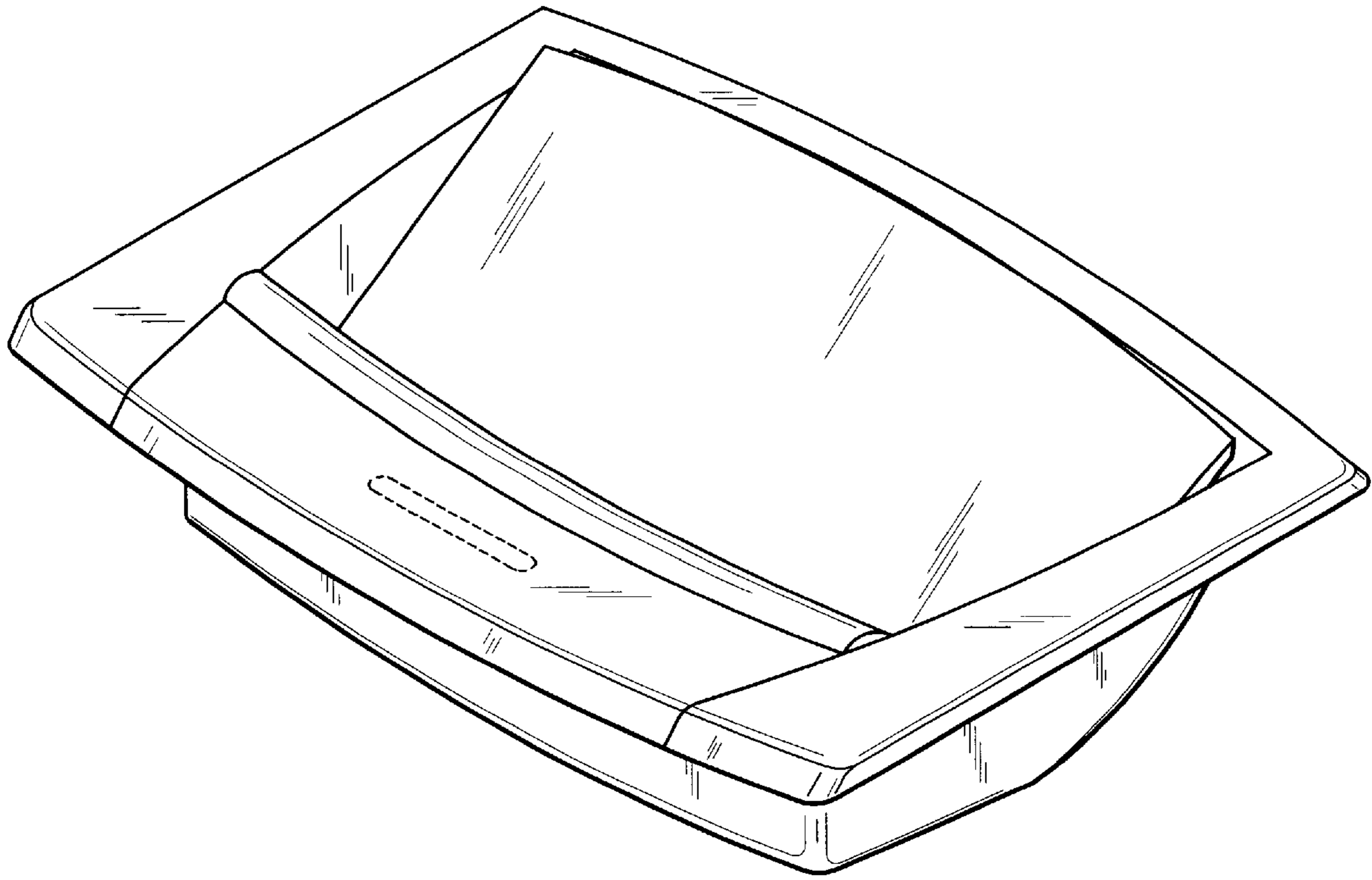

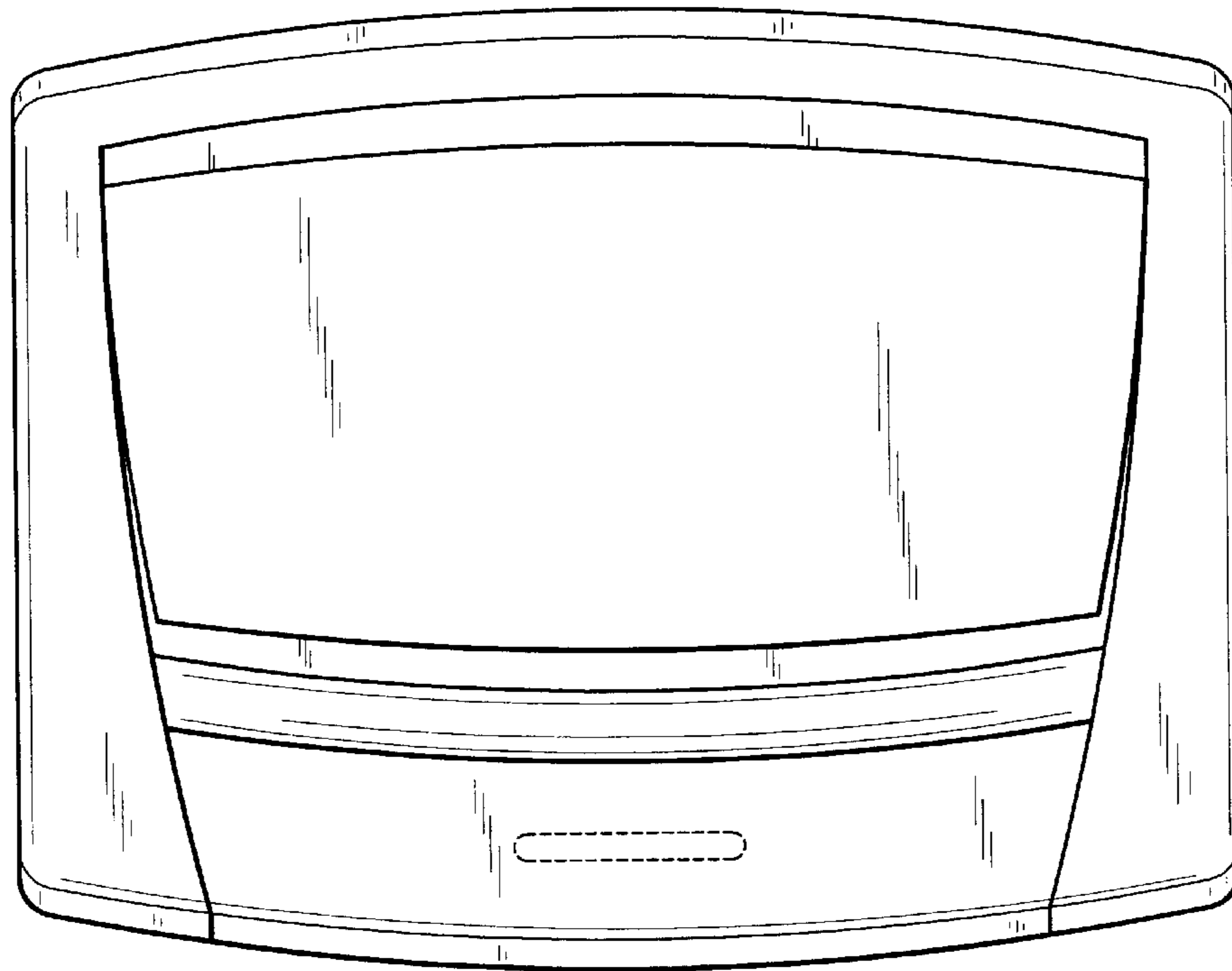

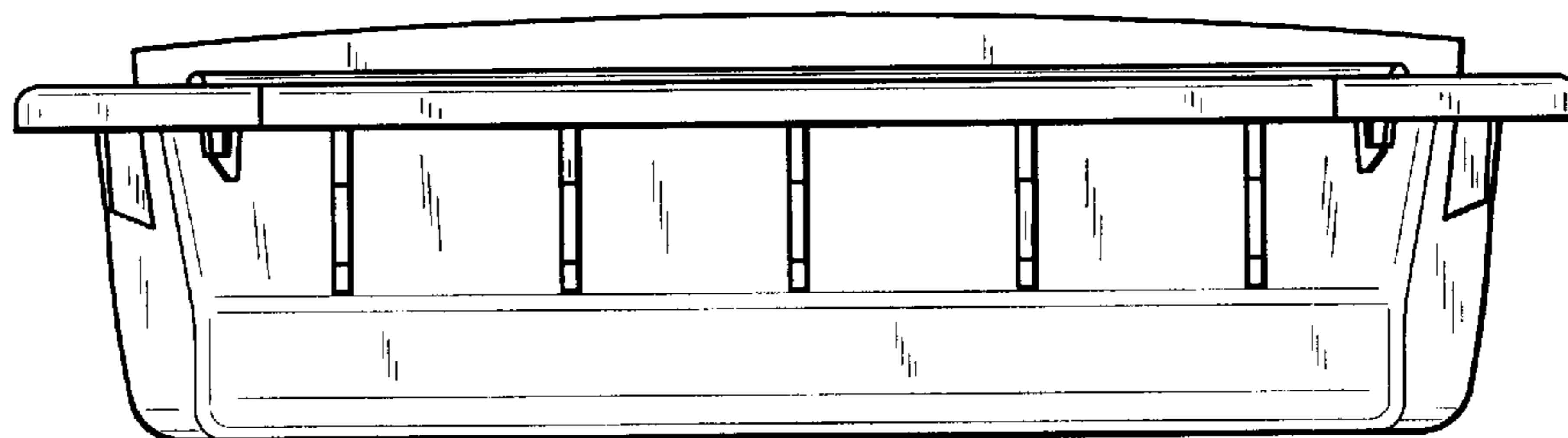

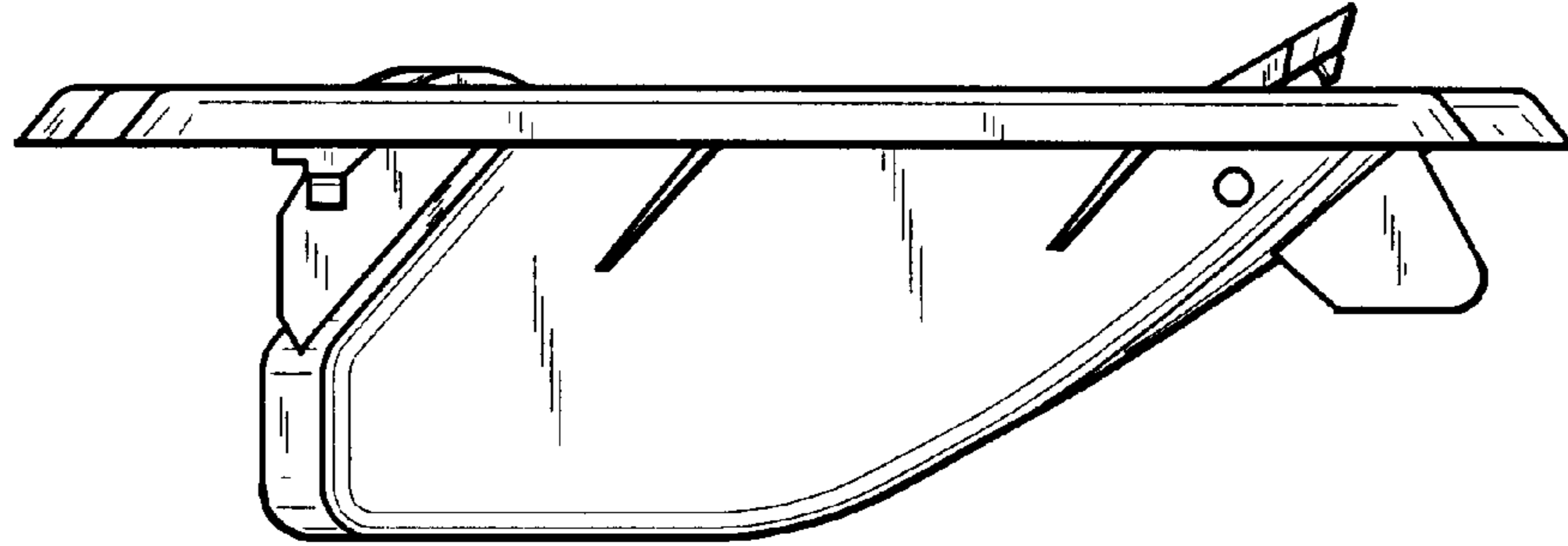

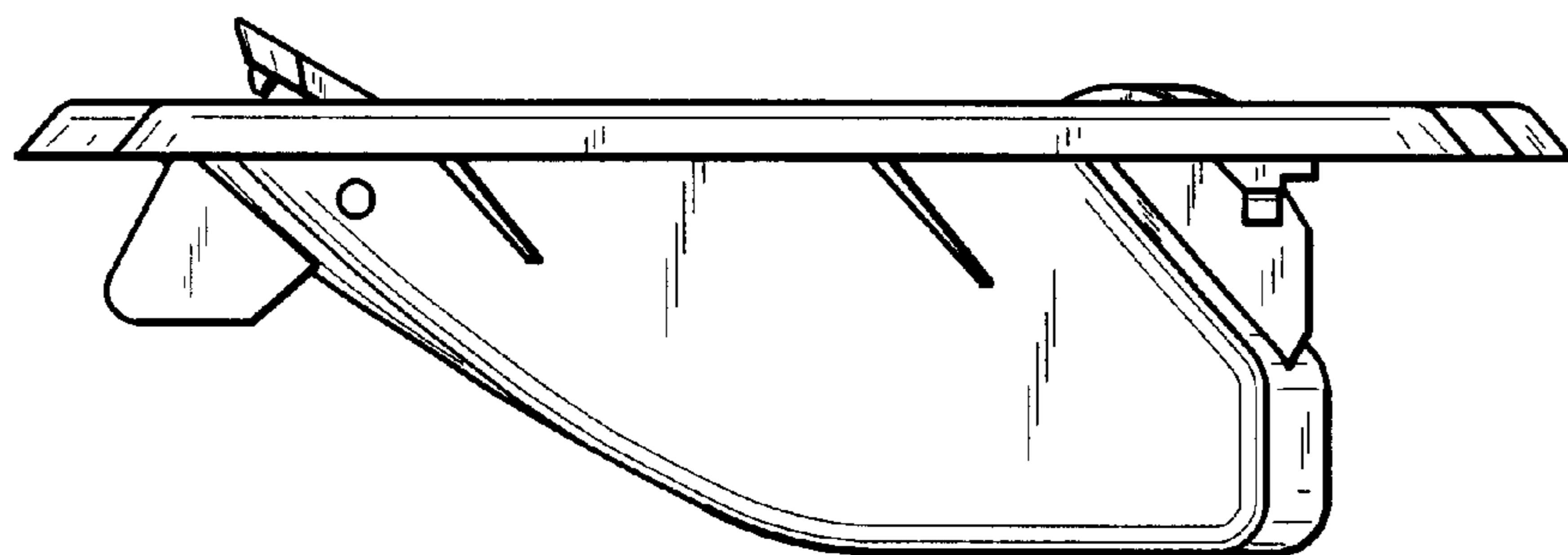

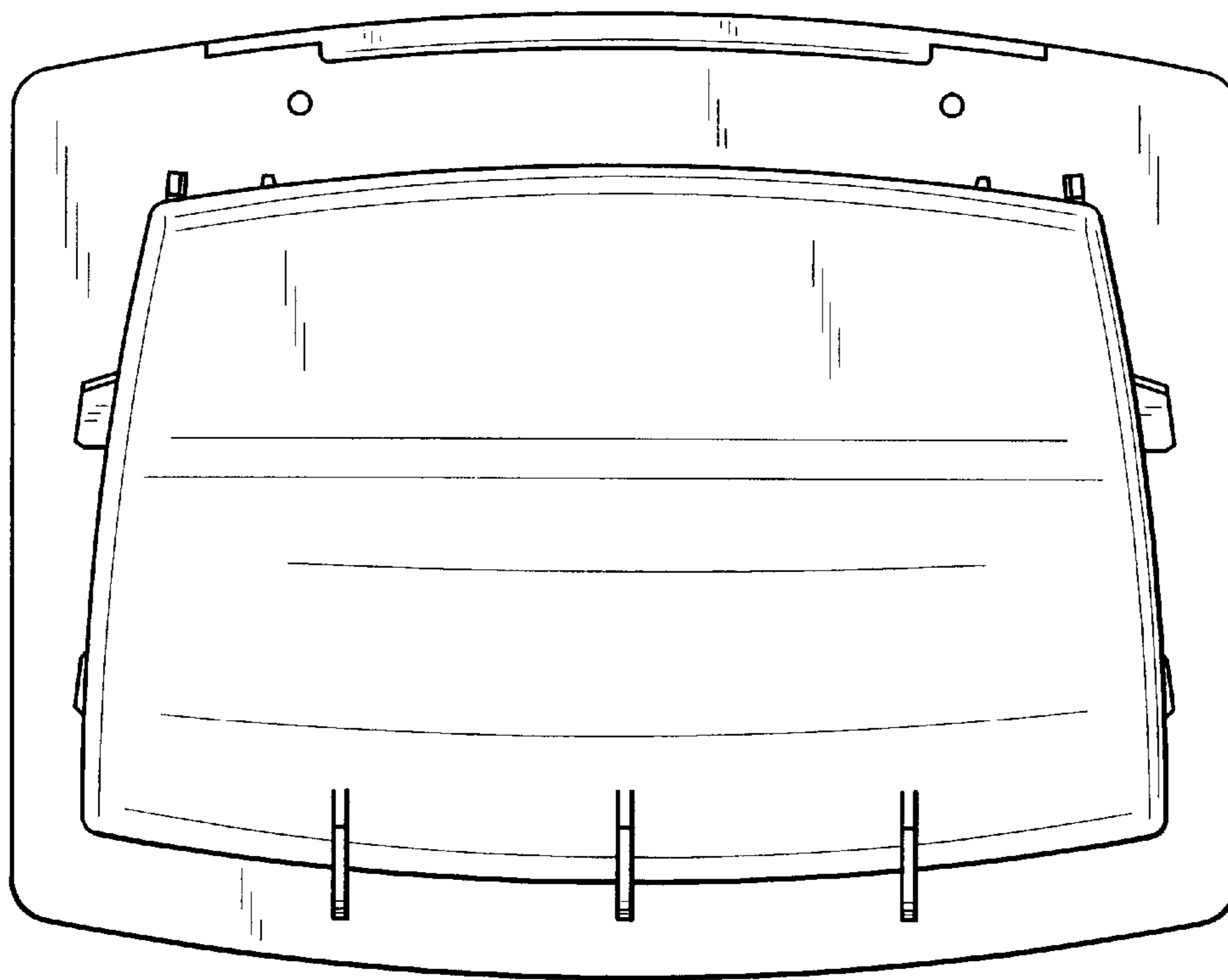

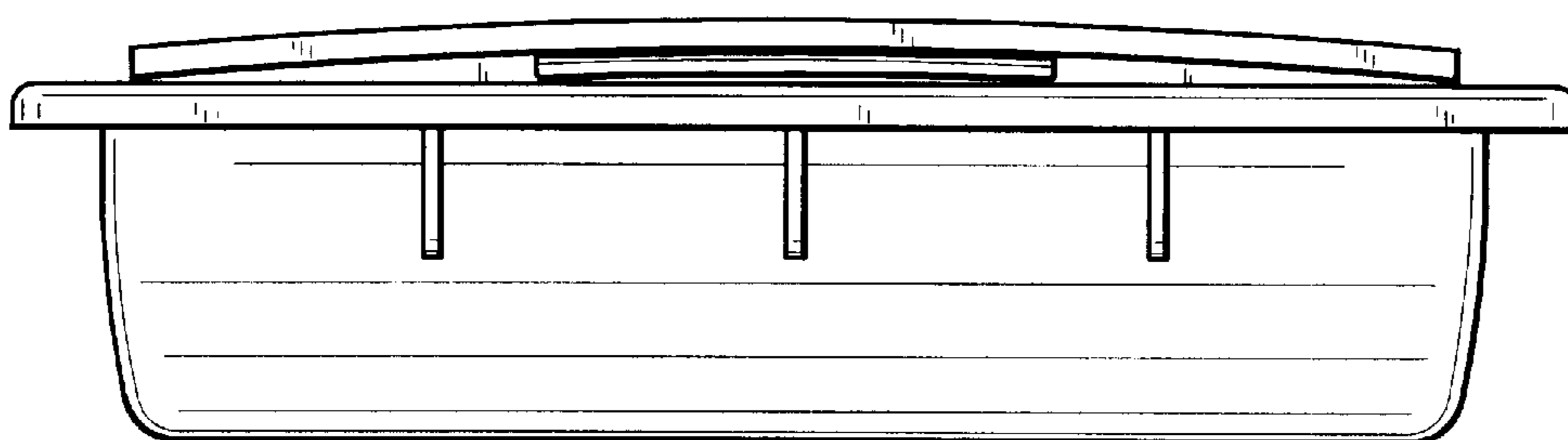
