FIG. 1 is a top perspective view of a package of the present invention;

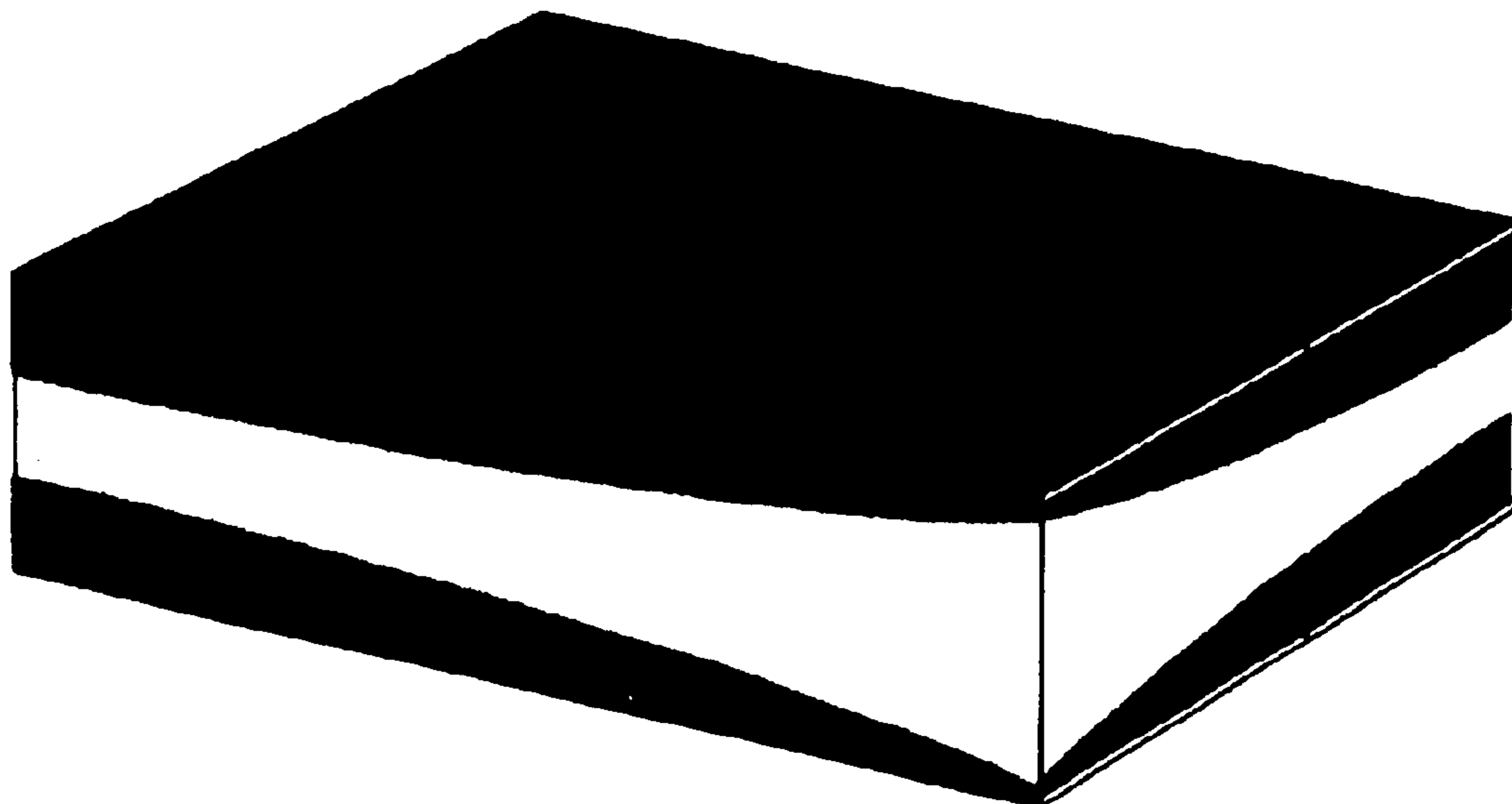
FIG. 2 is a front view thereof, wherein the rear view is a mirror image thereof;

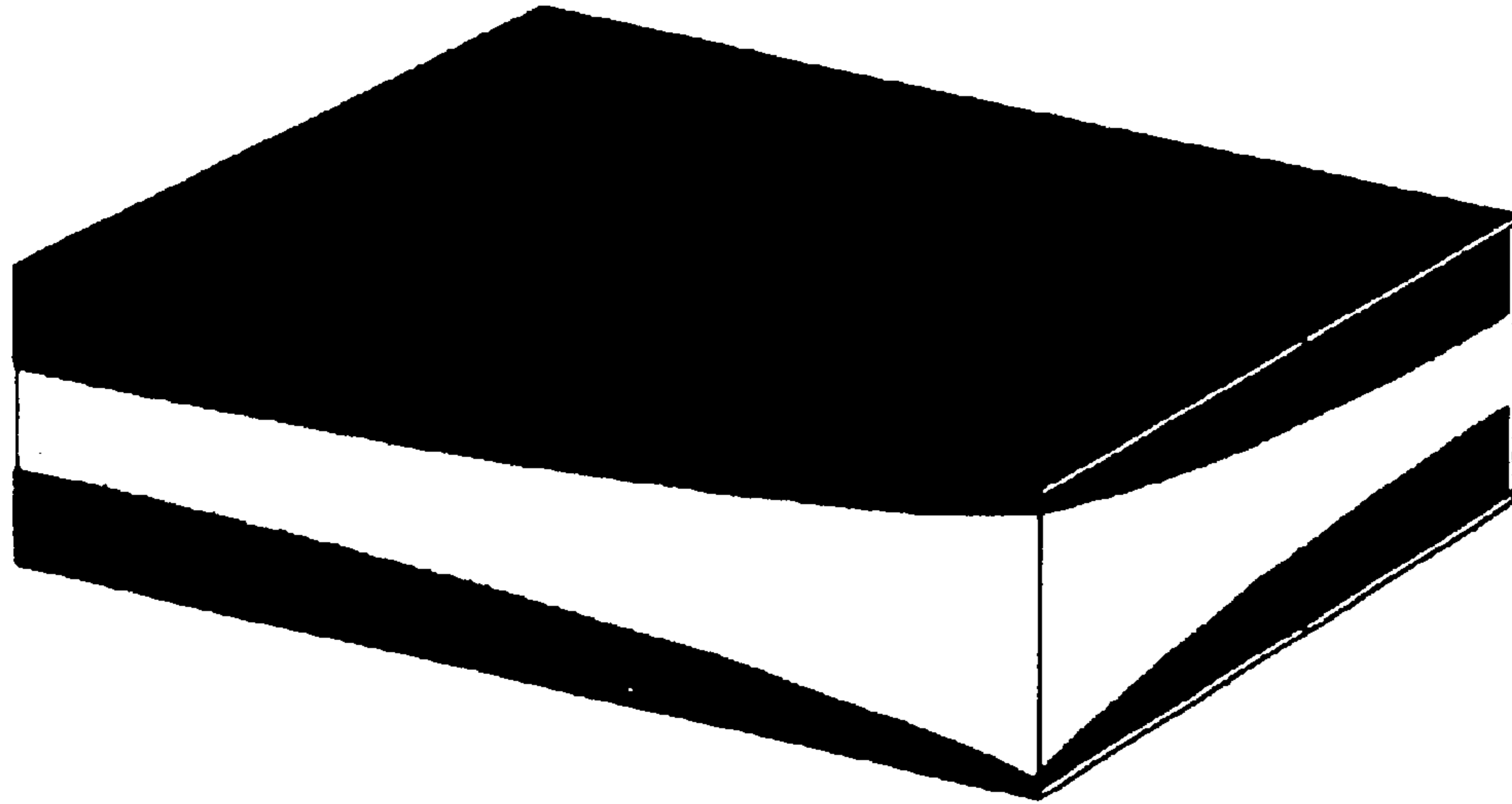

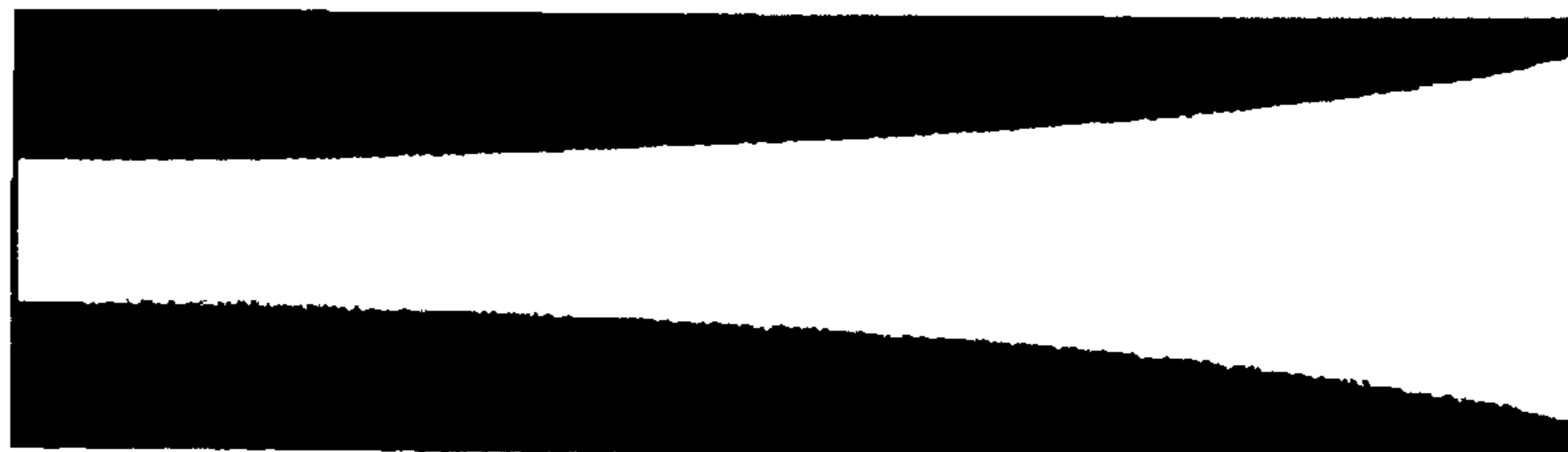

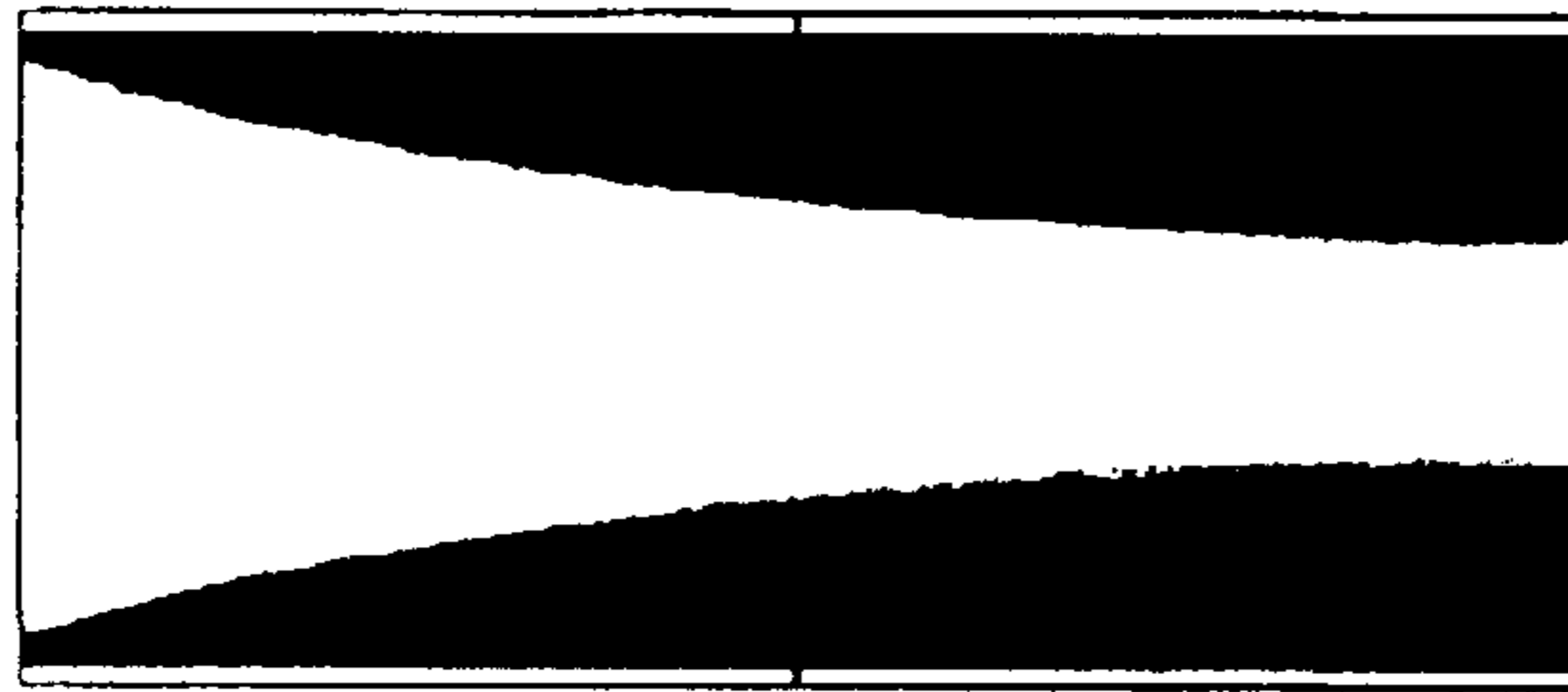

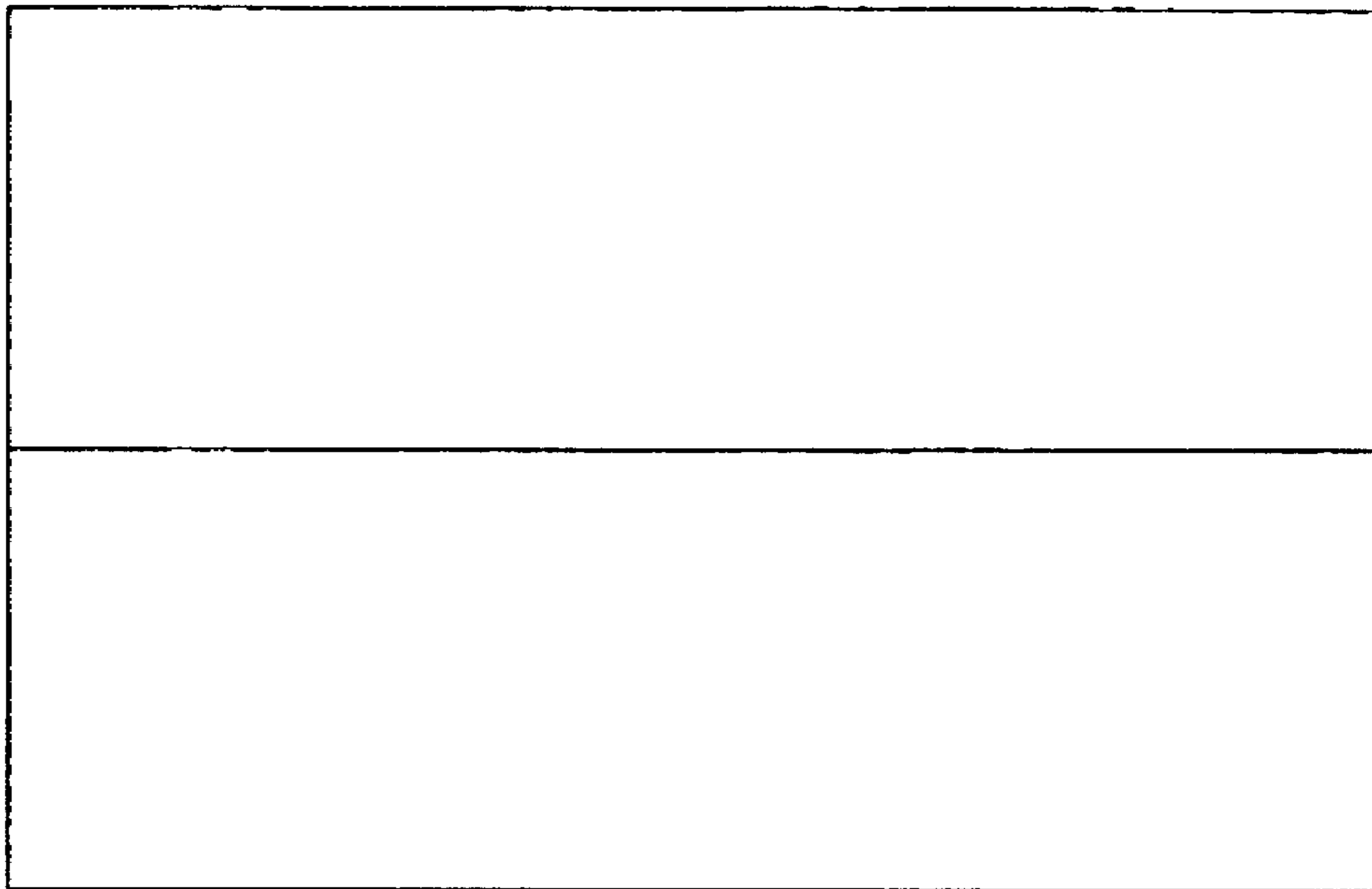
