(57) **CLAIM**

The ornamental design for a packaging for flowers, as shown and described.

DESCRIPTION

FIG. 1 is a plan view of packaging for flowers, shown spread flat, and showing my new design, the side opposite that shown in FIG. 1 being identical thereto, the three panels in FIG. 1 being separated by bend lines;

FIG. 2 is a top, side and perspective view thereof, with the panels folded into the operative condition;

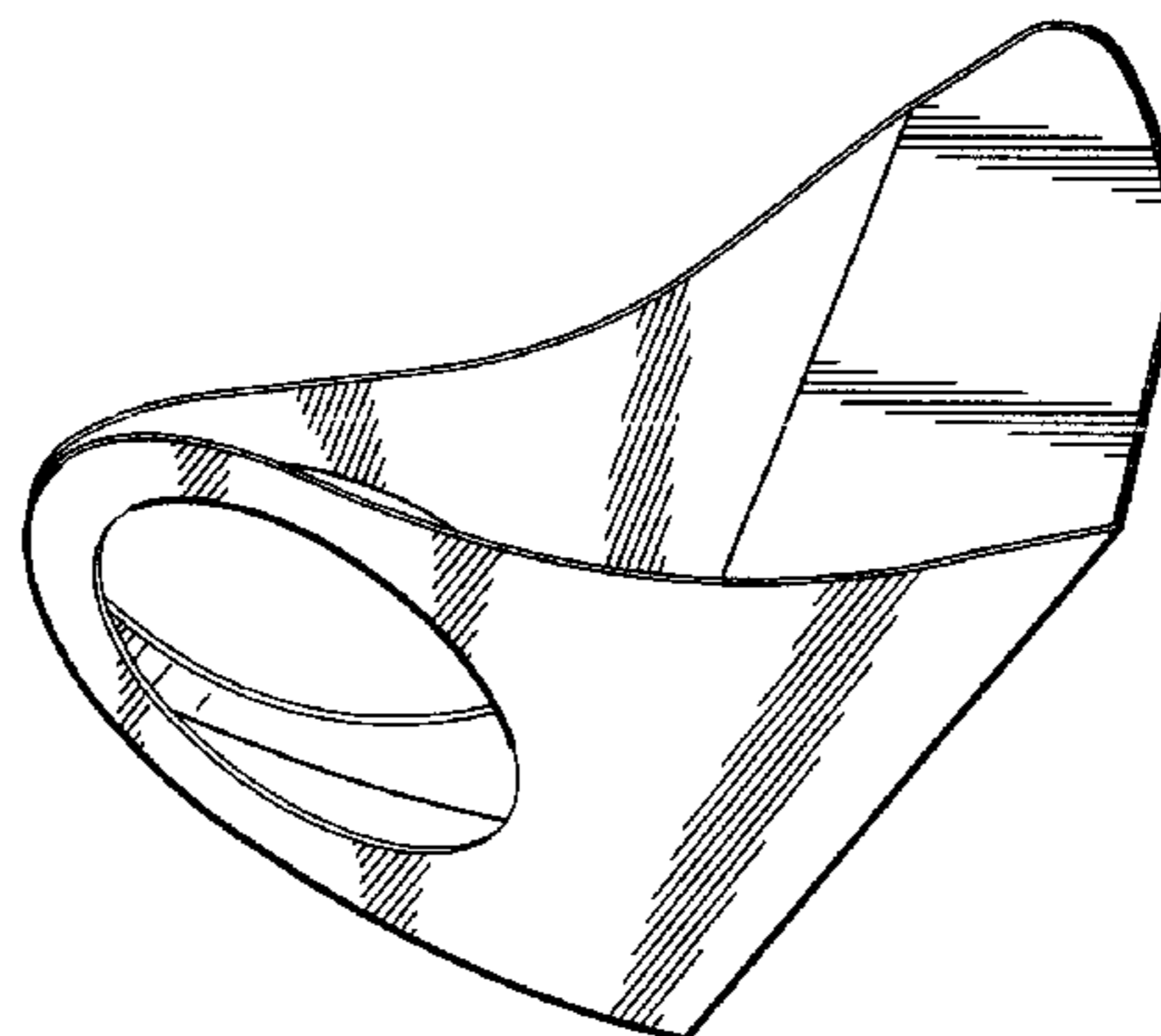
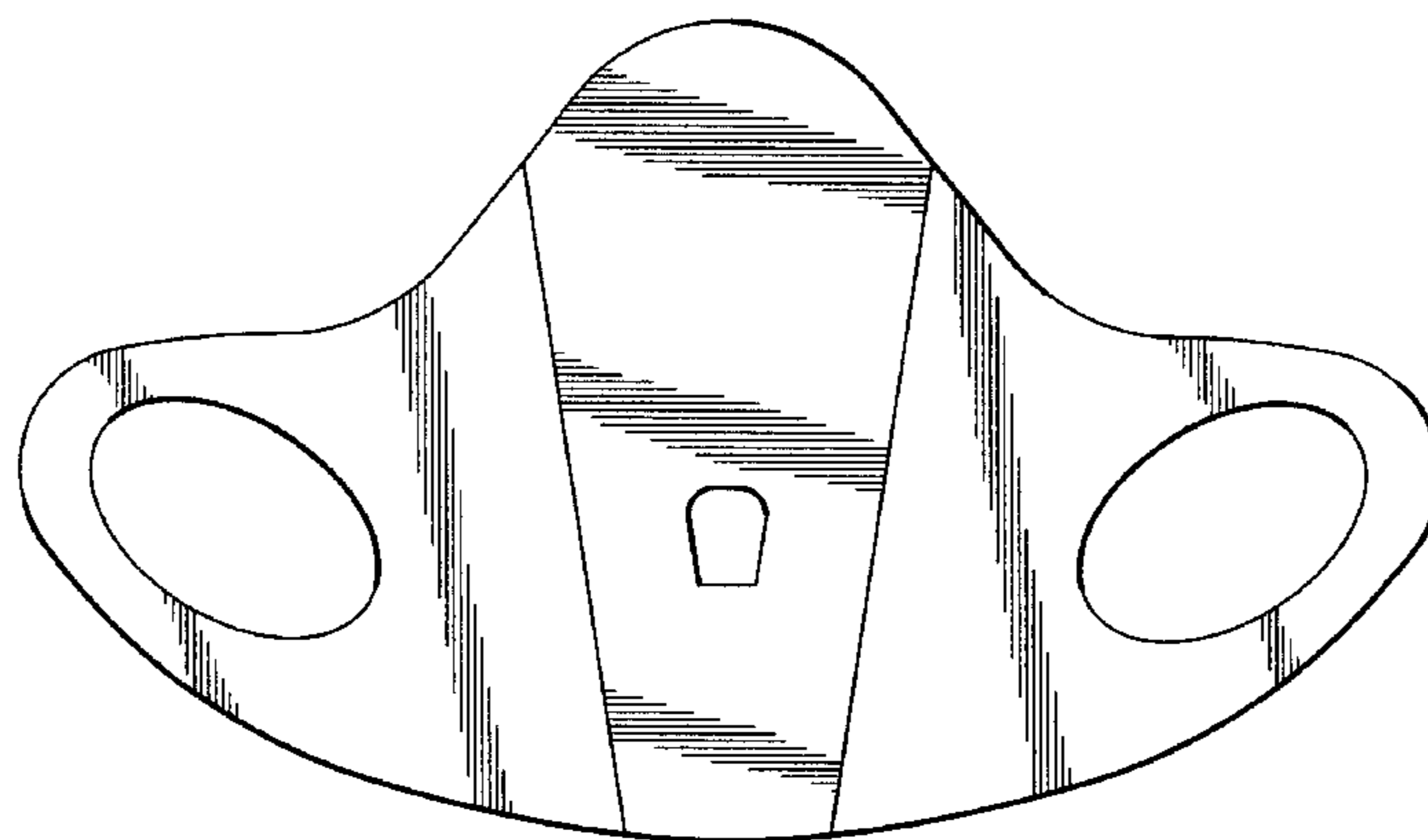
FIG. 3 is a front elevational view thereof;

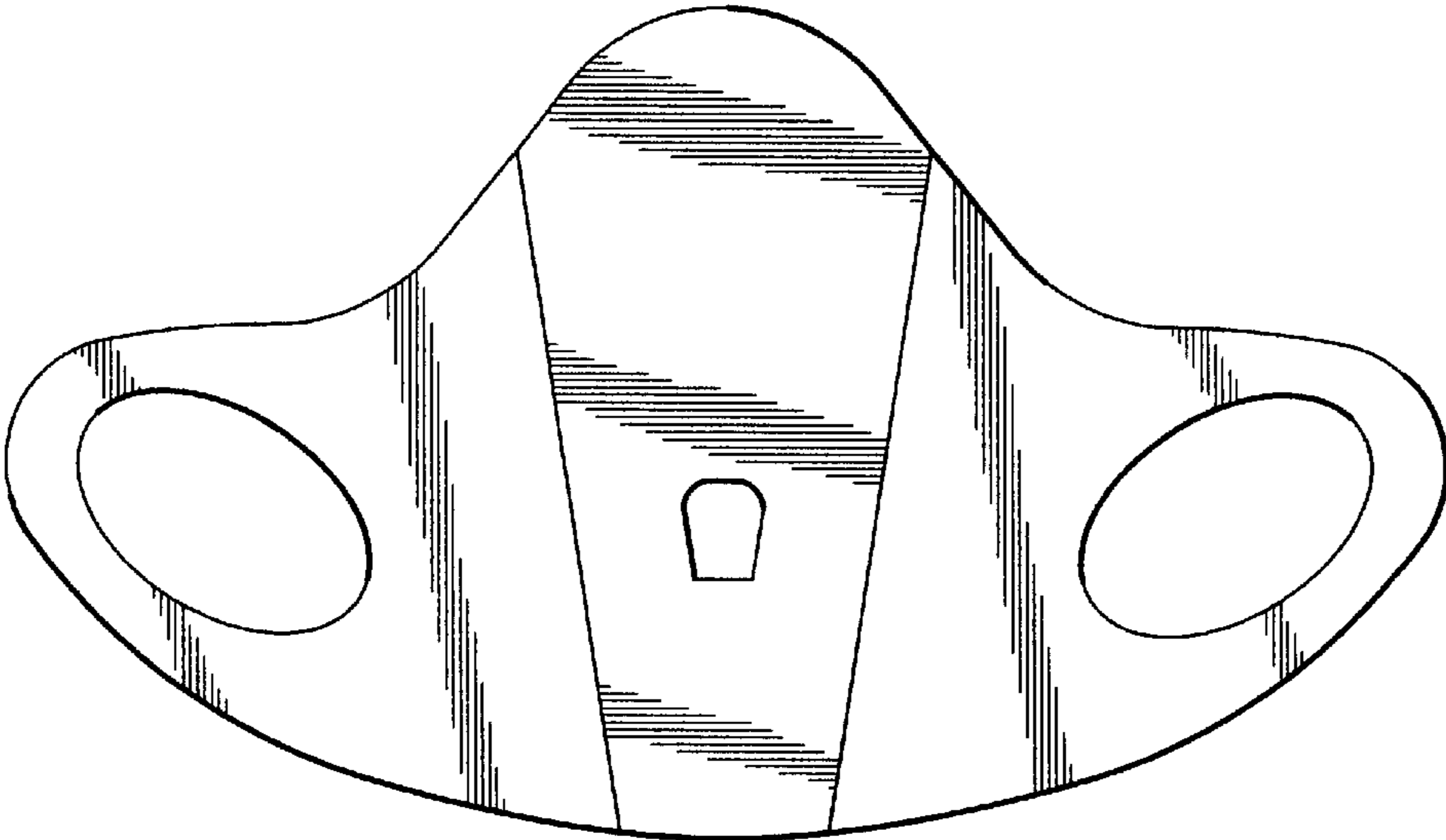

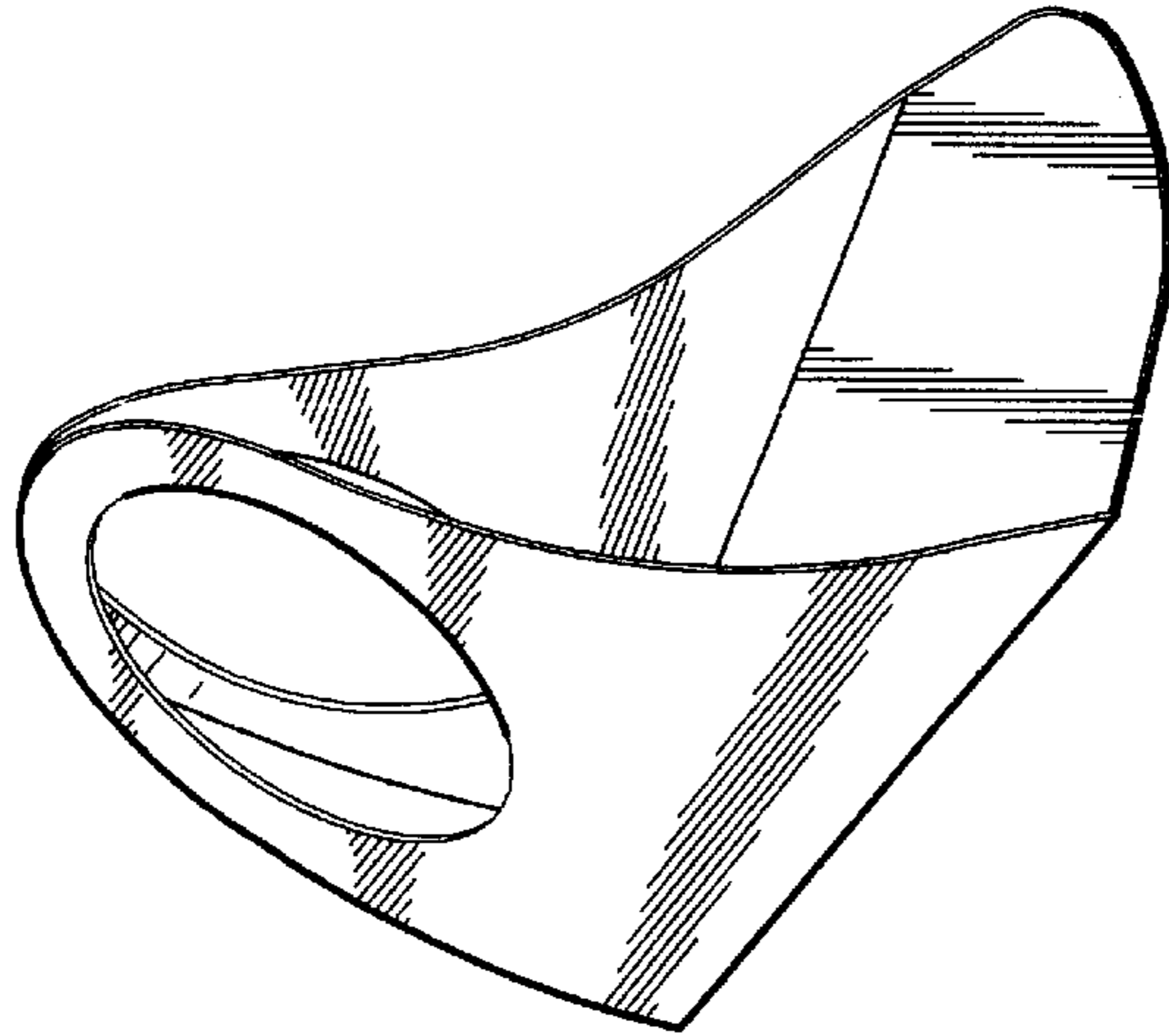

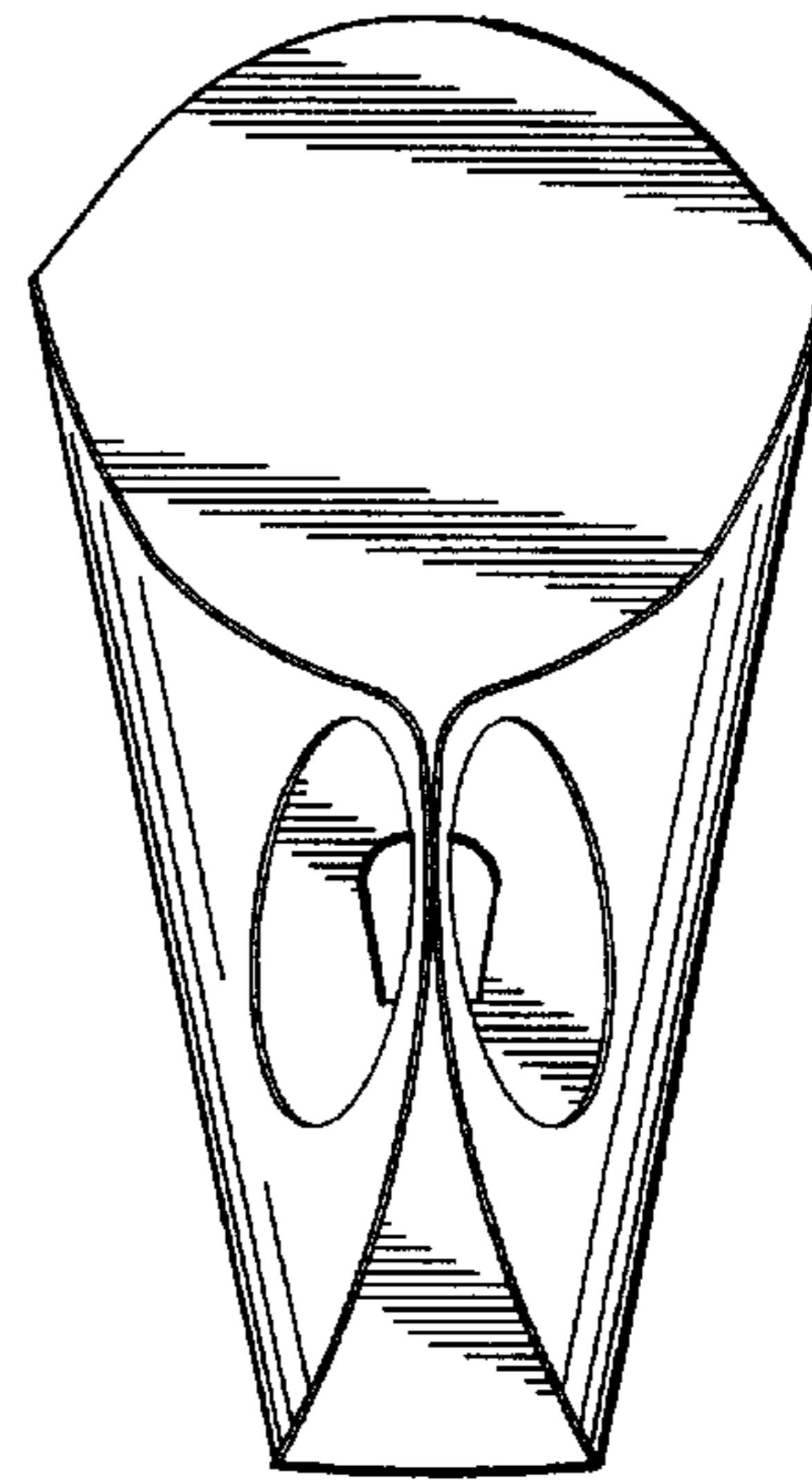

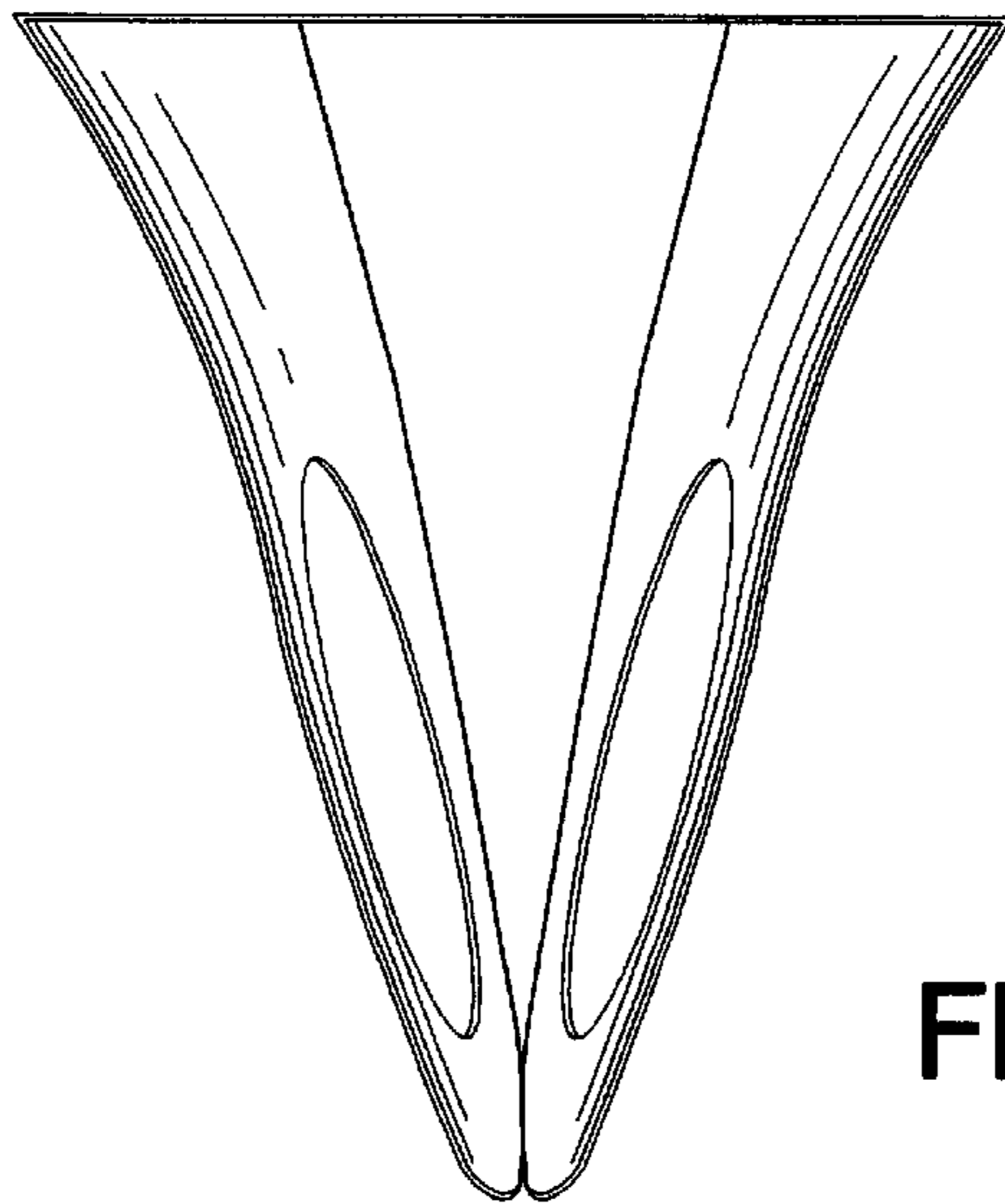

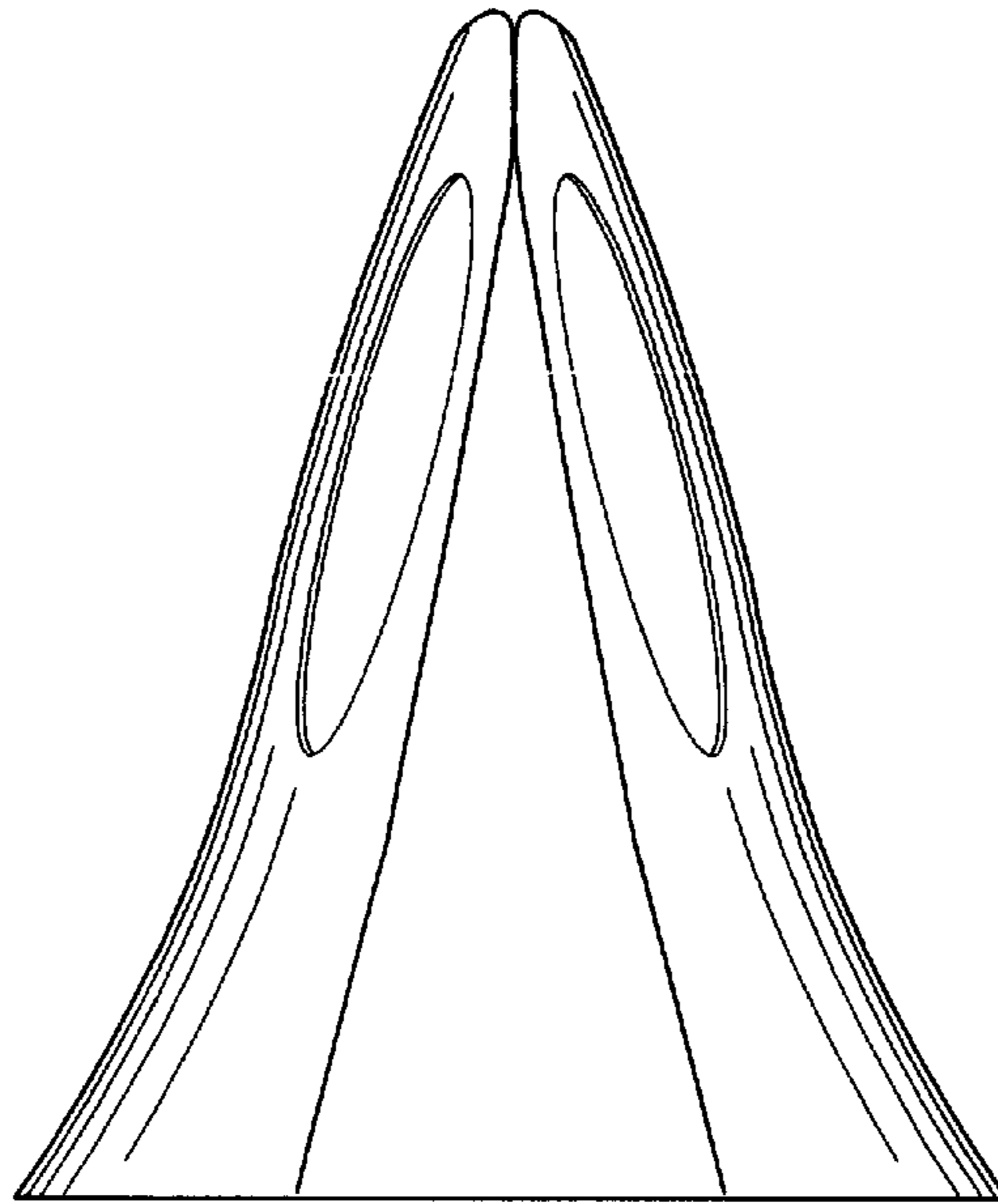

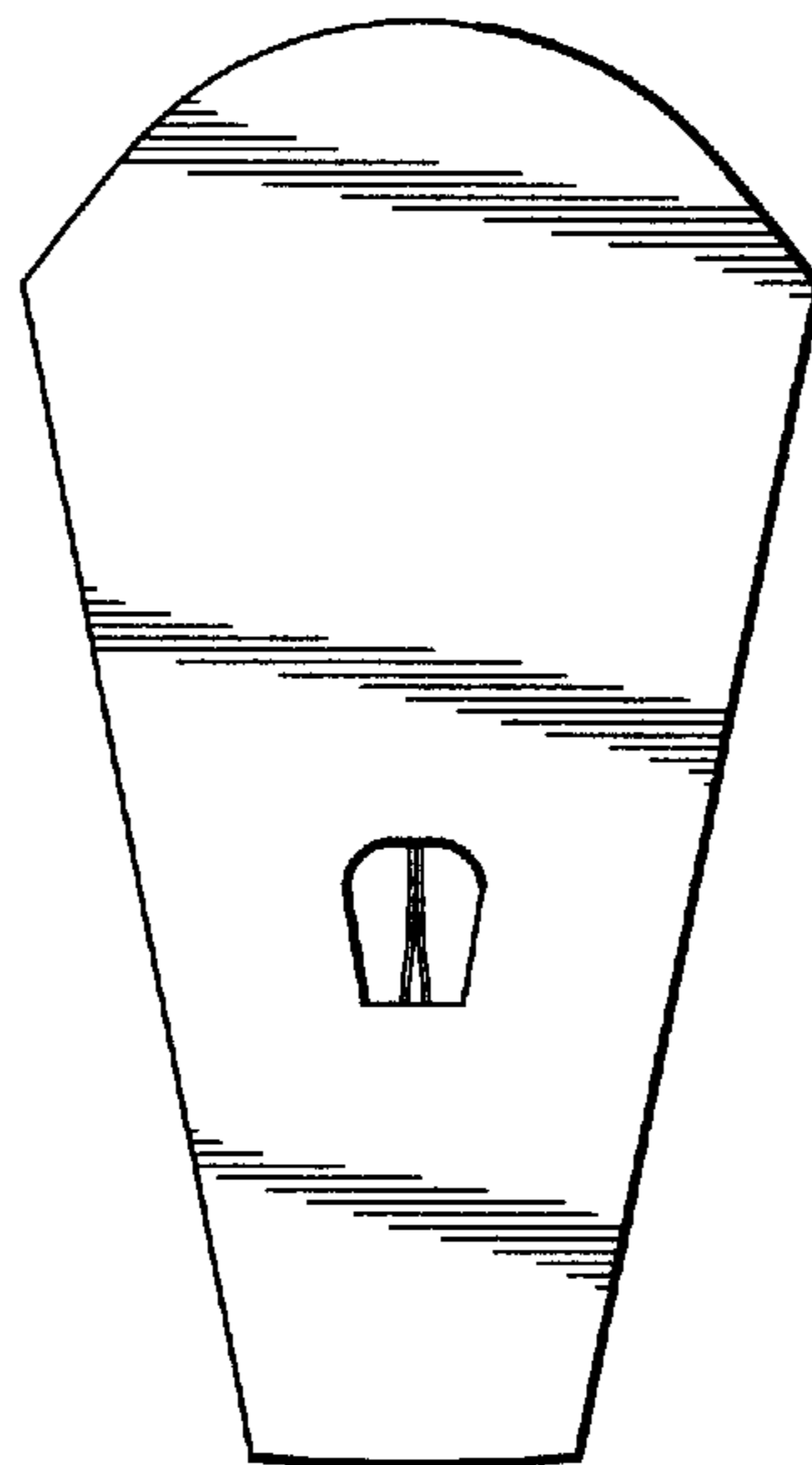
