DESCRIPTION

FIG. 3 is a back side view of the wrist watch;

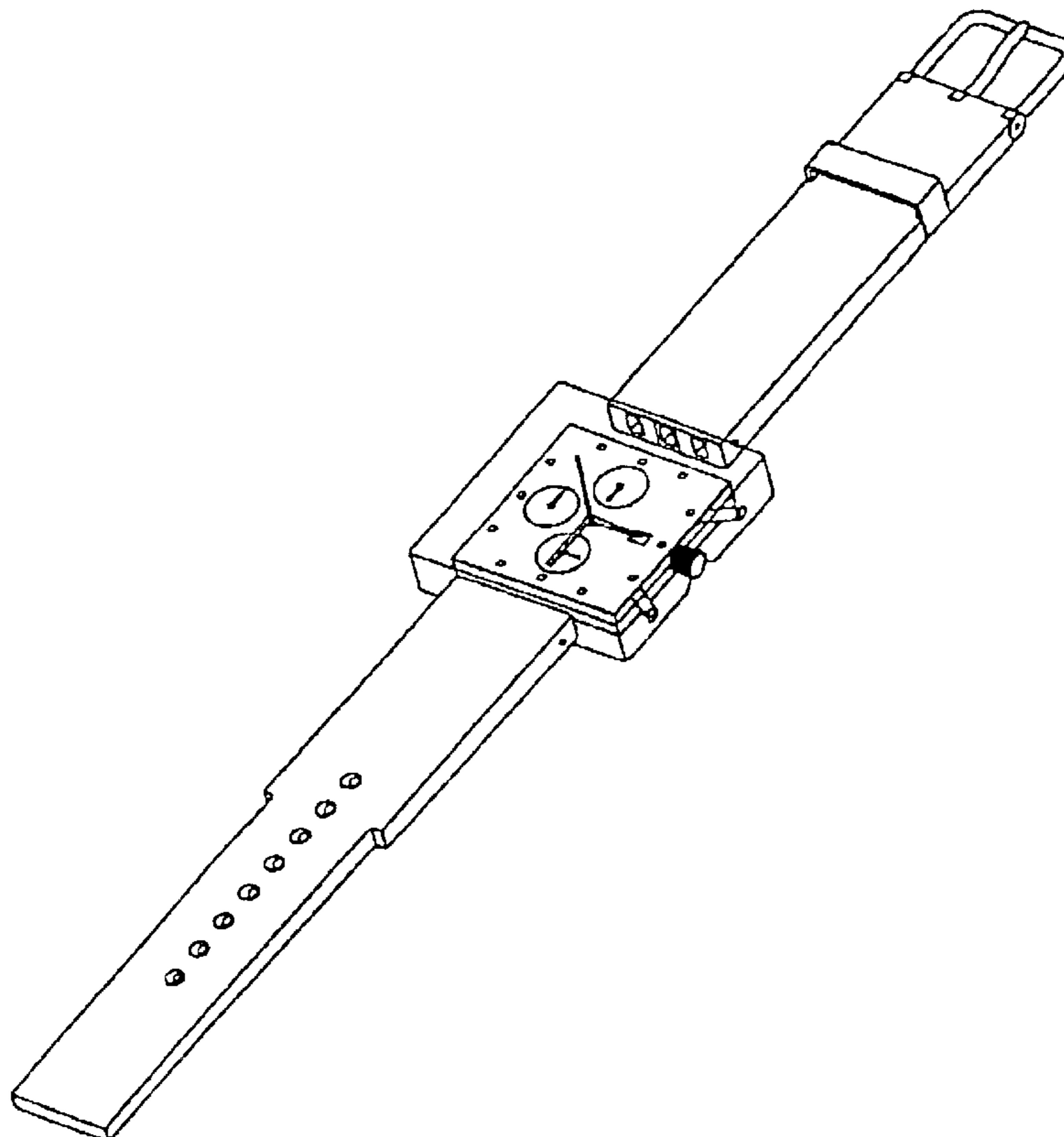
FIG. 4 is a right side view of the wrist watch;

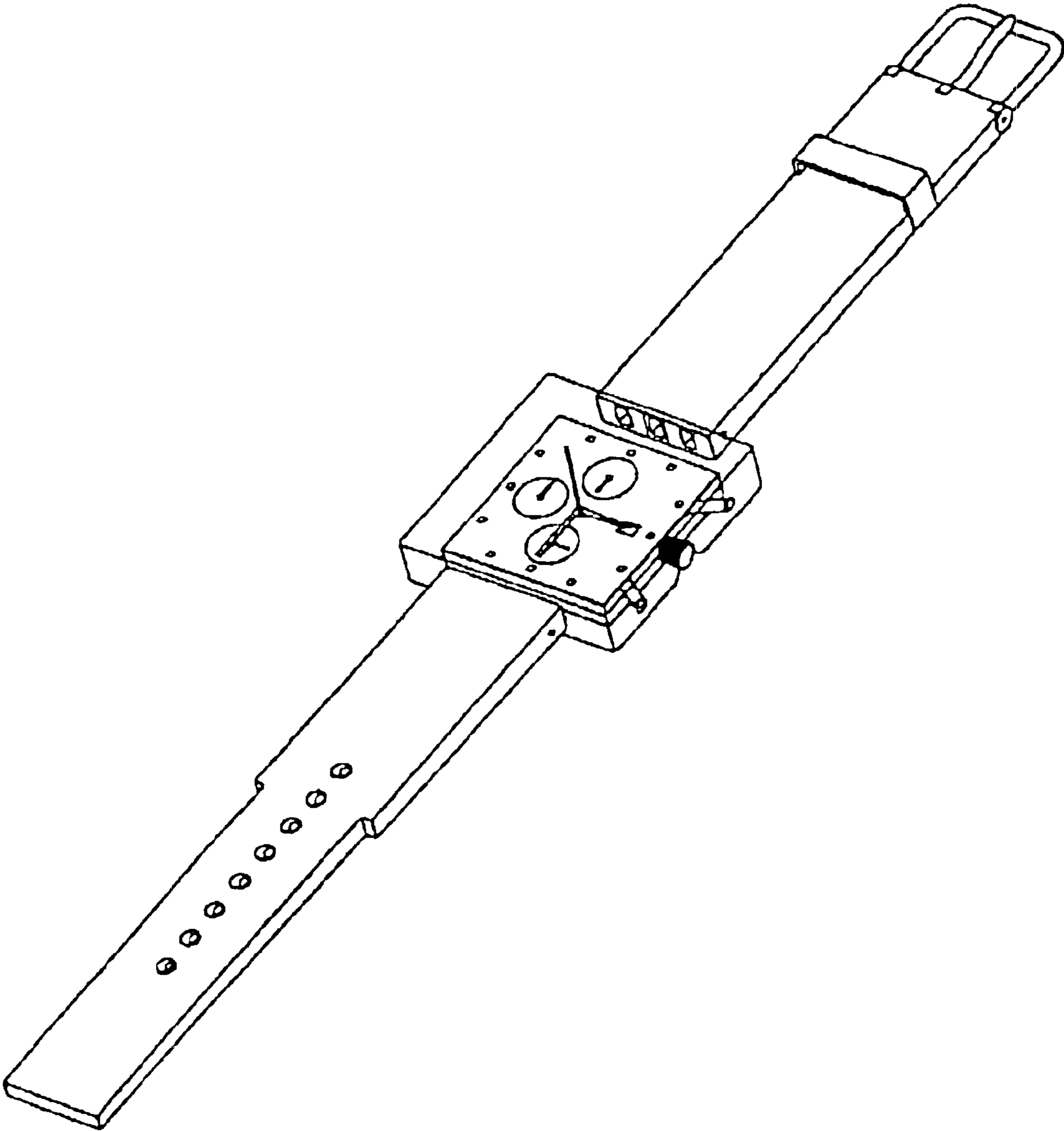

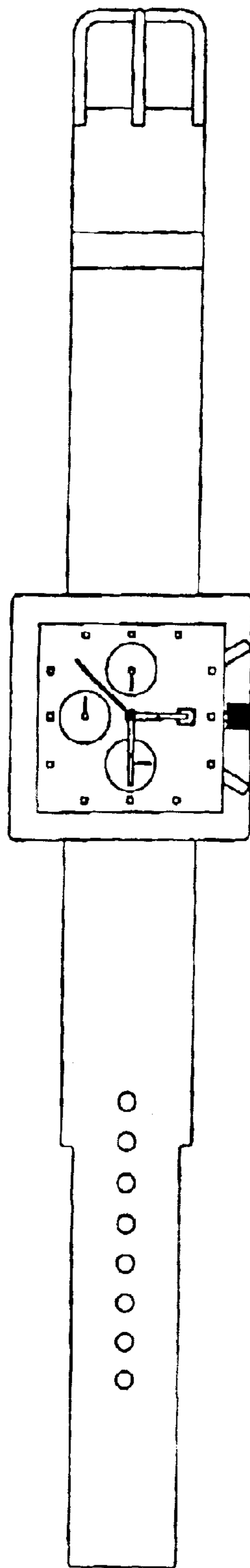

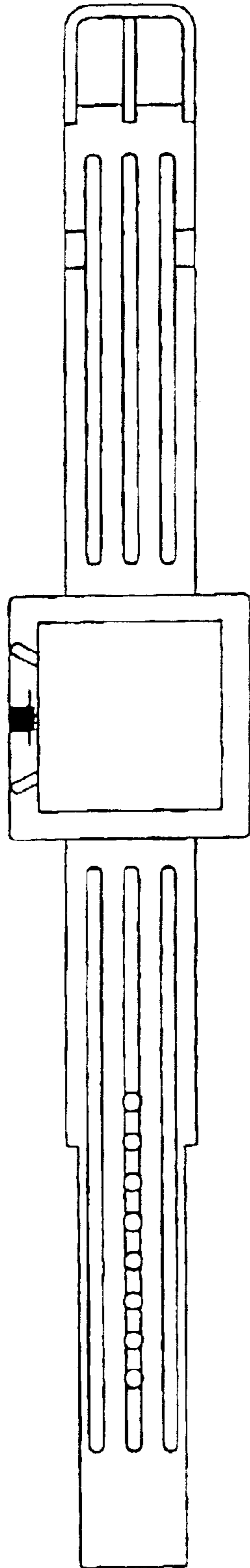

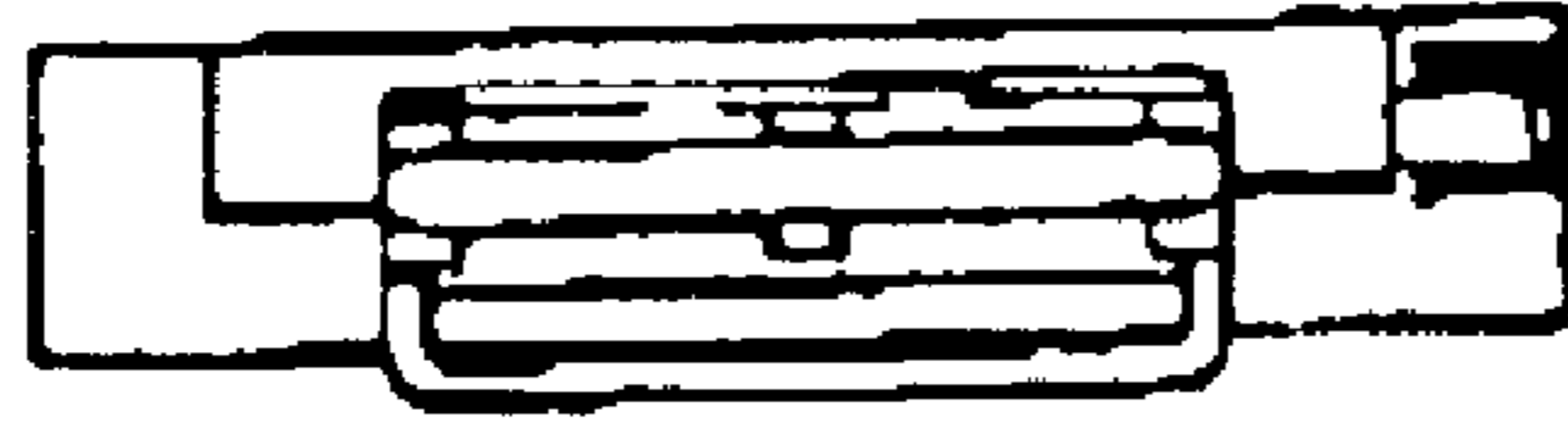

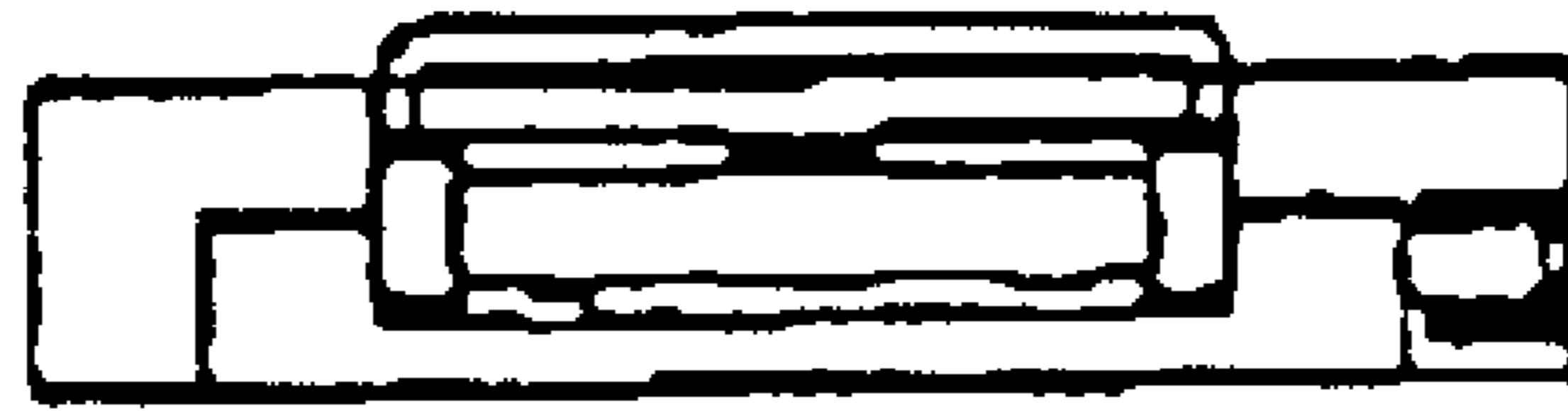
