I claim the ornamental design for <cellular phone>, as shown and described.

DESCRIPTION

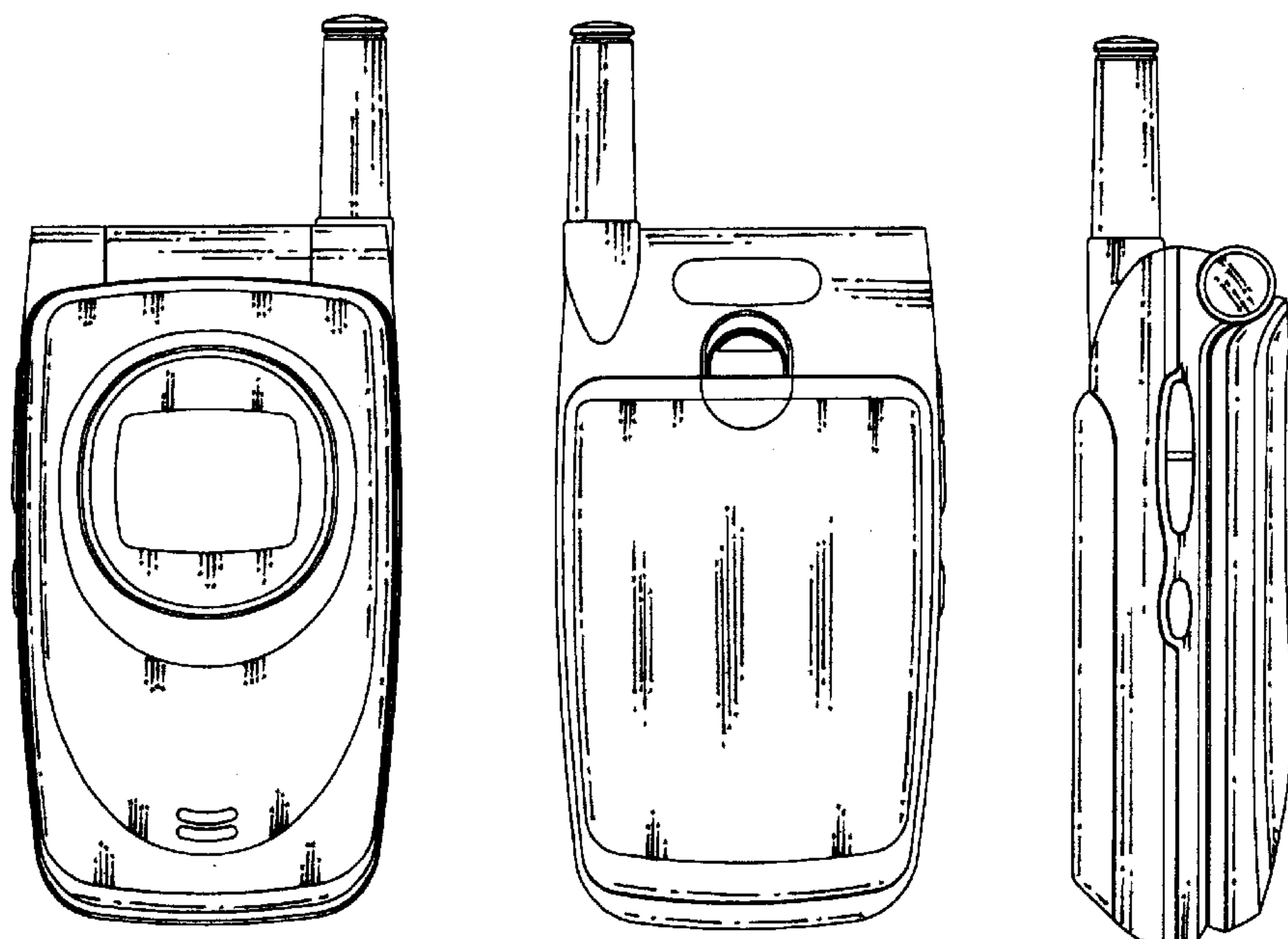

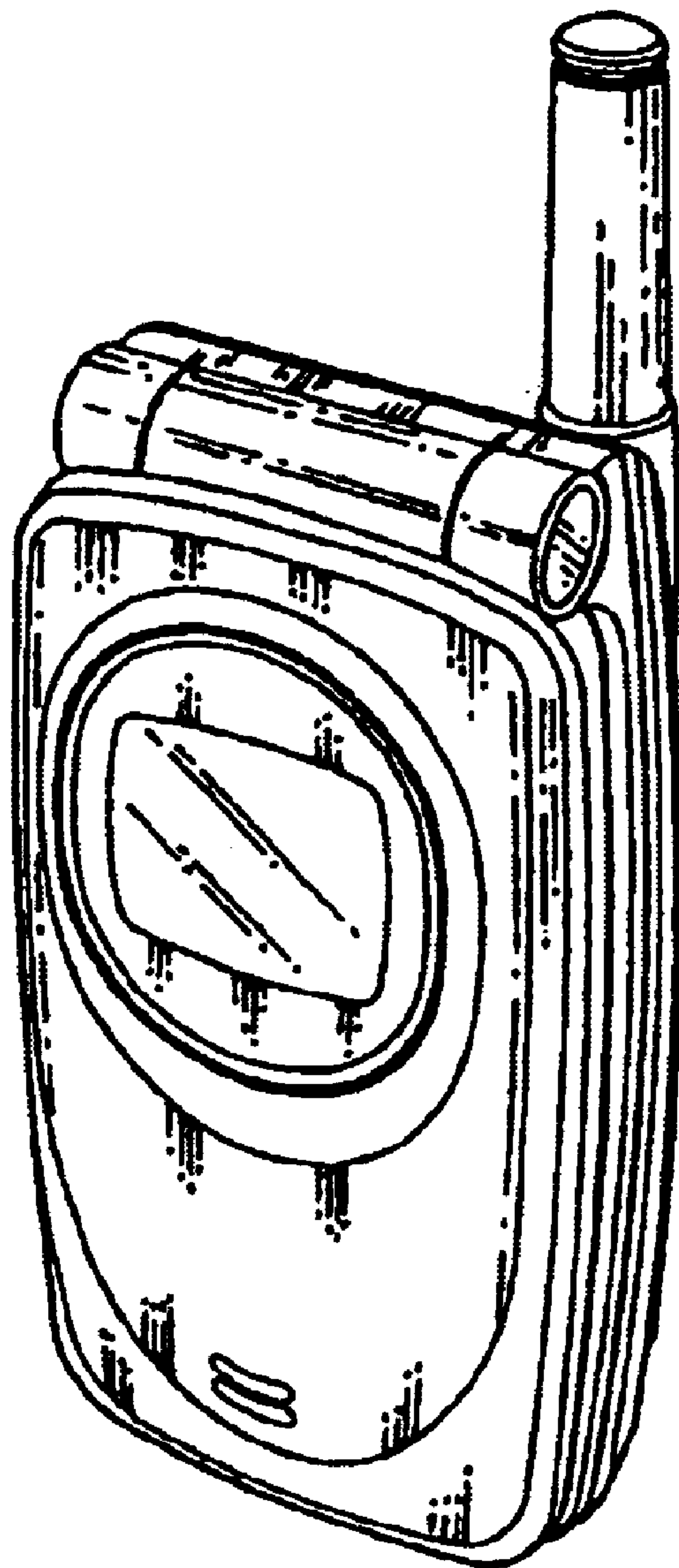

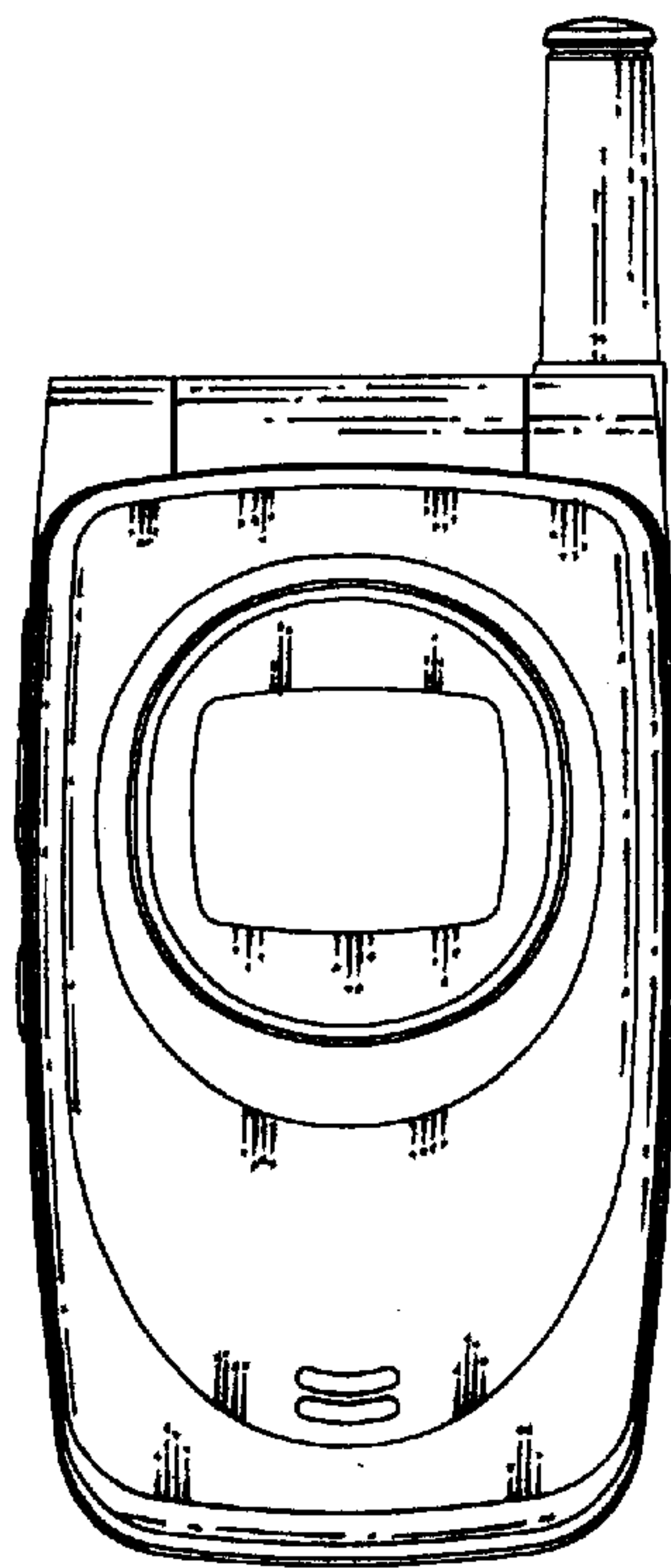

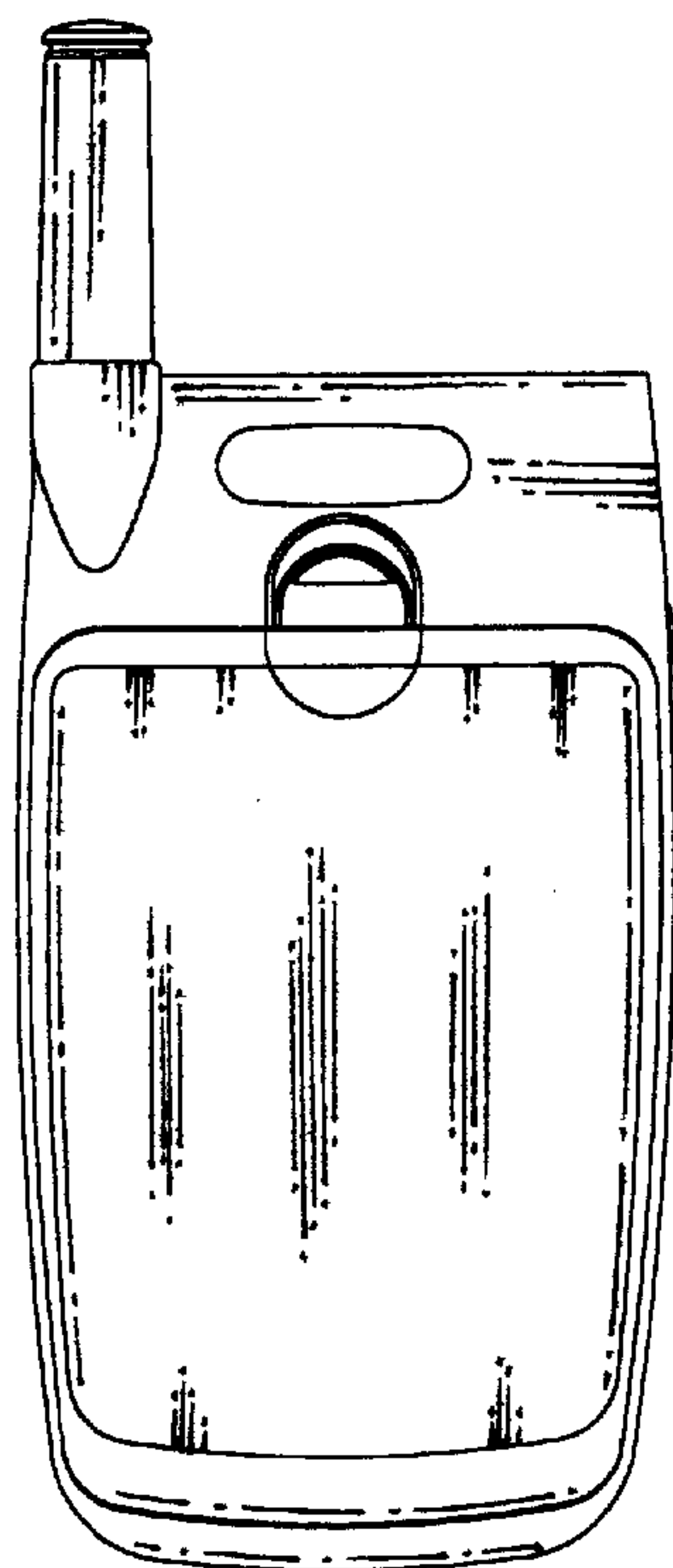

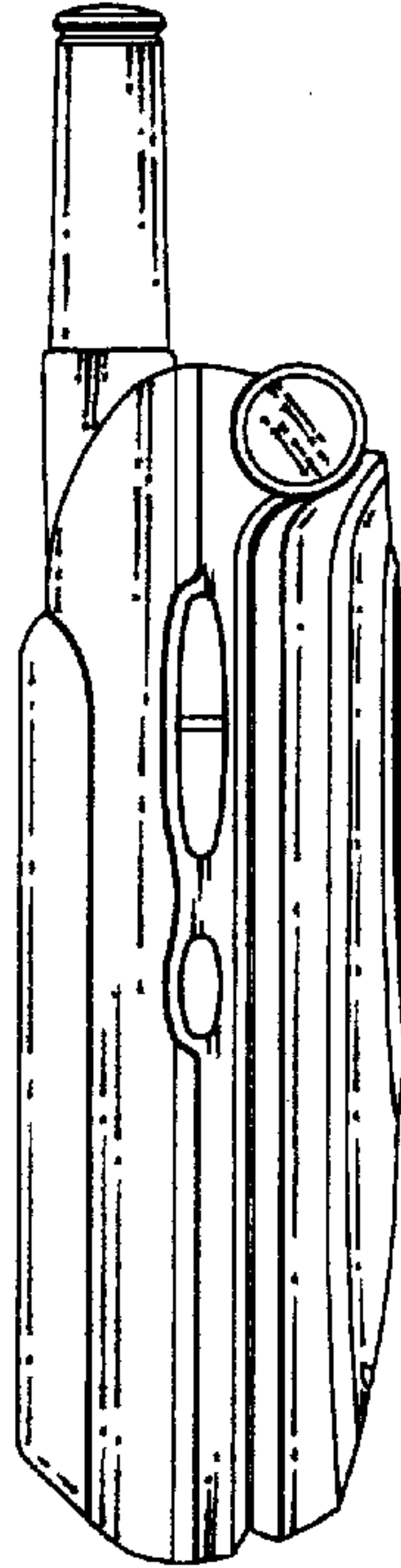

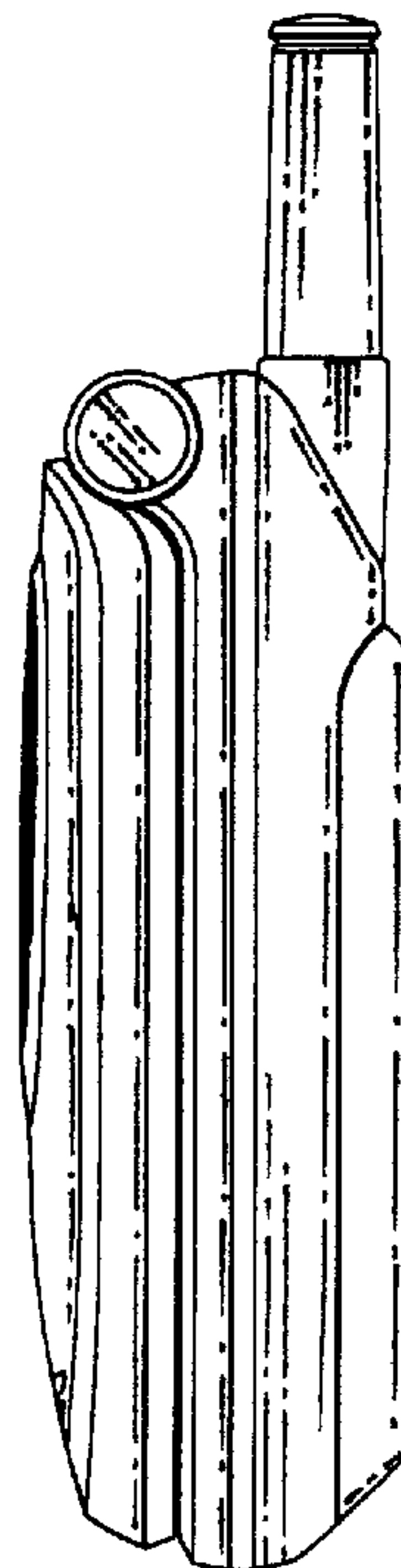

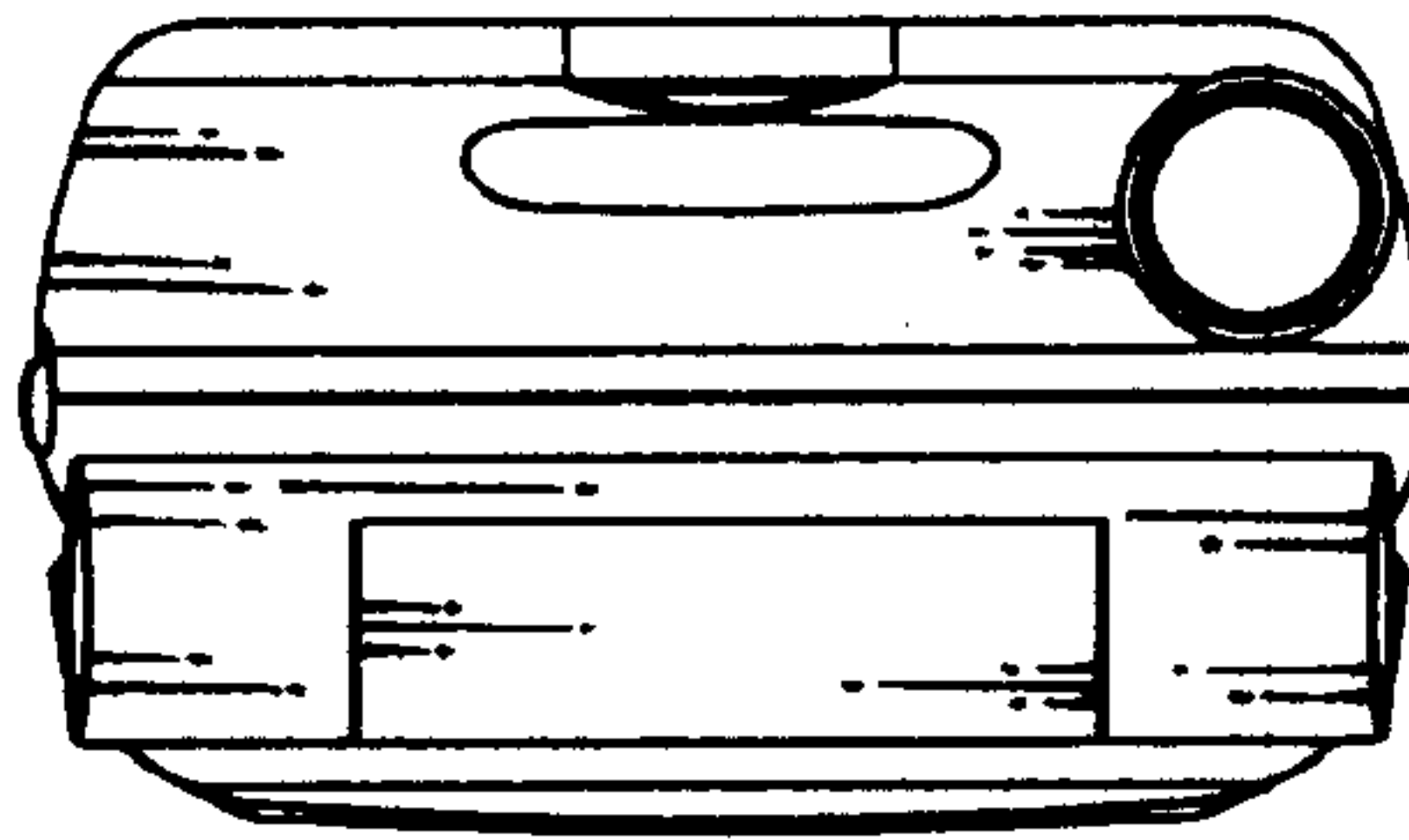
