FIG. 3 is a rear view for the storage server shown in FIG. 1.

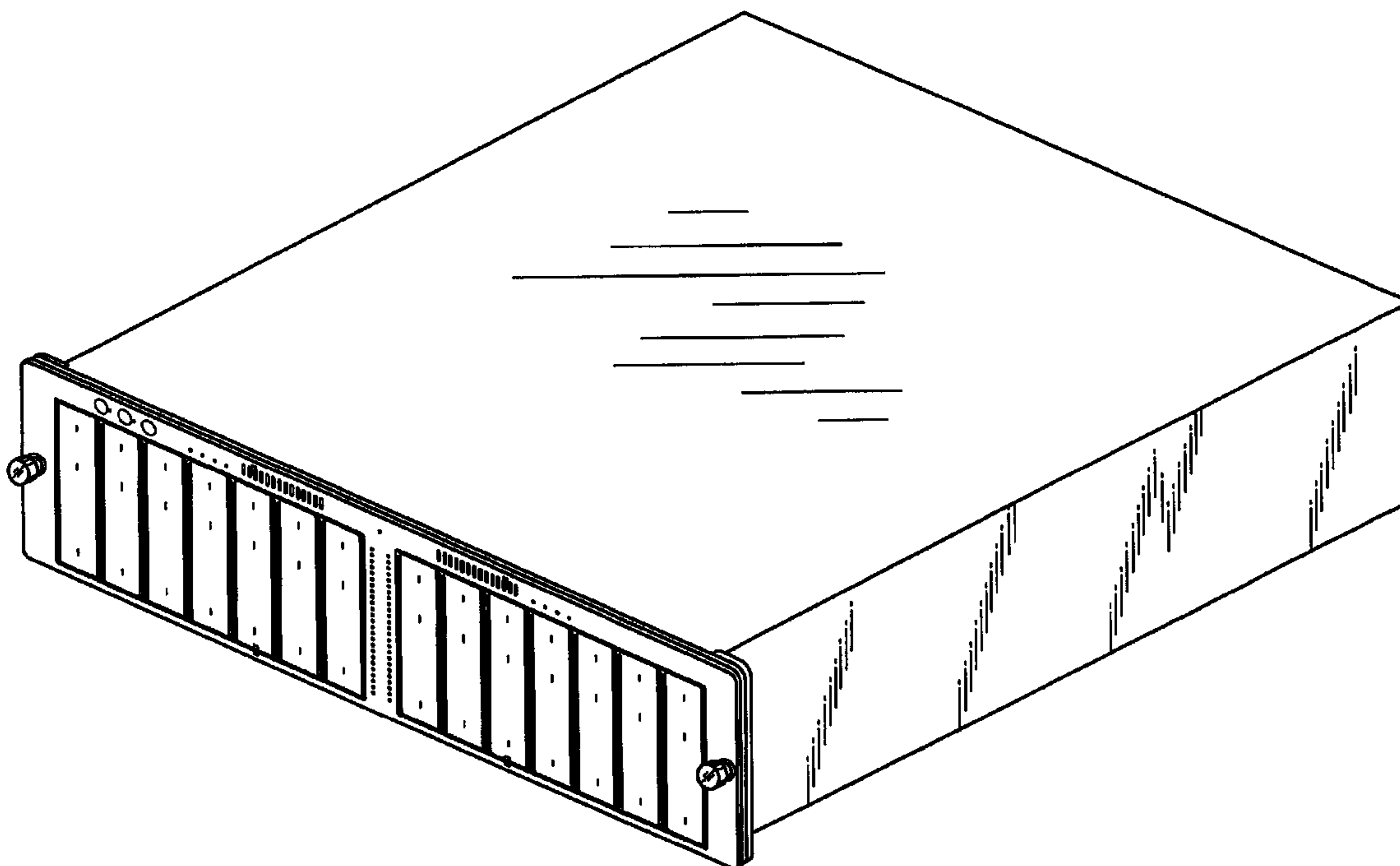
FIG. 4 is a left side view for the storage server shown in FIG. 1.

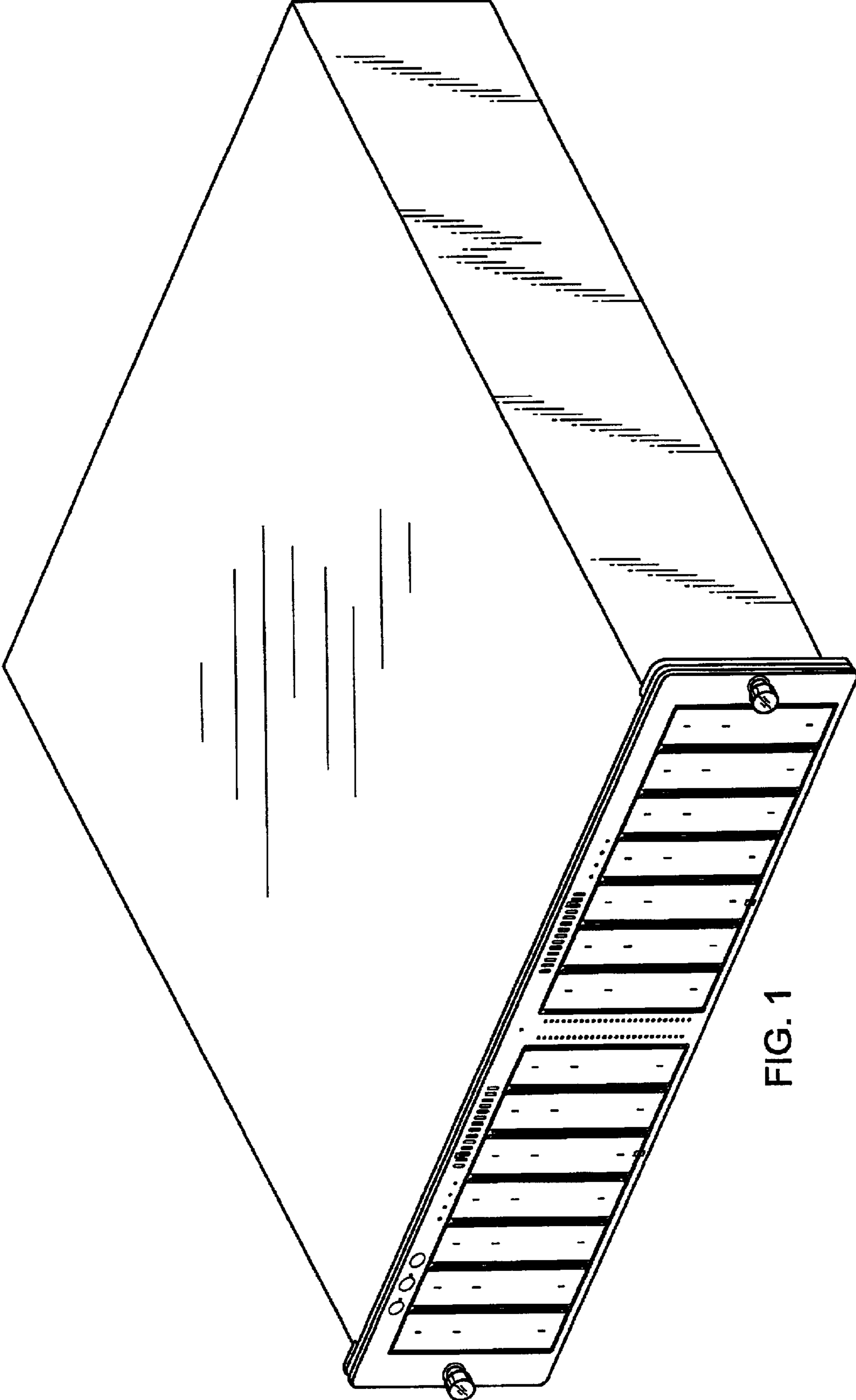

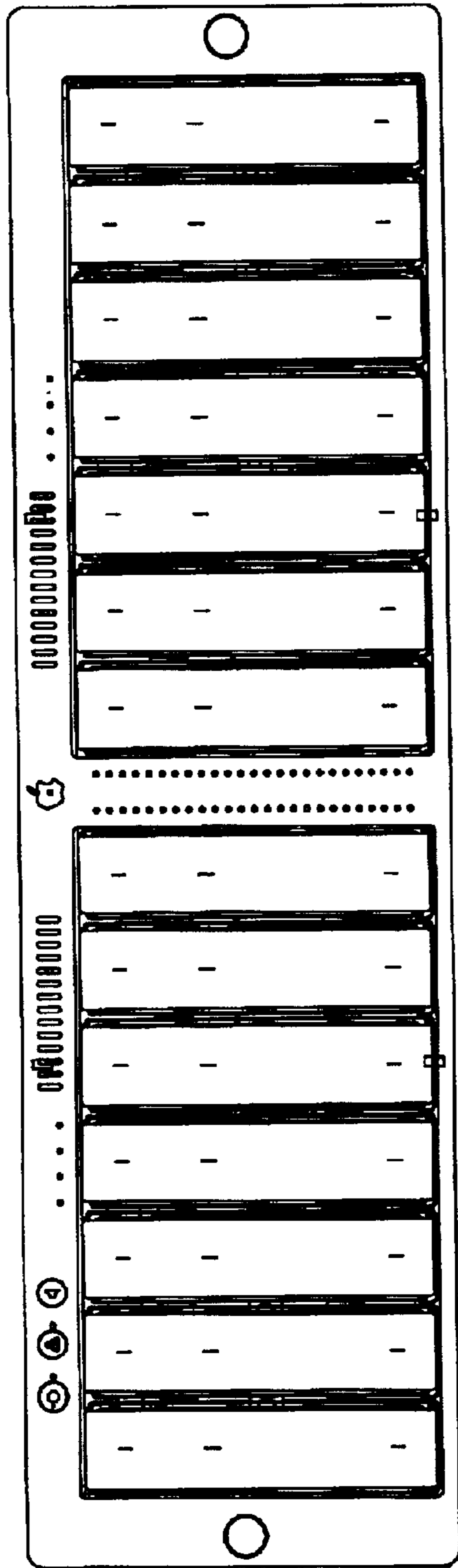

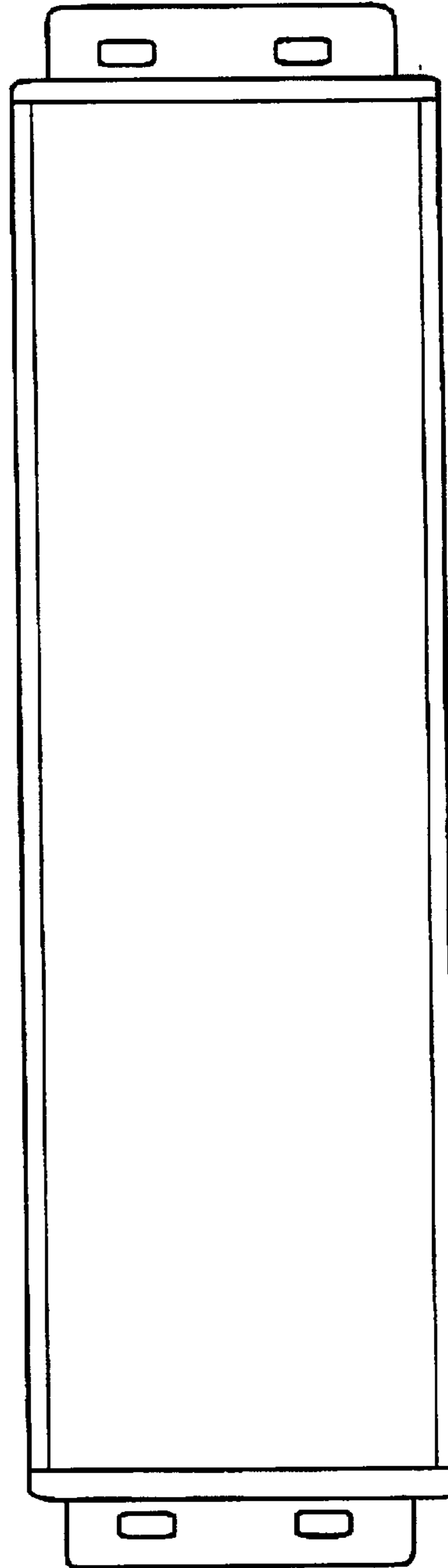

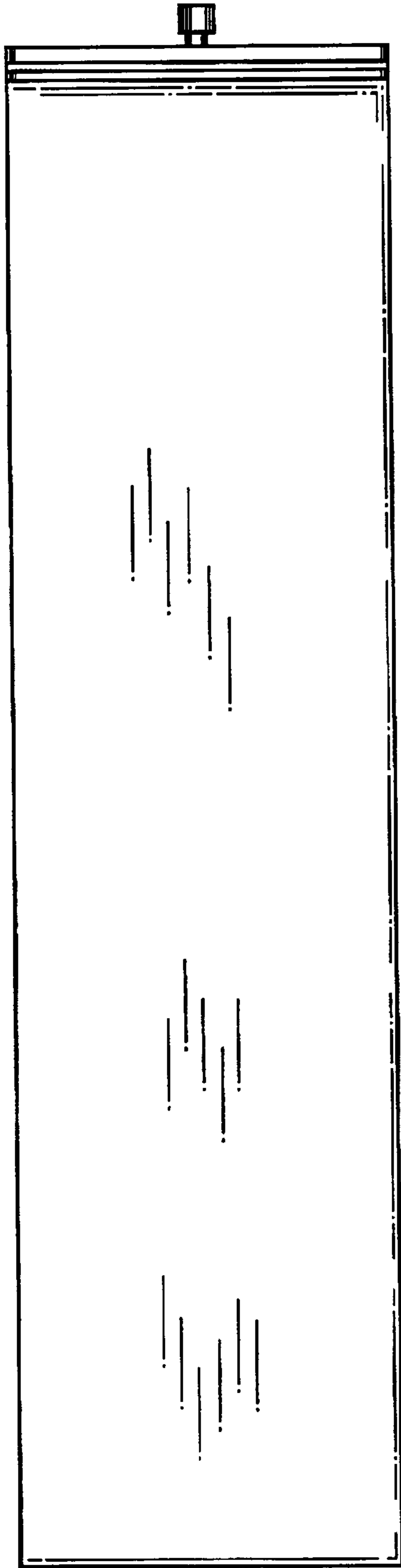

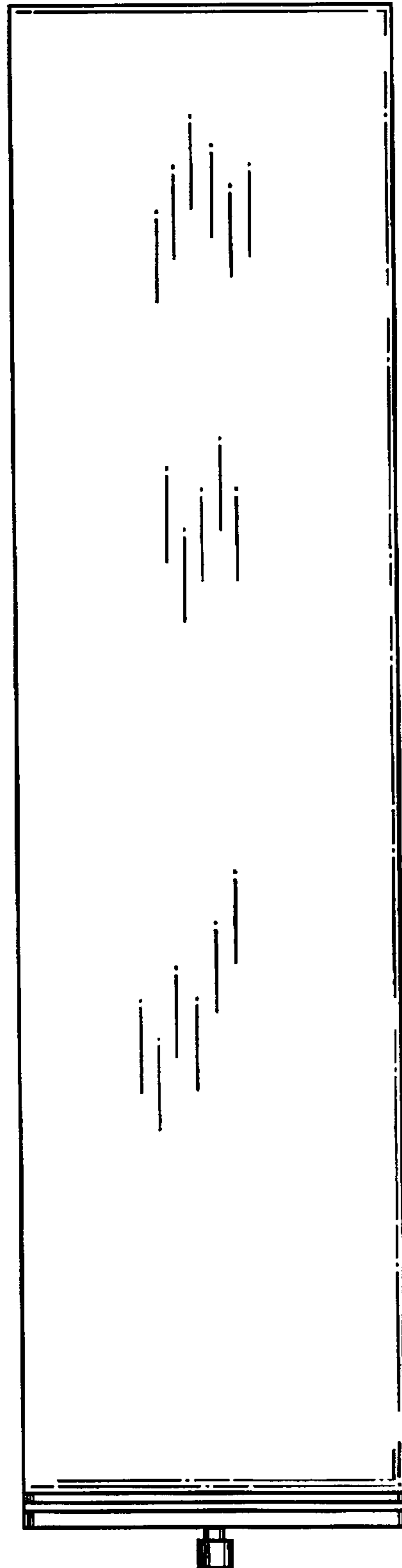

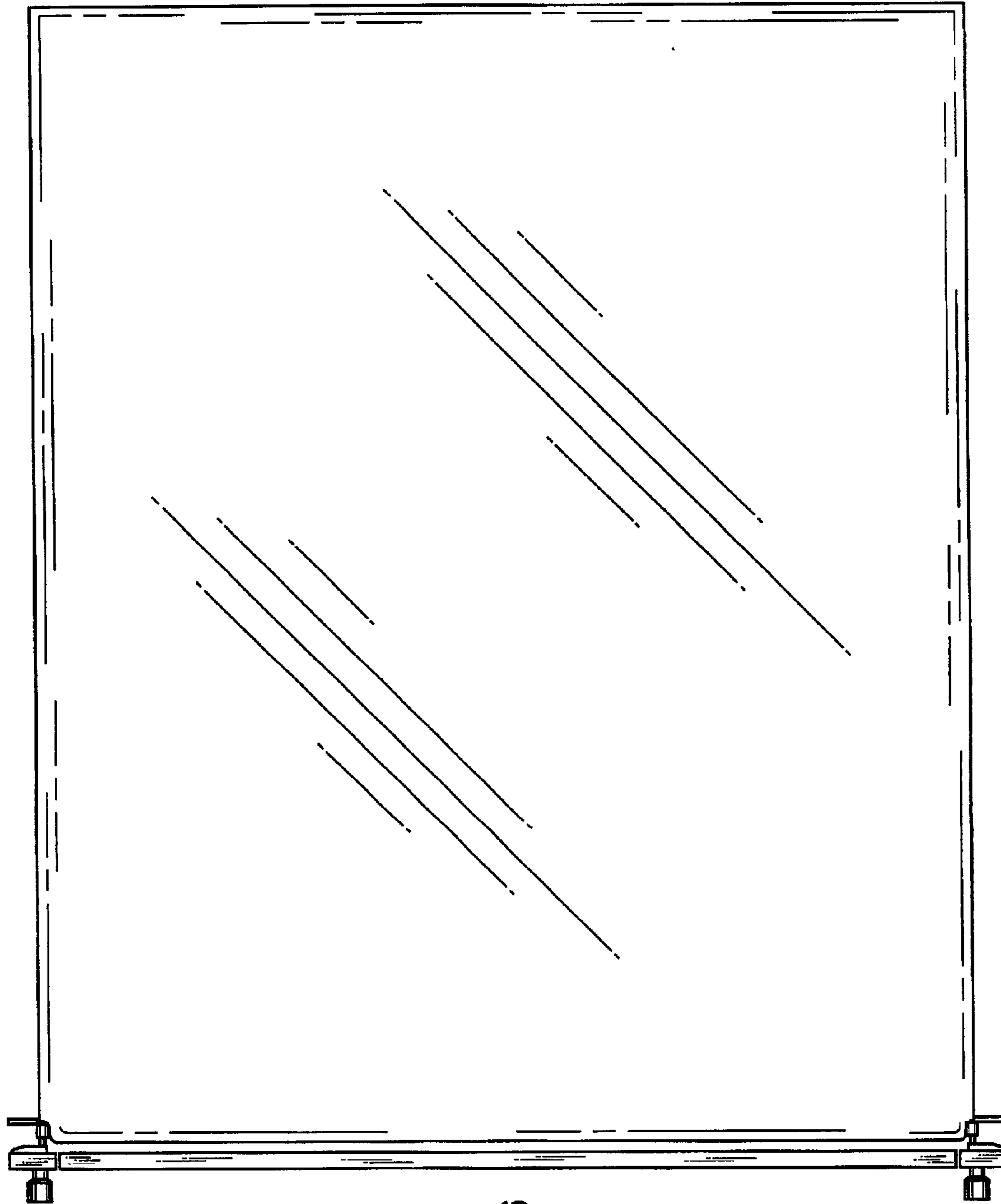

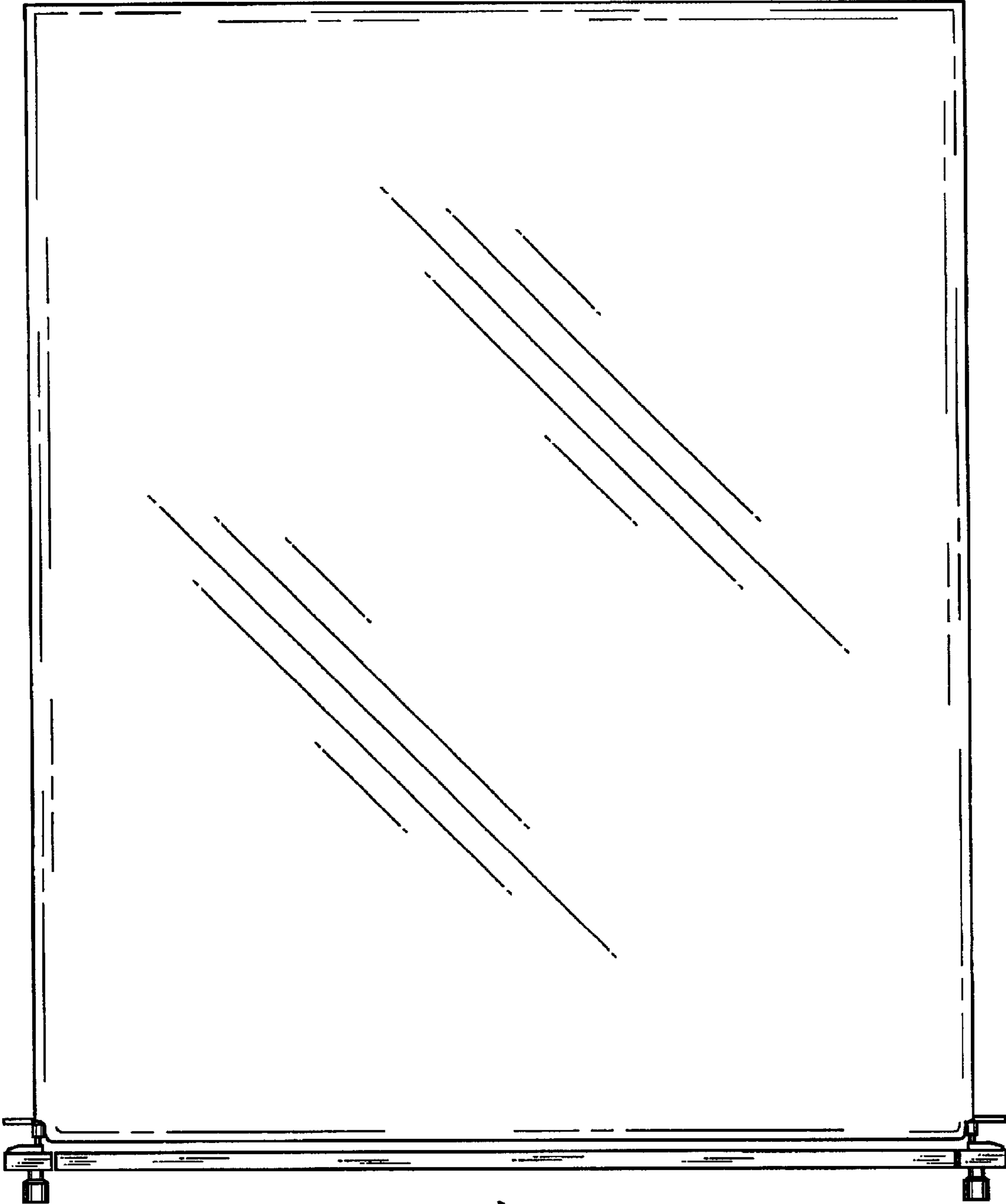
