(57) **CLAIM**

The ornamental design for a glass door refrigeration cabinet with cooling chamber, as shown and described.

**DESCRIPTION**

The claimed glass door refrigeration cabinet with cooling chamber is used to refrigerate items.

FIG. 1 is a bottom plan view of a design for a glass door refrigeration cabinet with cooling chamber in accordance with the present invention.

FIG. 2 is a right elevational view of the glass door refrigeration cabinet with cooling chamber.

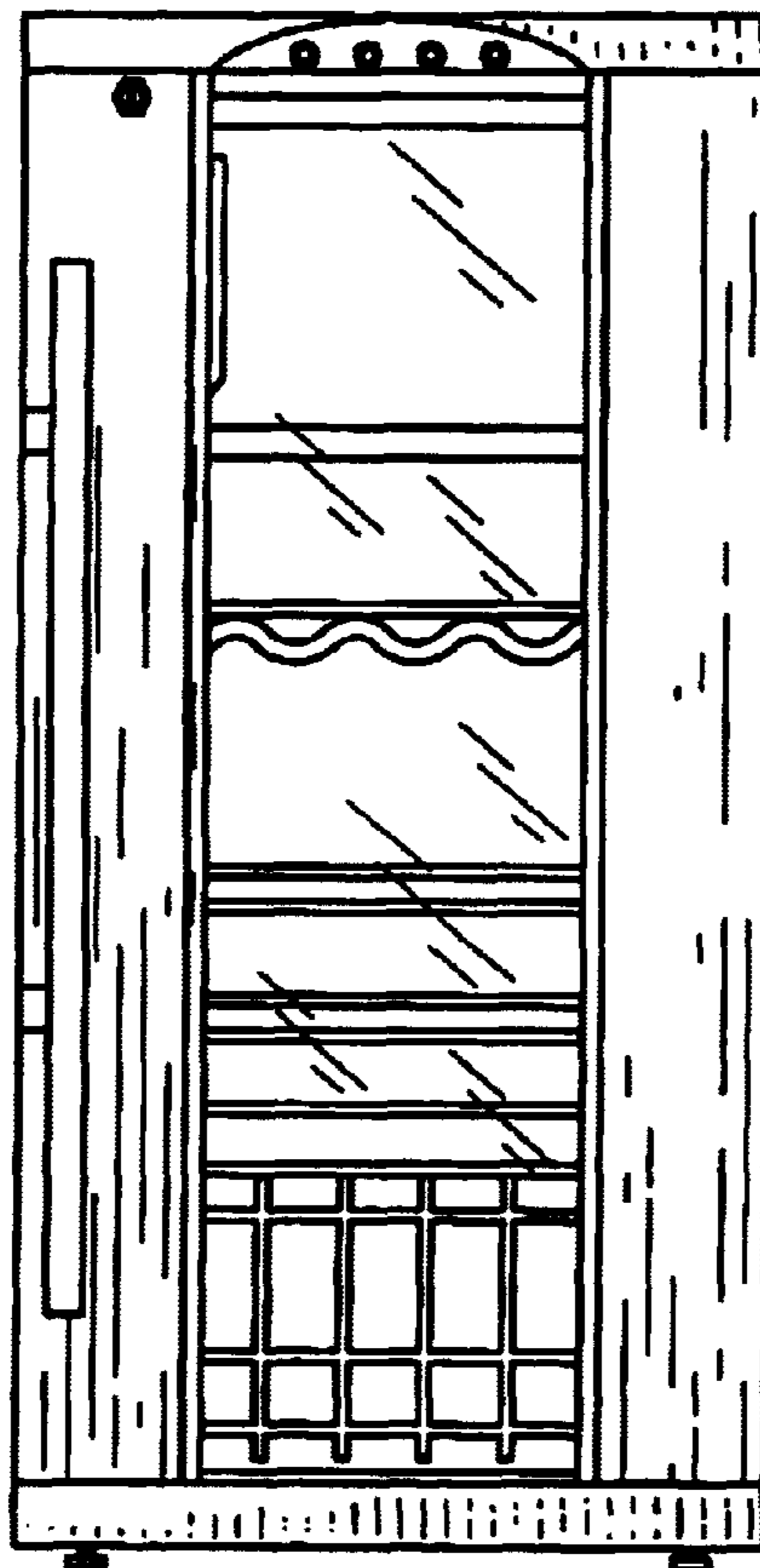
FIG. 3 is a front elevational view of the display glass door refrigeration cabinet with cooling chamber.

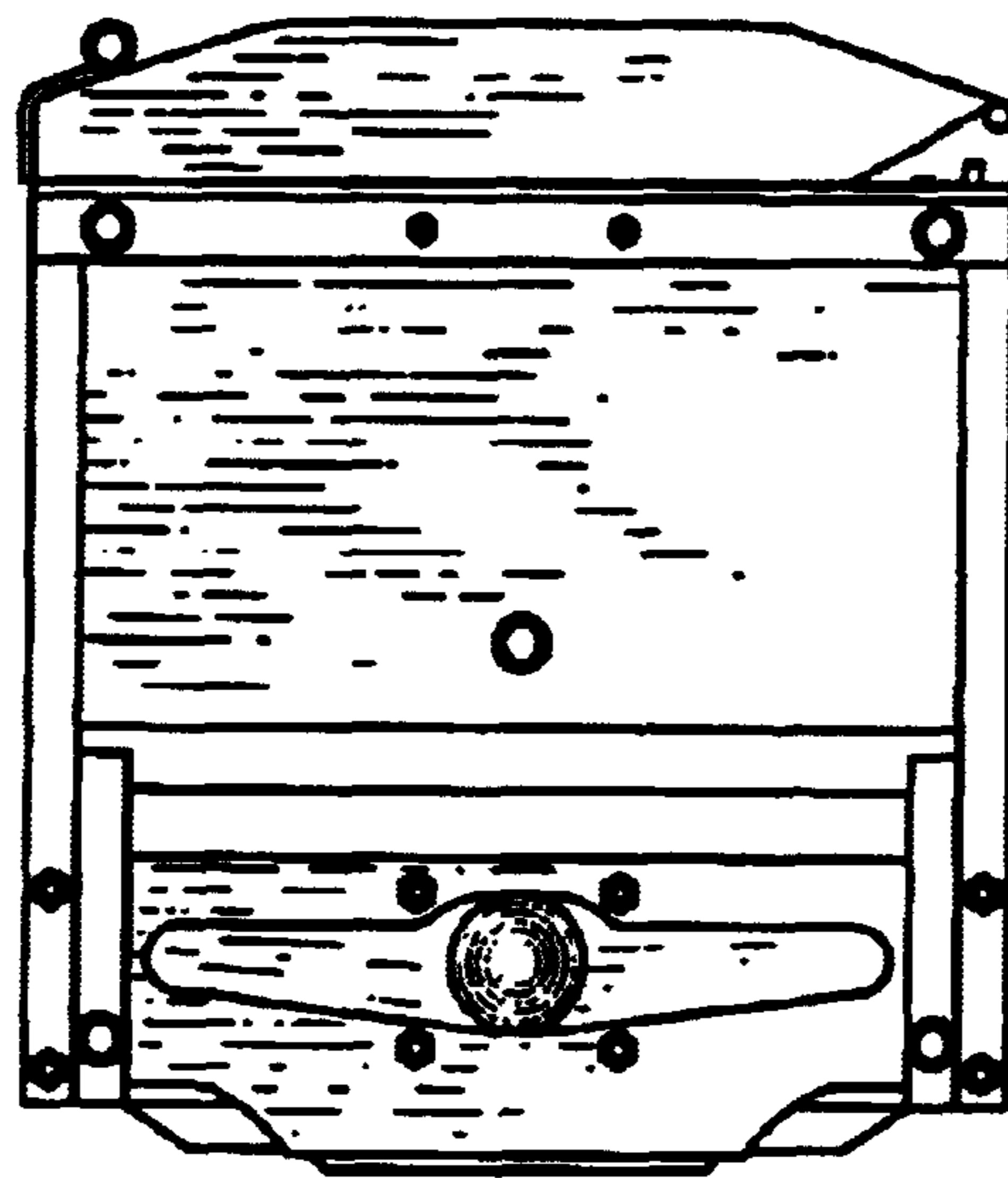
FIG. 4 is a left elevational view of the glass door refrigeration cabinet with cooling chamber.

FIG. 5 is a rear elevational view of the glass door refrigeration cabinet with cooling chamber; and,

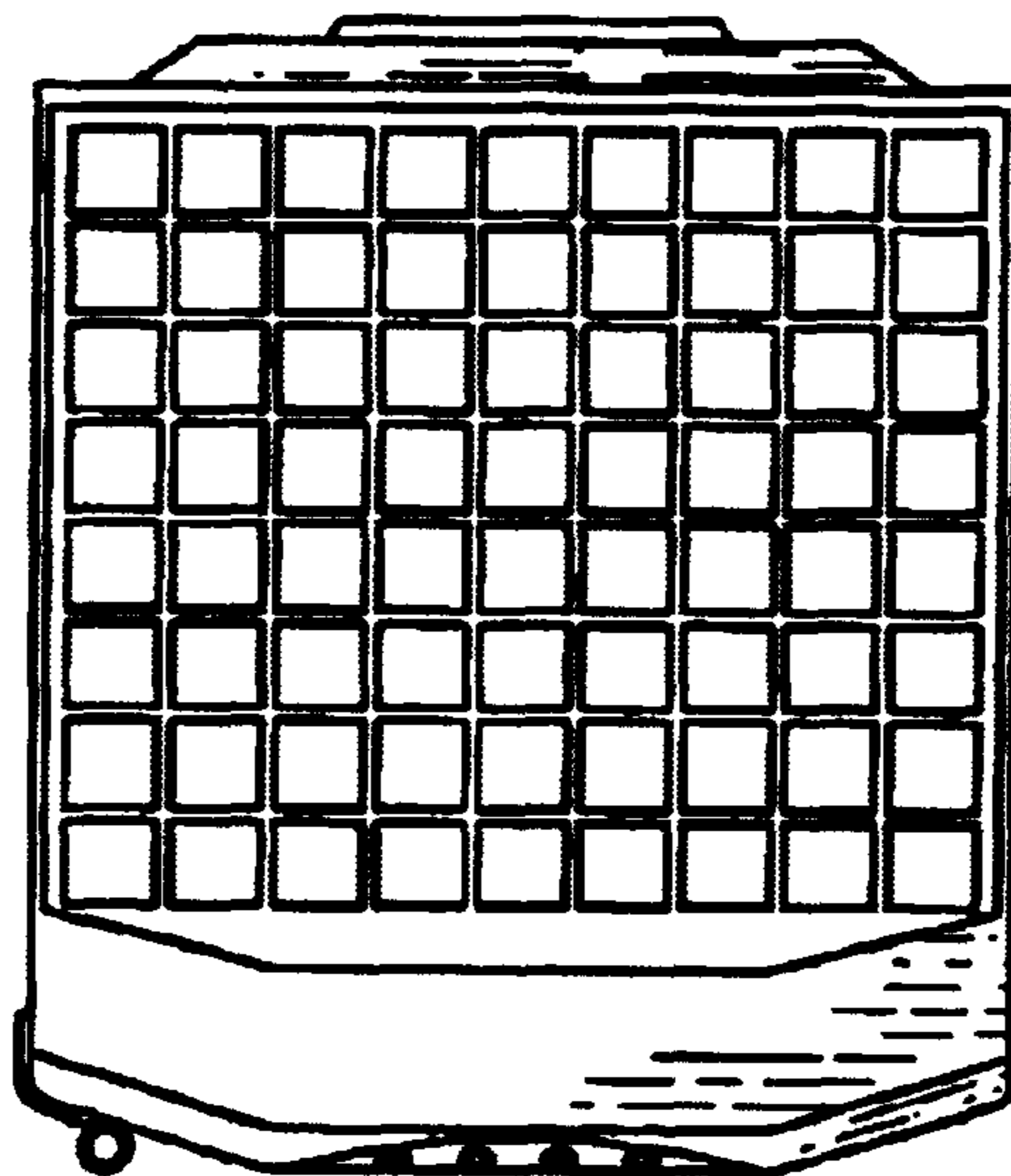
FIG. 6 is a top plan view of the glass door refrigeration cabinet with cooling chamber.

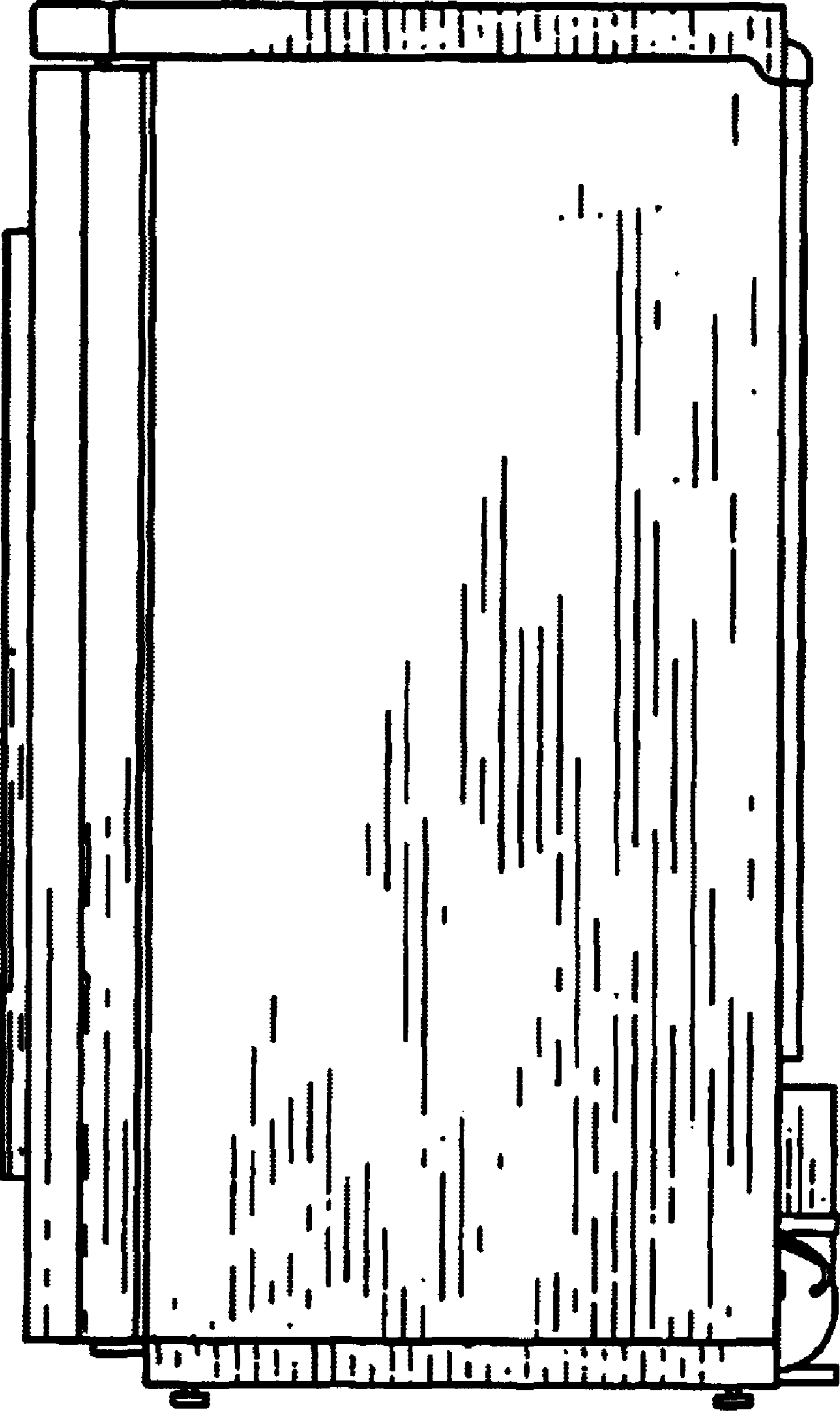




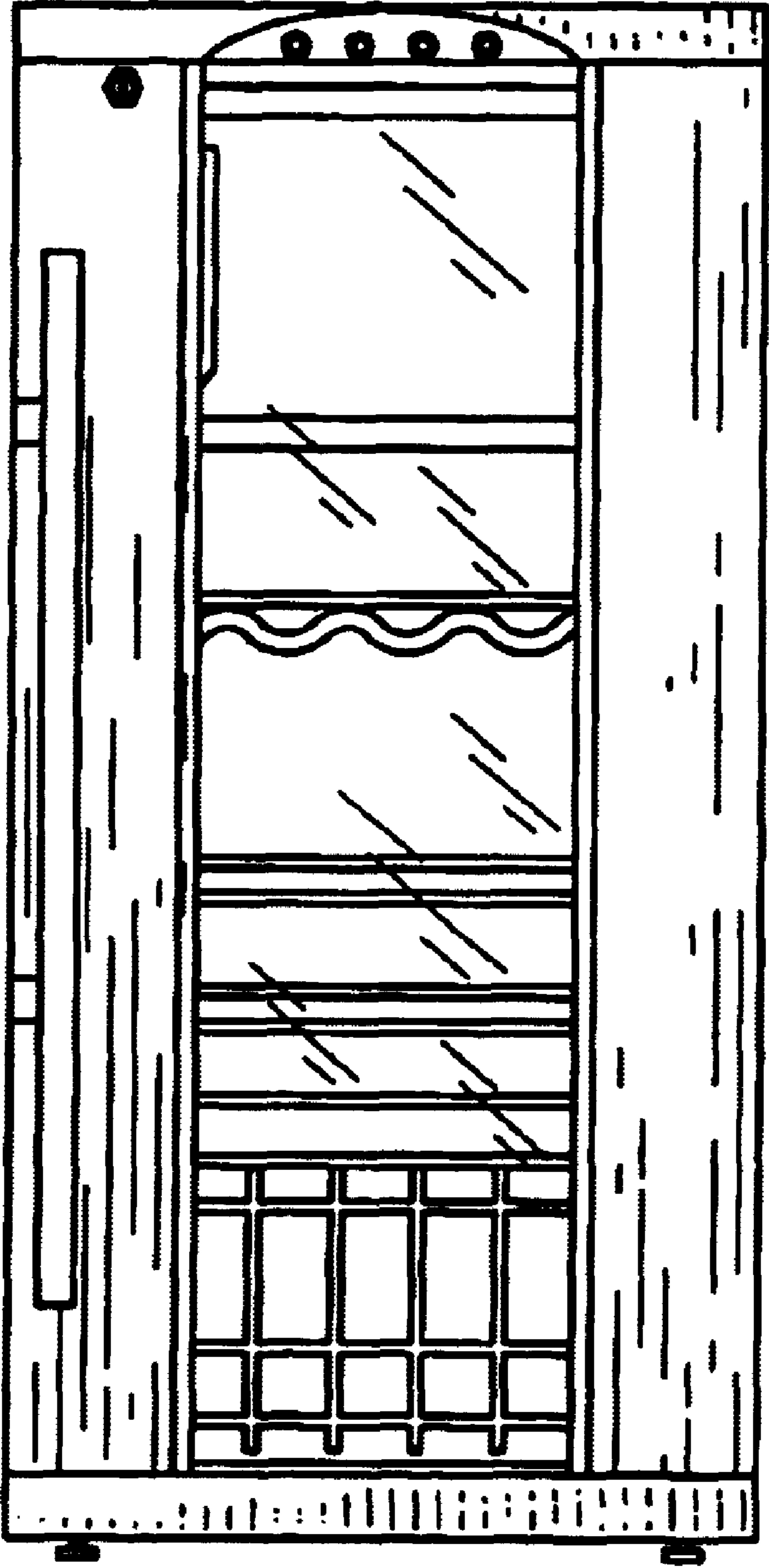

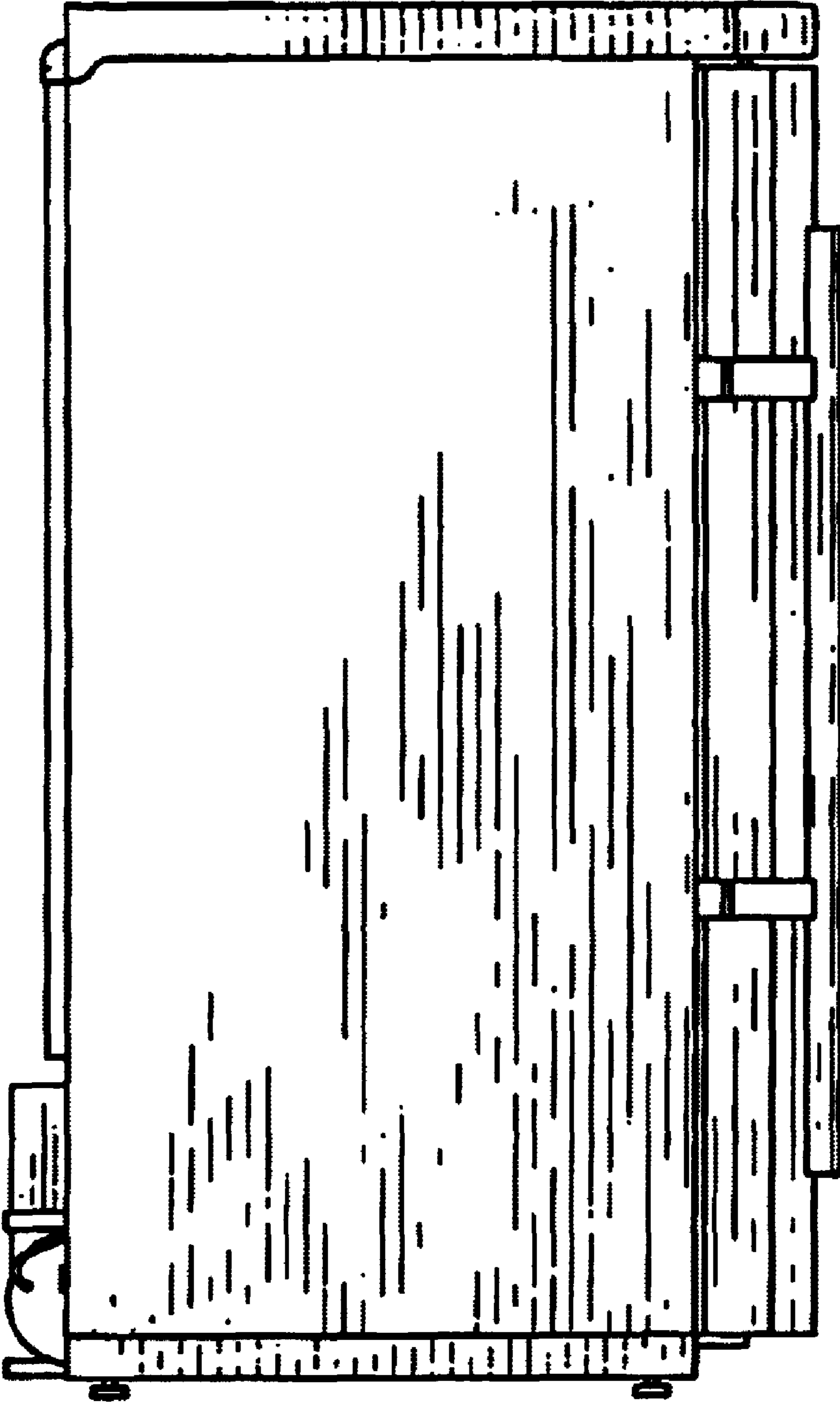

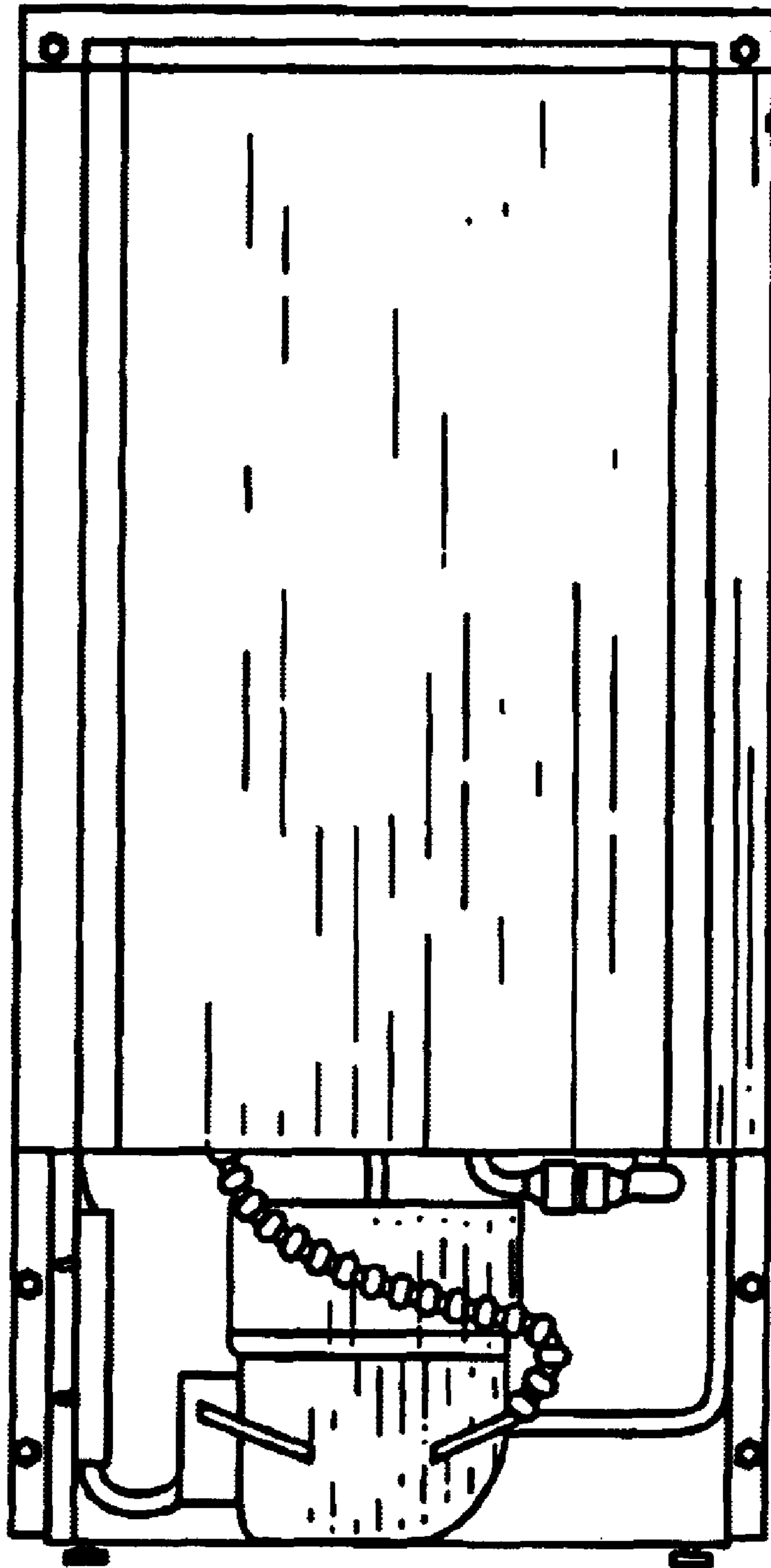
