(57) **CLAIM**

The ornamental design for a golf putter, as shown and described.

DESCRIPTION

FIG. 1 is a top, right side perspective view of the golf putter, the fragmented showing of the shaft is shown broken away due to indeterminate length;

FIG. 2 is a top, left side perspective view of the golf putter according to FIG. 1.

FIG. 3 is a top plan view of the golf putter;

FIG. 4 is a bottom plan view of the golf putter;

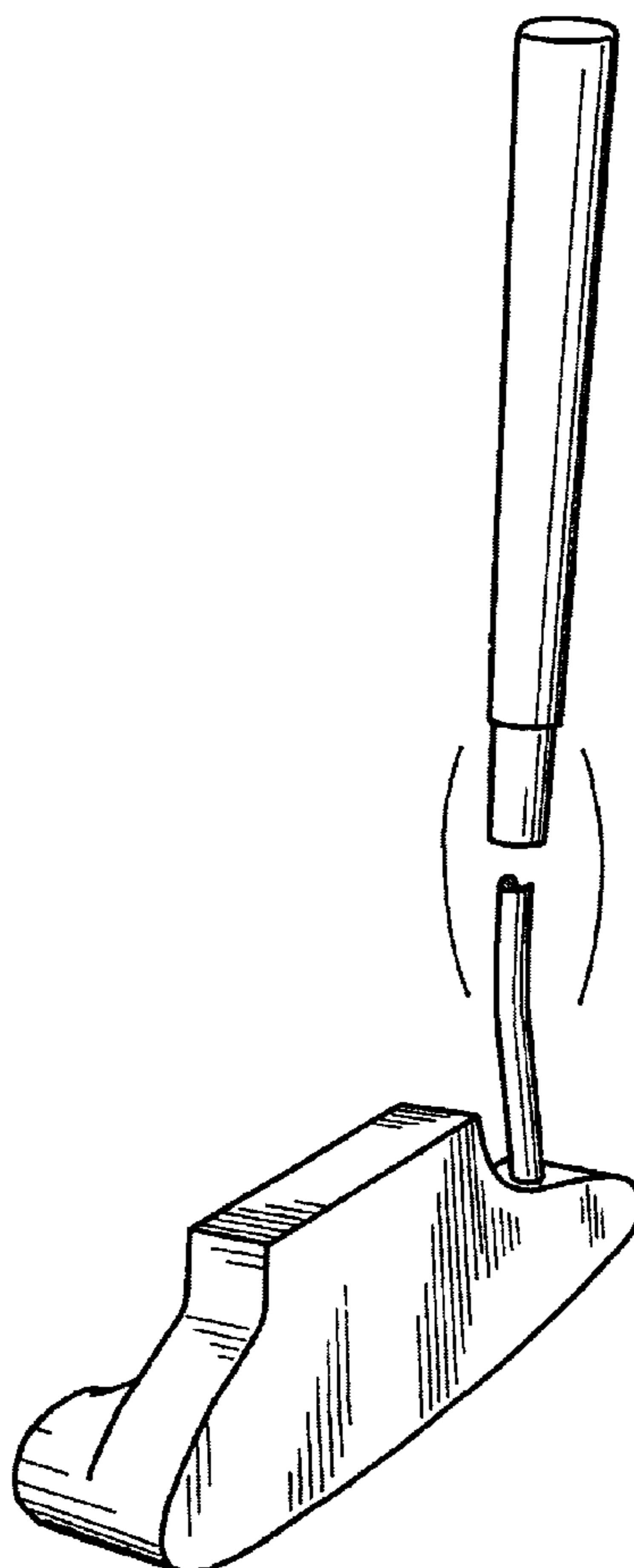
FIG. 5 is a right side elevational view of the golf putter;

FIG. 6 is a left side elevational view of the golf putter;

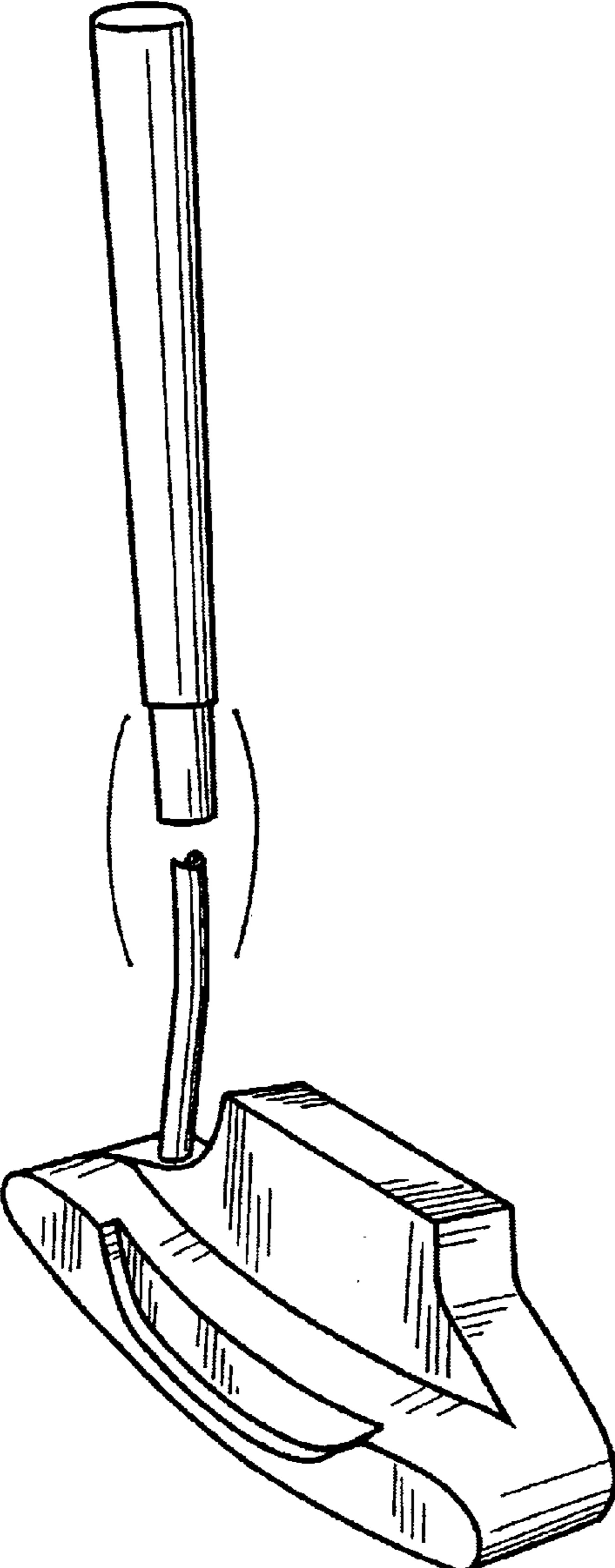

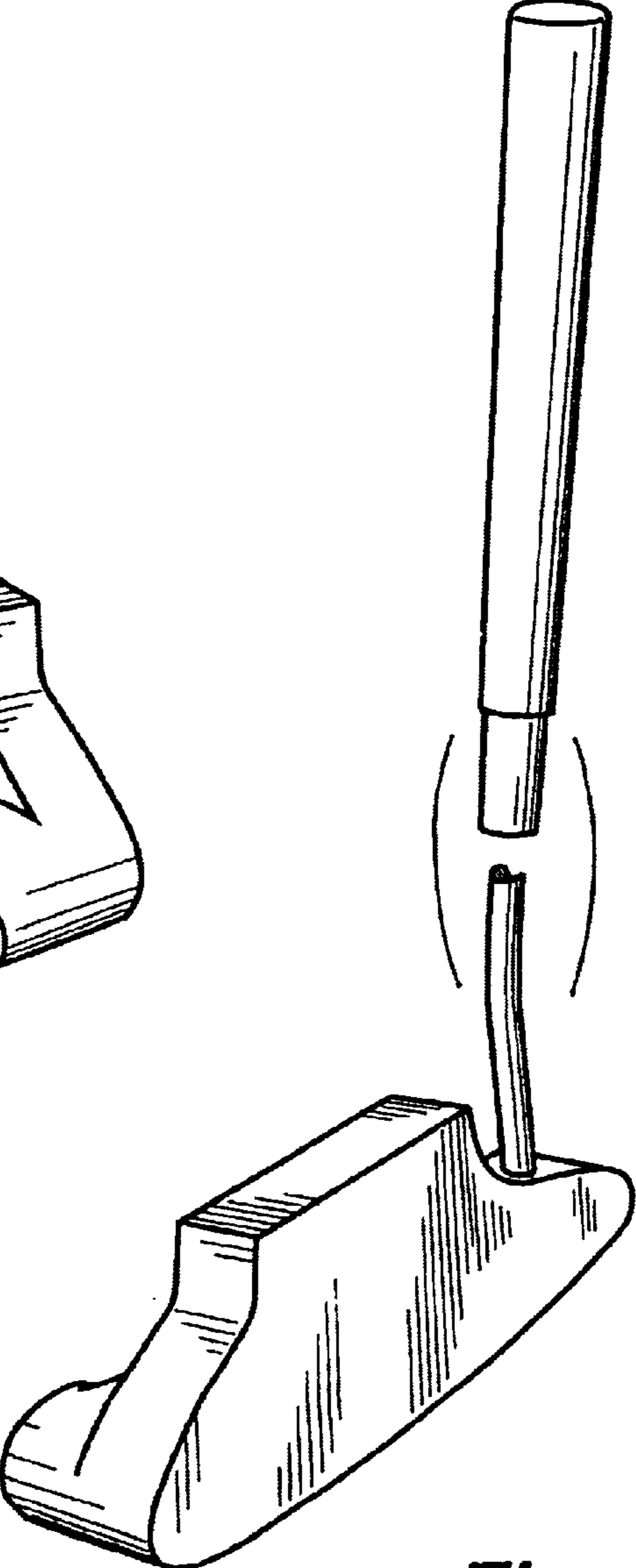

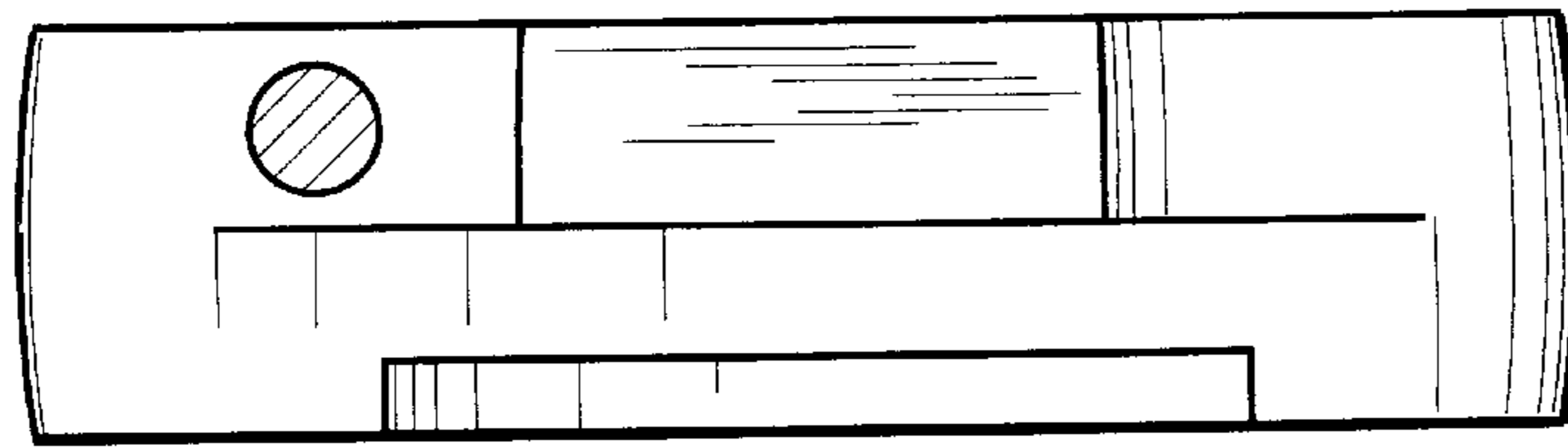

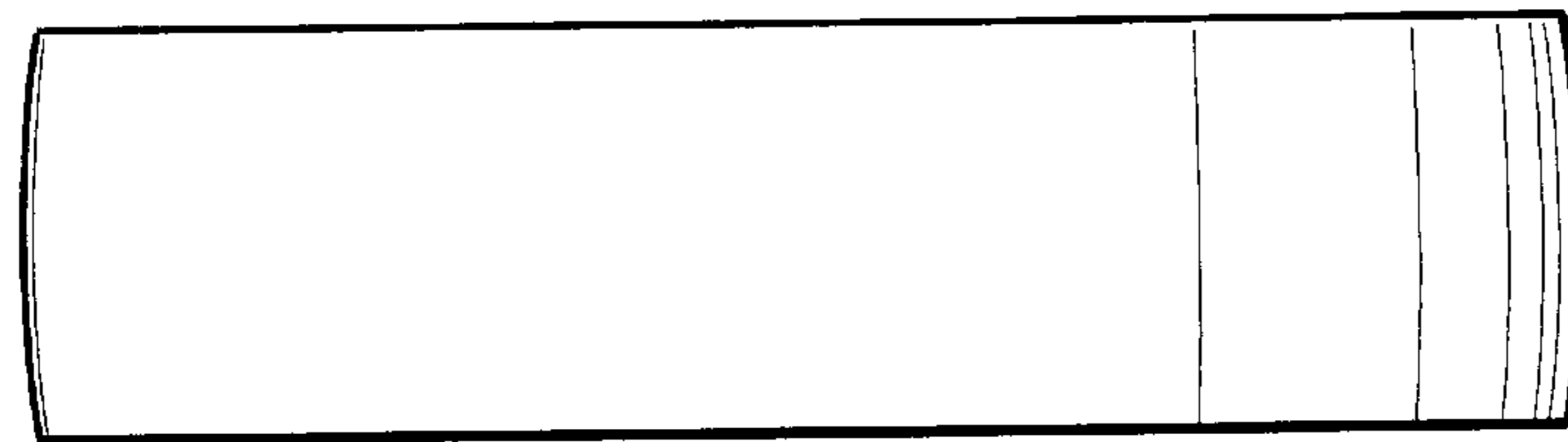

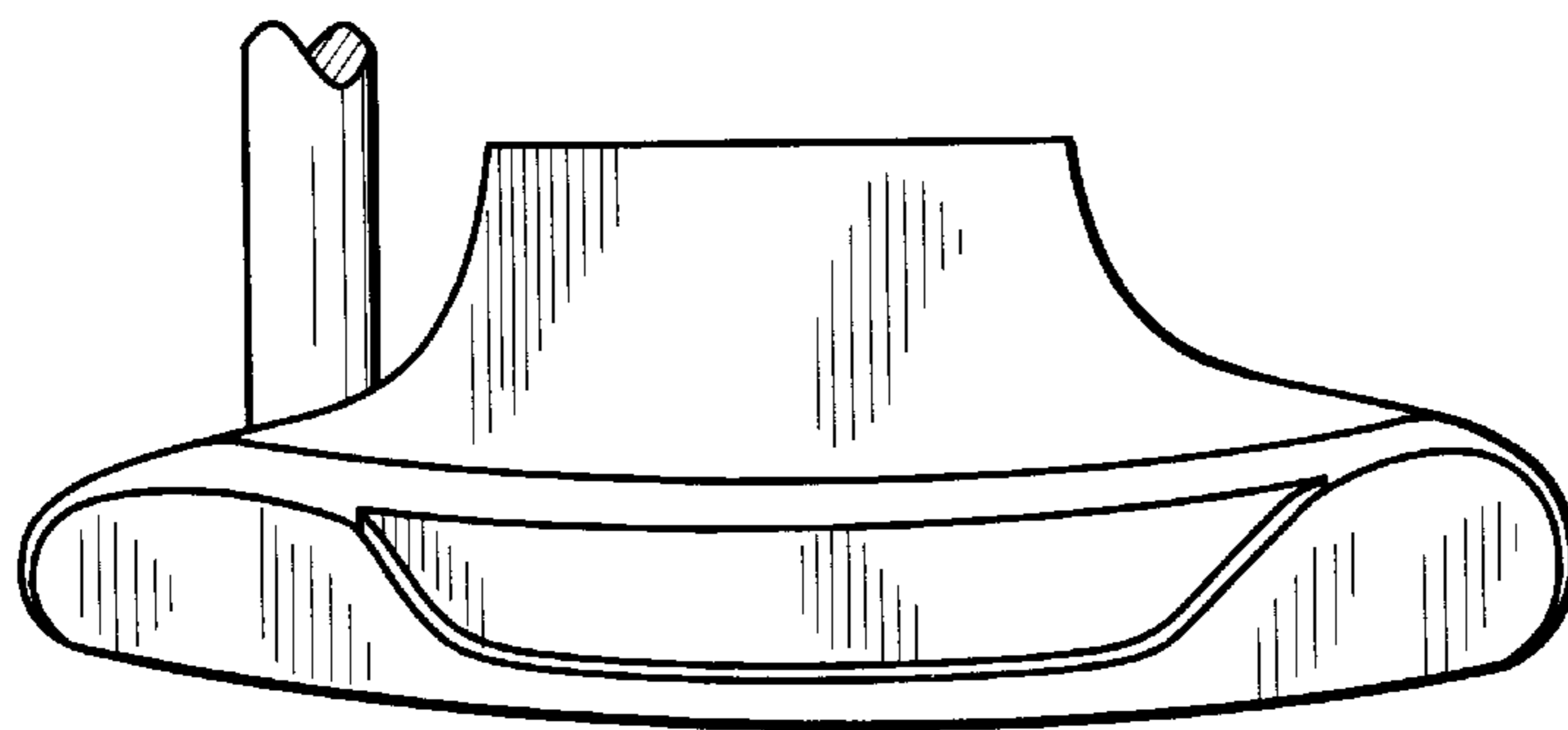

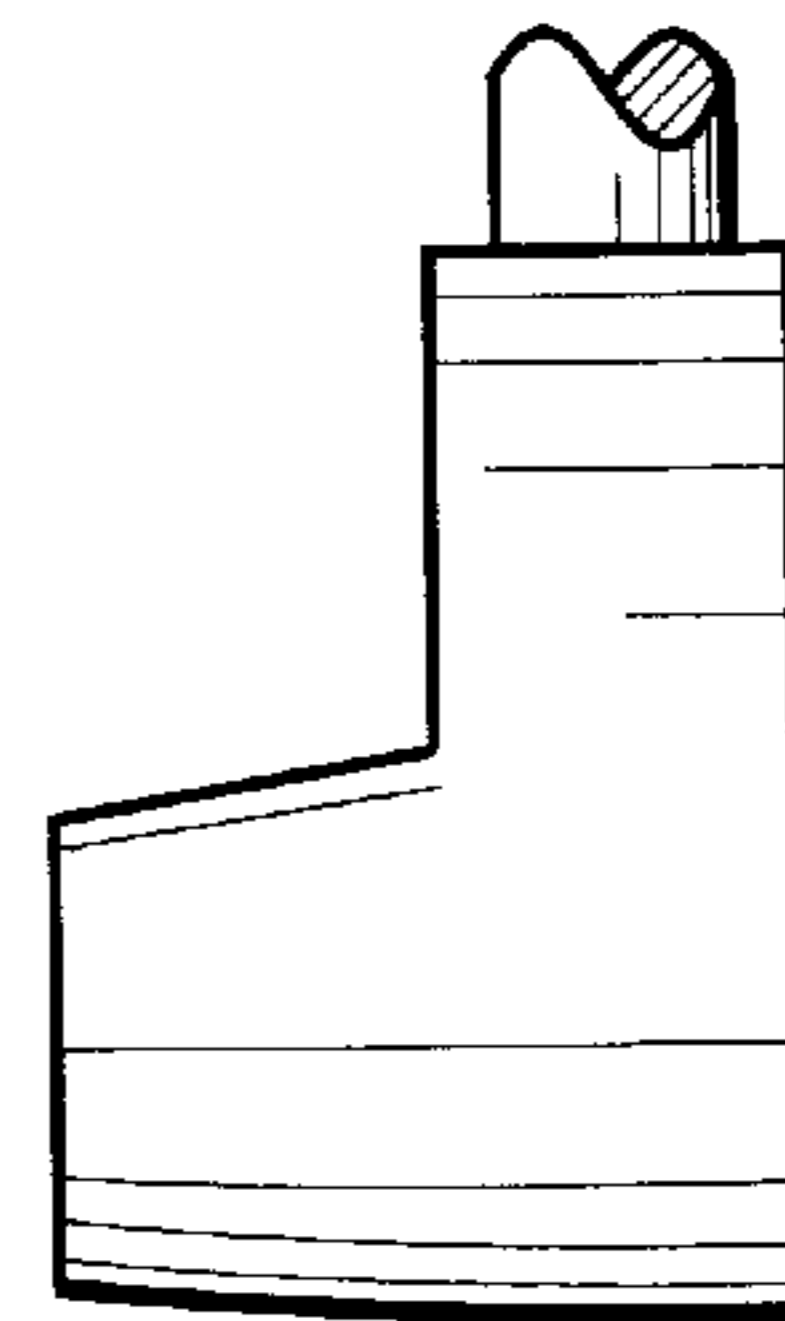

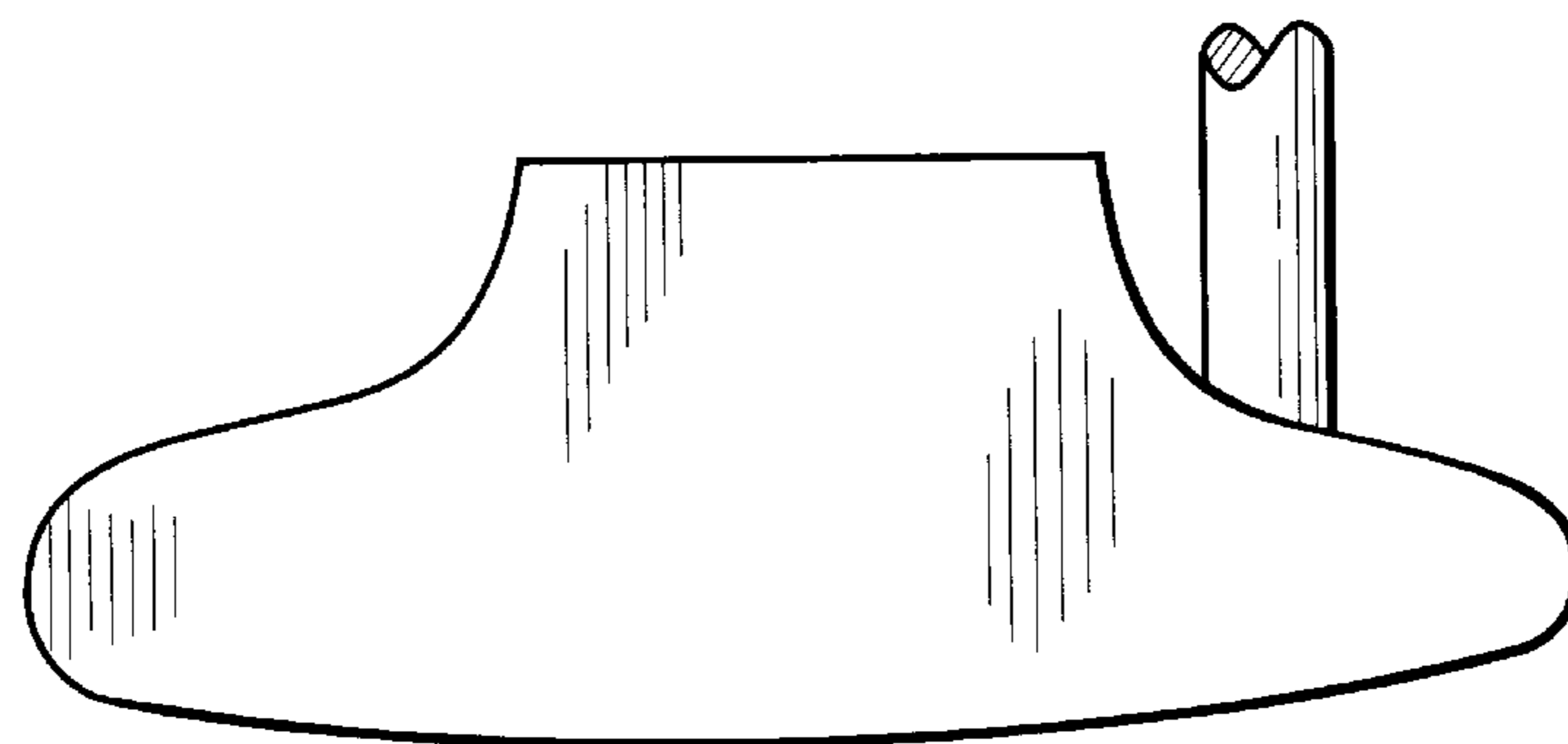

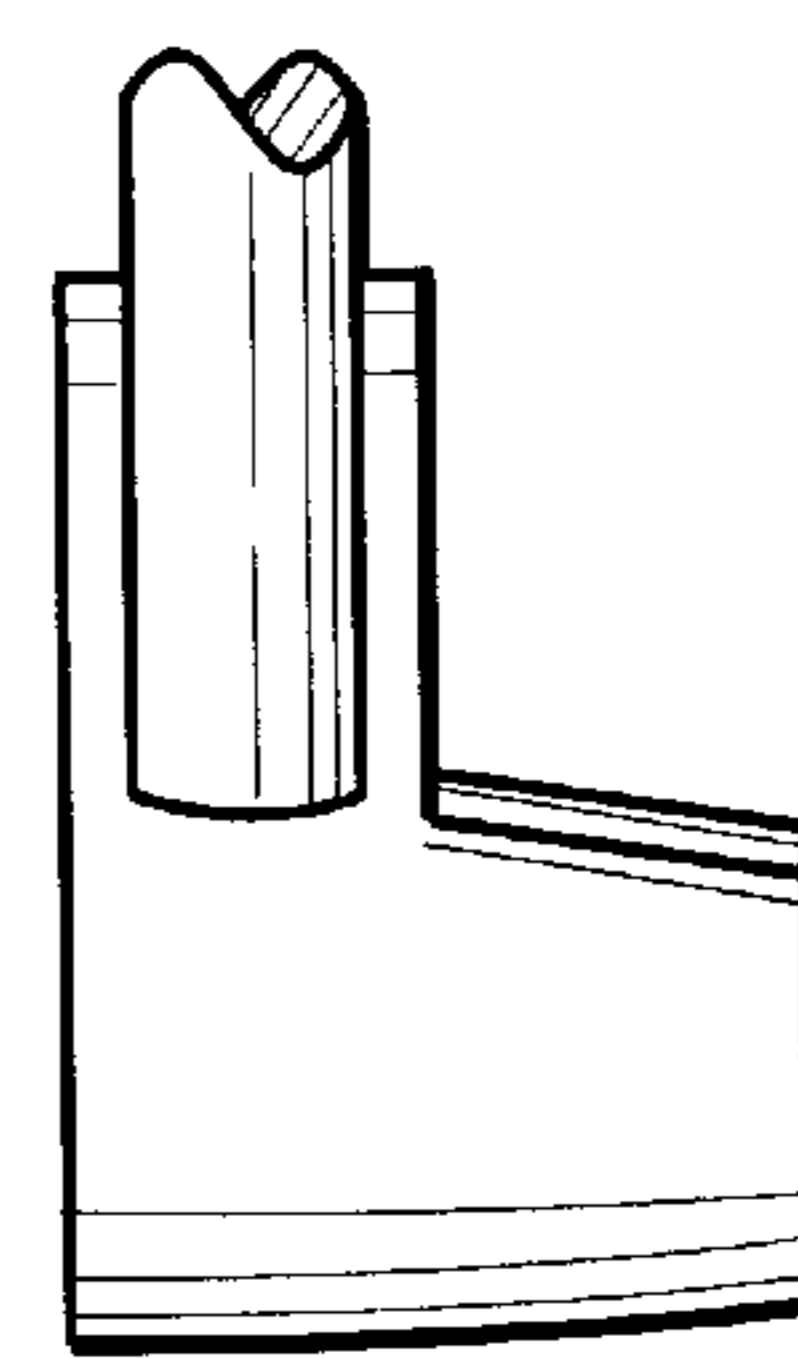
