(57) **CLAIM**

The ornamental design for a surface configuration of a taillight for a vehicle, as shown and described.

**DESCRIPTION**

This application is related to the following co-pending application, of the inventor: Application Ser. No. 29/170, 335, entitled “Surface Configuration of a Vehicle, Toy and/or Other Replicas”.

FIG. 1 is a front view of a first embodiment of a surface configuration of a taillight for a vehicle according to my novel design;

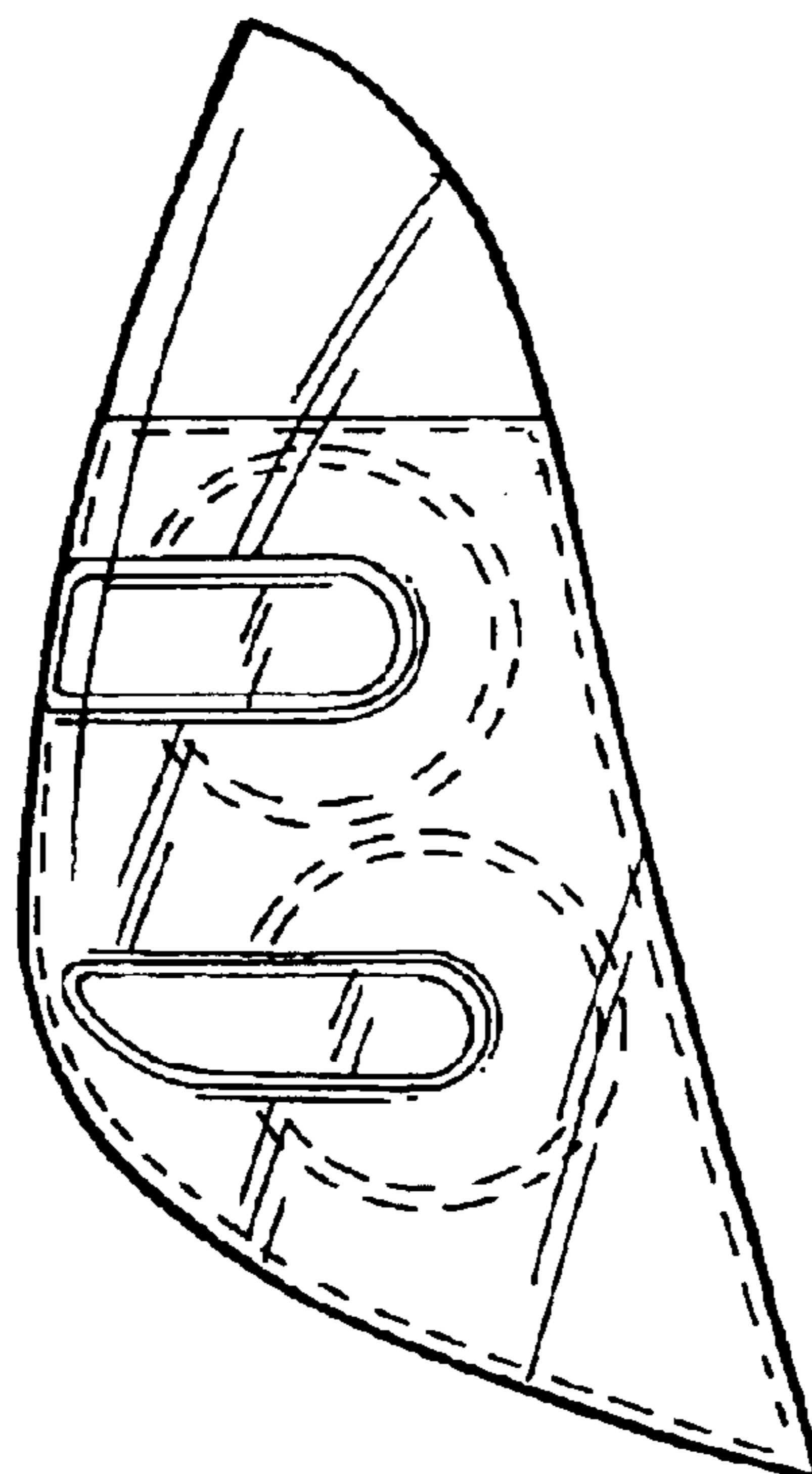
FIG. 2 is a perspective view of the first embodiment of the surface configuration of a taillight for a vehicle according to my novel design;

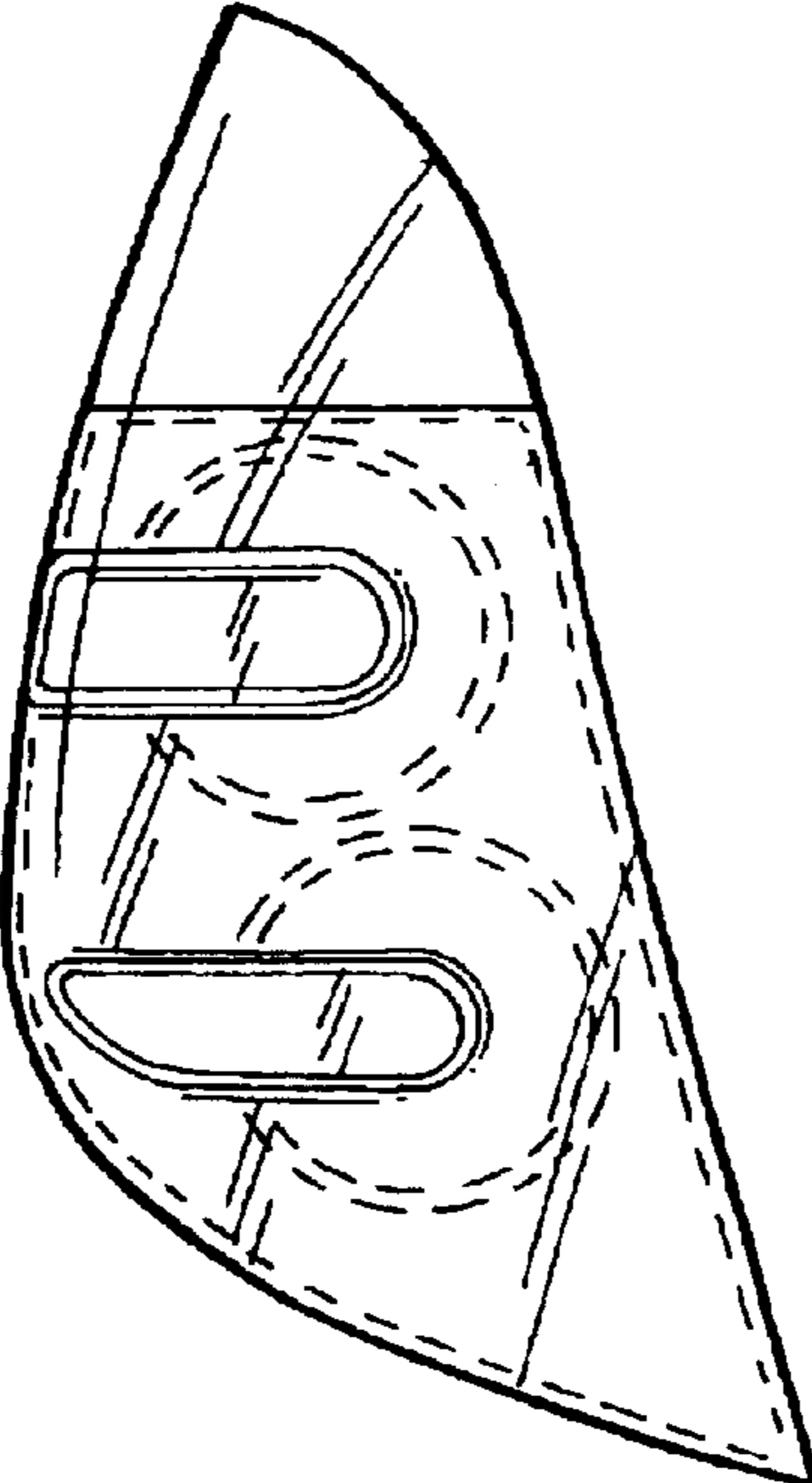

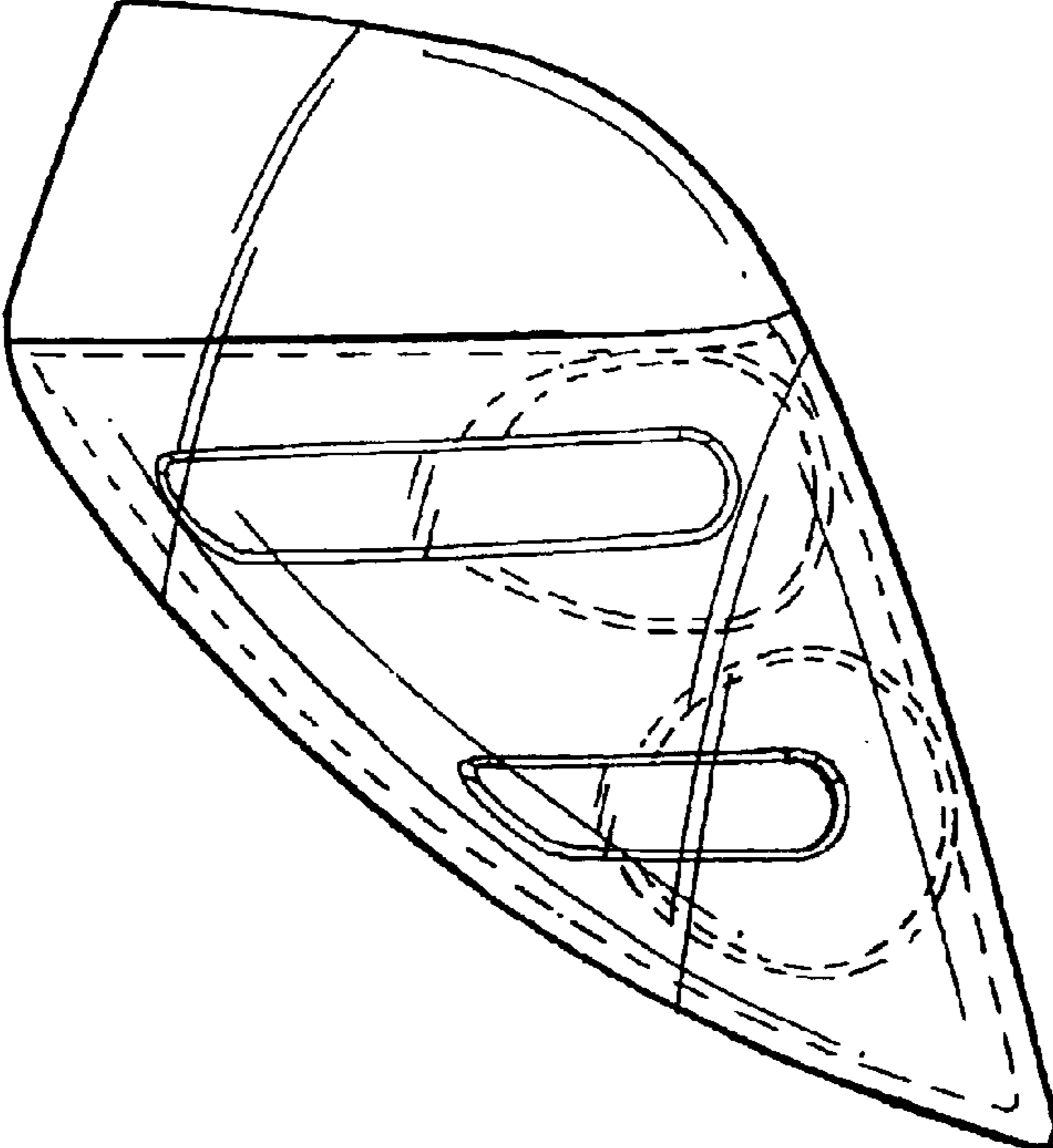

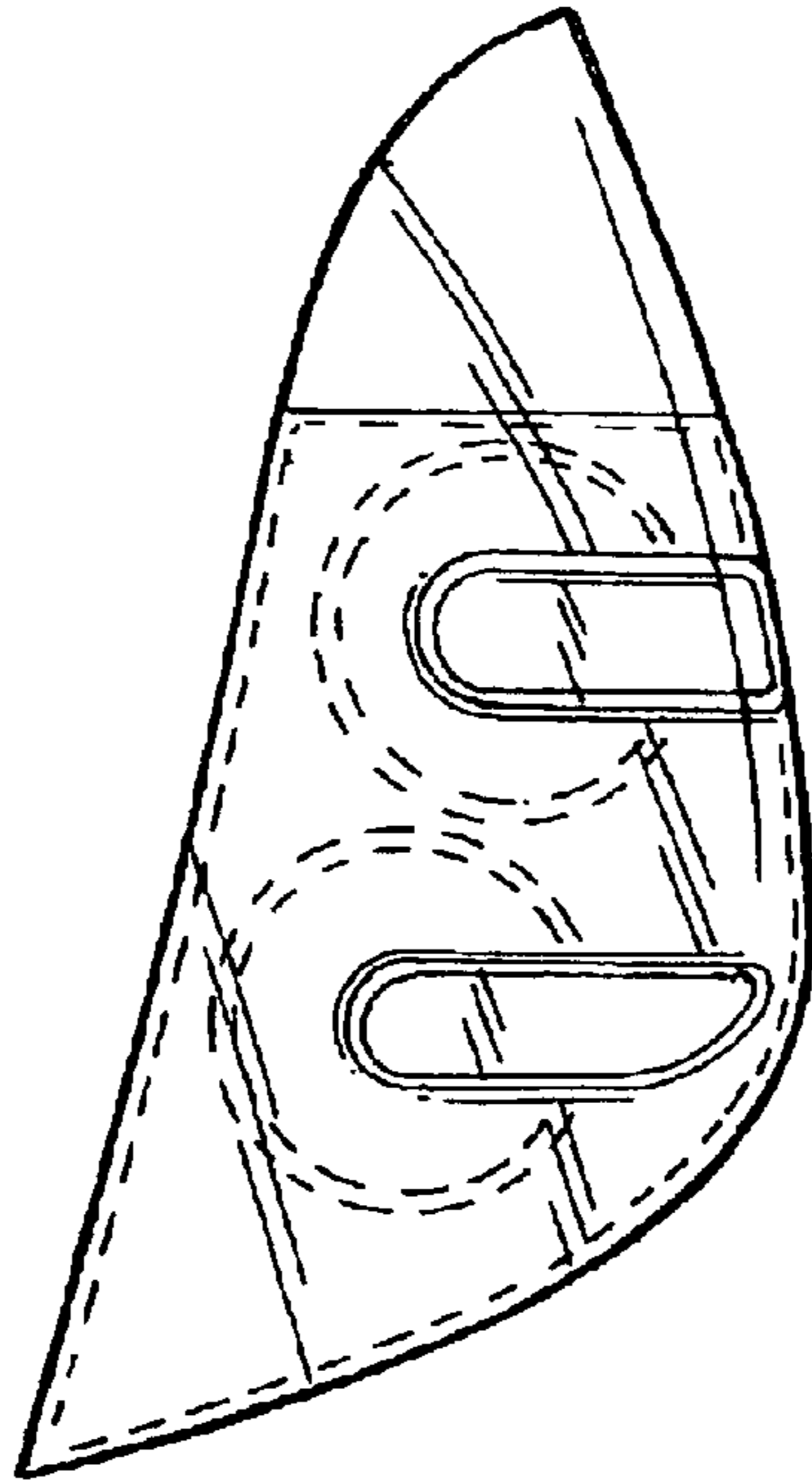

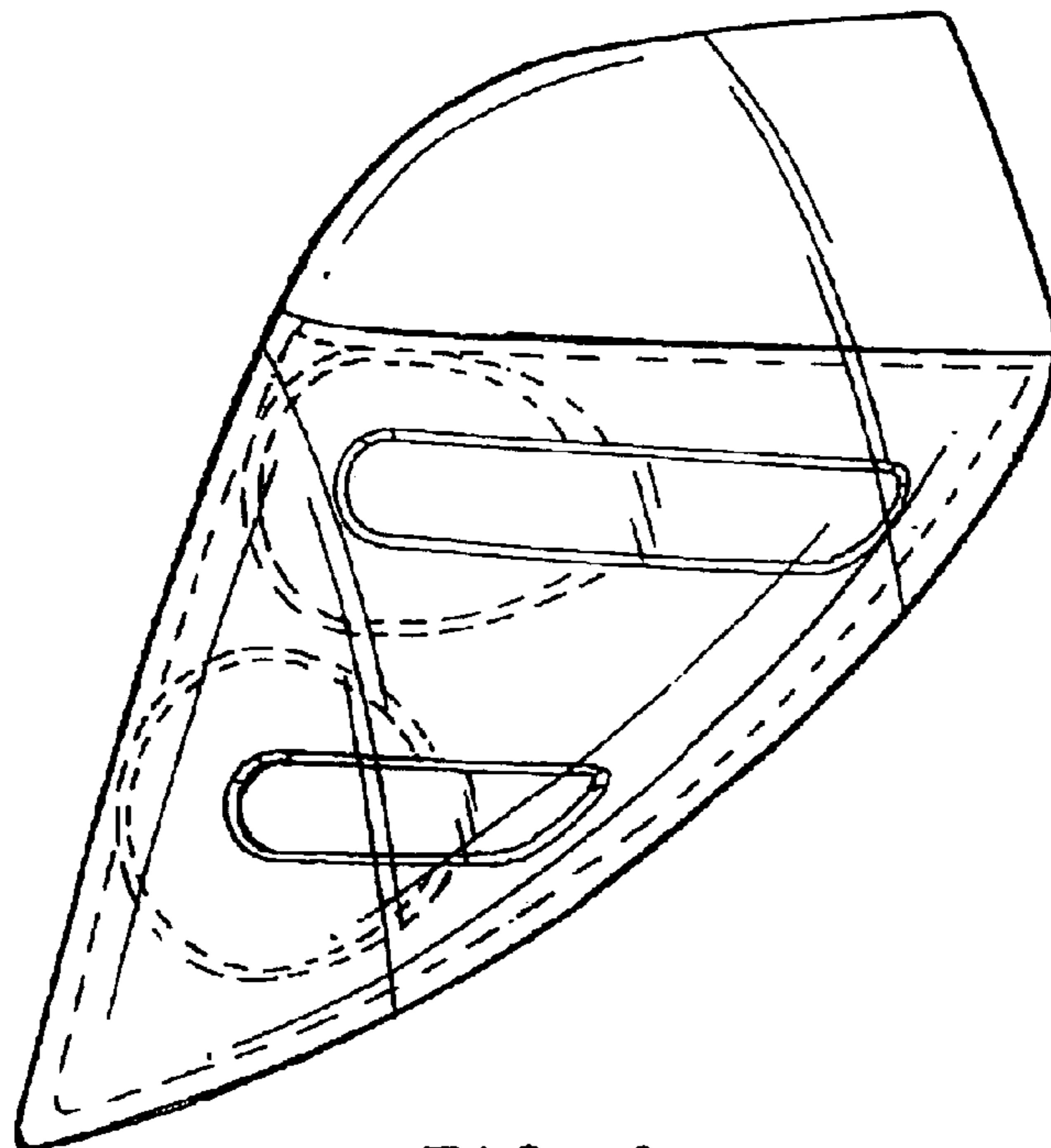
