 FIG. 6 is a bottom perspective view of the baseball glove of FIG. 1.

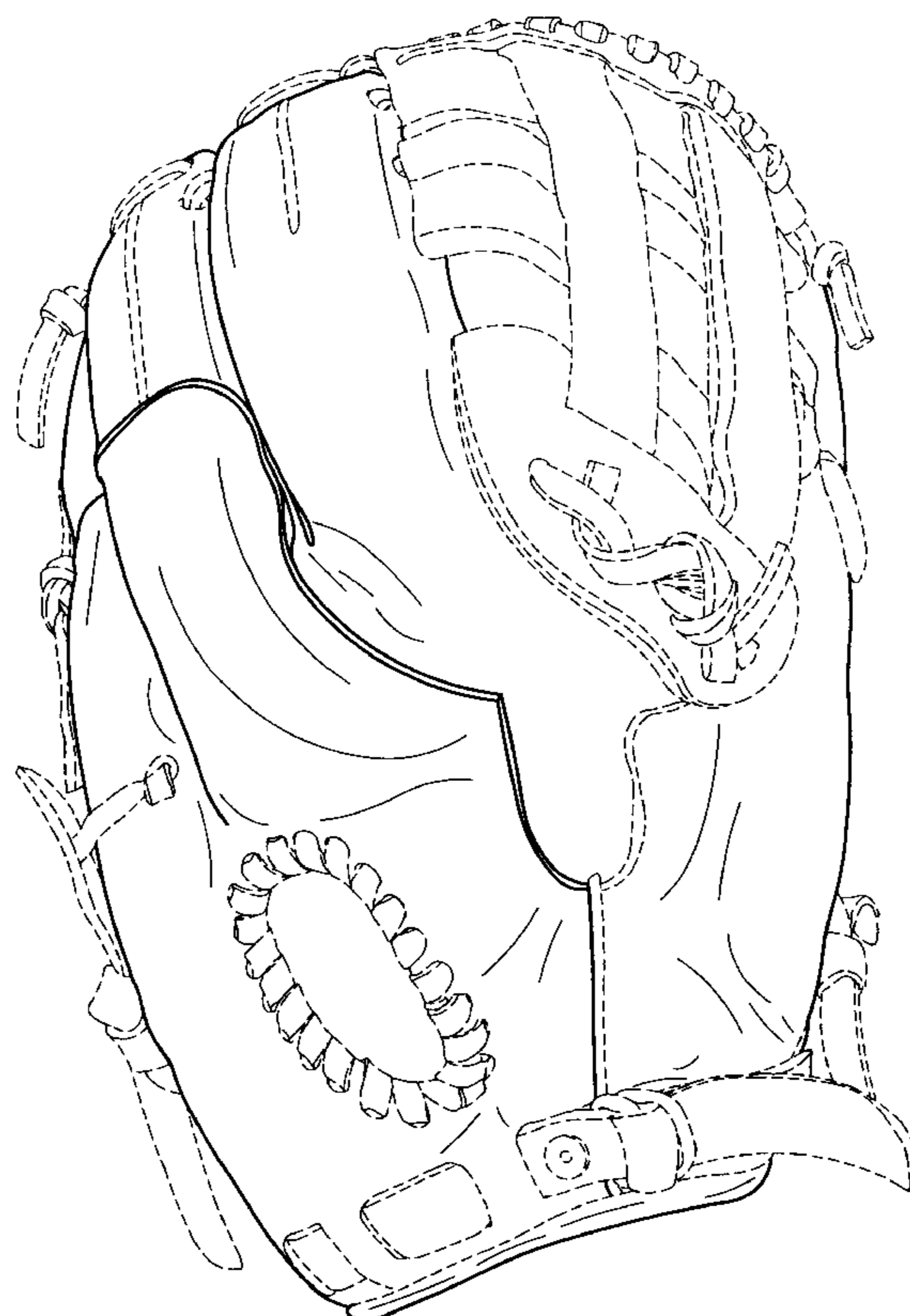

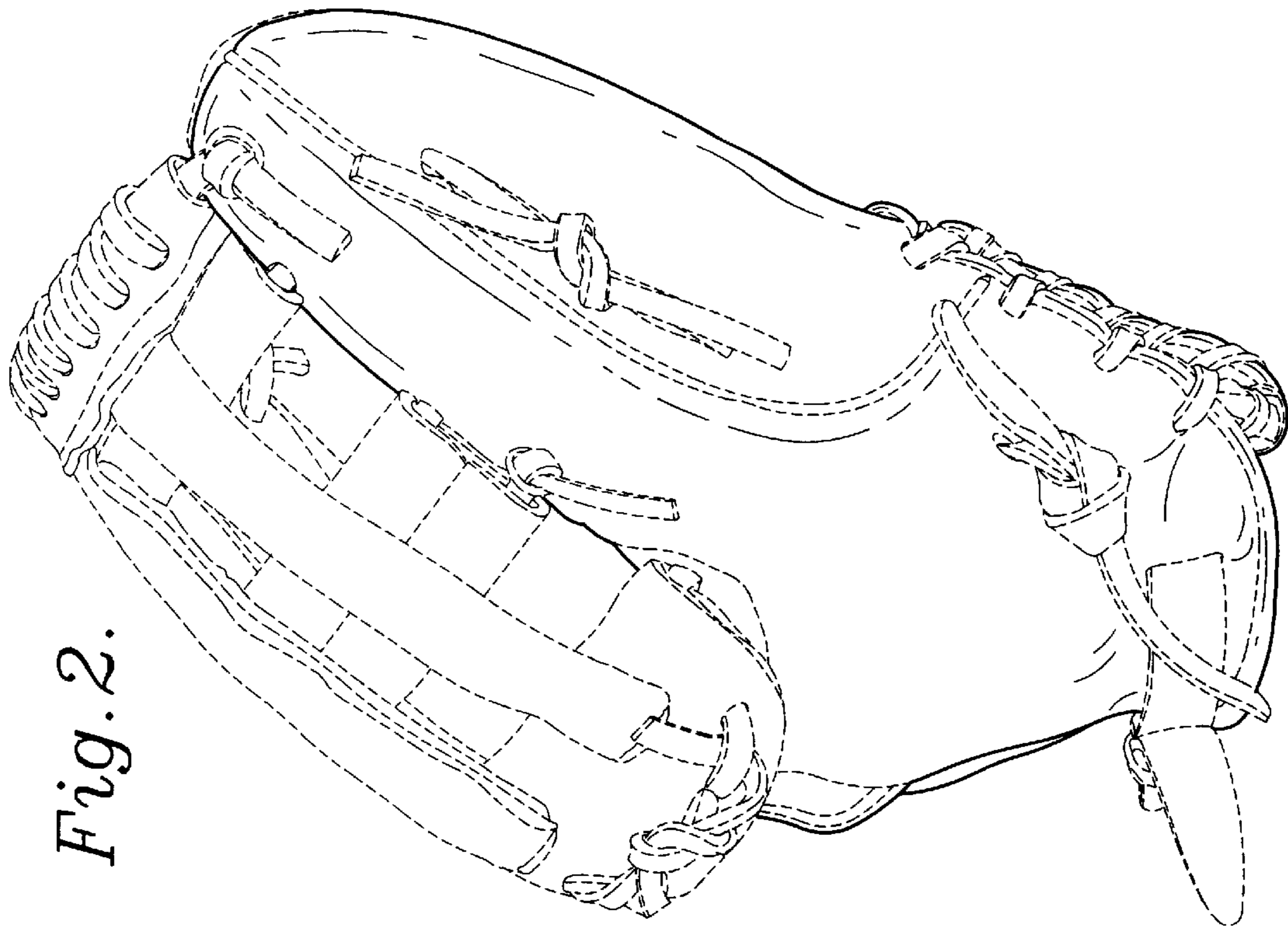

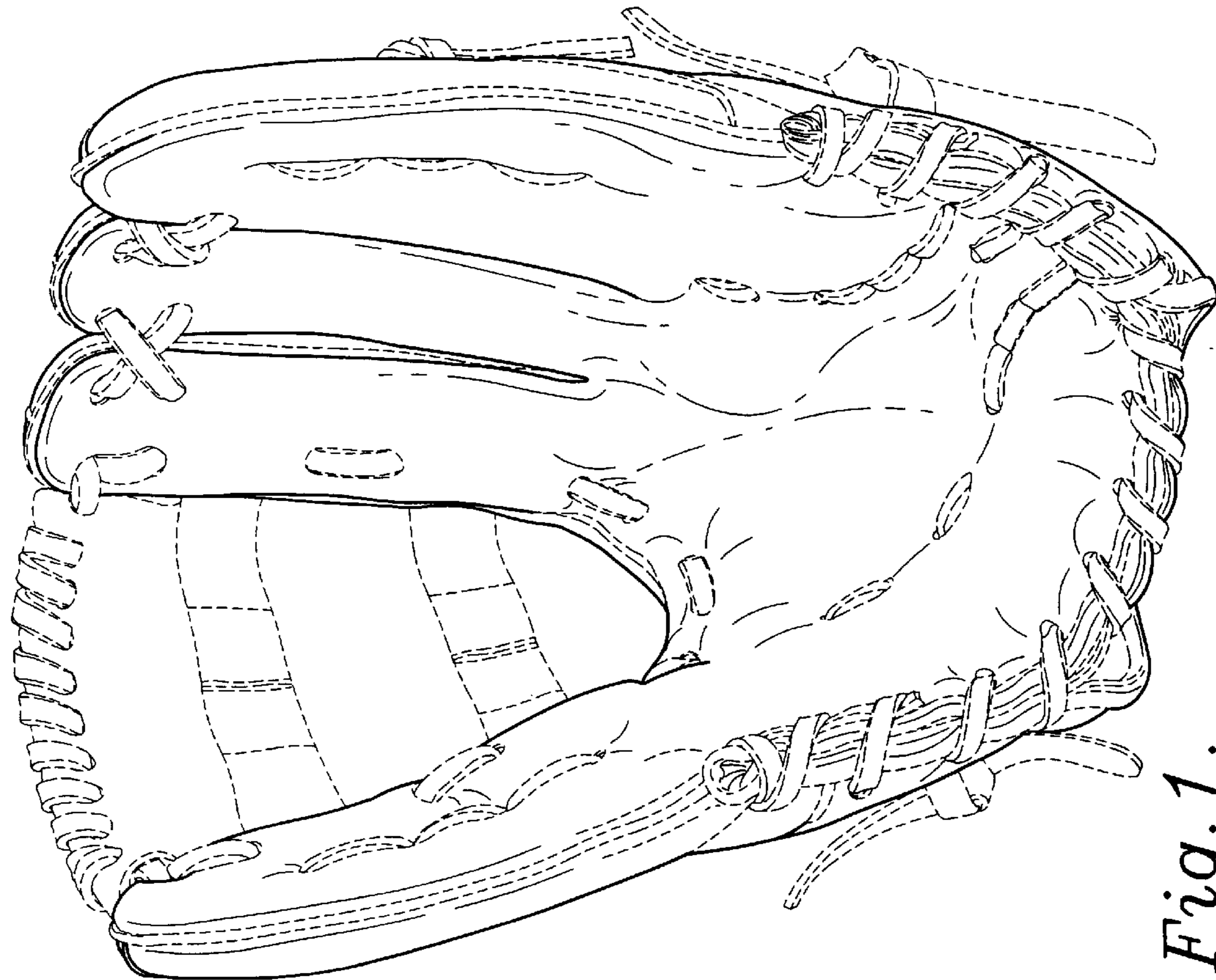

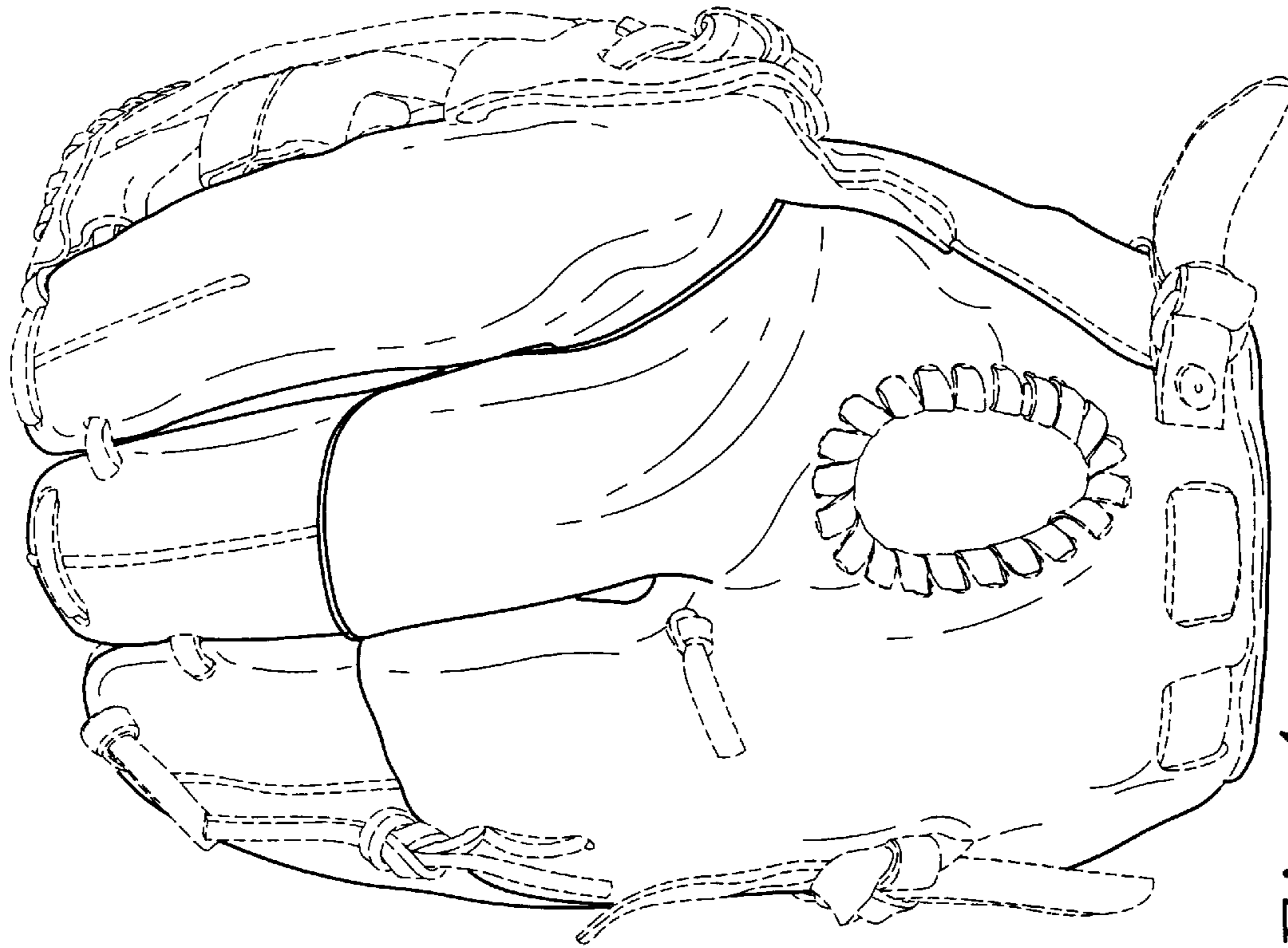

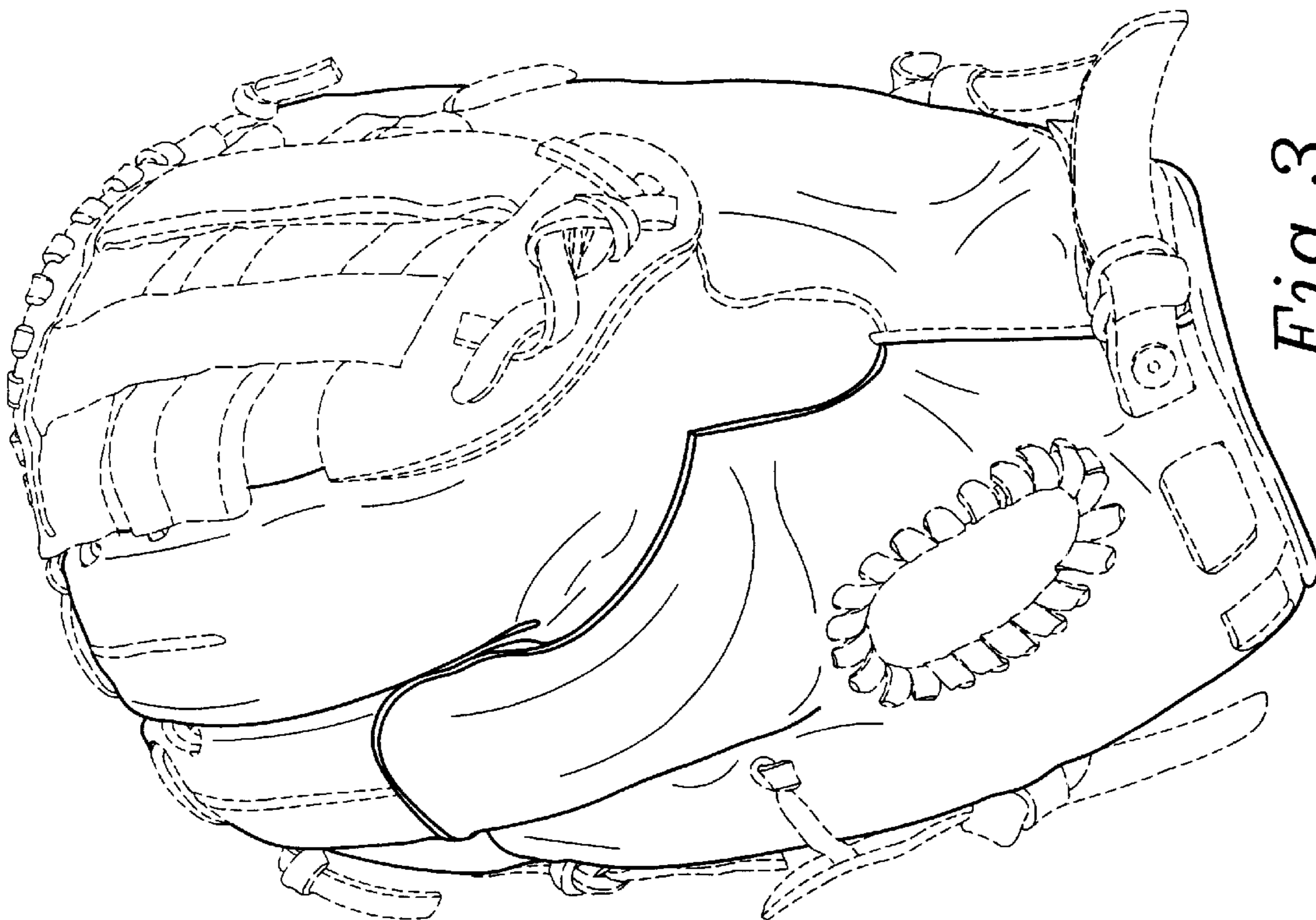

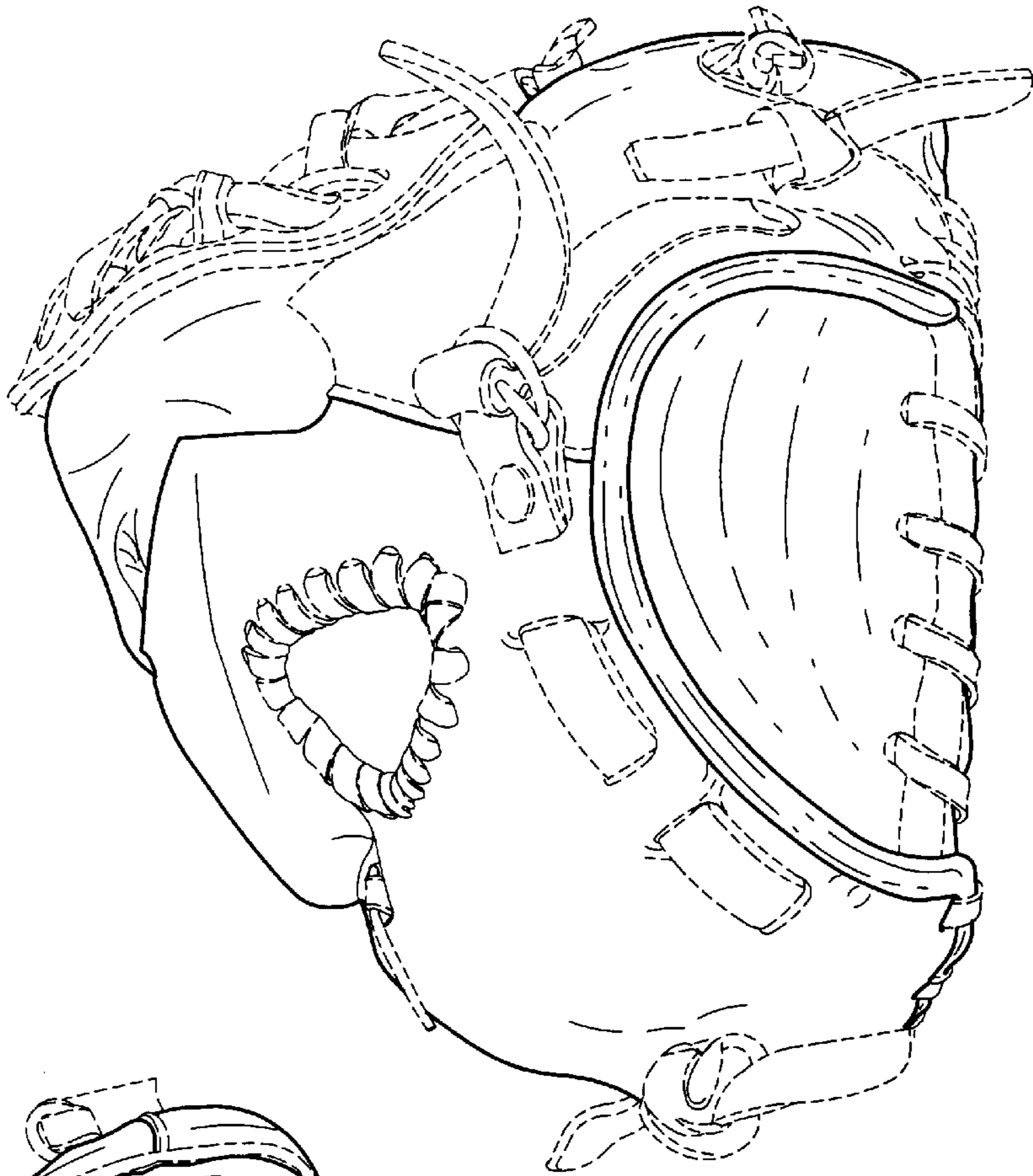
