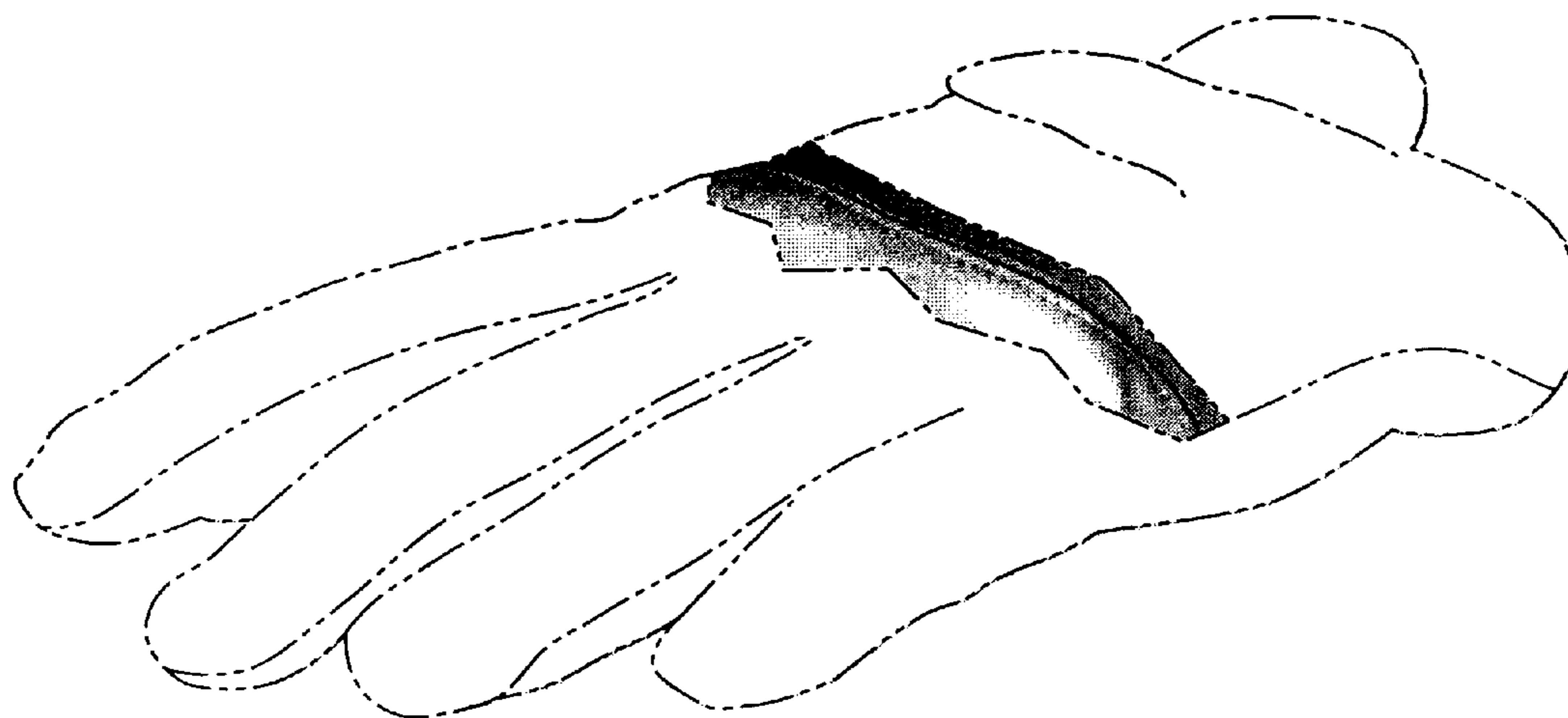
(57) **CLAIM**

The ornamental design for a golf glove, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a portion of the golf glove of our new design;
FIG. 2 is a top elevated view thereof;
FIG. 3 is a side elevated view thereof;
FIG. 4 is an opposite side elevated view thereof;
FIG. 5 is front elevated view thereof; and,
FIG. 6 is a front elevated view thereof in a fist position.
The broken lines of FIGS. 1-6 showing the glove body and finger casings are for illustrative purposes only and form no part of the claimed design. Any showing of color contrast in FIGS. 1-6 is for illustrative purposes only and forms no part of the claimed design.

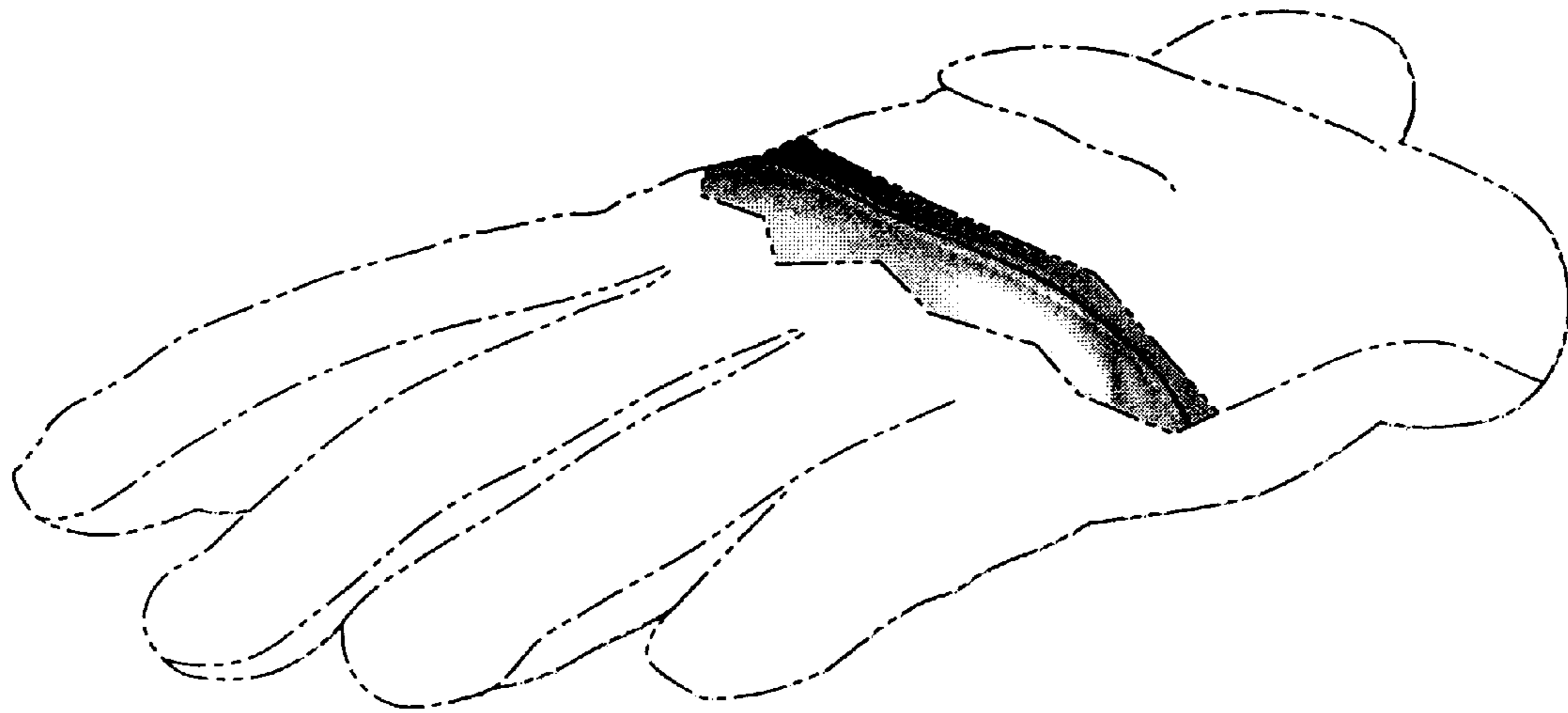

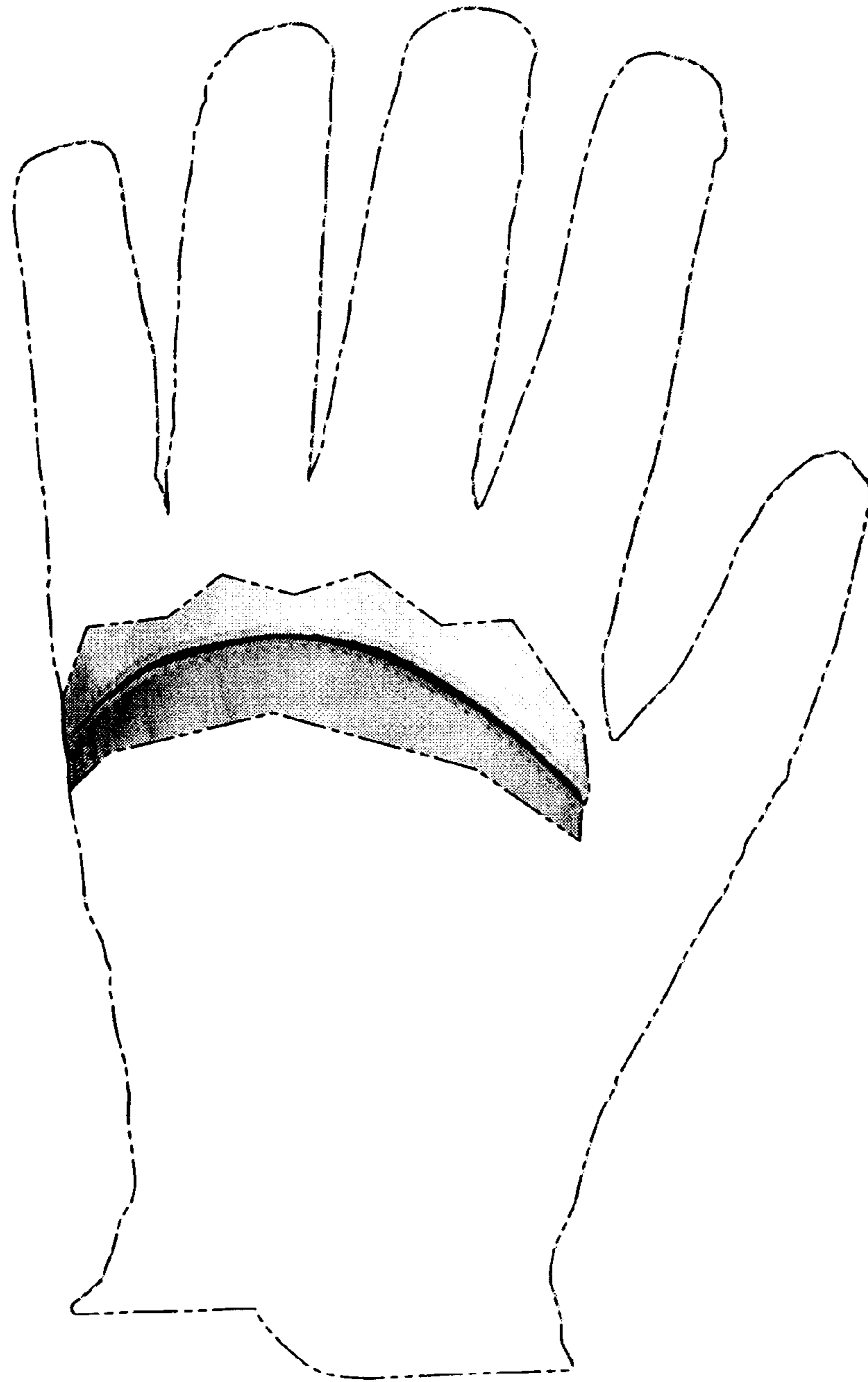

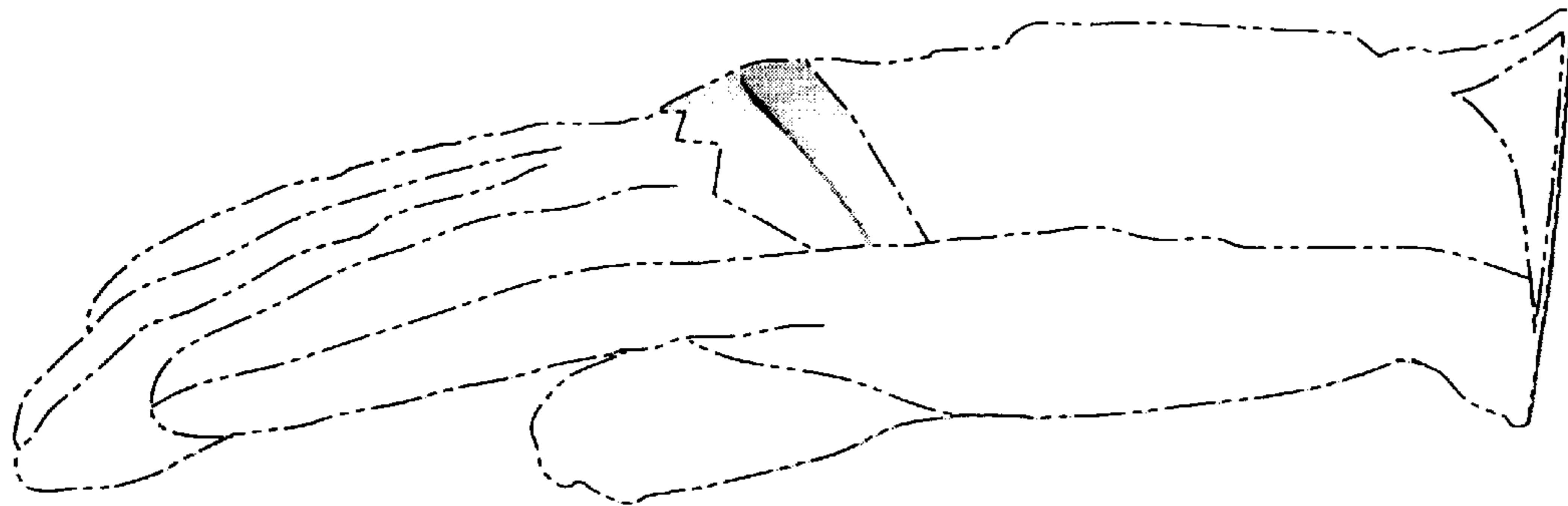

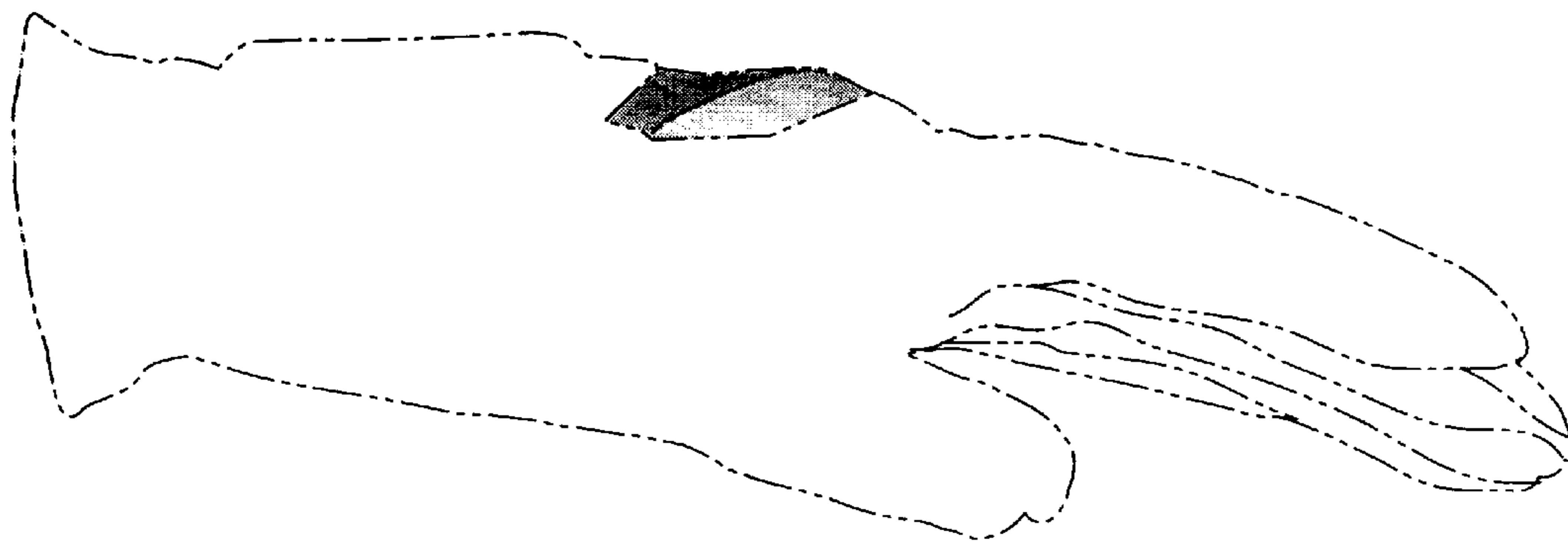

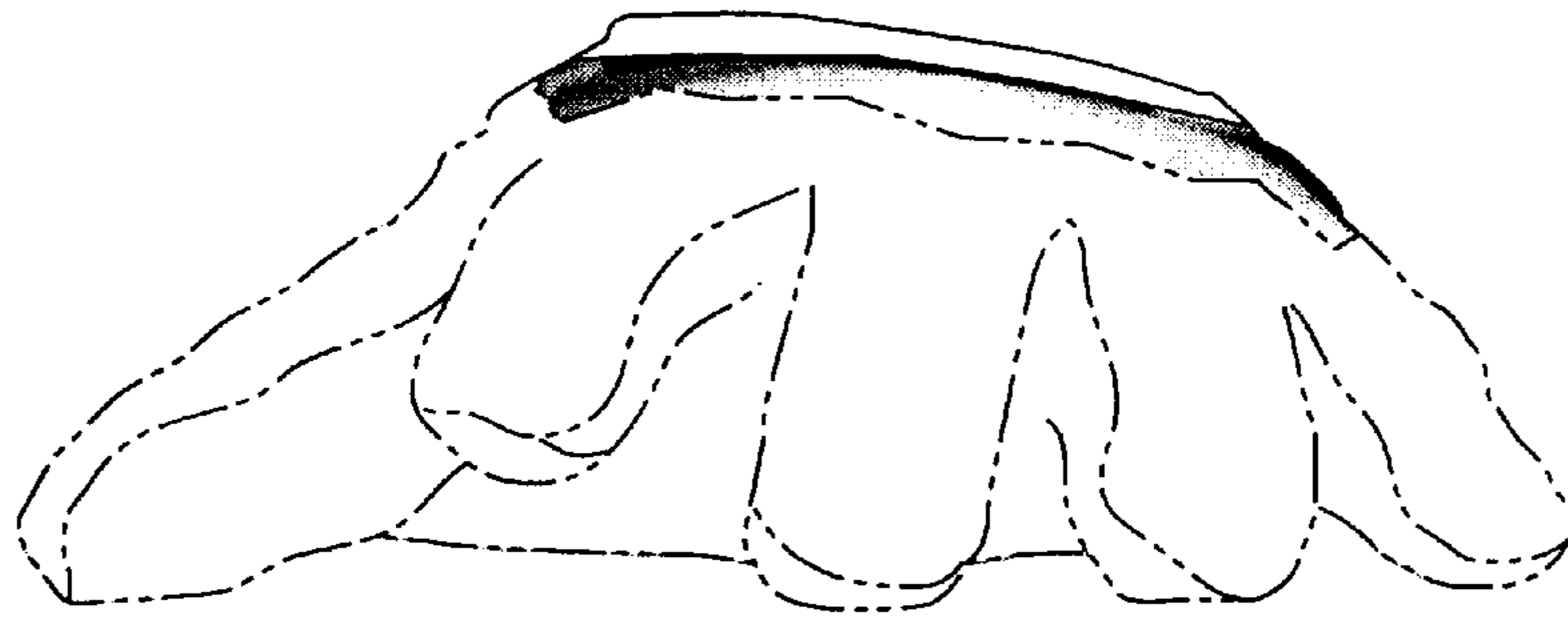

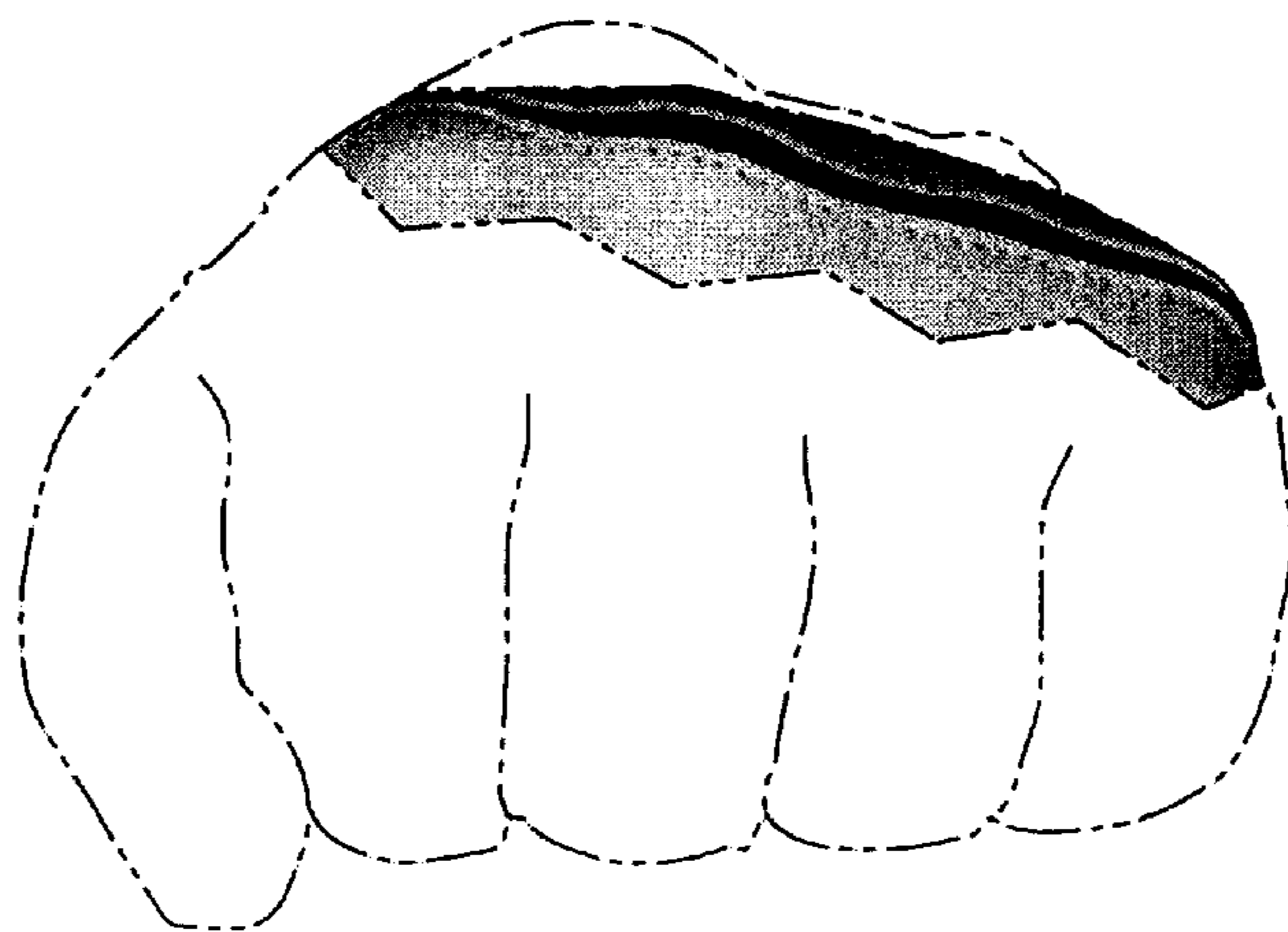
