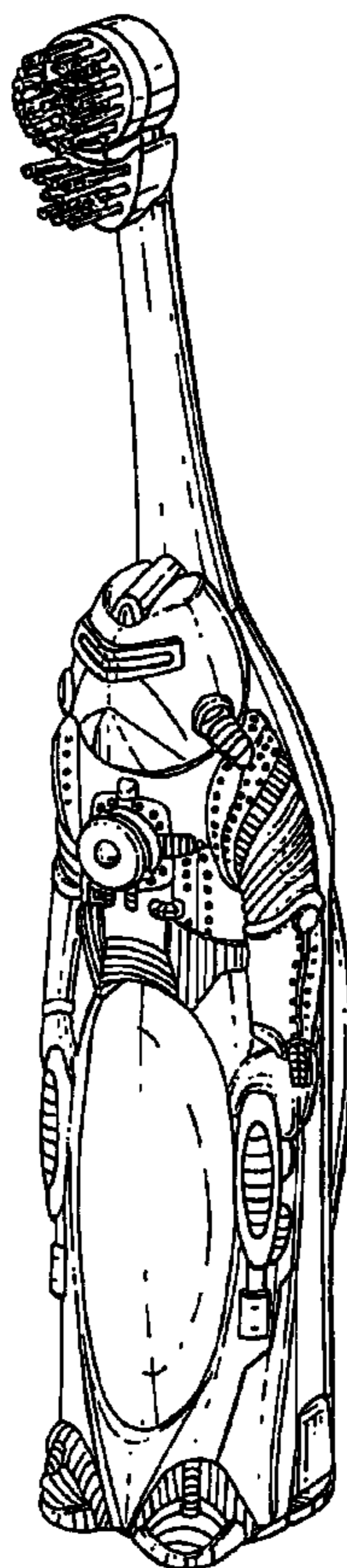
(57) **CLAIM**

ment, as shown and described.

FIG. 1 is a front perspective view from above and one side;

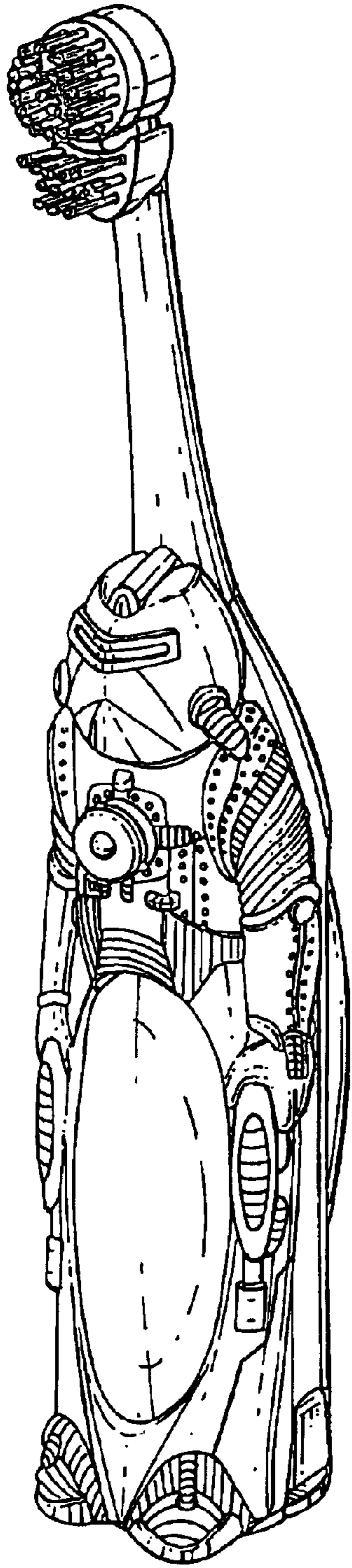

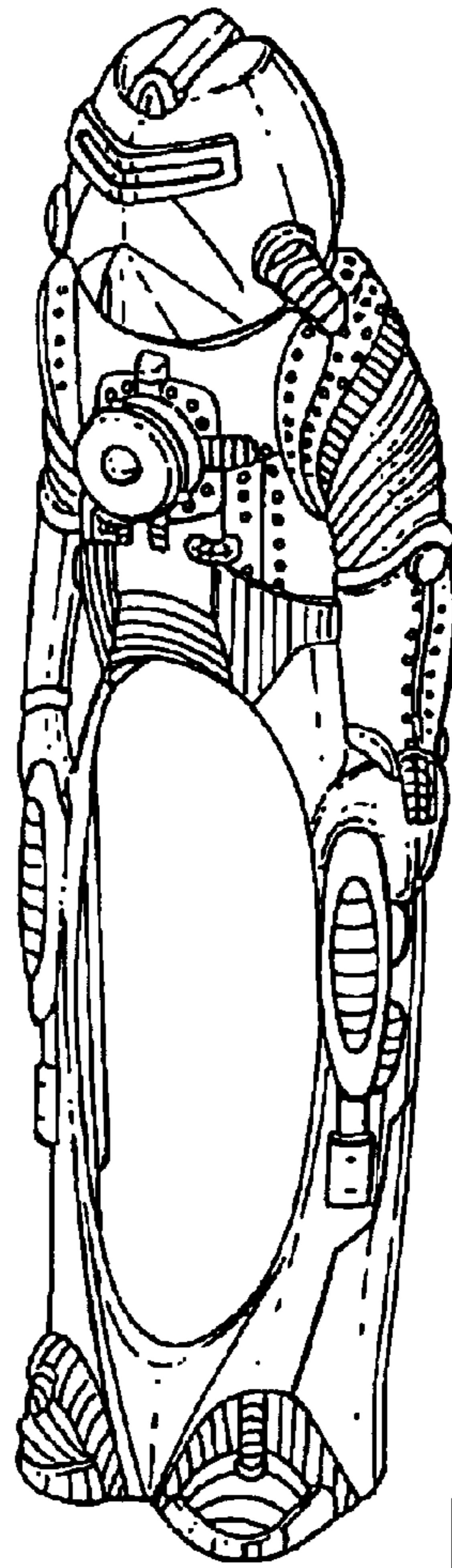
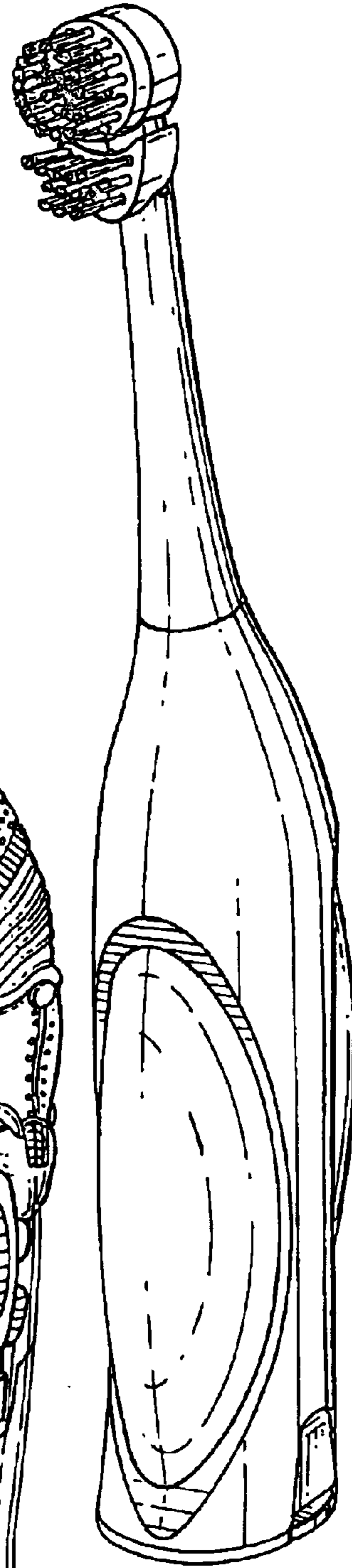

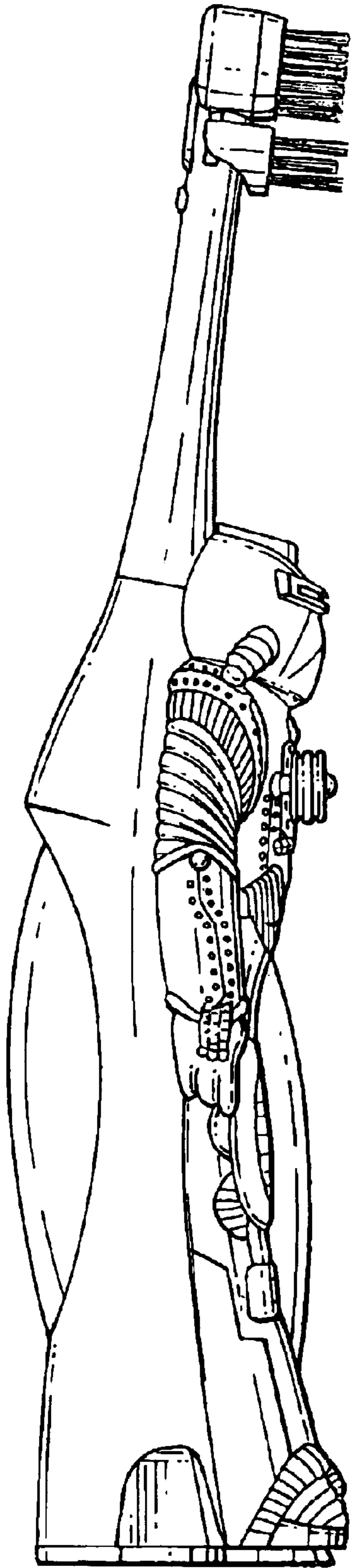

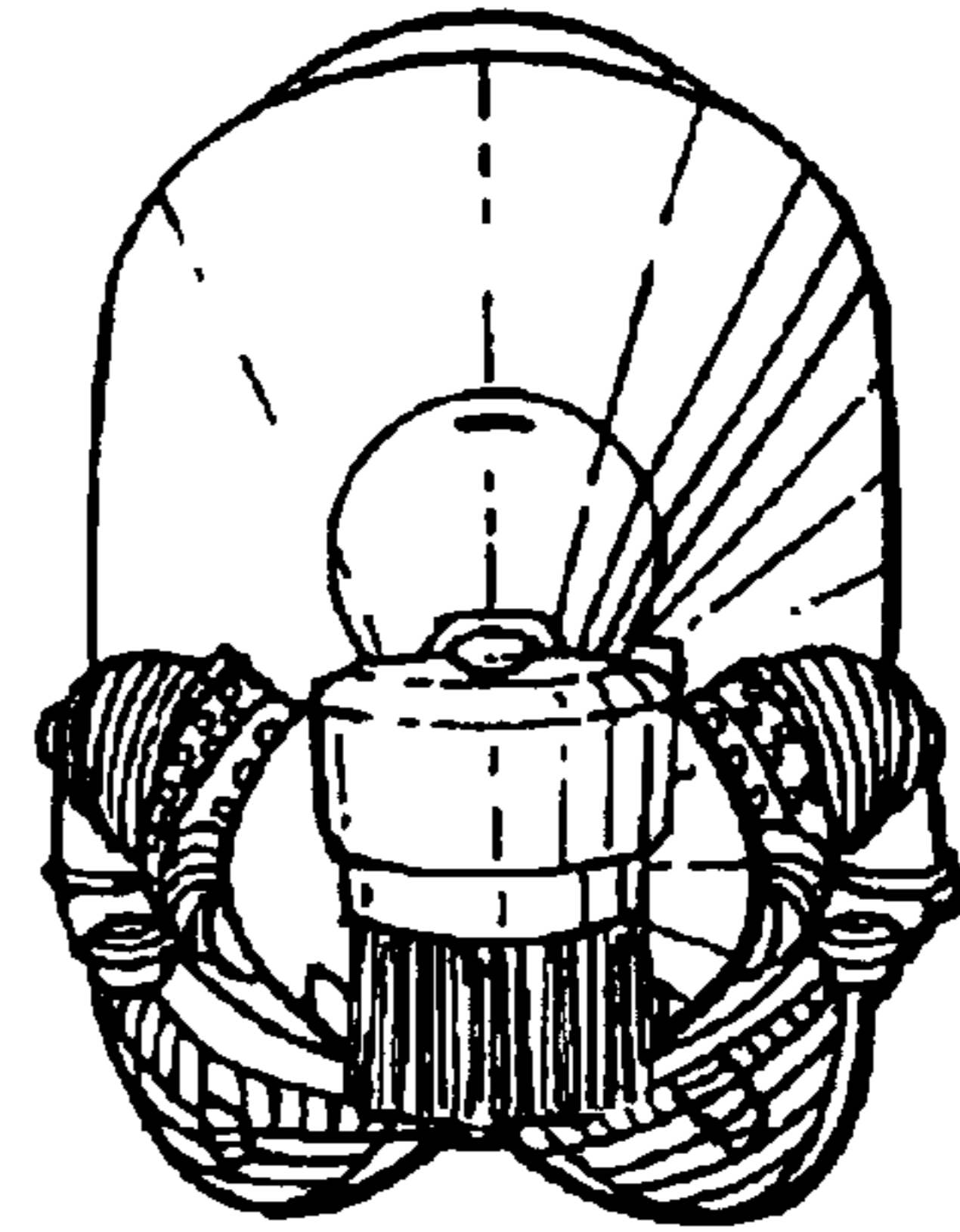

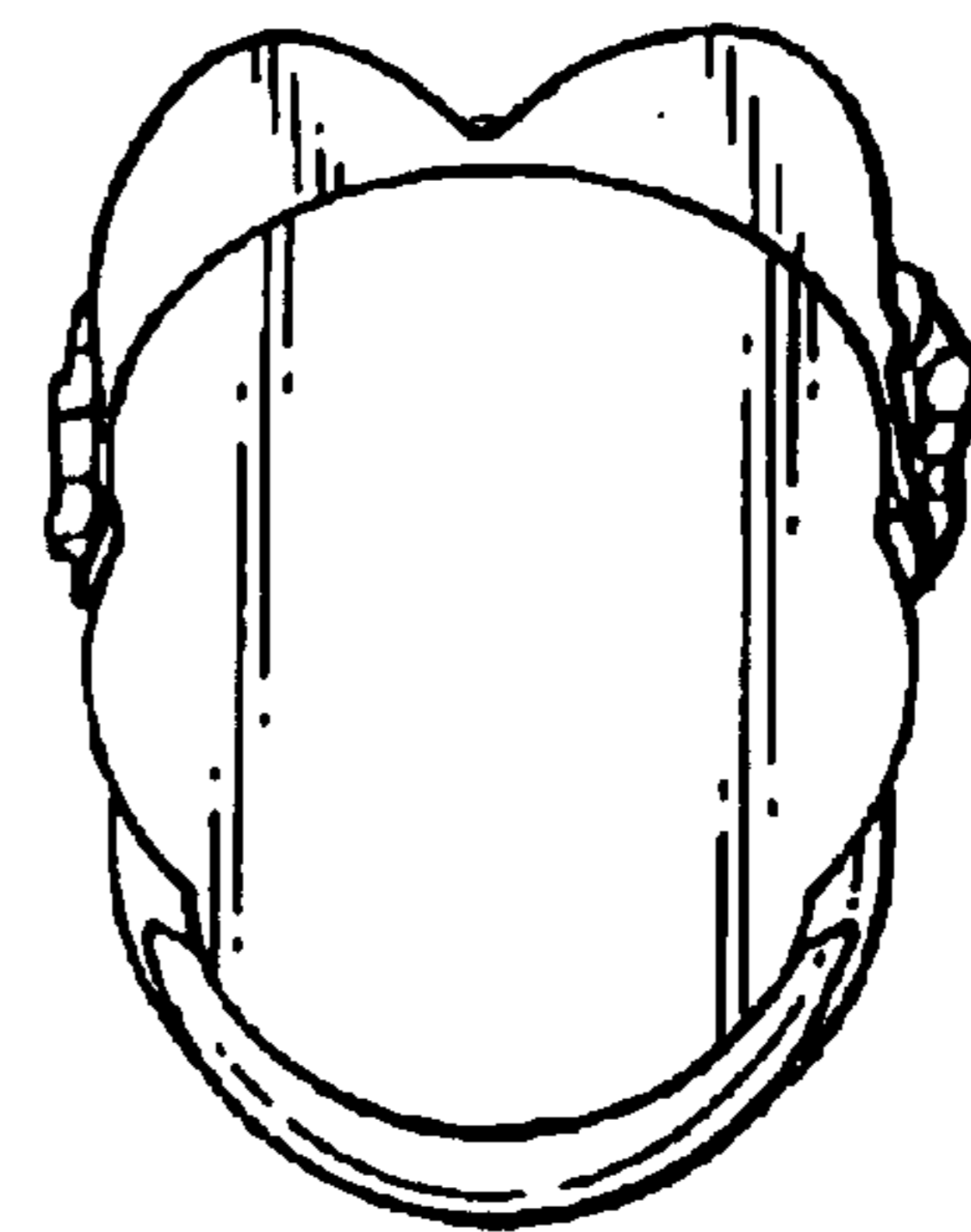

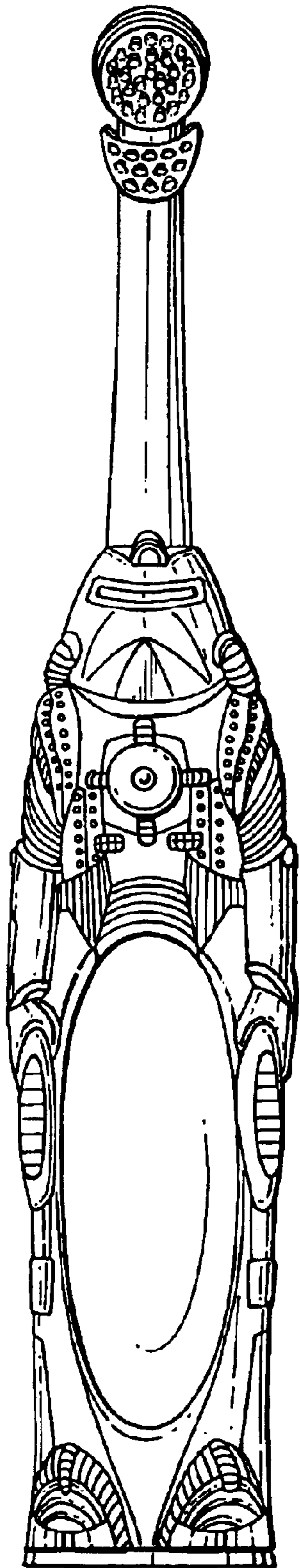

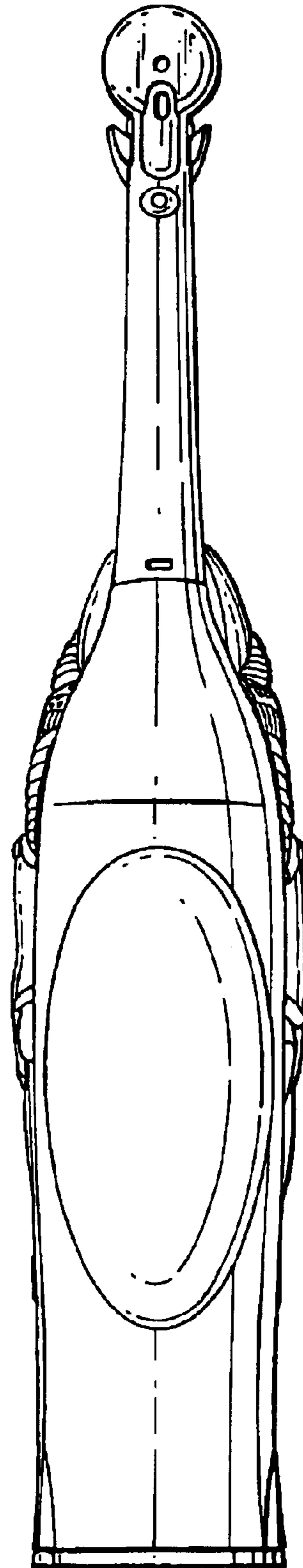
