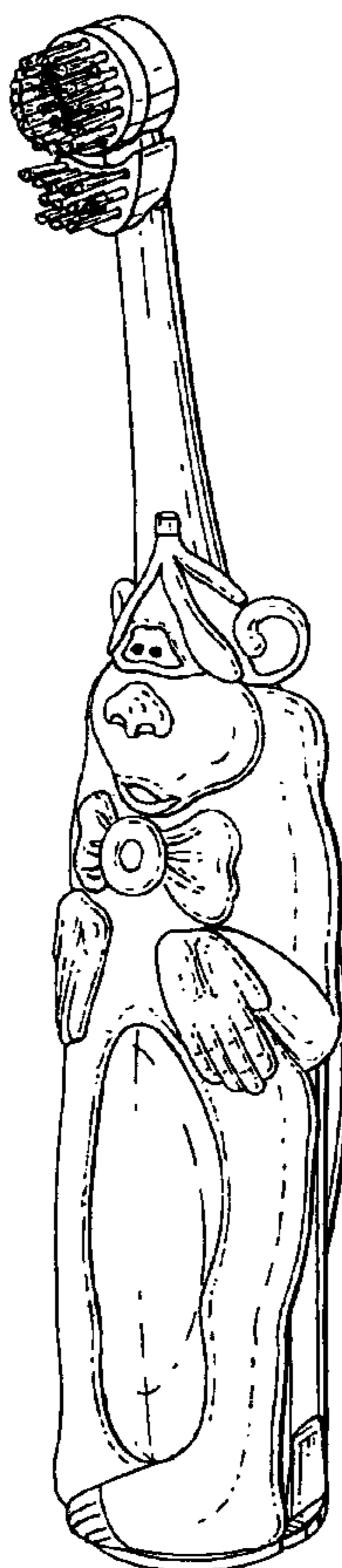
(57) **CLAIM**

The ornamental design for a toothbrush with clip attachment, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view from above and one side; FIG. 2 is an exploded perspective view showing the clip separated from the toothbrush; FIG. 3 is a view of the other side; FIG. 4 is a plan view; FIG. 5 is an underneath plan view; FIG. 6 is a front view; and, FIG. 7 is a rear view.

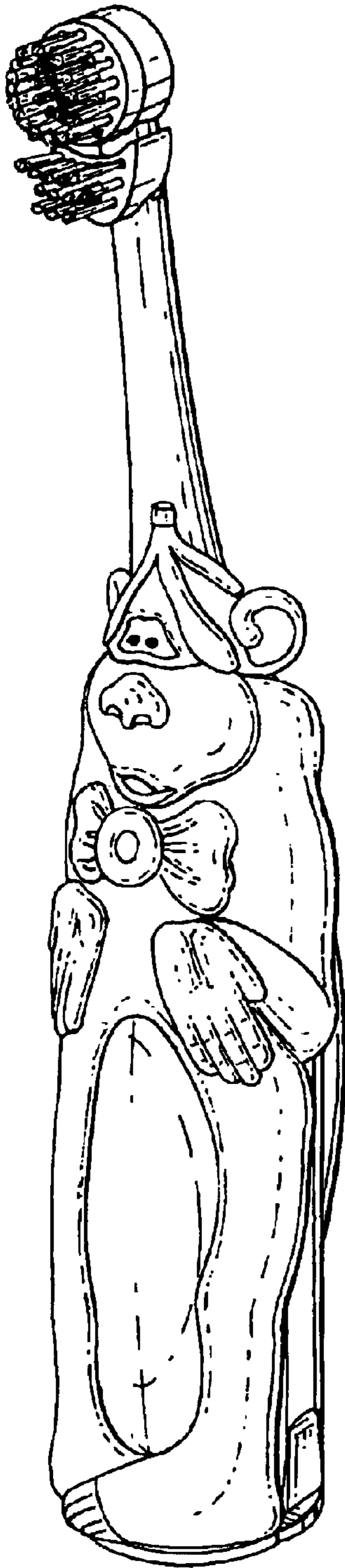

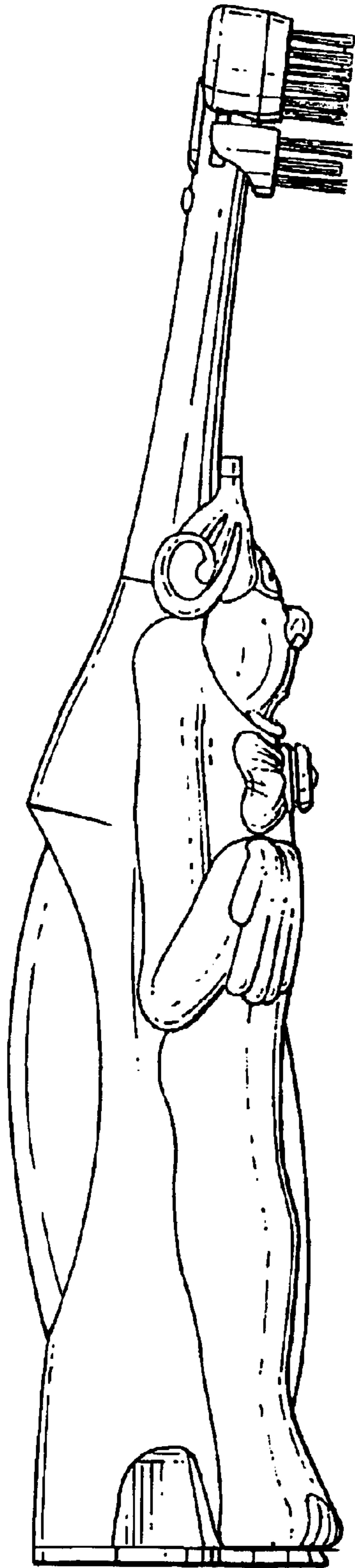

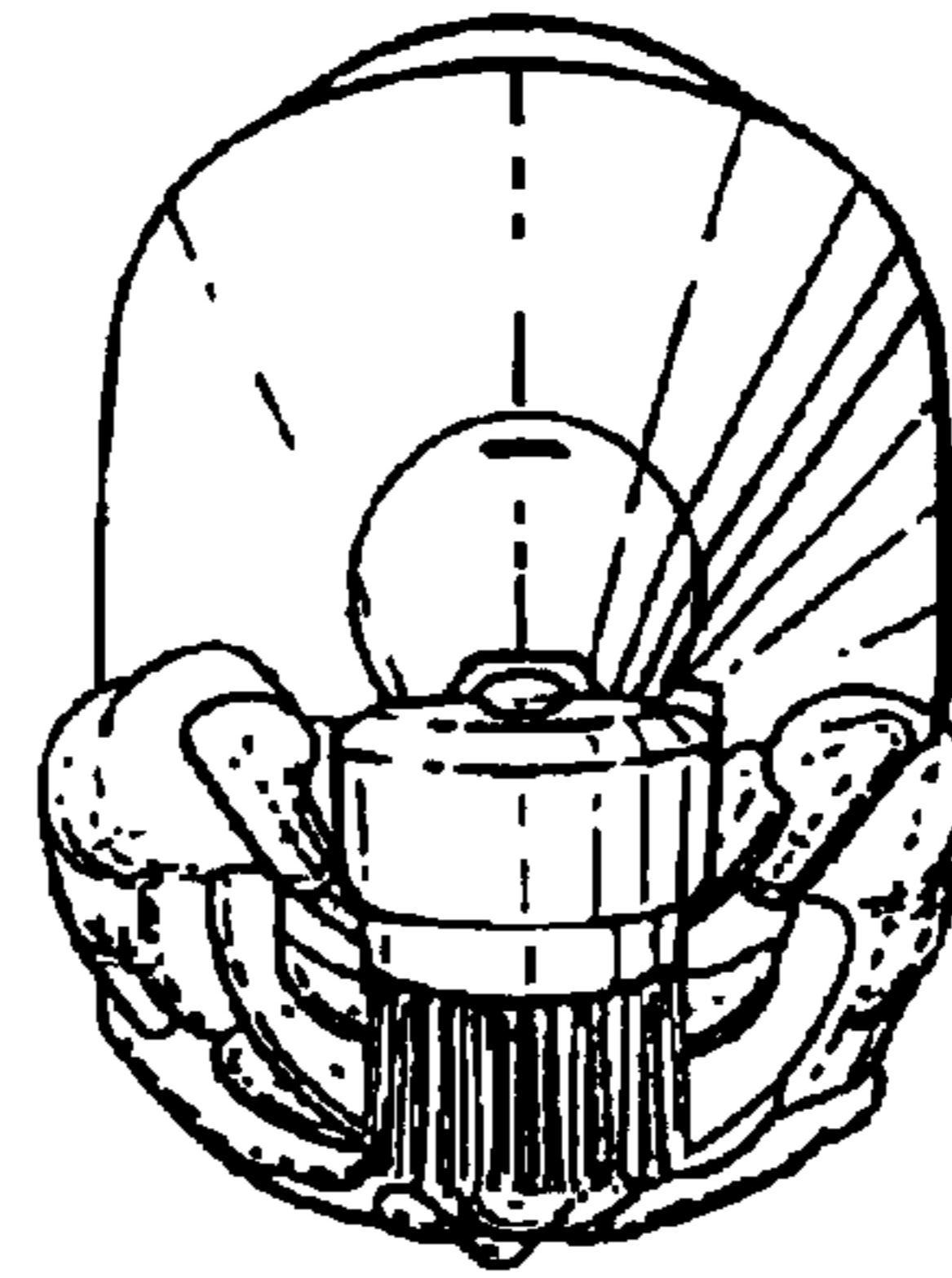

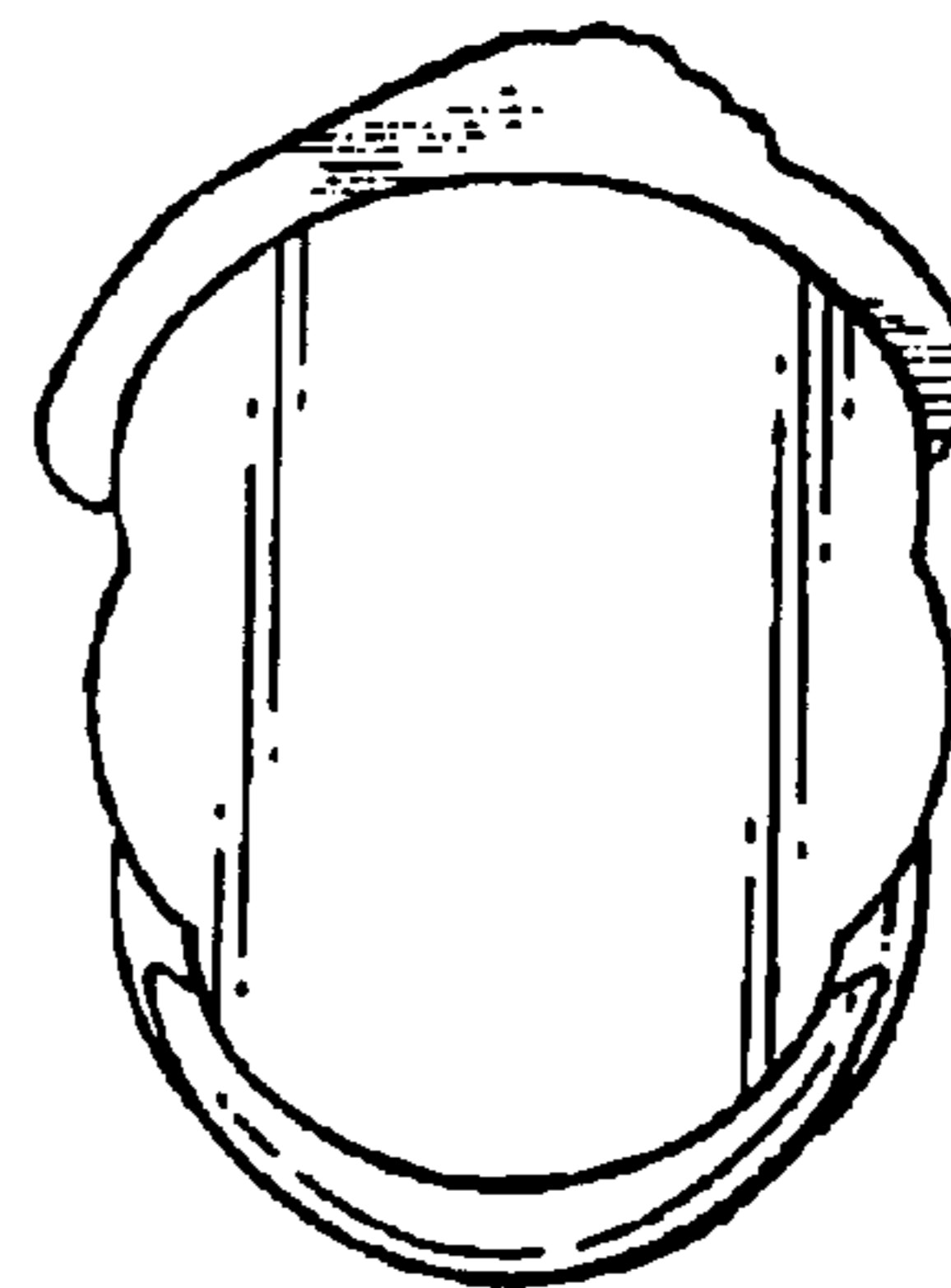

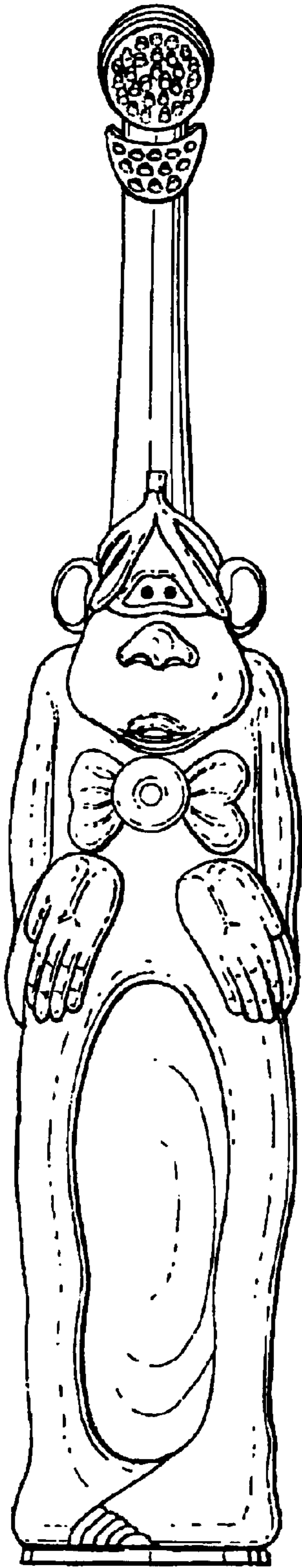

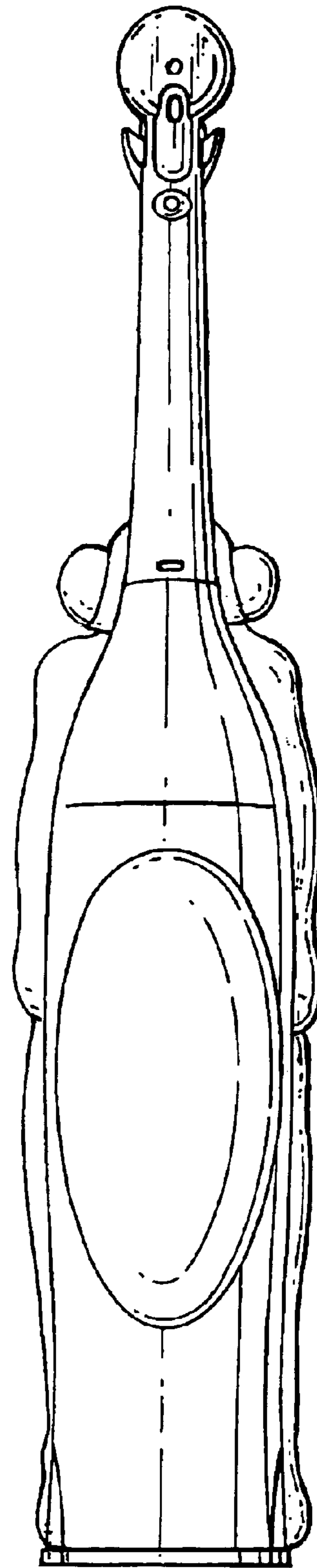
