The ornamental design for a paint brush handle, as shown and described.

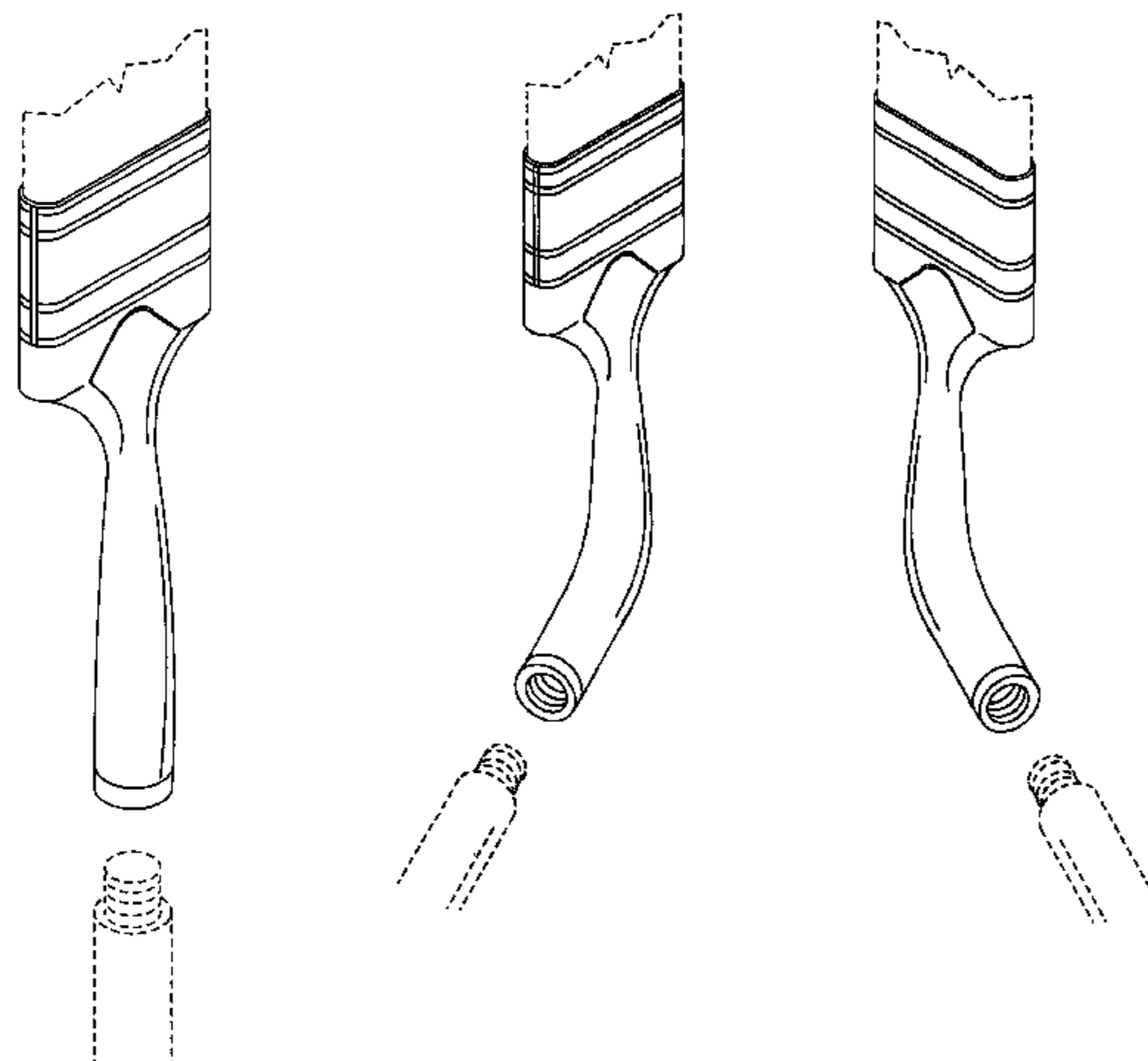
DESCRIPTION

FIG. 1 is a perspective view of the invented paint brush handle, and showing my new design with an internally threaded opening for selectively receiving a threaded extension handle, the extension handle being shown in dotted lines;

FIG. 2 is a top view thereof;
 FIG. 3 is a right side view thereof;
 FIG. 4 is a front view thereof;
 FIG. 5 is a left side view thereof;
 FIG. 6 is a rear view thereof;
 FIG. 7 is a bottom view thereof;
 FIG. 8 is a perspective view of a first alternative embodiment of the invented paint brush handle, having the paint brush handle curved leftward;
 FIG. 9 is a top view of the first alternative embodiment thereof;
 FIG. 10 is a left side view of the first alternative embodiment thereof;
 FIG. 11 is a front view of the first alternative embodiment thereof;
 FIG. 12 is a right side view of the first alternative embodiment thereof;
 FIG. 13 is a rear view of the first alternative embodiment thereof;
 FIG. 14 is a bottom view of the first alternative embodiment thereof;
 FIG. 15 is a perspective view of a second alternative embodiment of the paint brush handle, having the paint brush handle curved rightward;
 FIG. 16 is a top view of the second alternative embodiment thereof;
 FIG. 17 is a rear view of the second alternative embodiment thereof;
 FIG. 18 is a left side view of the second alternative embodiment thereof;
 FIG. 19 is a front view of the second alternative embodiment thereof;
 FIG. 20 is a right side view of the second alternative embodiment thereof; and,
 FIG. 21 is a bottom view of the second alternative embodiment thereof.

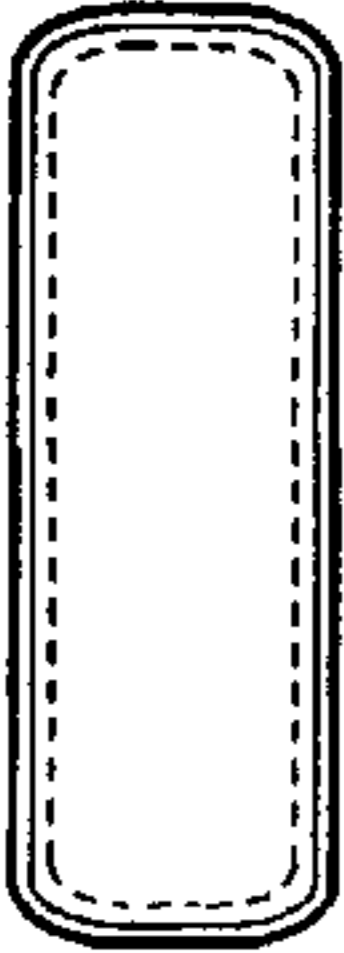

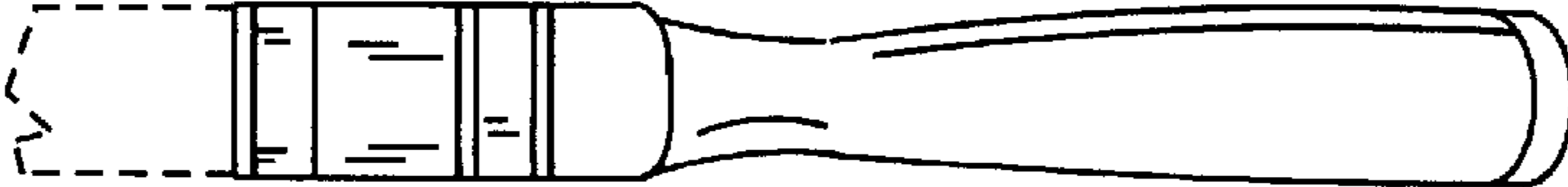

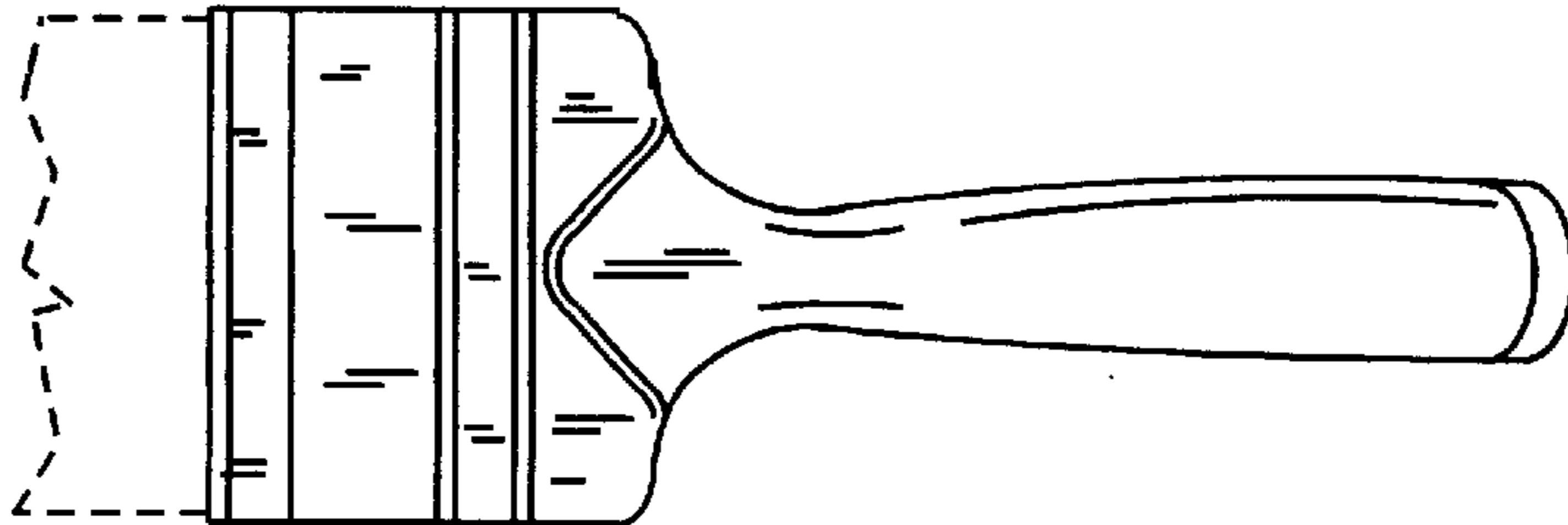

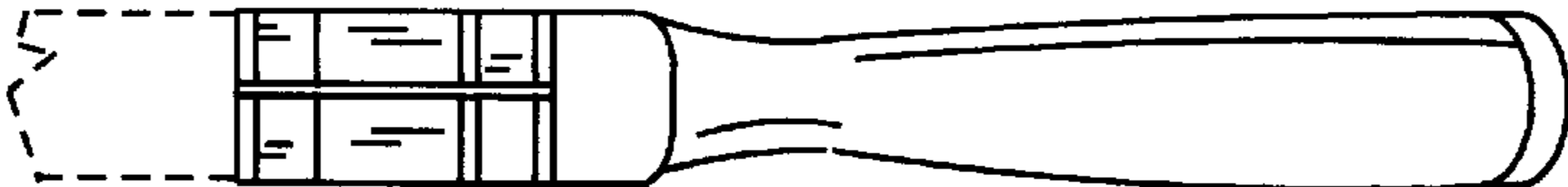

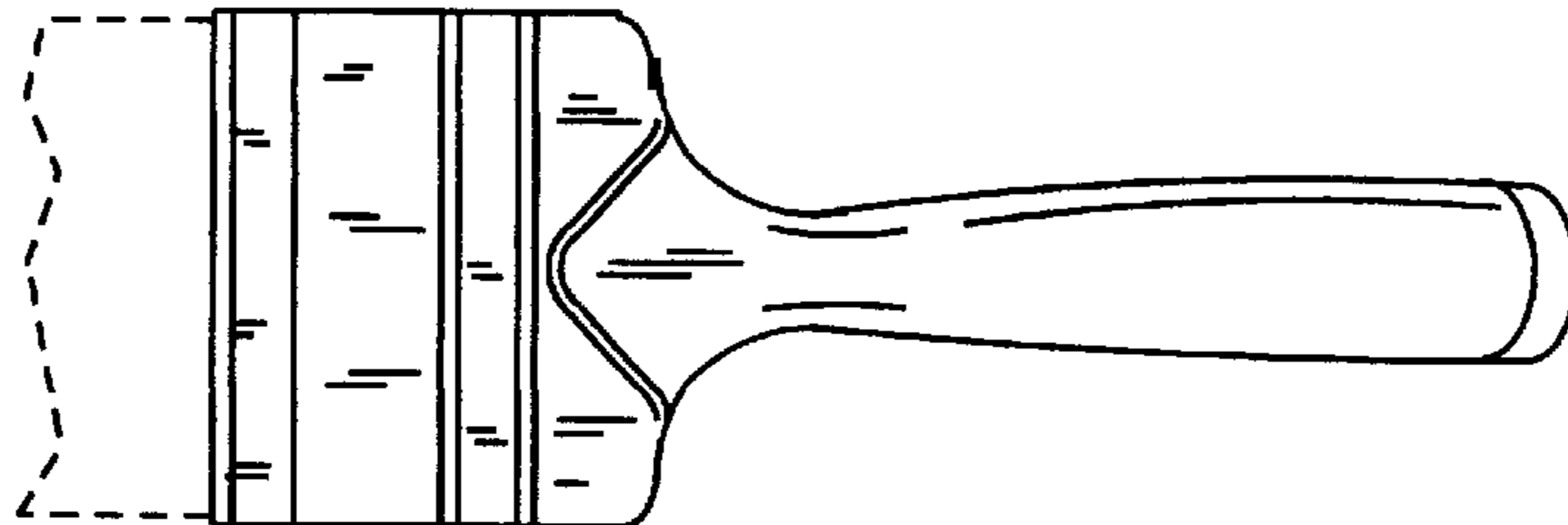
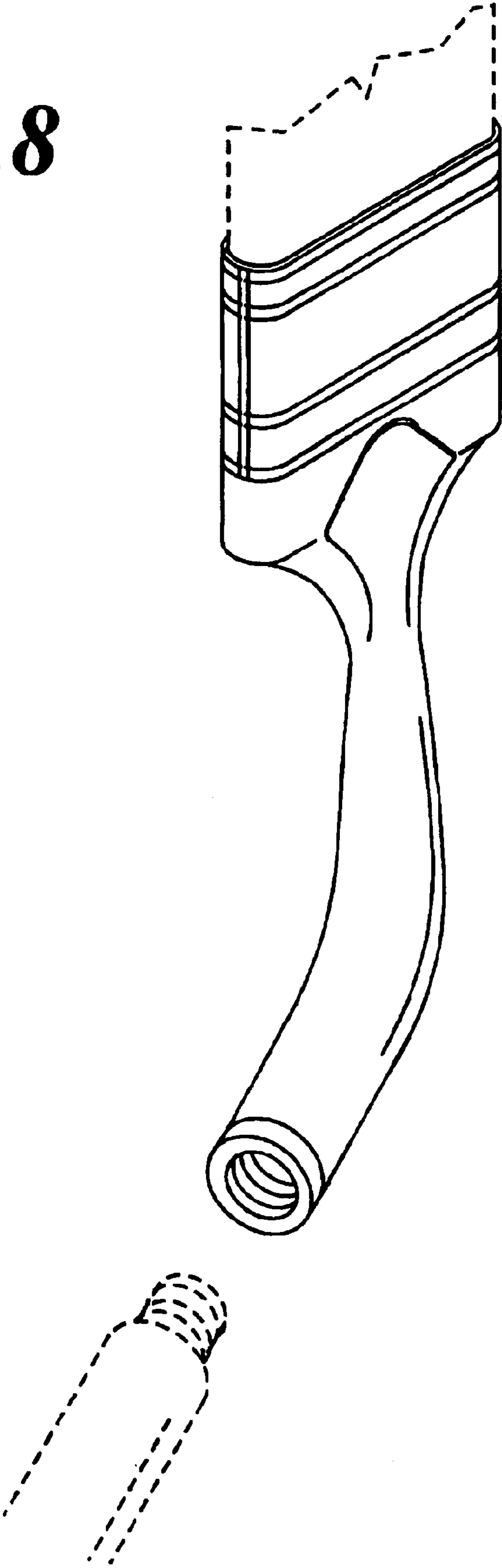

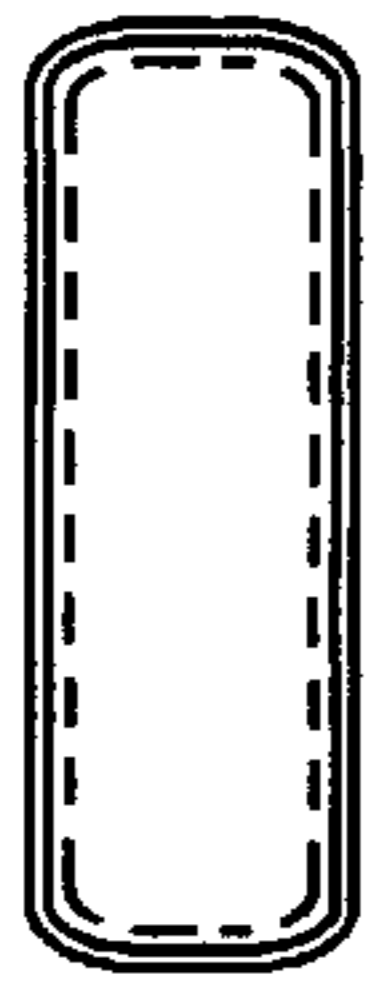

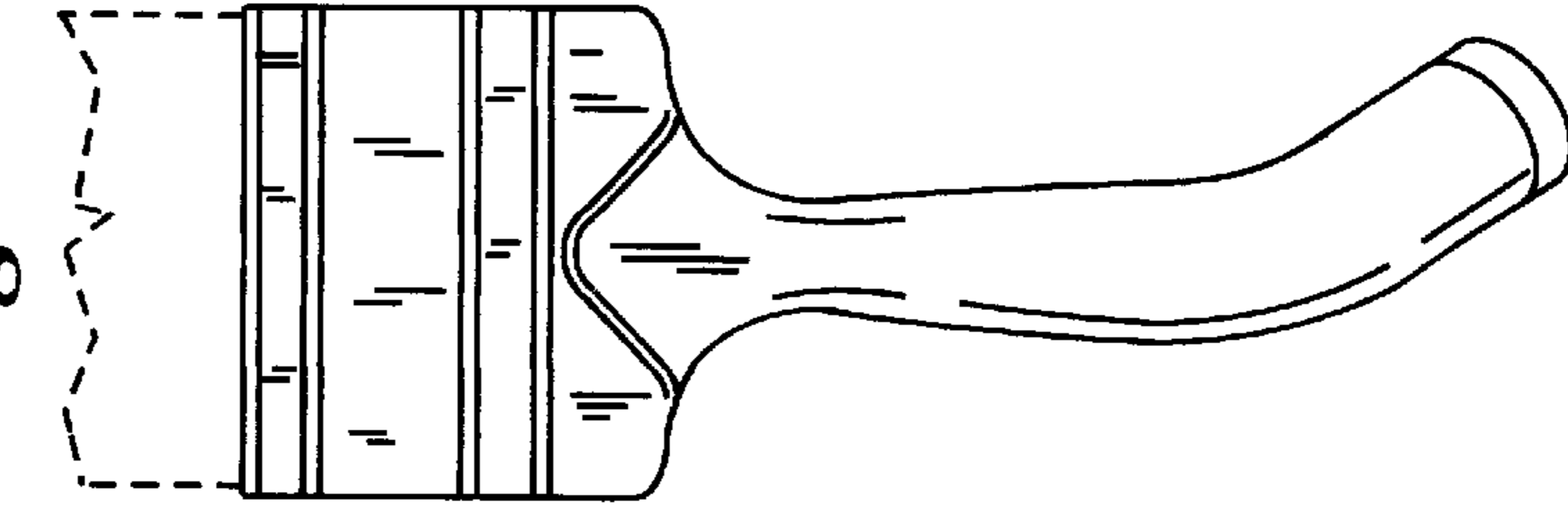
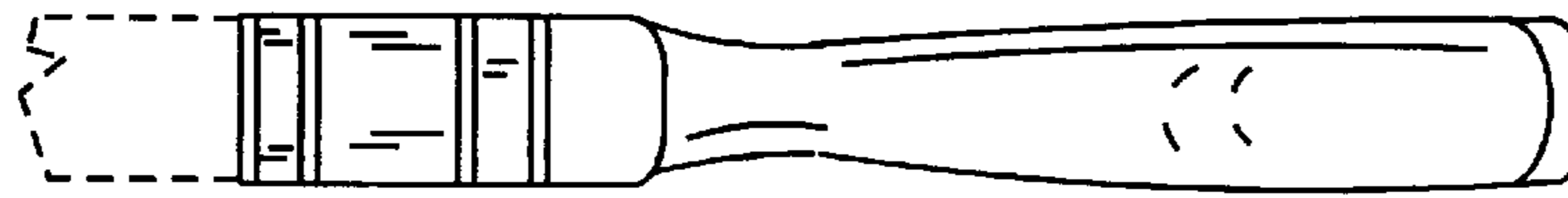
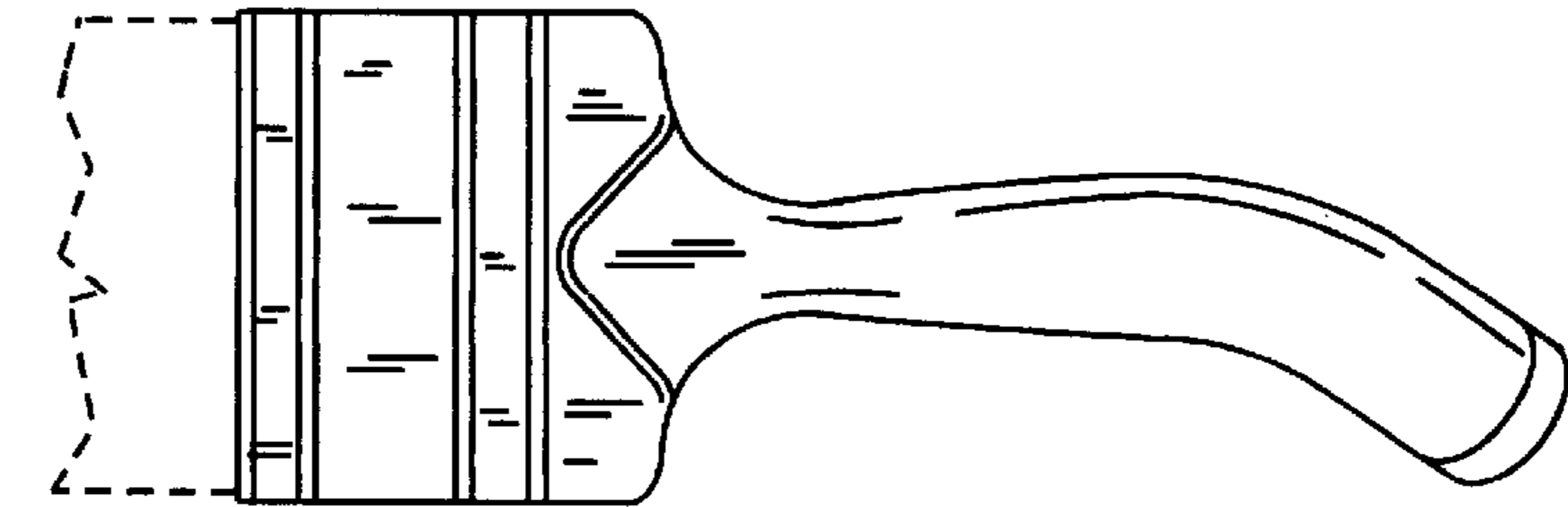
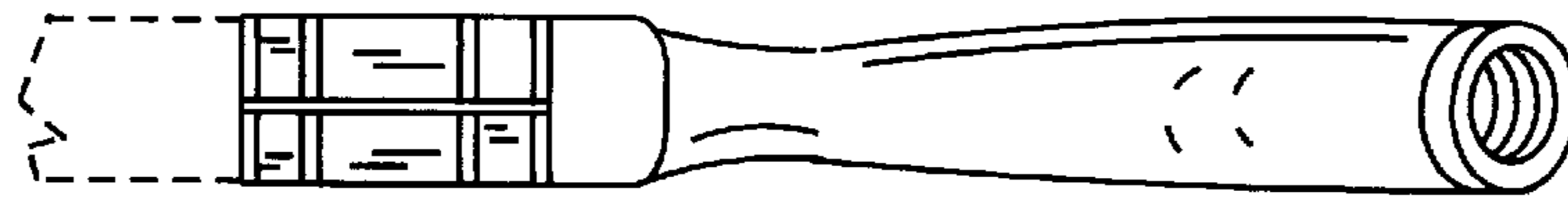

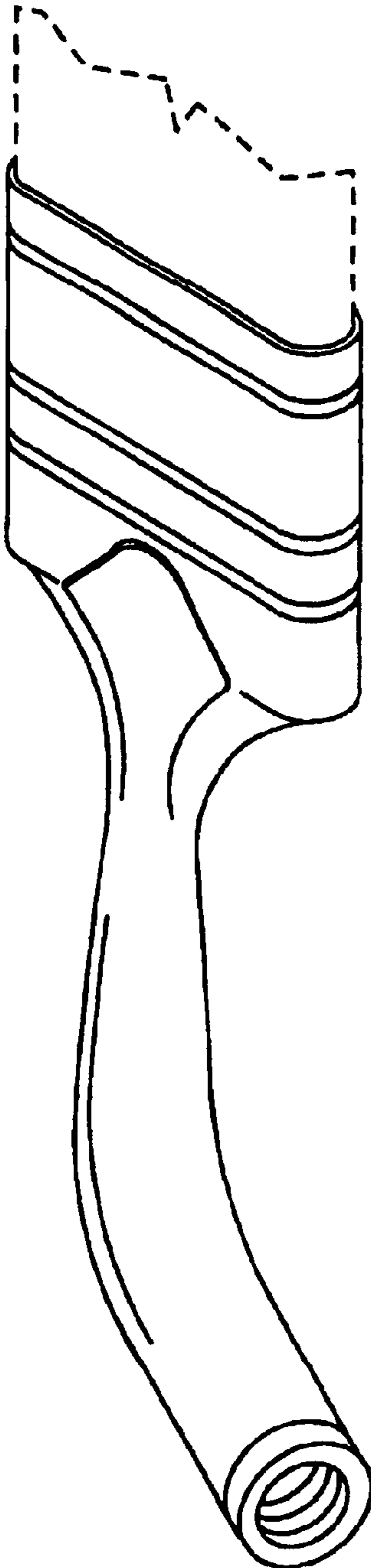

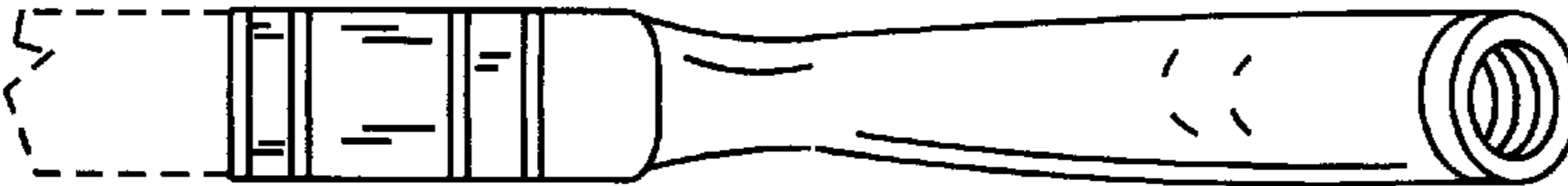

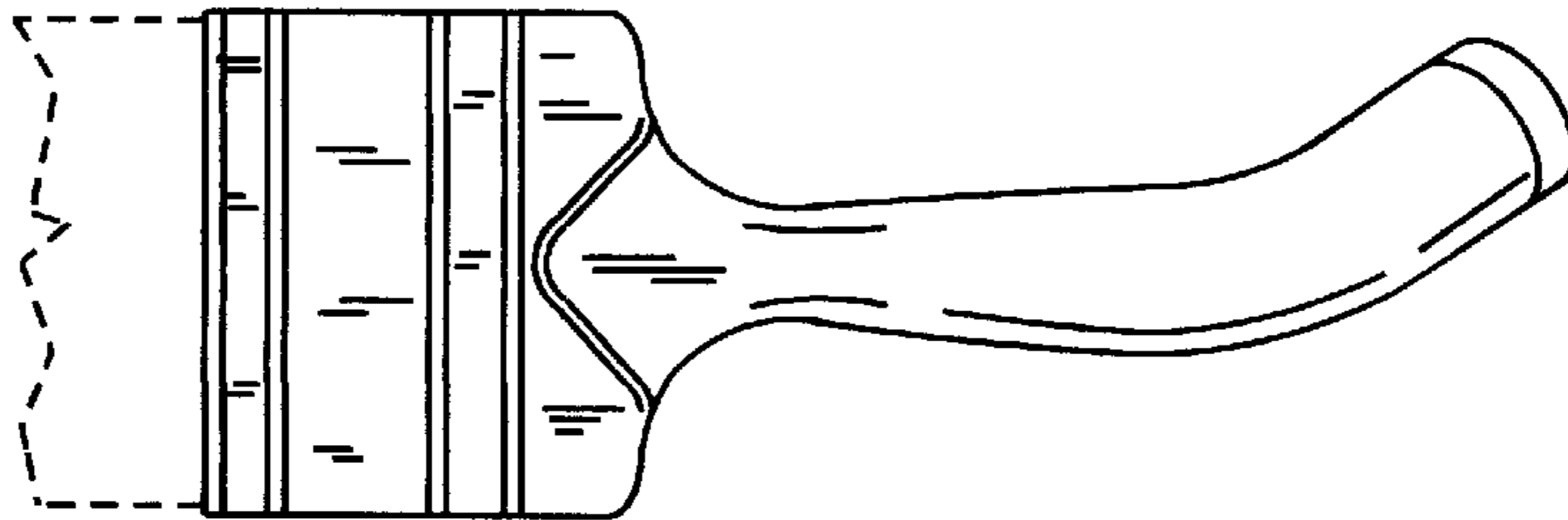

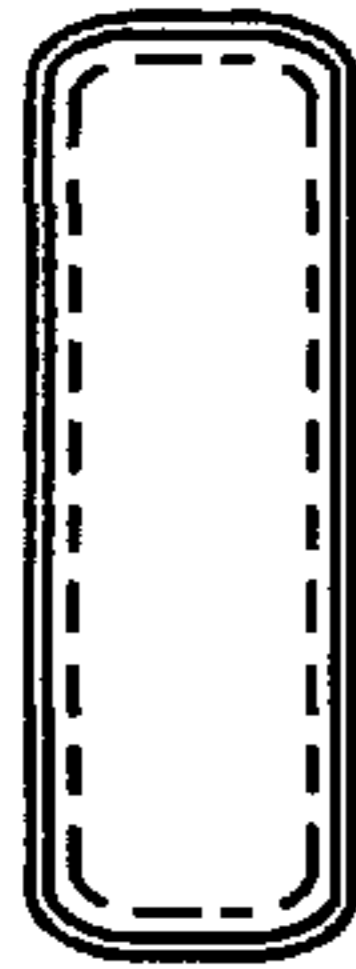

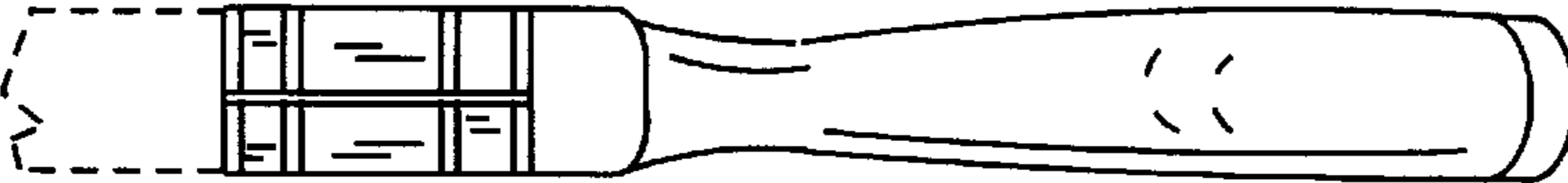
