(57) **CLAIM**

The ornamental design for a caddy, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a caddy embodying our design;

FIG. 2 is a side view of the caddy shown in FIG. 1;

FIG. 3 is a front view of the caddy shown in FIG. 1;

FIG. 4 is a rear view of the caddy shown in FIG. 1;

FIG. 5 is a top view of the caddy in FIG. 1;

FIG. 6 is a bottom view of the caddy shown in FIG. 1;

FIG. 7 is a perspective view of a second embodiment of a caddy;

FIG. 8 is a side view of the caddy in FIG. 7;

FIG. 9 is a front view of the caddy in FIG. 7;

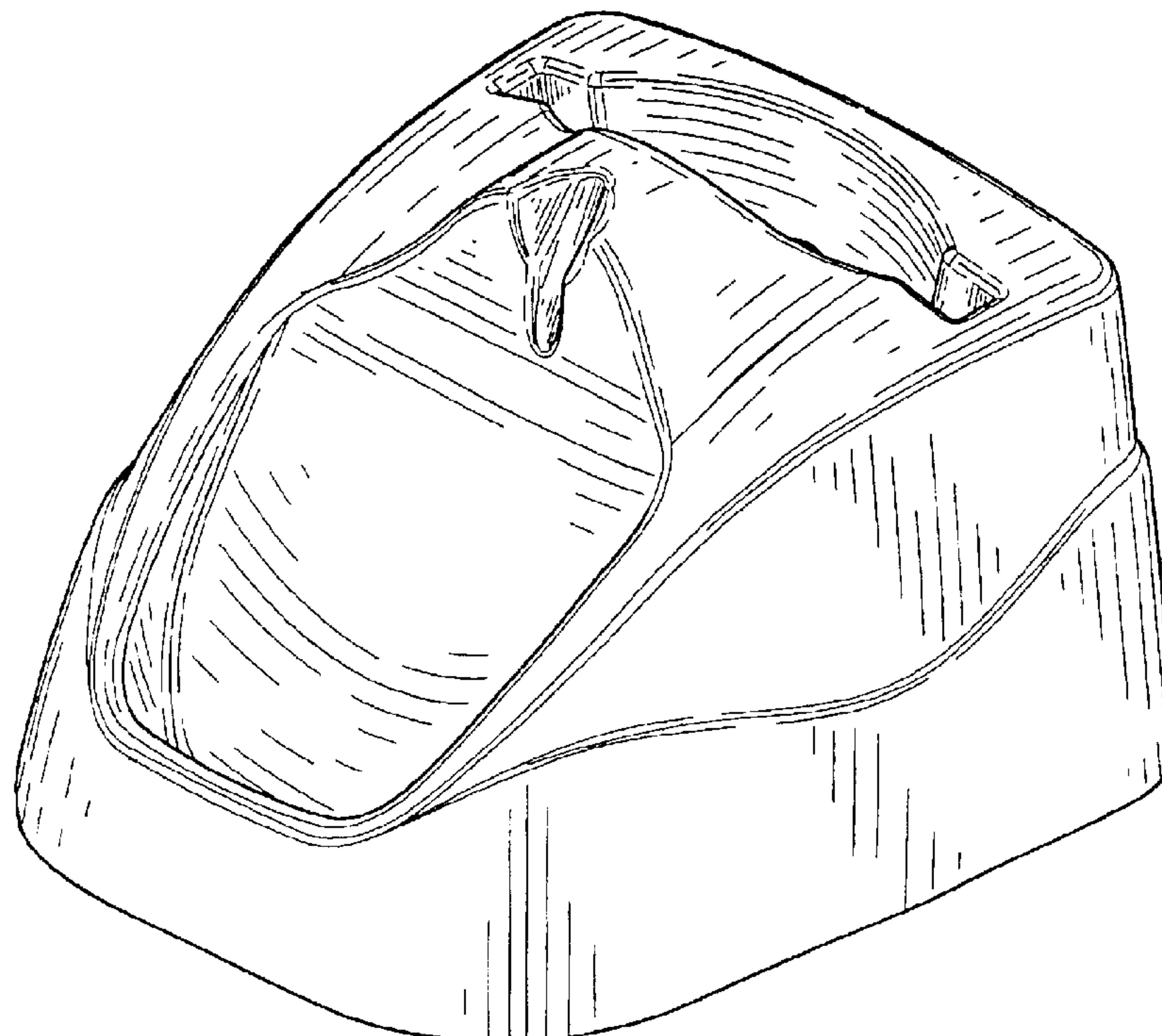
FIG. 10 is a rear view of the caddy in FIG. 7;

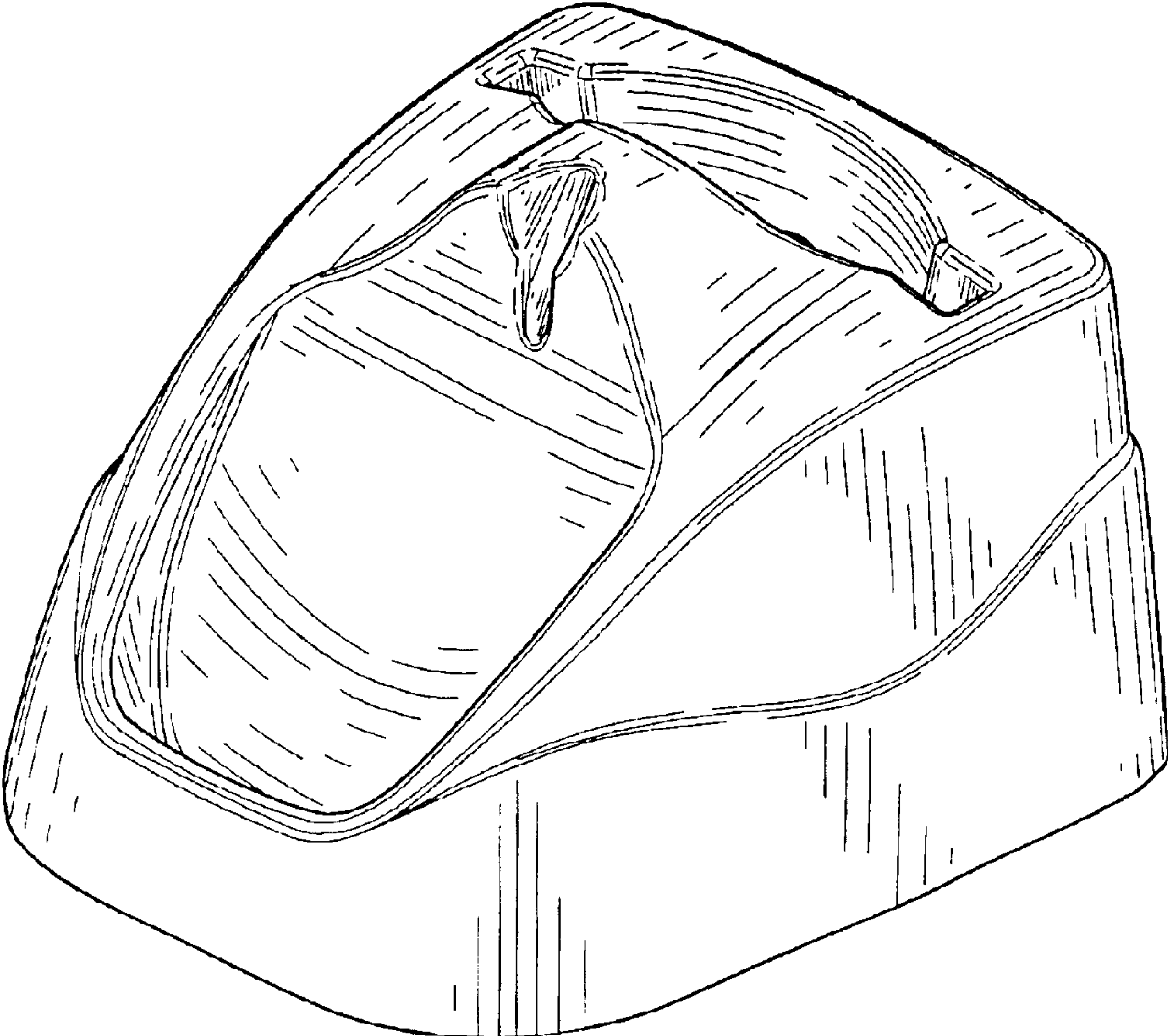

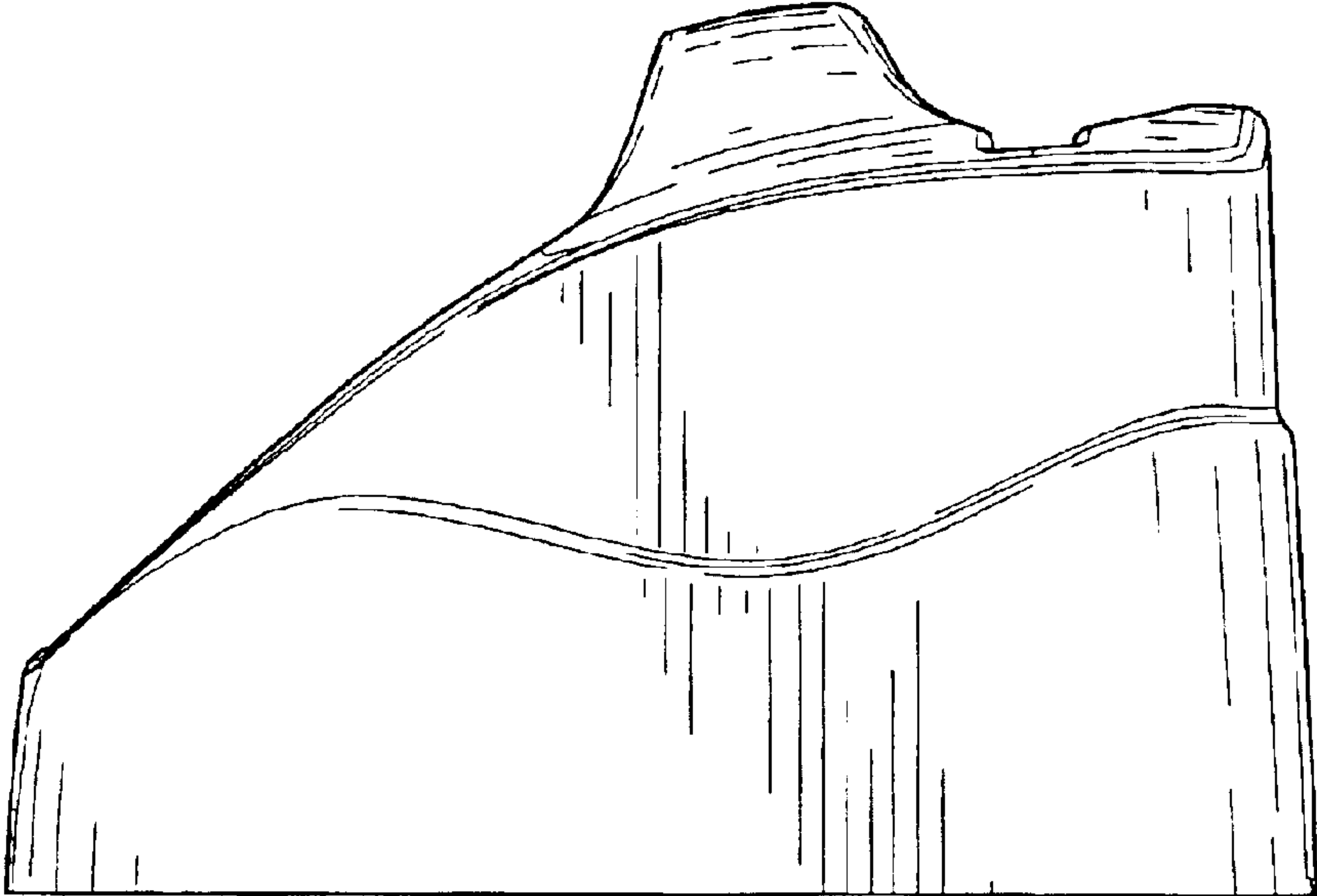

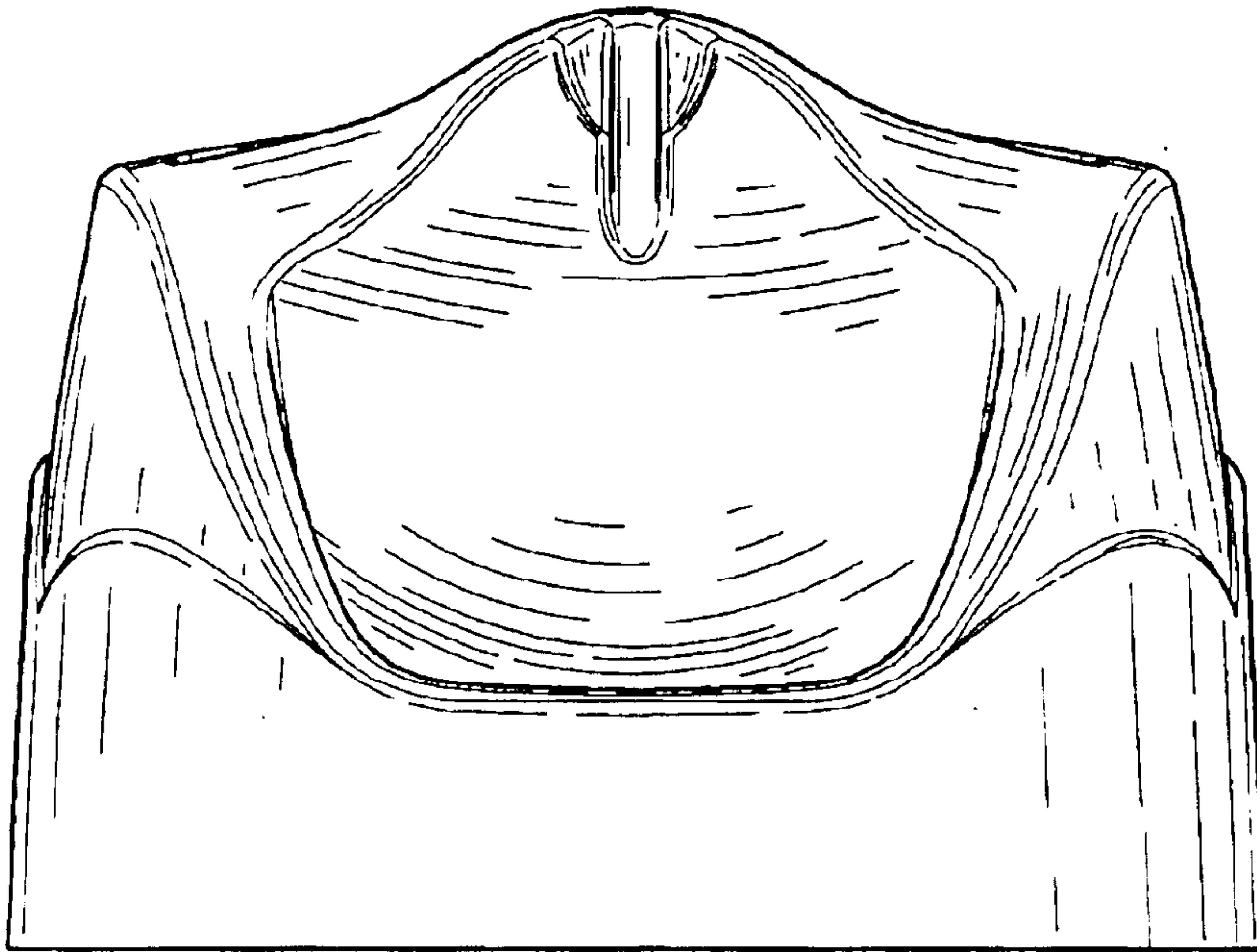

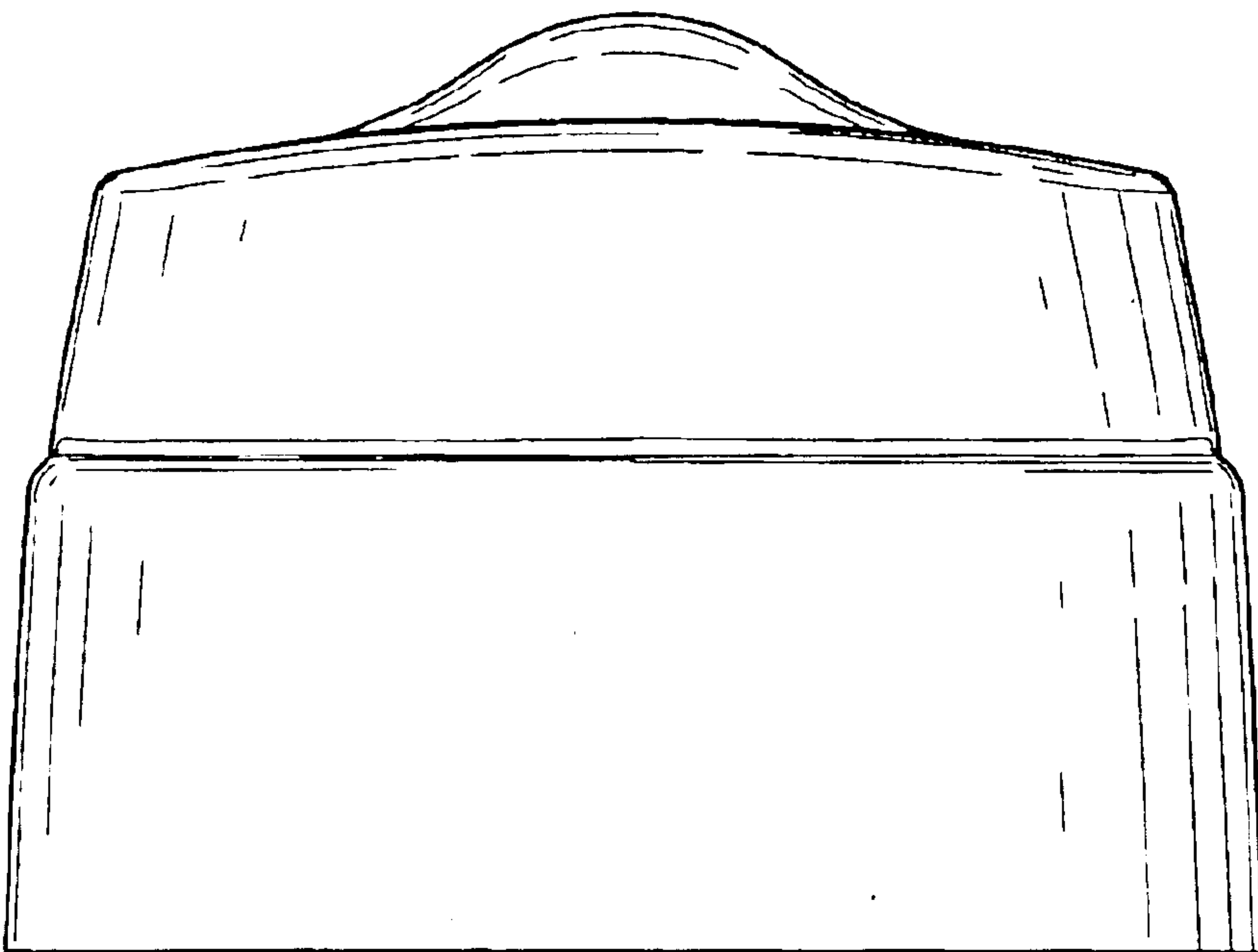

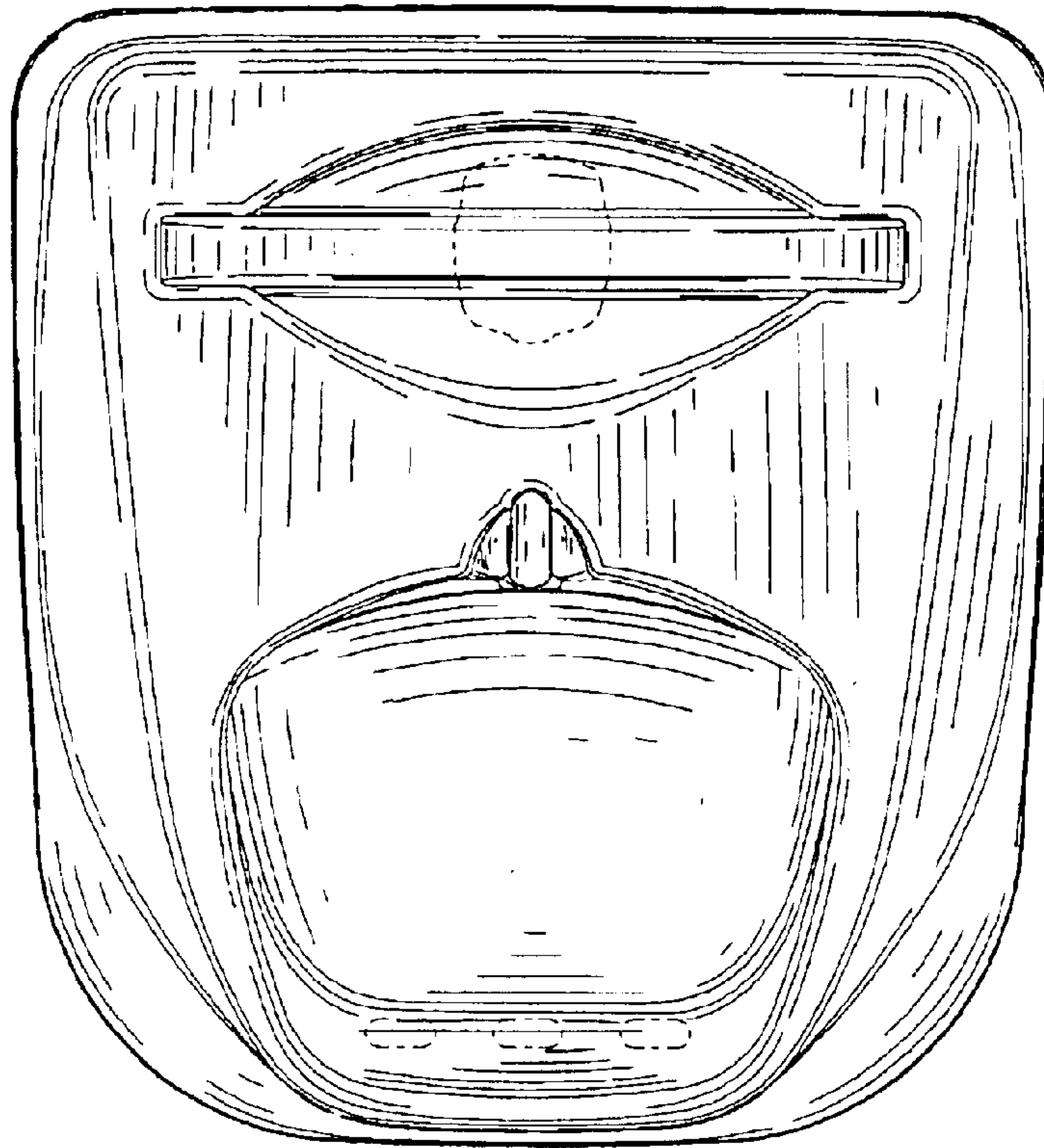

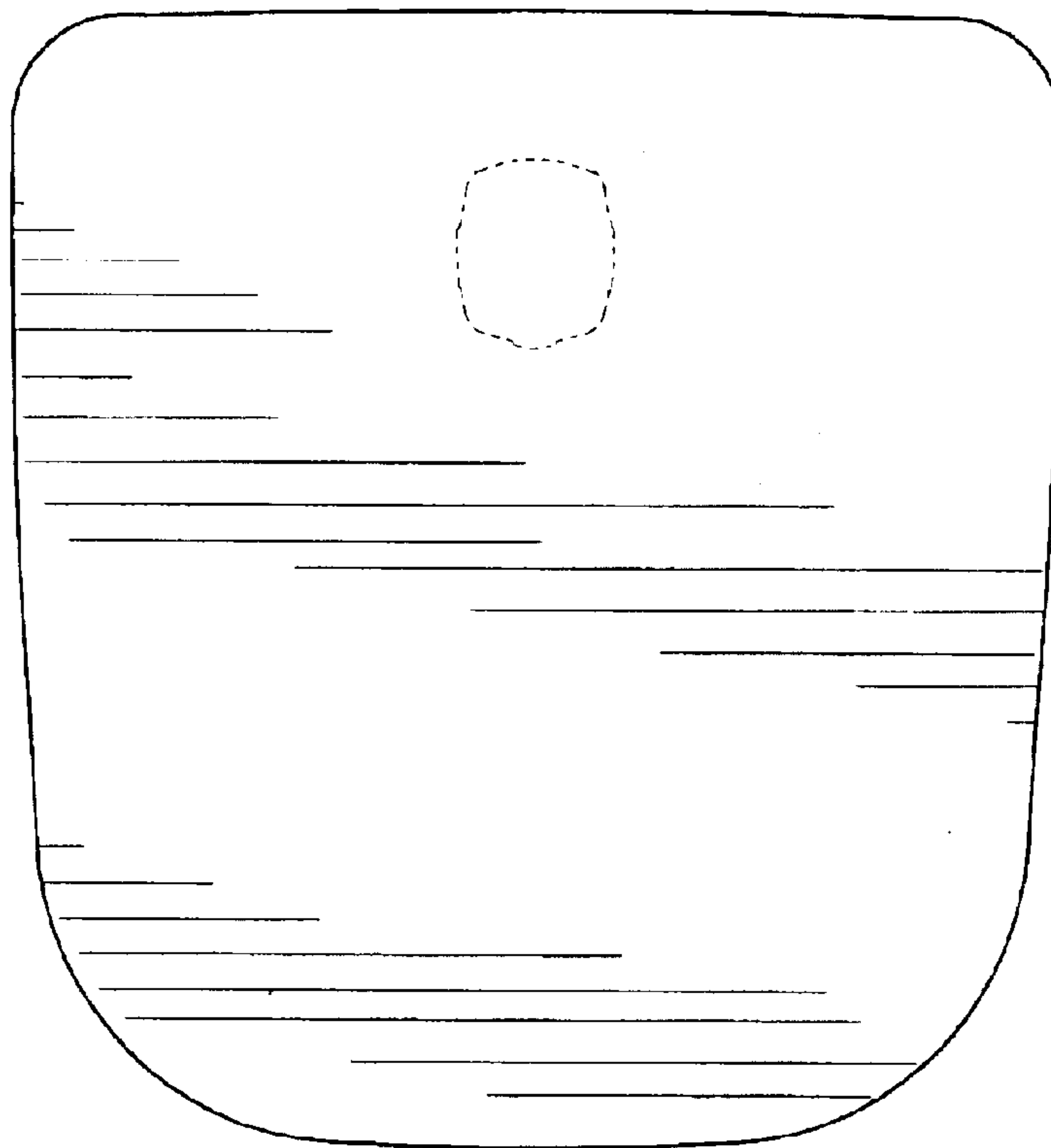

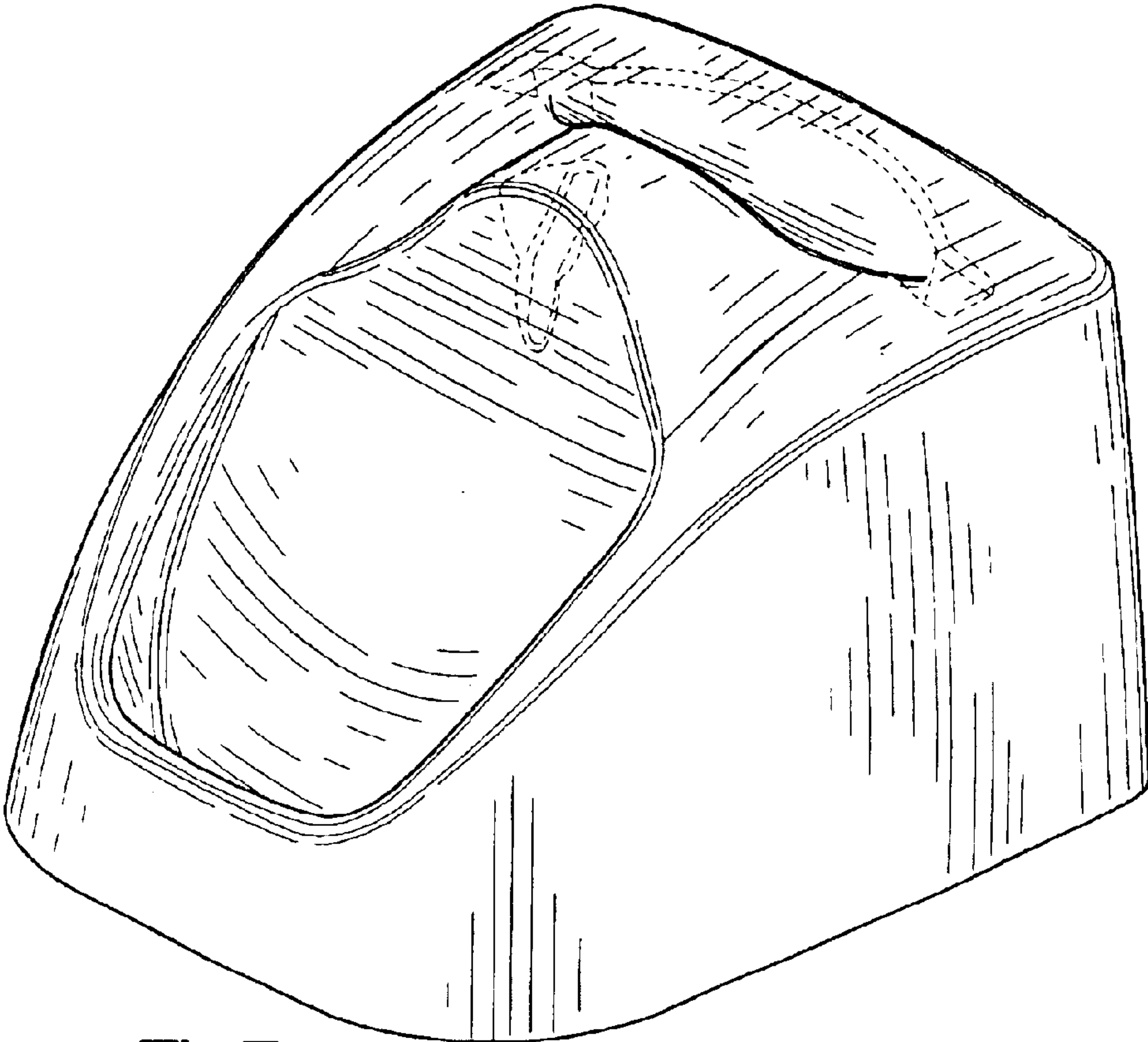

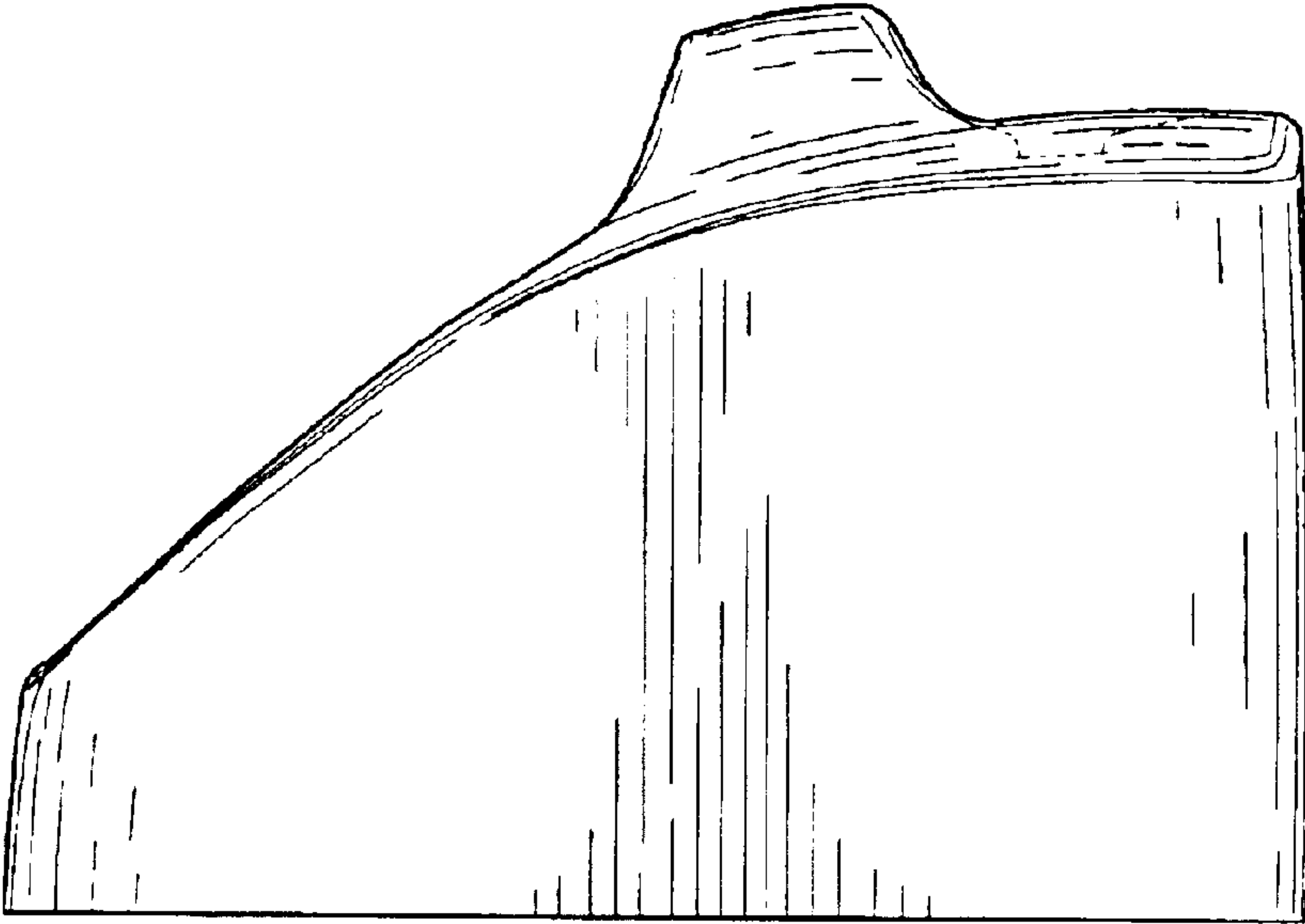

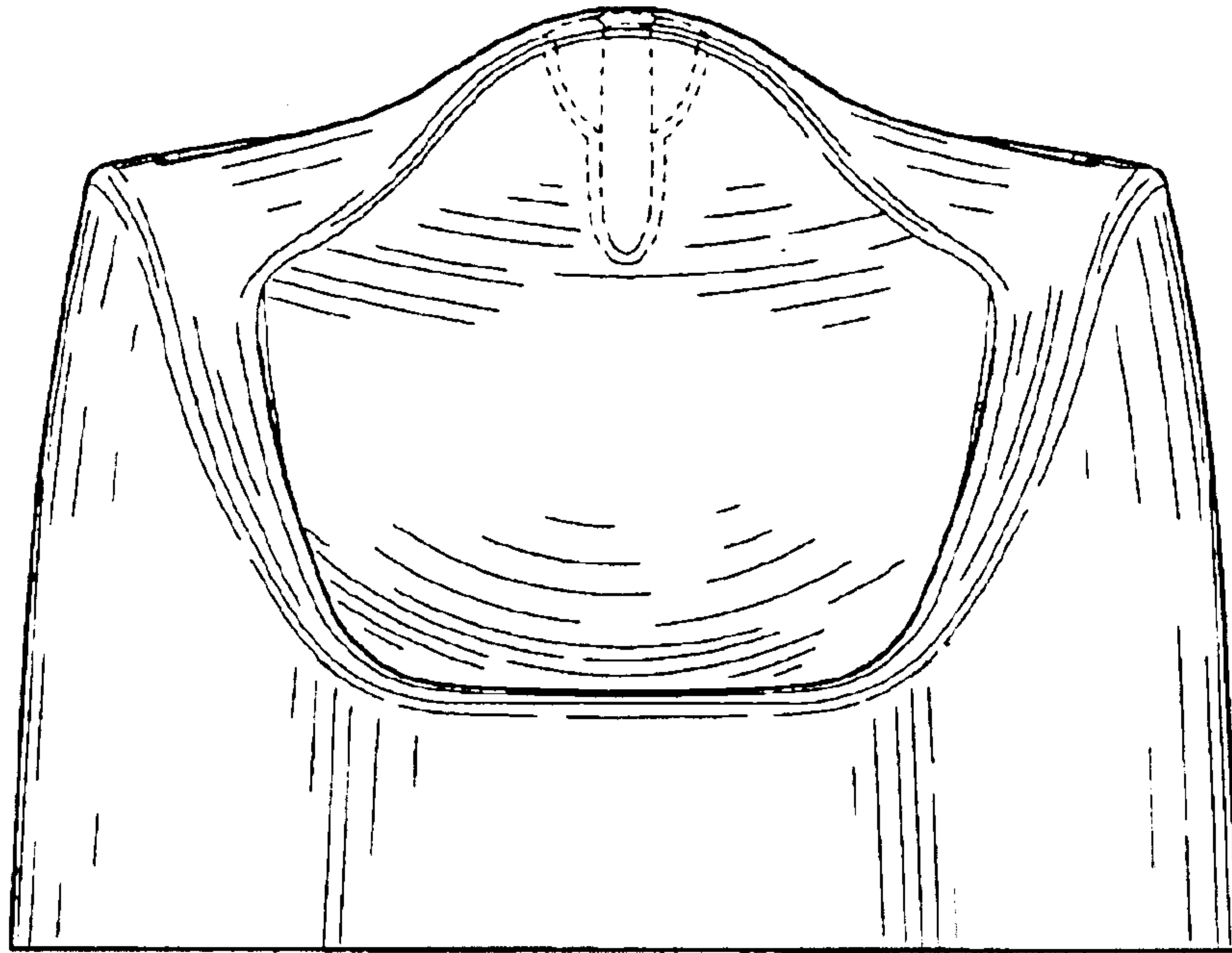

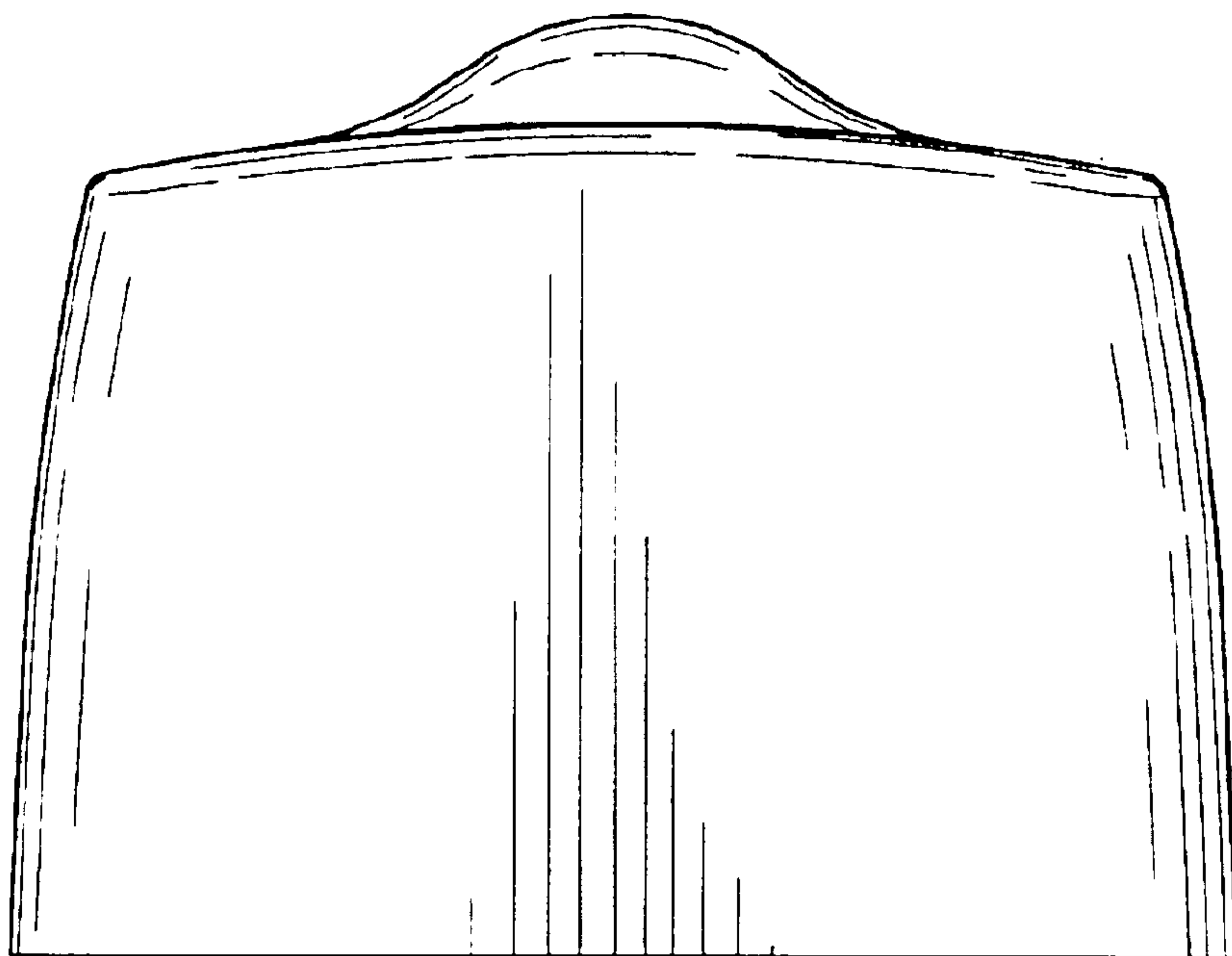

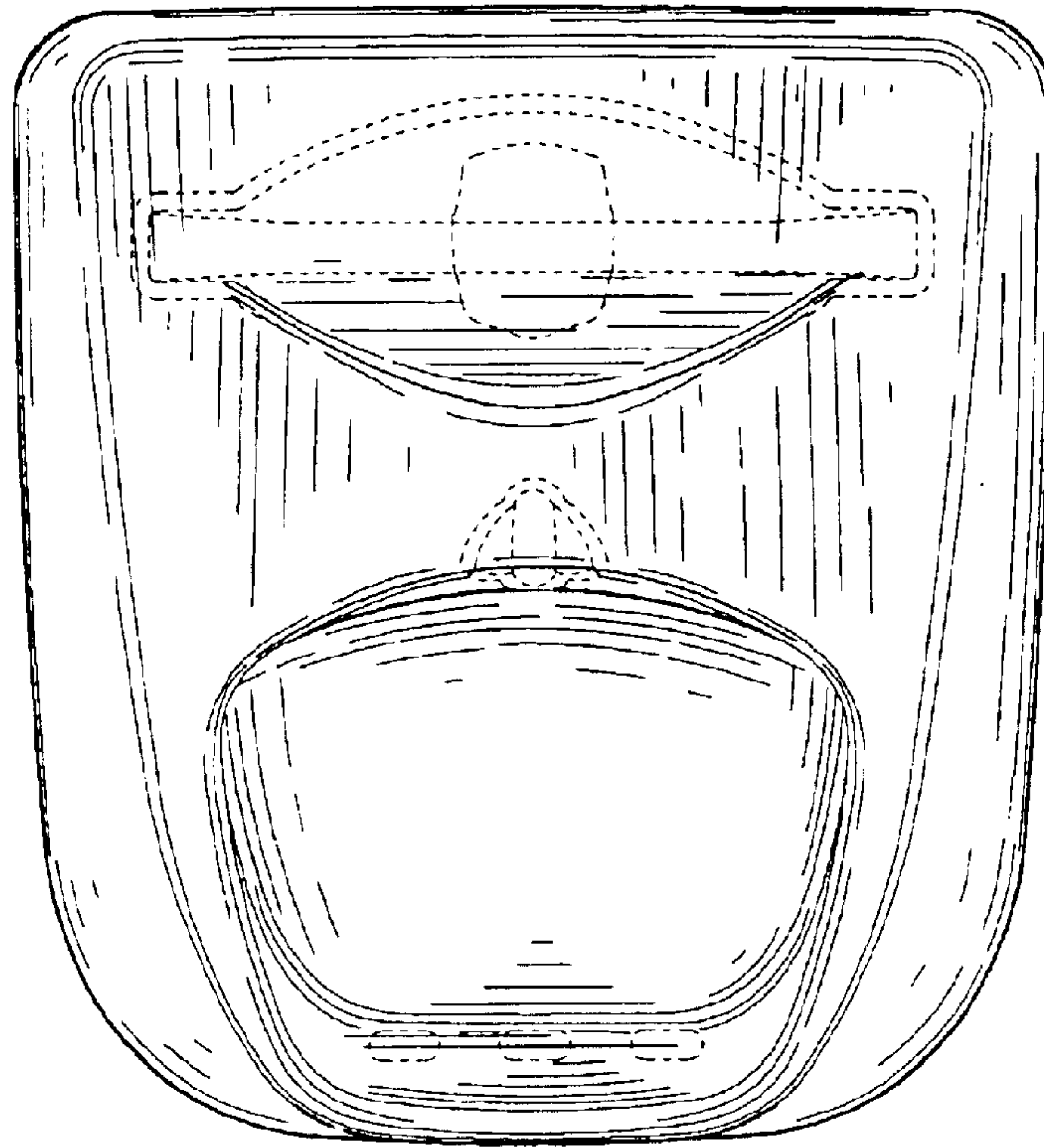

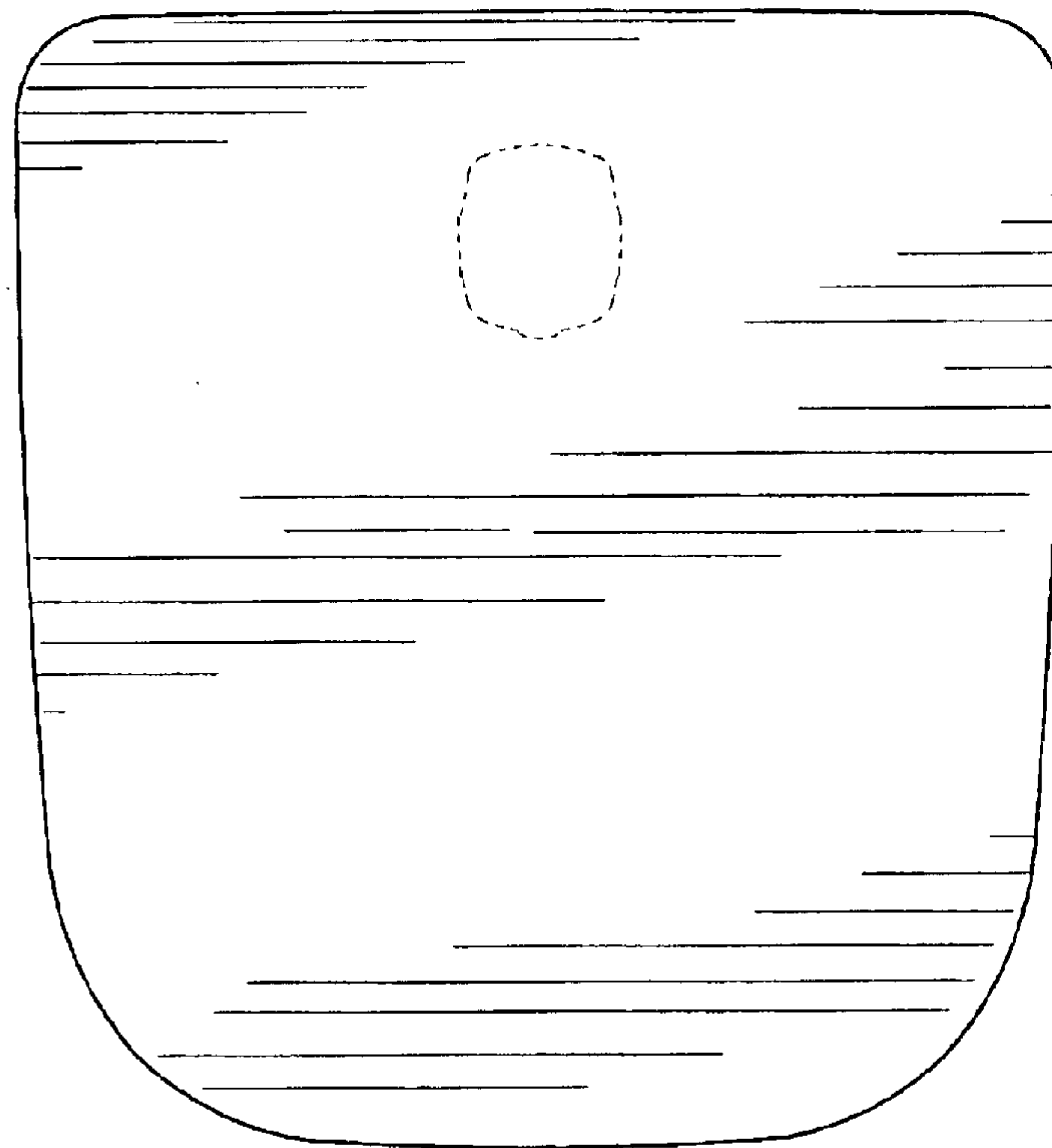
