The ornamental design for a triangular plate, as shown.

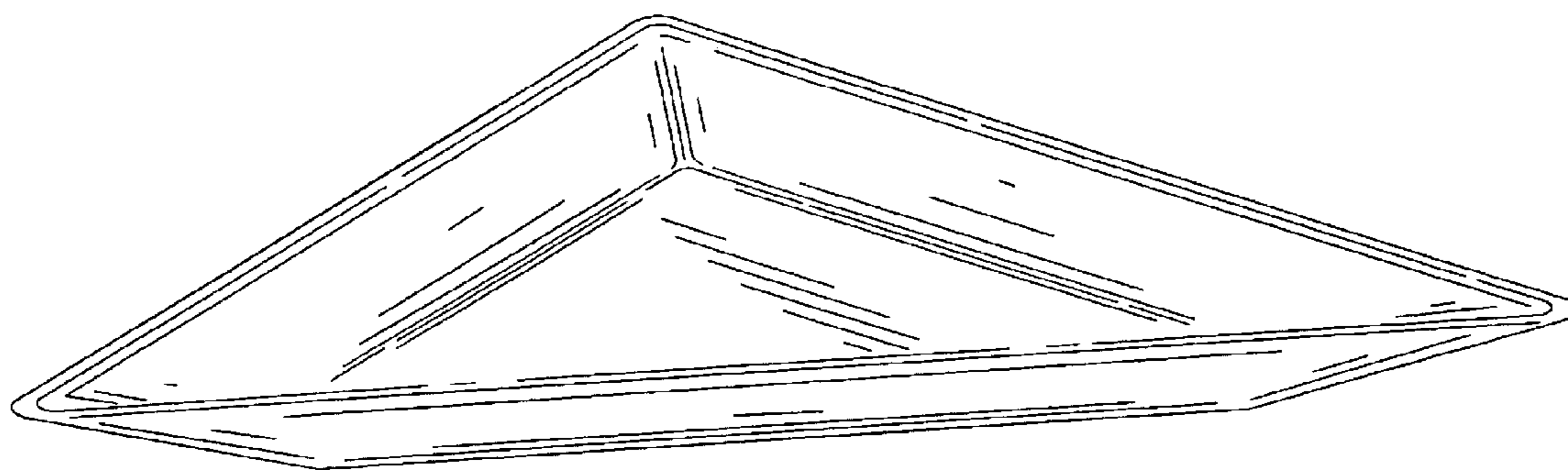
**DESCRIPTION**

FIG. 1 is a top plan view of a triangular plate showing our new design;

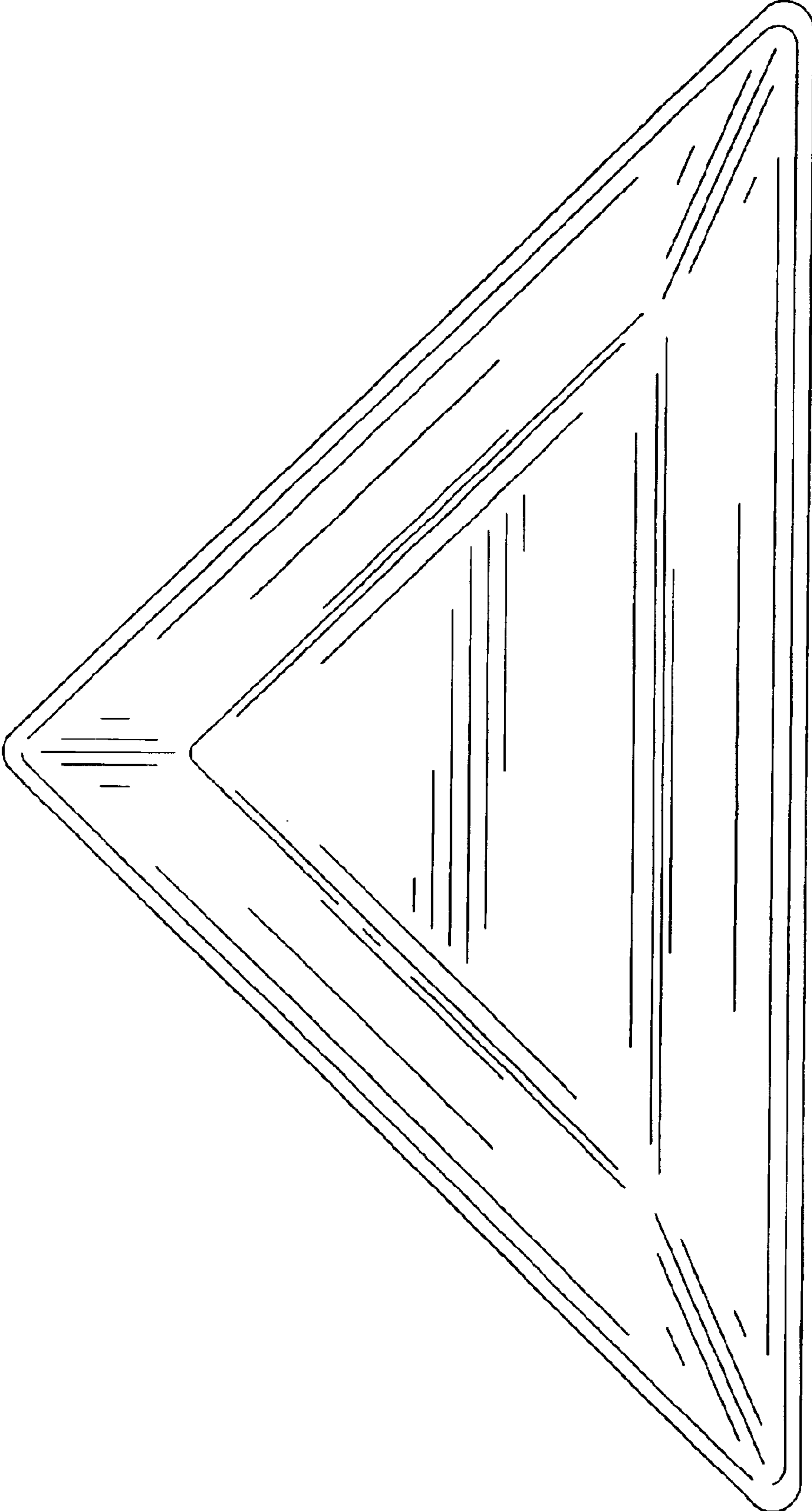

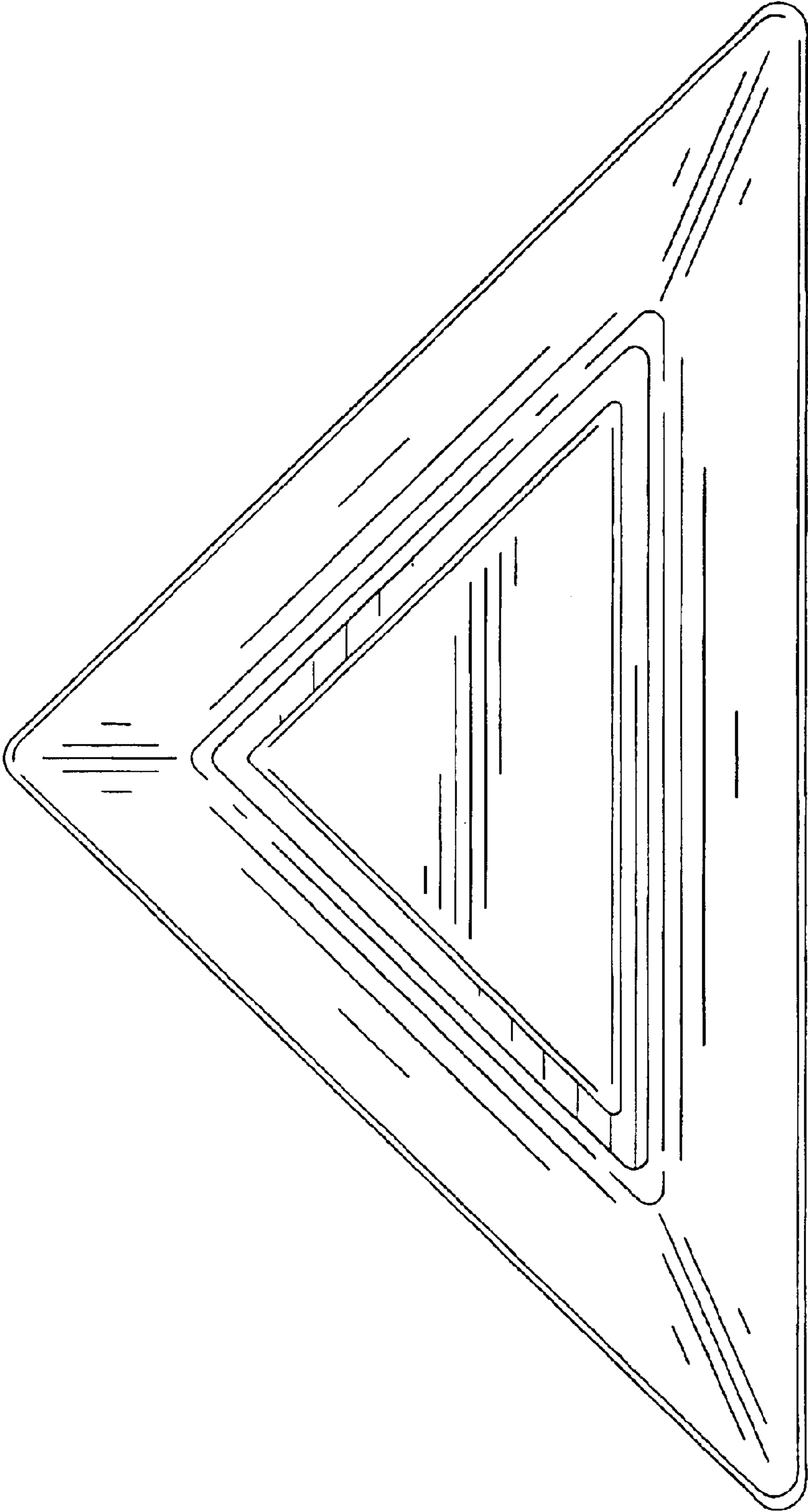

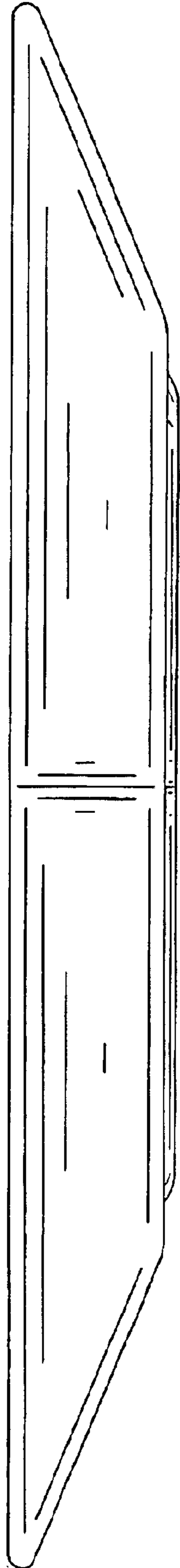

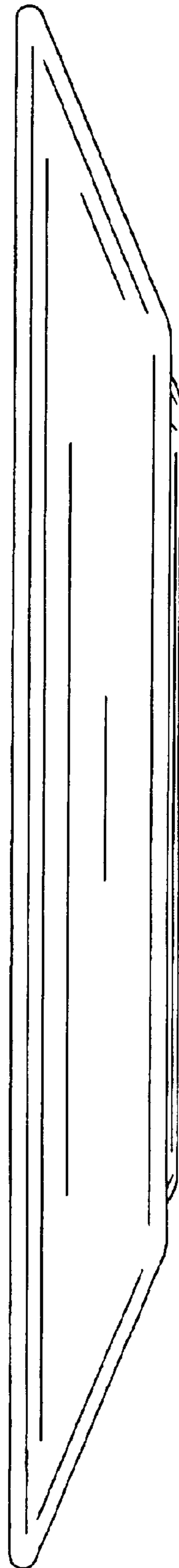

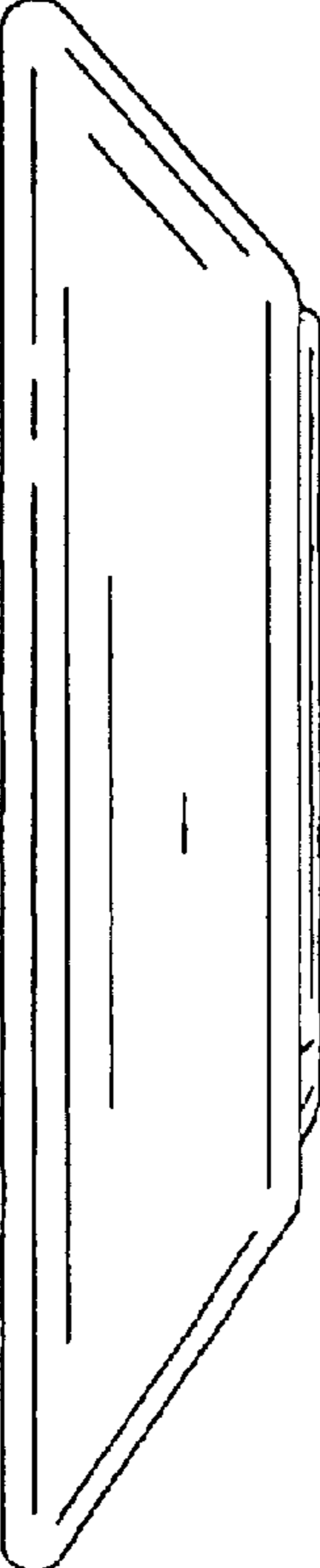

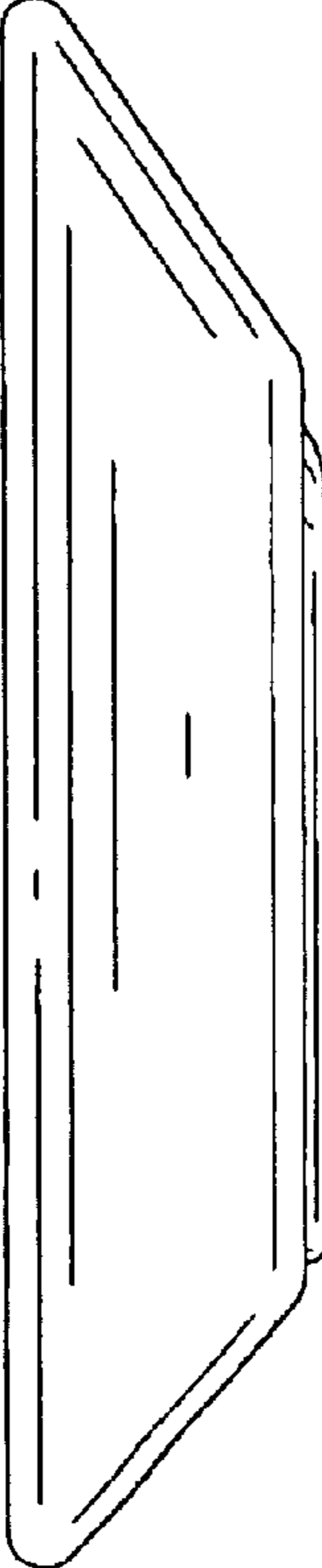

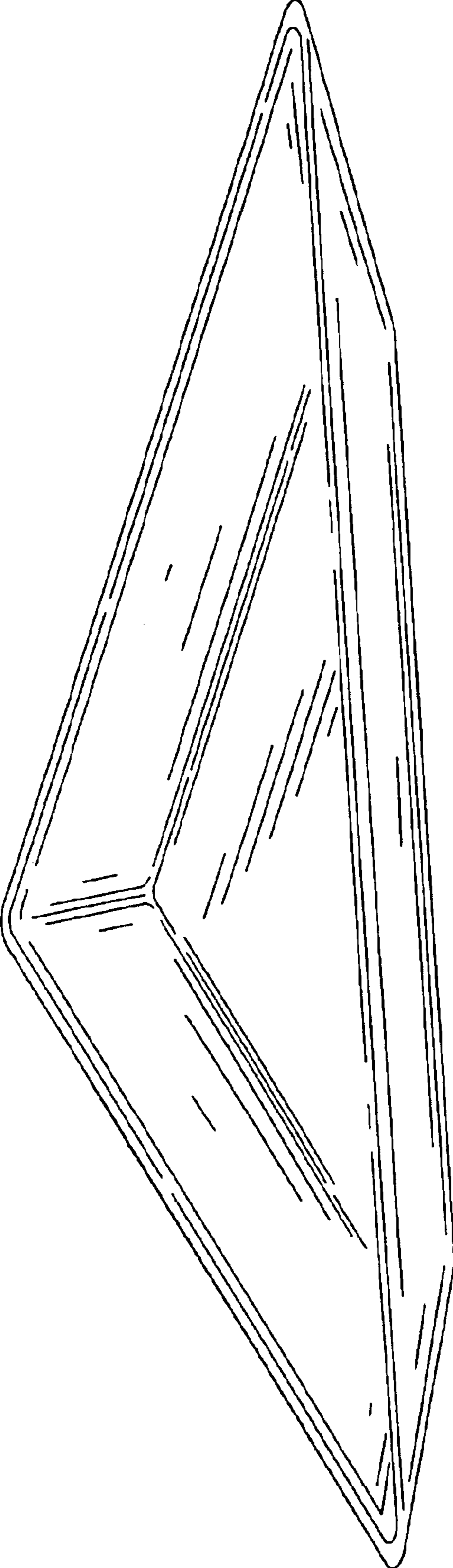
