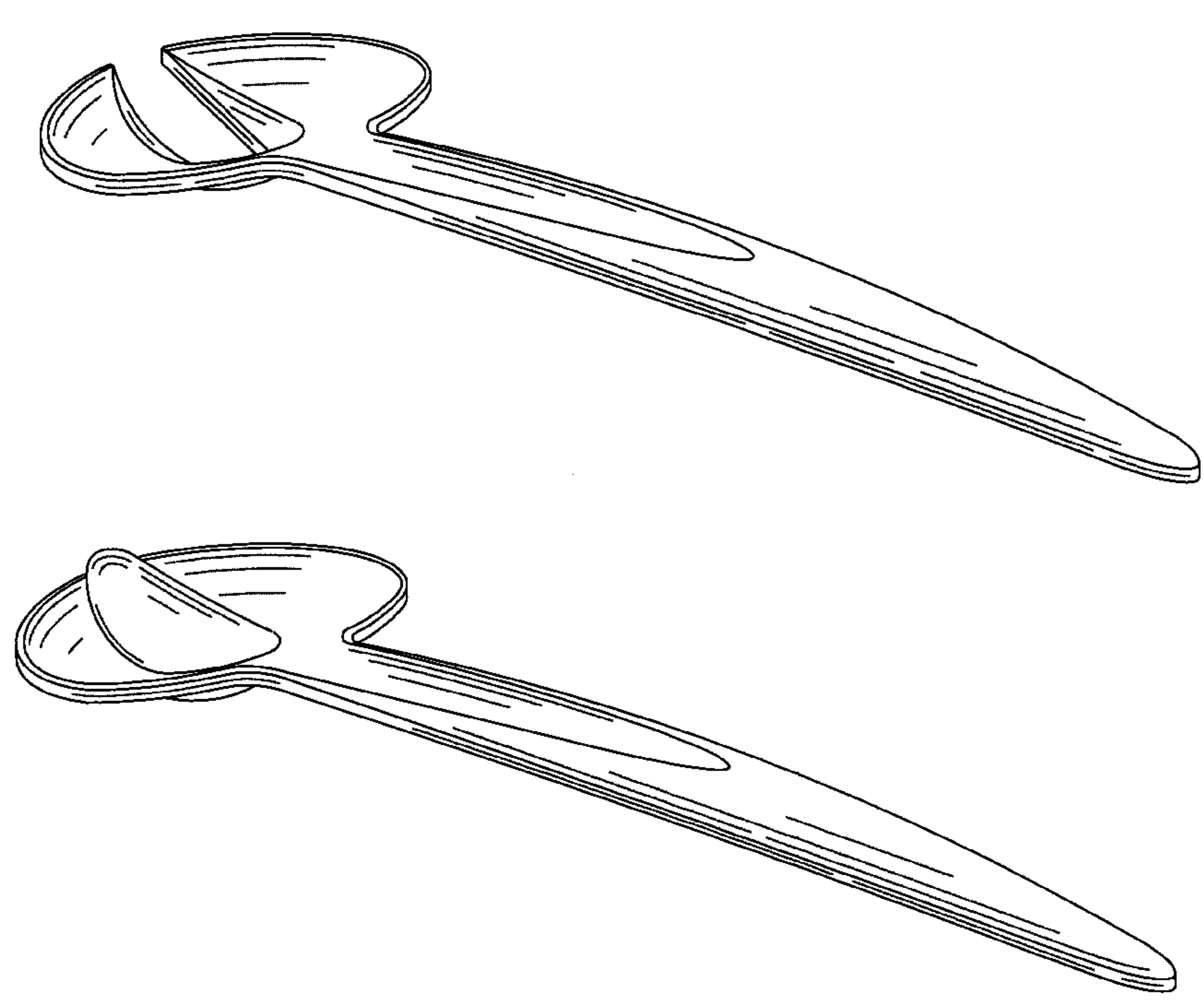
(57) **CLAIM**

The ornamental design for a salad utensil set, as shown and described.

DESCRIPTION

FIG. 1 is a top, side and handle end perspective view of the fork portion of the salad utensil set showing my new design; FIG. 2 is a left side elevation view thereof; FIG. 3 is a right side elevation view thereof; FIG. 4 is a handle end elevation view thereof; FIG. 5 is an implement end elevation view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; FIG. 8 is a top, side and handle end perspective view of the spoon portion of the salad utensil set thereof; FIG. 9 is a left side elevation view thereof; FIG. 10 is a right side elevation view thereof; FIG. 11 is a handle end elevation view thereof; FIG. 12 is an implement end elevation view thereof; FIG. 13 is a top plan view thereof; and, FIG. 14 is a bottom plan view thereof. The fork and spoon portions are shown separately for clarity of illustration.

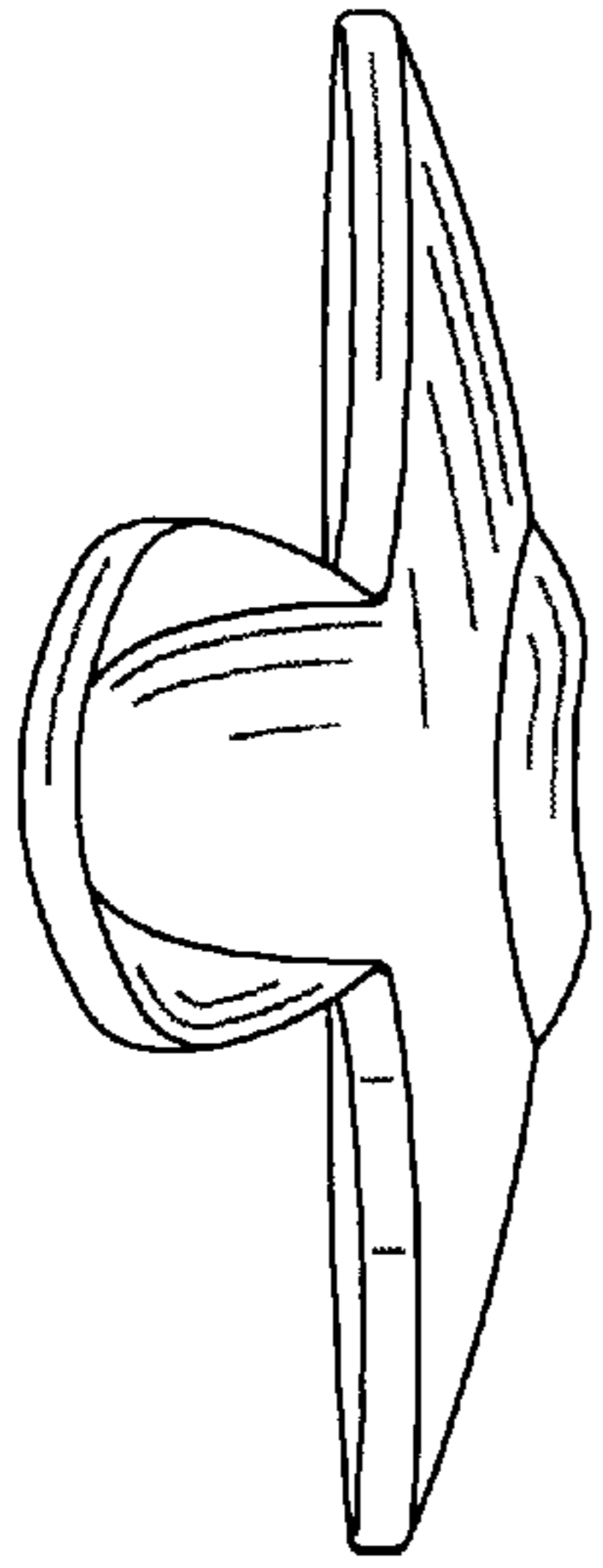

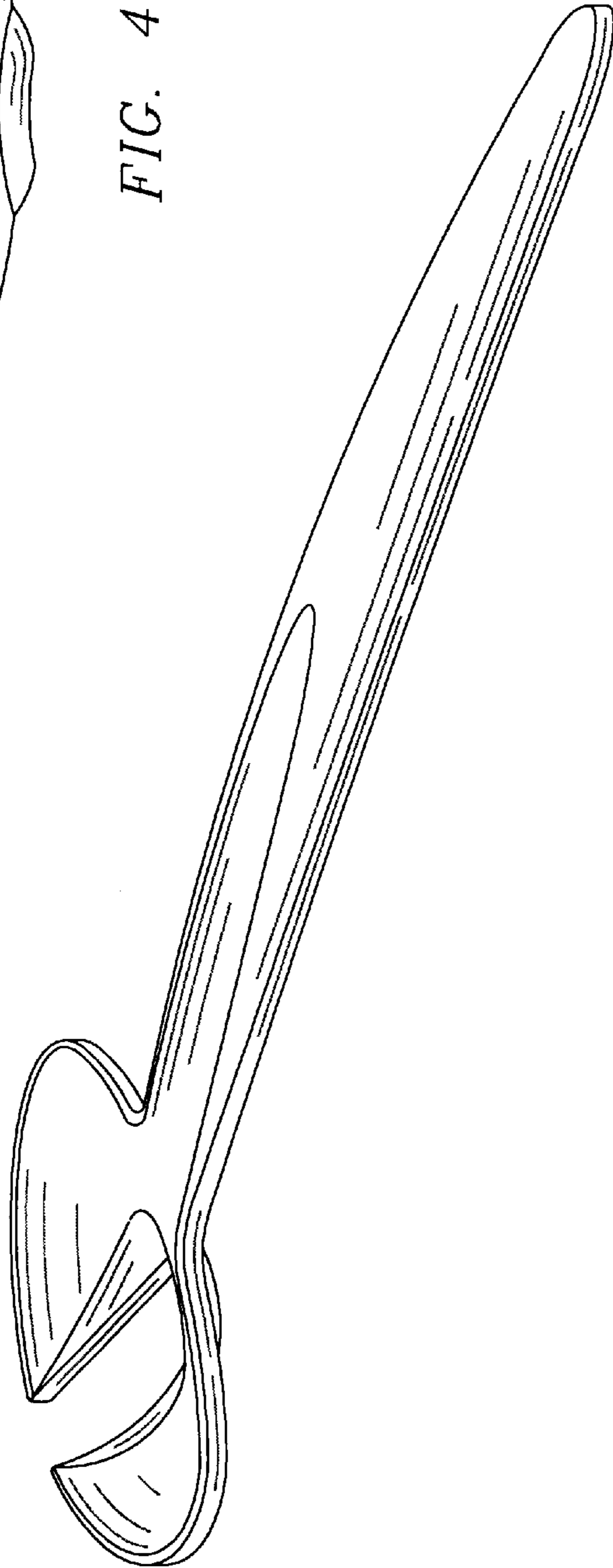

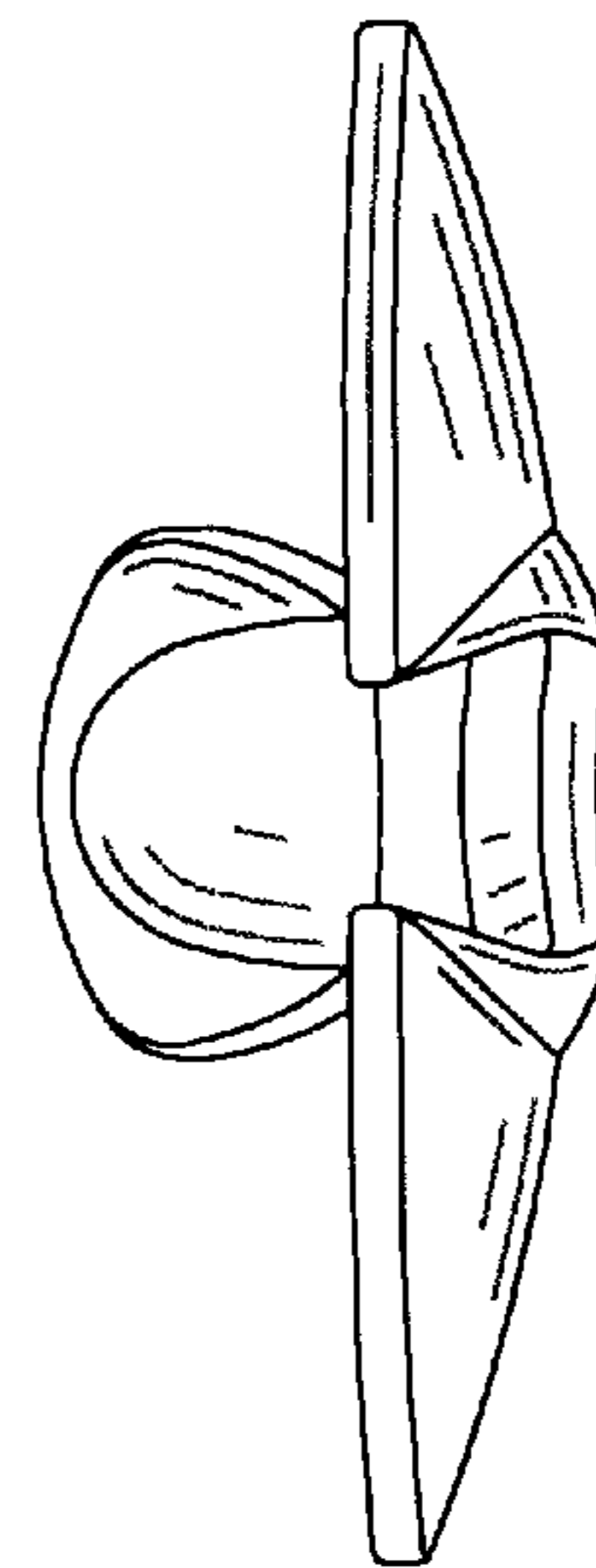

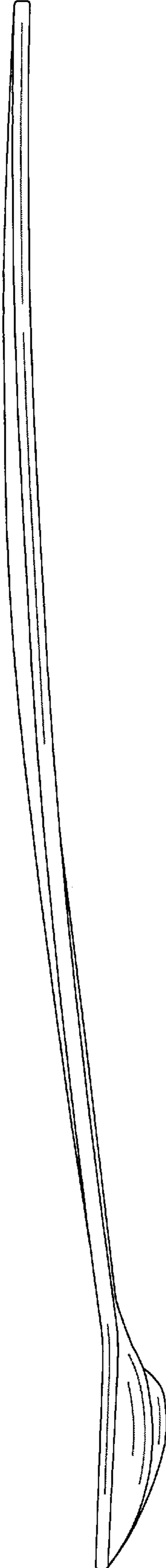

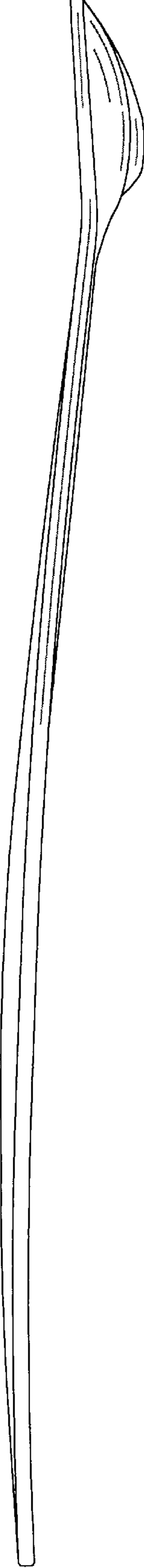

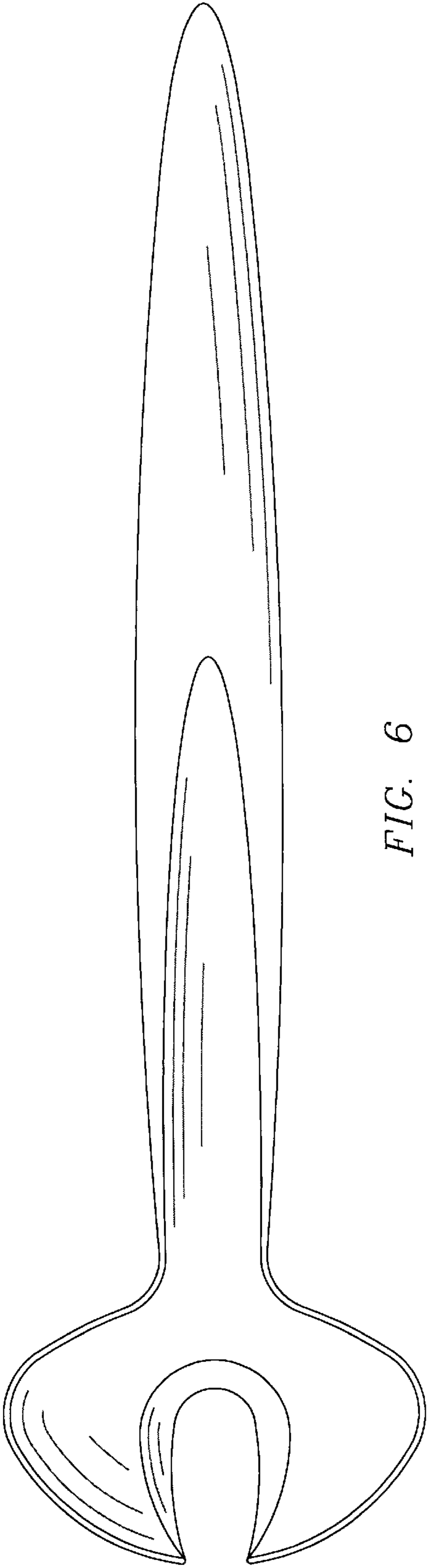

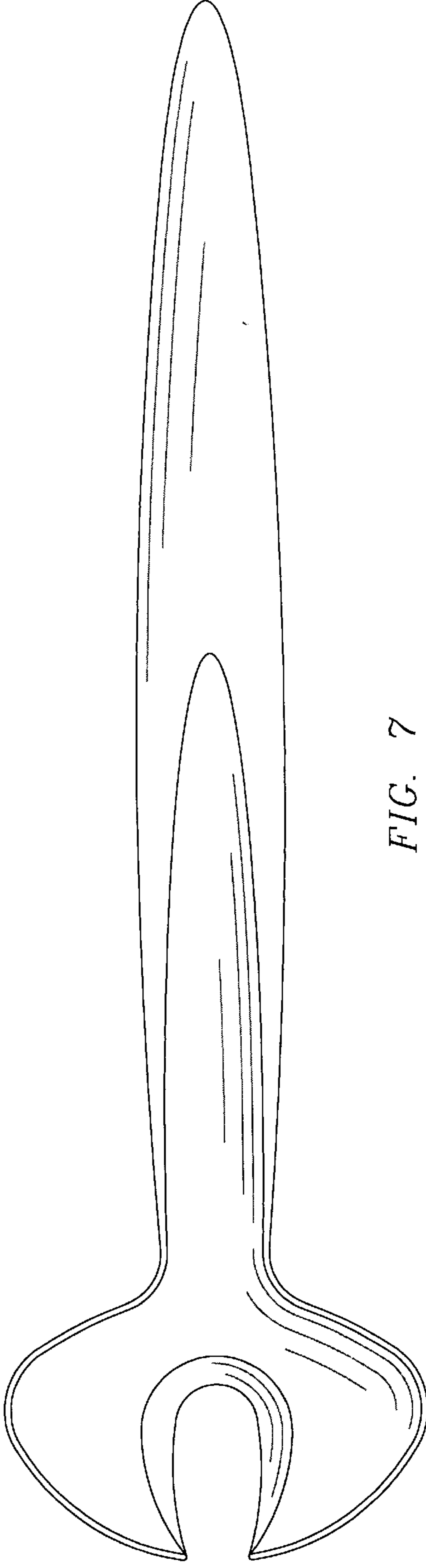

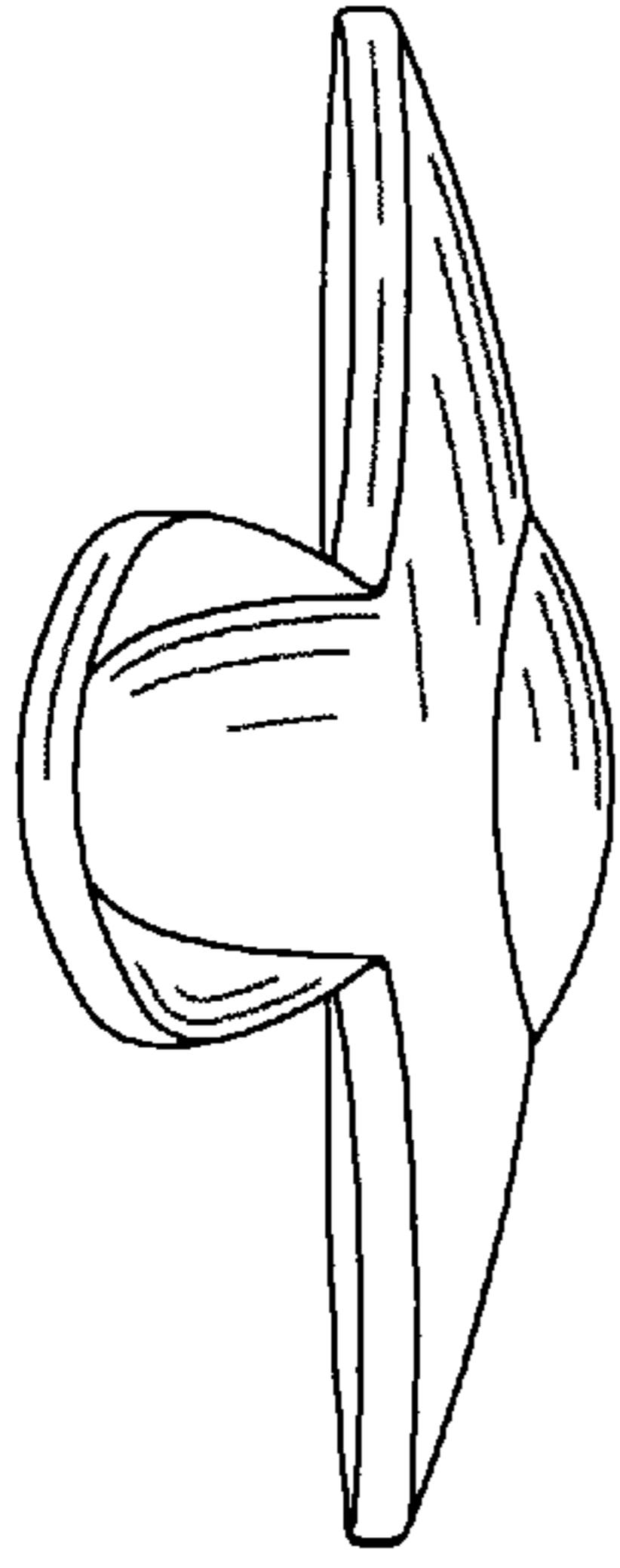

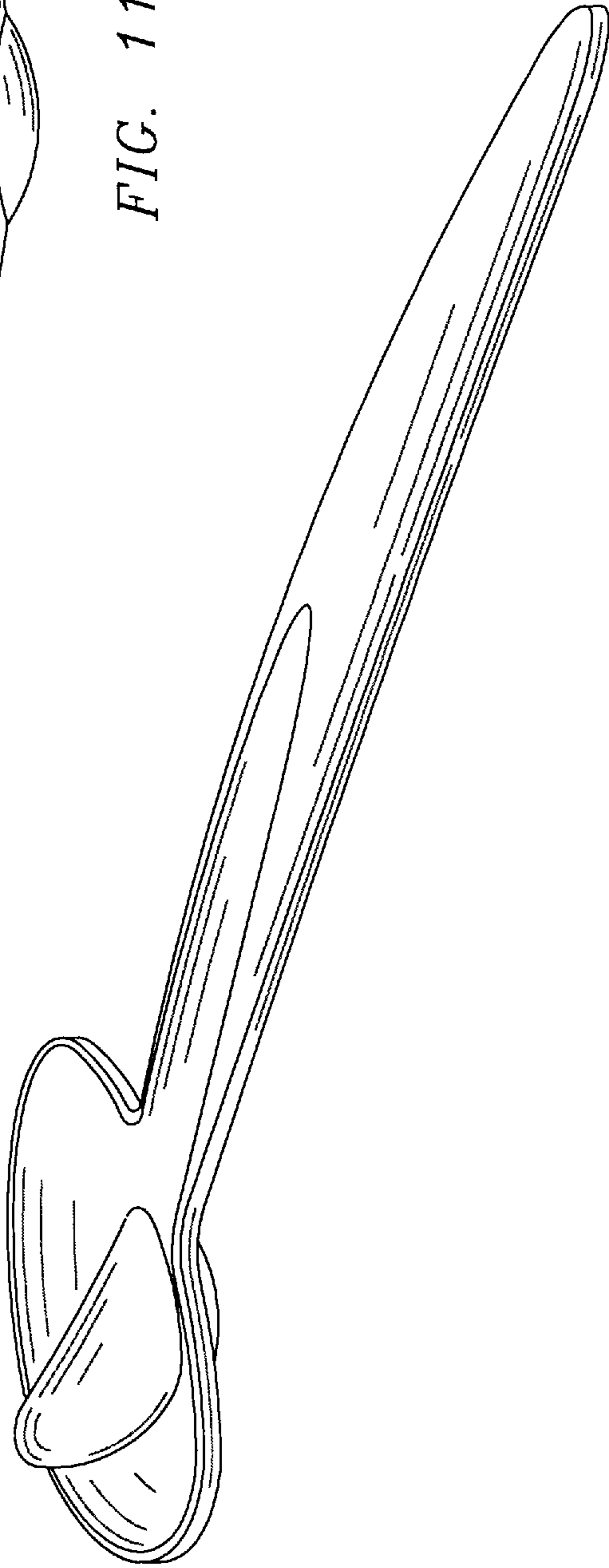

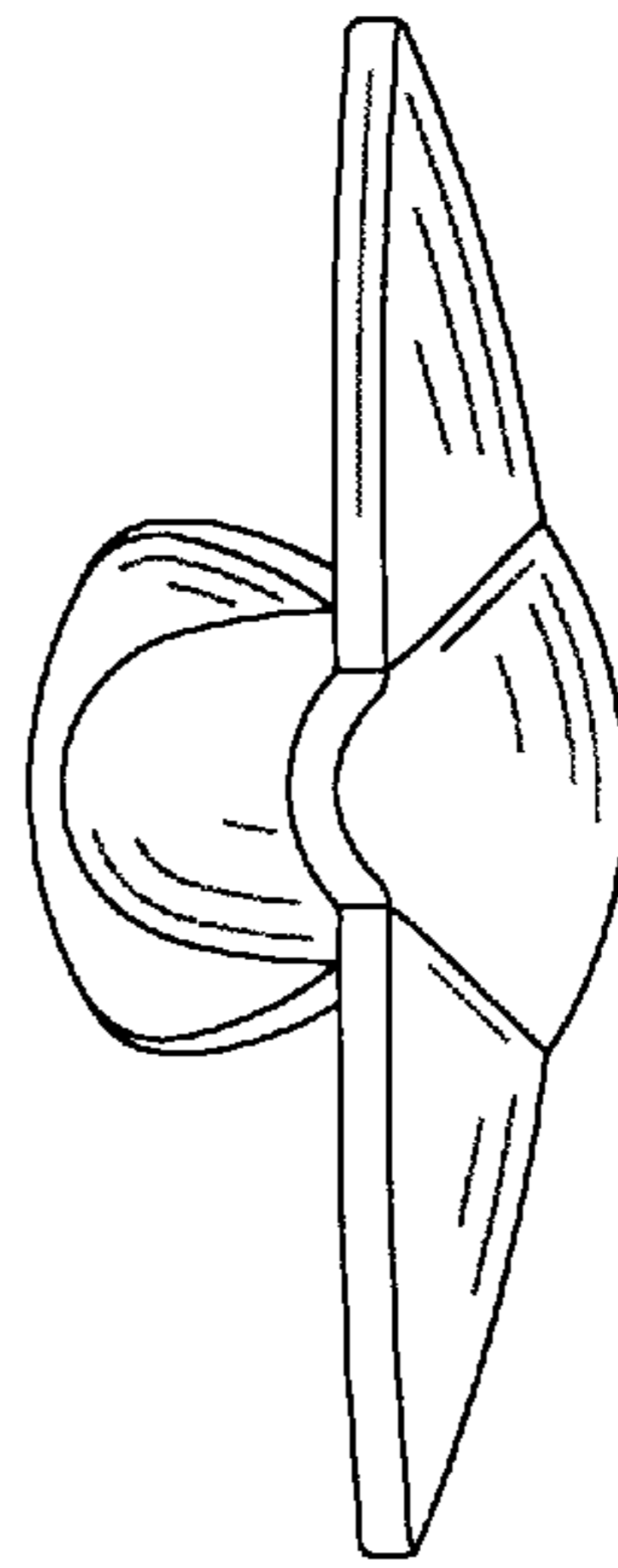

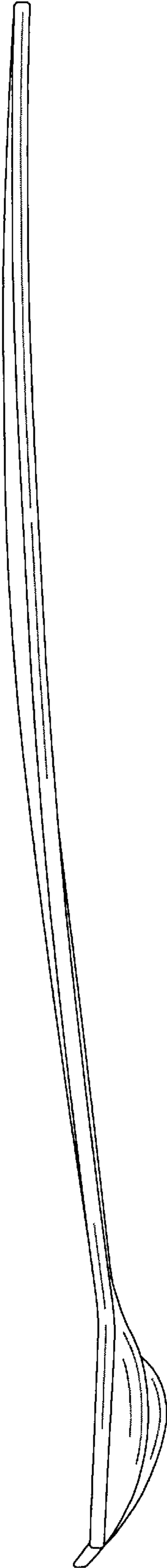

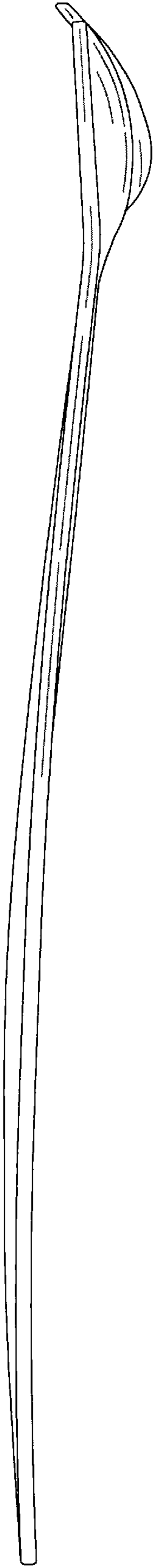

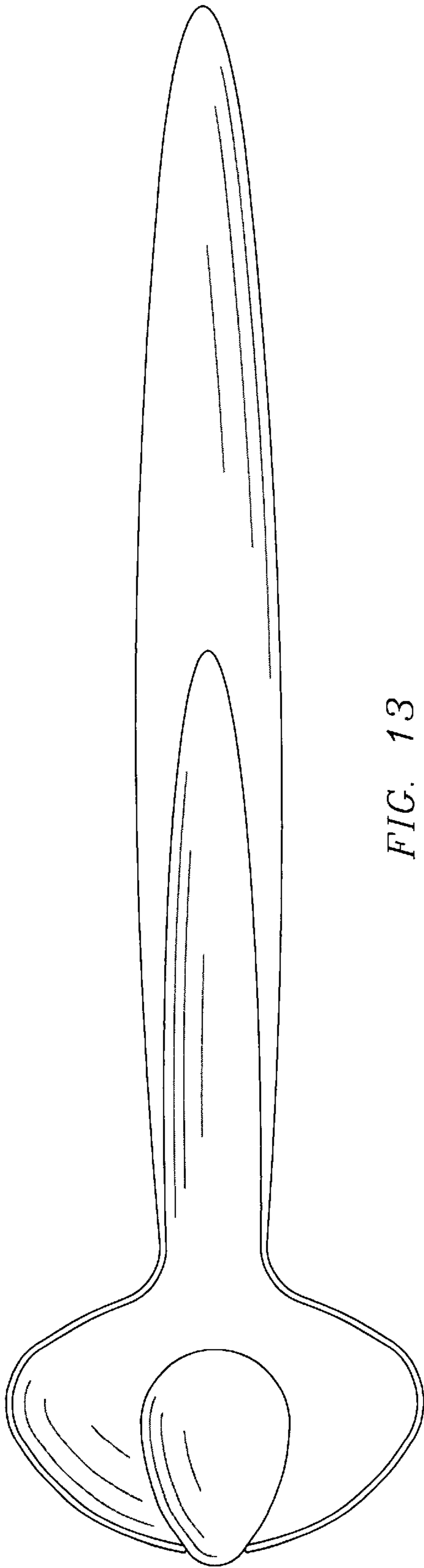

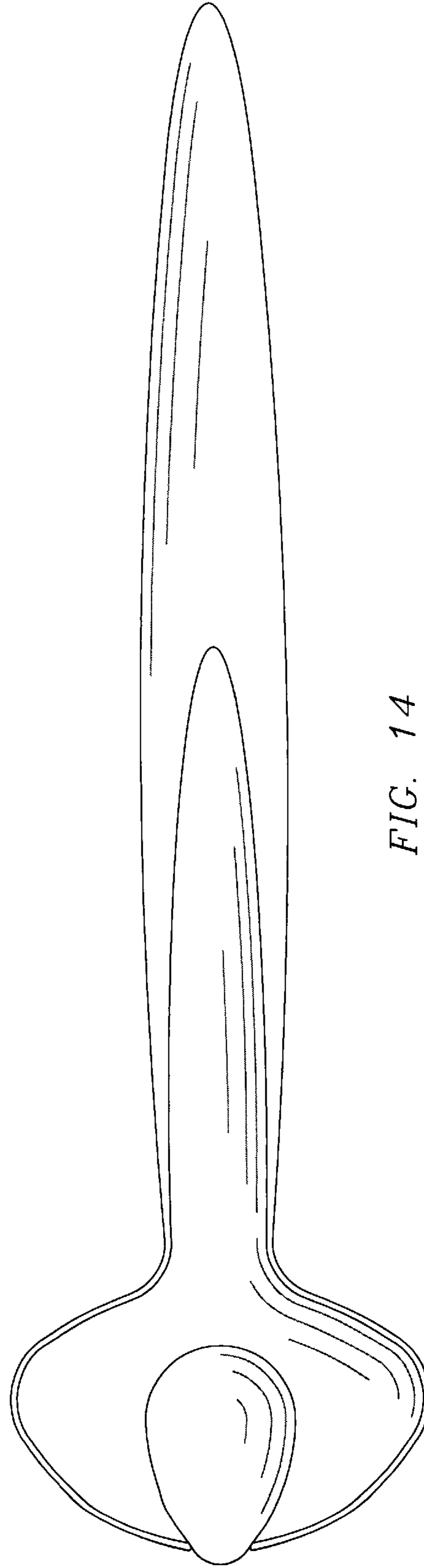
