(57) **CLAIM**

The ornamental design for the rectangular double barbed plate with fastener, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the rectangular double barbed plate with fastener of the present design; FIG. 2 is a side elevational view of the design; FIG. 3 is another side elevational view thereof; FIG. 4 is a top plan view thereof; and, FIG. 5 is a bottom perspective view thereof. The broken lines shown on the drawings are for illustrative purposes only and form no part of the claimed design.

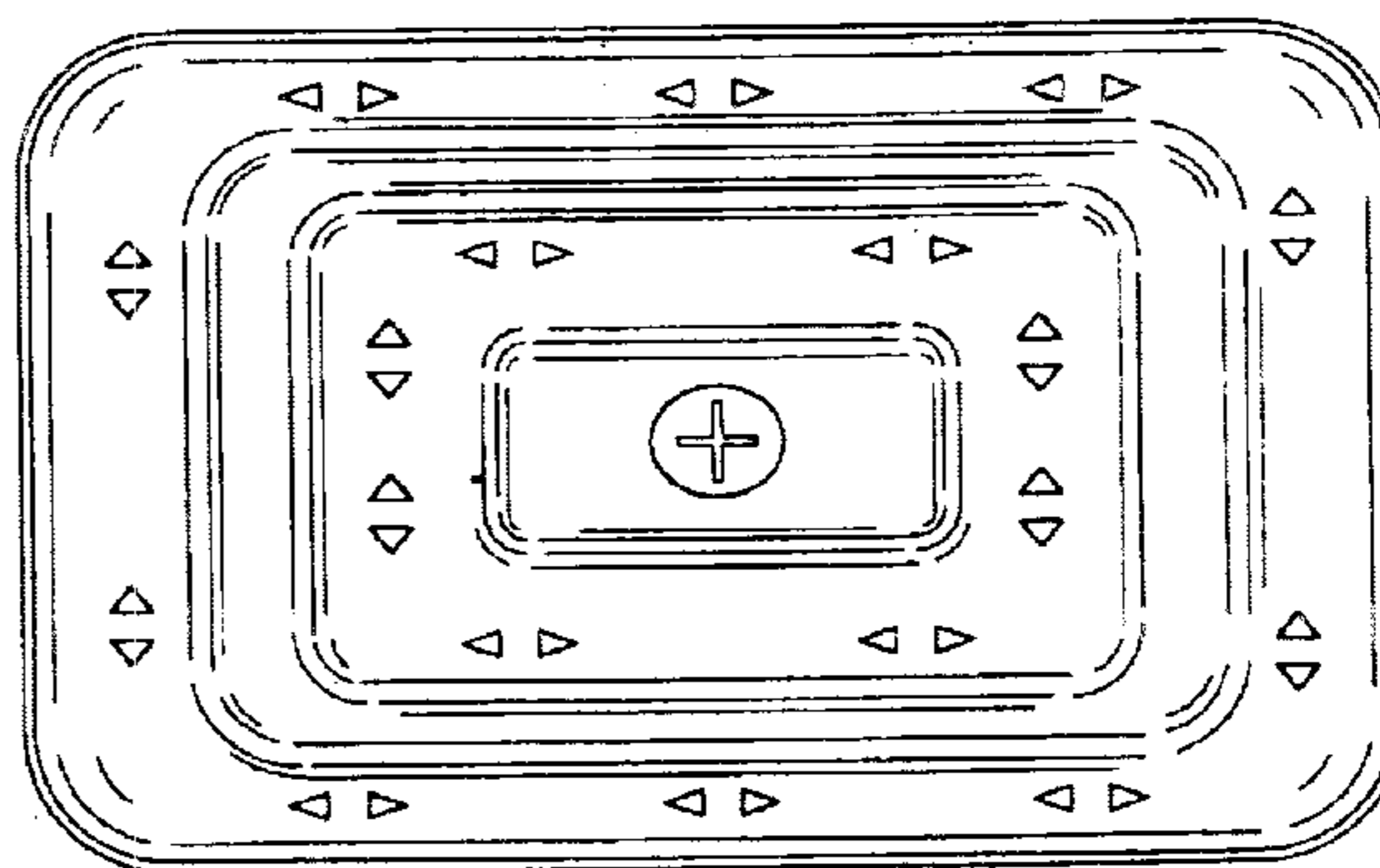
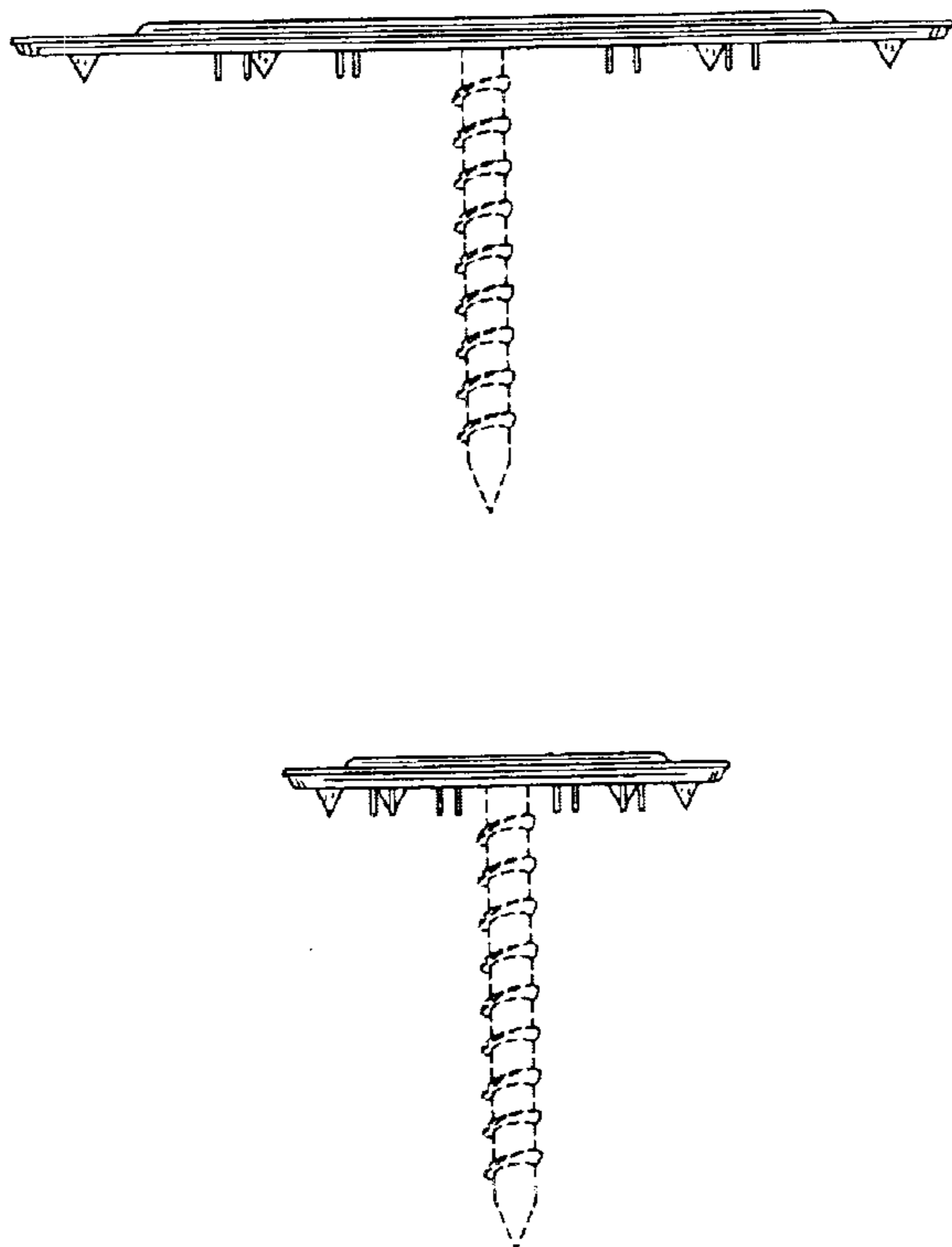

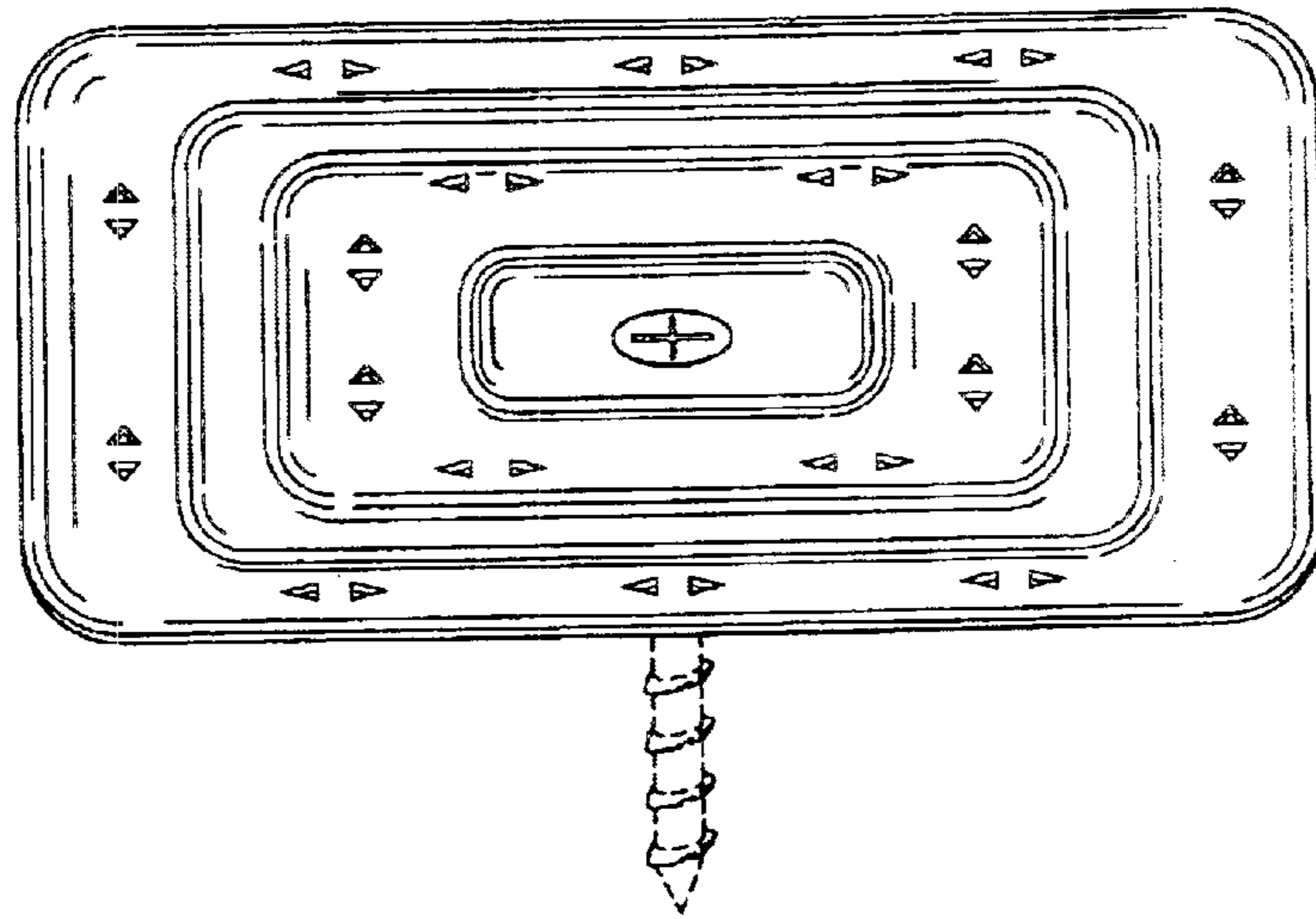

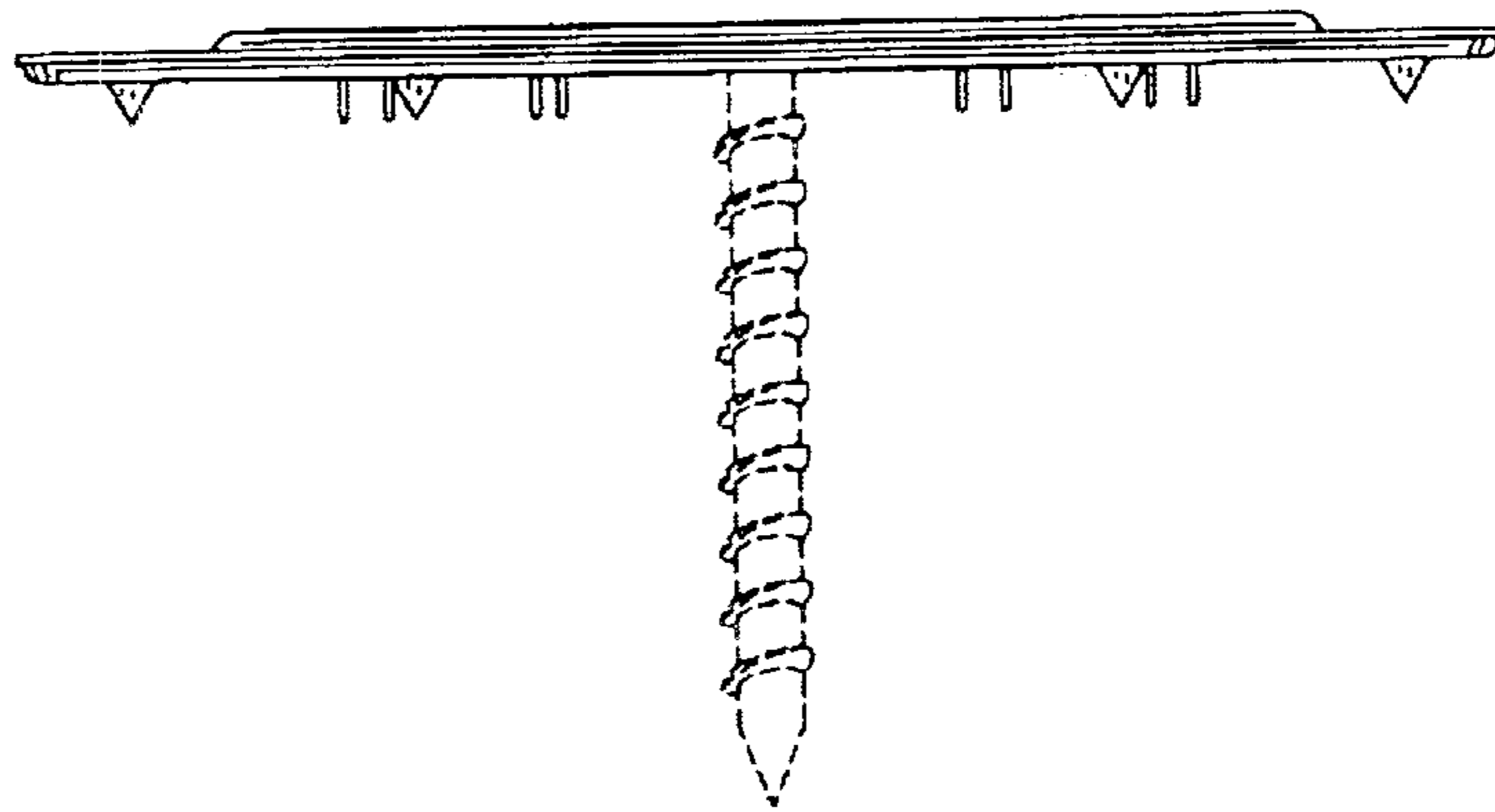

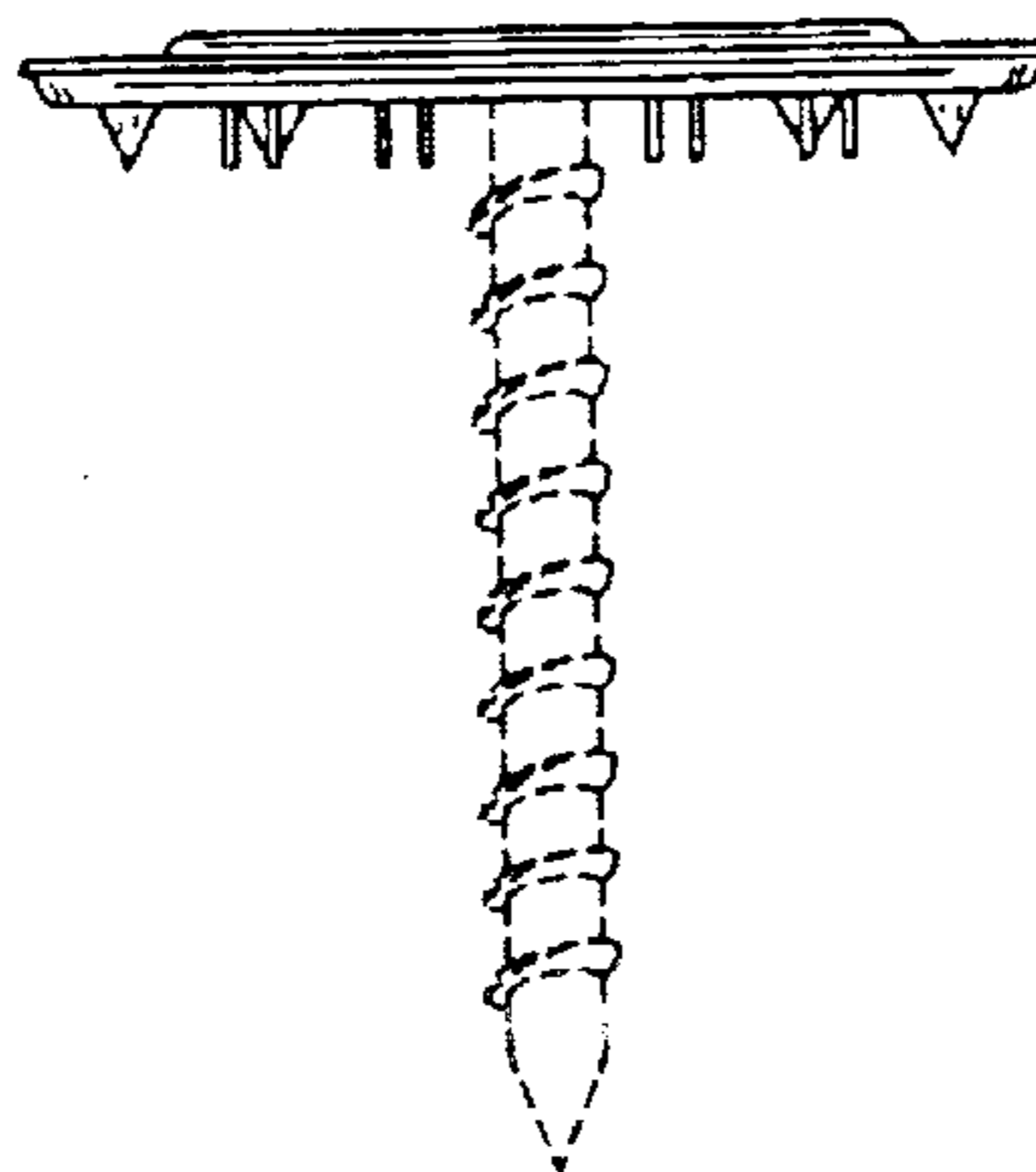

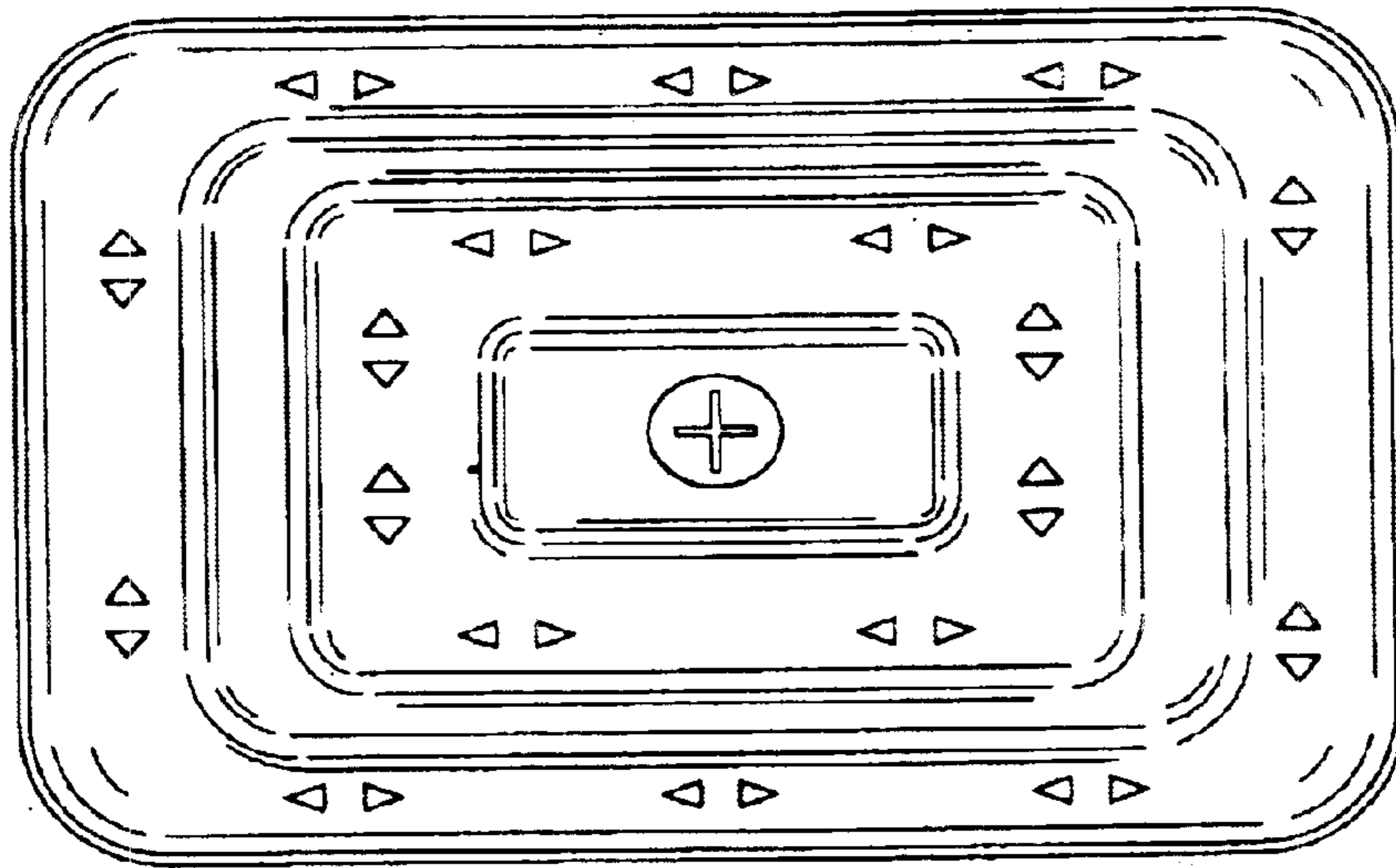
