(57) **CLAIM**

The ornamental design for feather bow, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of the feather bow showing our new design which shows in dotted lines the approximate size of a typical center ornament which will normally be added;

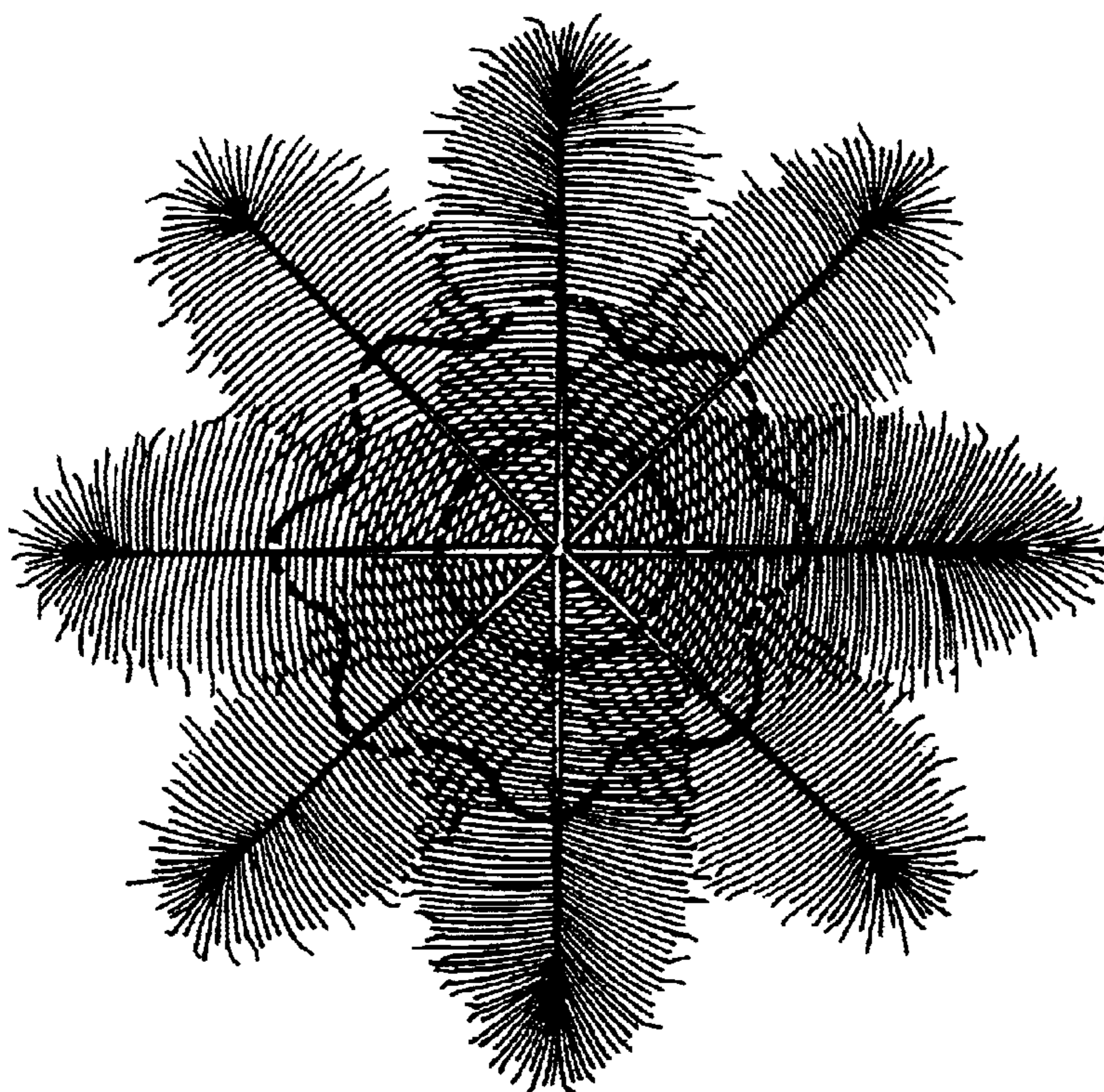
FIG. 2 is a left elevational view thereof with the right elevational view being identical;

FIG. 3 is a top plan view thereof with the bottom view being identical; and,

FIG. 4 is a rear elevational view thereof.

The broken line showing of the center ornament in FIG. 1 is for illustrative purposes only and forms no part of the claimed design.

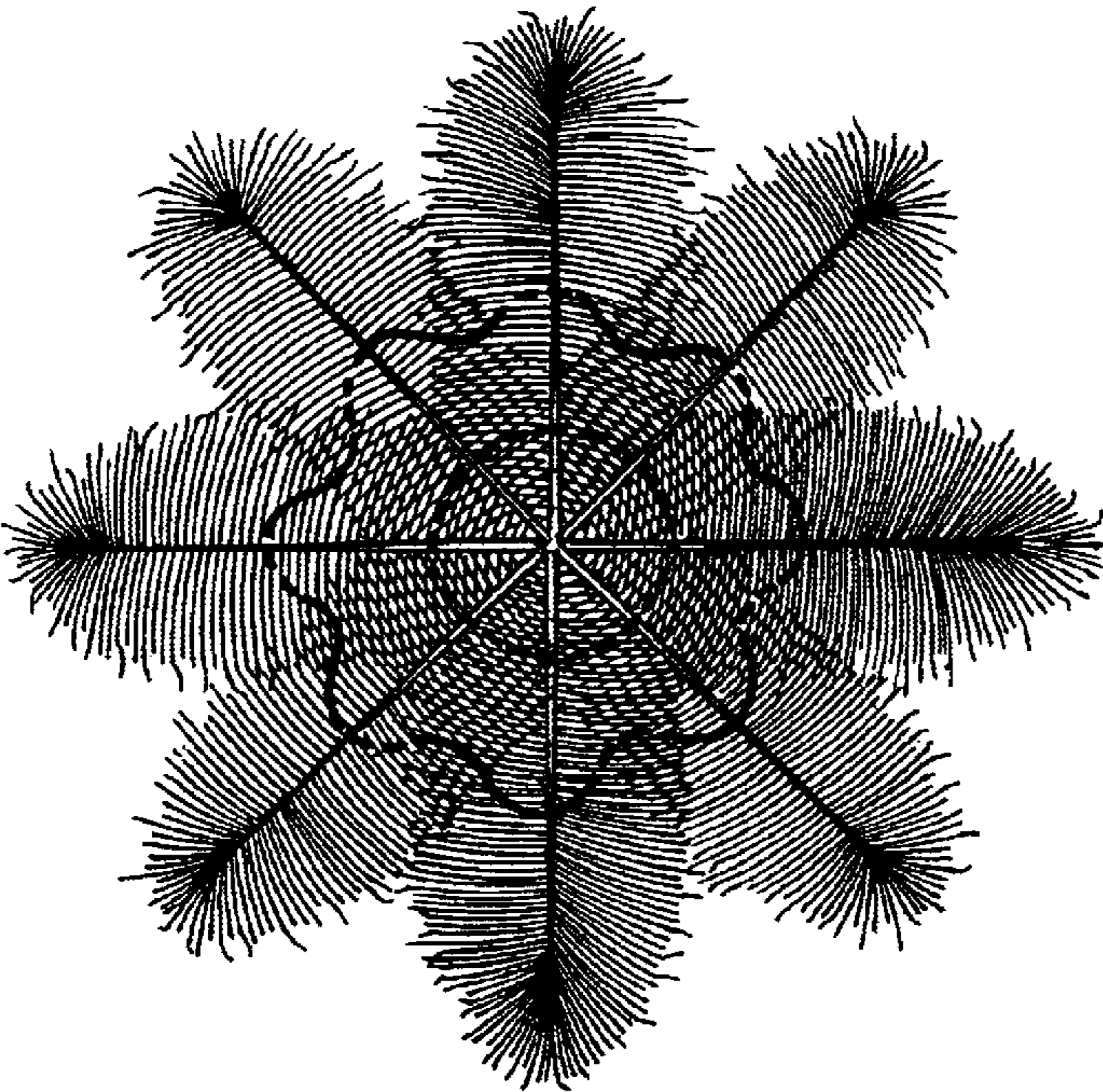

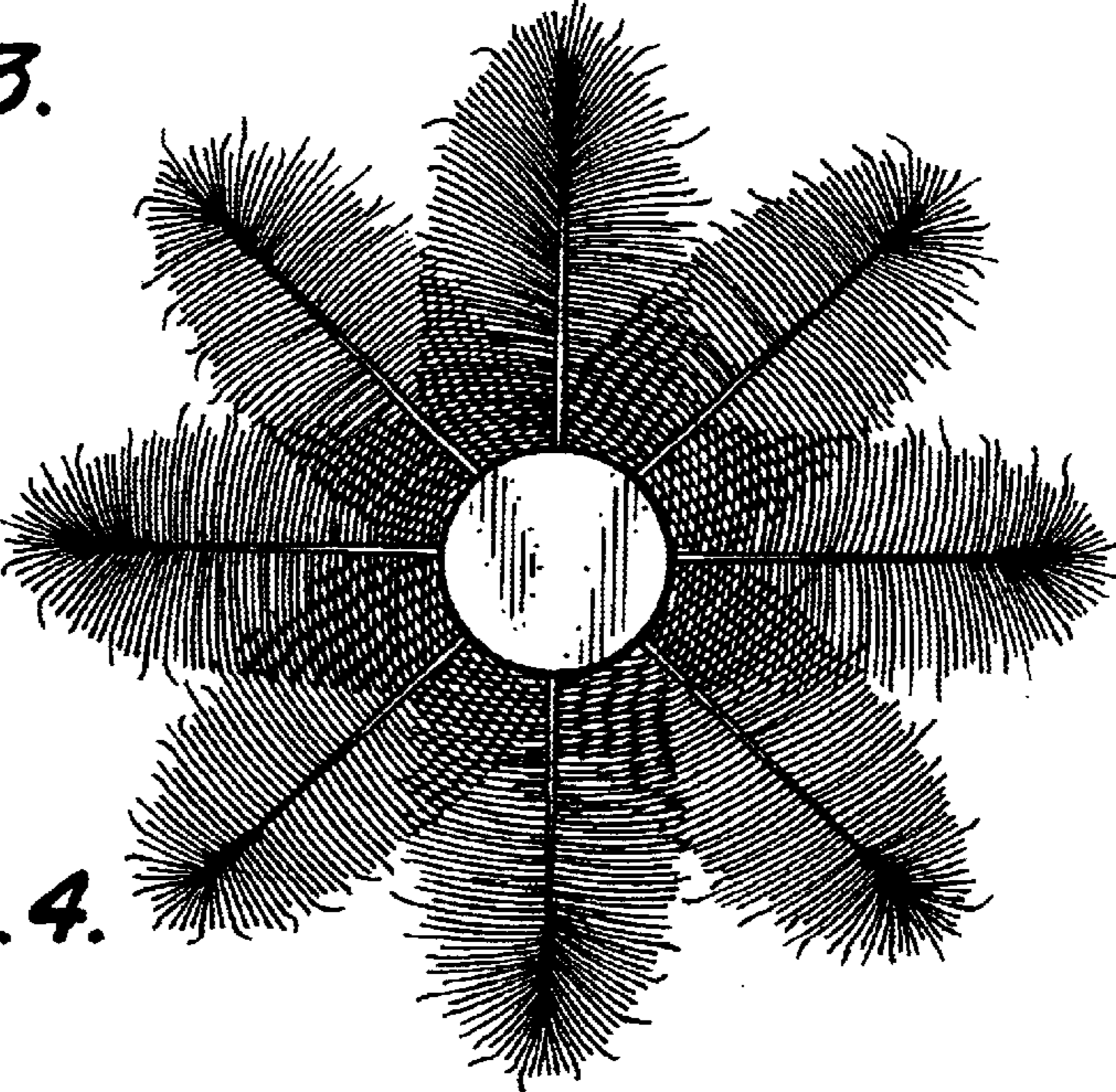
