FIG. 1 is a front view of the cell phone according to the subject invention.

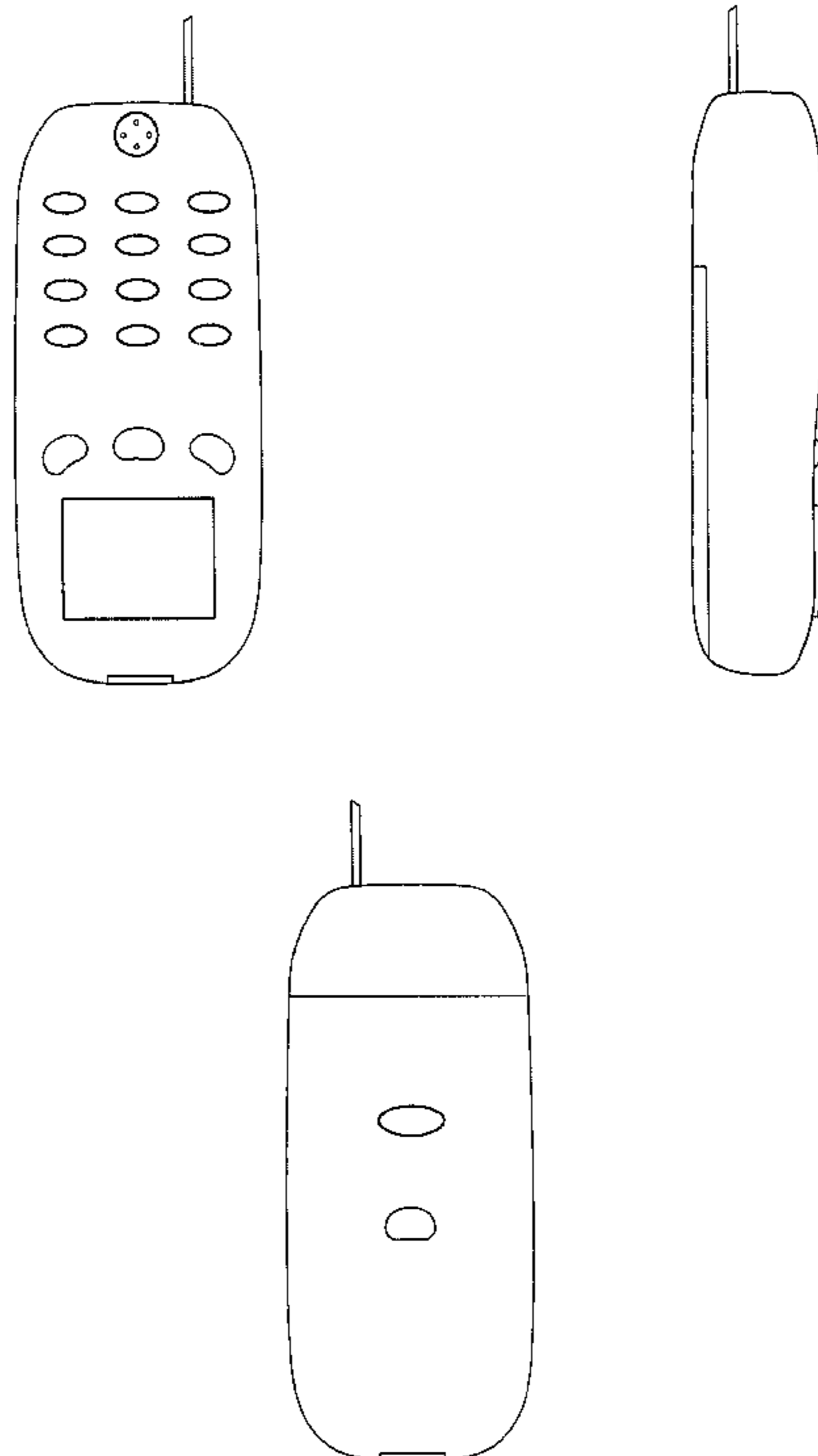
FIG. 2 is a side view of the cell phone in FIG. 1.

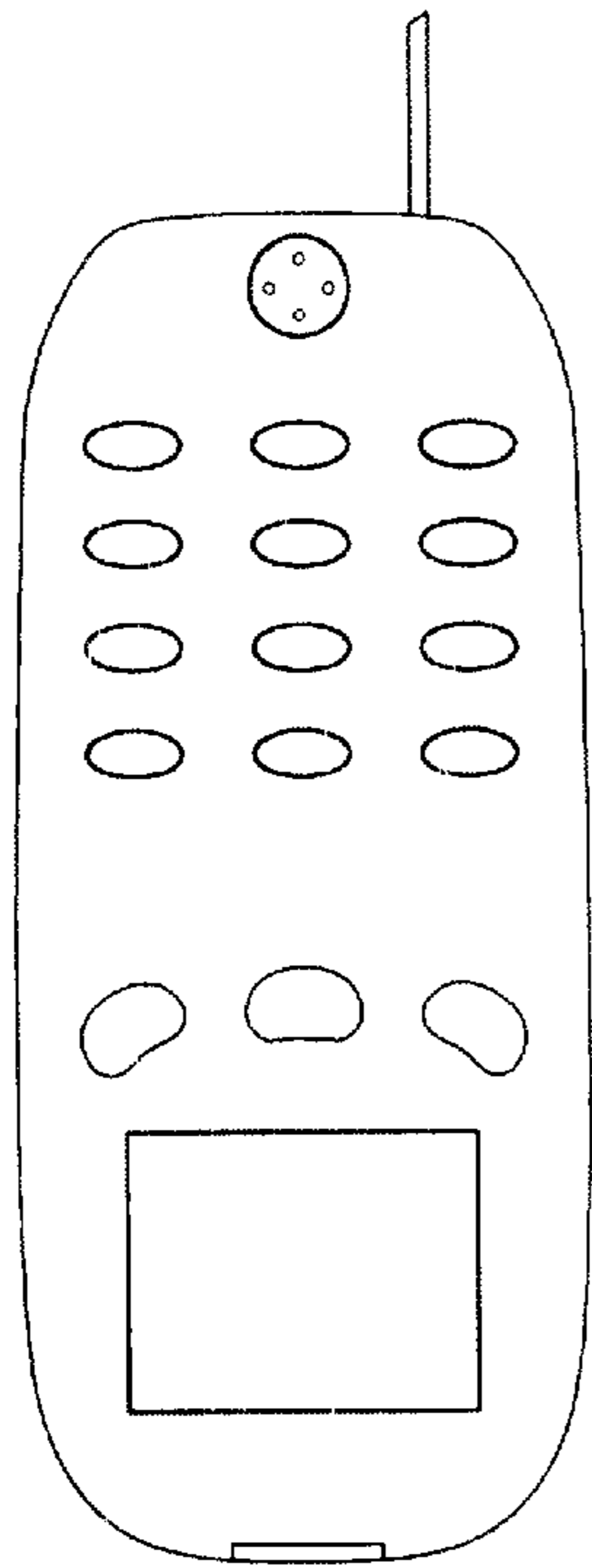

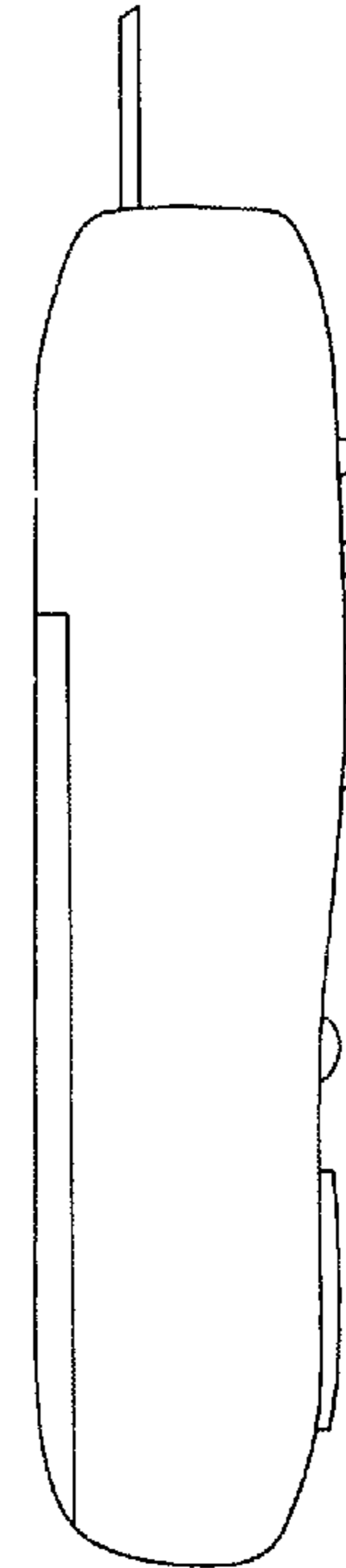

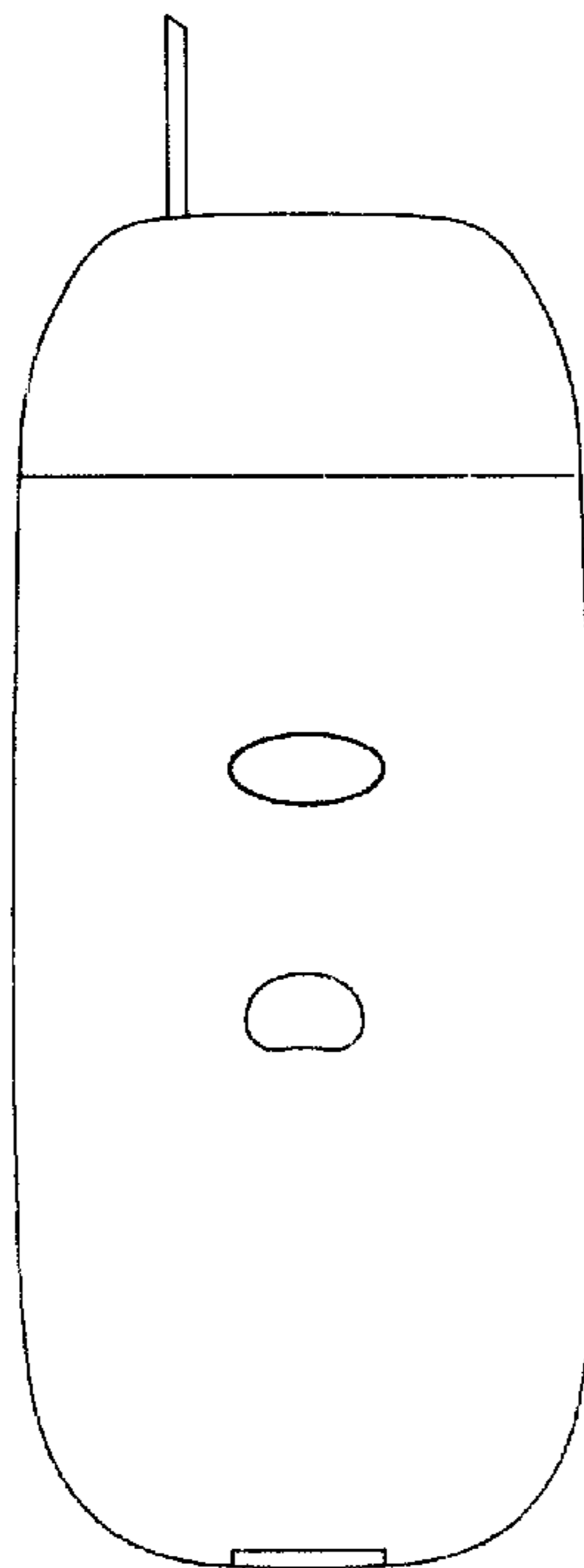

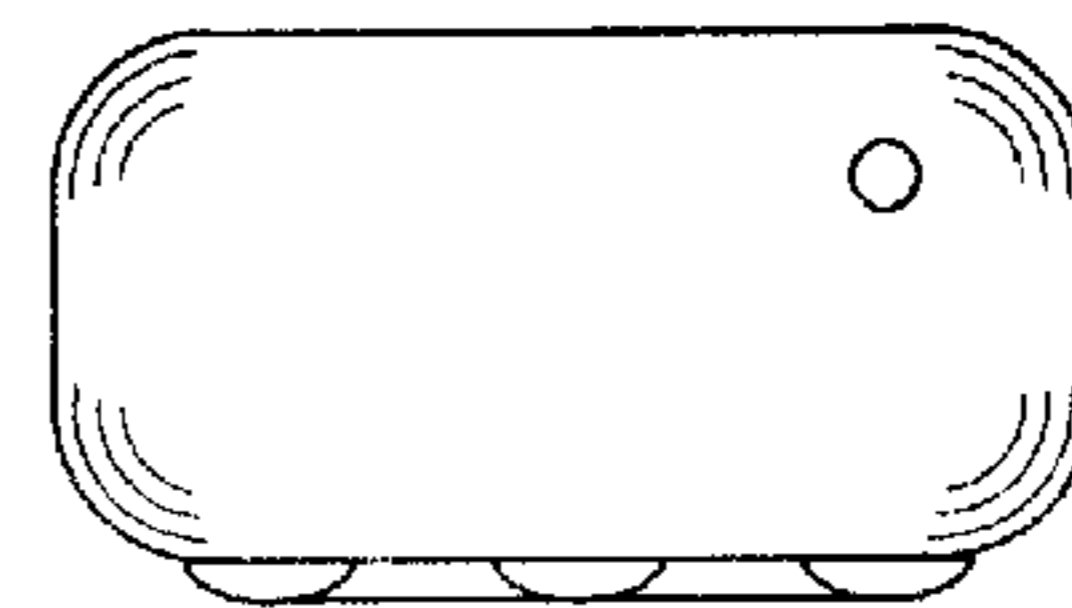

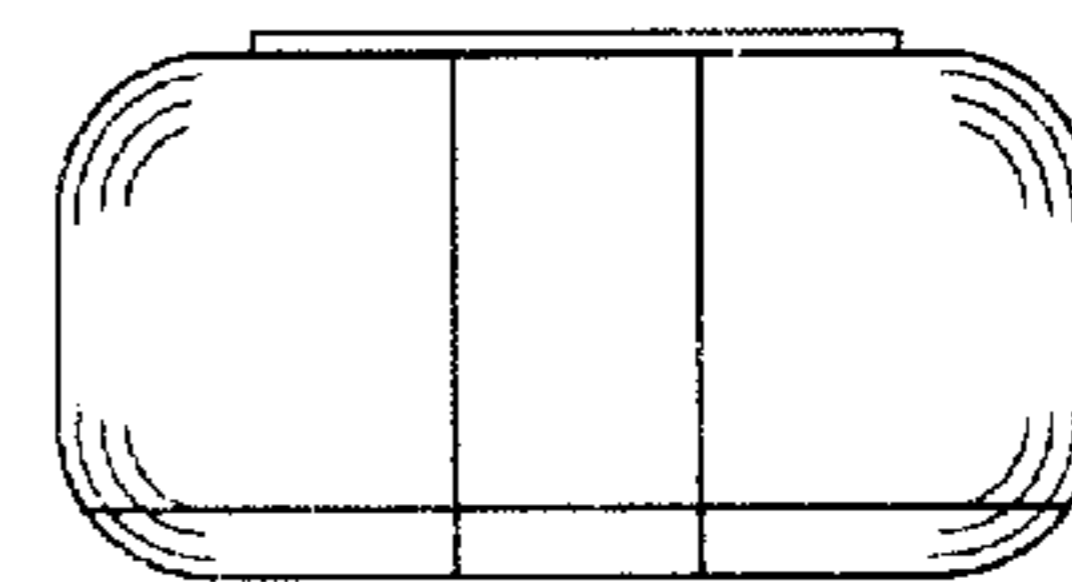
