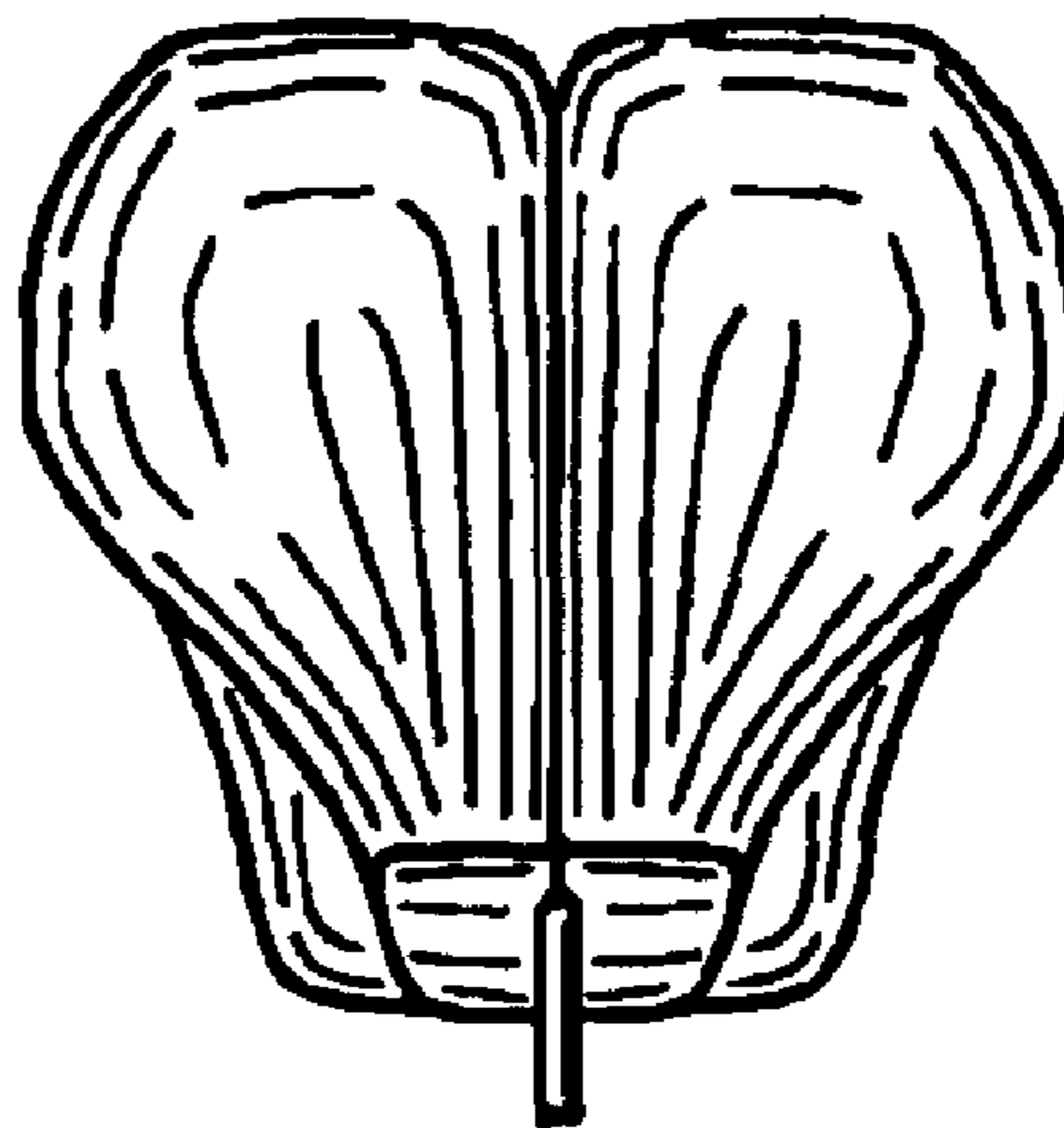
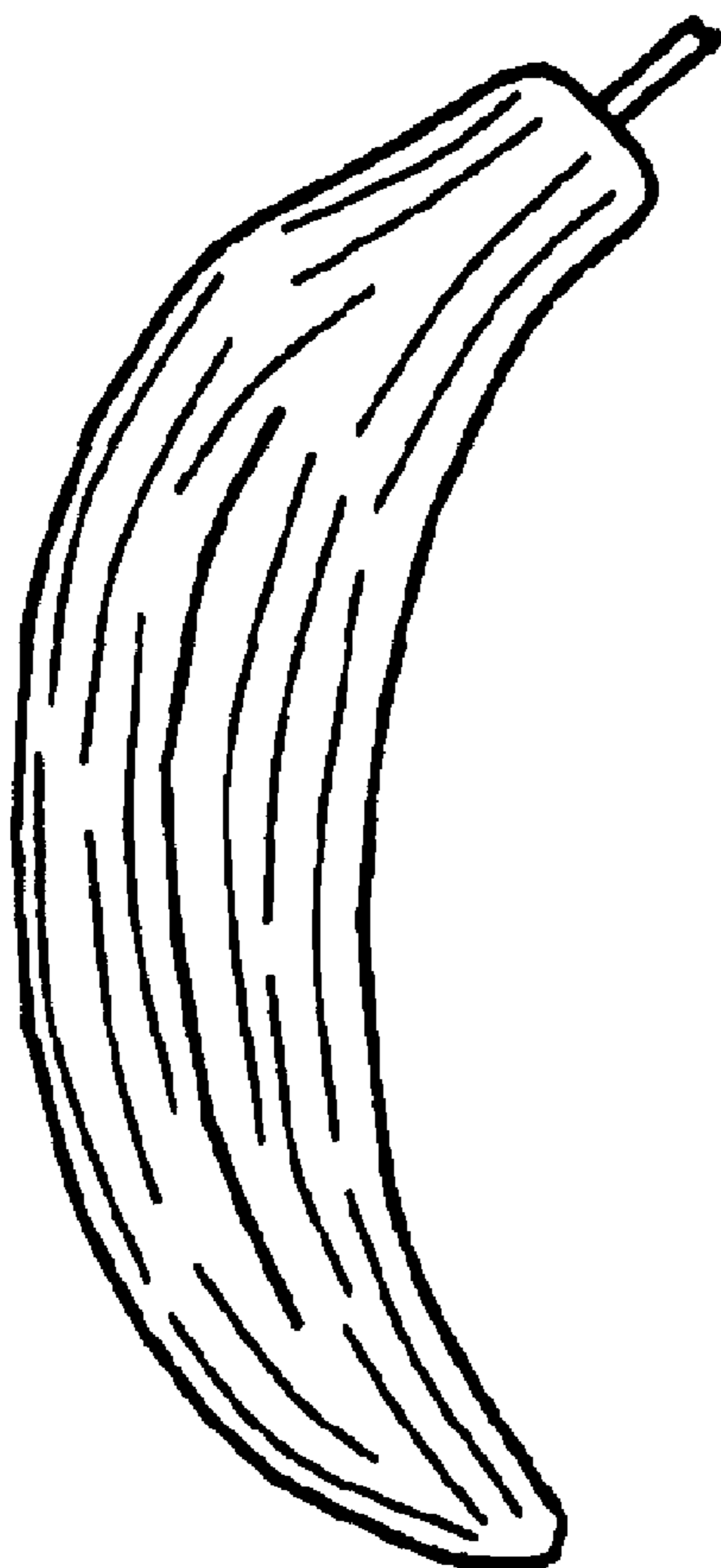
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front view of a vibrator, showing my new design.  
 FIG. 2 is a back view thereof.  
 FIG. 3 is a side view thereof, rotated 90° from that shown in FIG. 1.  
 FIG. 4 is a side view thereof, rotated 180° from that shown in FIG. 3.

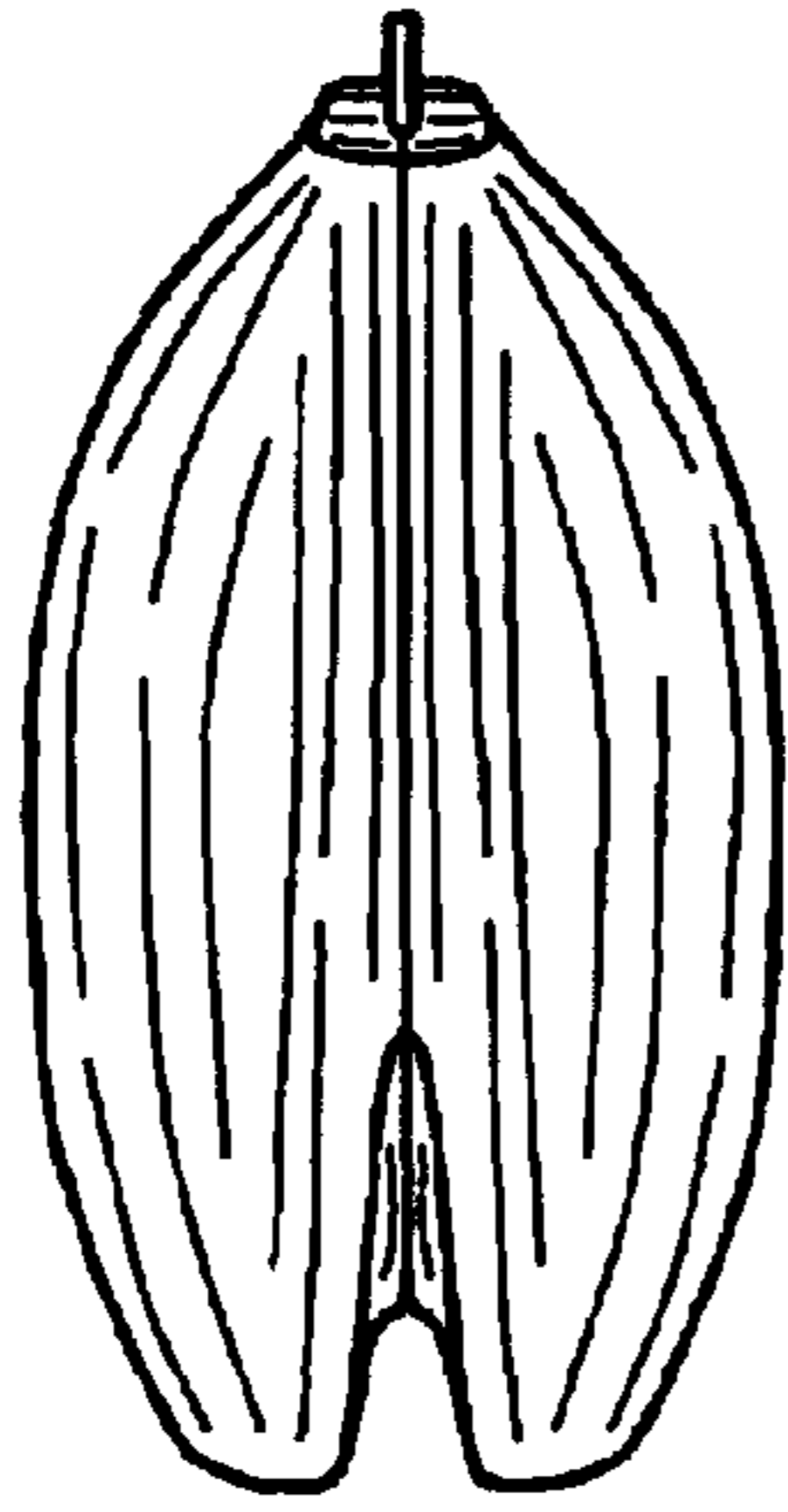

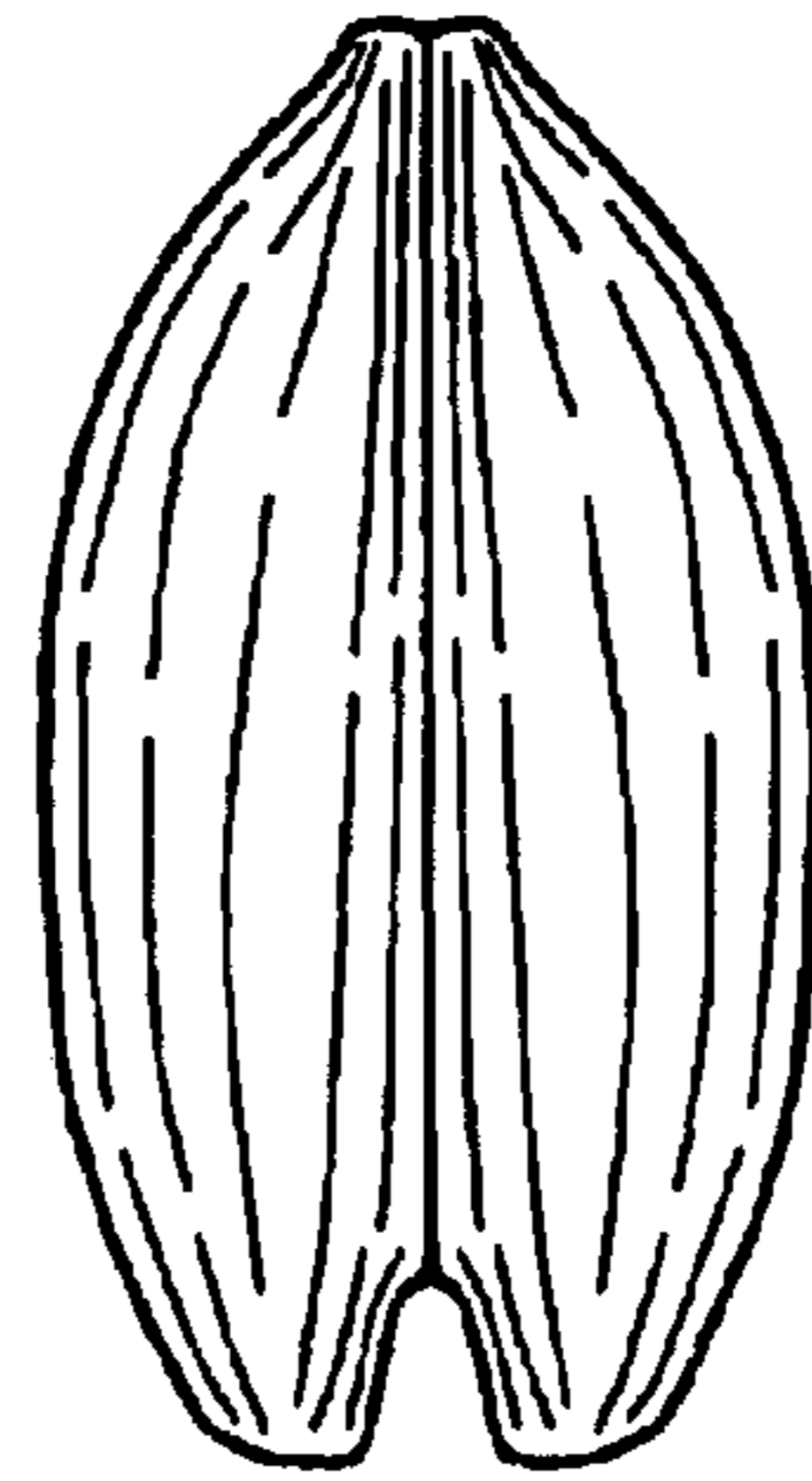

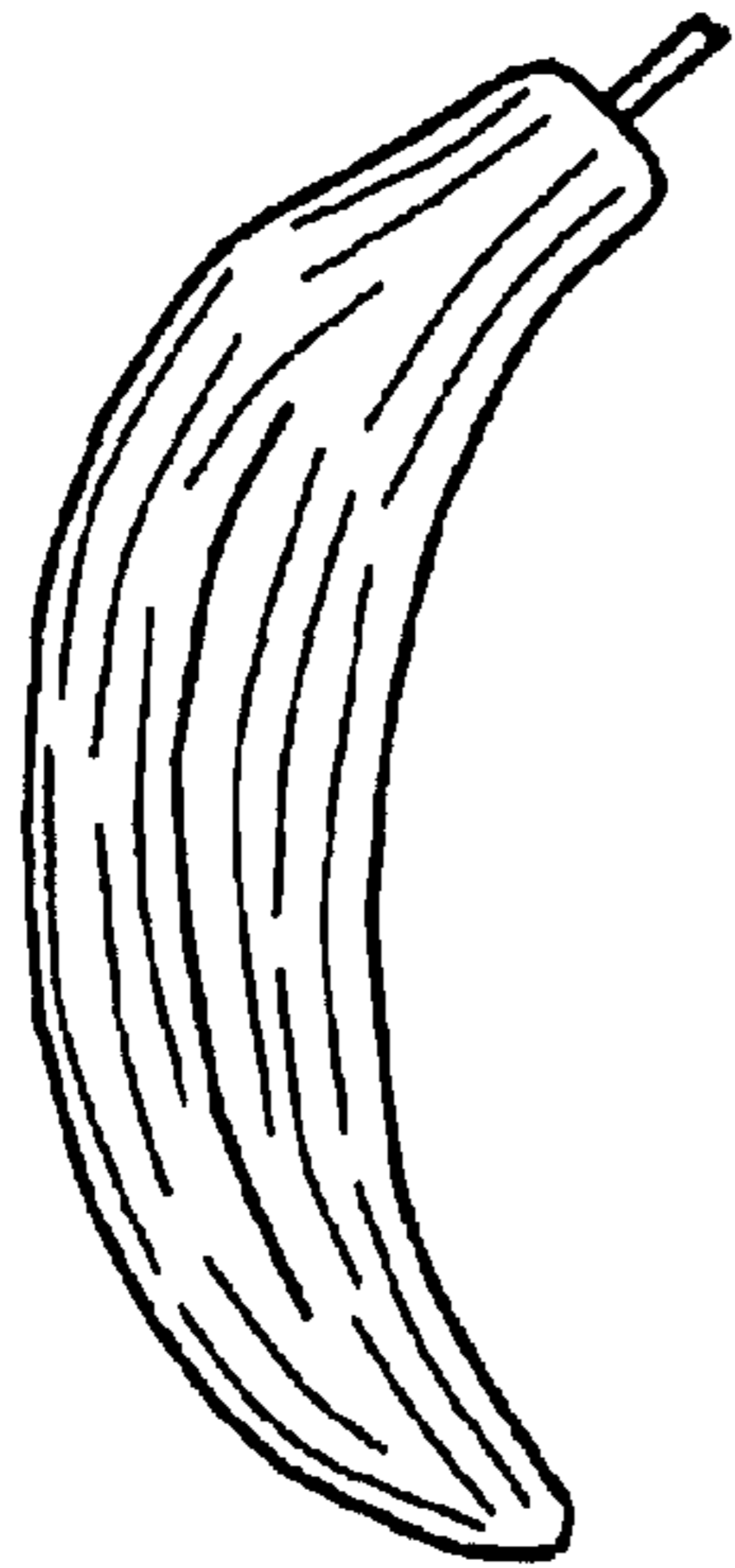

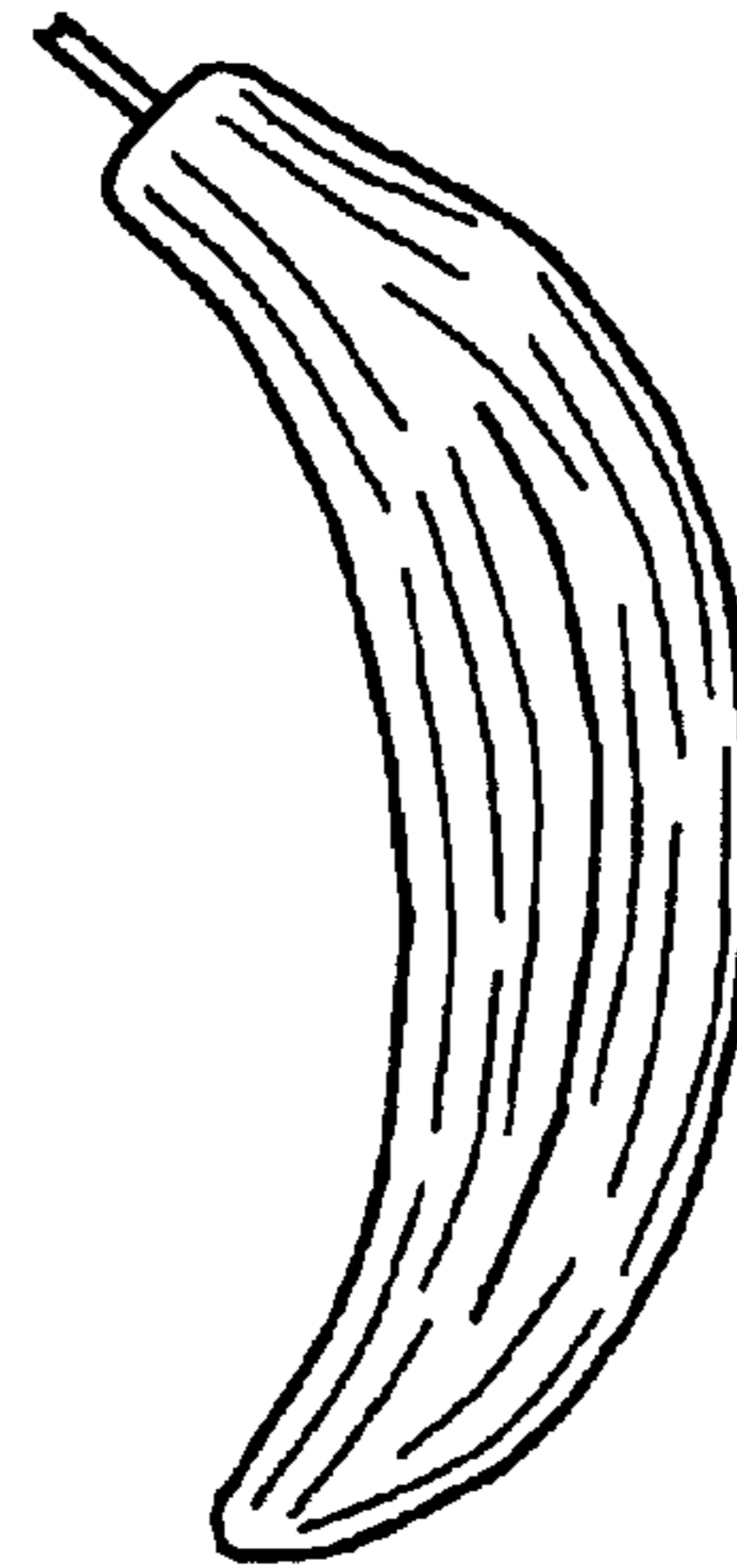

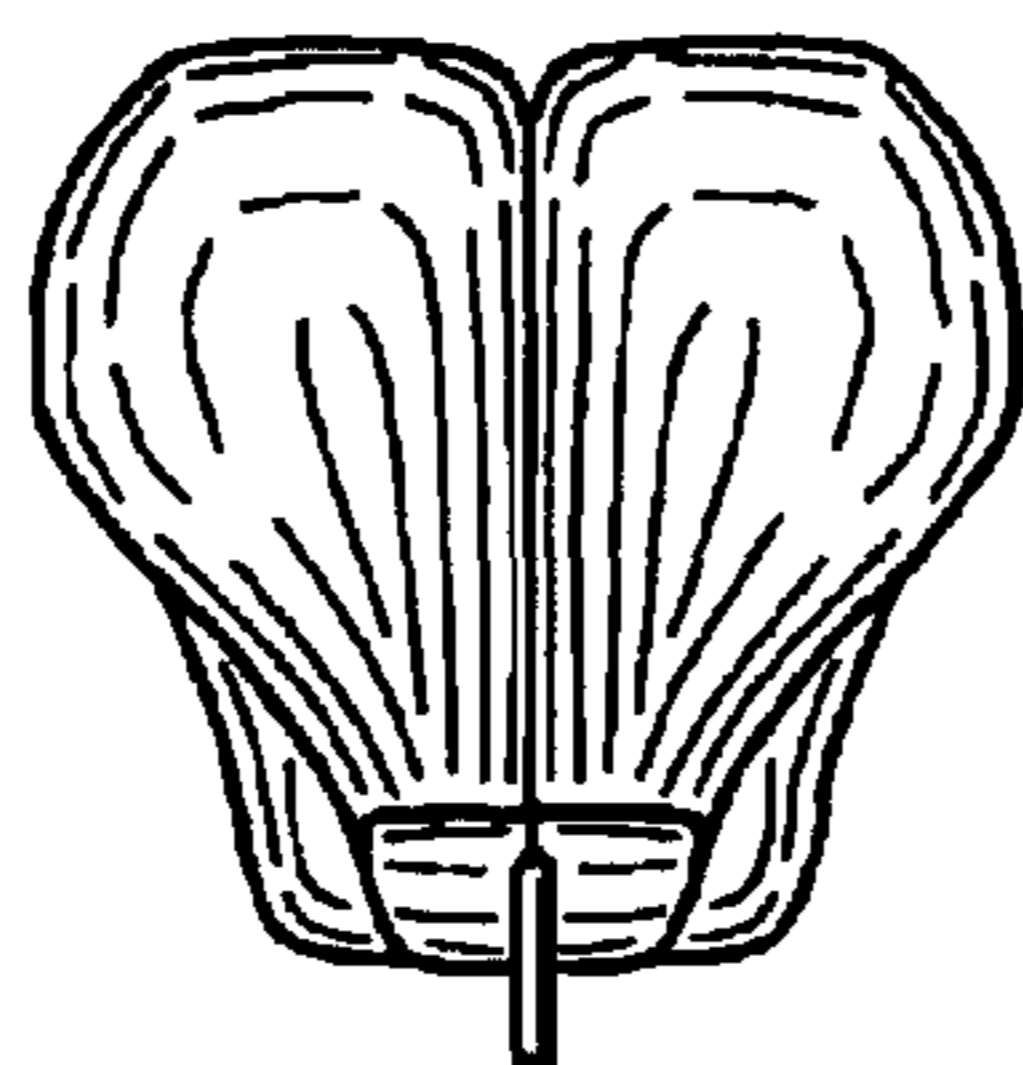

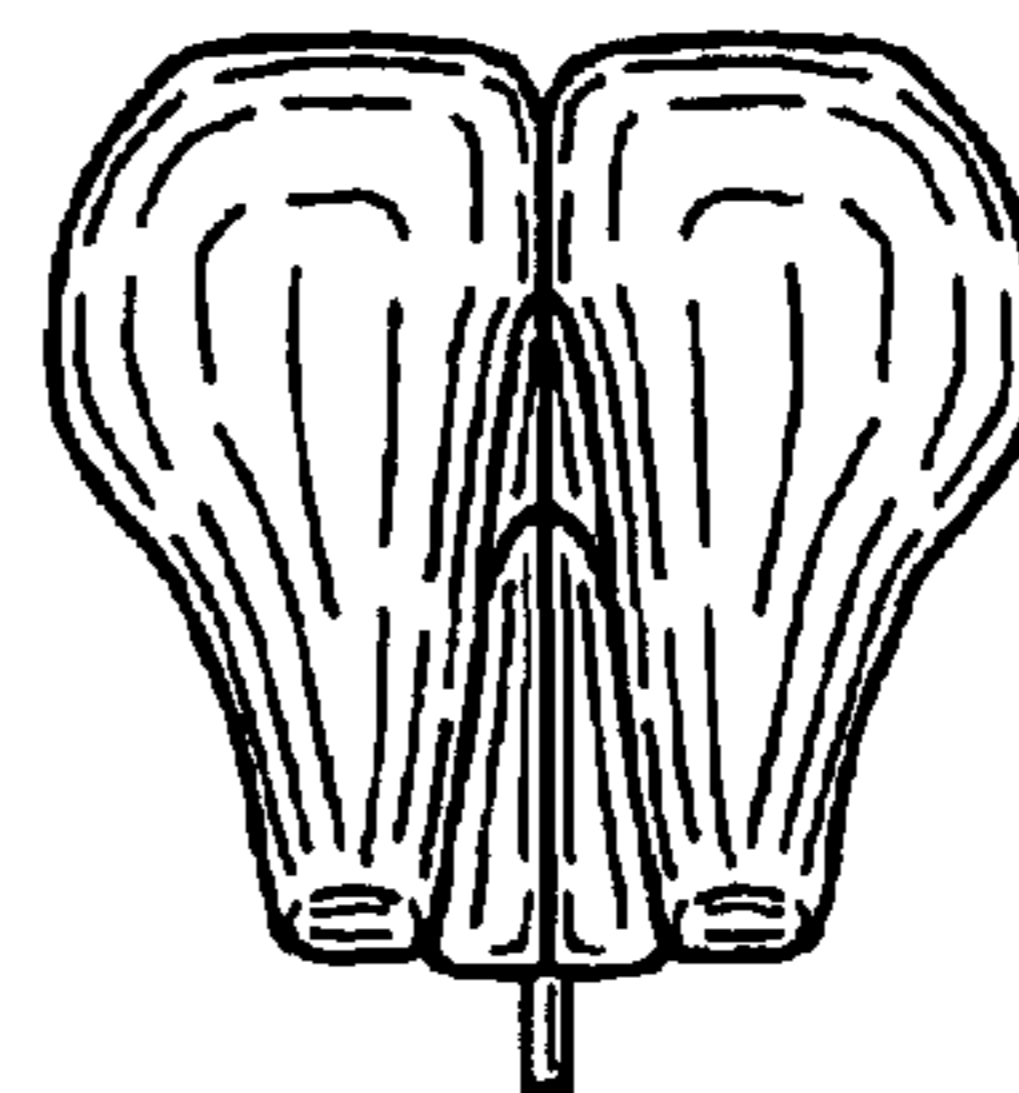
