FIG. 3 is a top view of our new design;

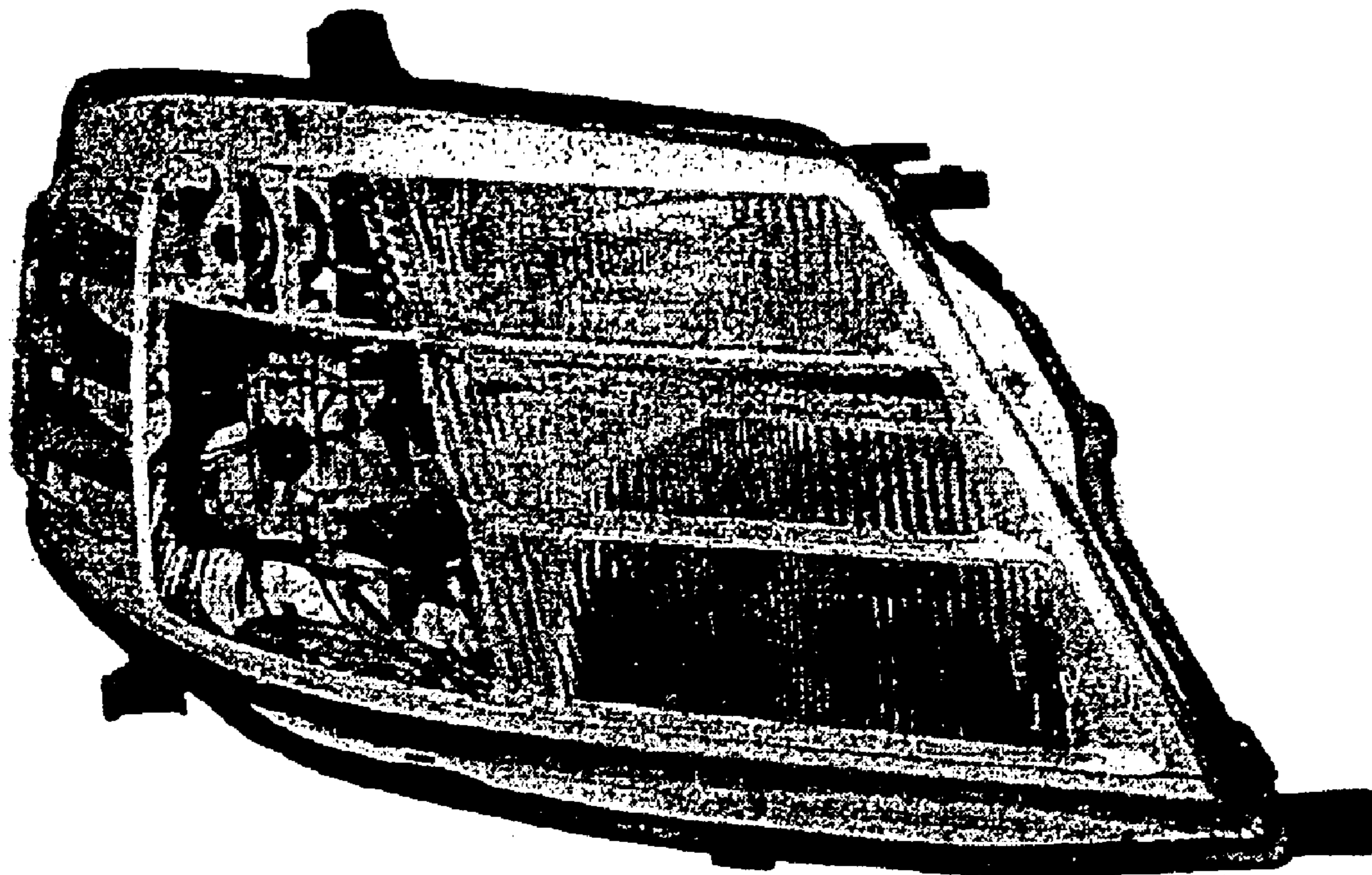
FIG. 4 is a bottom view of our new design;

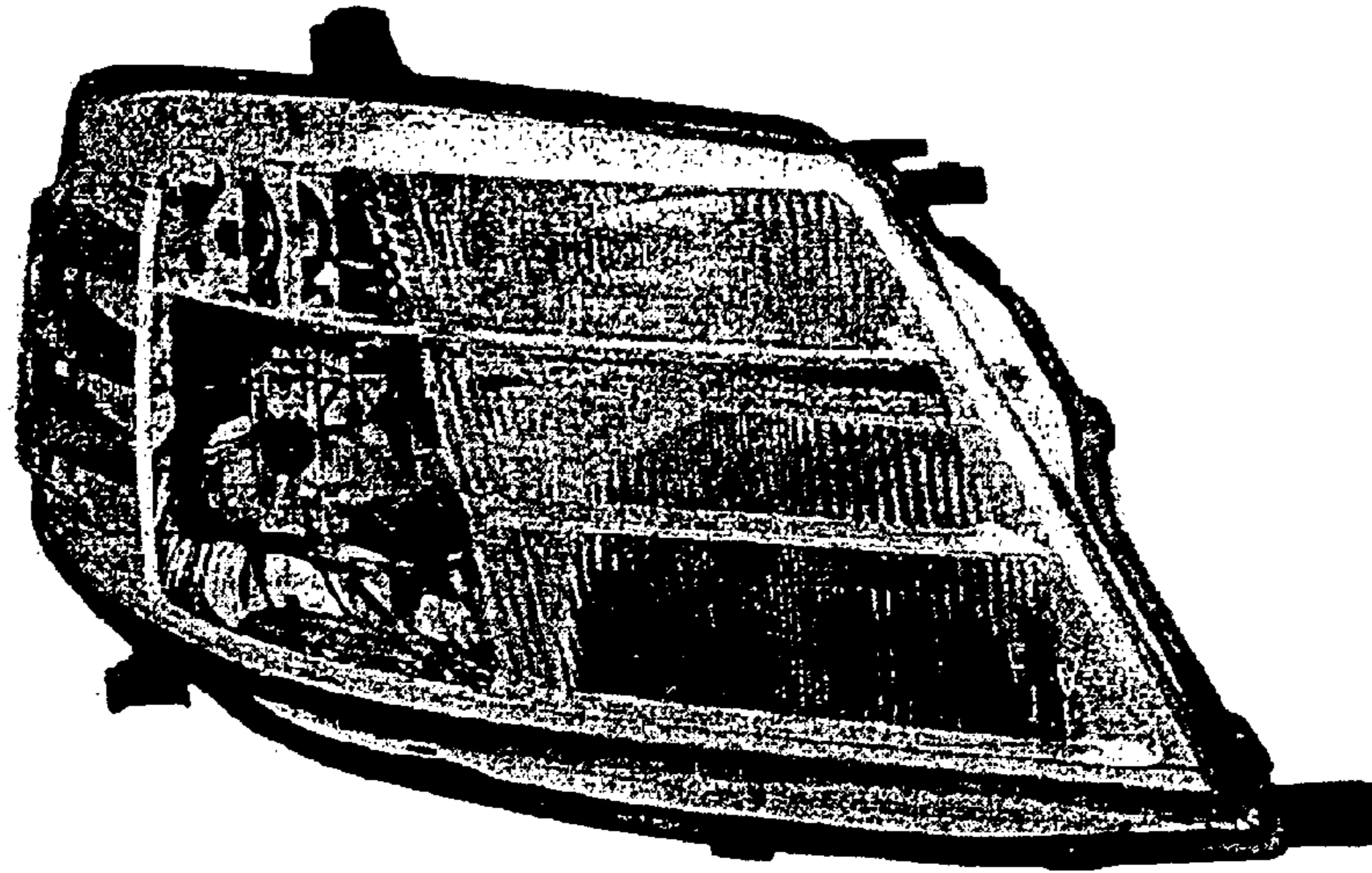
FIG. 5 is a left-side view of our new design; and,

FIG. 6 is a right-side rear view of our new design.

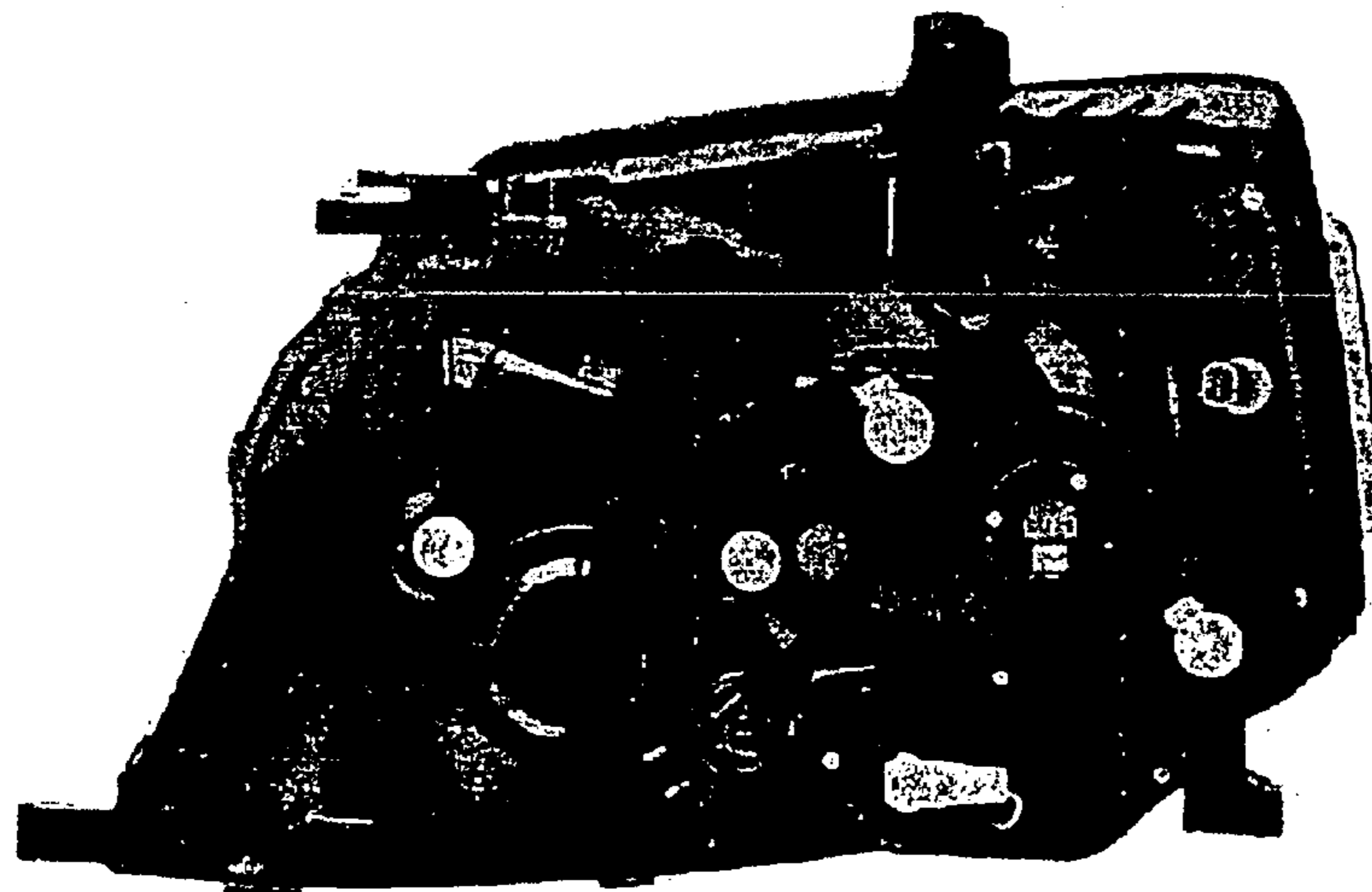

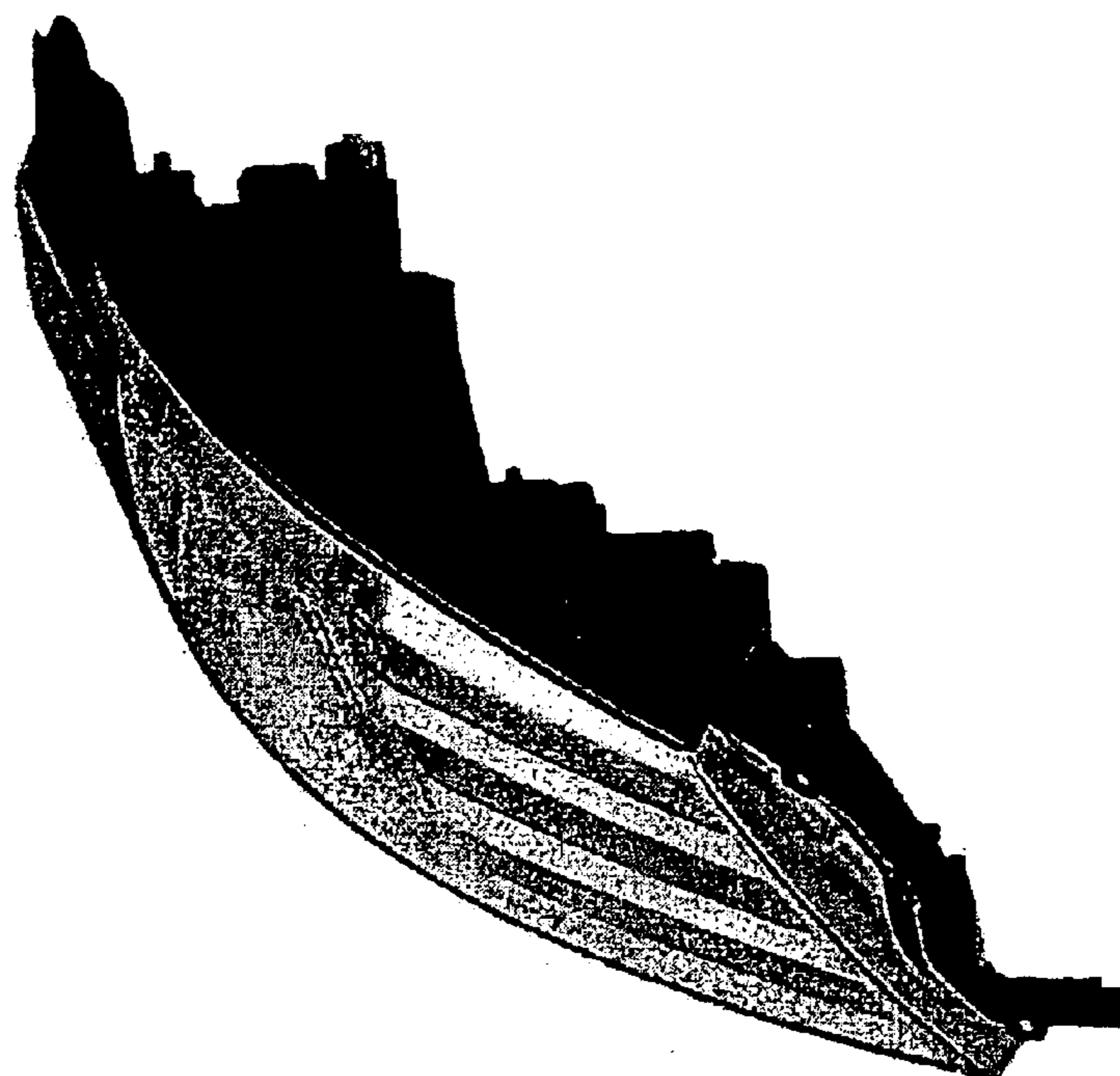




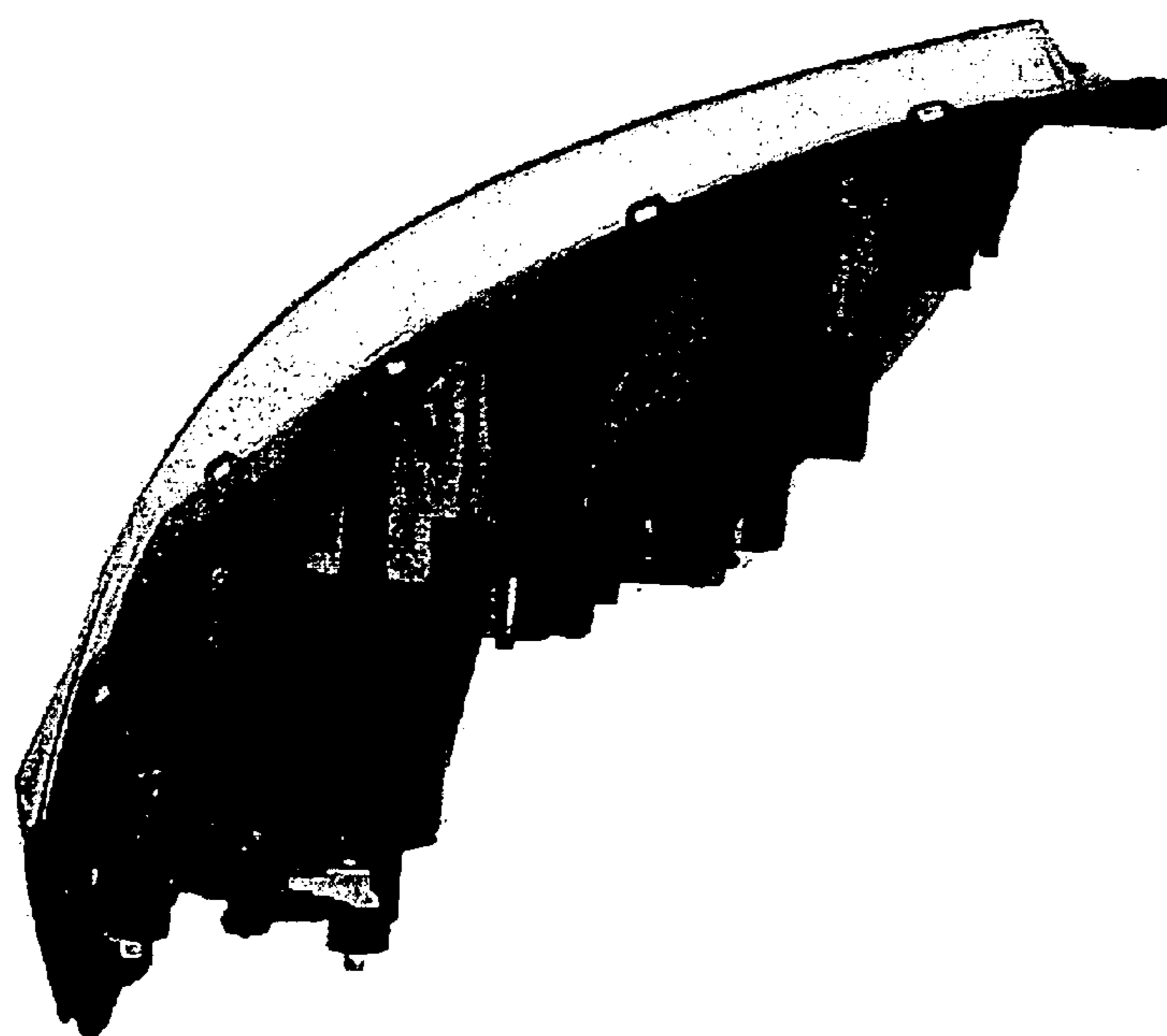

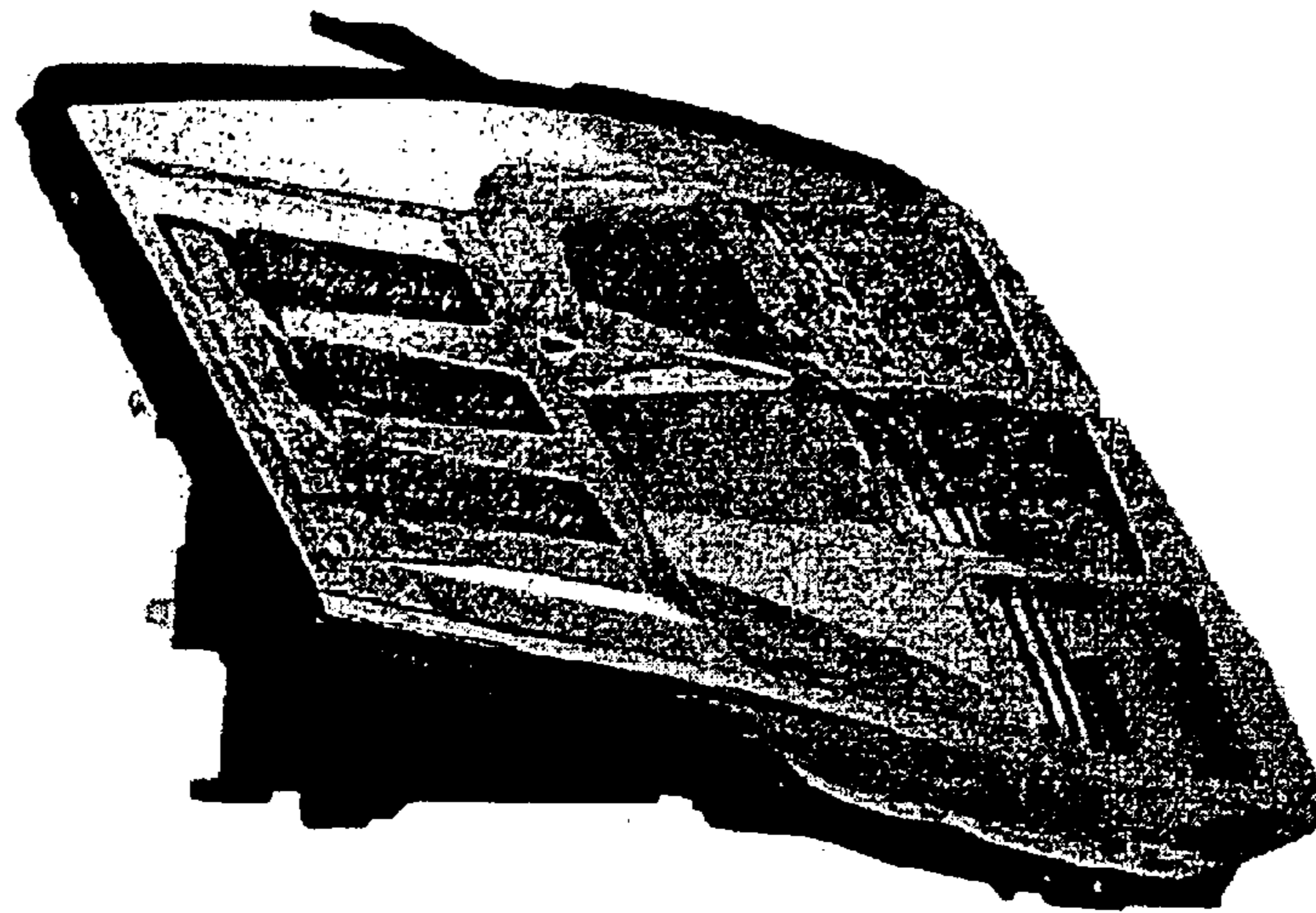

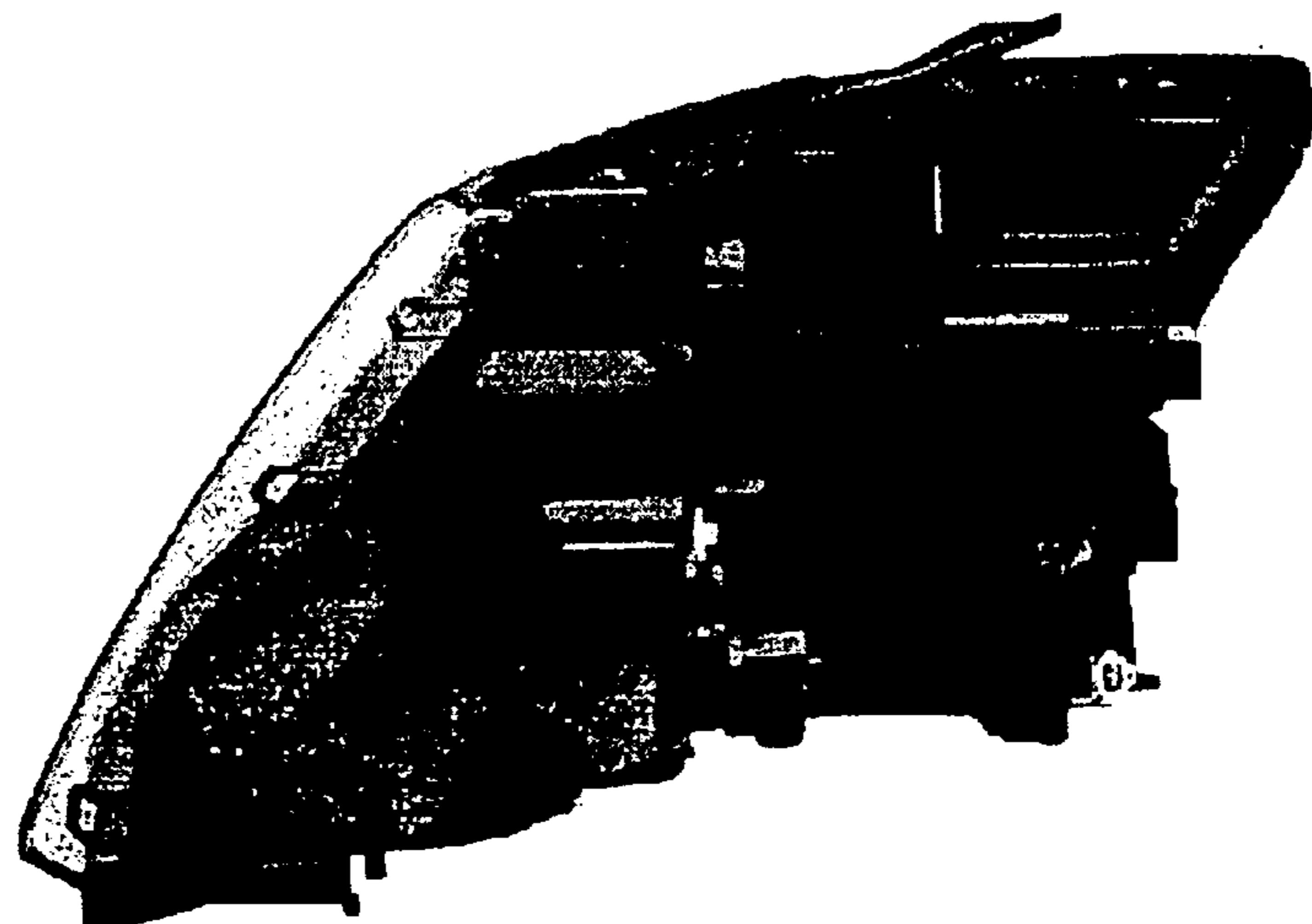

FIG. 3 is a top view of our new design;

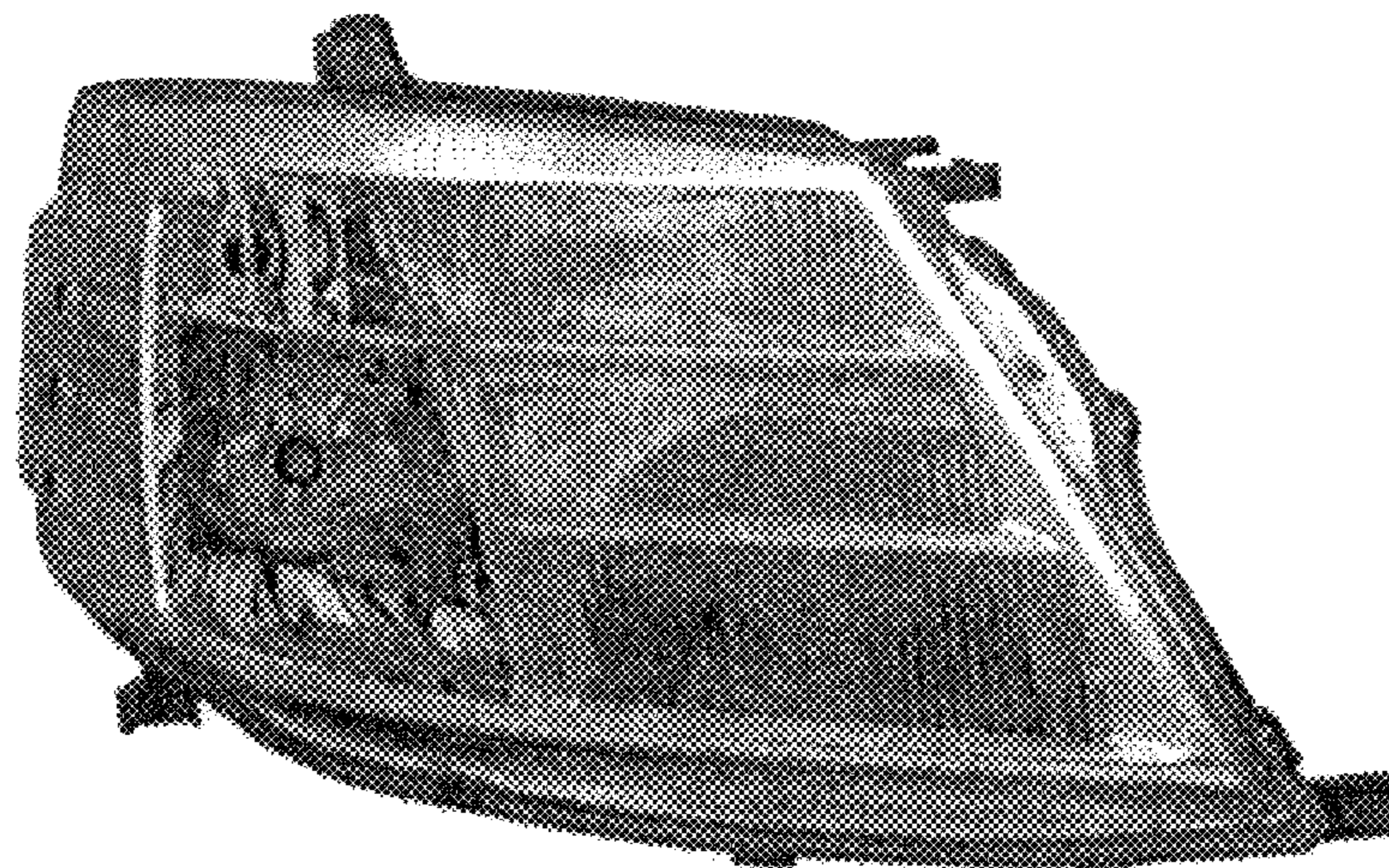

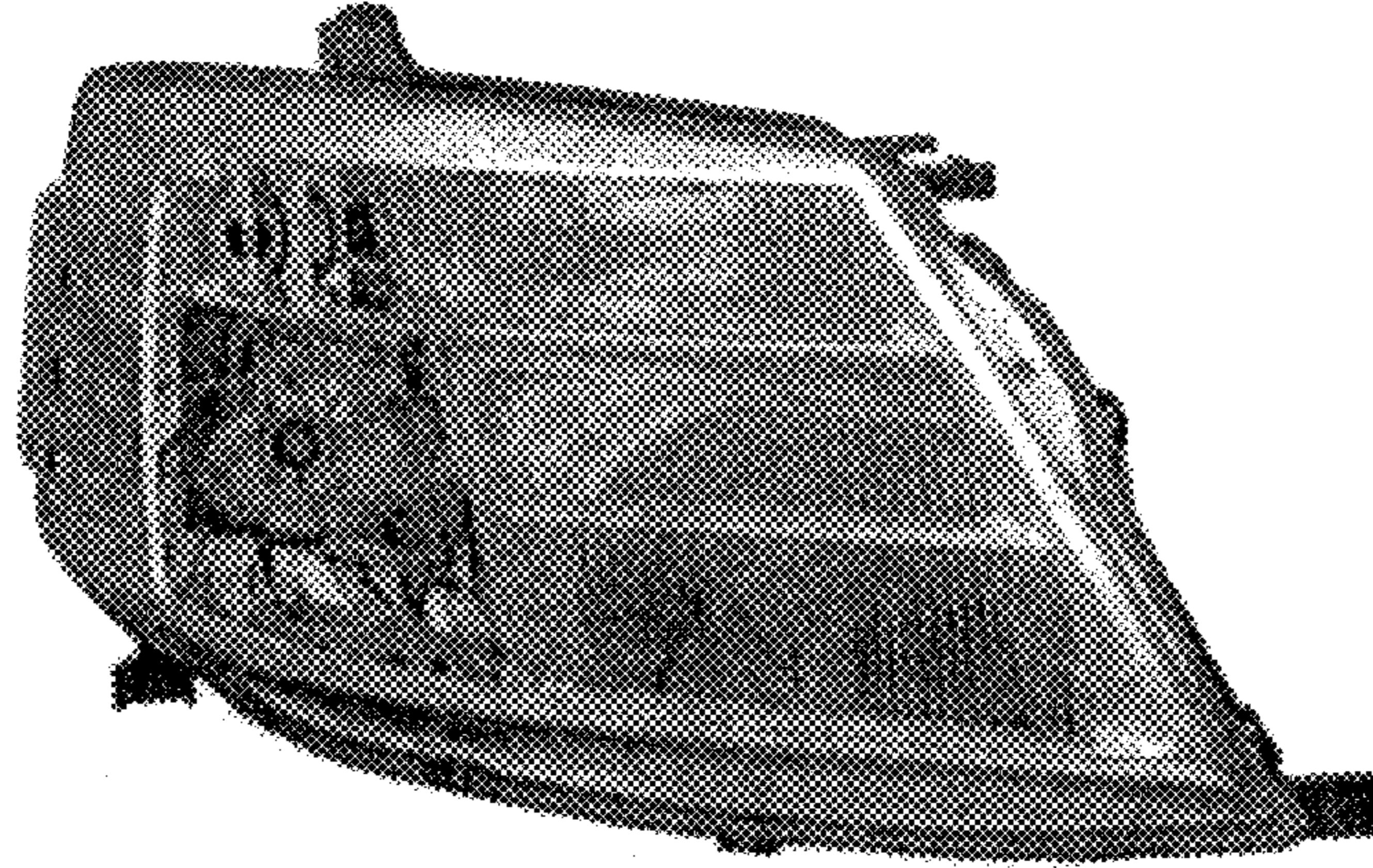

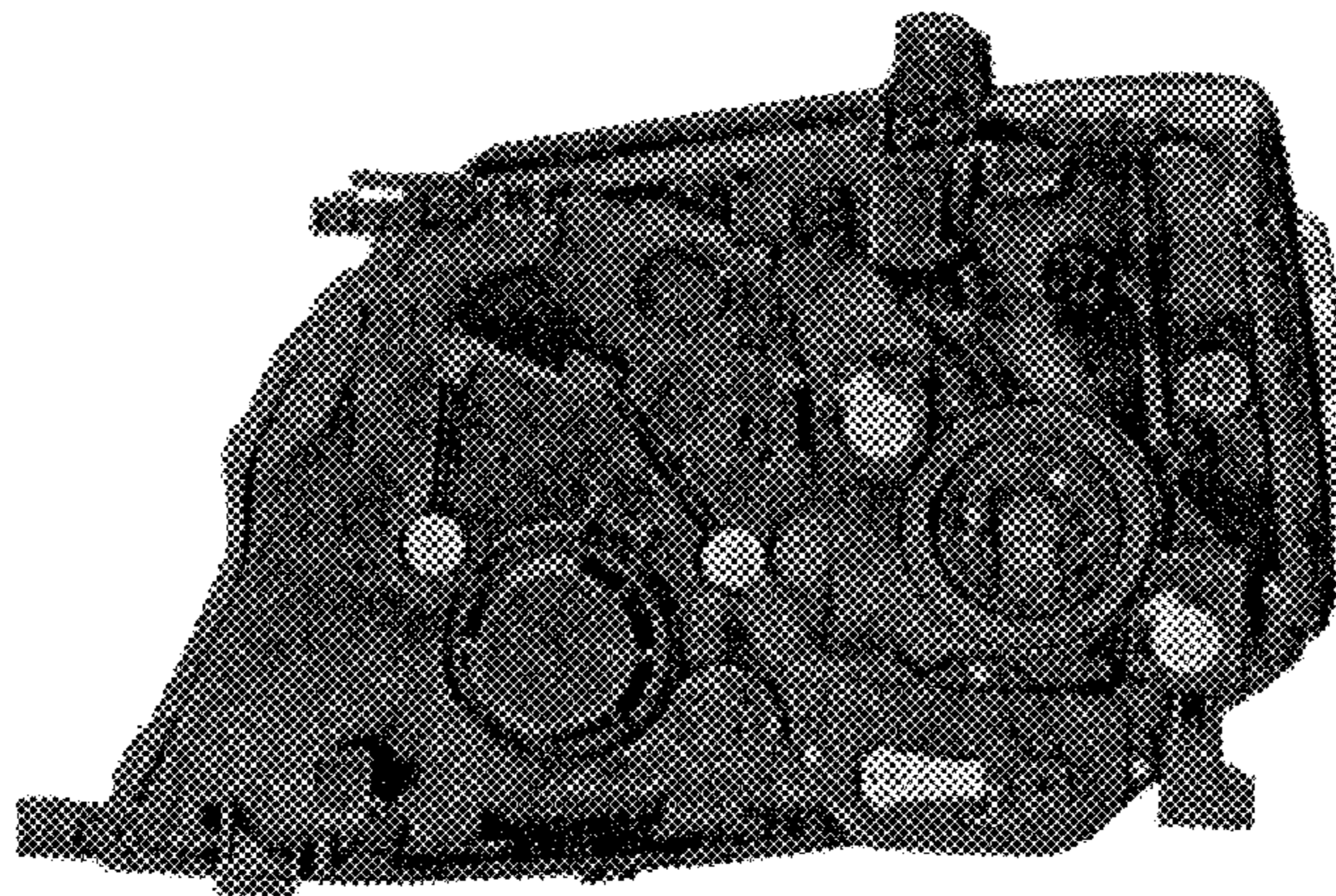

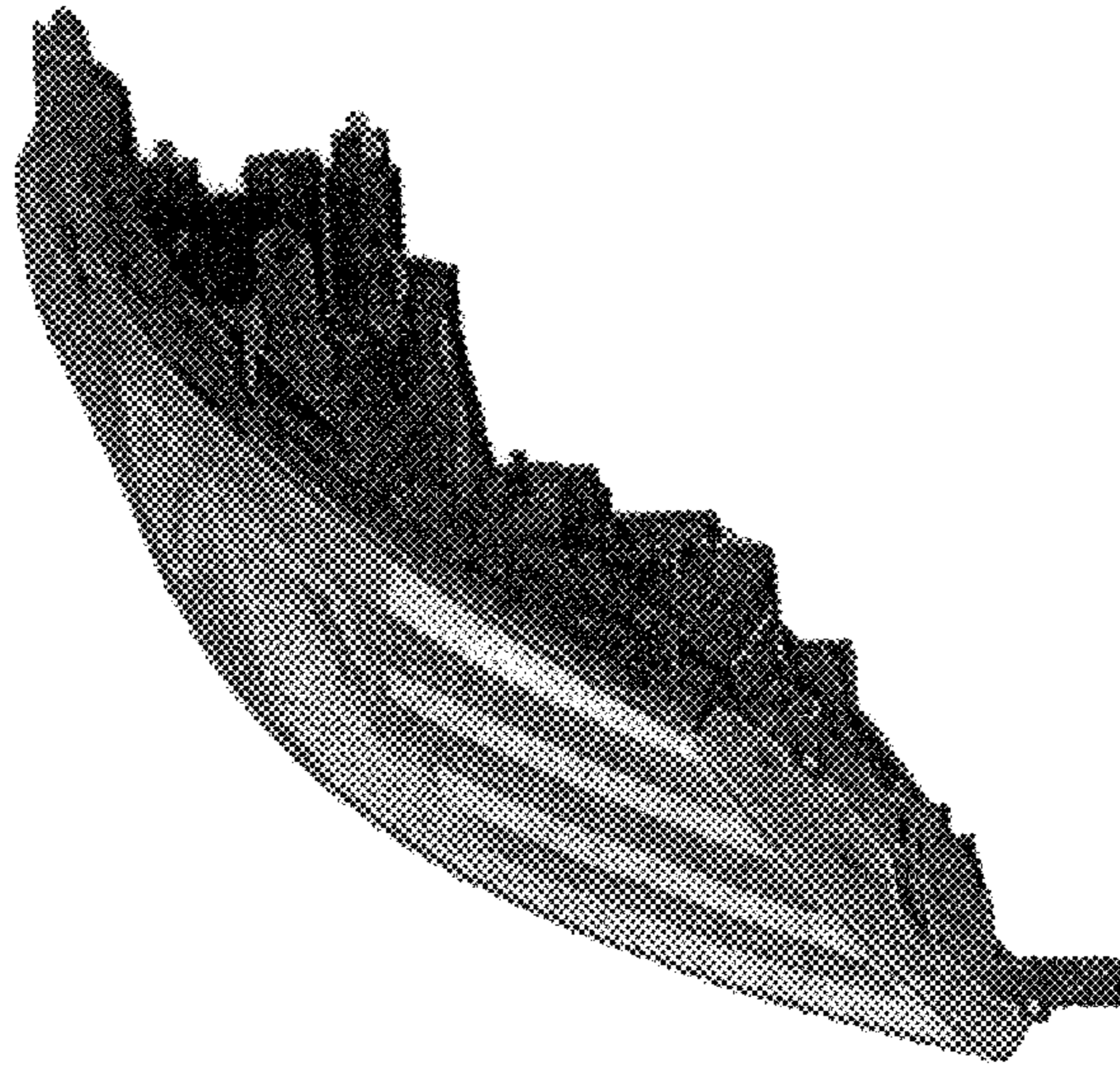

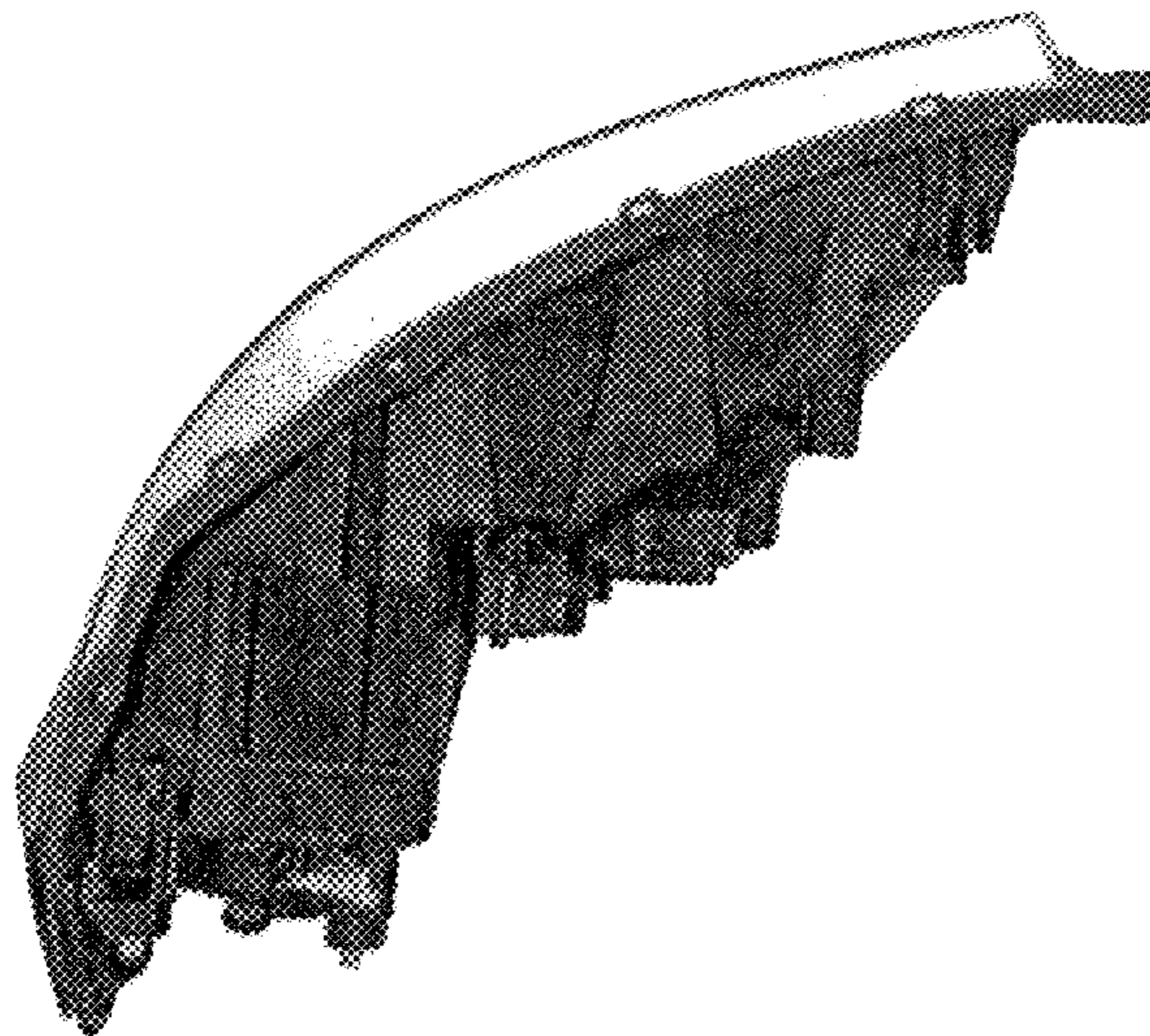

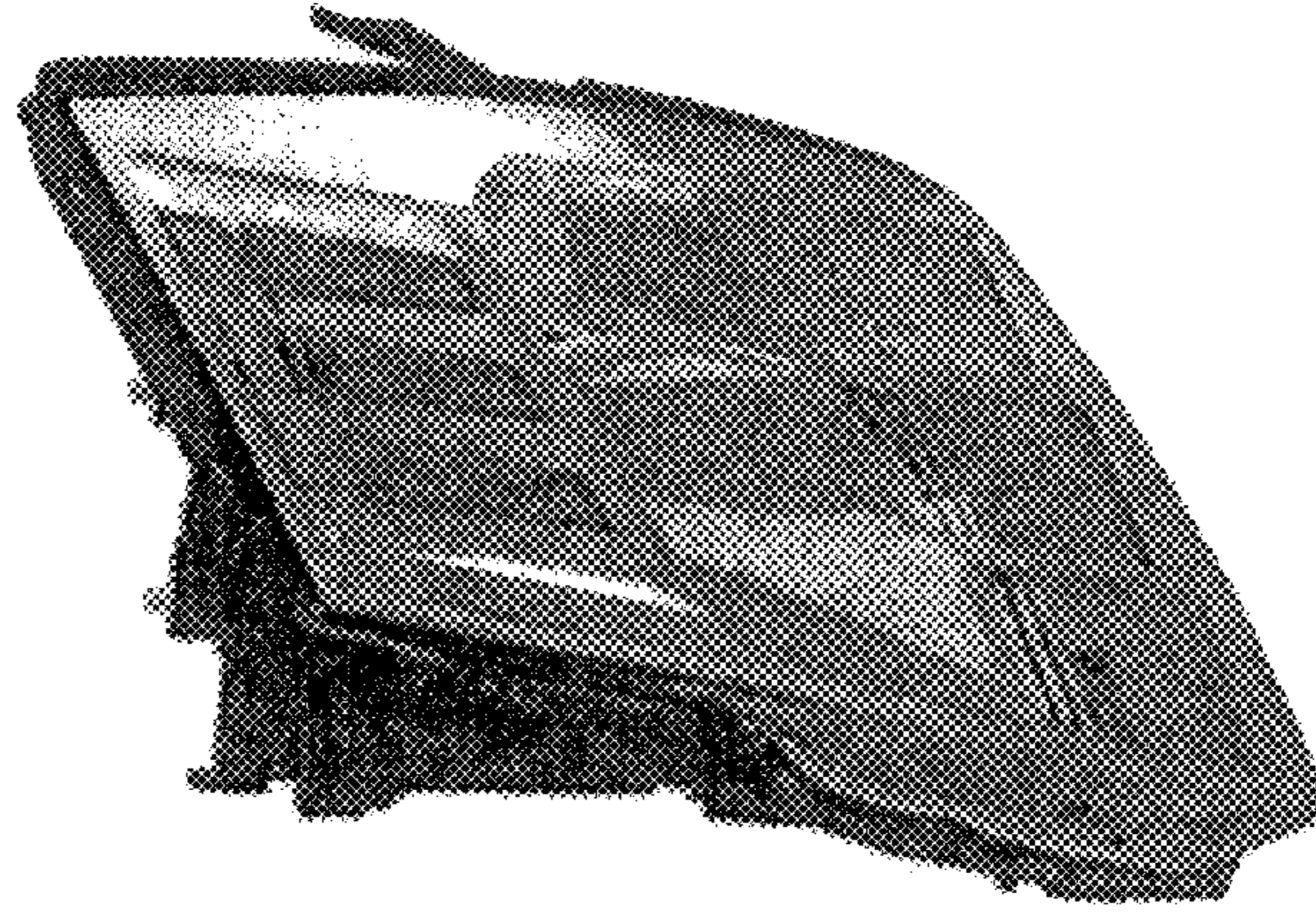

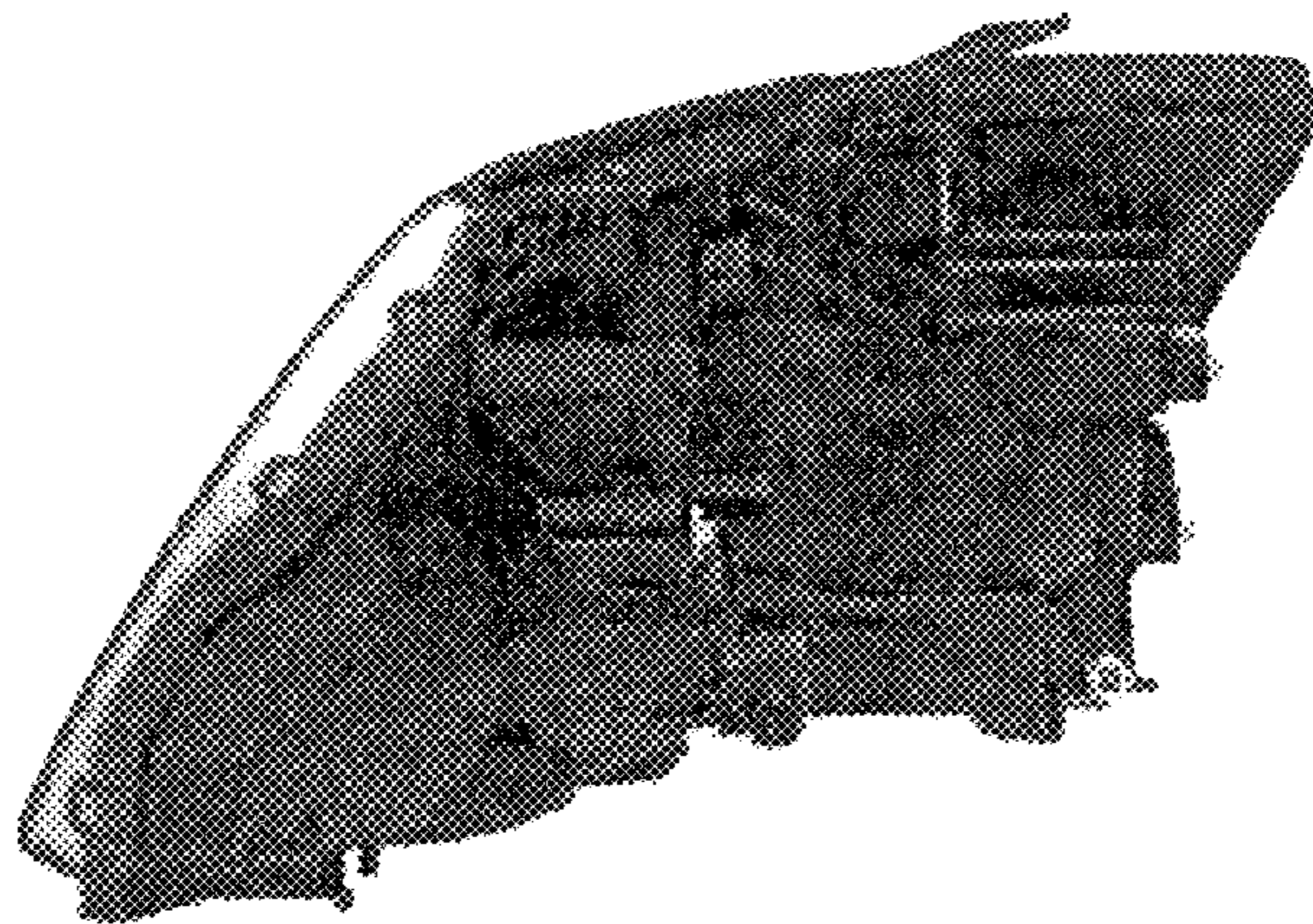
