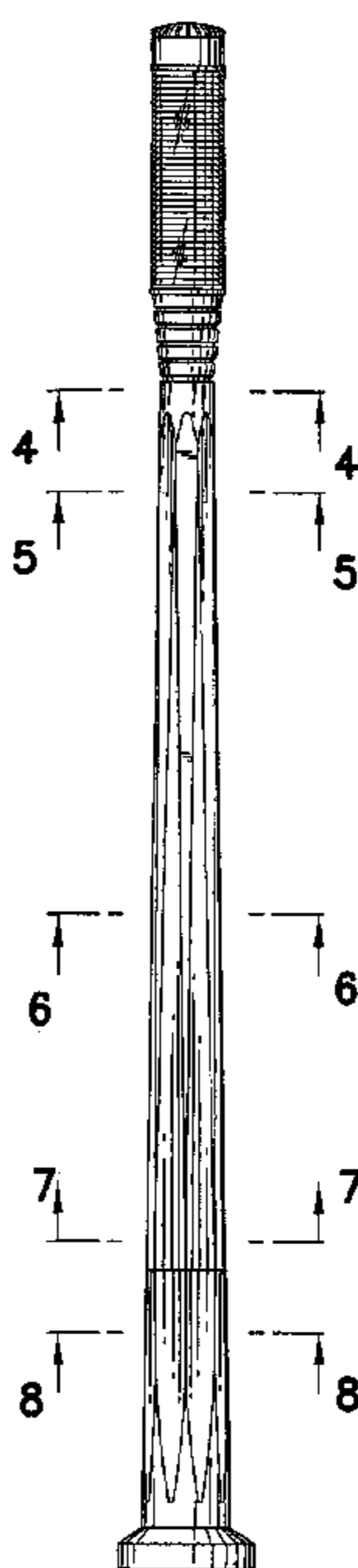
(57) **CLAIM**

The ornamental design for a light pole, as shown and described.

DESCRIPTION

FIG. 1 is a right side elevation view of a light pole showing our new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a bottom plan view thereof;
FIG. 4 is a cross-sectional view thereof, as indicated in the section line 4—4 in FIG. 1;
FIG. 5 is a cross-sectional view thereof, as indicated in the section line 5—5 in FIG. 1;
FIG. 6 is a cross-sectional view thereof, as indicated in the section line 6—6 in FIG. 1;
FIG. 7 is a cross-sectional view thereof, as indicated in the section line 7—7 in FIG. 1;
FIG. 8 is a cross-sectional view thereof, as indicated in the section line 8—8 in FIG. 1; and,
FIG. 9 is an enlarged view thereof as illustrated in FIG. 2. The left side elevation view, the front side elevation view and the back side elevation view are images of the right side elevation view in FIG. 1.

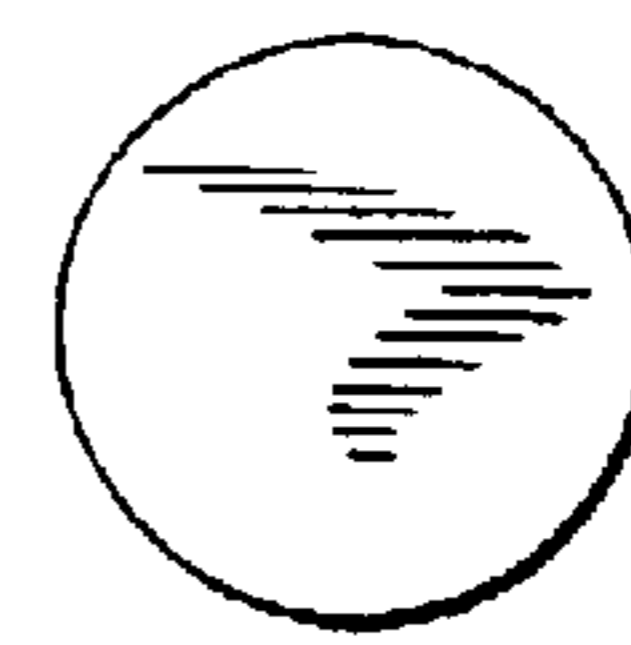
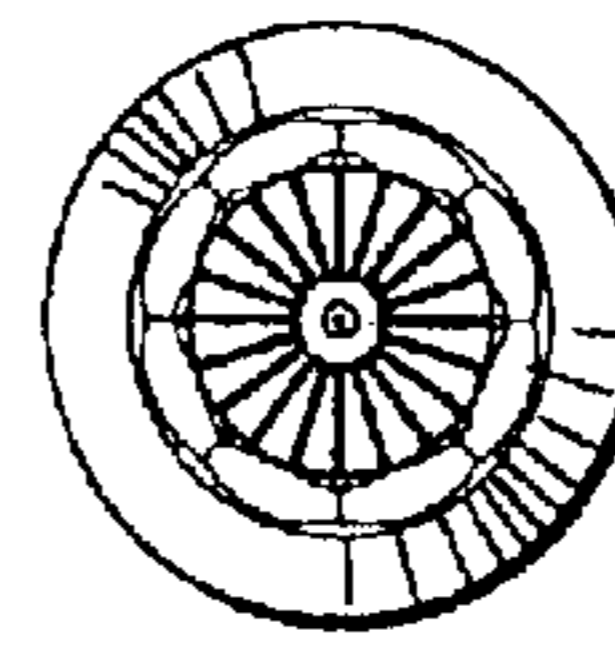
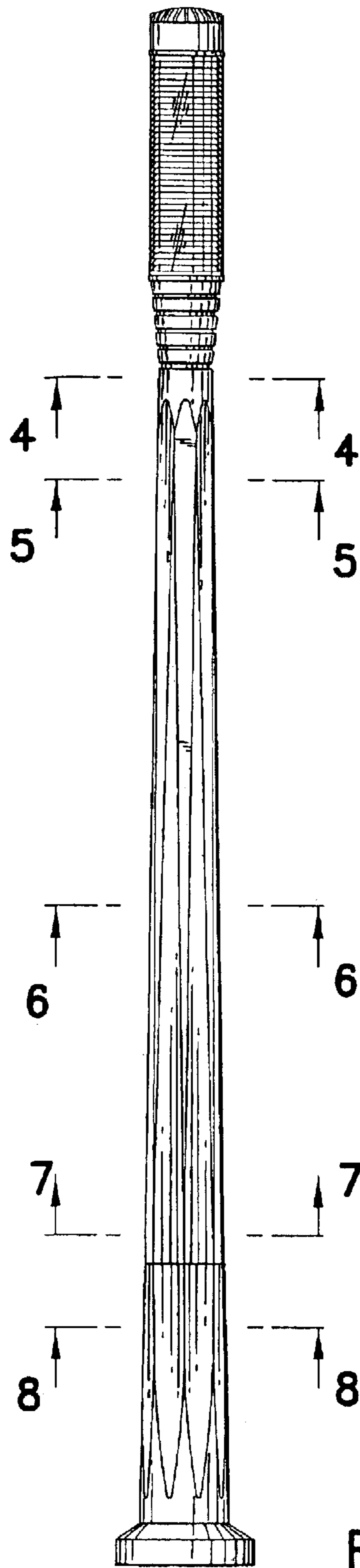

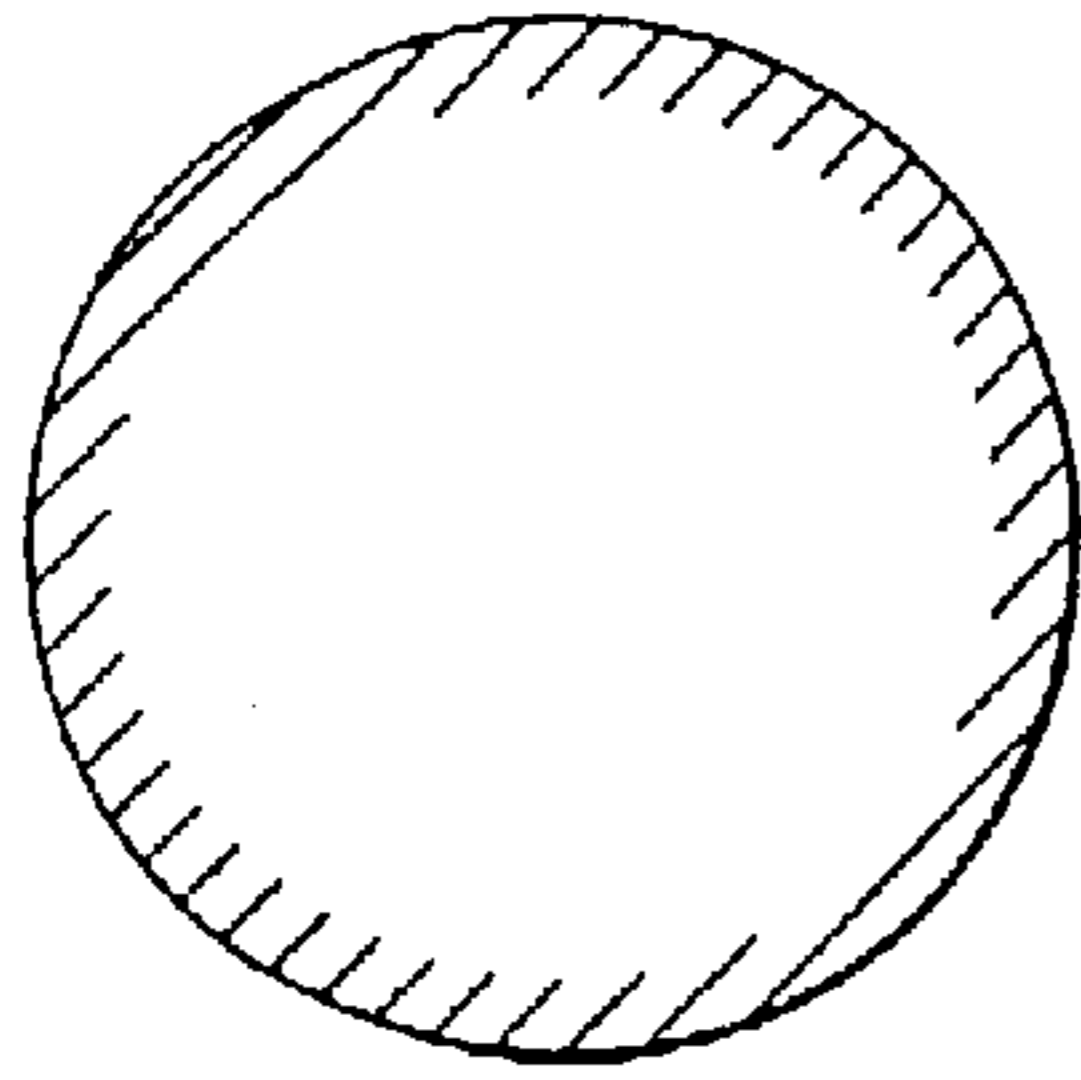

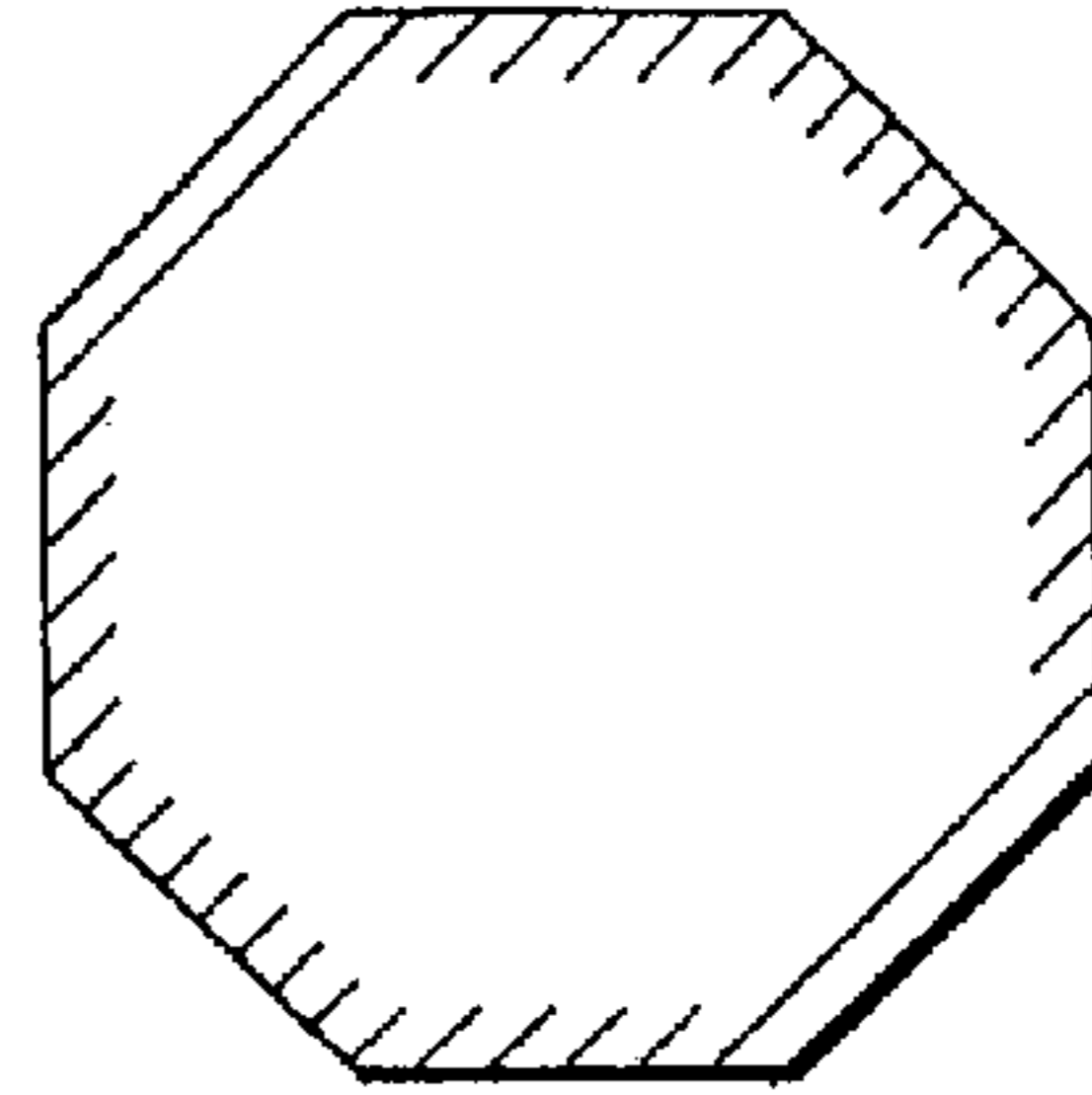

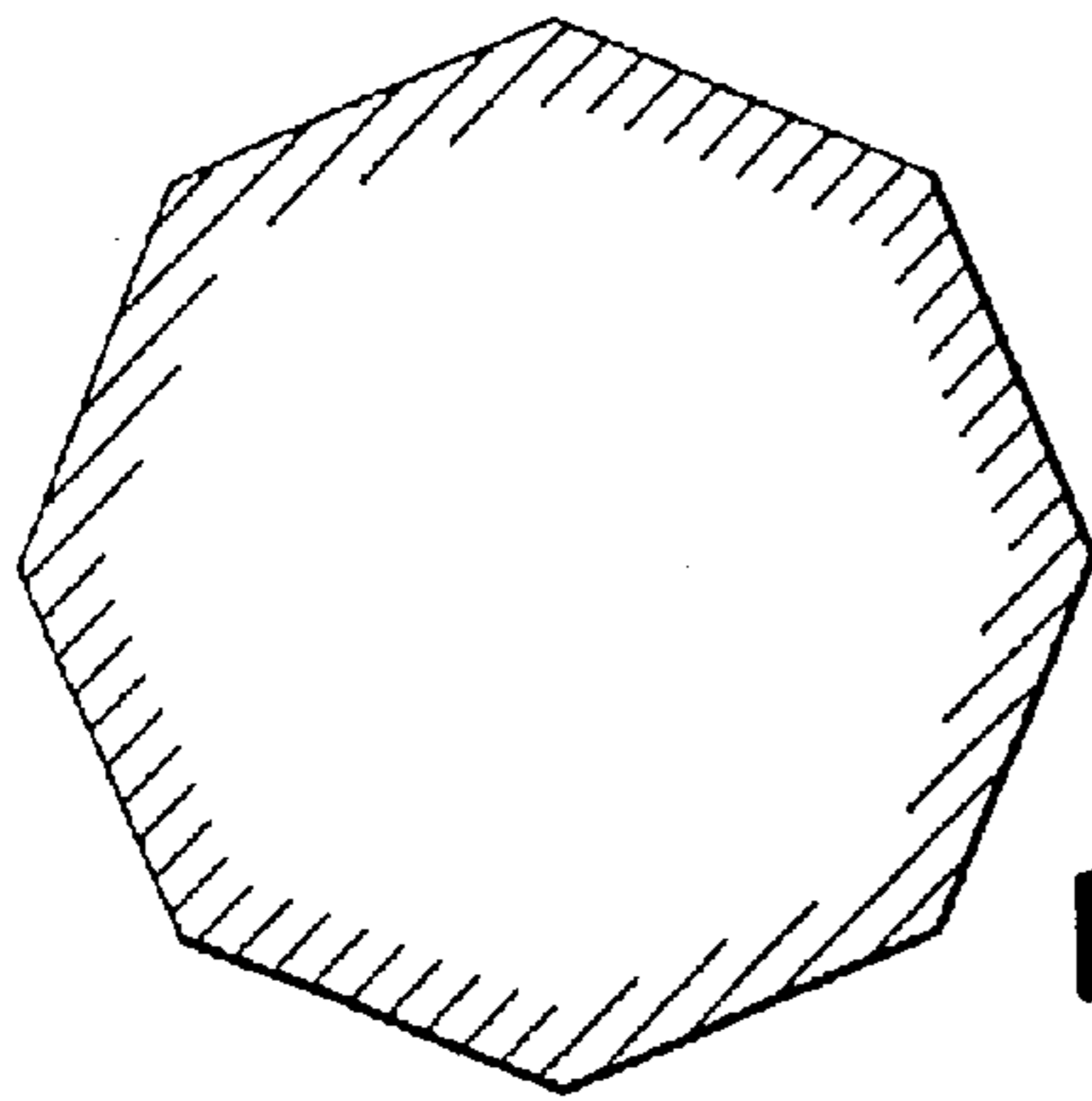
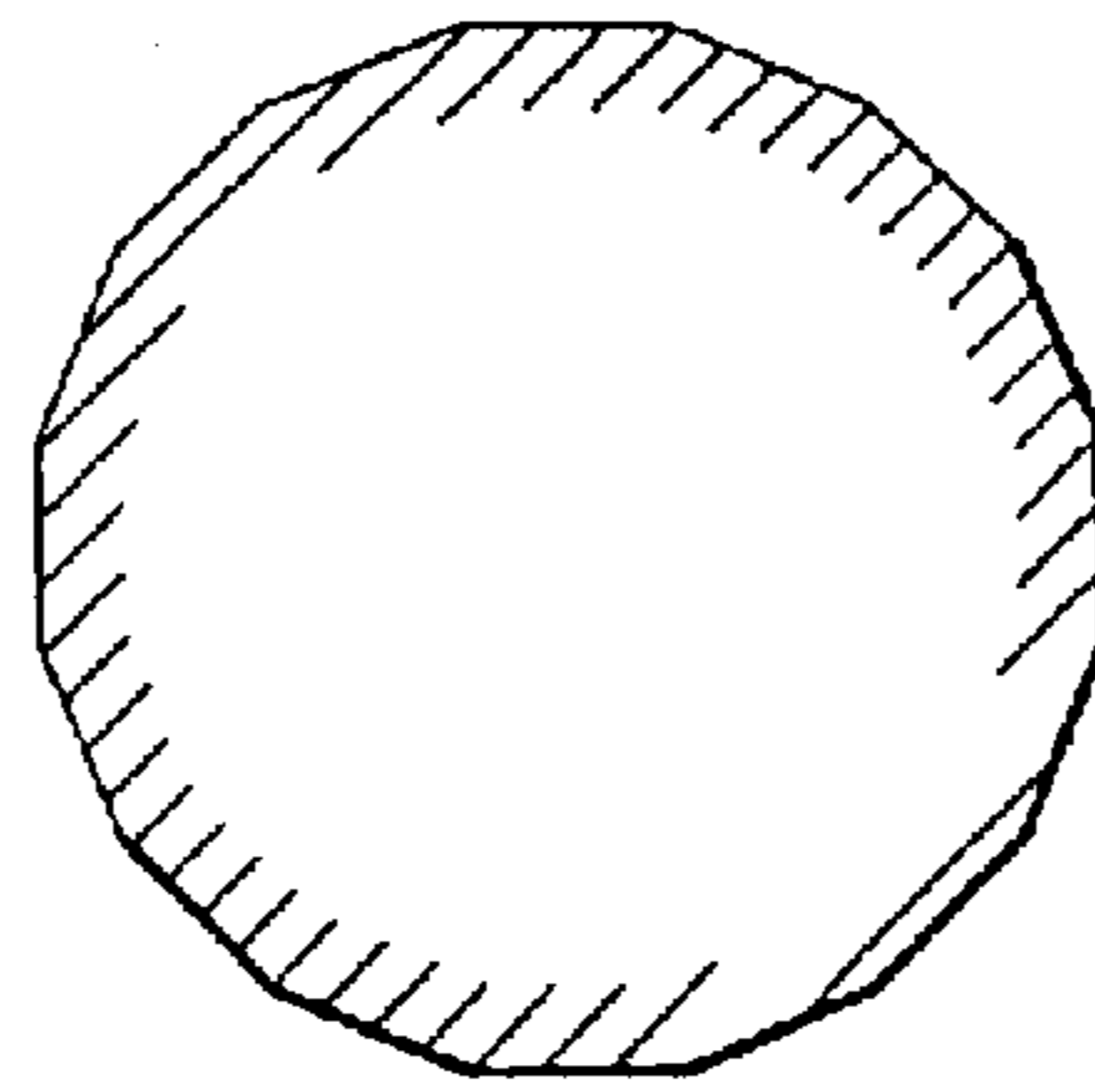

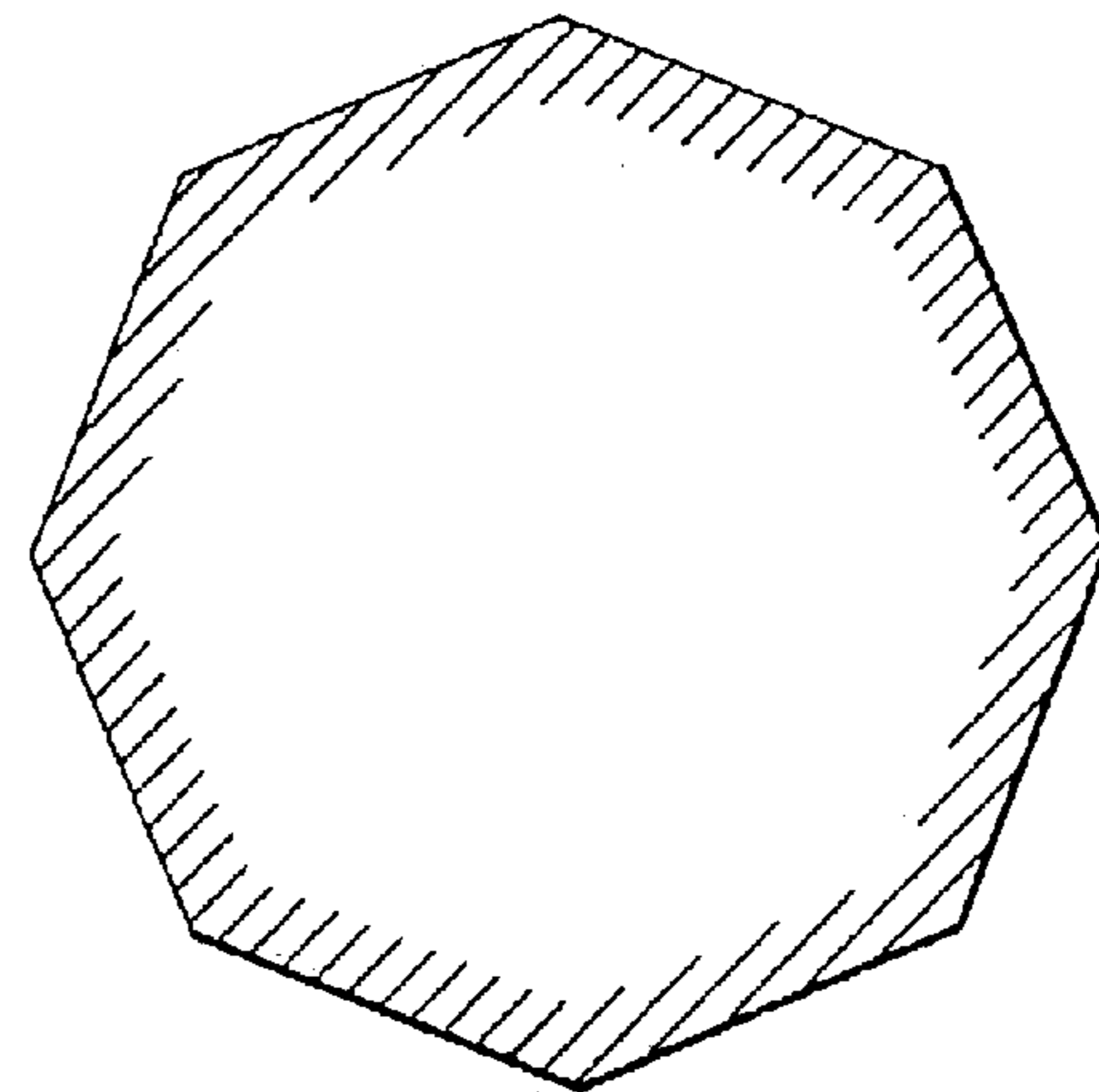

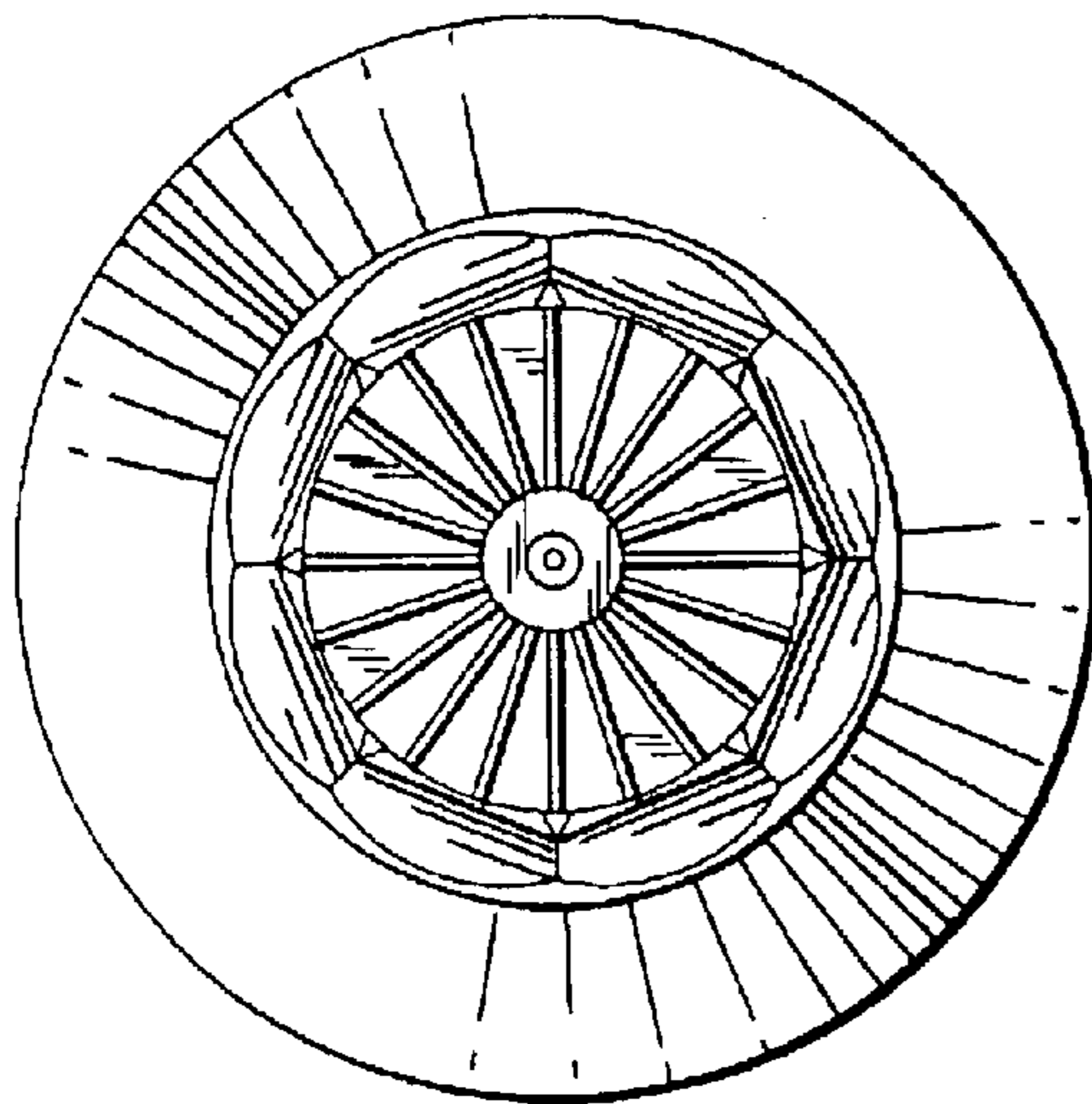
