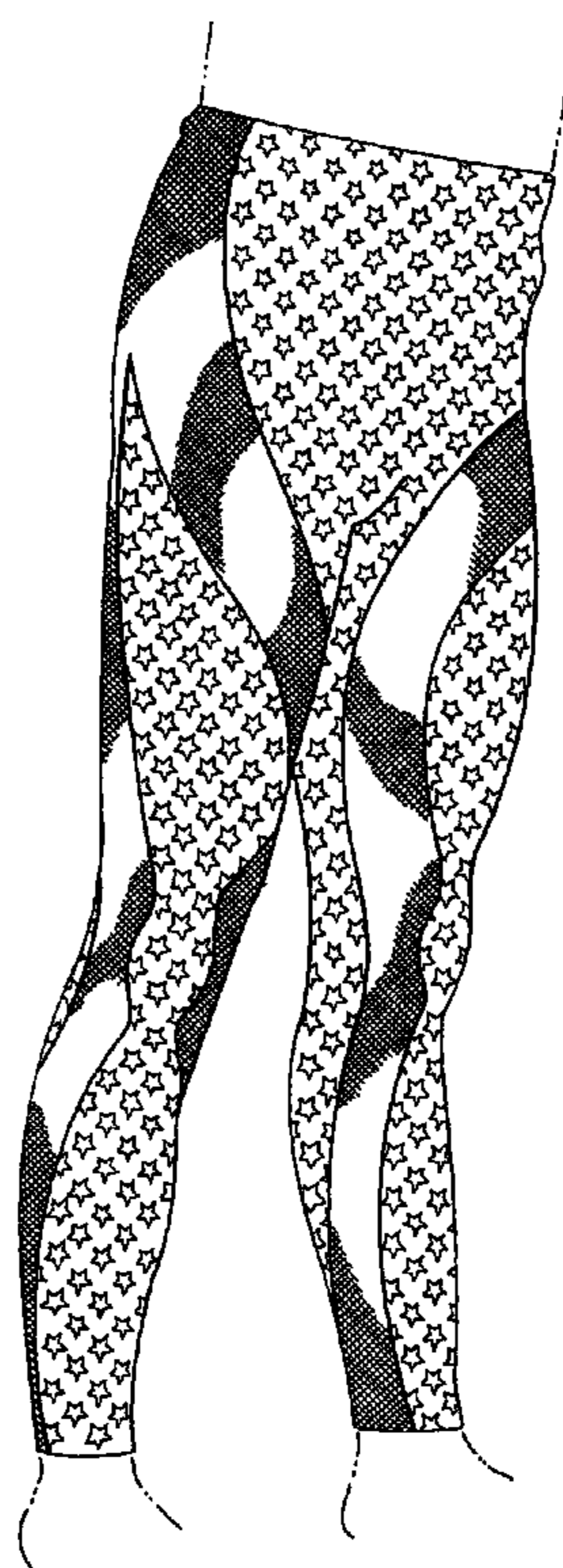

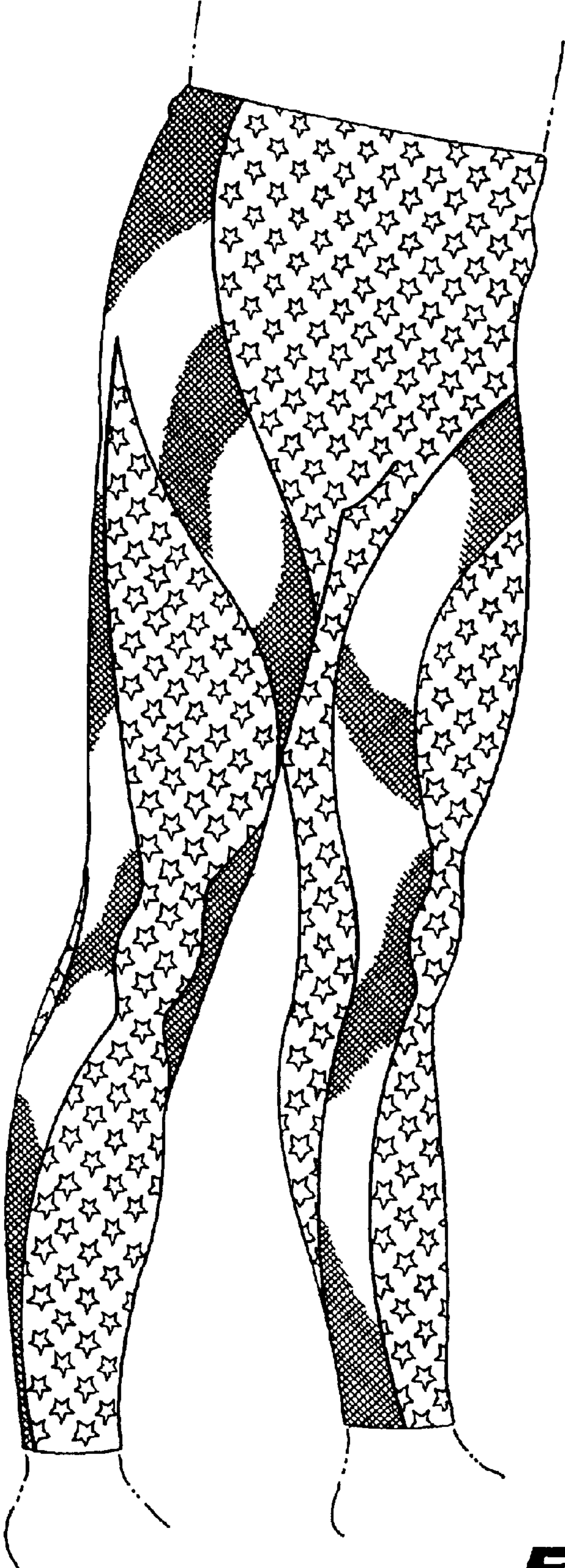
**DESCRIPTION**

FIG. 1 is a front perspective view of a performance up type, ankle length stars & stripes sports pants, showing our new design; and,

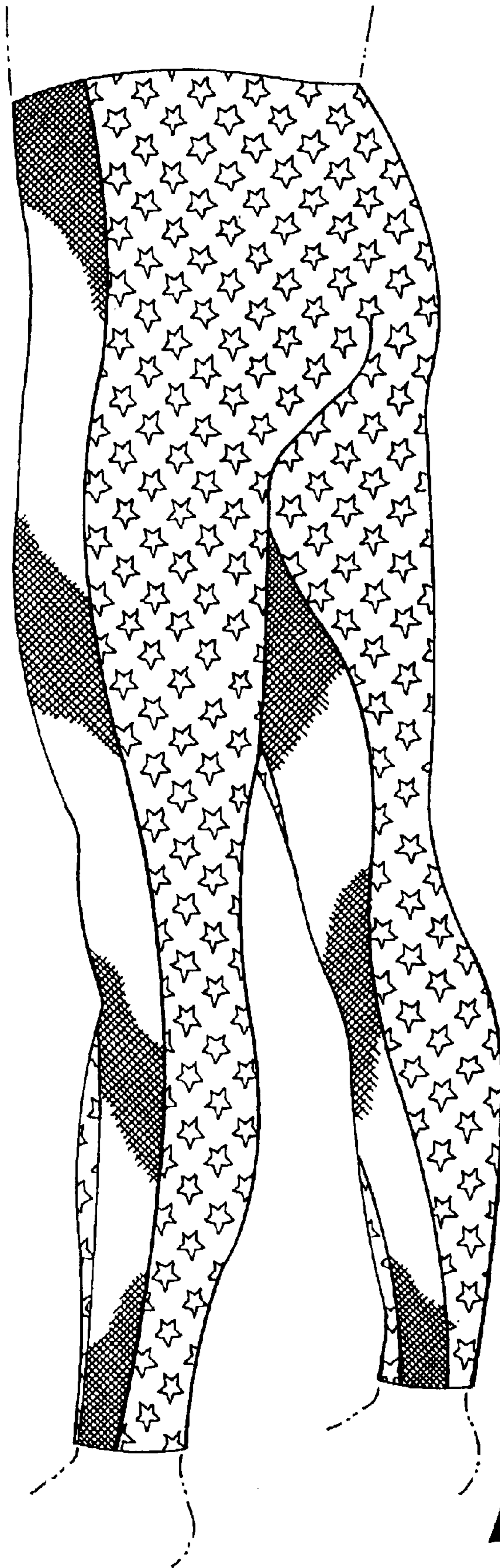
