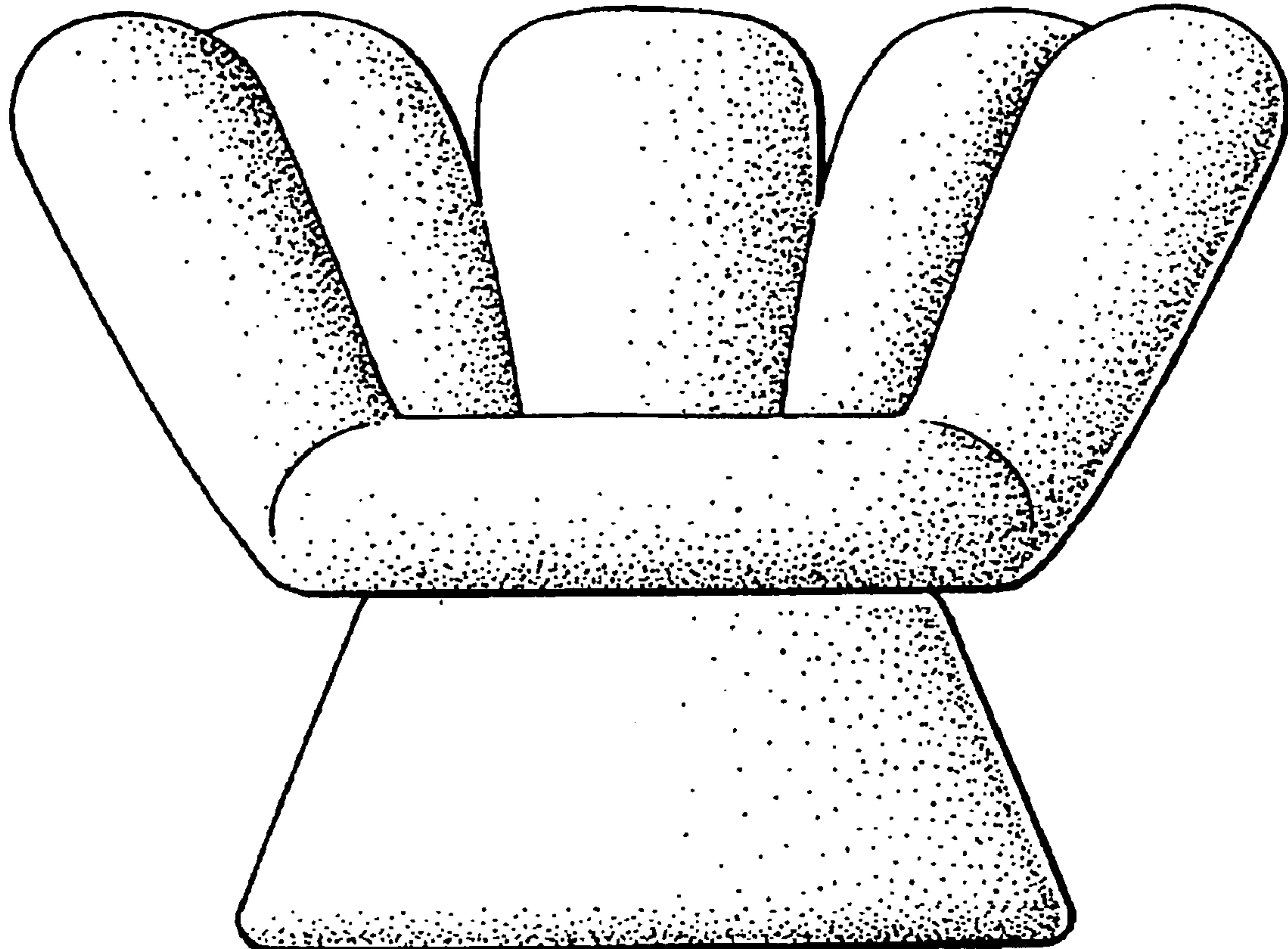

(57) **CLAIM**  
The ornamental design for a chair, as shown and described.

**DESCRIPTION**  
FIG. 1 is a front view of a chair, showing my new design; FIG. 2 is a top view of the chair, as shown in FIG. 1; FIG. 3 is a bottom view of the chair with a base of the chair detached, for ease of illustration; FIG. 4 is a front view of the chair, as shown in FIG. 3, with the base removed and positioned in the seat of the chair, to show an alternate position; FIG. 5 is a side view of the chair, as shown in FIG. 1; FIG. 6 is a side view of the chair, opposite the side view of FIG. 5, as shown in FIG. 1; FIG. 7 is a bottom view of the chair, as shown in FIG. 1; and, FIG. 8 is a back view of the chair, as shown in FIG. 1.

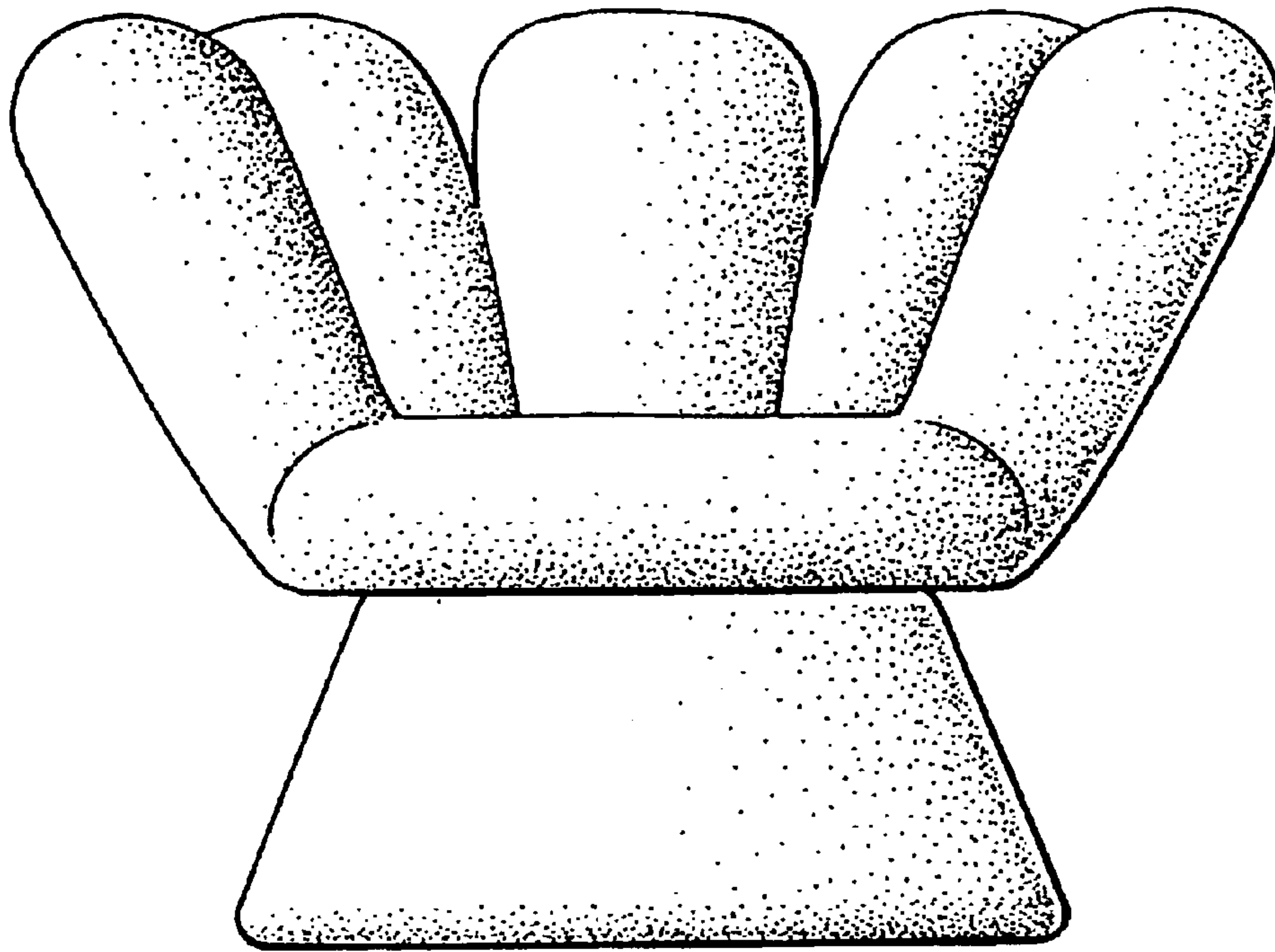

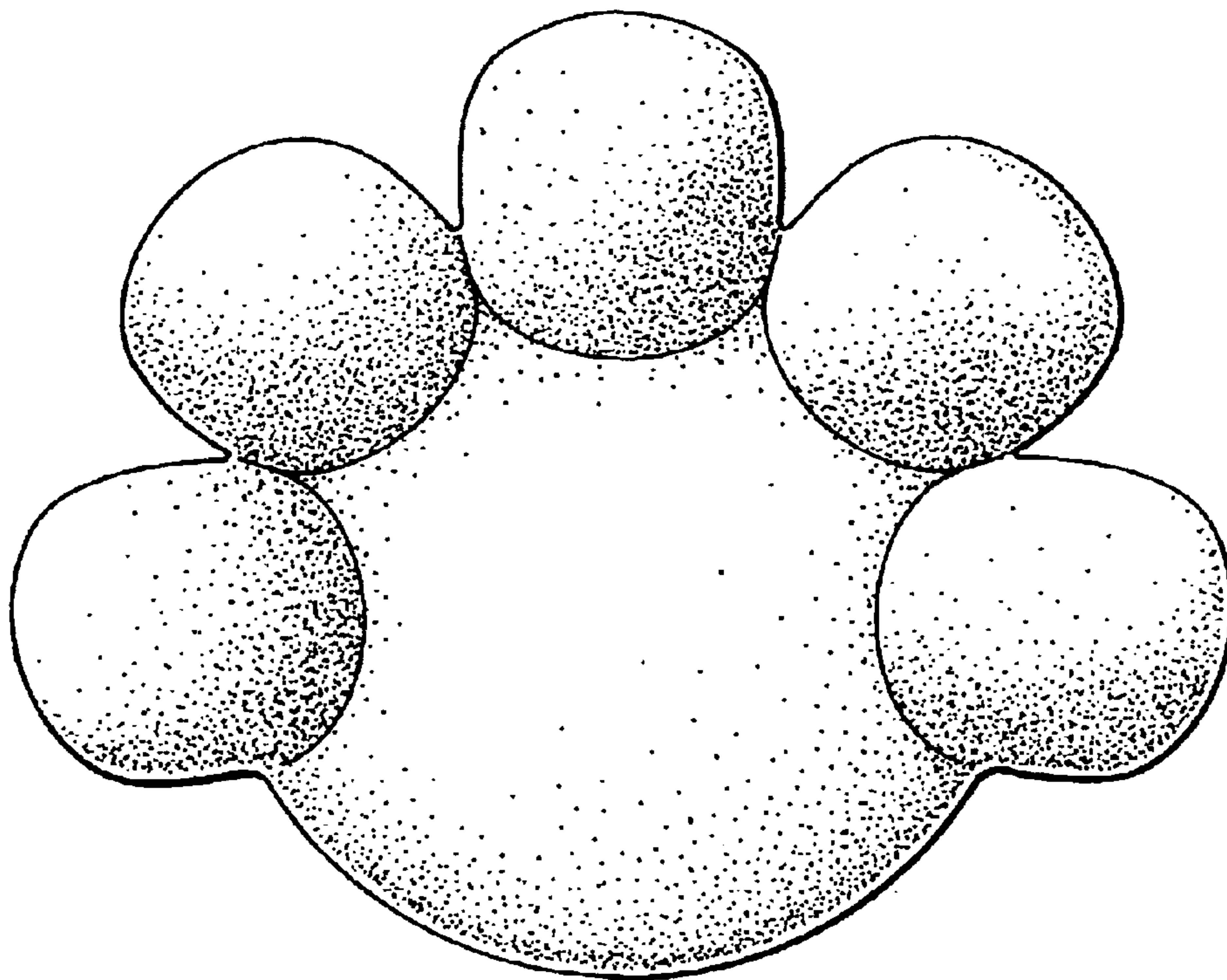

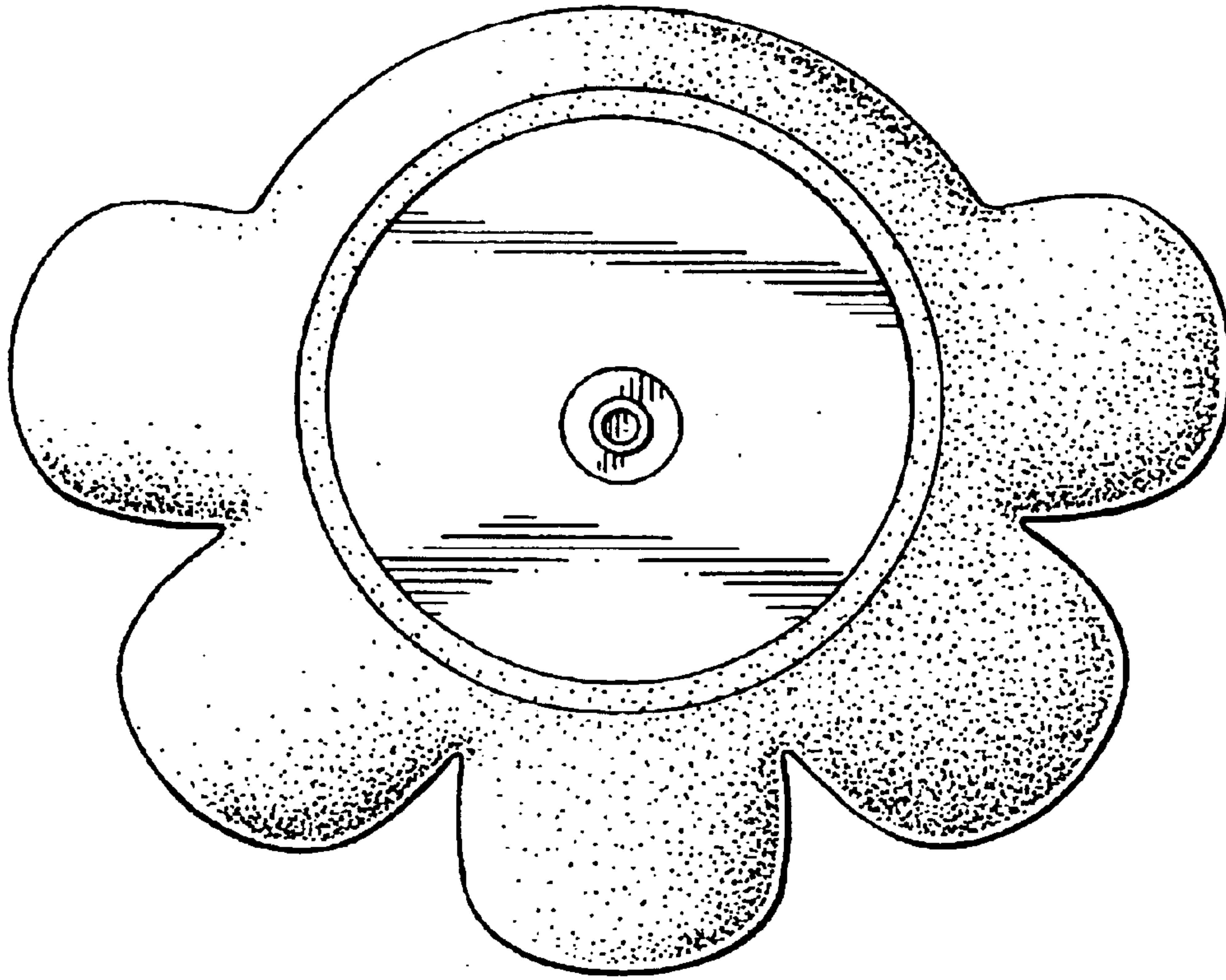

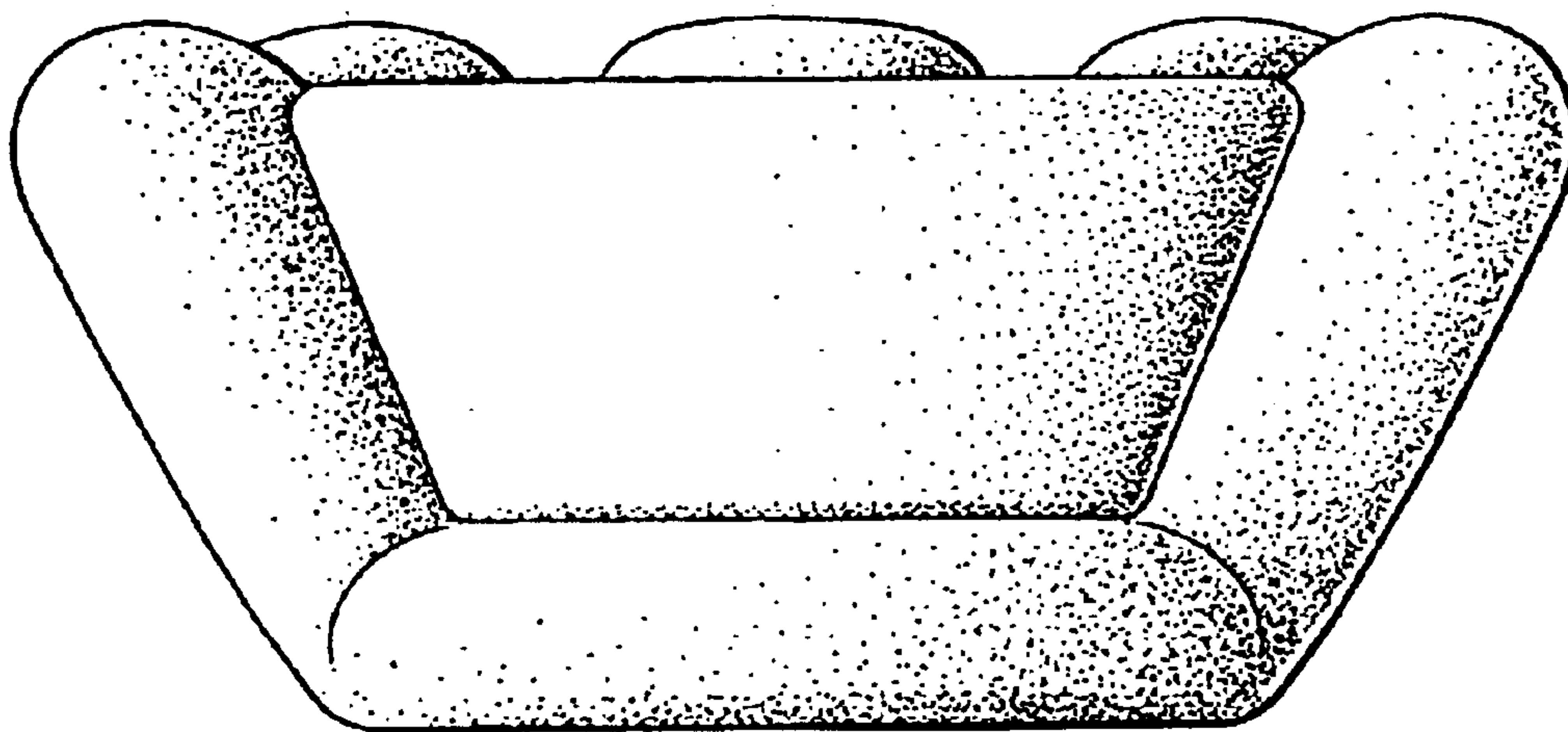

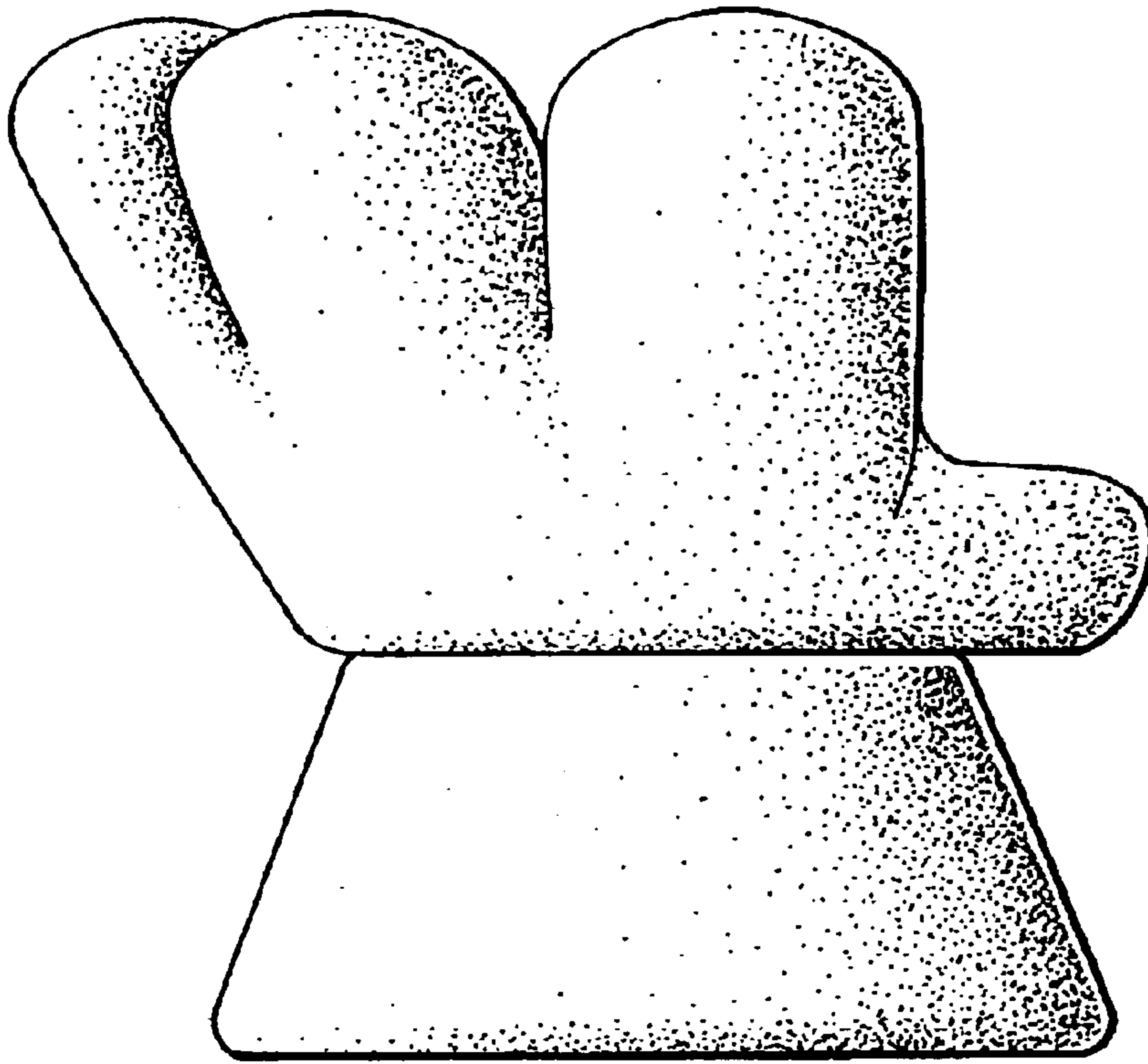

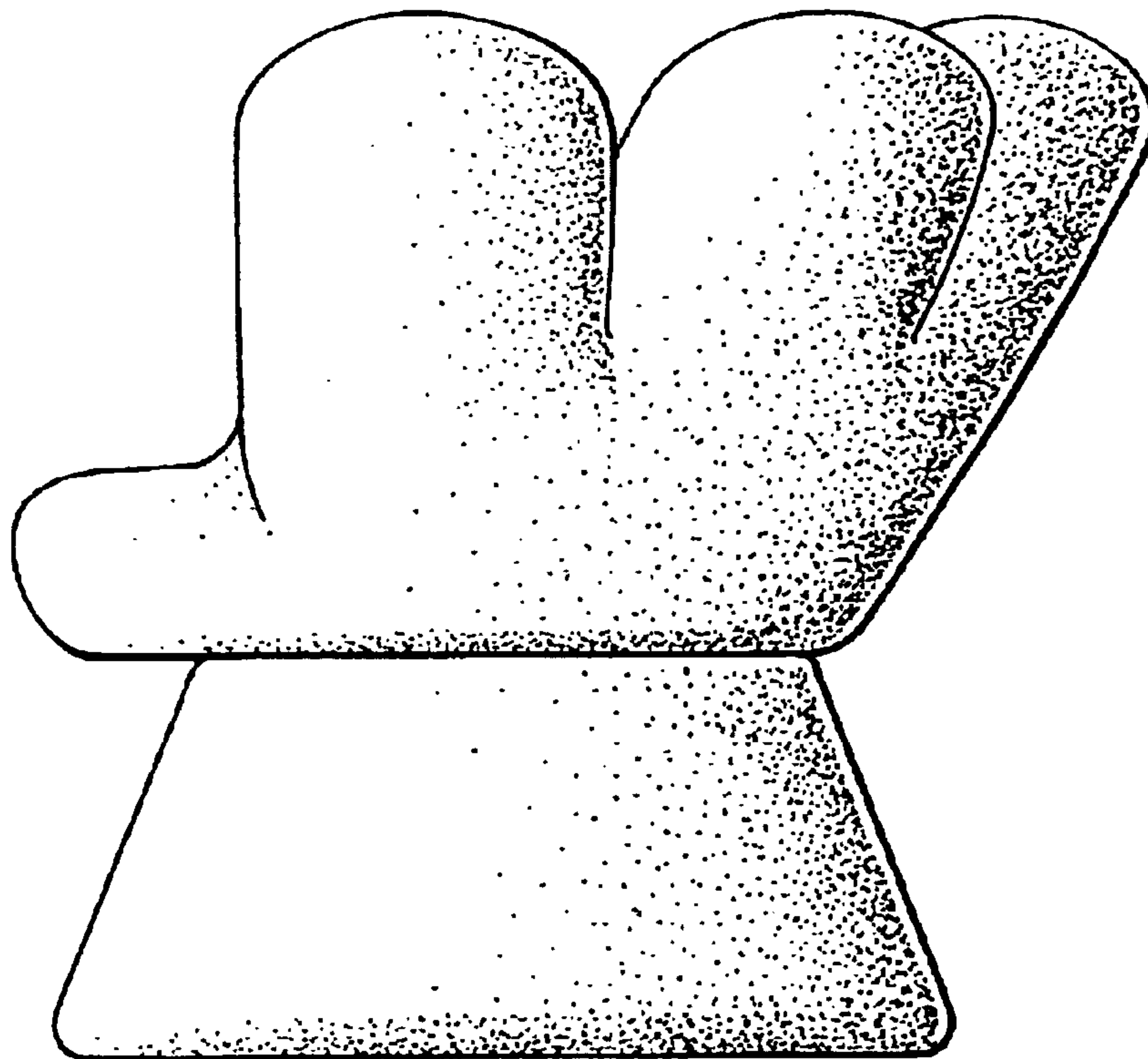

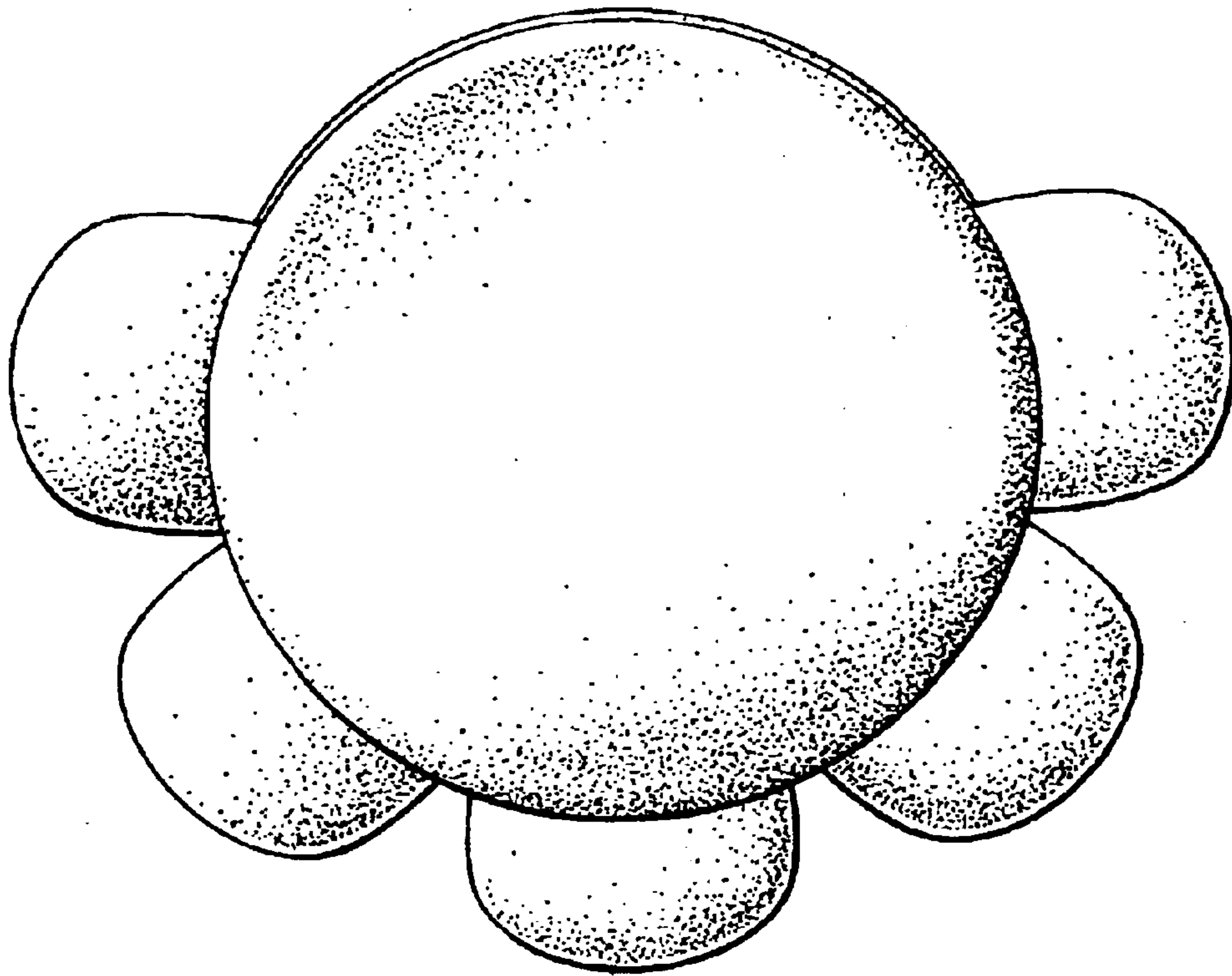

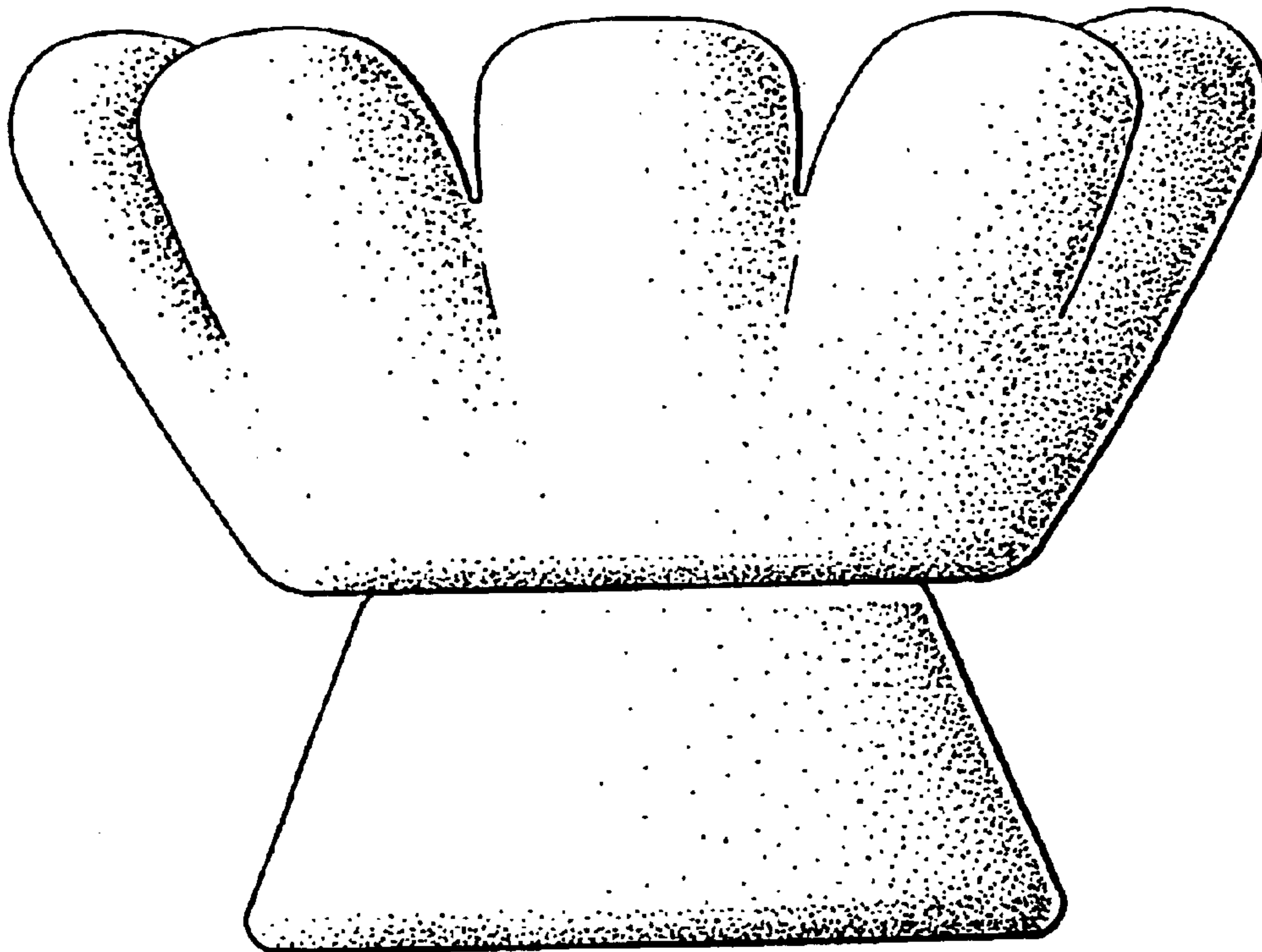
