DESCRIPTION

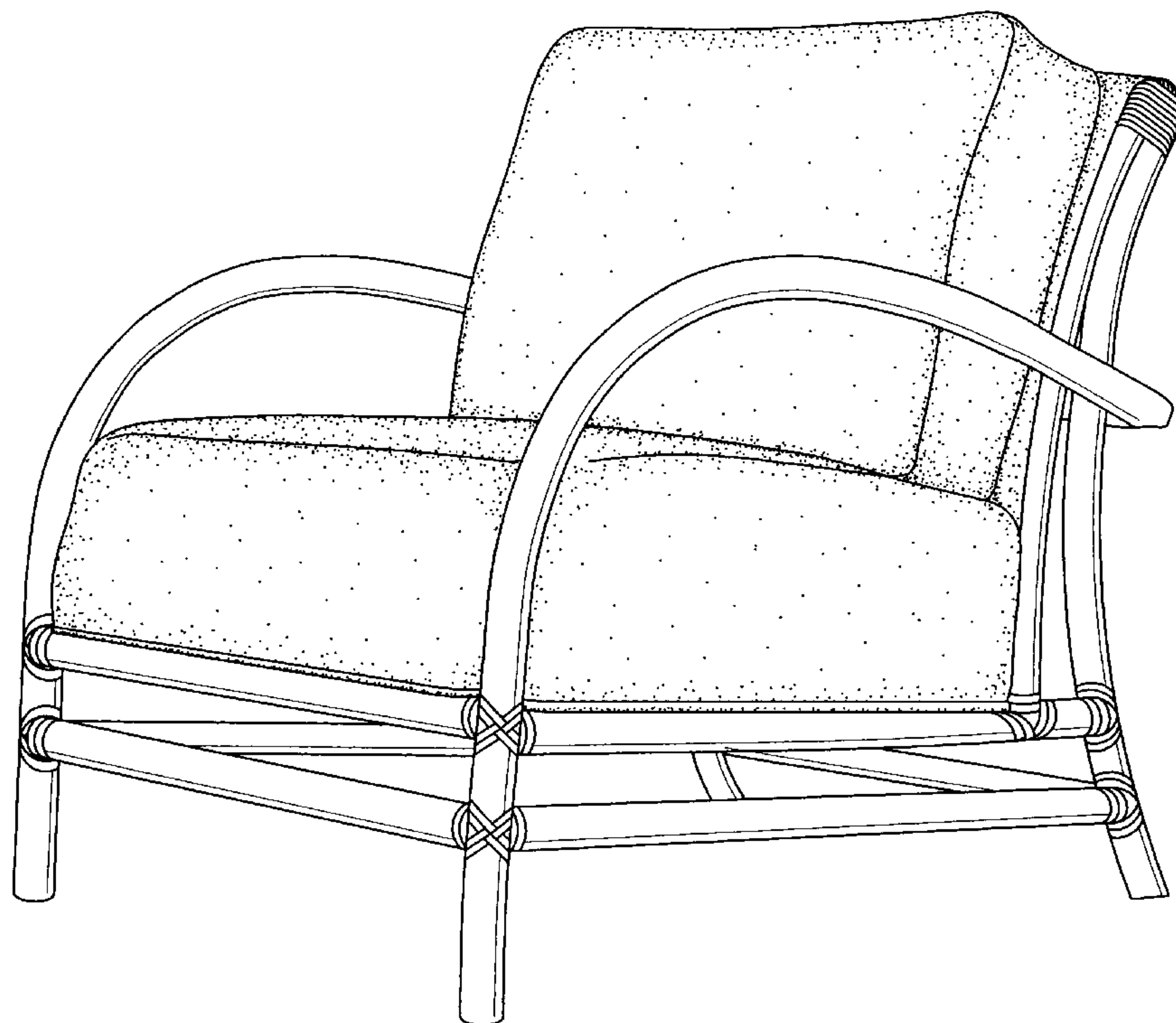

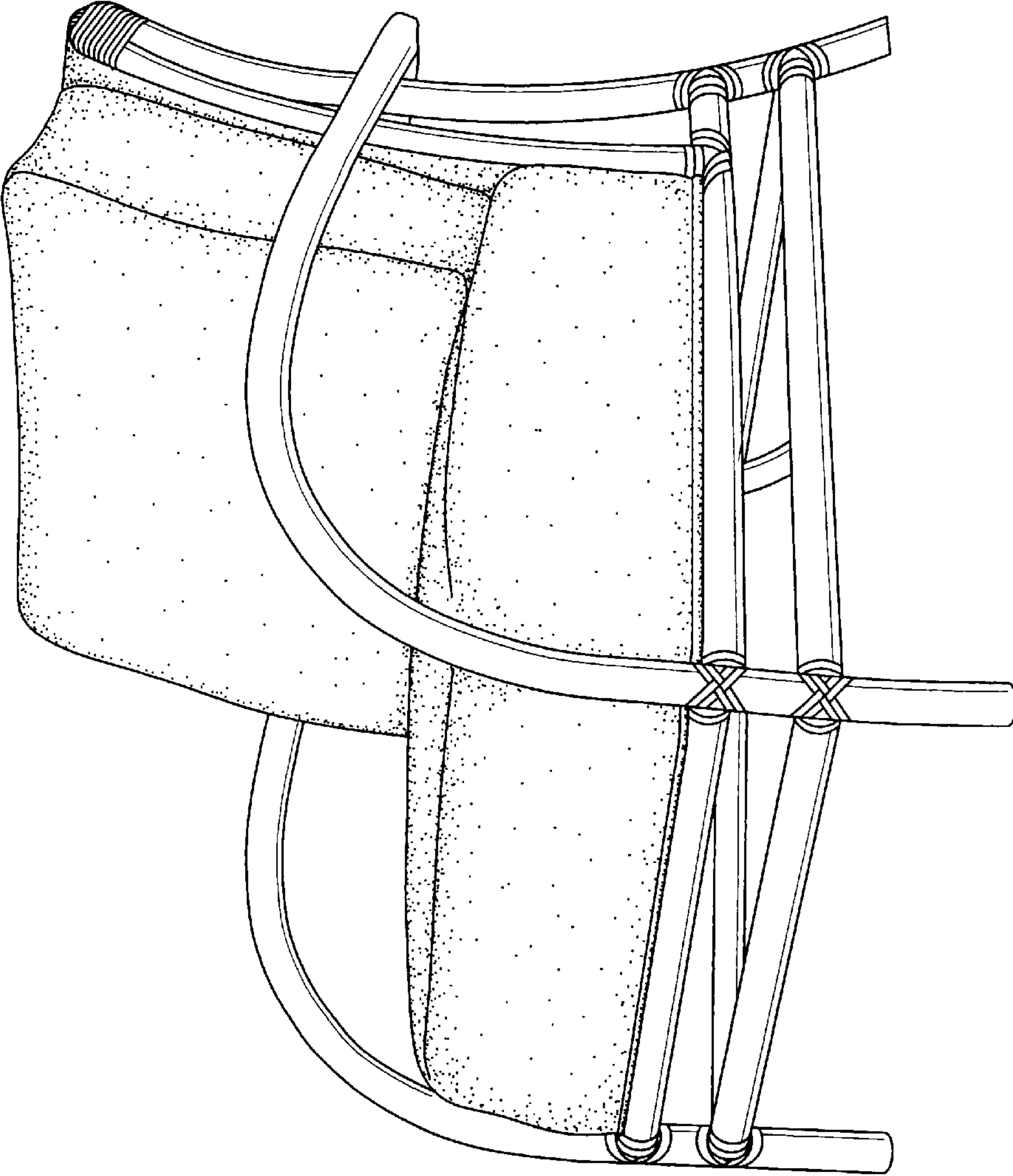

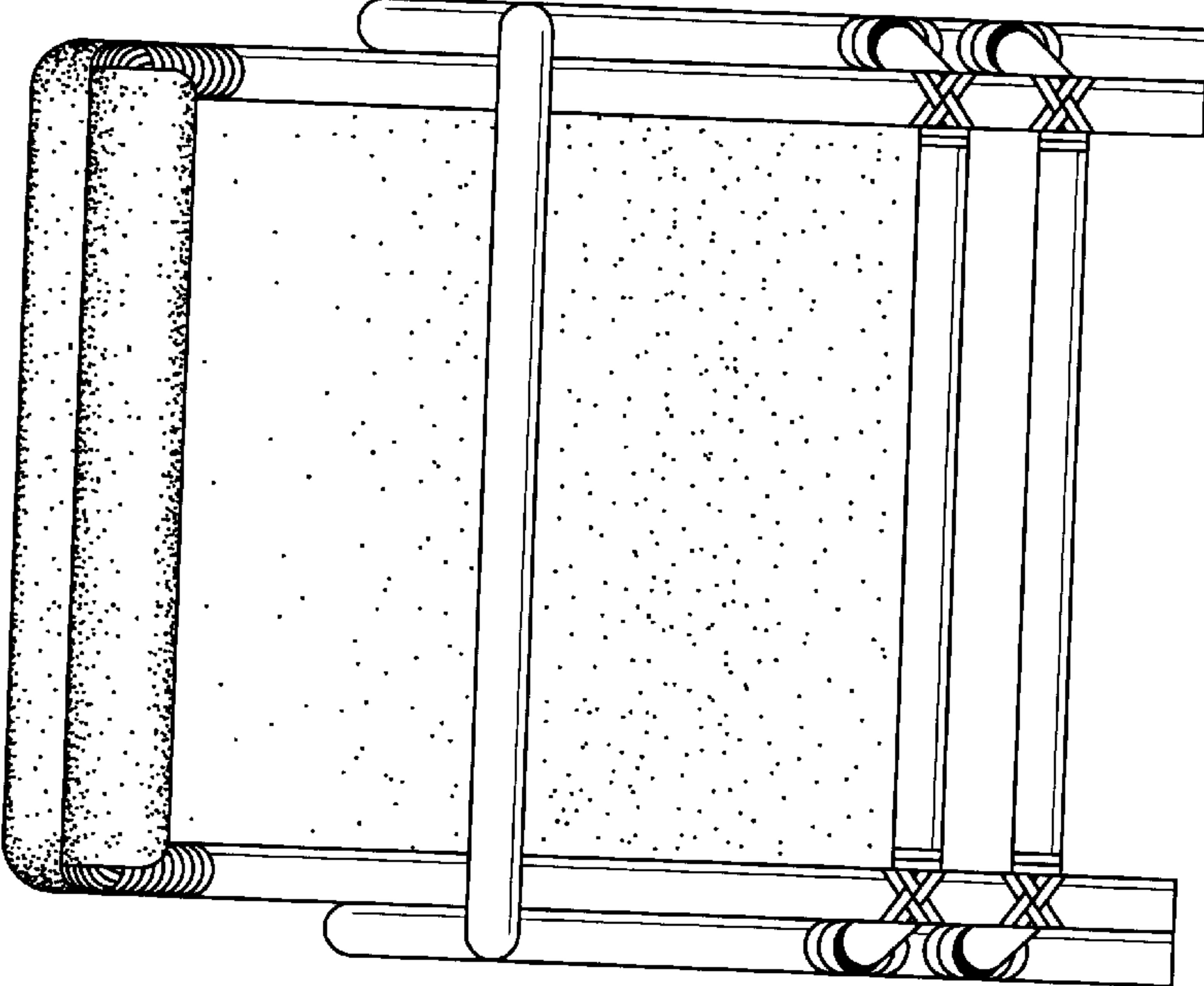
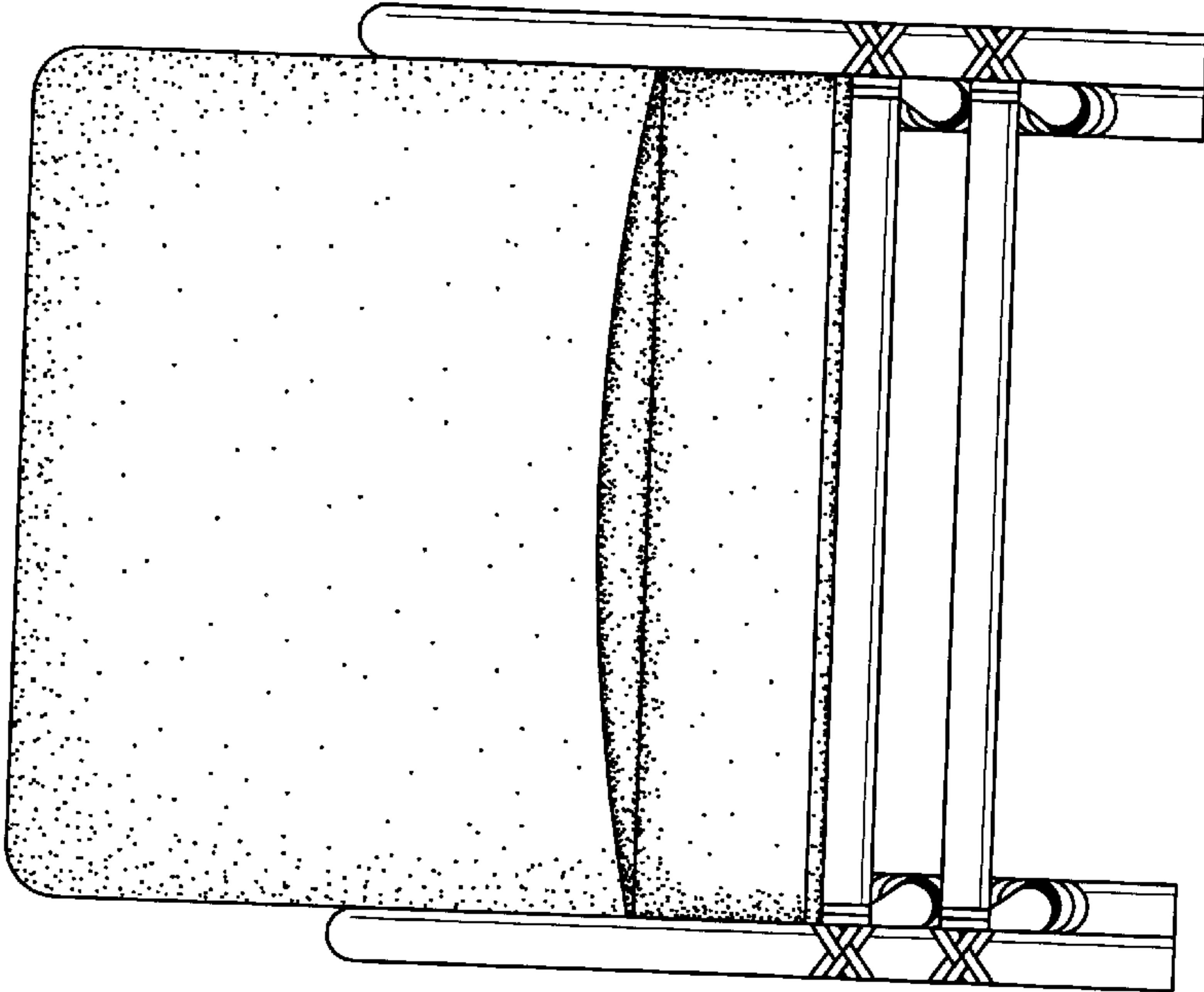

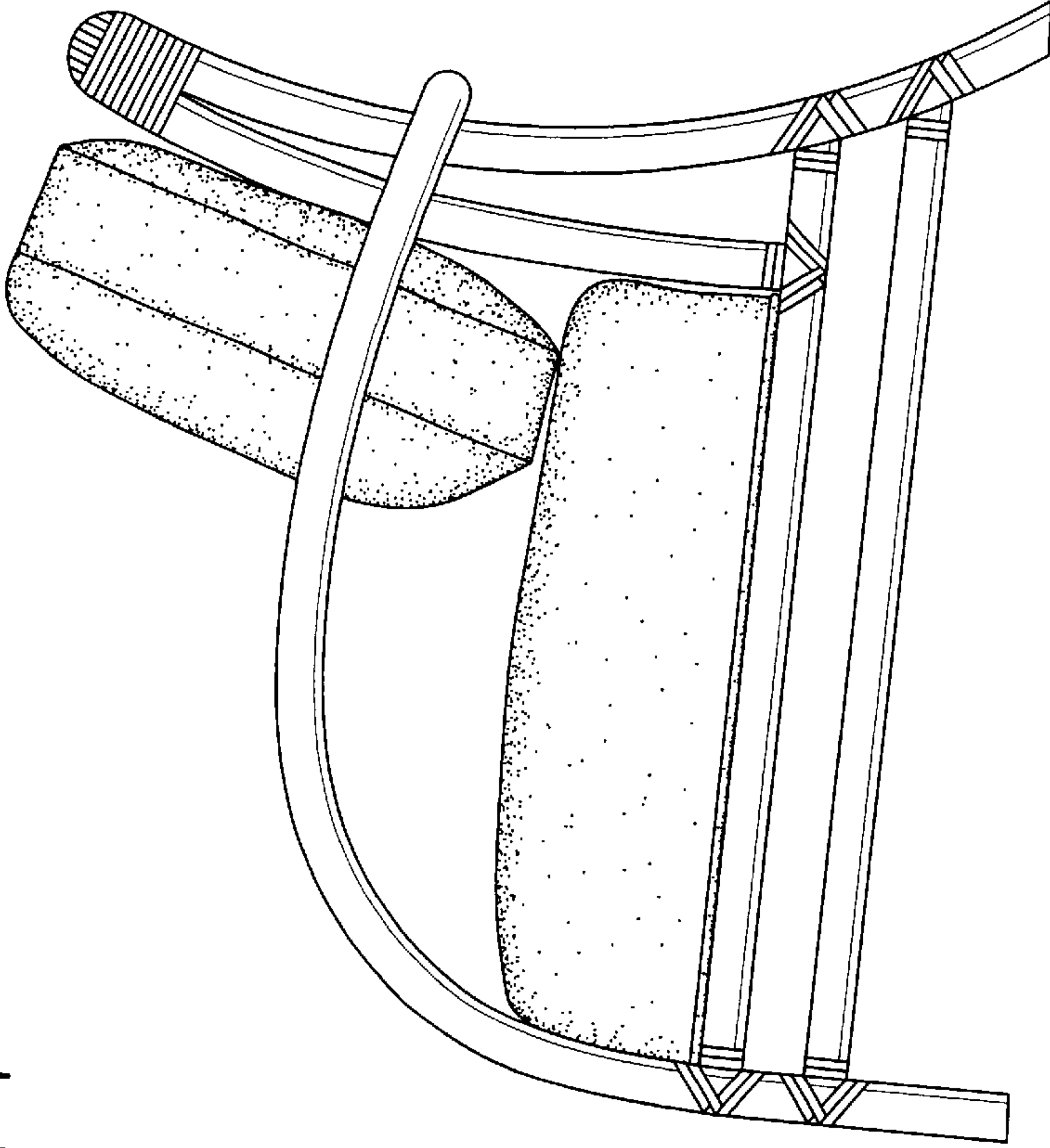

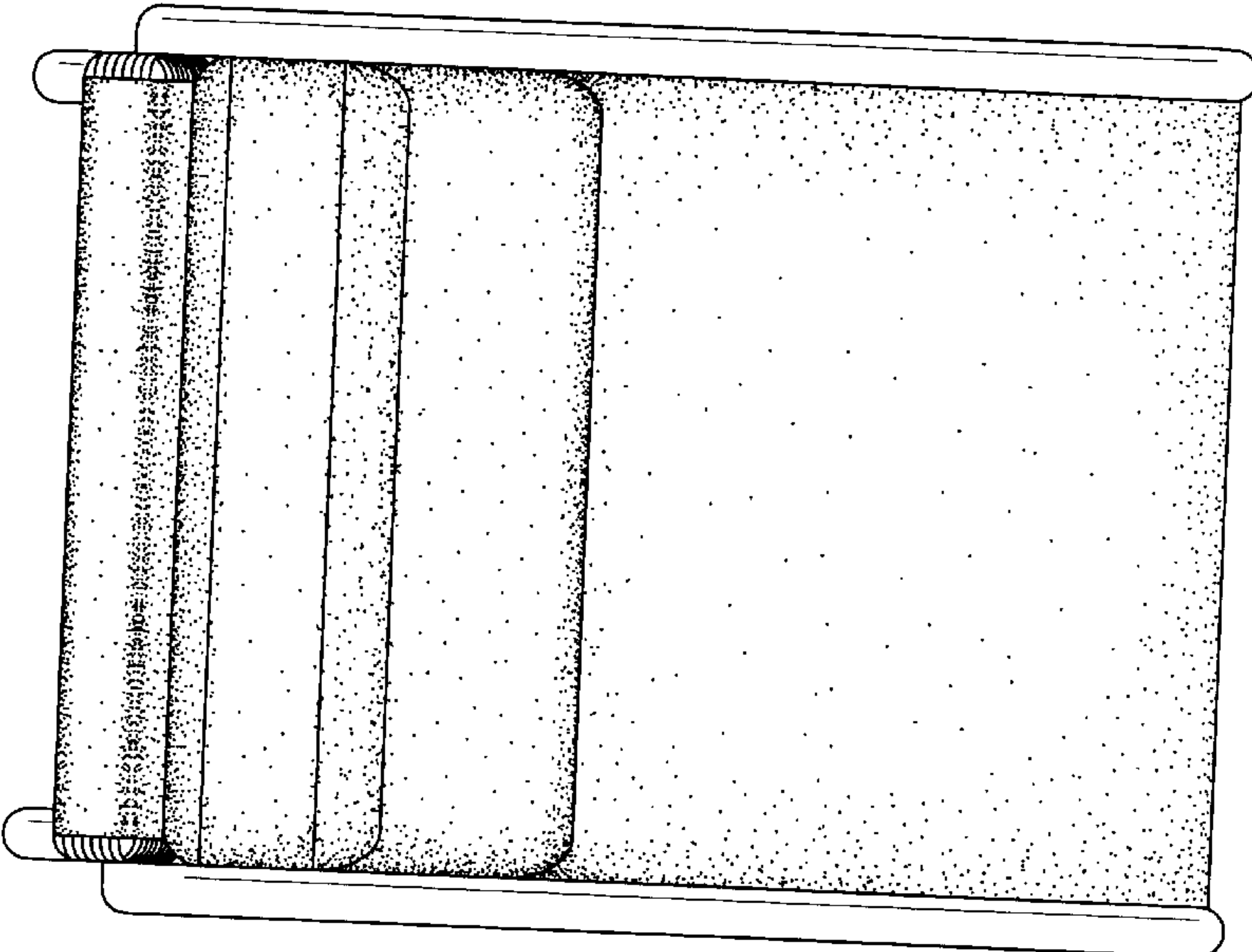
