FIG. 3 is a top view thereof.

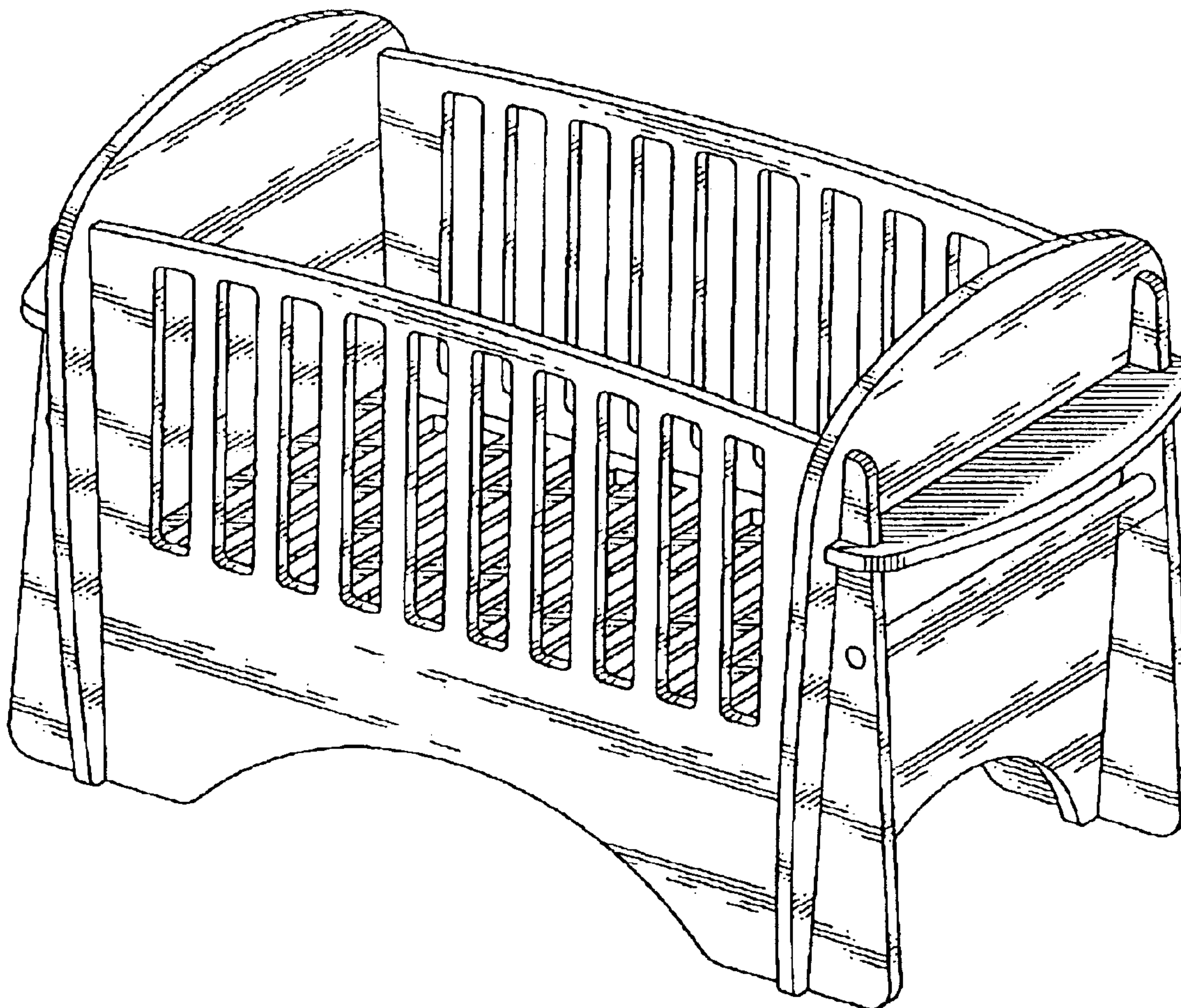
FIG. 4 is a front view thereof, the rear being a mirror image; and,

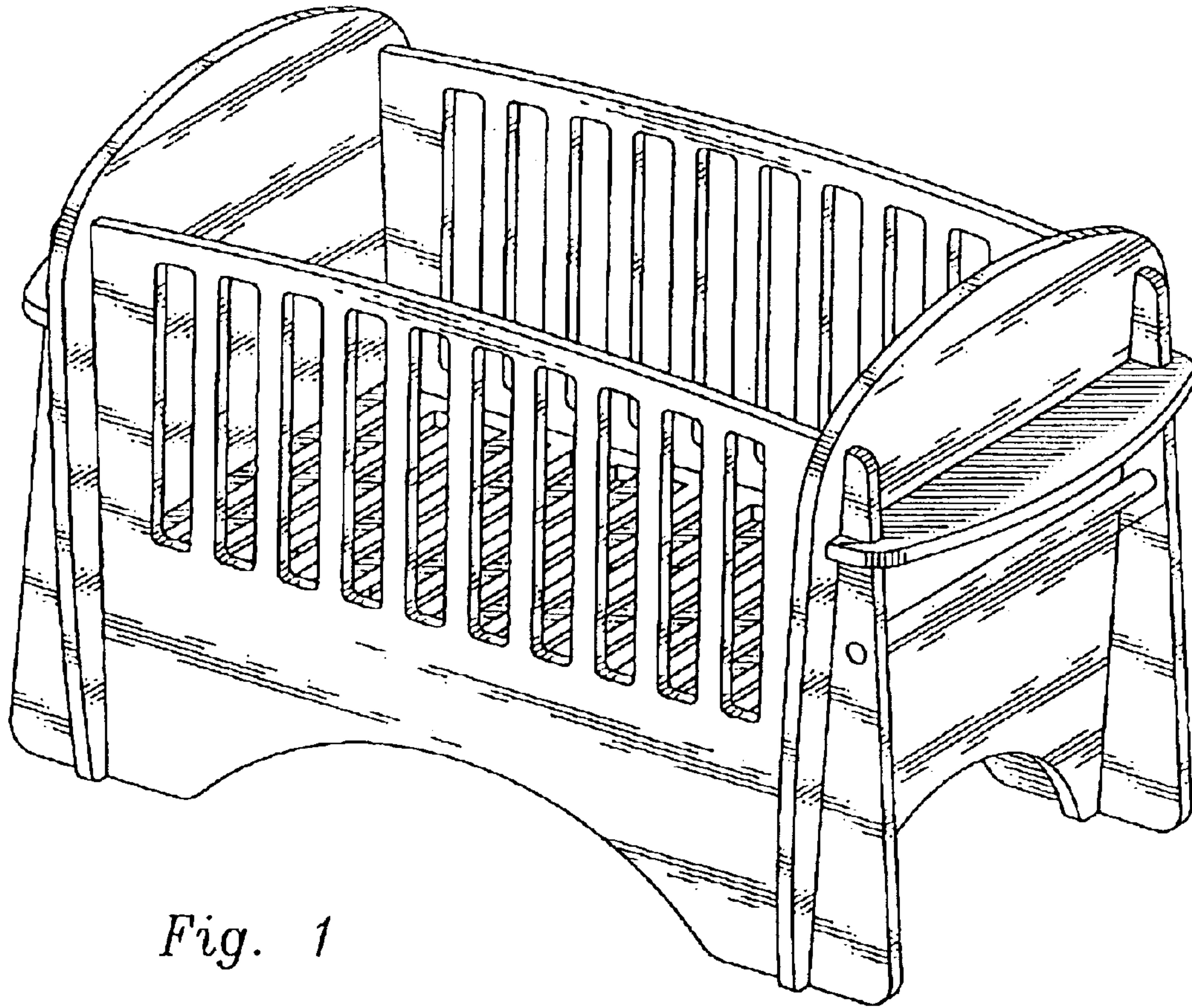

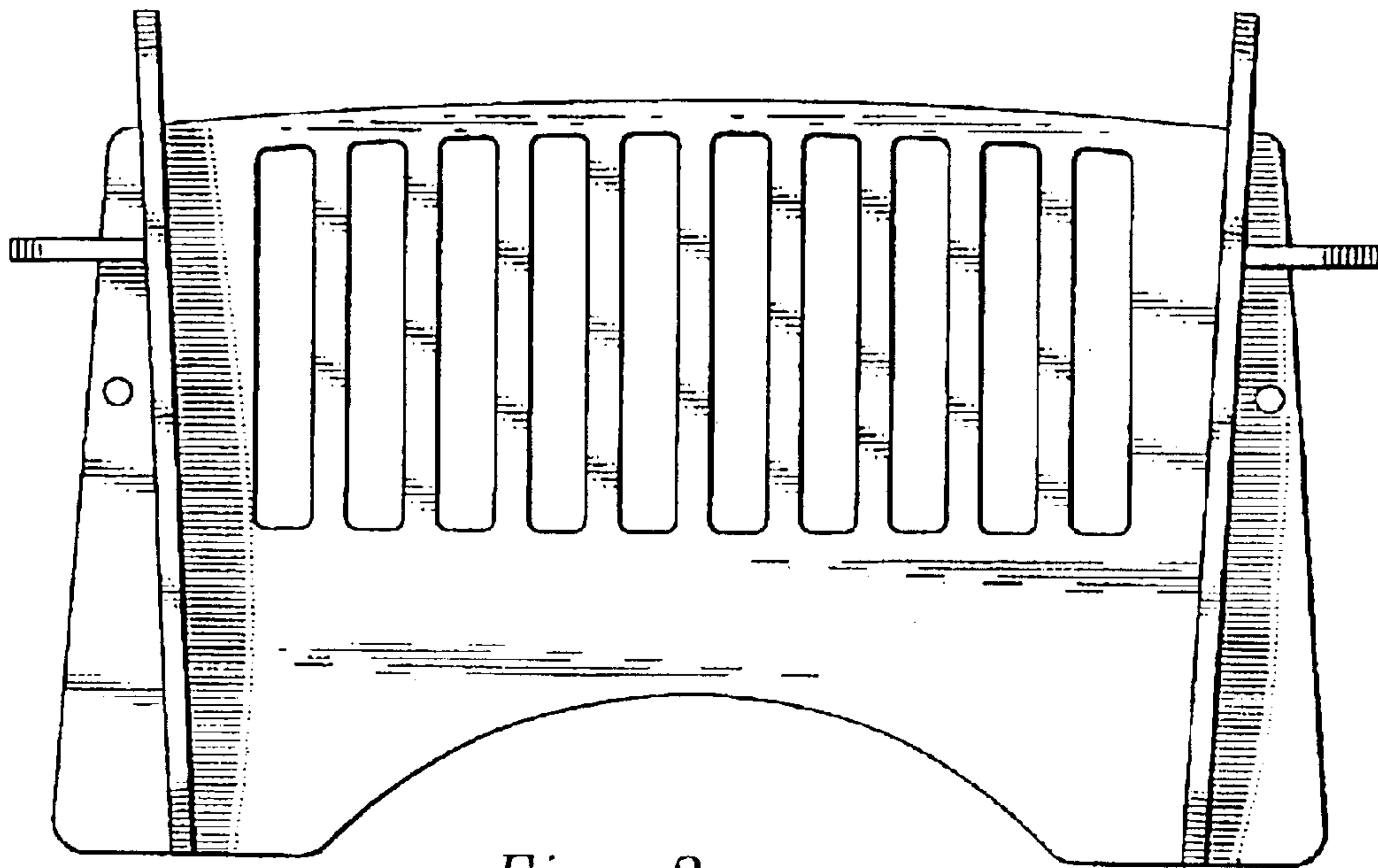

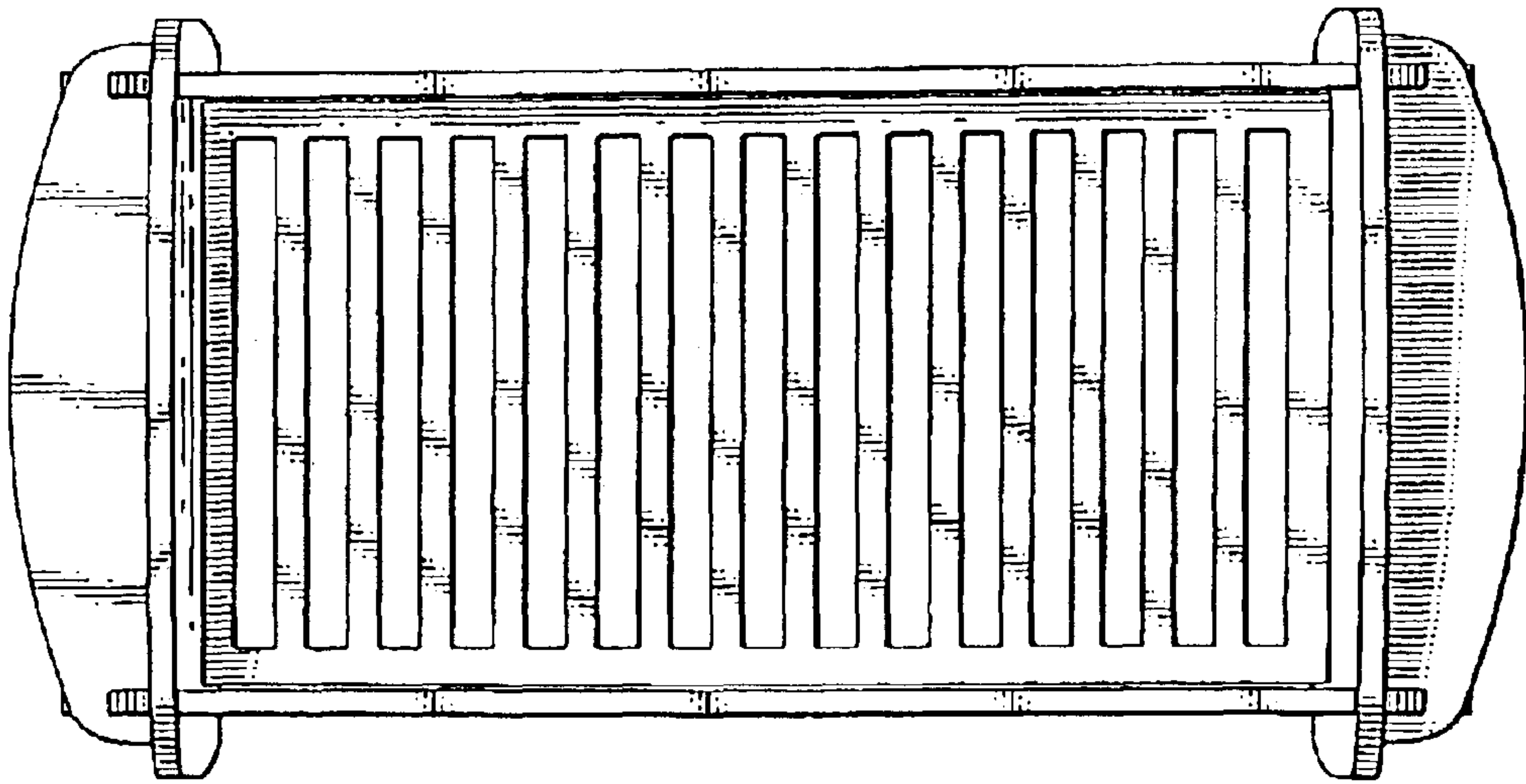

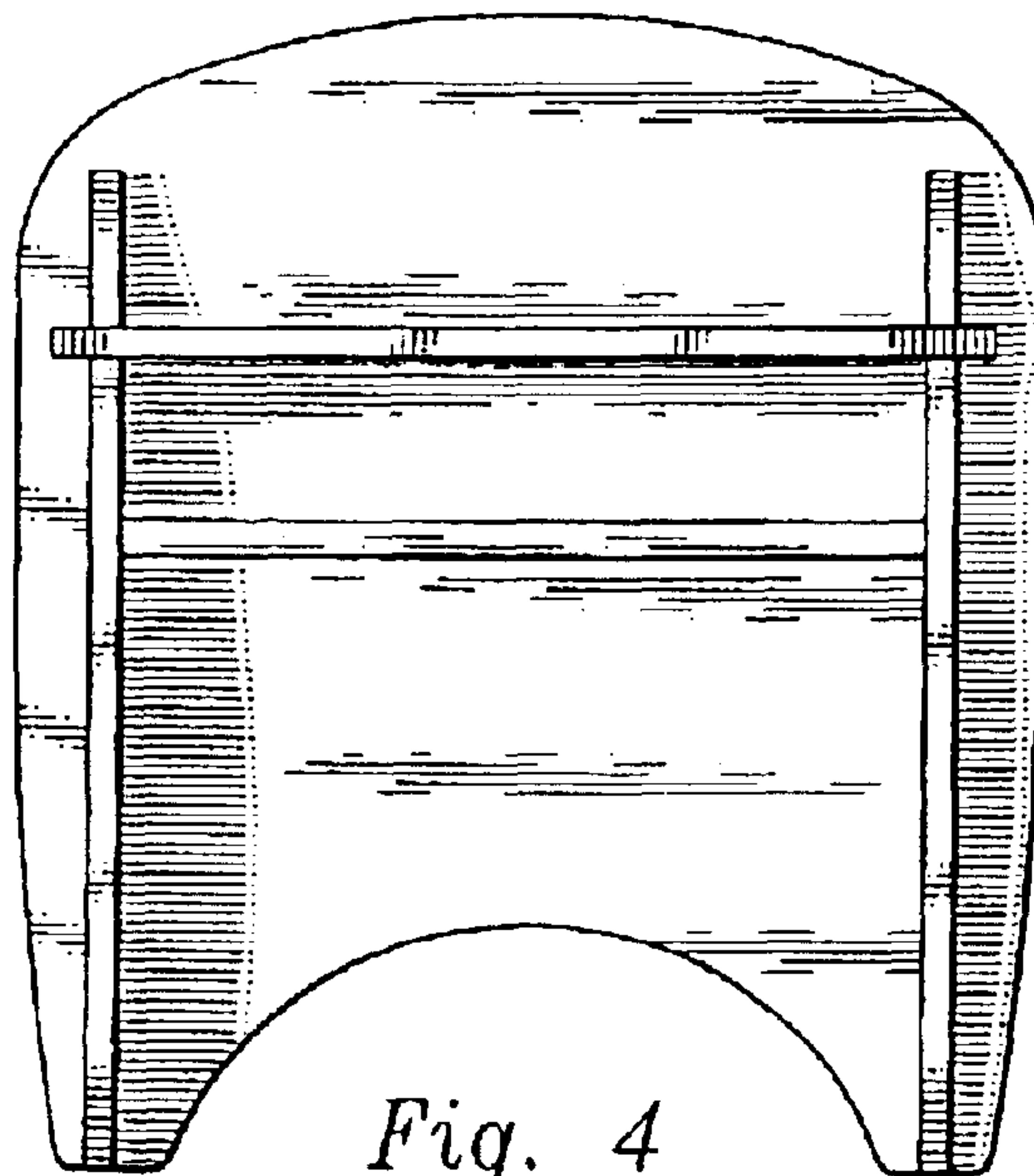

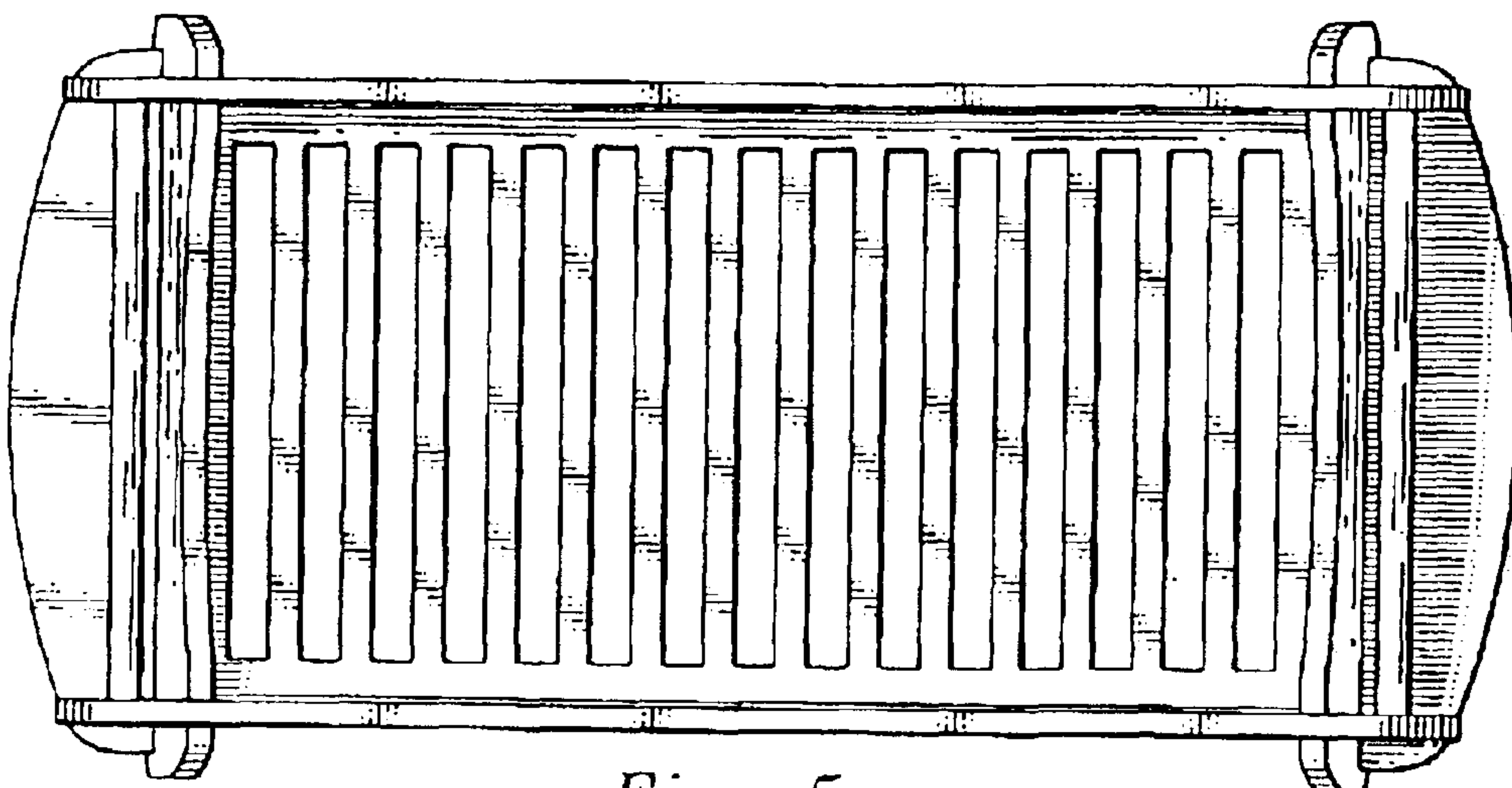
