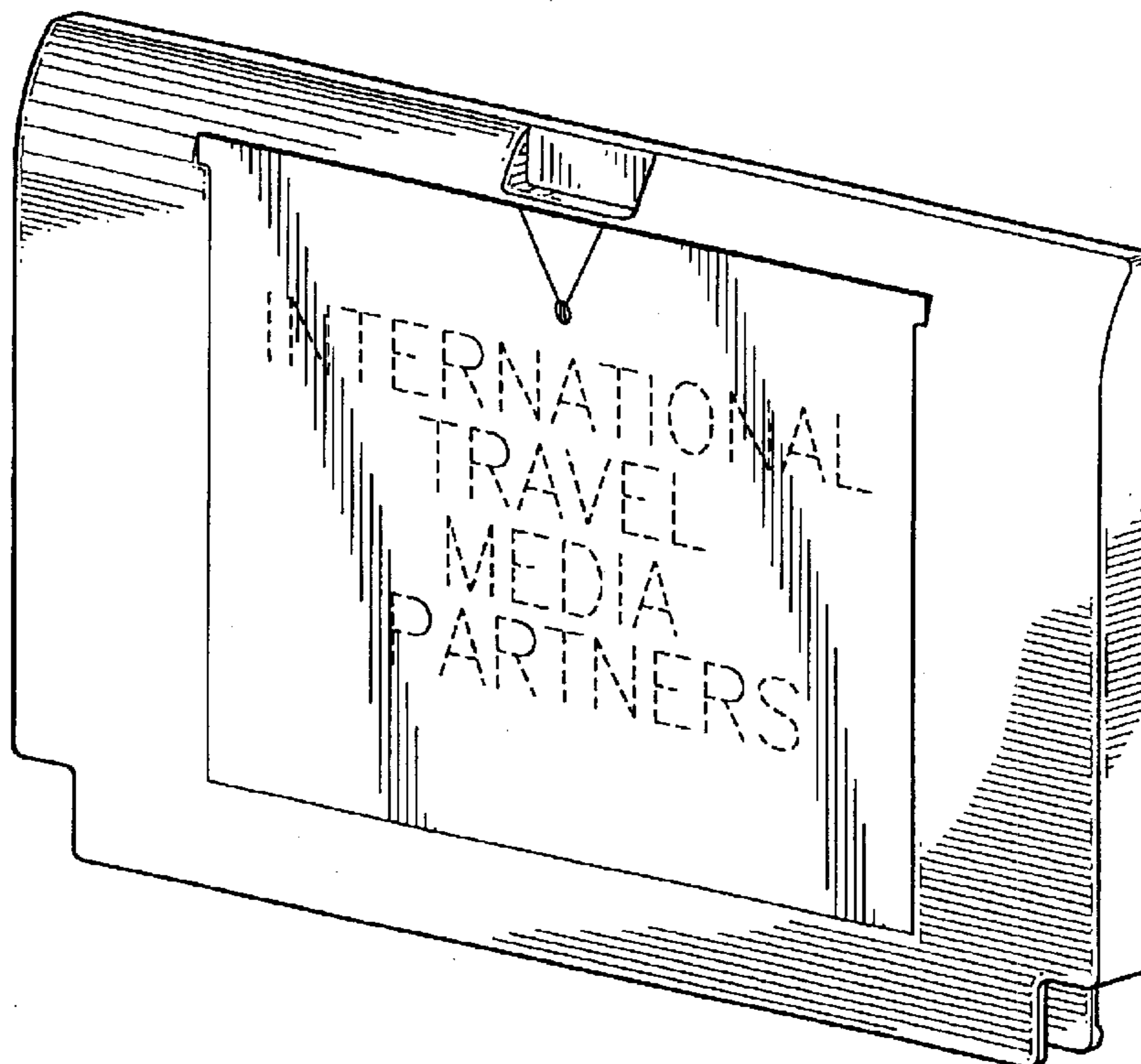
(57) **CLAIM**

The ornamental design for an airliner tray table with an advertisement window, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the airliner tray table with an advertisement window.
 FIG. 2 is a front view of the airliner tray table with an advertisement window.
 FIG. 3 is a top view of the airliner tray table with an advertisement window of FIG. 1.
 FIG. 4 is a bottom view of the airliner tray table with an advertisement window of FIG. 1.
 FIG. 5 is a back view of the airliner tray table with an advertisement window of FIG. 1; and,
 FIG. 6 is a left side view of the airliner tray table with an advertisement window of FIG. 1, the right side view being a mirror image thereof.
 The broken line showing of the written indicia in FIGS. 1 and 2 is for illustrative purposes only and forms no part of the claimed design.

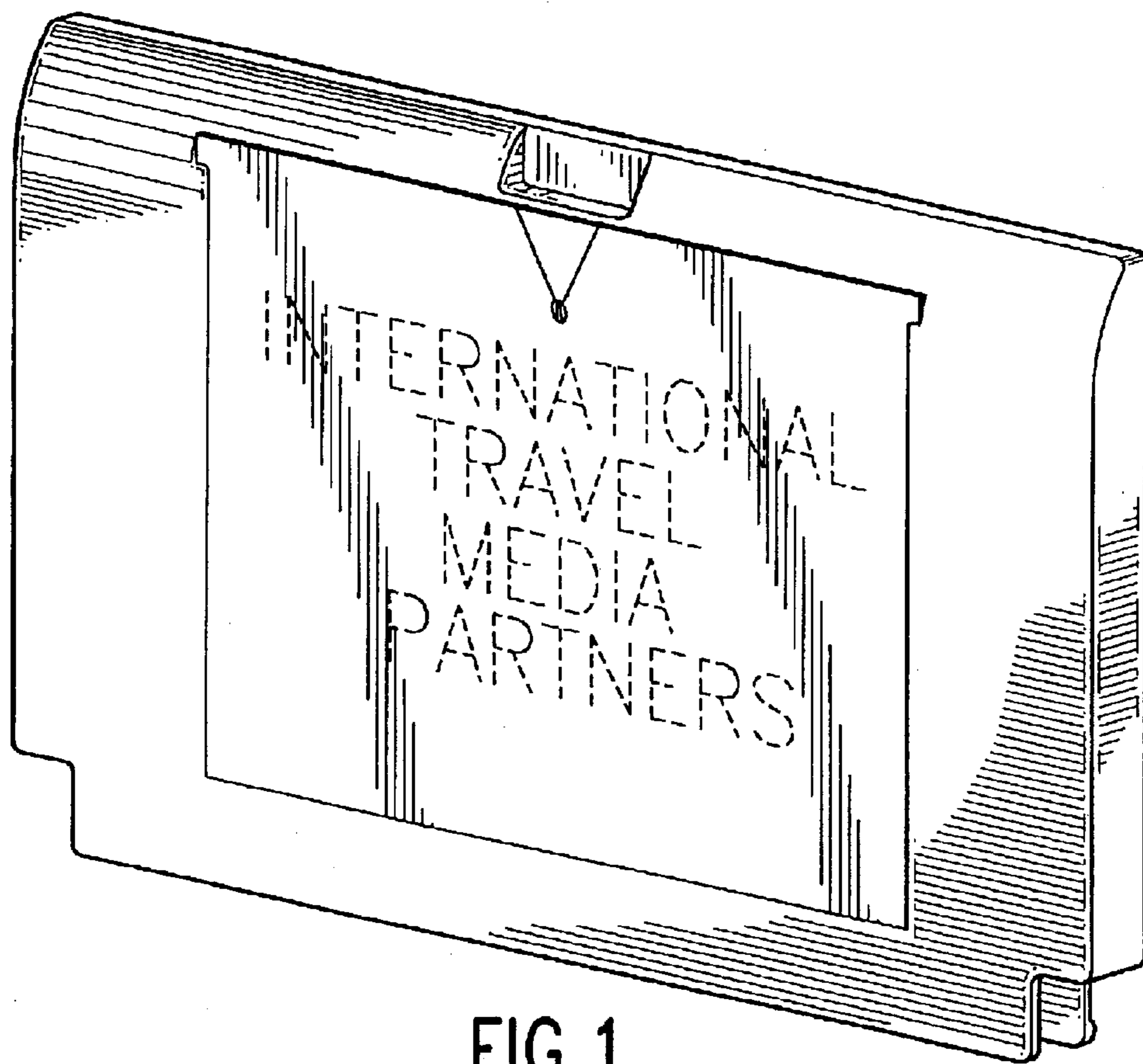

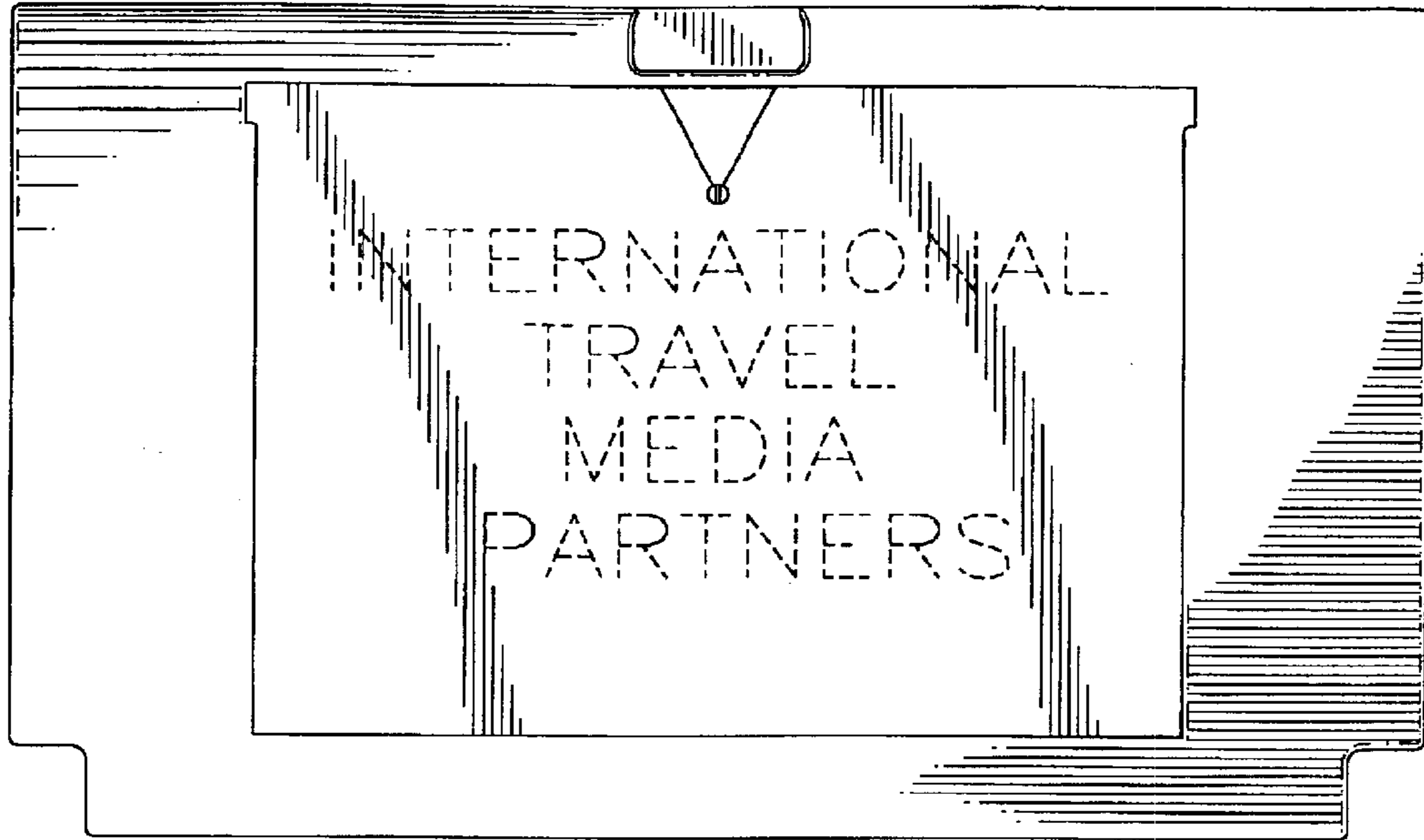

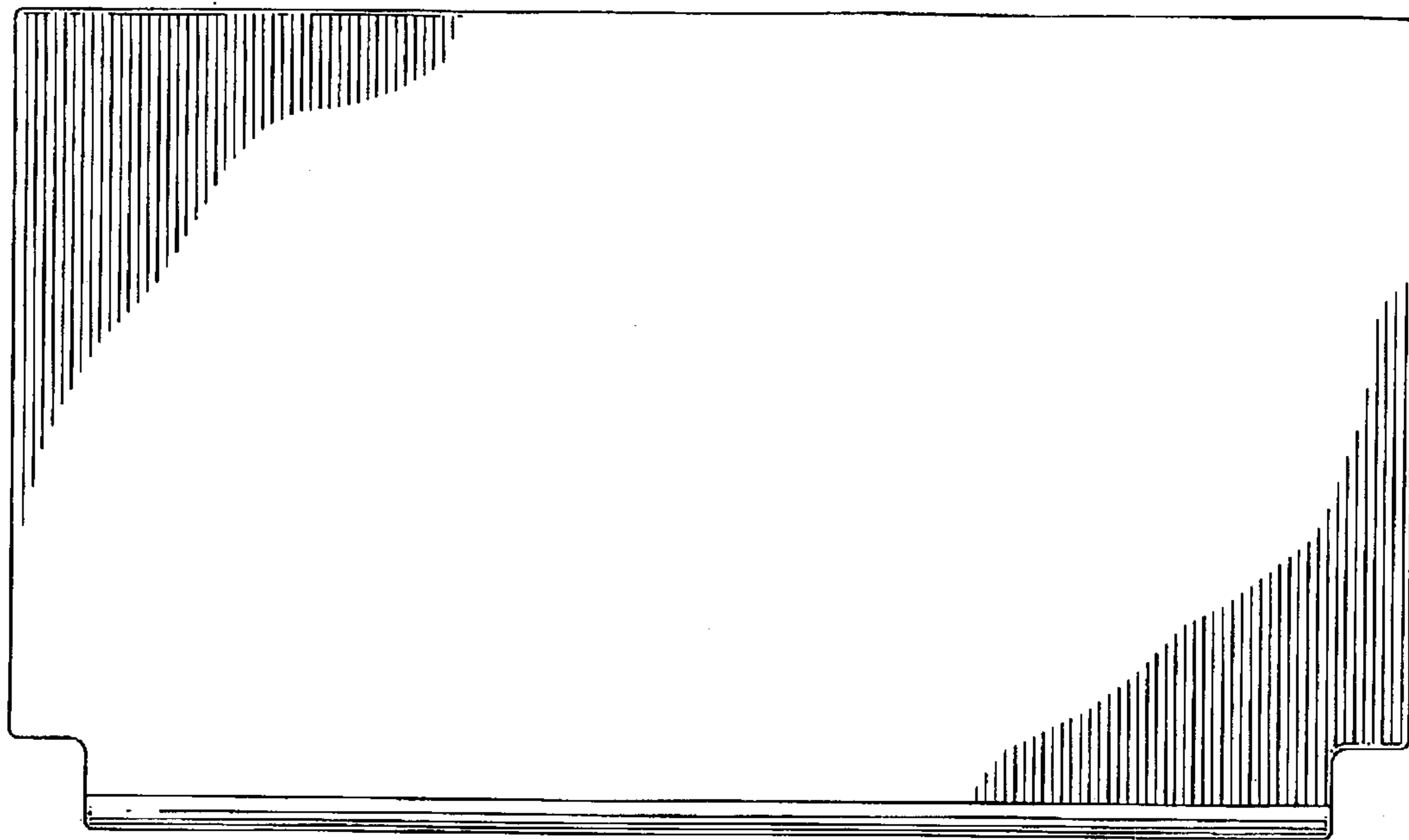
