DESCRIPTION

FIG. 1 is a perspective view of a neck towel for absorbing perspiration.

FIG. 2 is a front elevational view thereof.

FIG. 3 is a rear elevational view thereof.

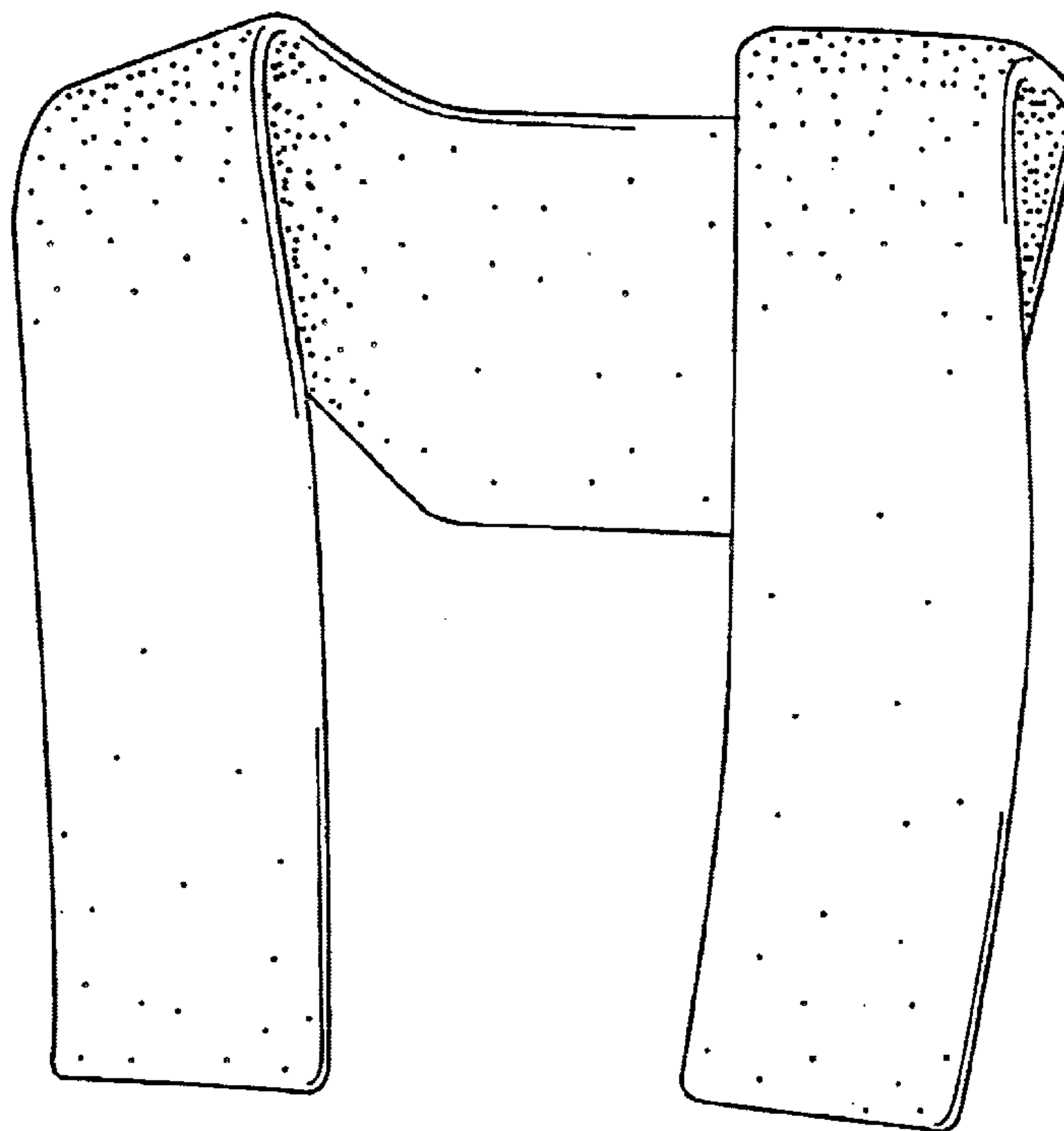
FIG. 4 is a right side elevational view thereof.

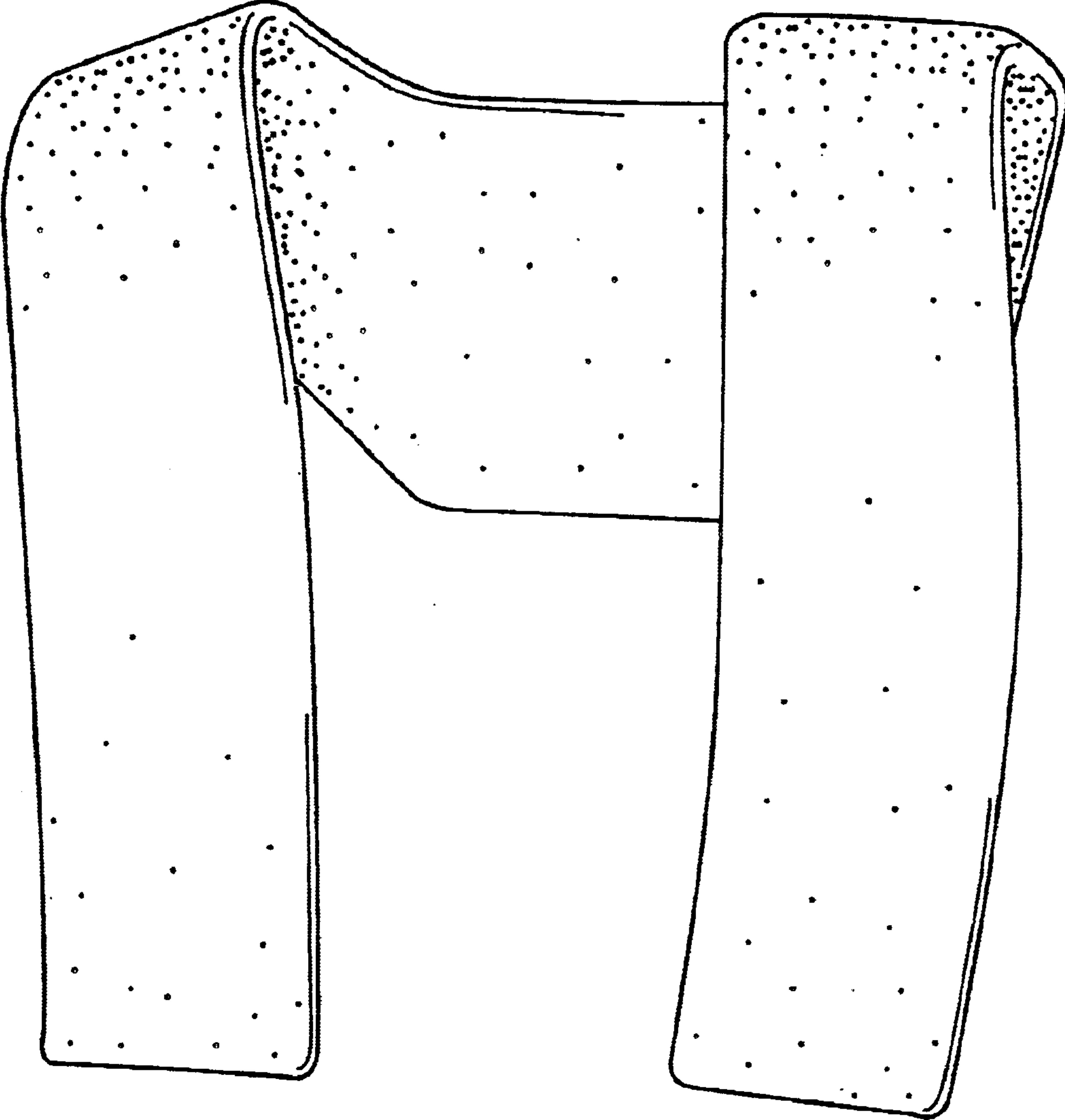

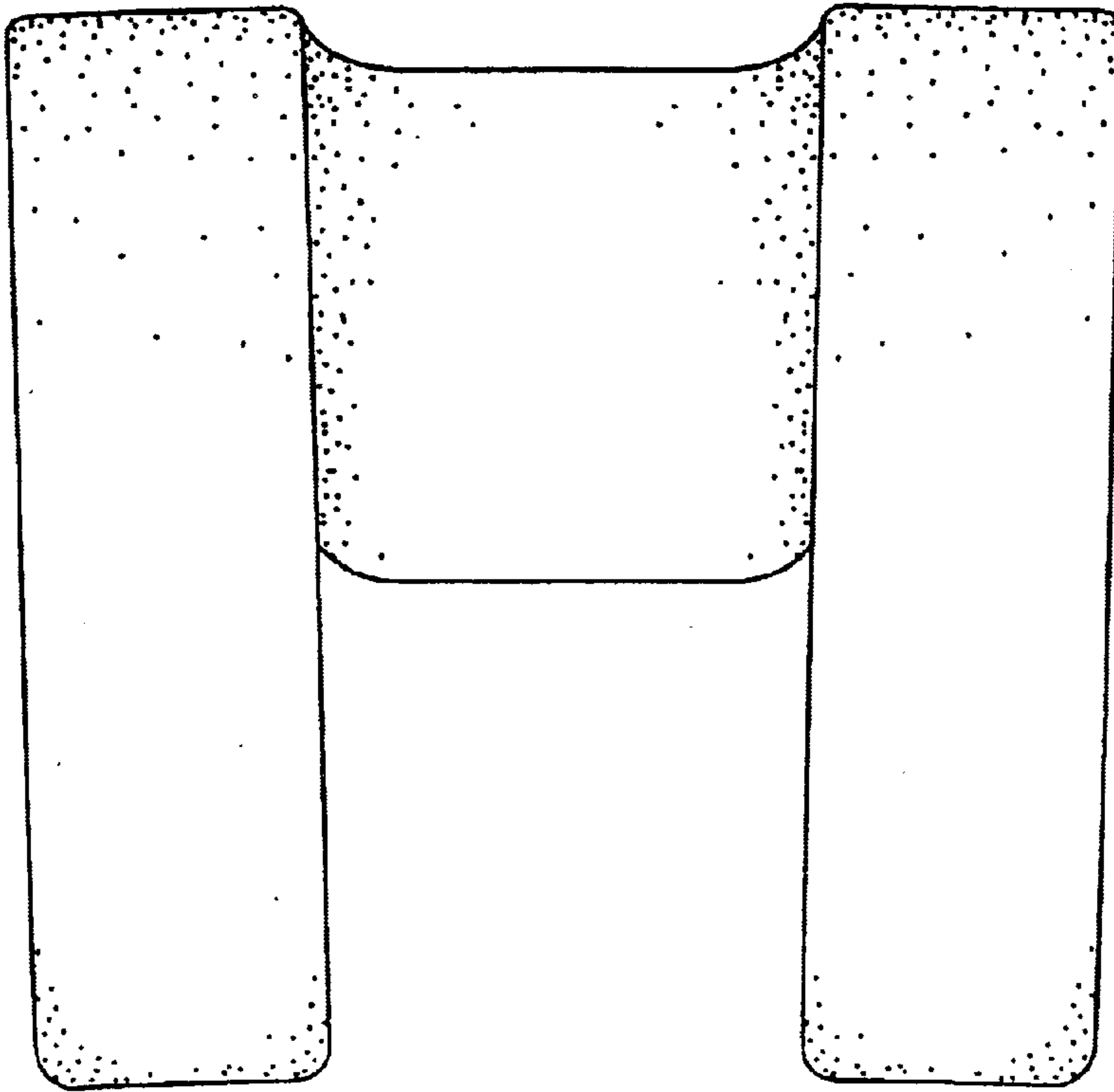

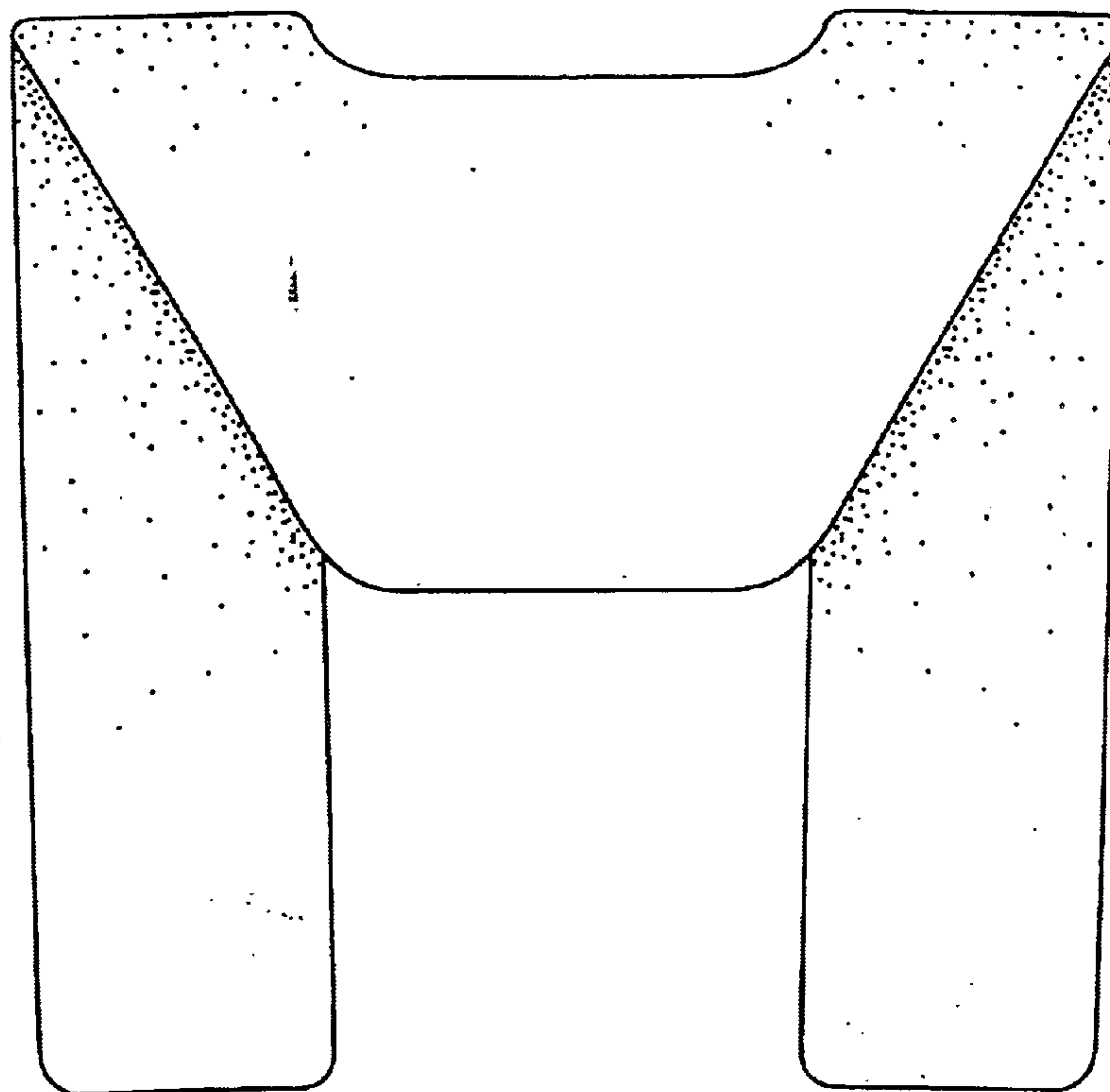

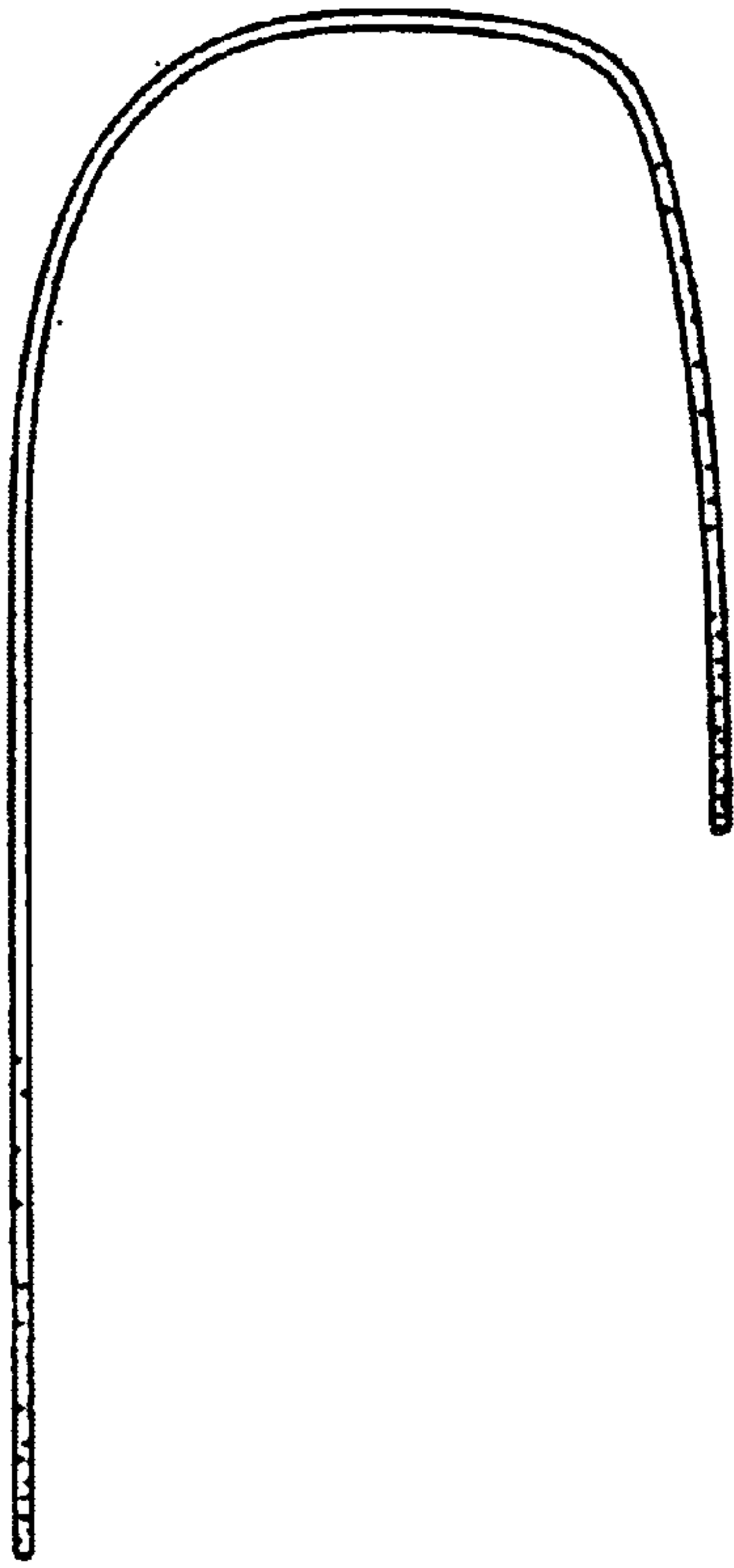

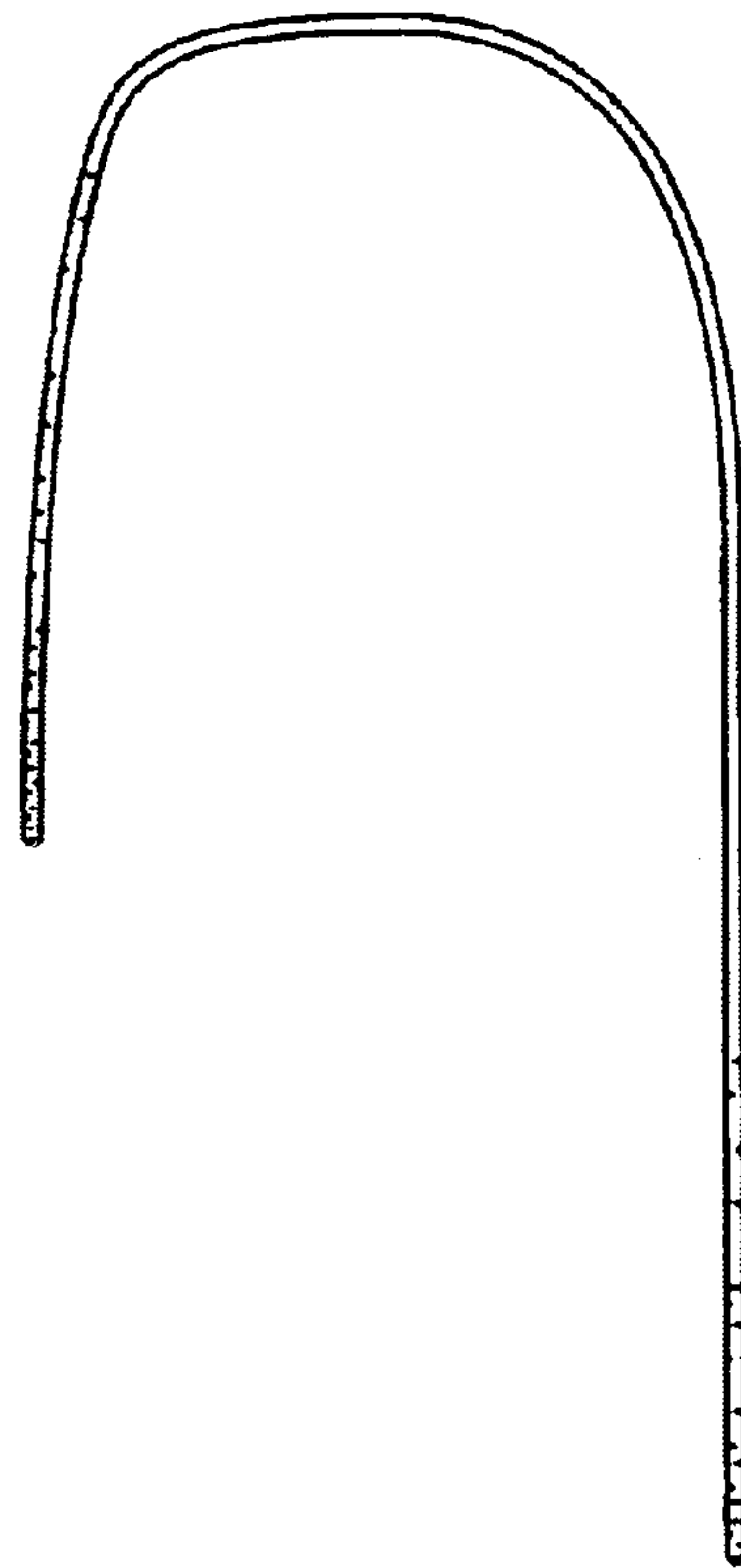

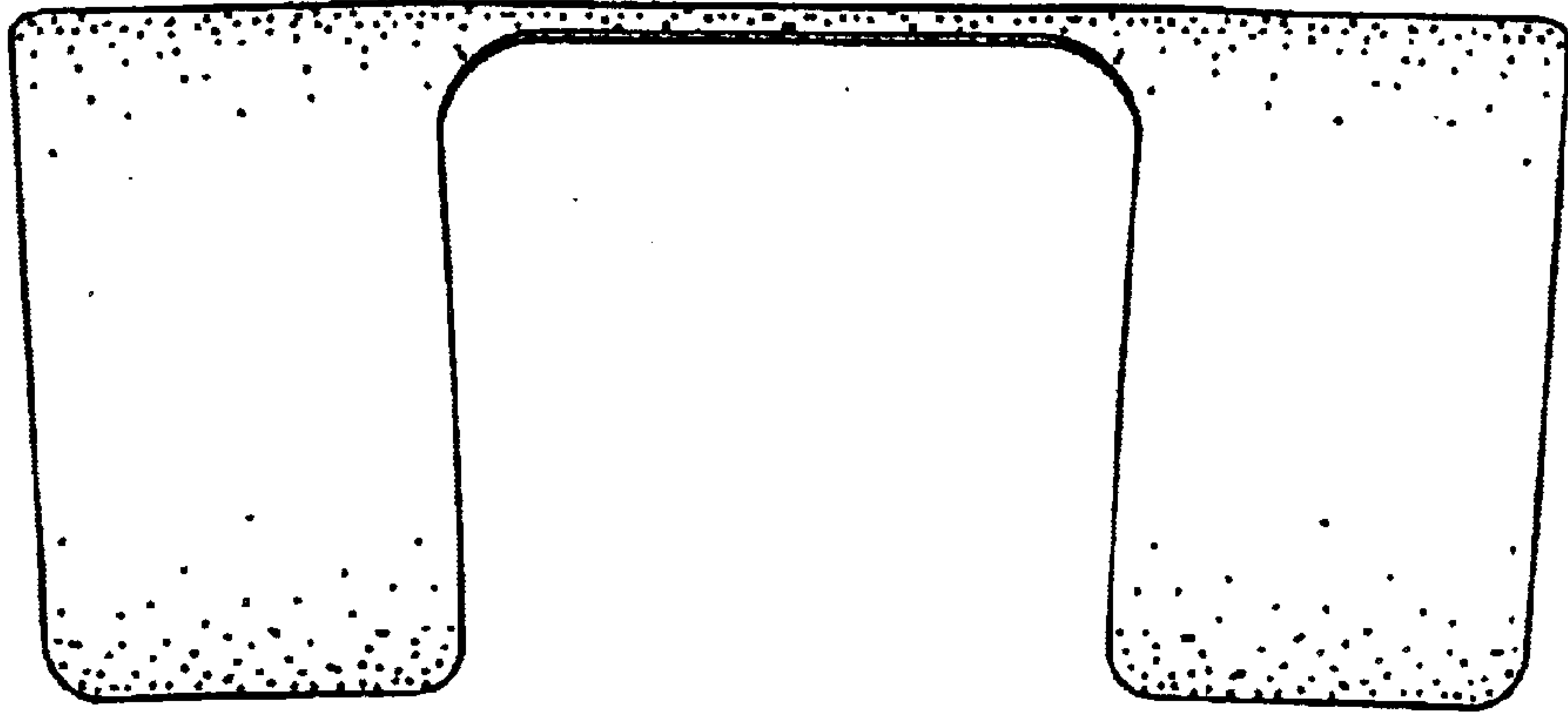

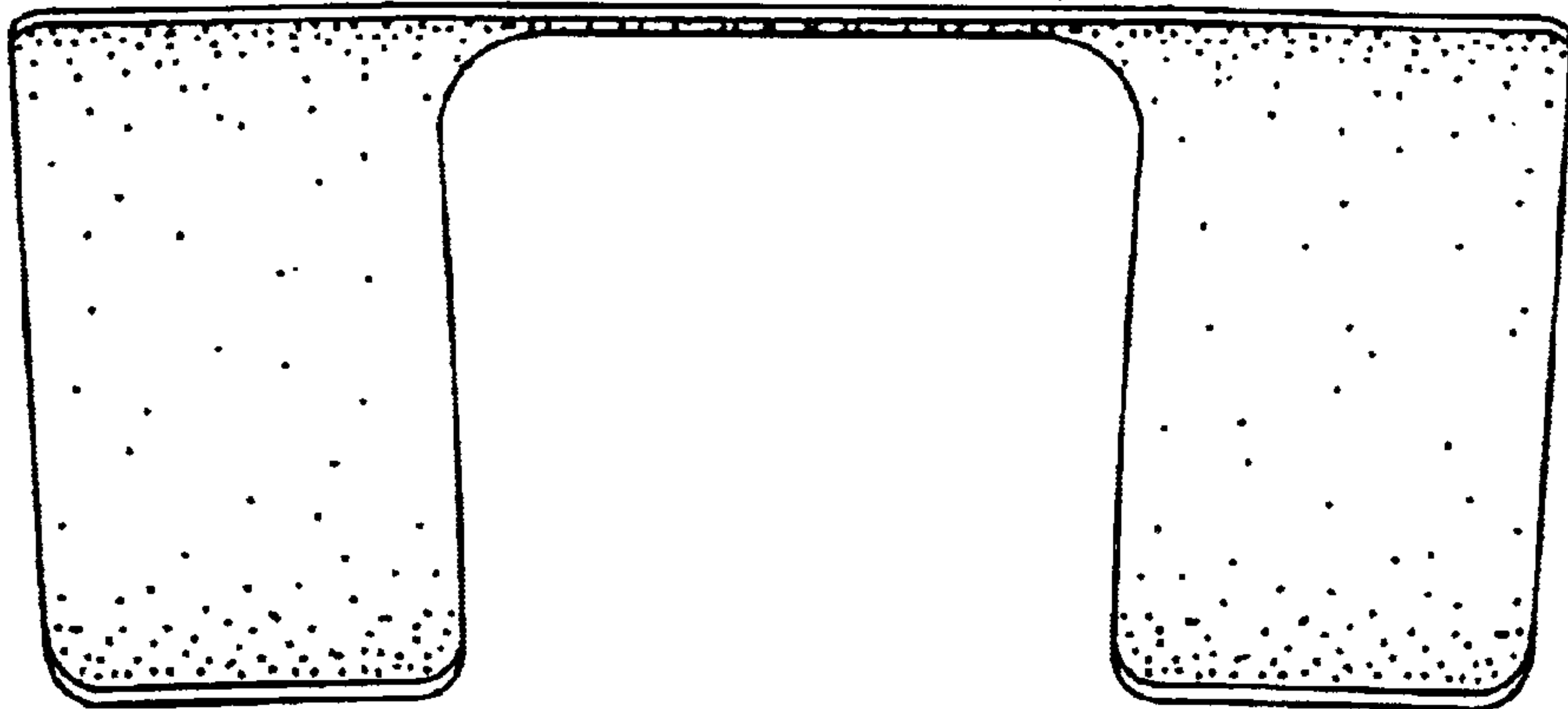
