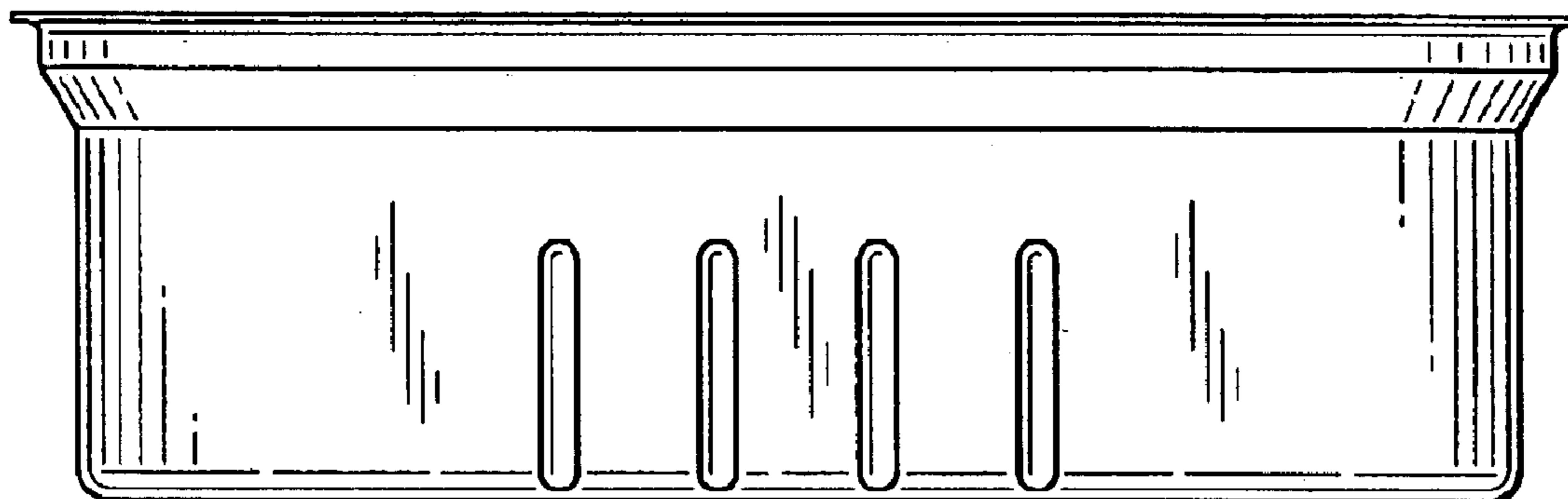
(57) **CLAIM**

The ornamental design for a single serving canned meat container, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of the single serving canned meat container;
FIG. 2 is a side elevational view of the container of FIG. 1, the opposite side being a mirror image;
FIG. 3 is a sectional elevational view taken along line 3—3 of FIG. 1;
FIG. 4 is a bottom plan view; and,
FIG. 5 is an end elevational view, the opposite end being a mirror image.

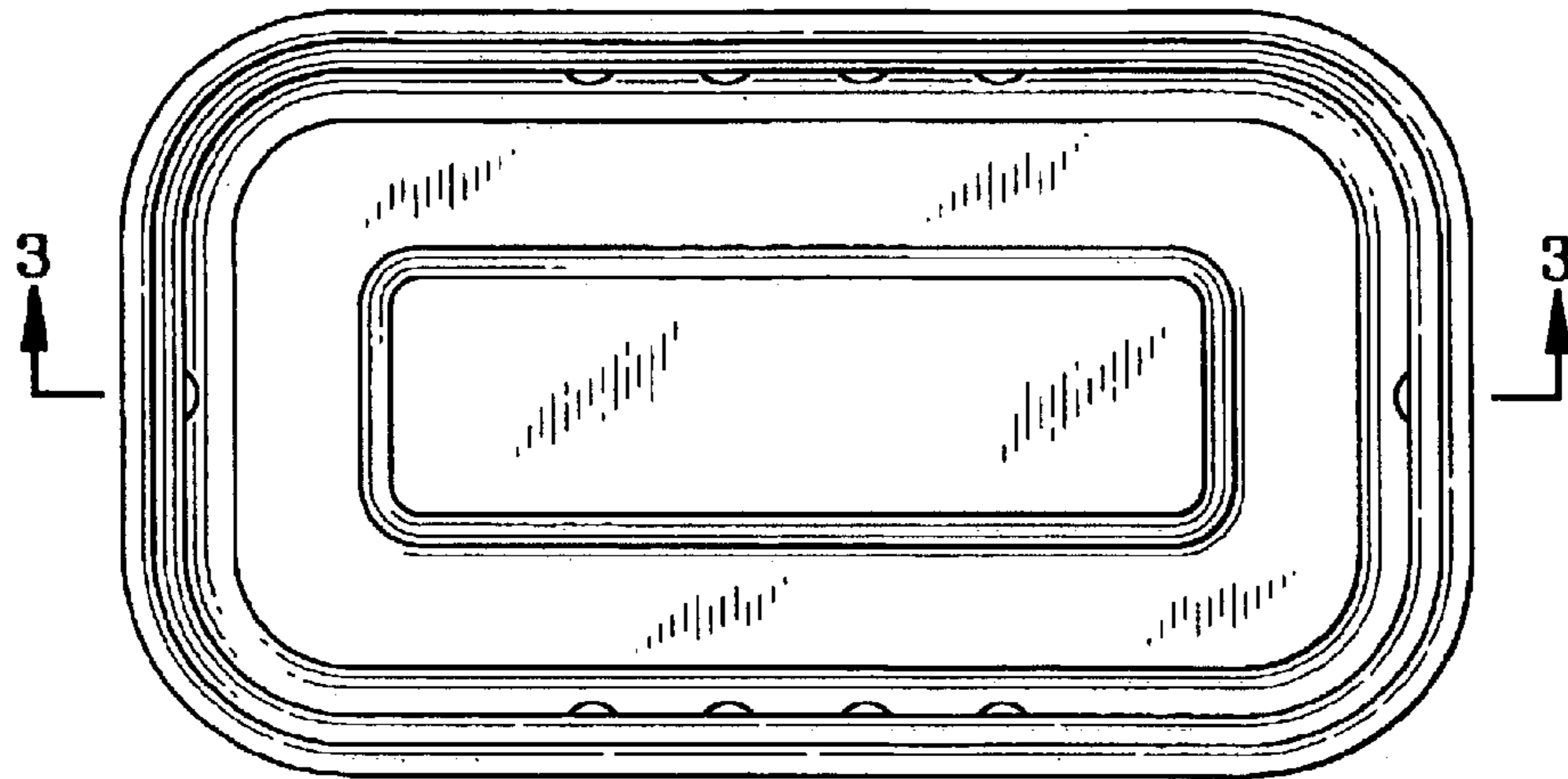

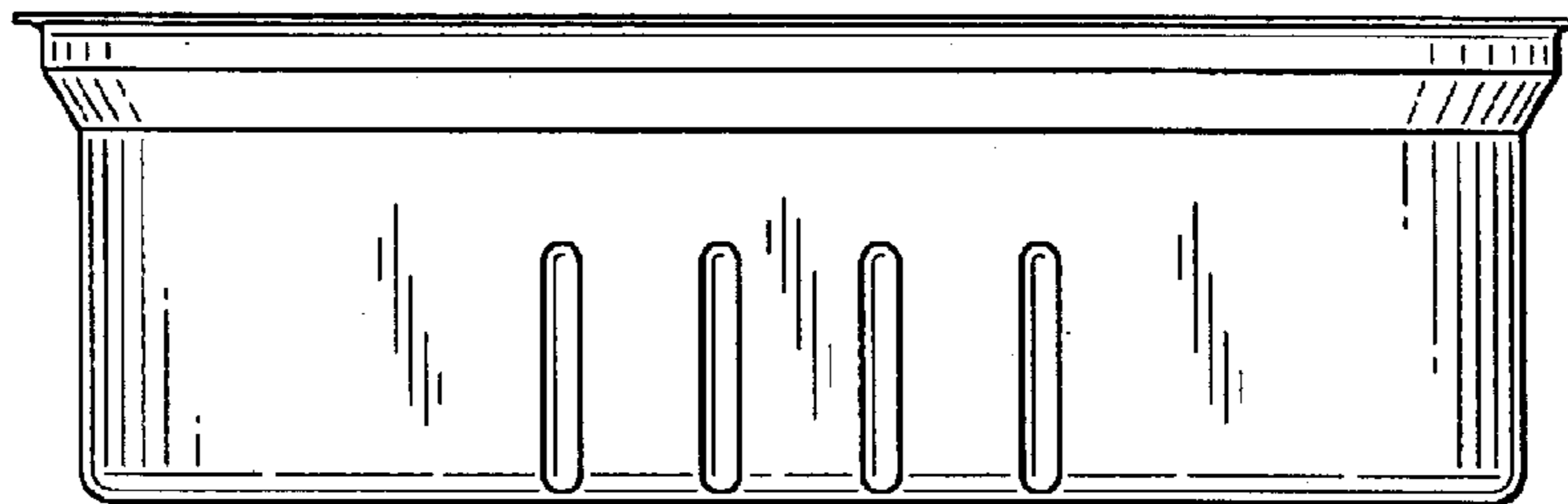

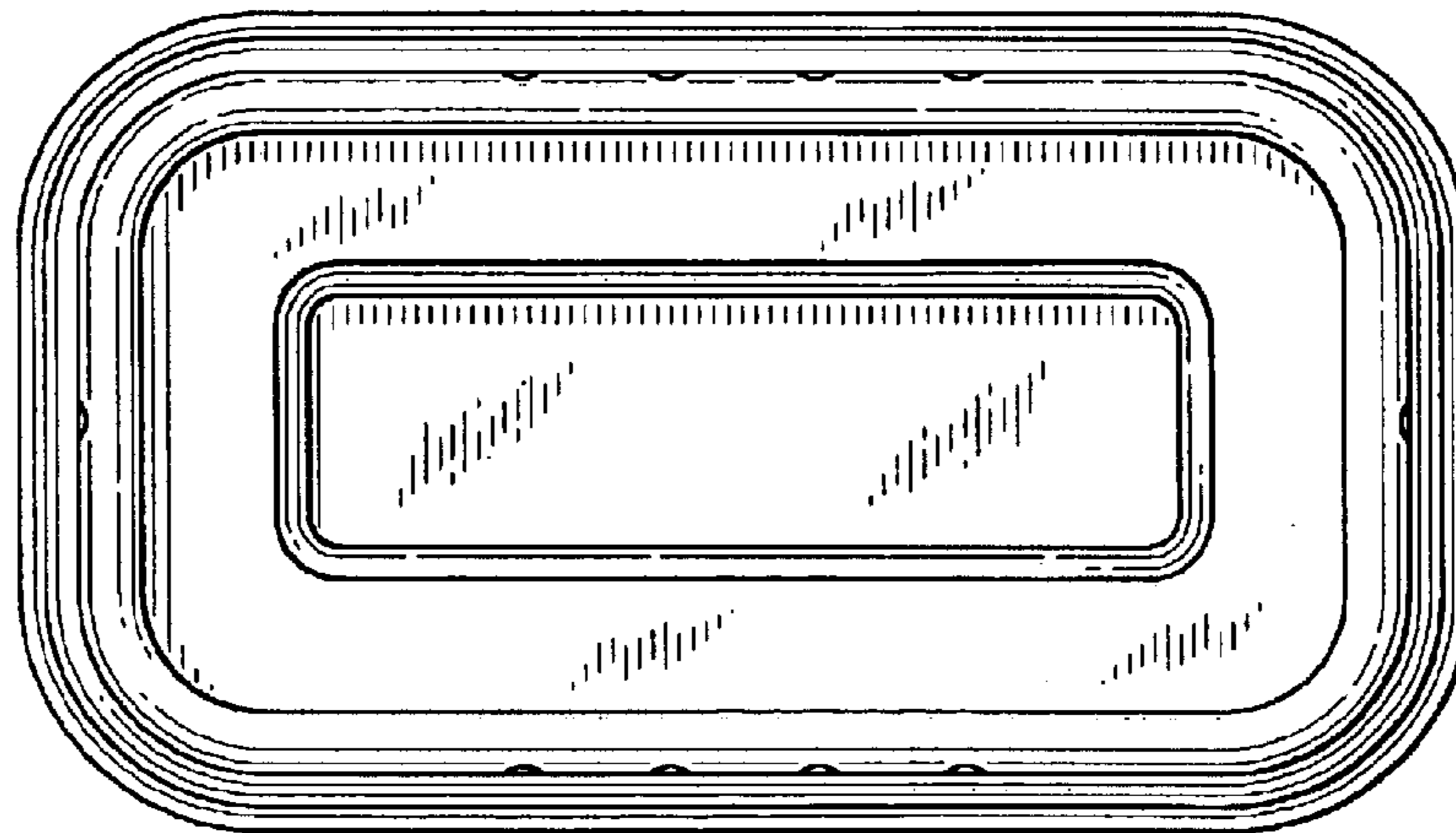

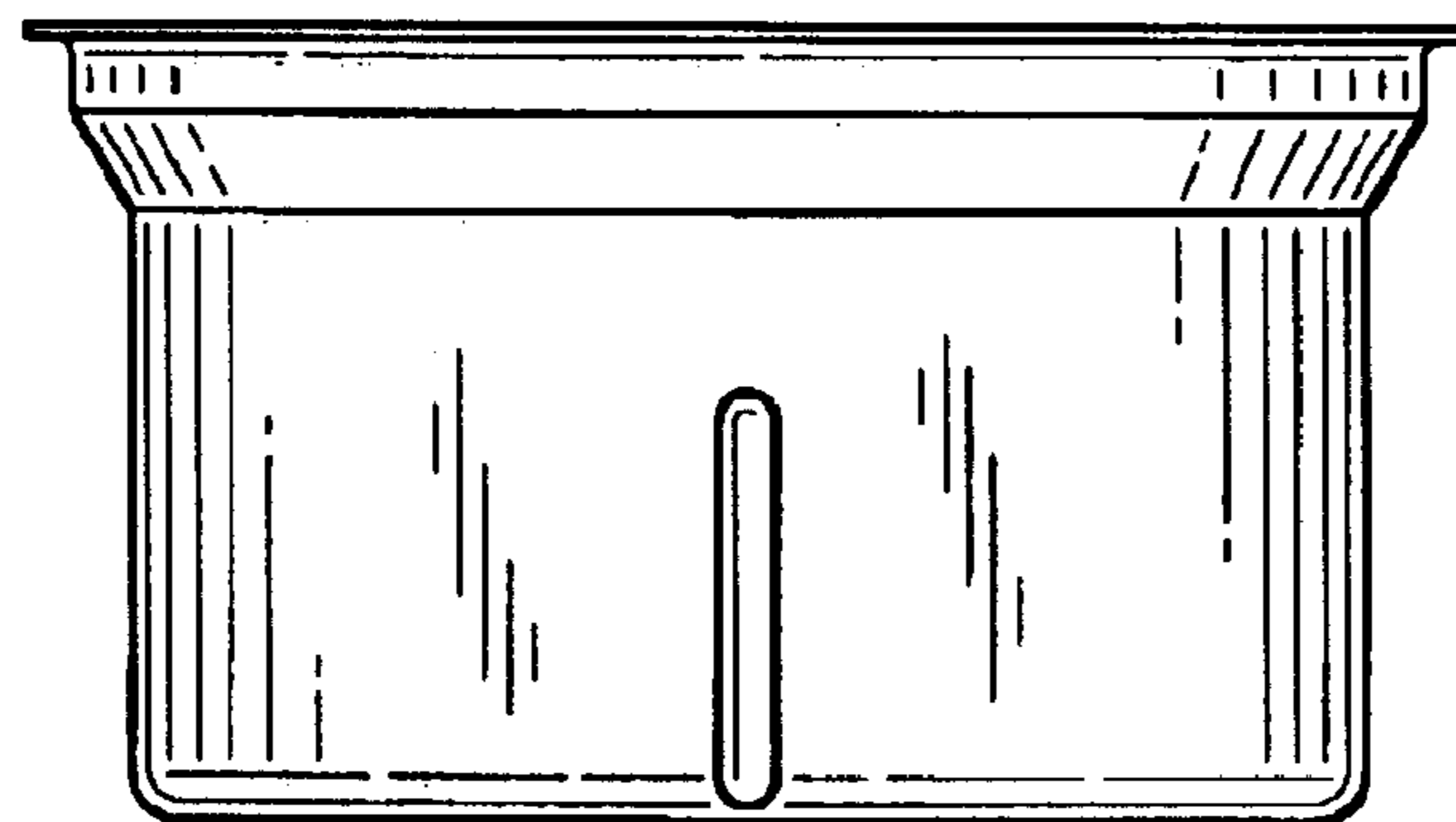
