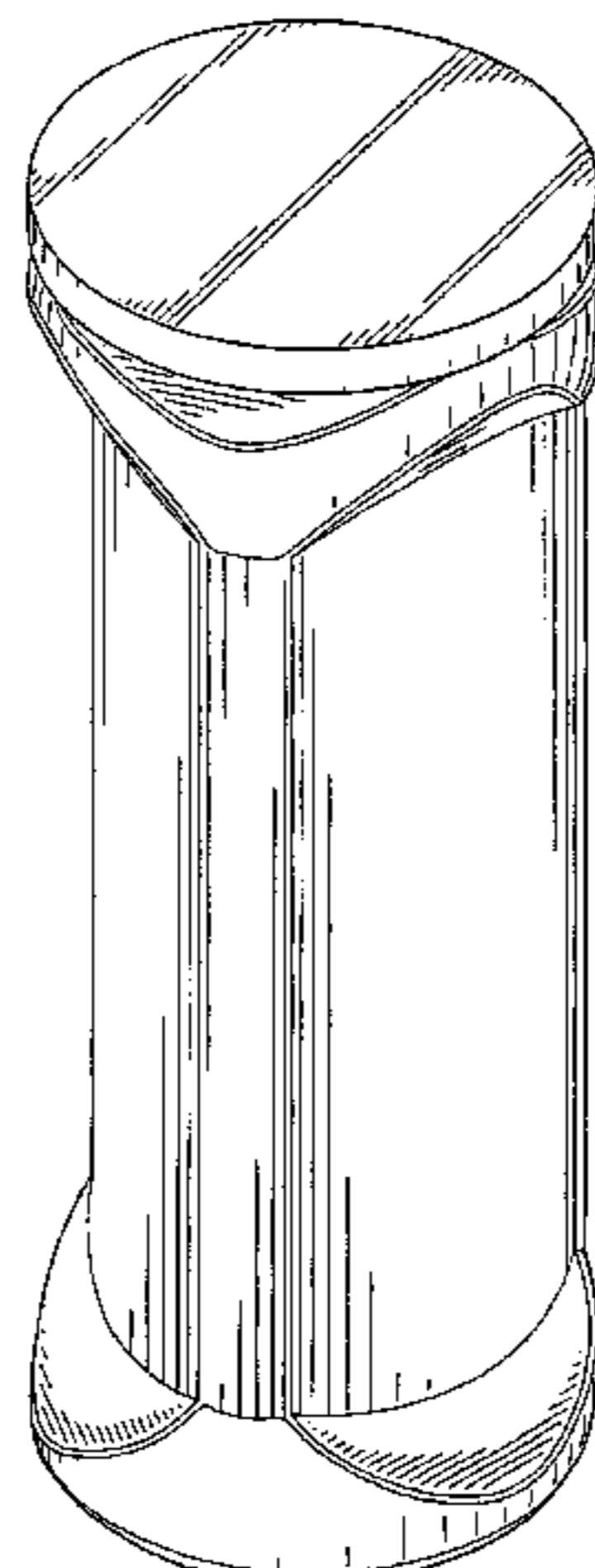
(57) **CLAIM**

The ornamental design for a snack food container, as shown and described.

DESCRIPTION

FIG. 1 is a front, top perspective view of the snack food container of the present invention;
FIG. 2 is a front elevation view of the snack food container of the present invention;
FIG. 3 is a left elevation view of the snack food container of the present invention, the right elevation view being a mirror image of the left elevation view;
FIG. 4 is a rear elevation view of the snack food container of the present invention;
FIG. 5 is a top plan view of the snack food container of the present invention; and,
FIG. 6 is a bottom plan view of the snack food container of the present invention.

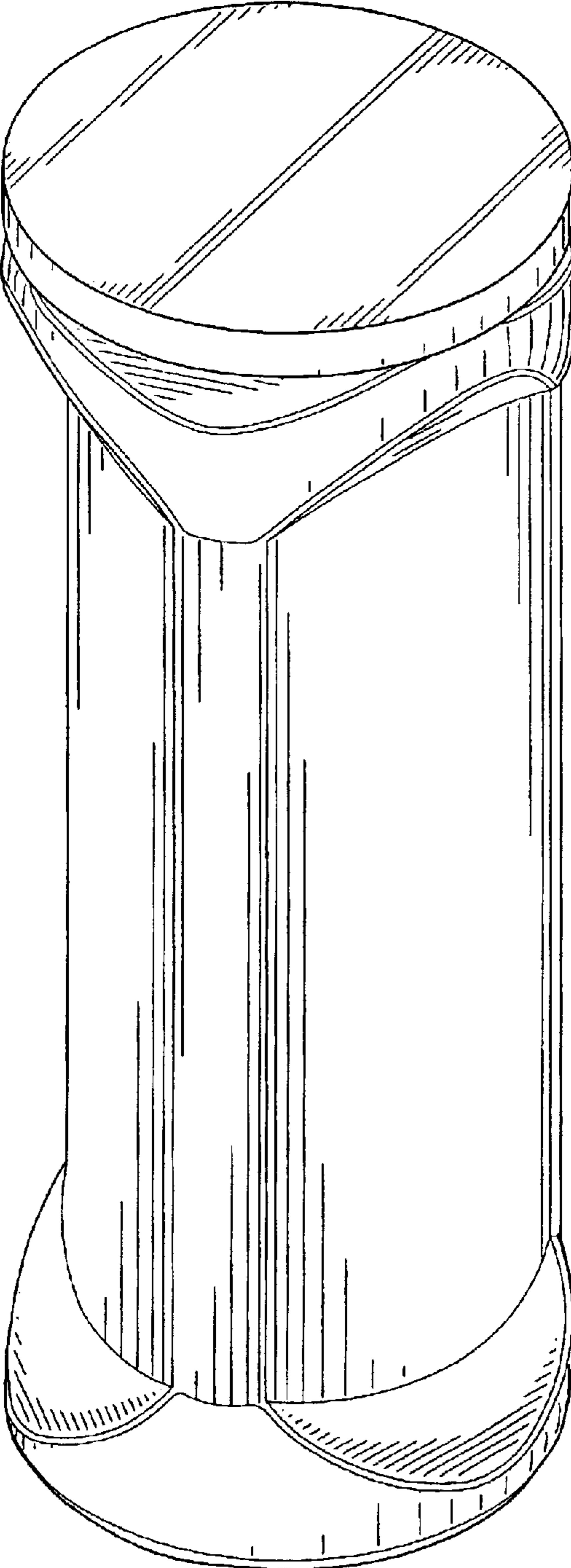

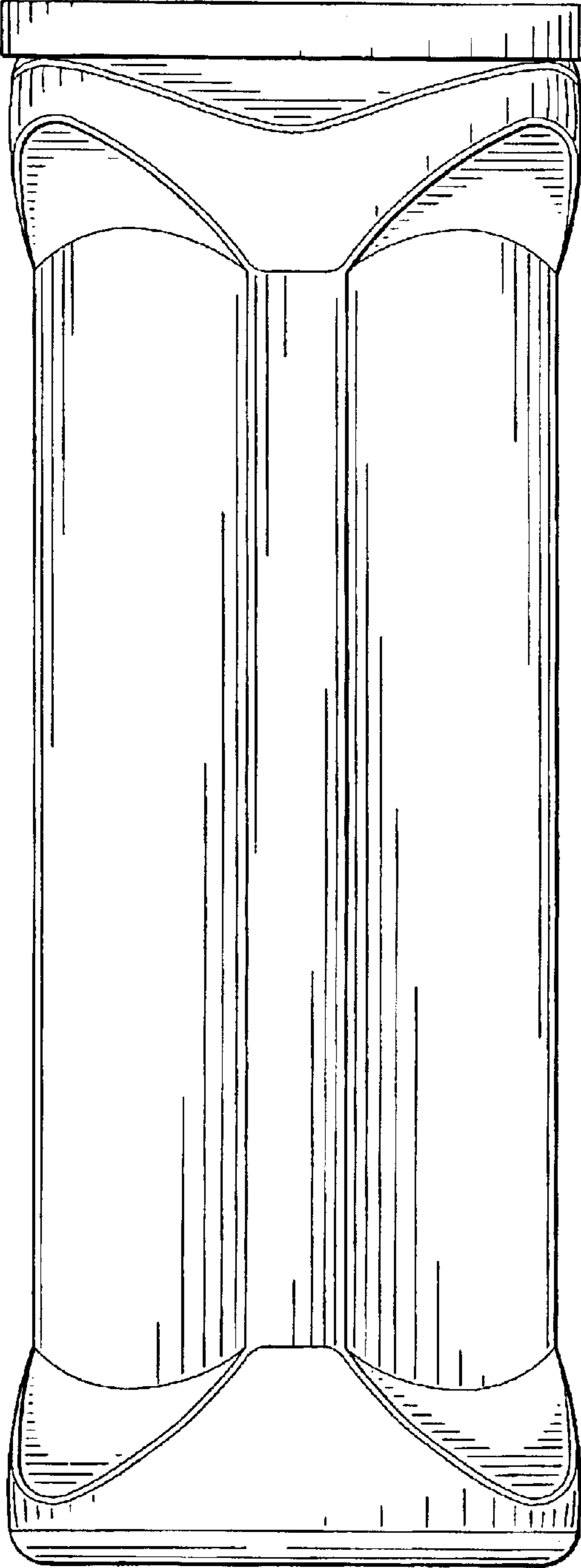

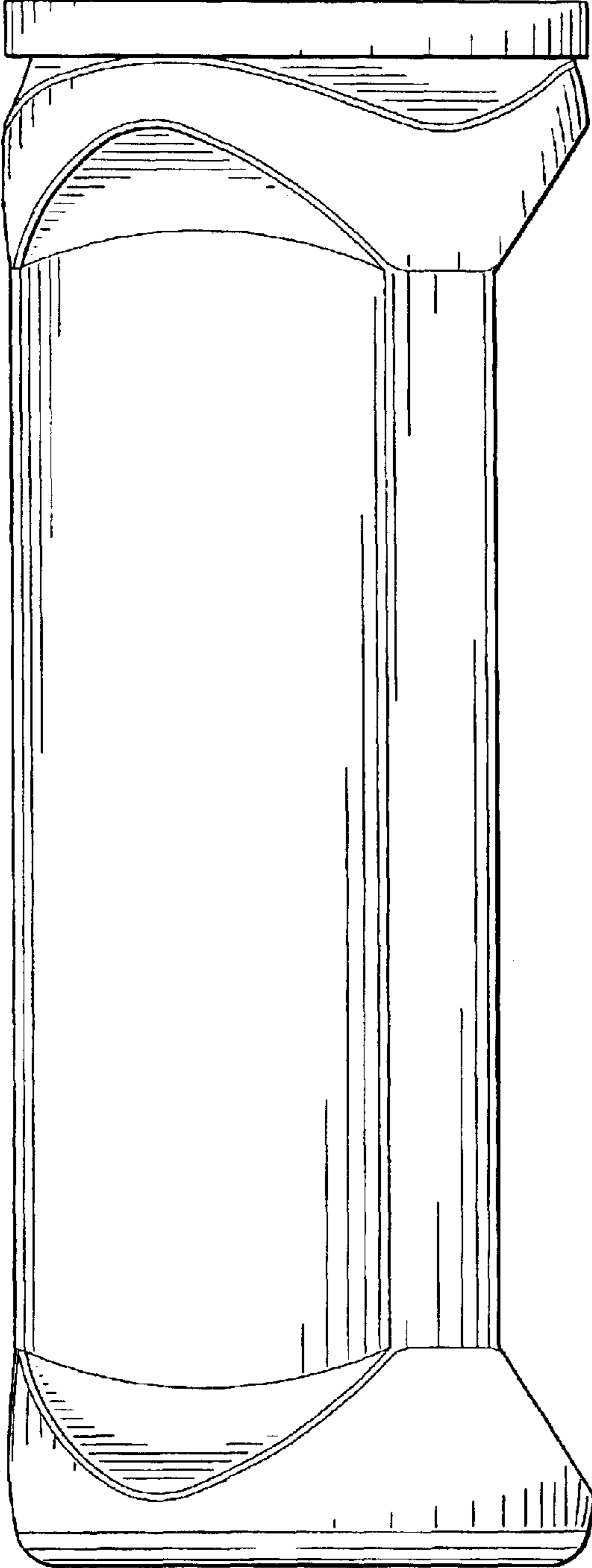

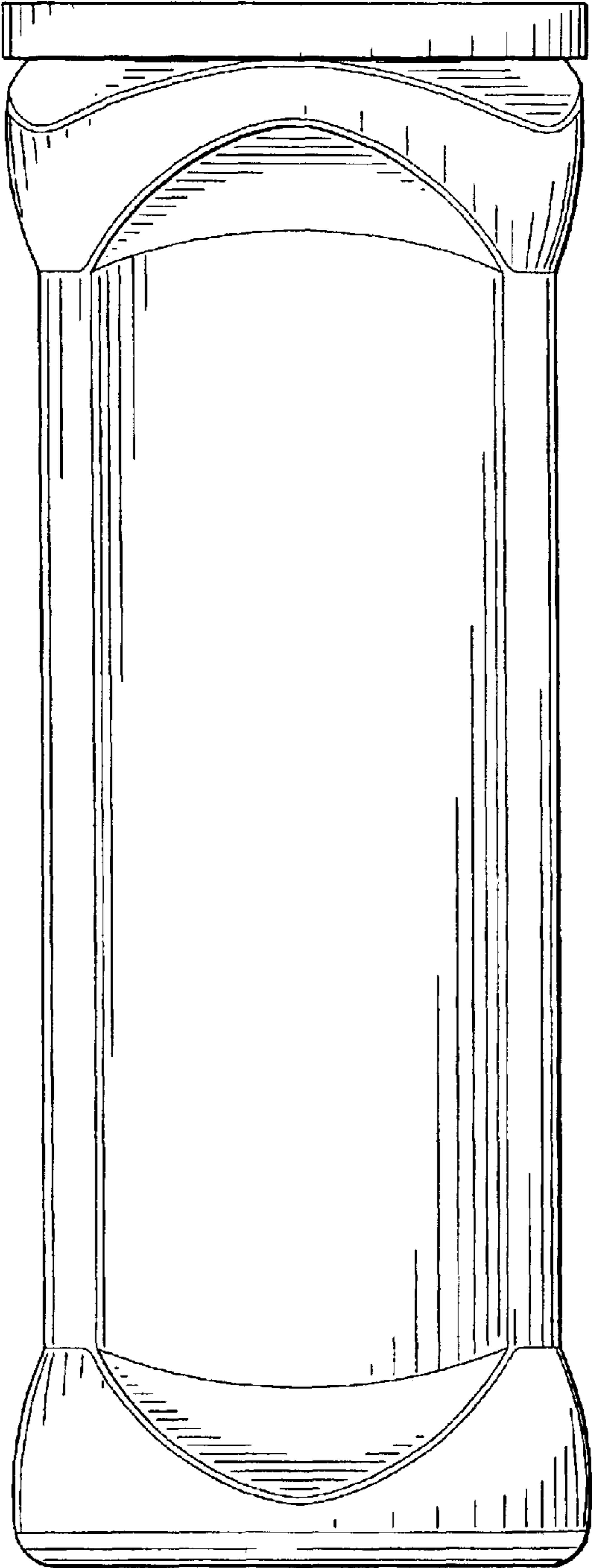

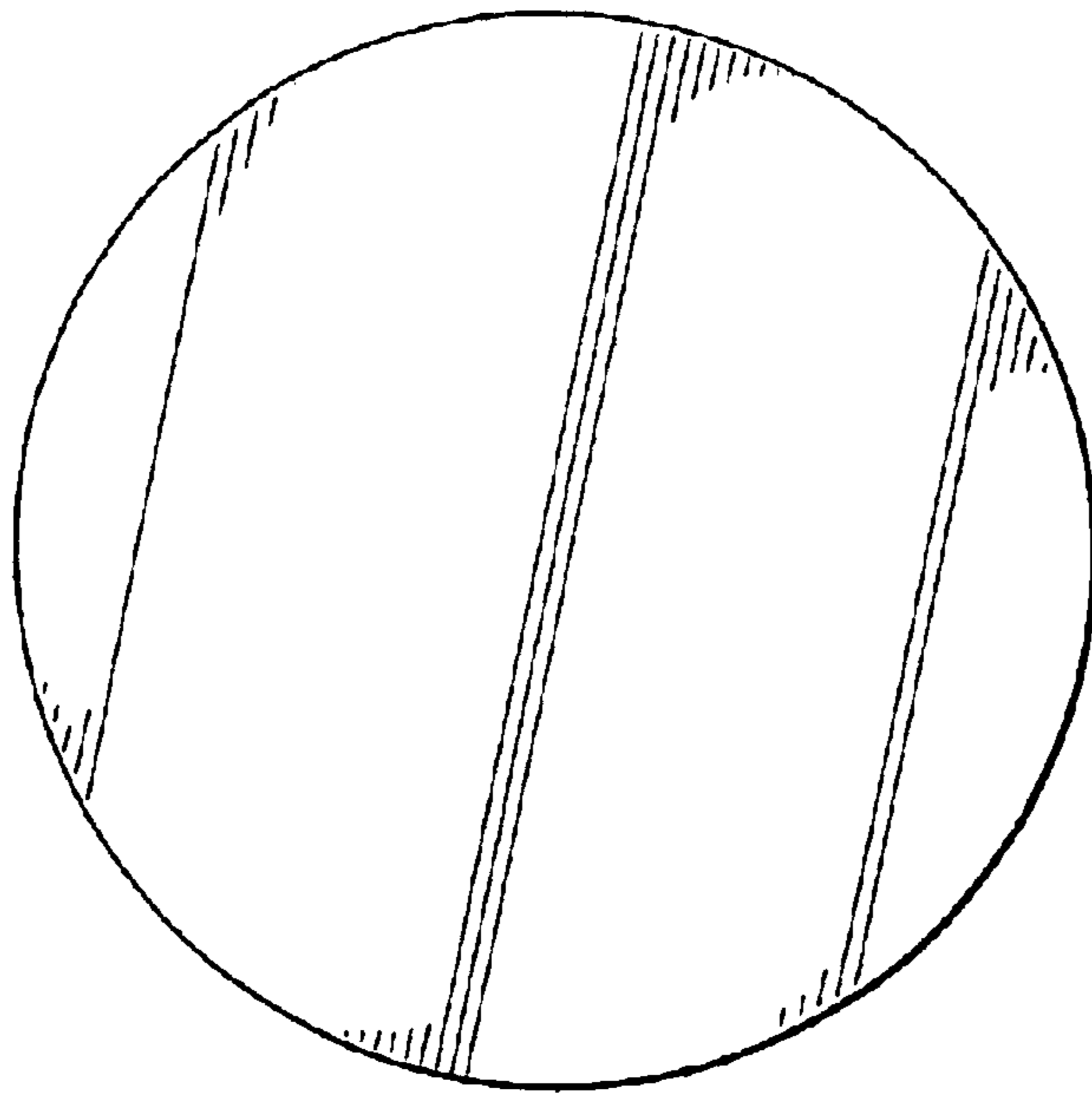

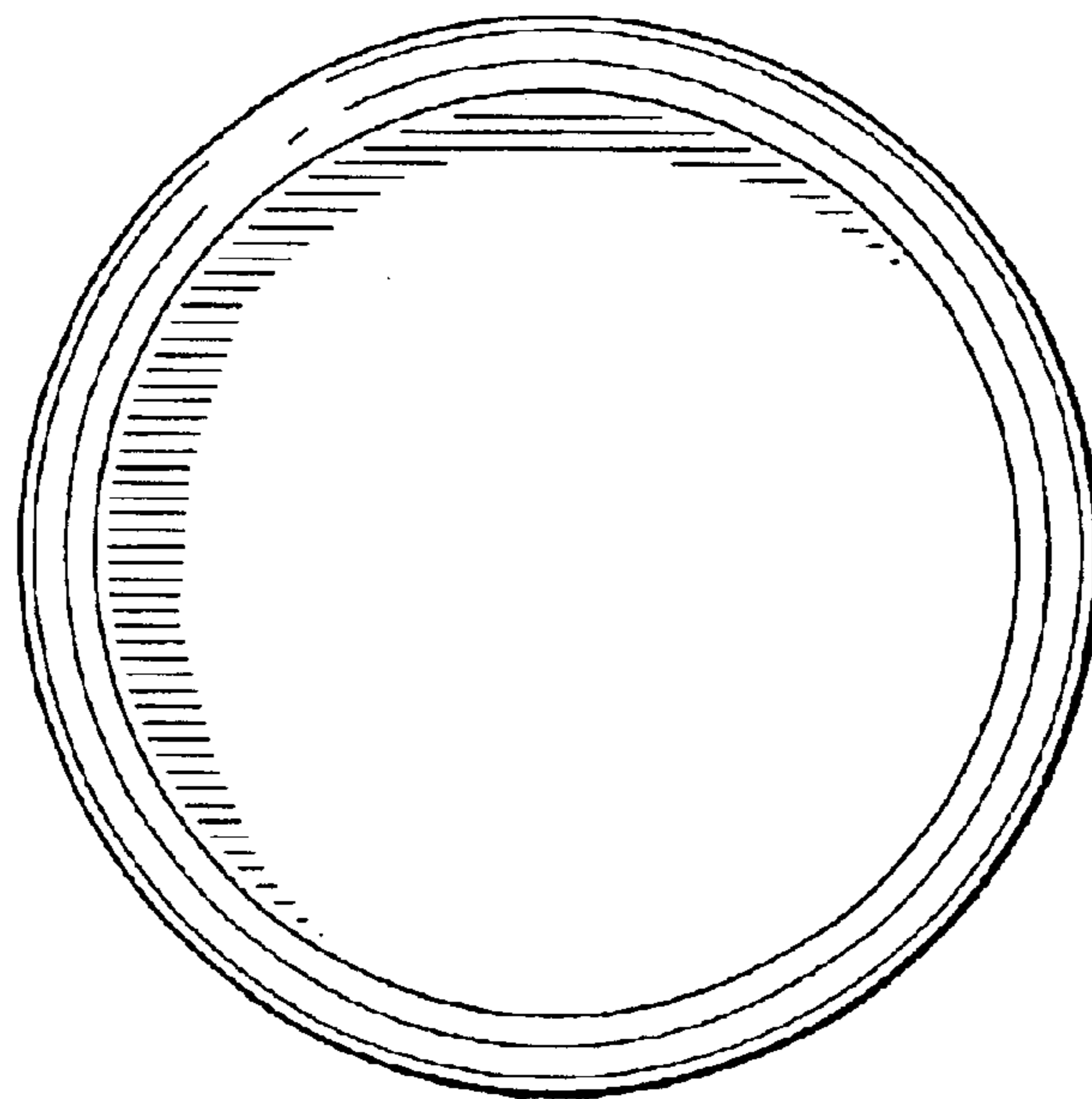
