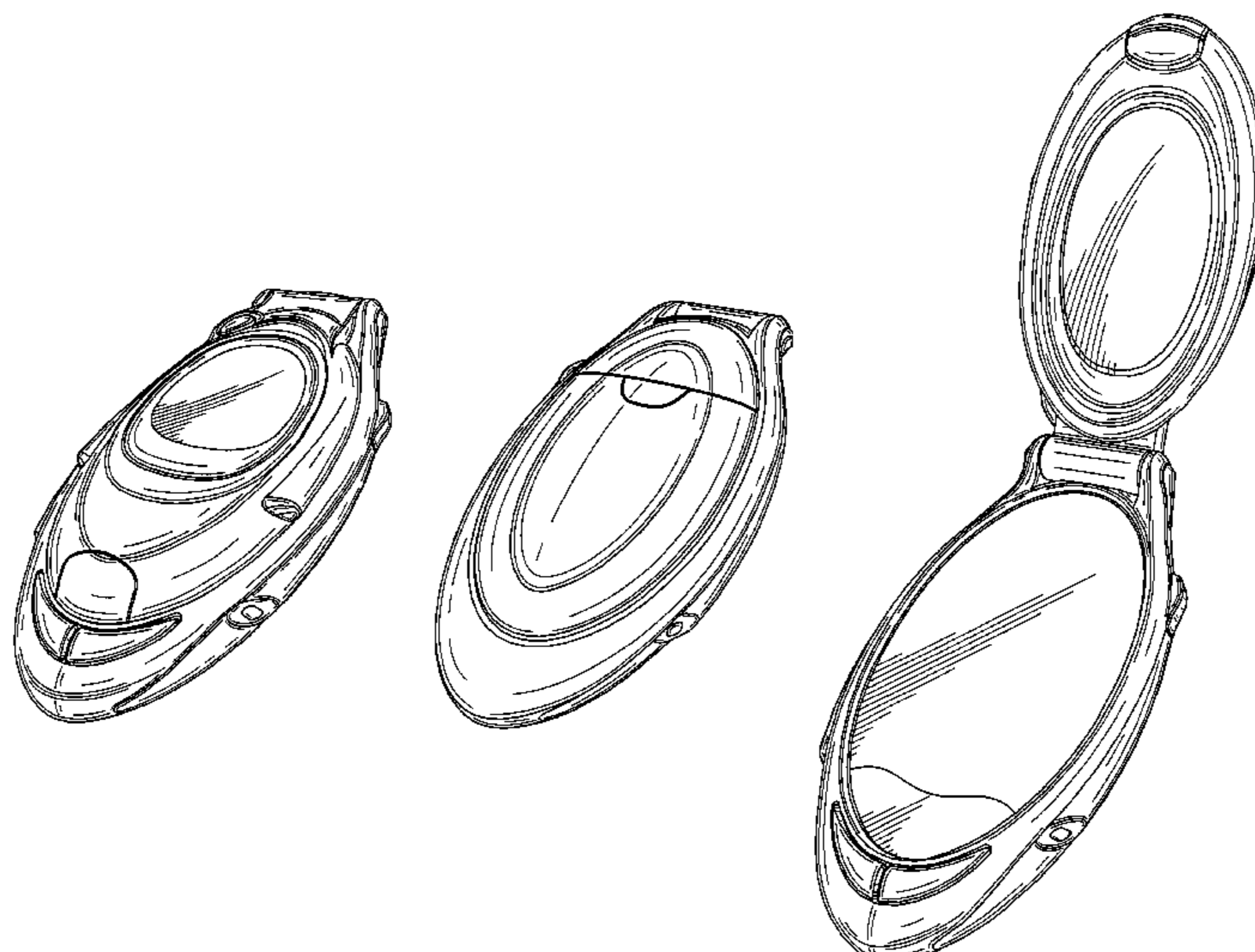
(57) **CLAIM**

We claim the ornamental design for a pocket watch com-
municator, as shown.

DESCRIPTION

FIG. 1 is a front view of the pocket watch communicator in the closed position;
 FIG. 2 is a rear view thereof;

 FIG. 4 is a top plan view thereof;

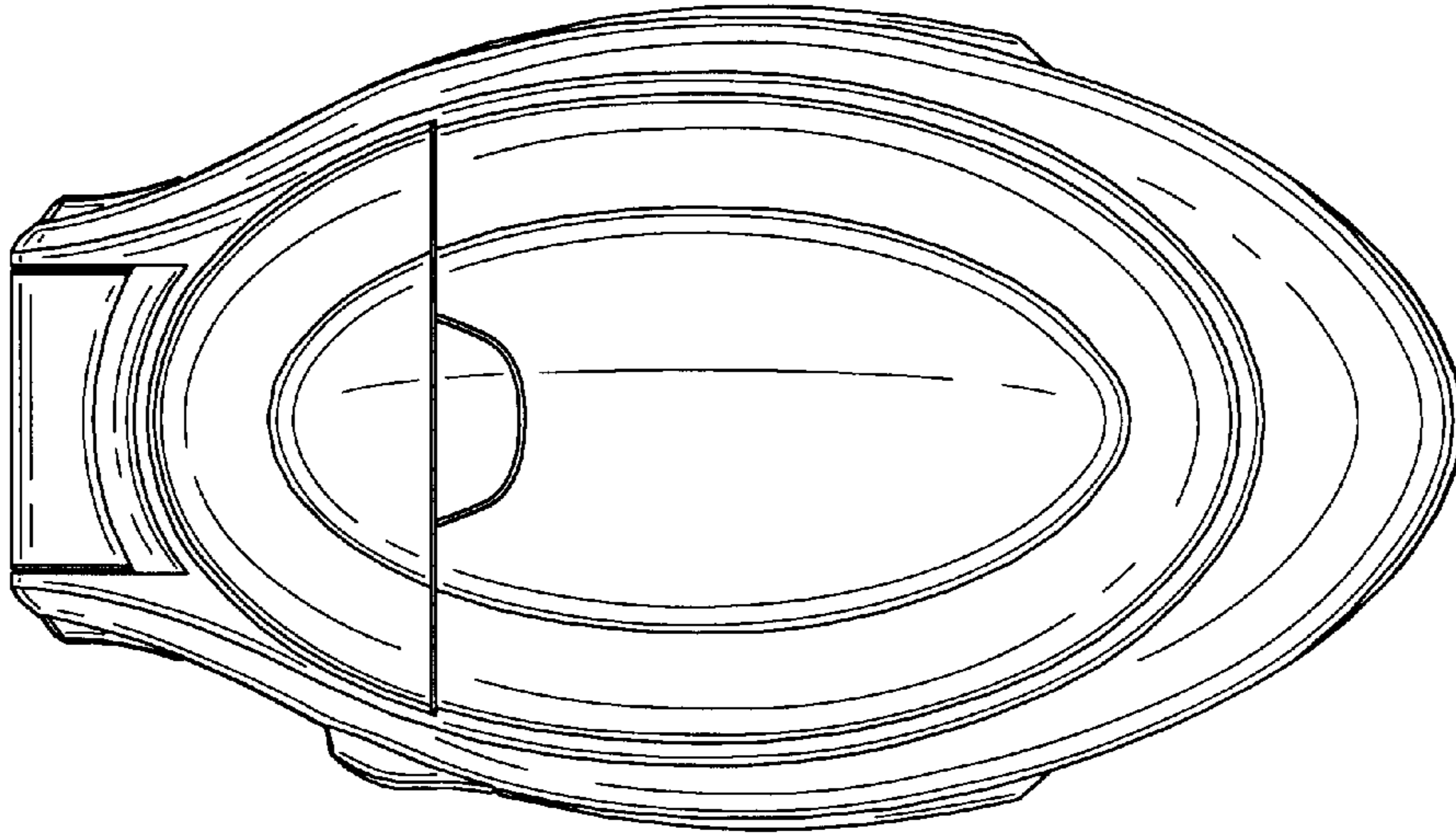

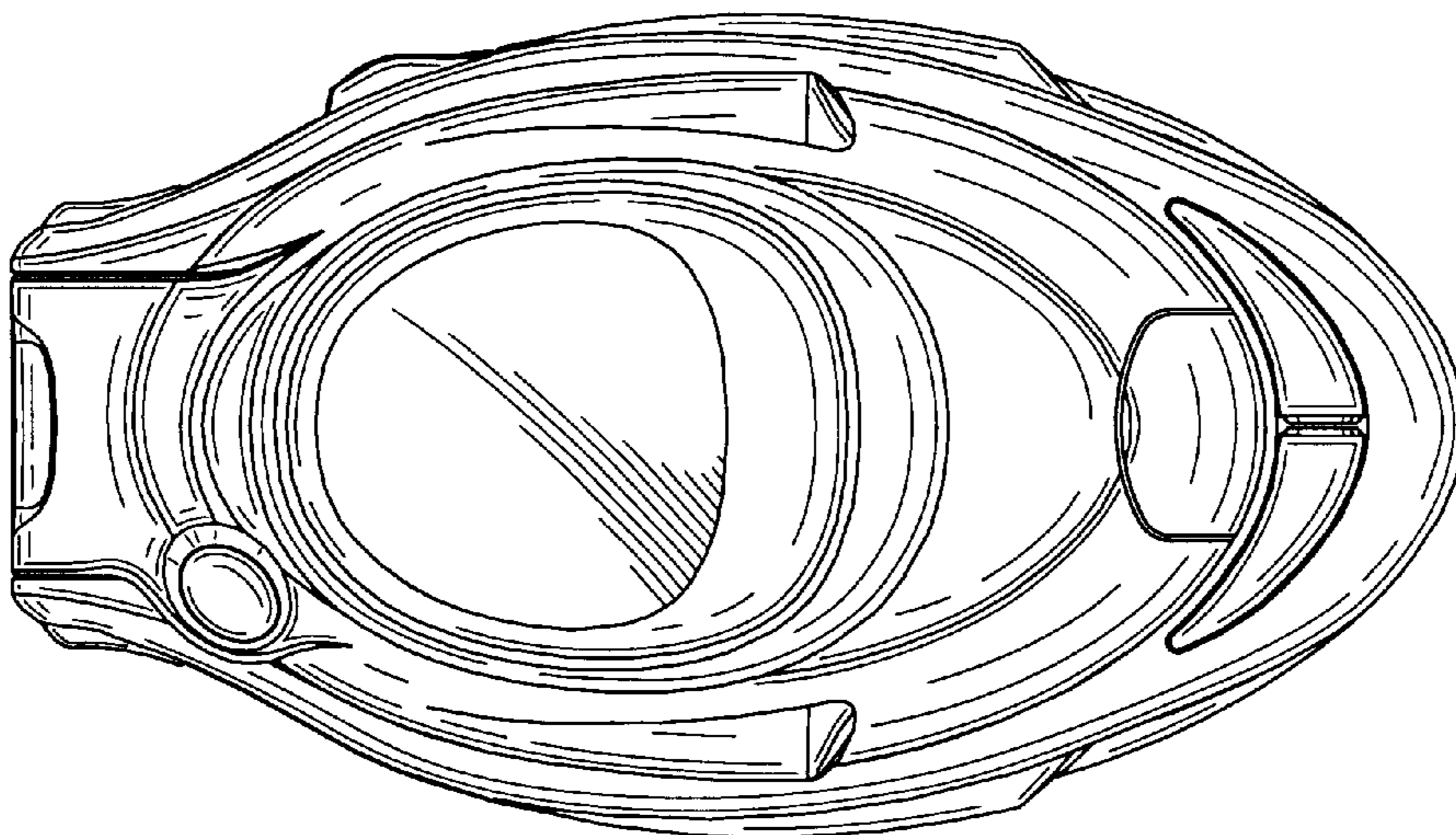

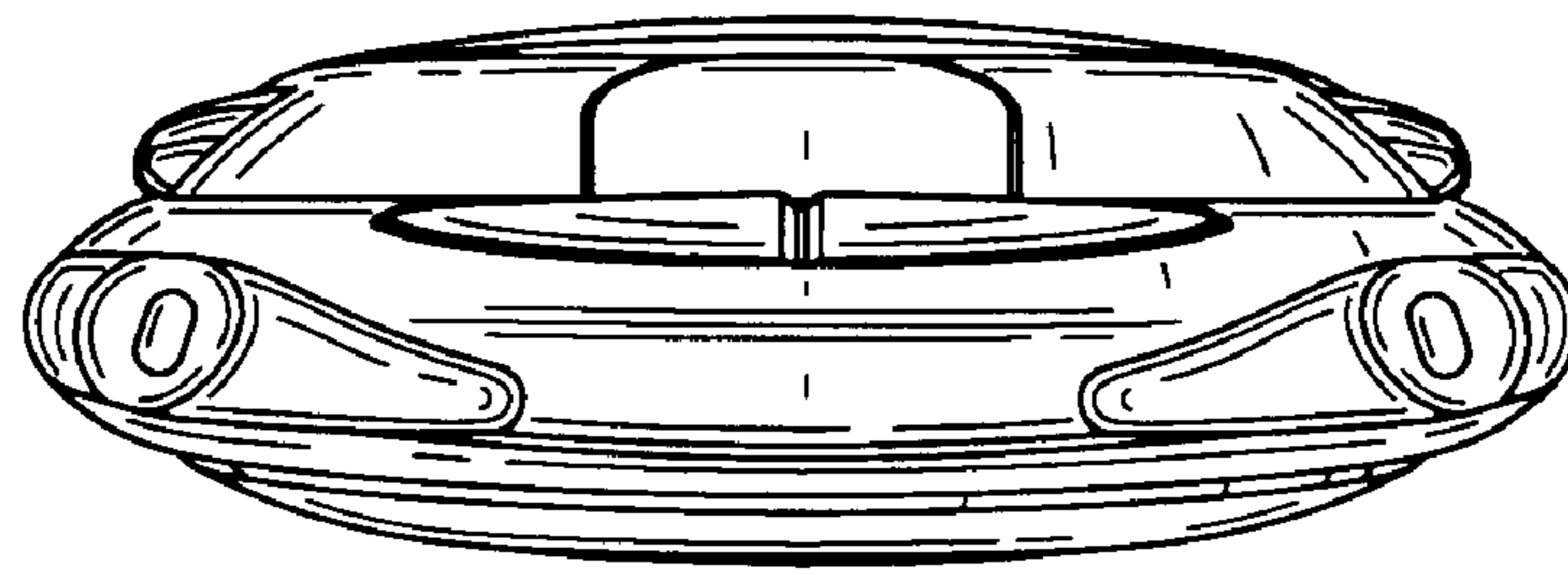

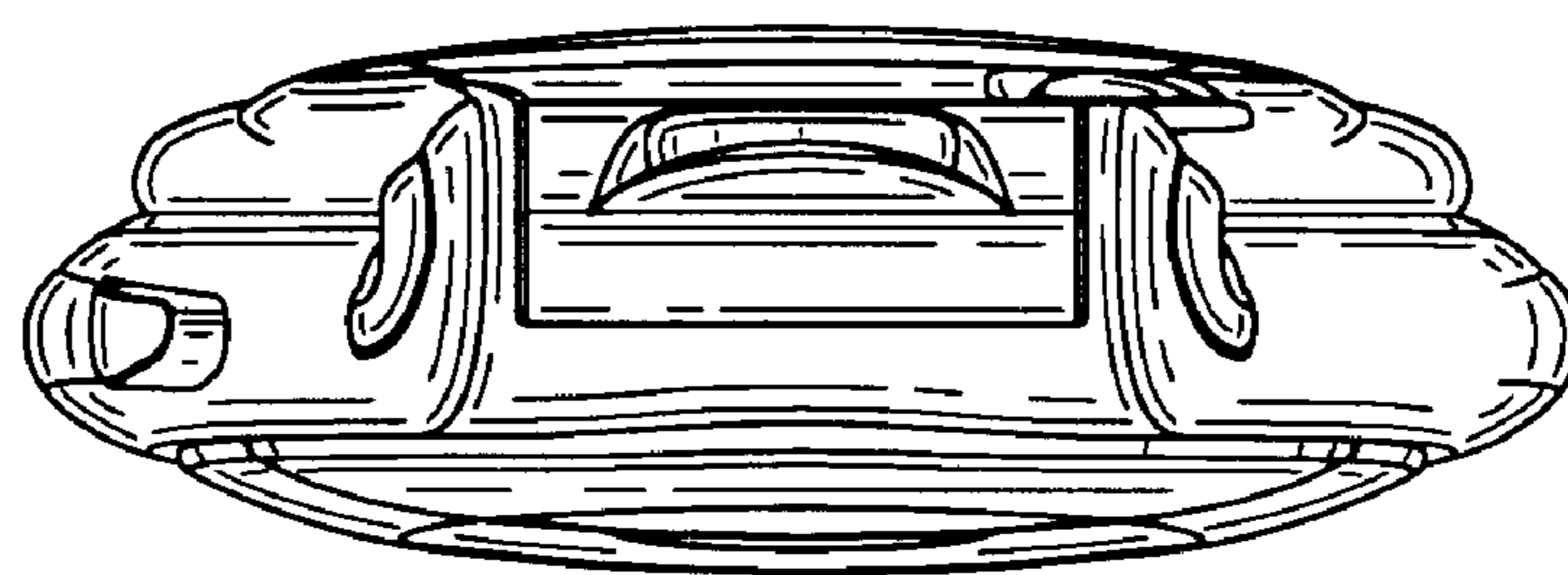

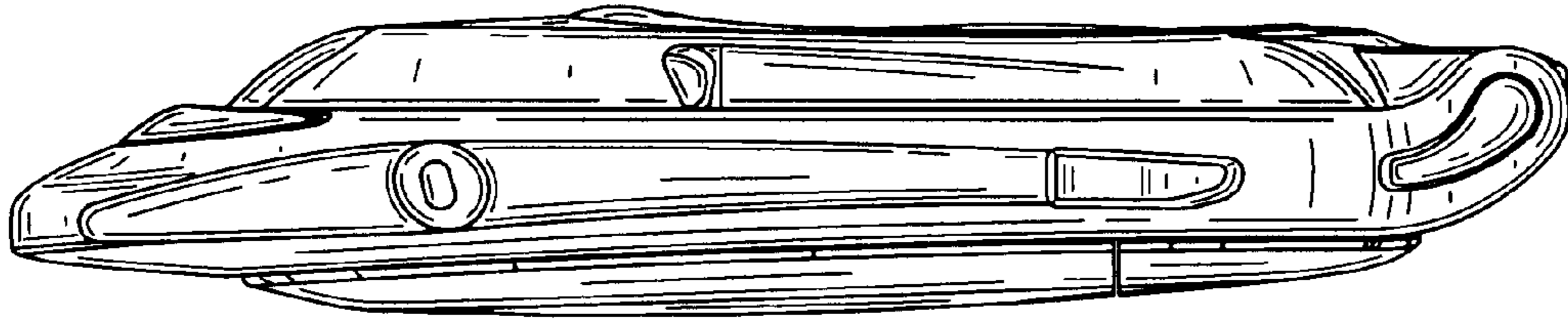

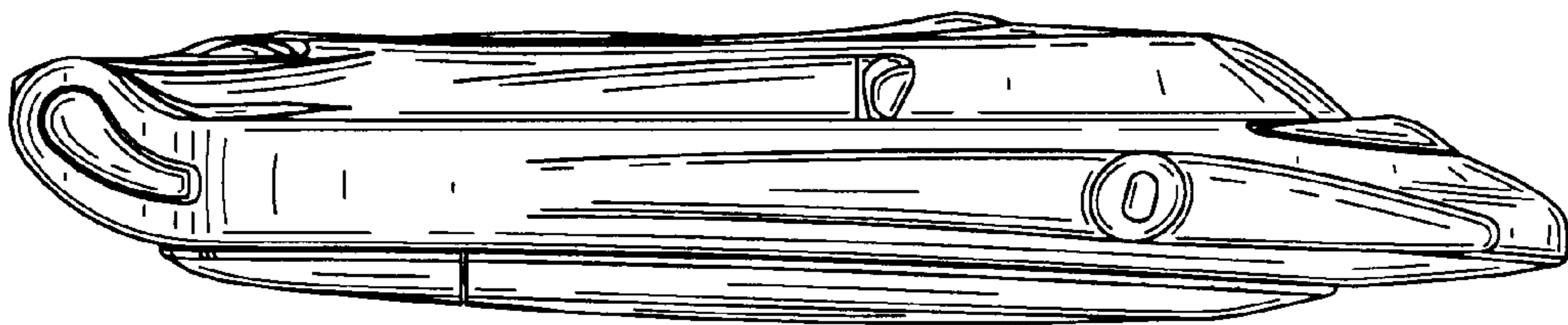

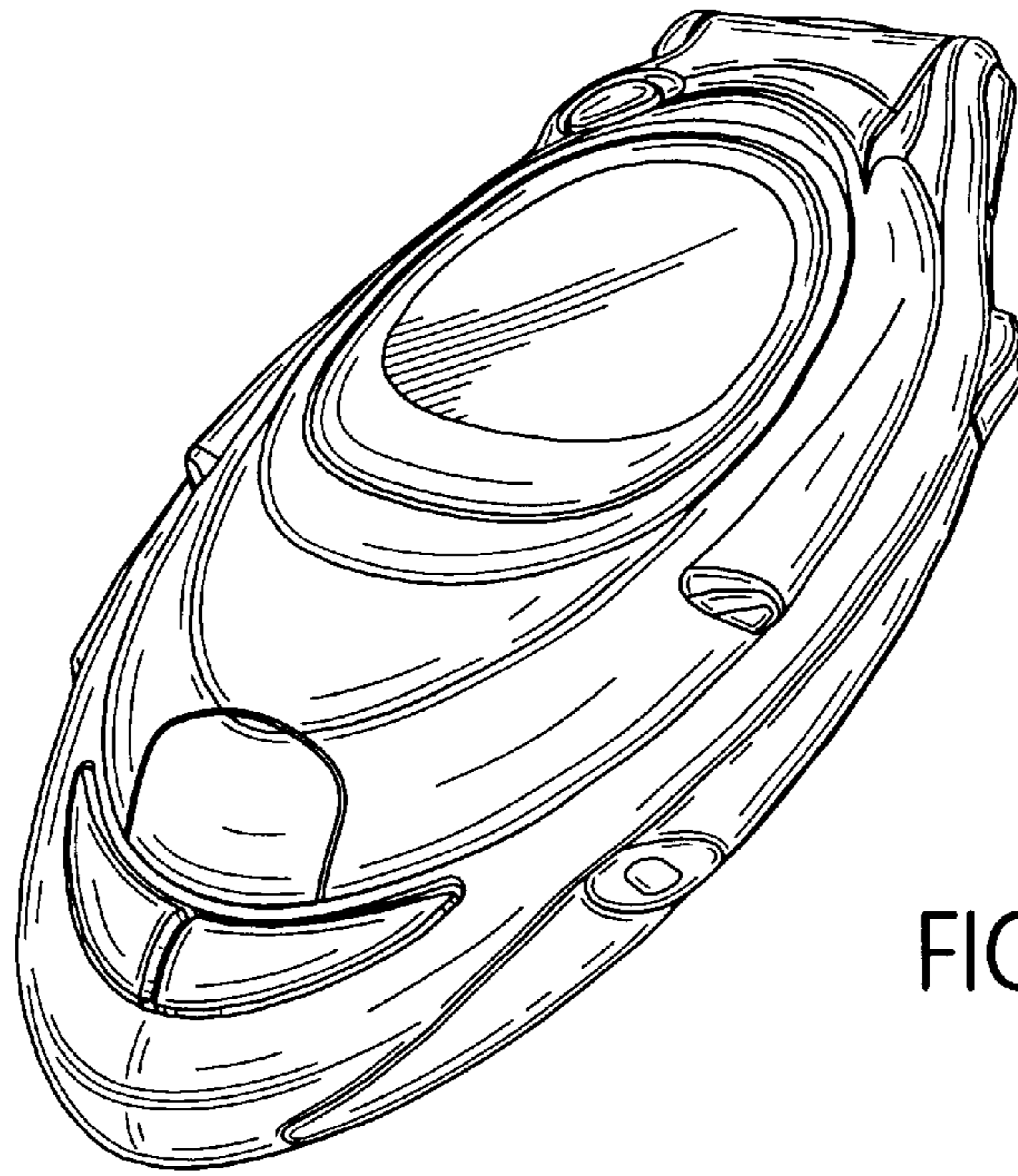

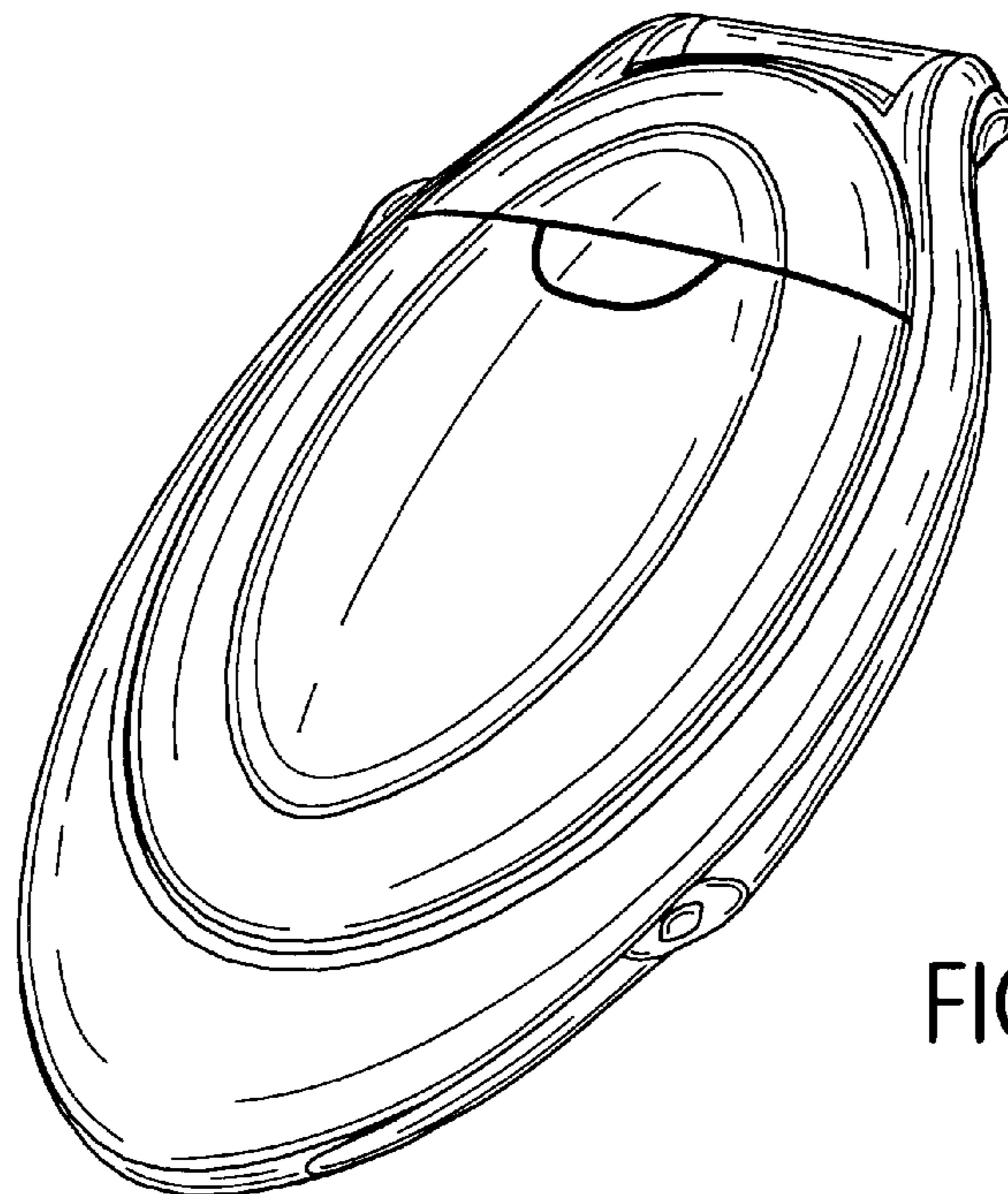

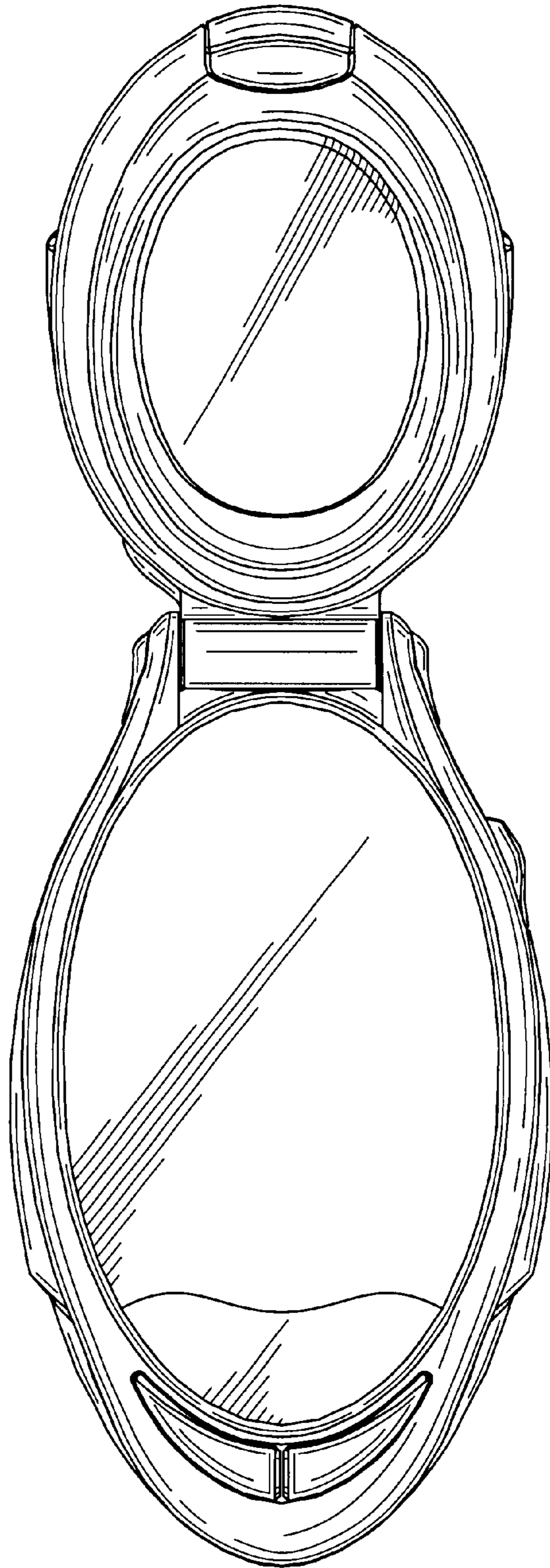

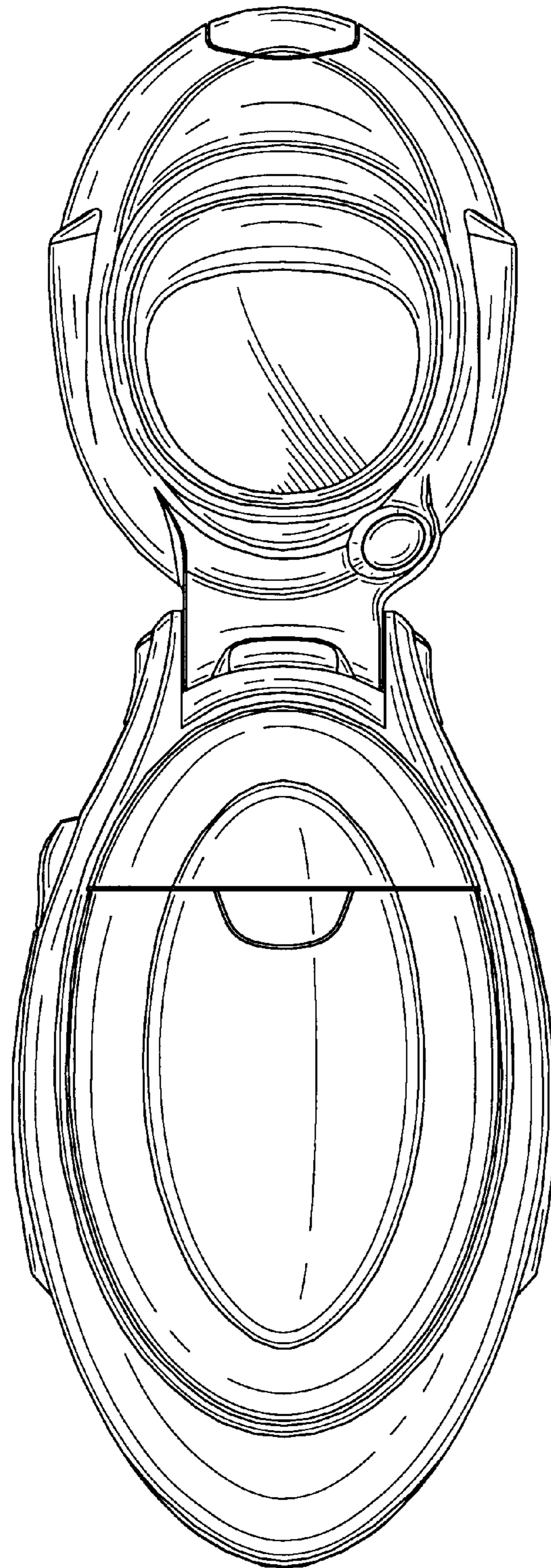

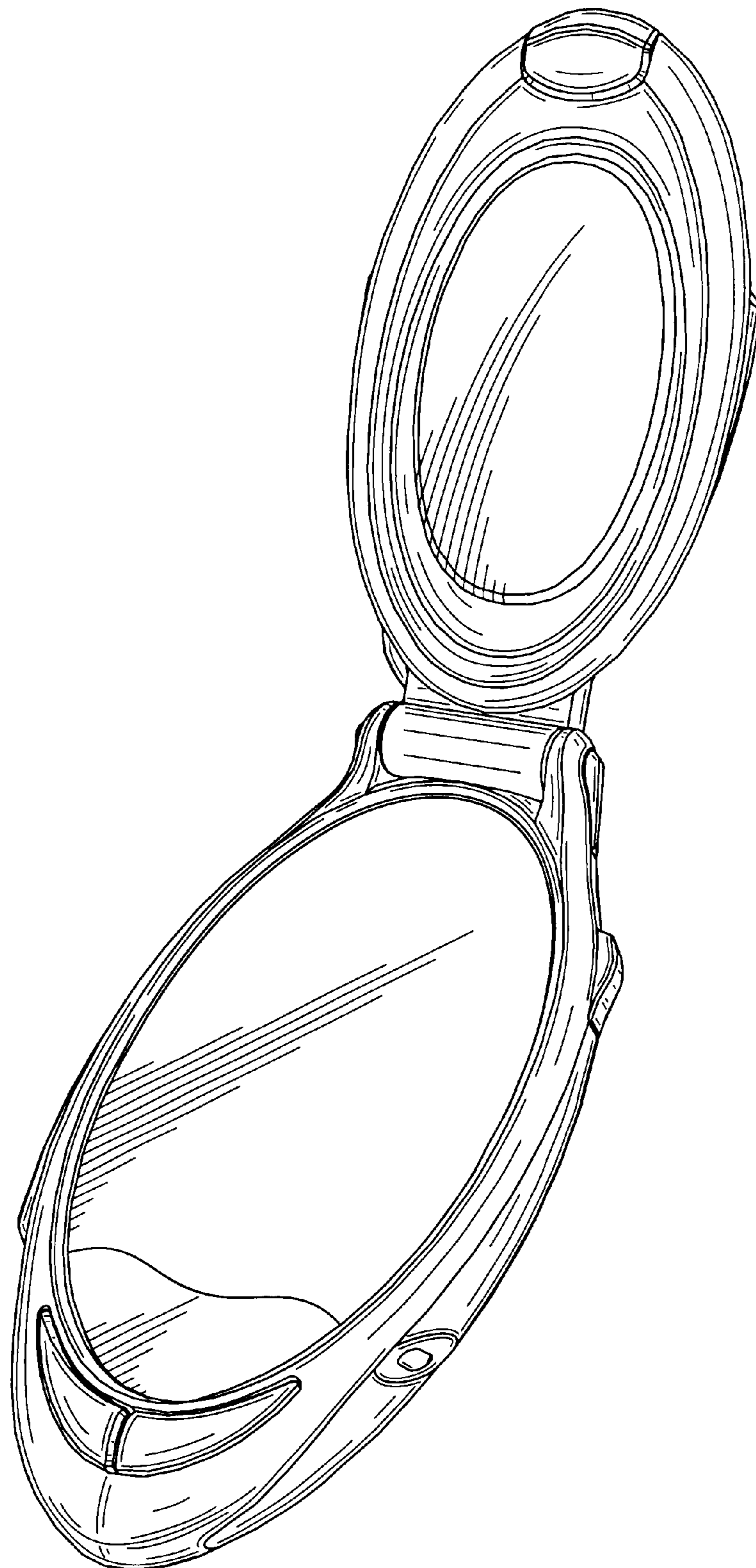

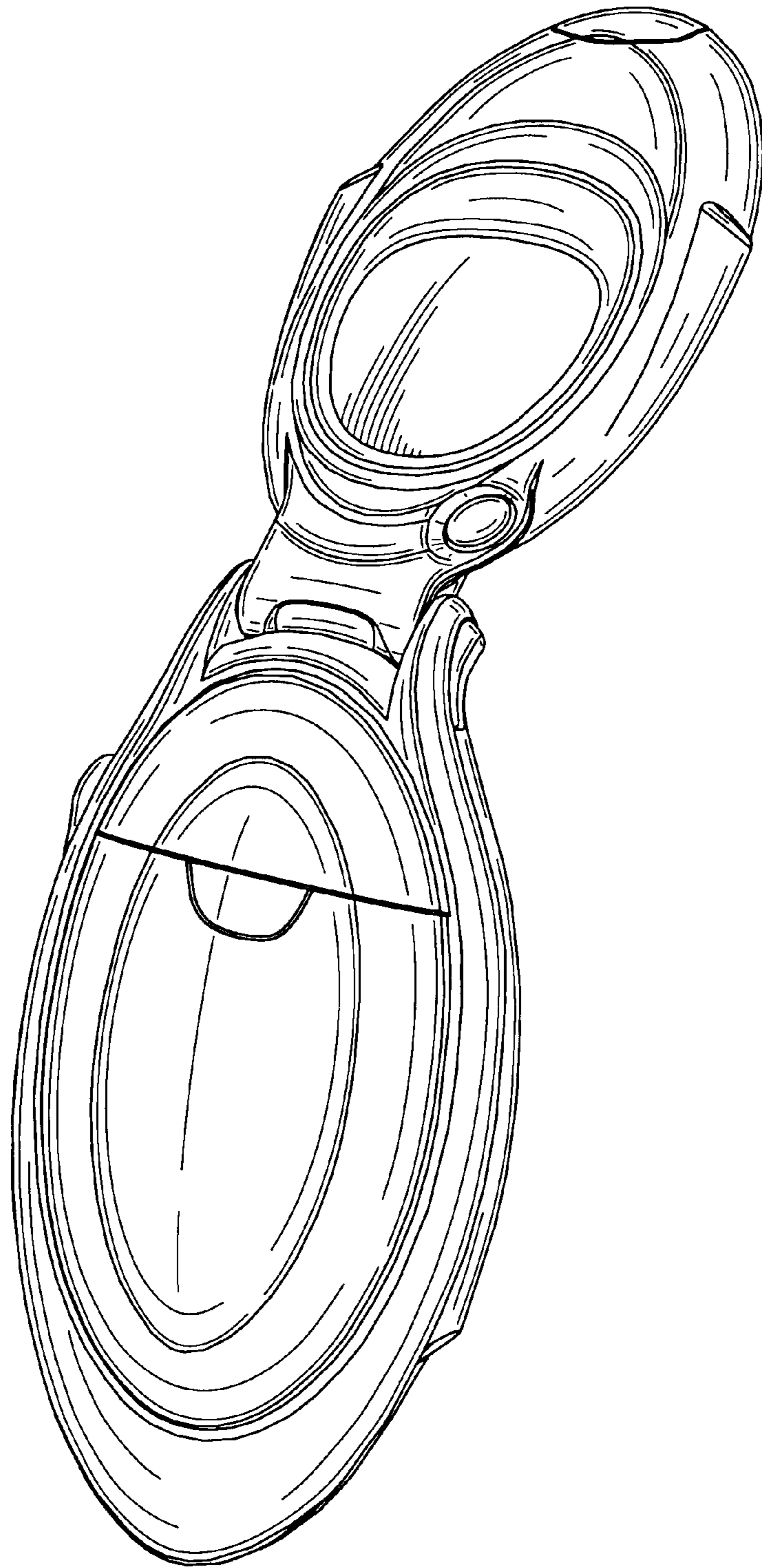
