**DESCRIPTION**

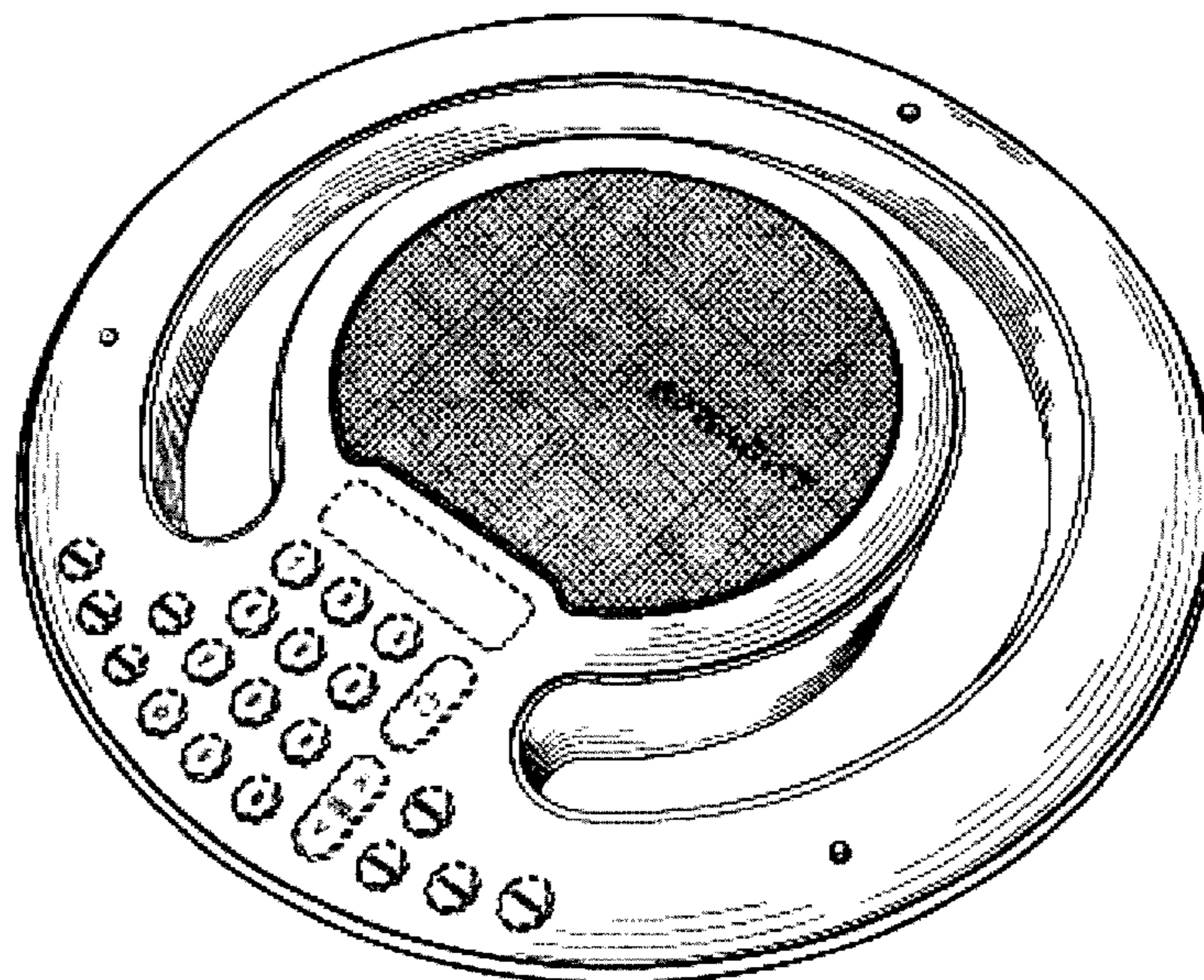
FIG. 1 is a perspective view of a speakerphone showing our new design;

The broken line showings throughout the views are for illustrative purposes only and form no part of the claimed design.

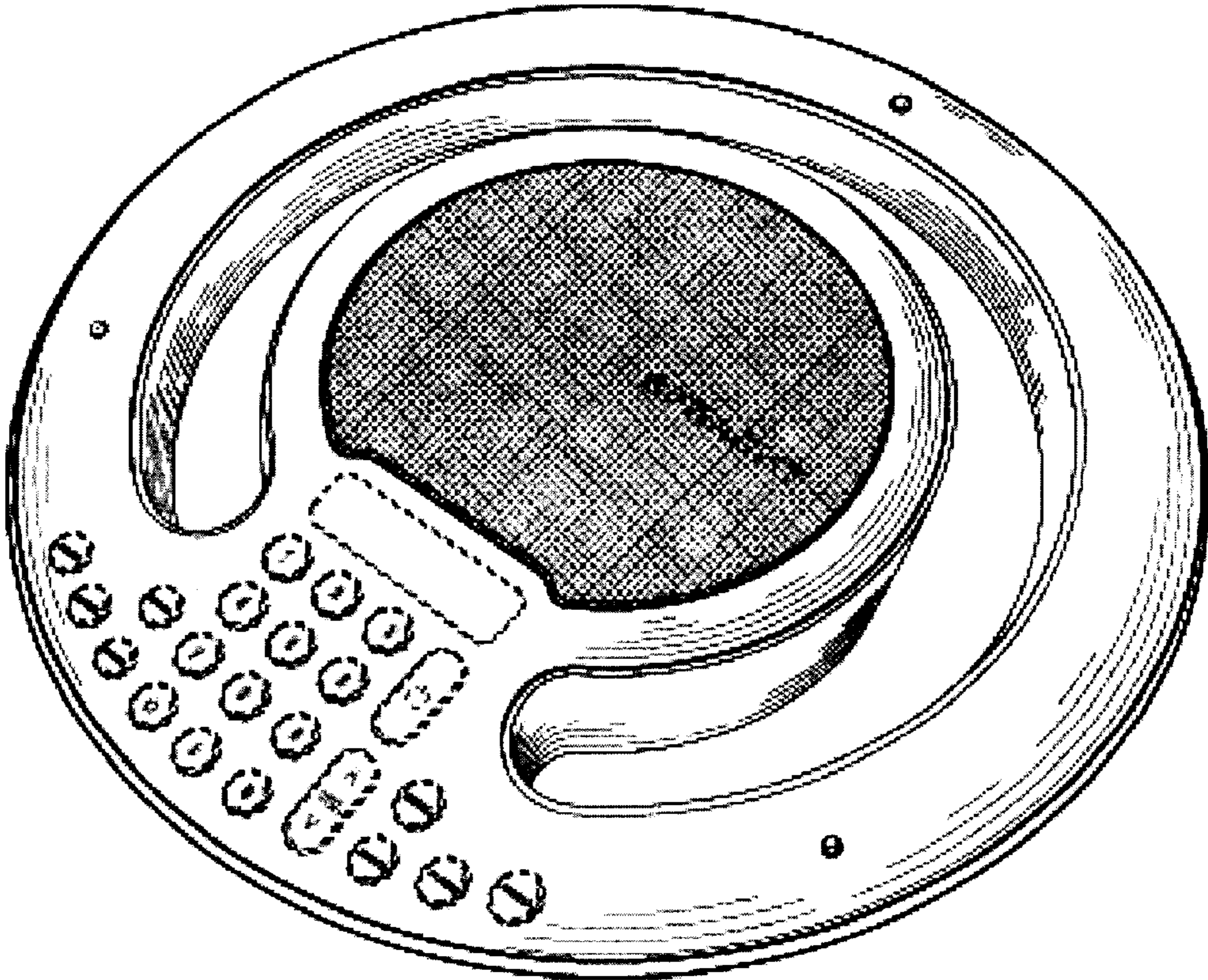

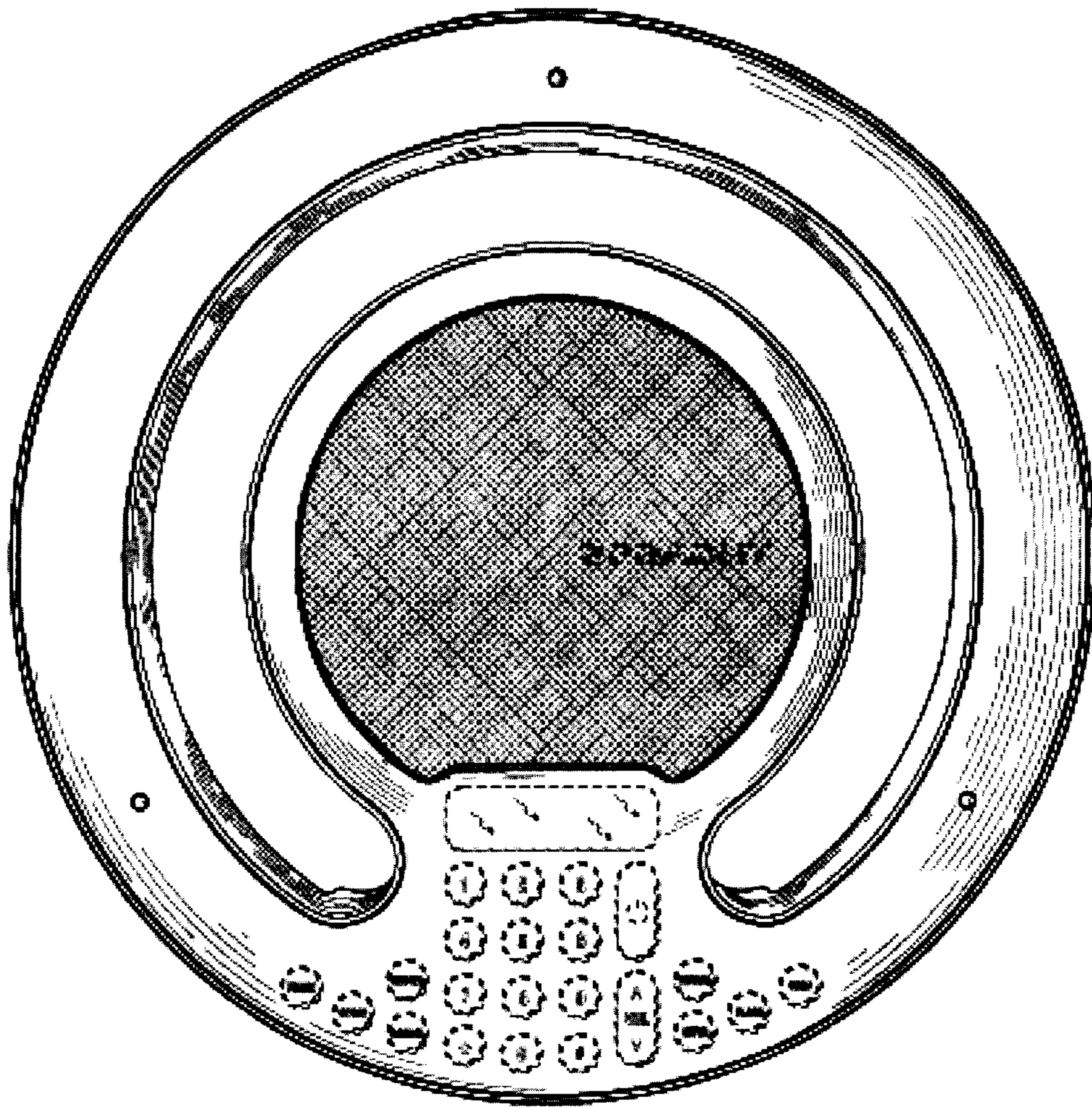

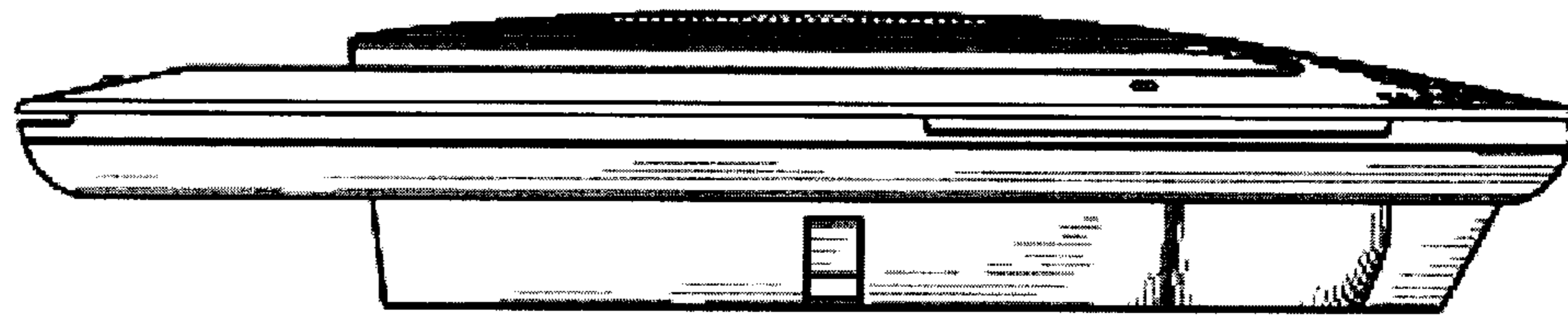




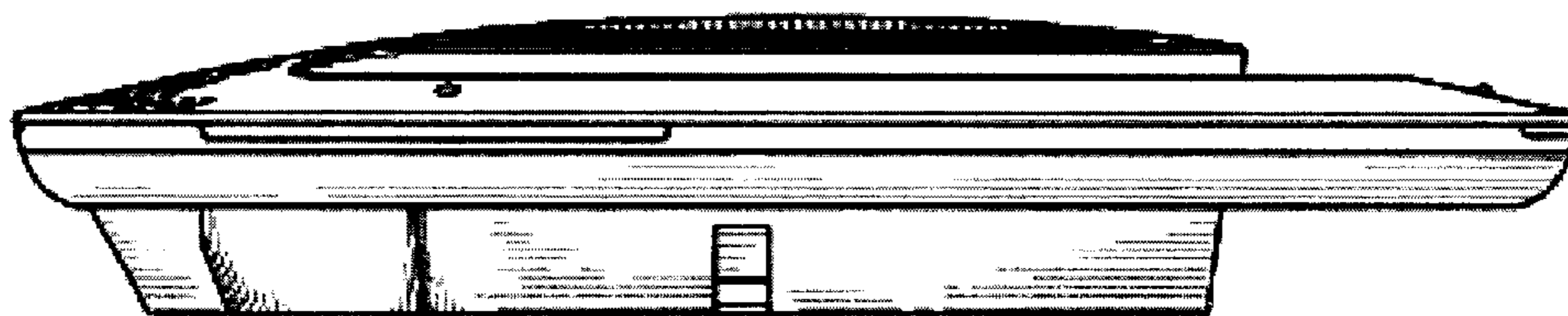

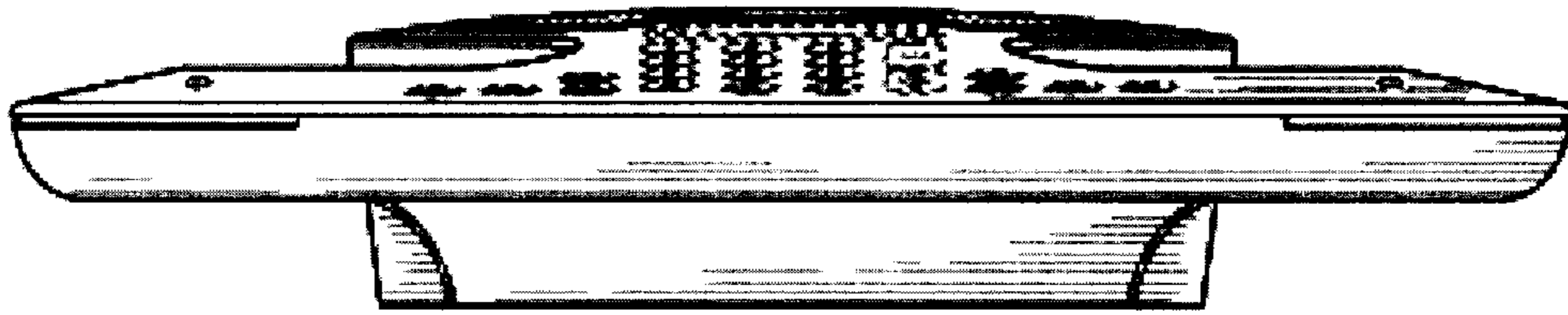

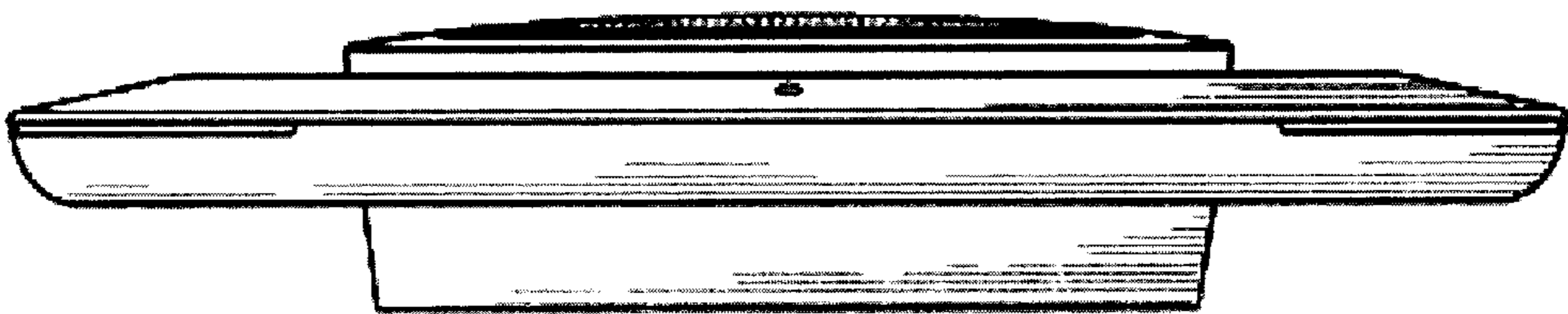
