The ornamental design for an electronic computer, as shown and described.

DESCRIPTION

FIG. 1 is a reduced top, front, and right side perspective view of an electronic computer showing my new design thereof; FIG. 2 is a front elevational view thereof, FIG. 3 is a rear elevational view thereof, FIG. 4 is a left side elevational view thereof, FIG. 5 is a right side elevational view thereof, FIG. 6 is a top plan view thereof, FIG. 7 is a bottom plan view thereof, FIG. 8 is a front elevational view showing the article in a closed position thereof, FIG. 9 is a right side elevational view showing the article in the closed position thereof, and, FIG. 10 is a top plan view showing the article in the closed position thereof.

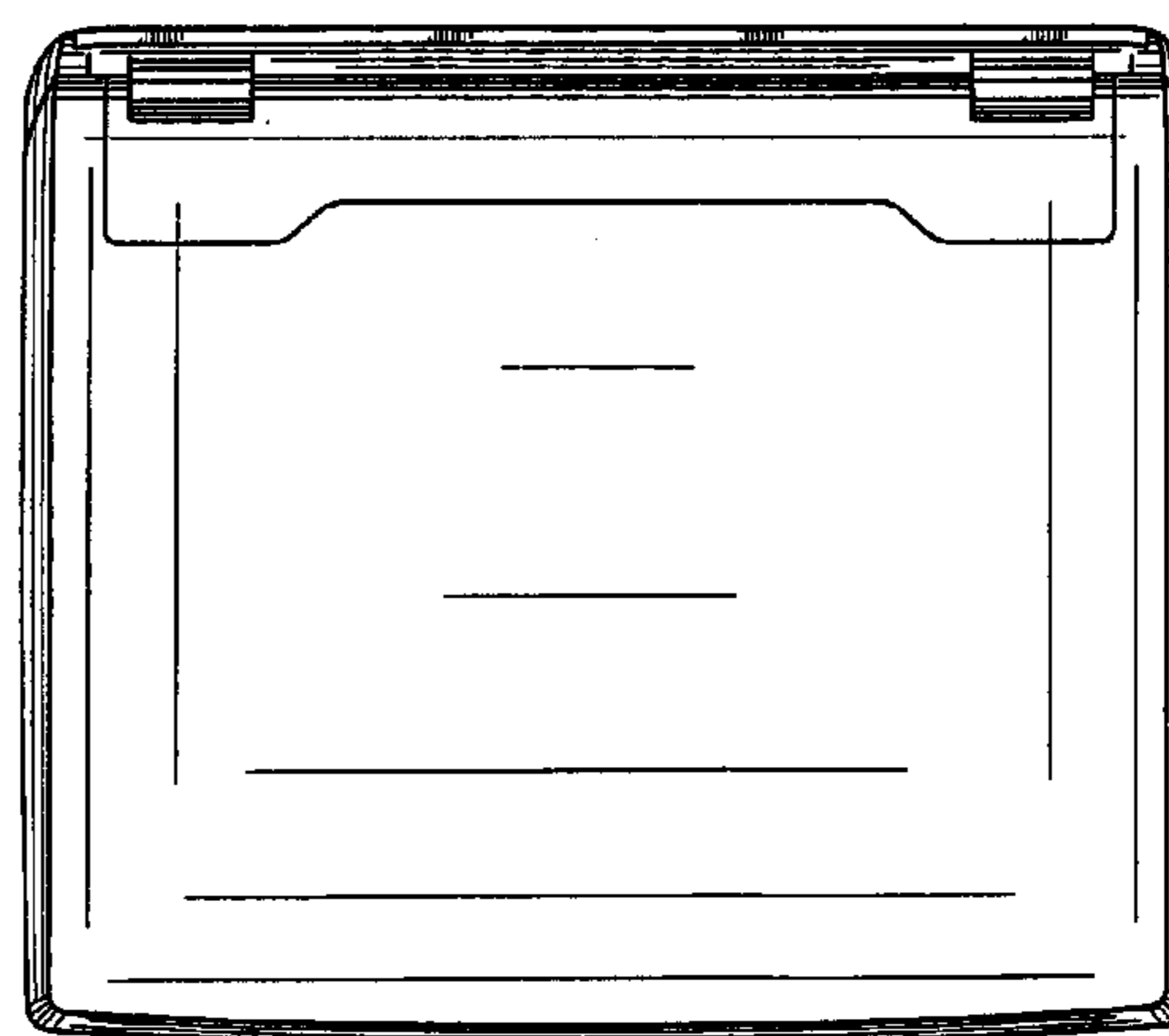
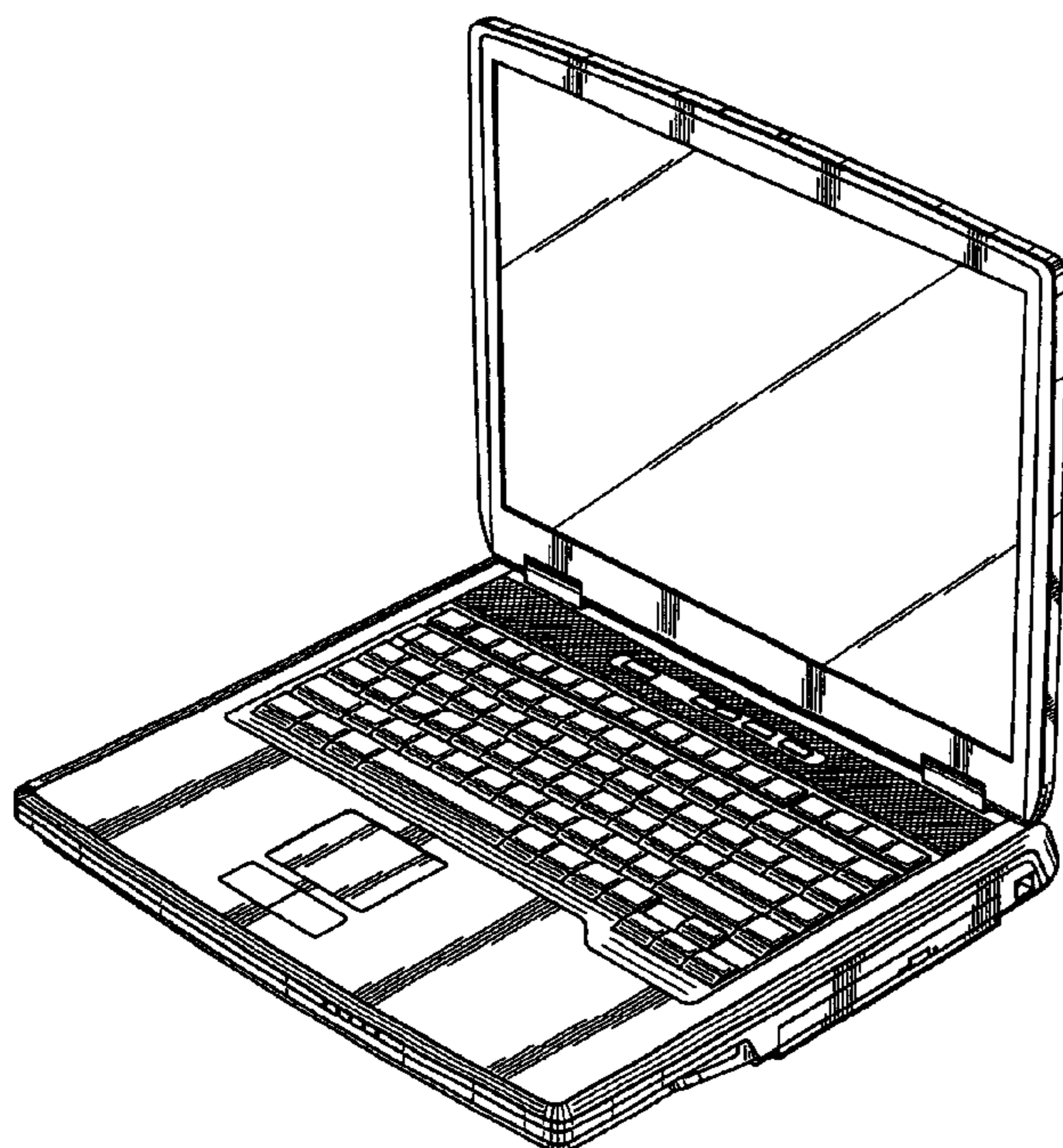

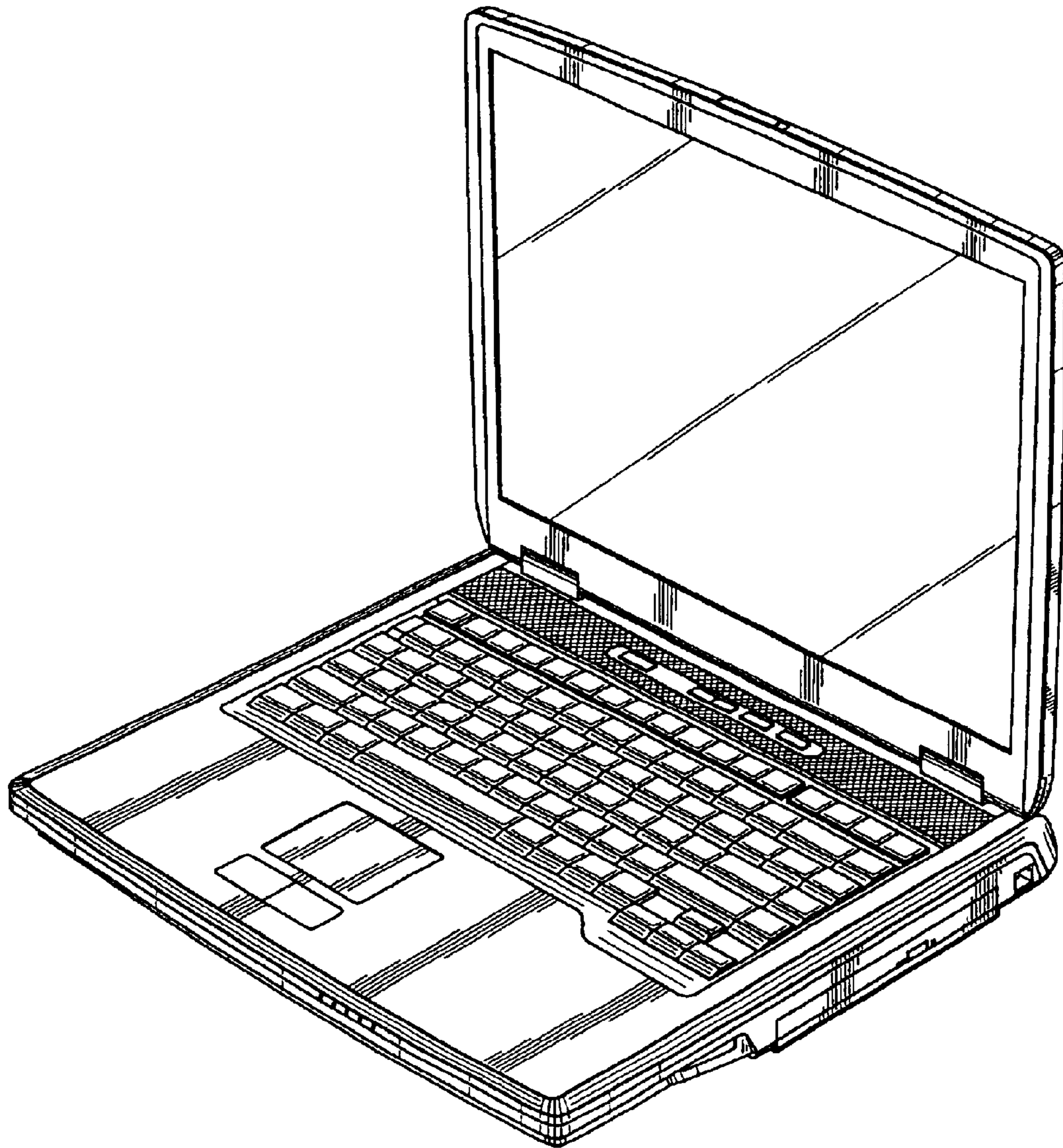

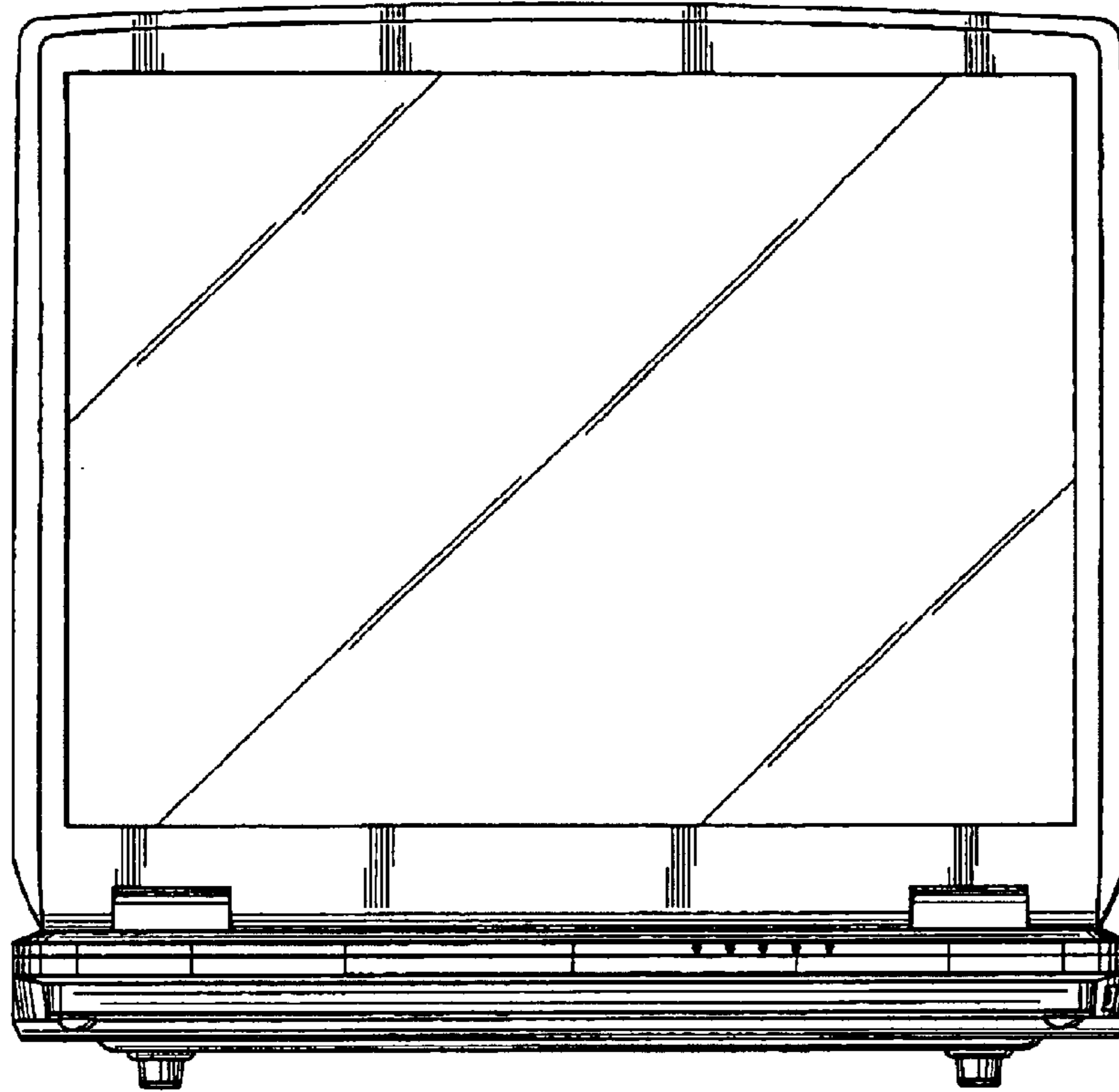

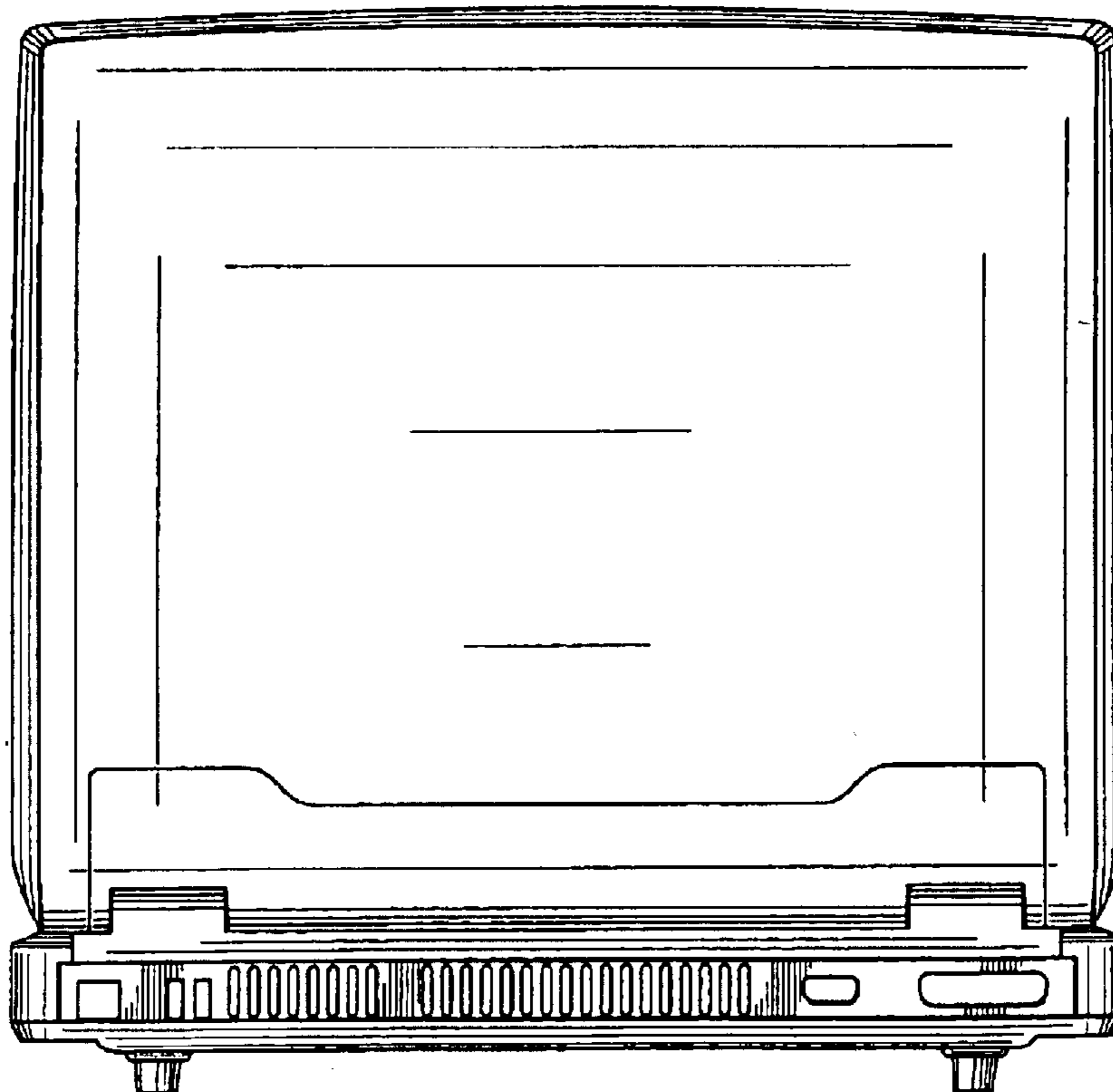

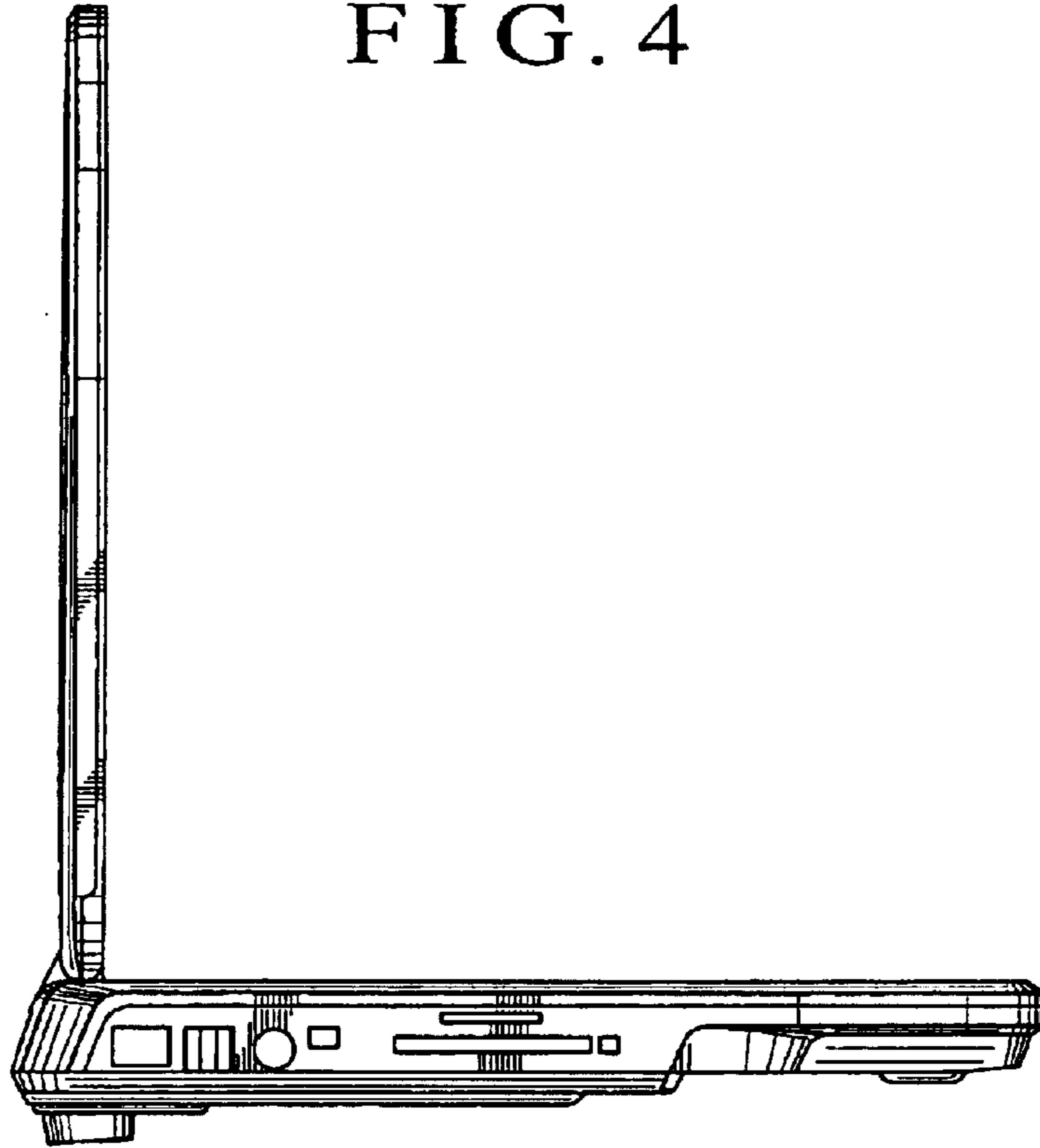

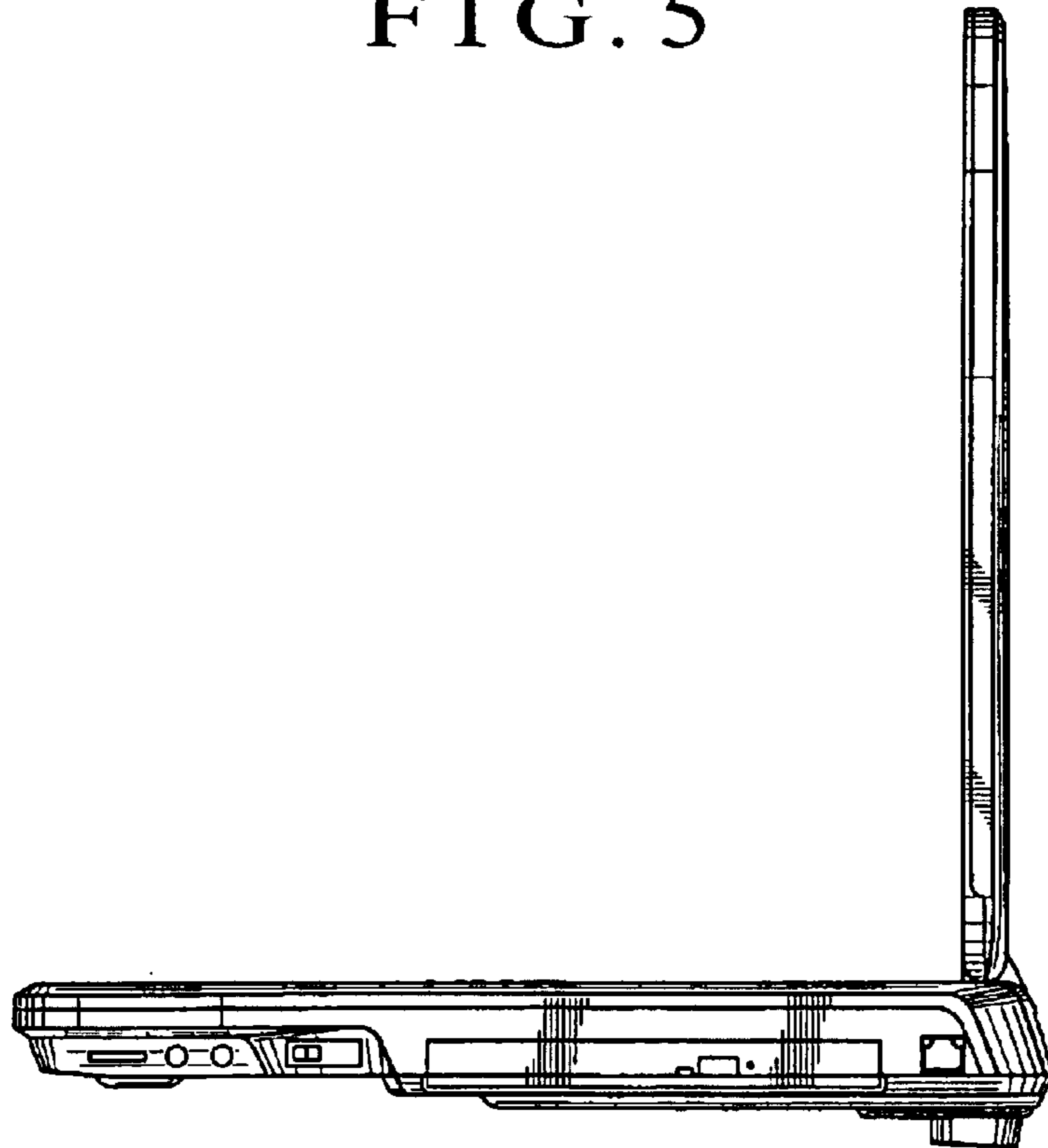

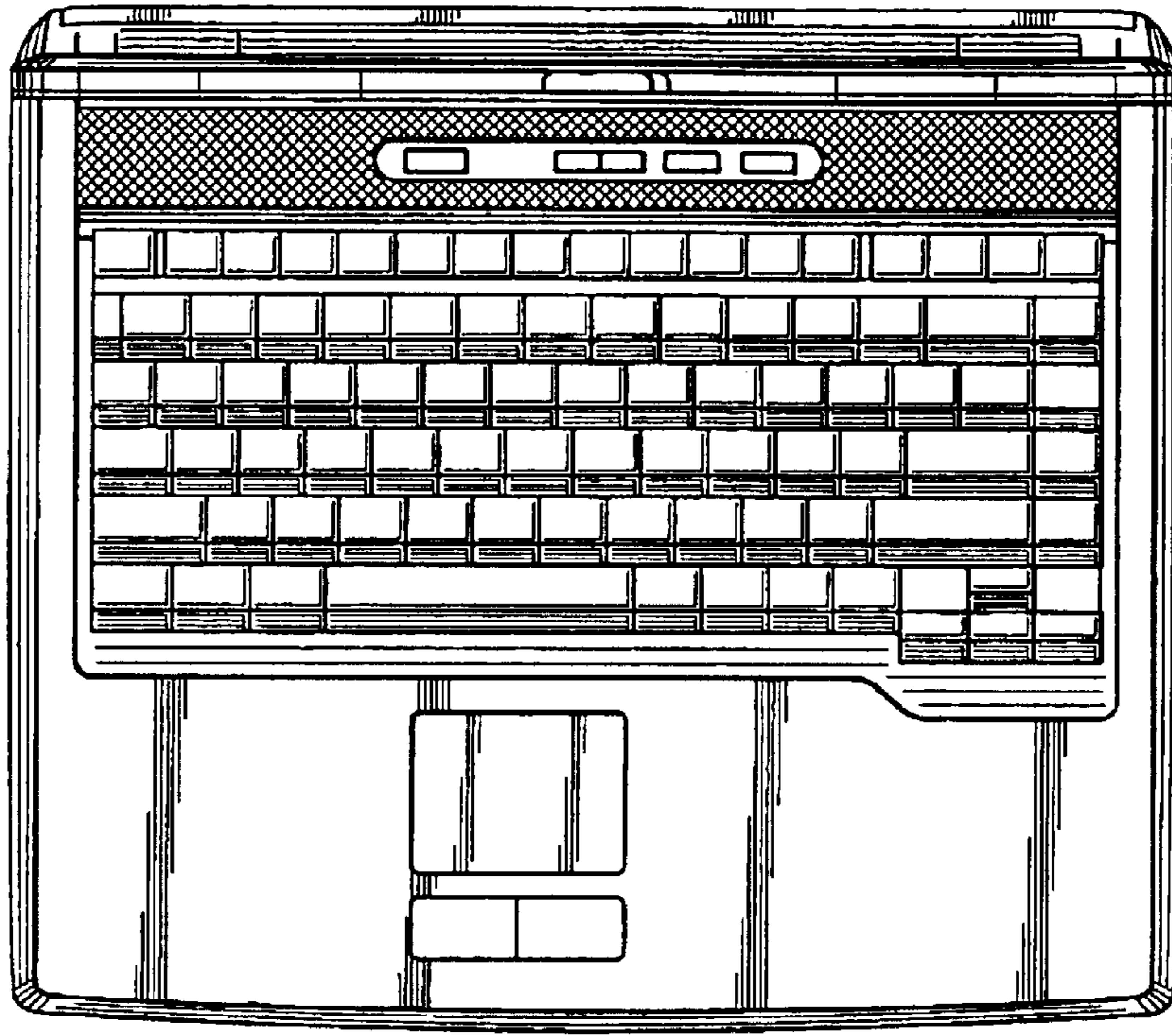

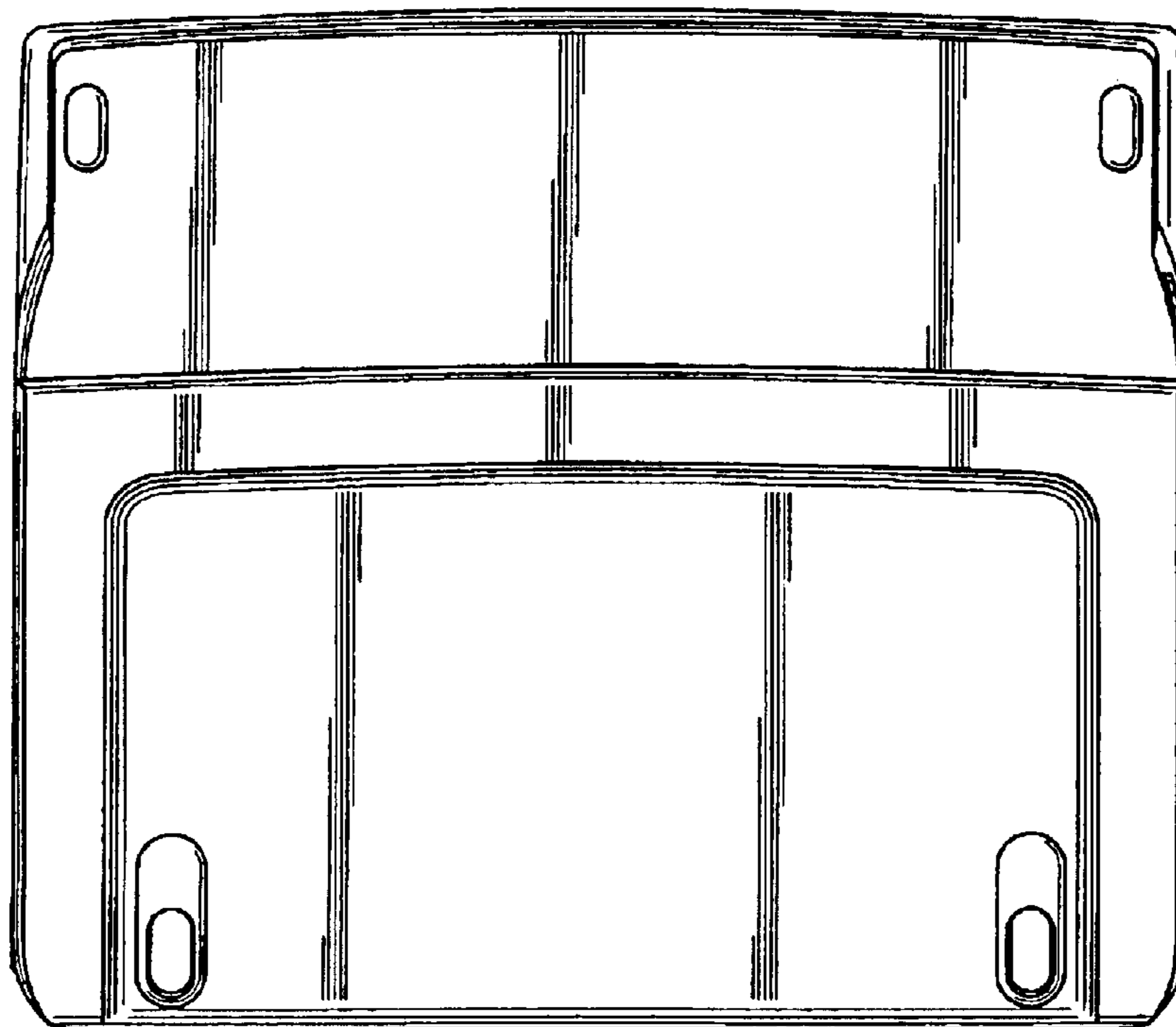

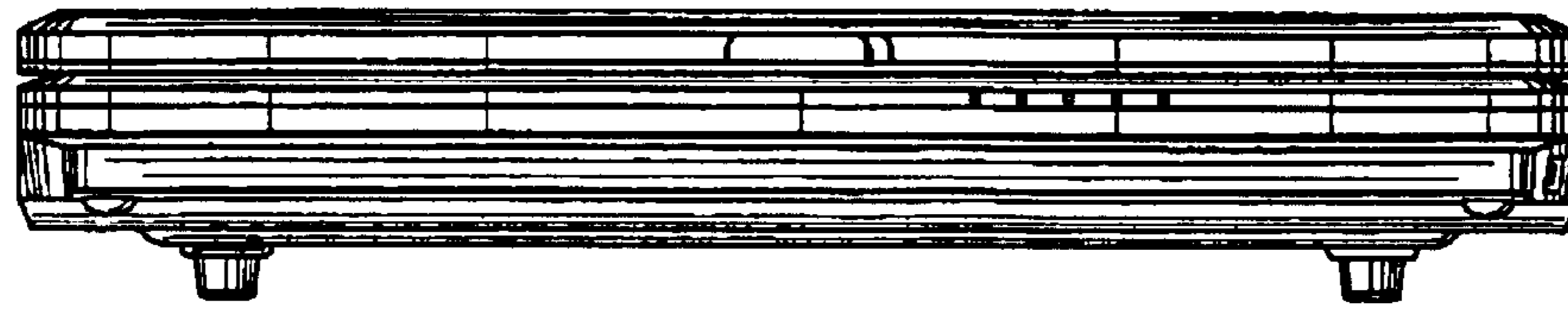

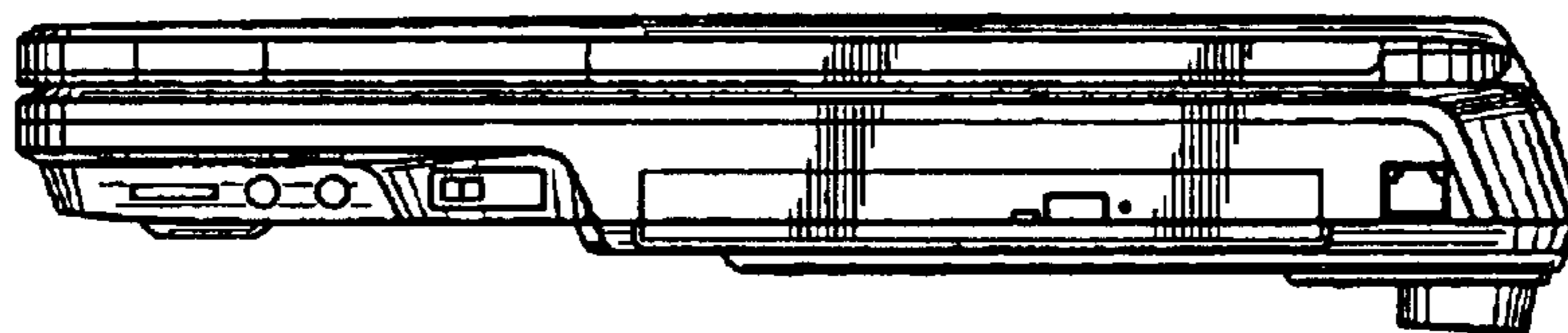
